(57) **CLAIM**

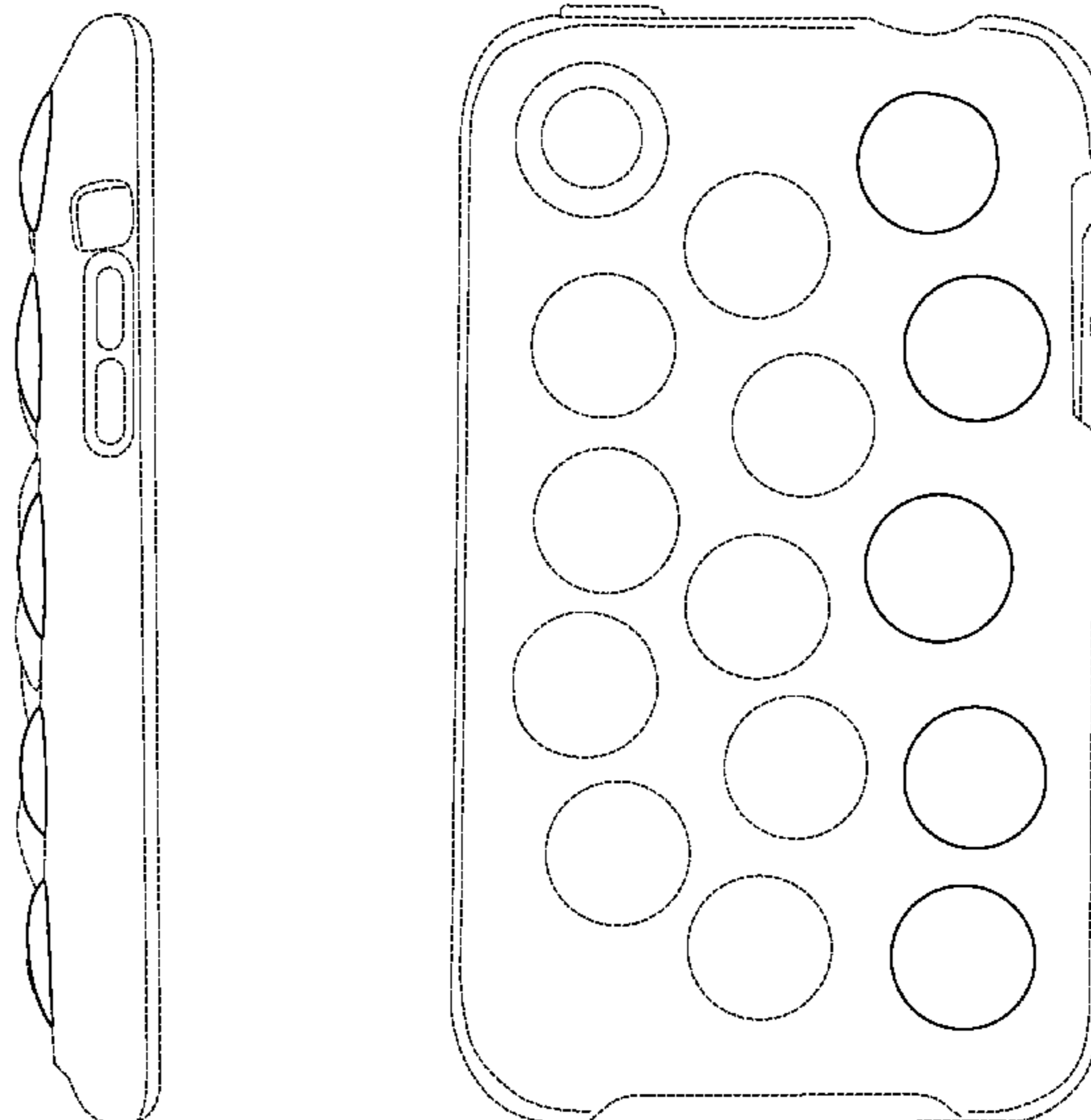
I claim the ornamental design for a case, as shown and
described.

DESCRIPTION

FIG. 1 is a top view of a case showing our new design;
FIG. 2 is a bottom view of the case of FIG. 1;
FIG. 3 is a left side view of the case of FIG. 1;
FIG. 4 is a right side view of the case of FIG. 1;
FIG. 5 is a front view of the case of FIG. 1;
FIG. 6 is a rear view of the case of FIG. 1; and,
FIG. 7 is a rear perspective view of the case of FIG. 1.

The broken lines in the drawing figures are for illustrative
purposes only and form no part of the claimed design. As is
apparent from FIG. 3, the surfaces between the portions
shown in solid lines are not claimed. For clarity, the surfaces
outside the five generally annular shapes in solid lines form
no part of the claimed design.

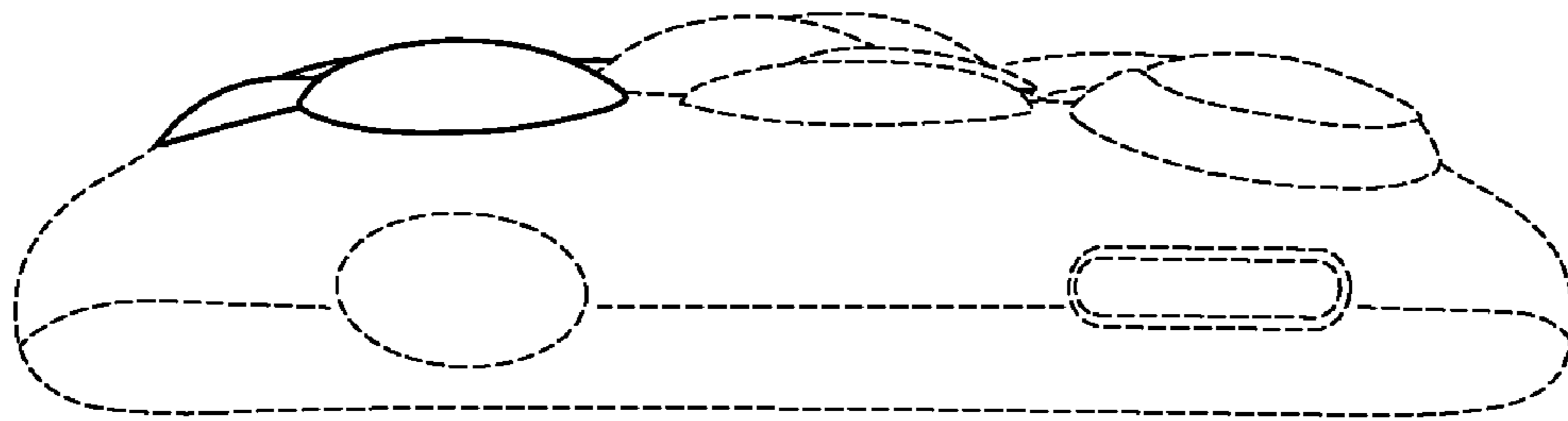

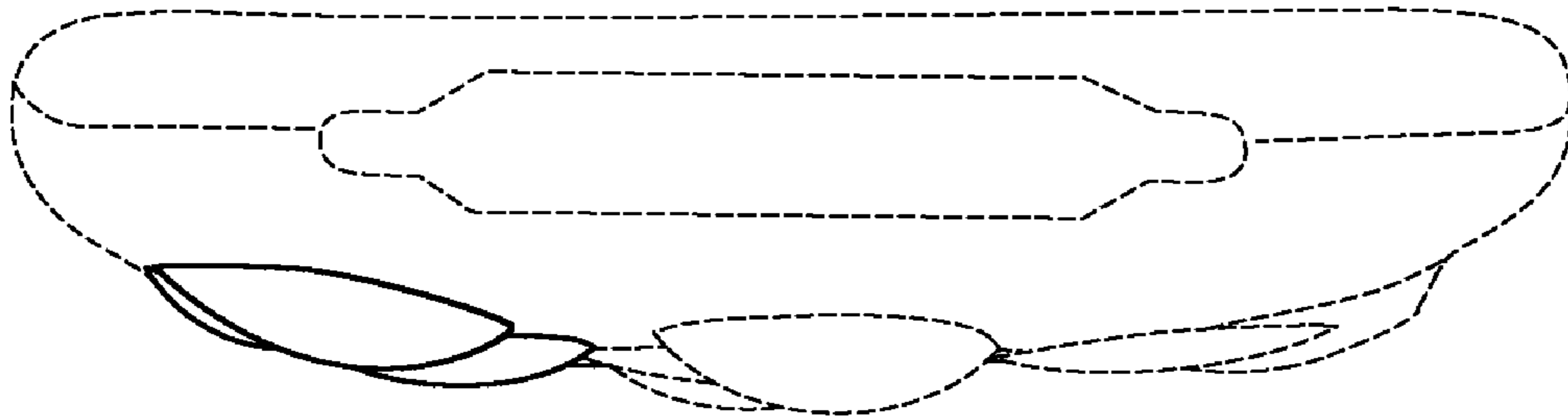

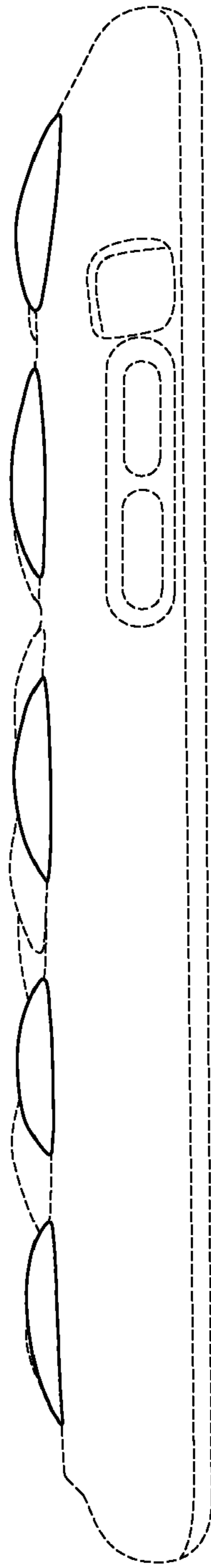

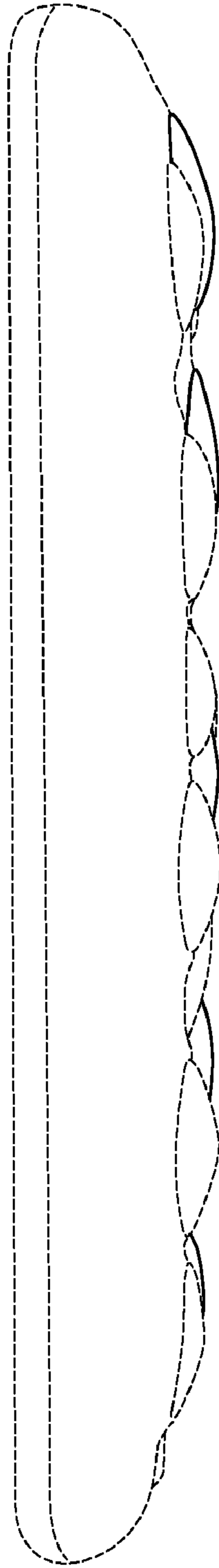

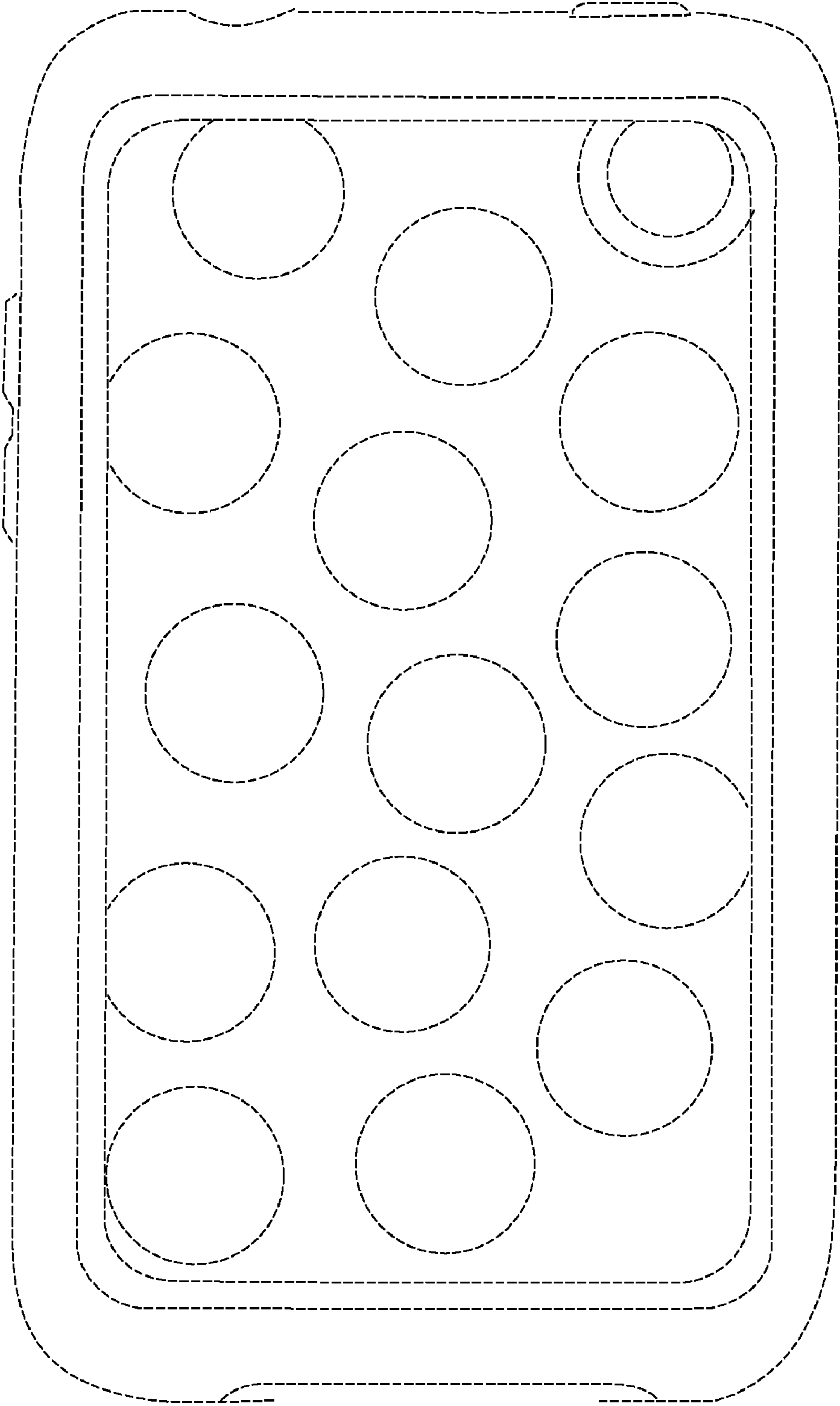

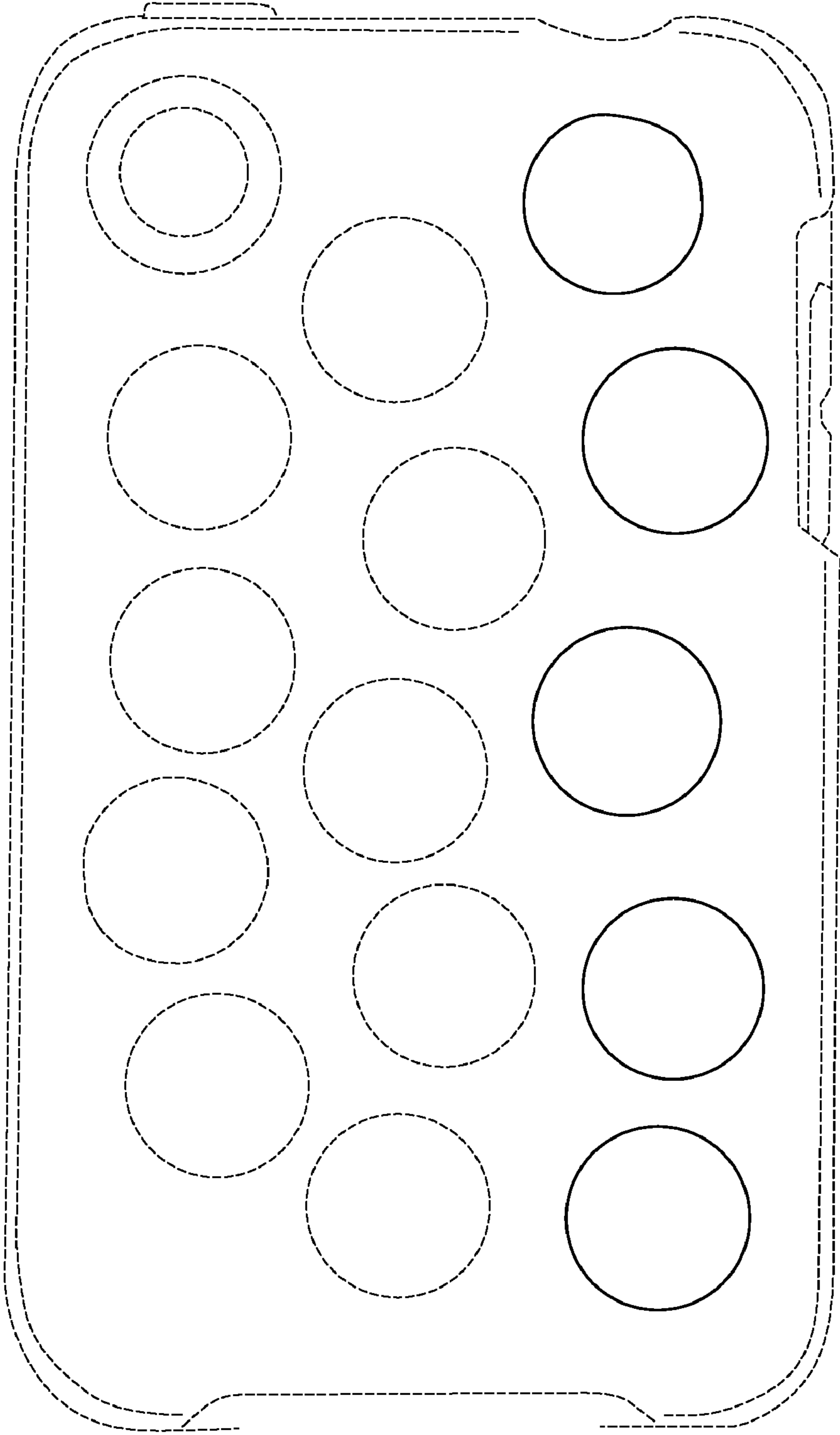

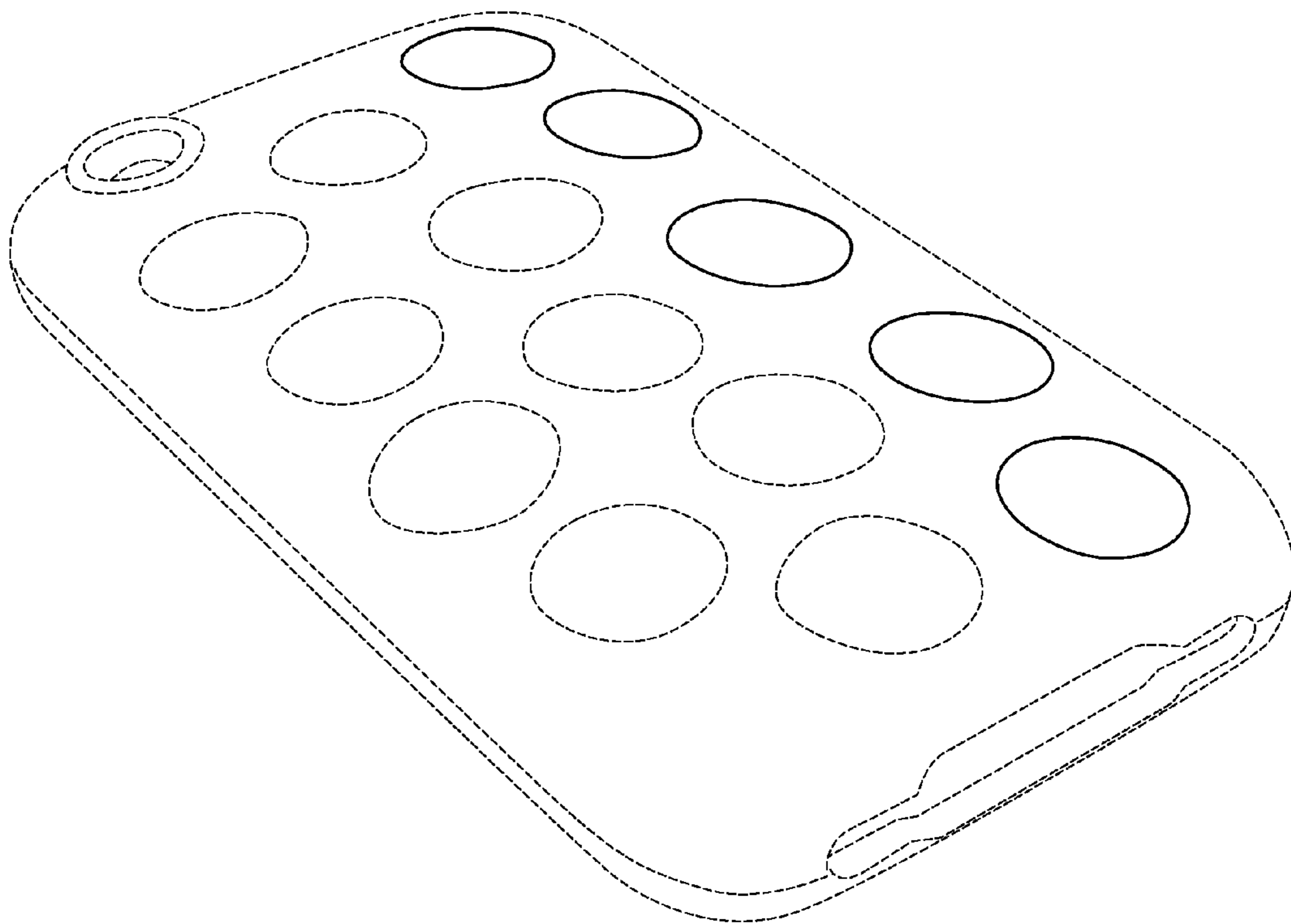
