FIG. 4 is a rear view of the return air bulkhead of FIG. 1.

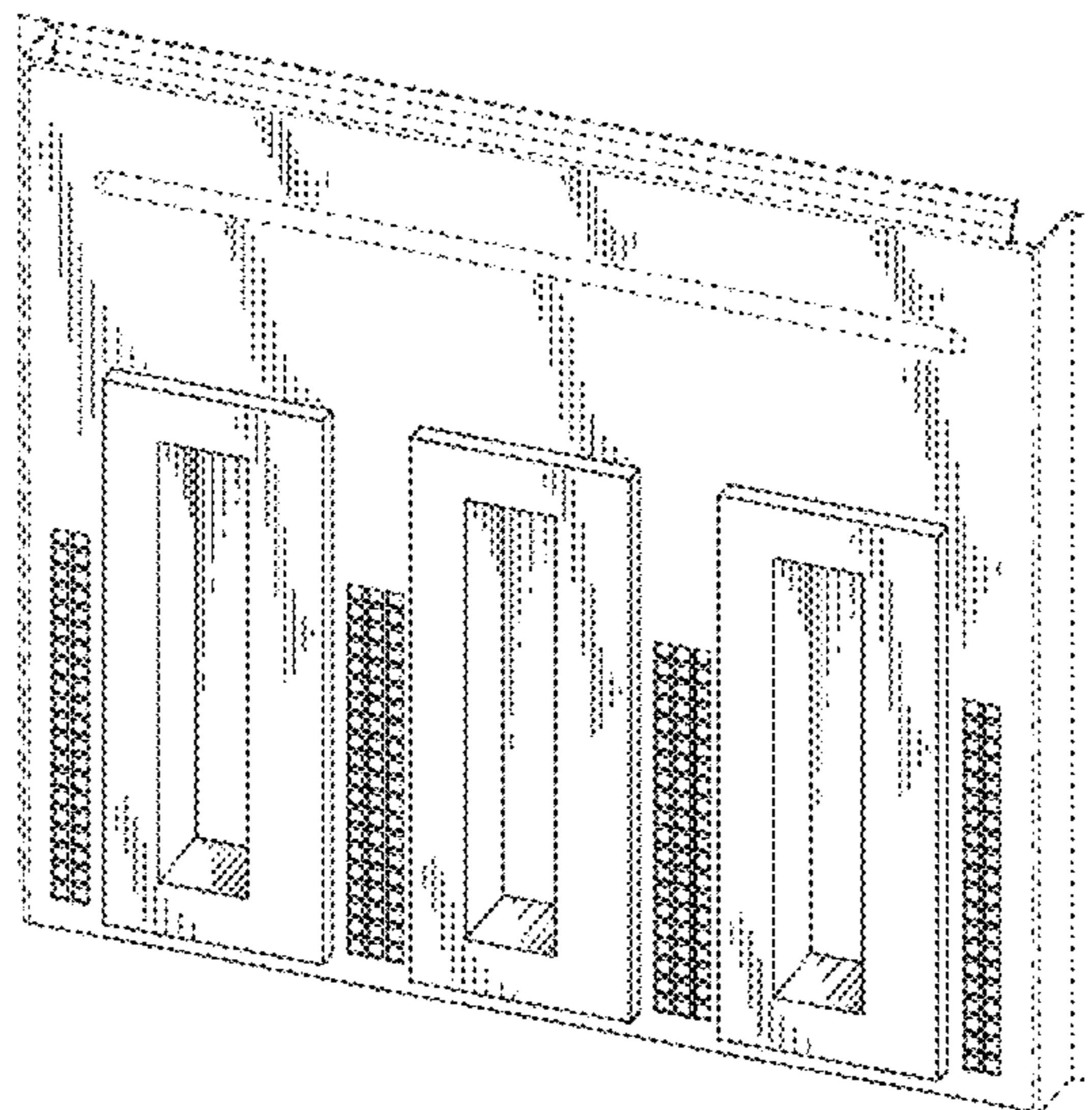
FIG. 5 is a left-side view of the return air bulkhead of FIG. 1.

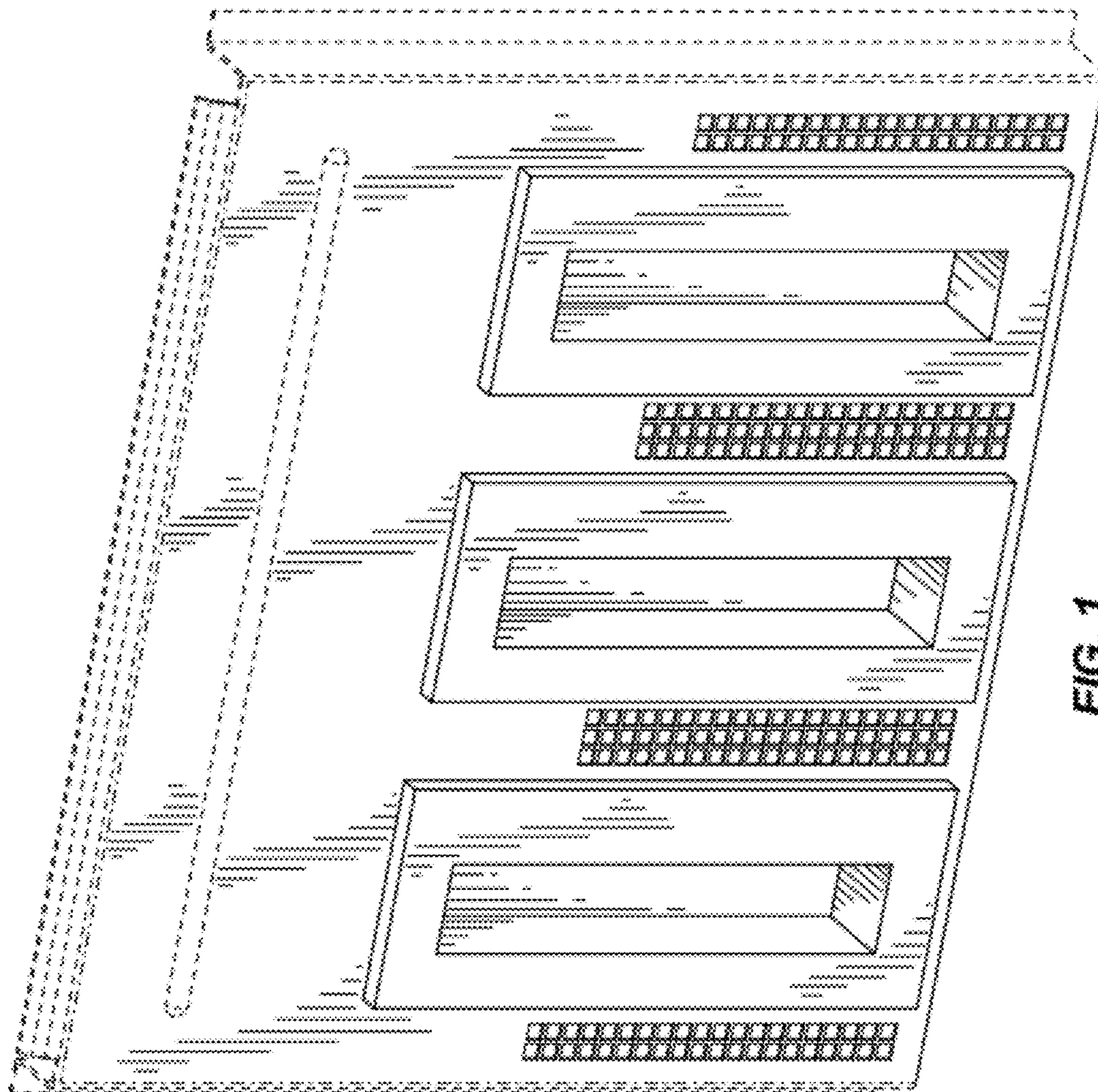

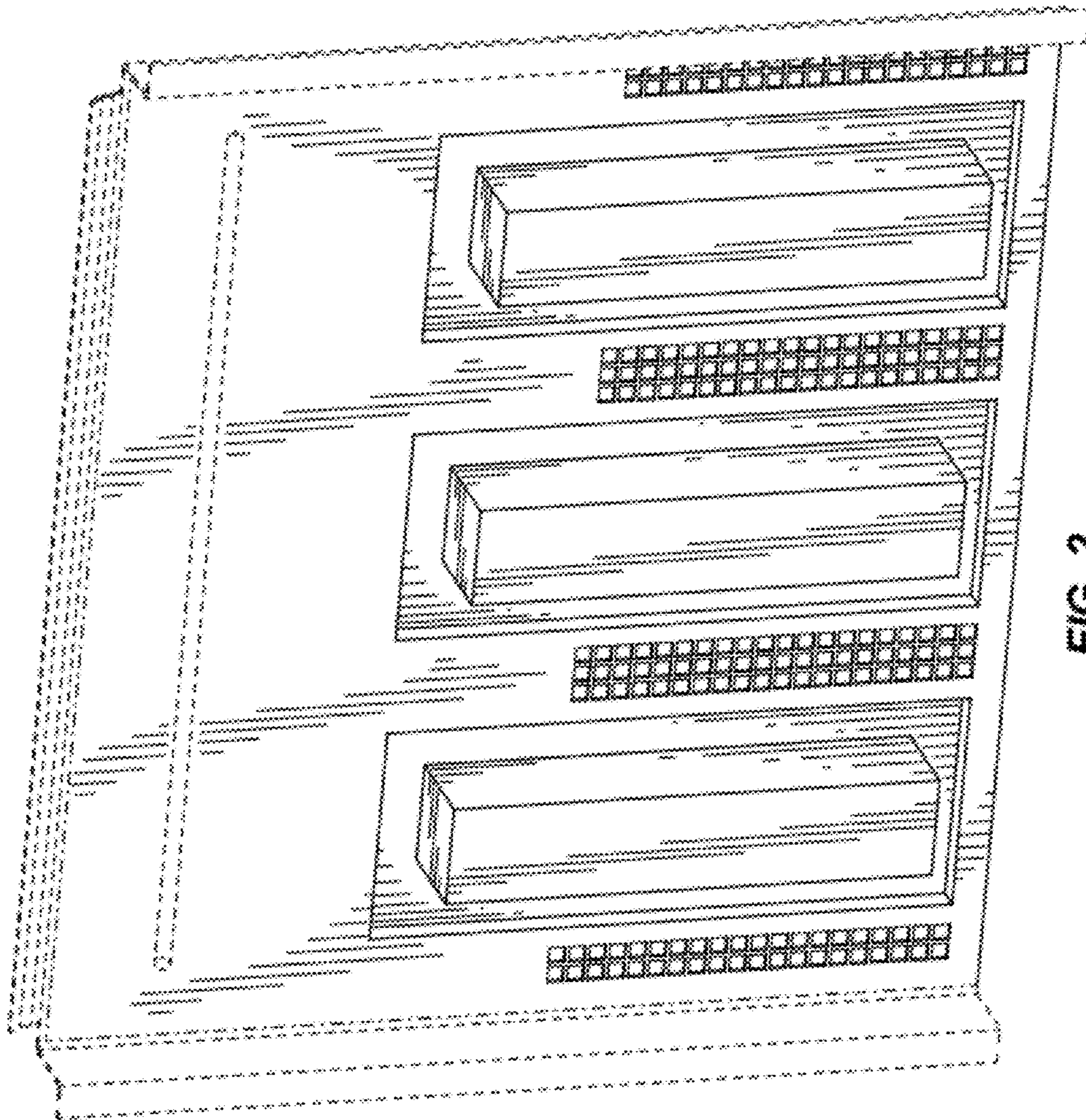

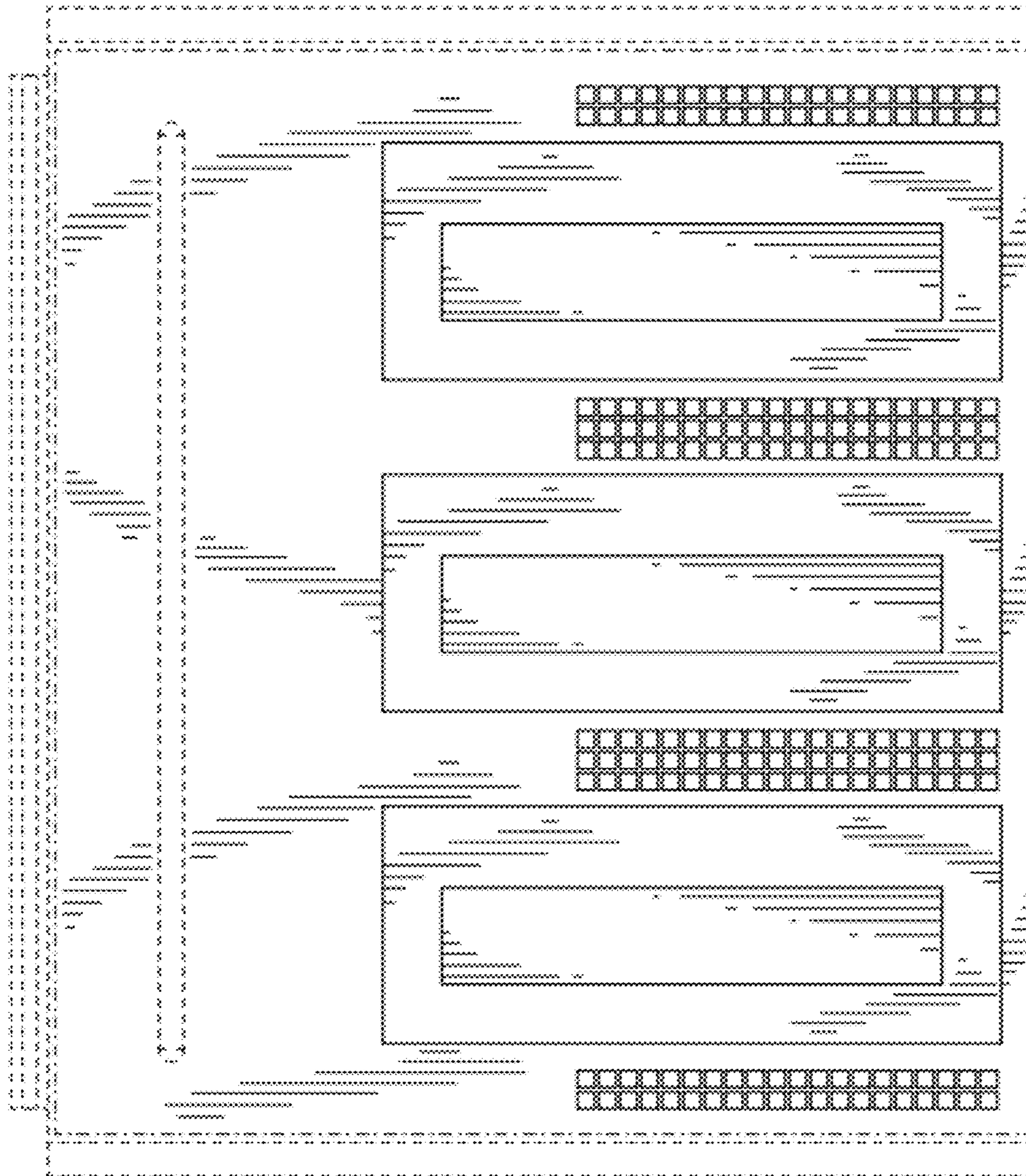

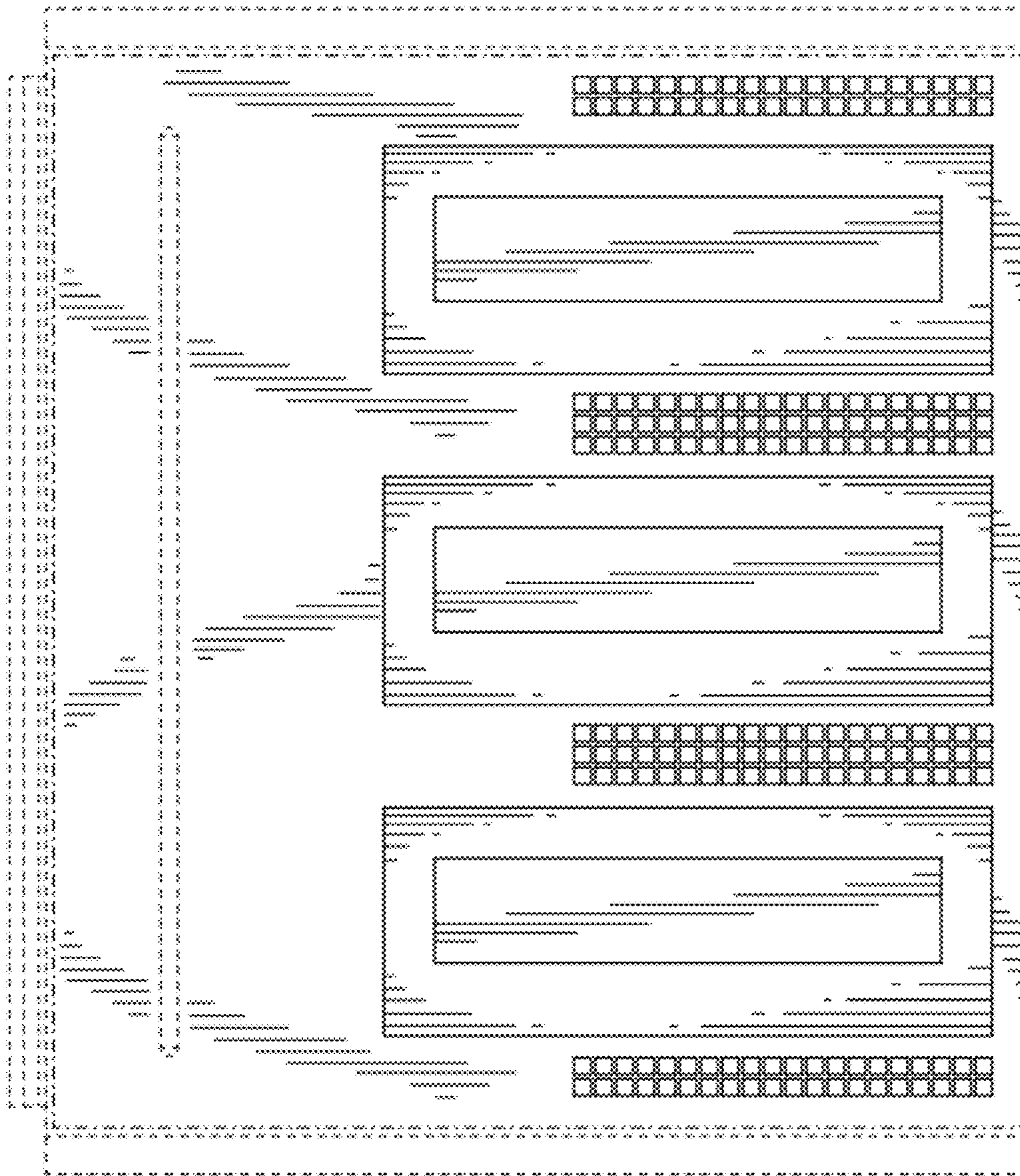
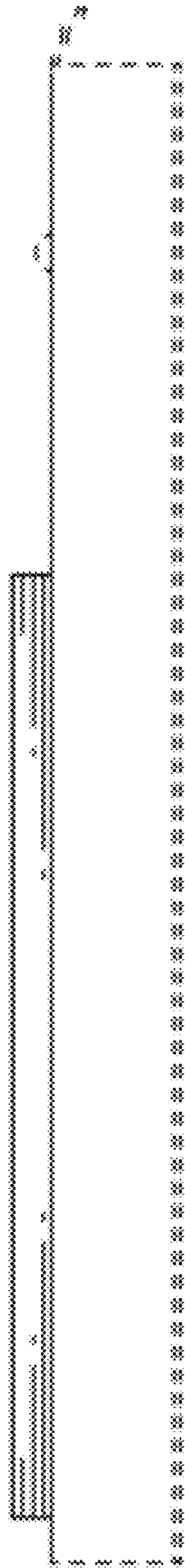
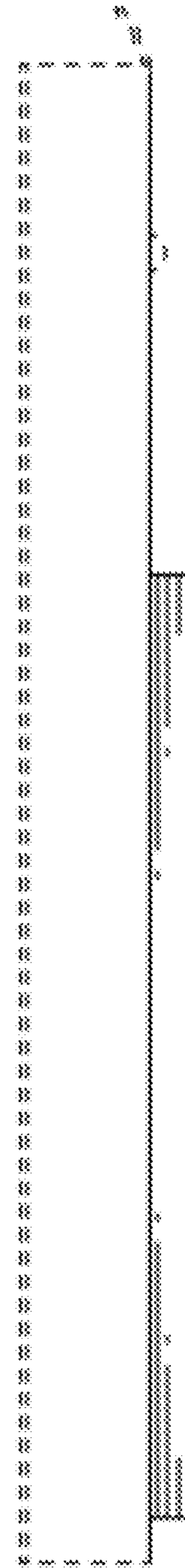


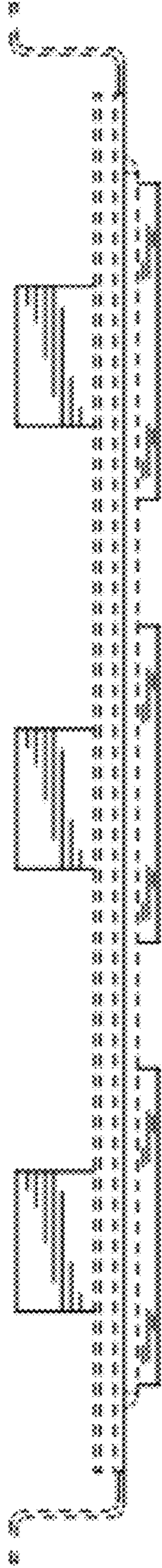

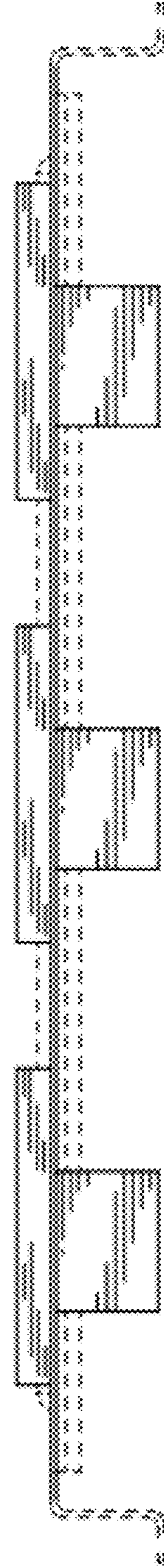
