(57) **CLAIM**

The ornamental design for a wire electric discharge machine,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a wire electric discharge machine, showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a cross-sectional view thereof; taken along line 8-8 of FIG. 2, with the internal system omitted.

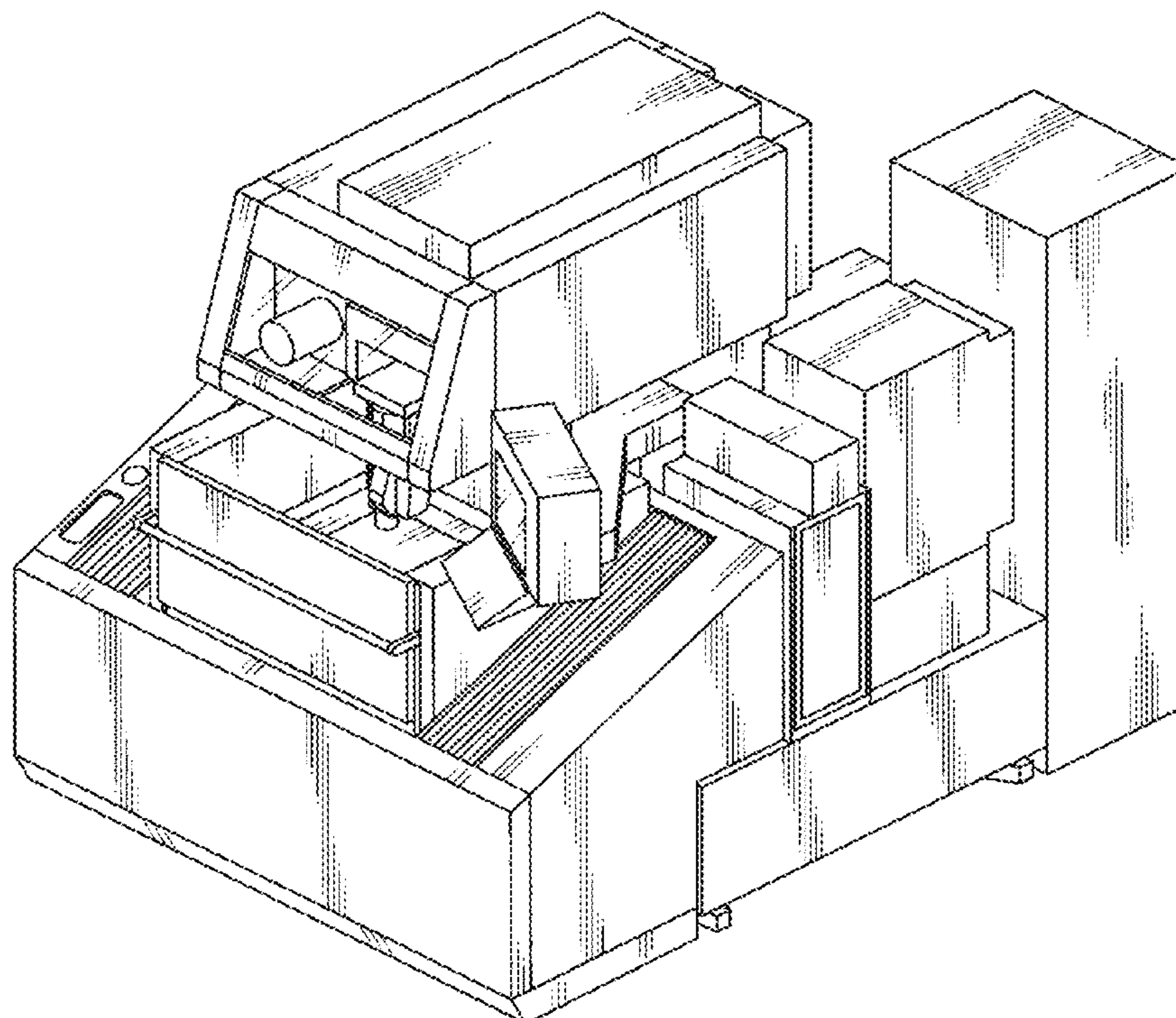

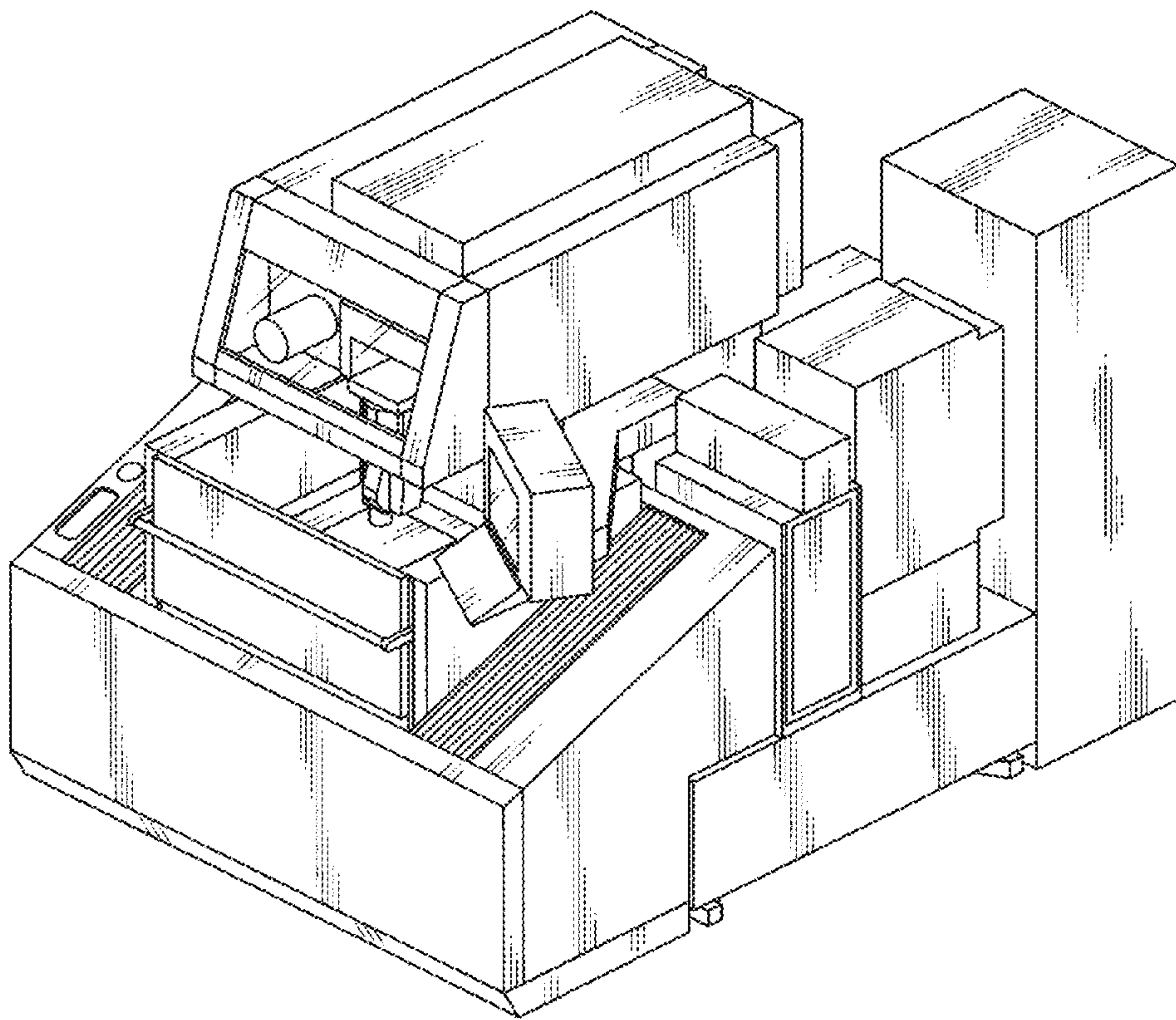

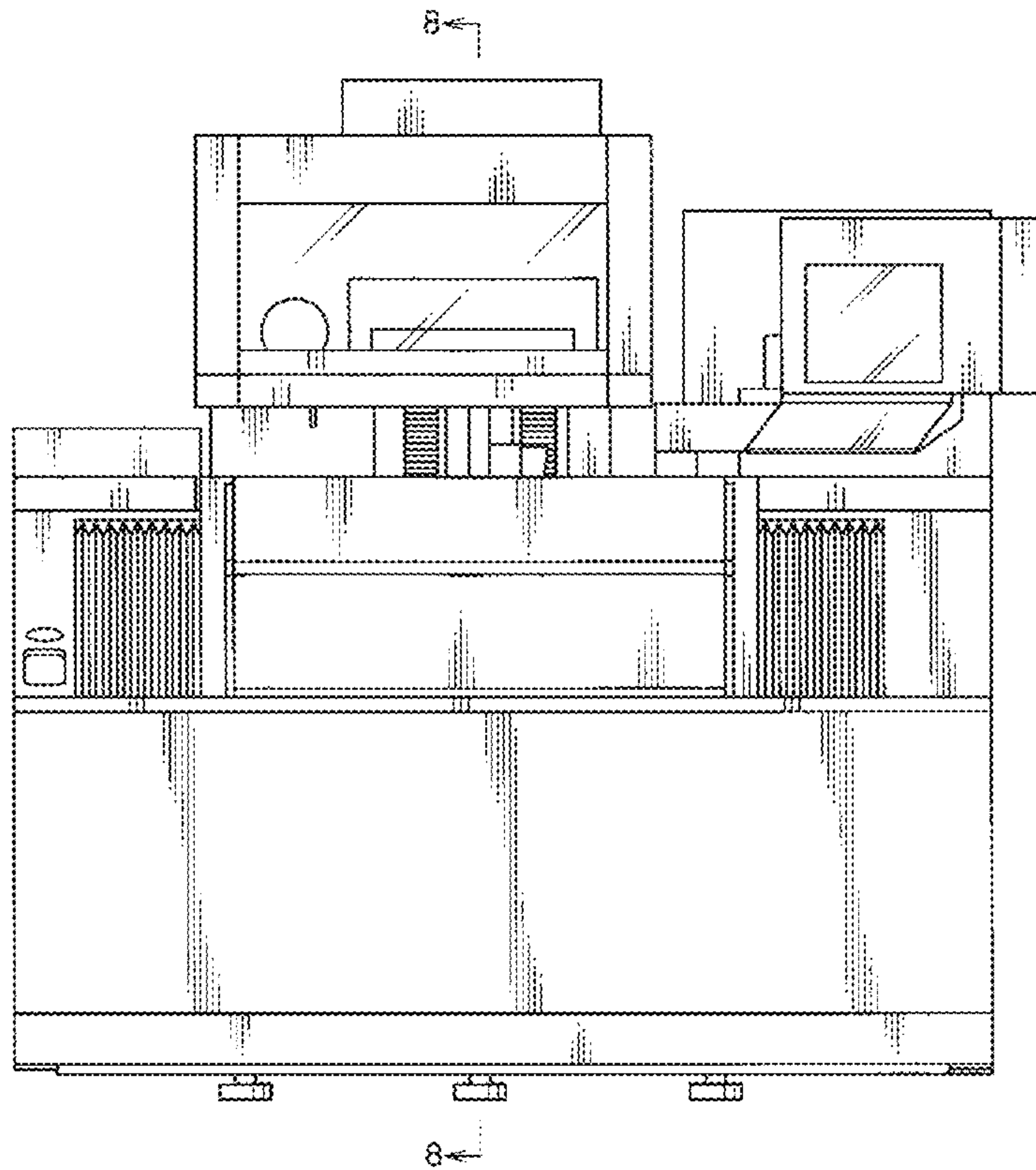

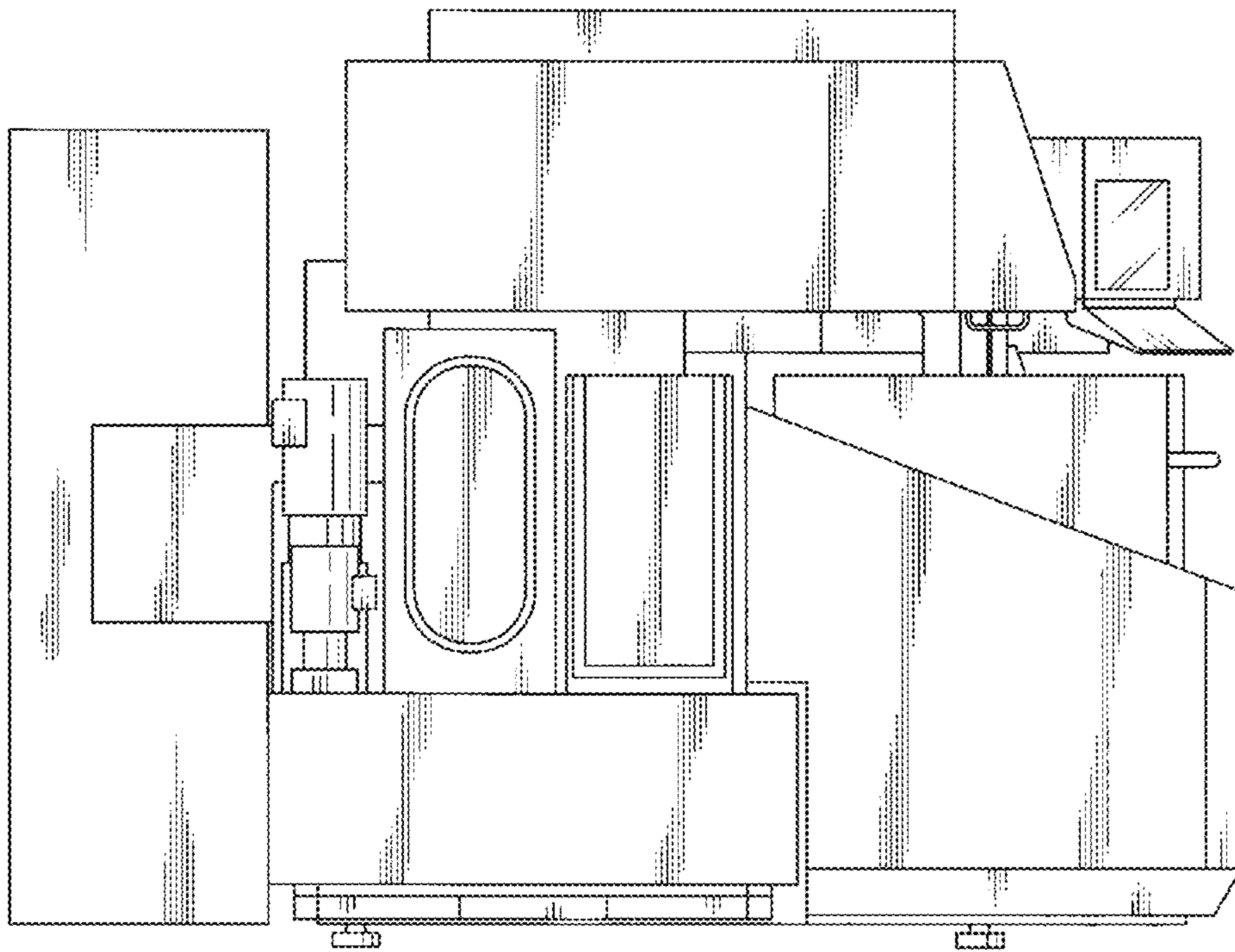

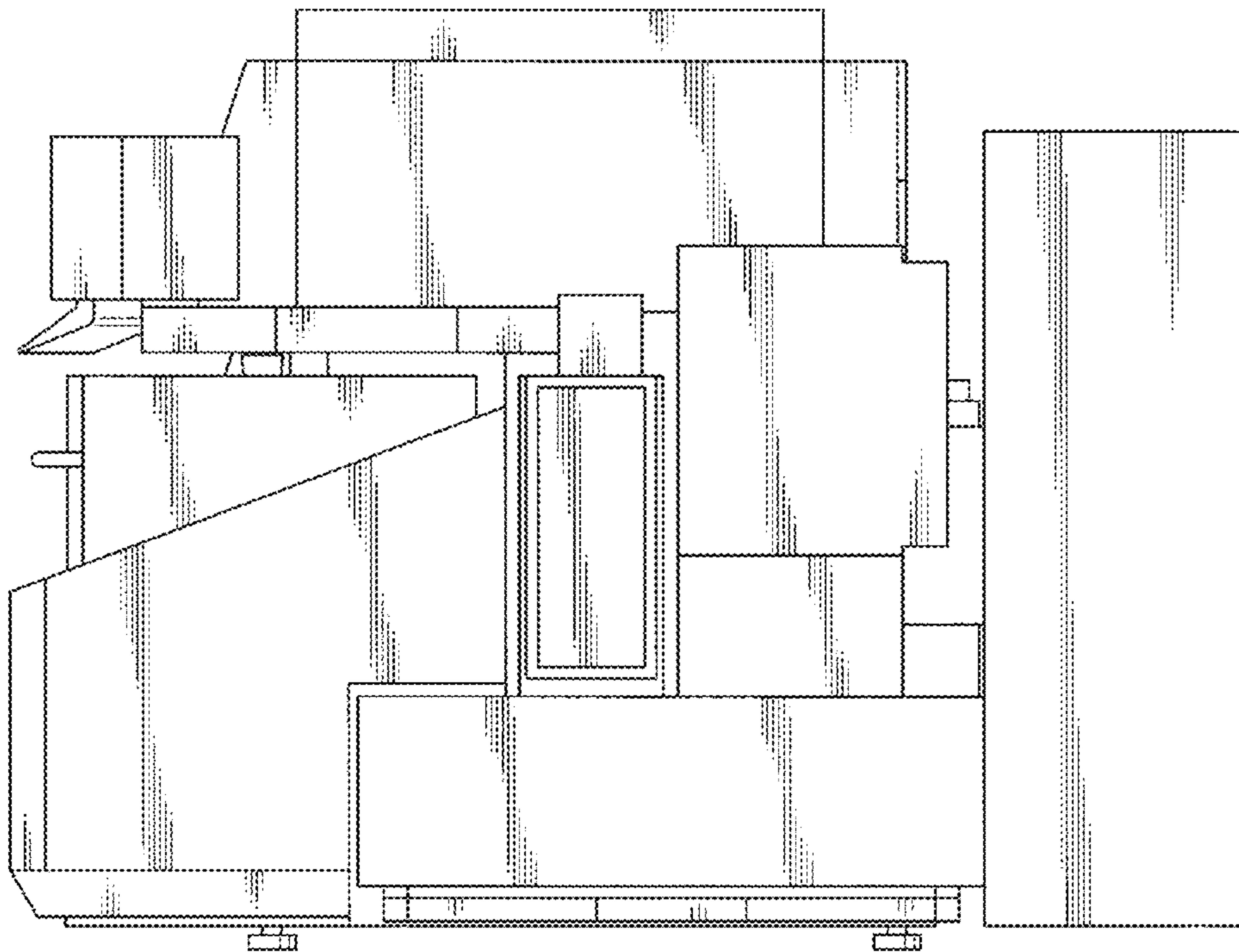

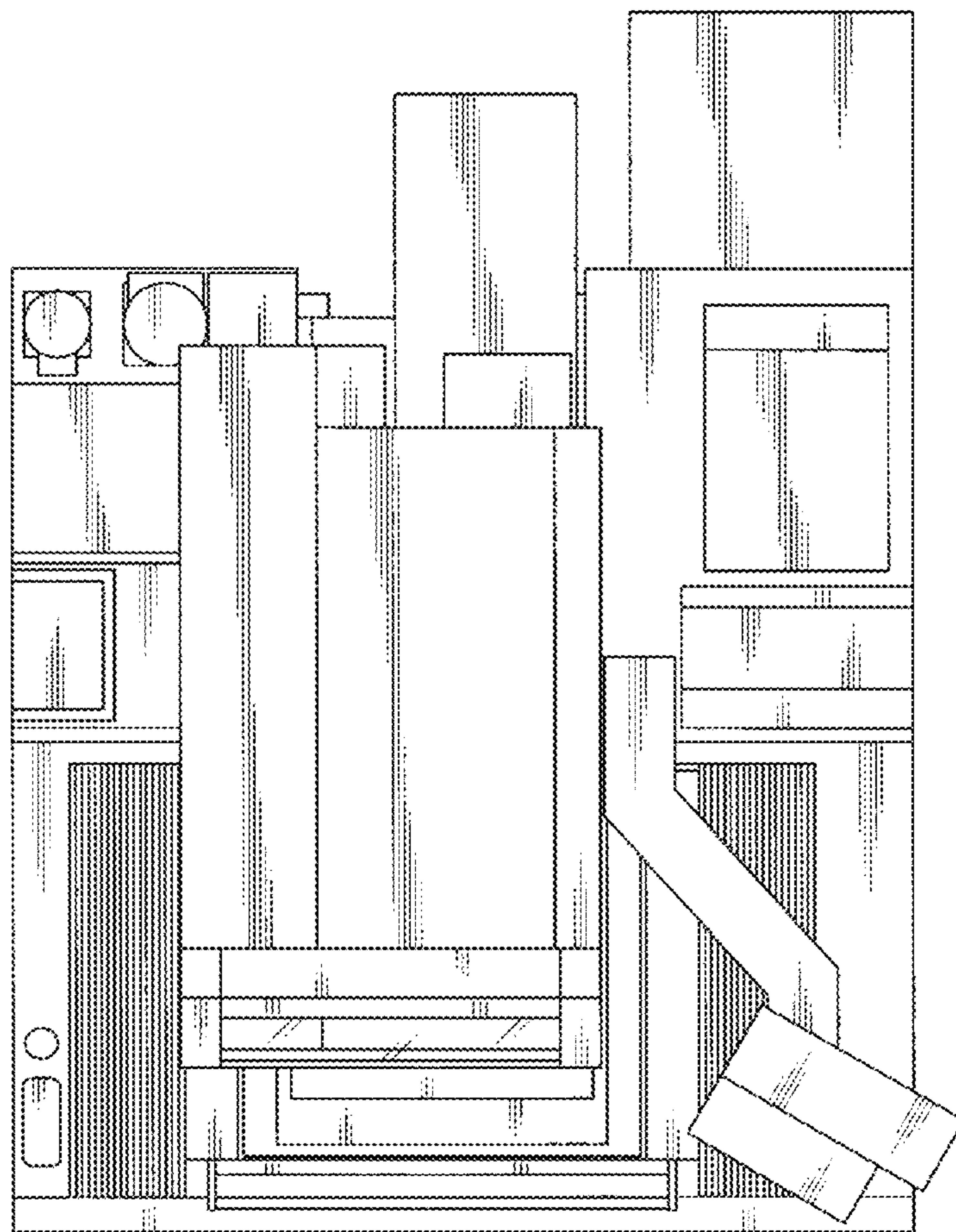

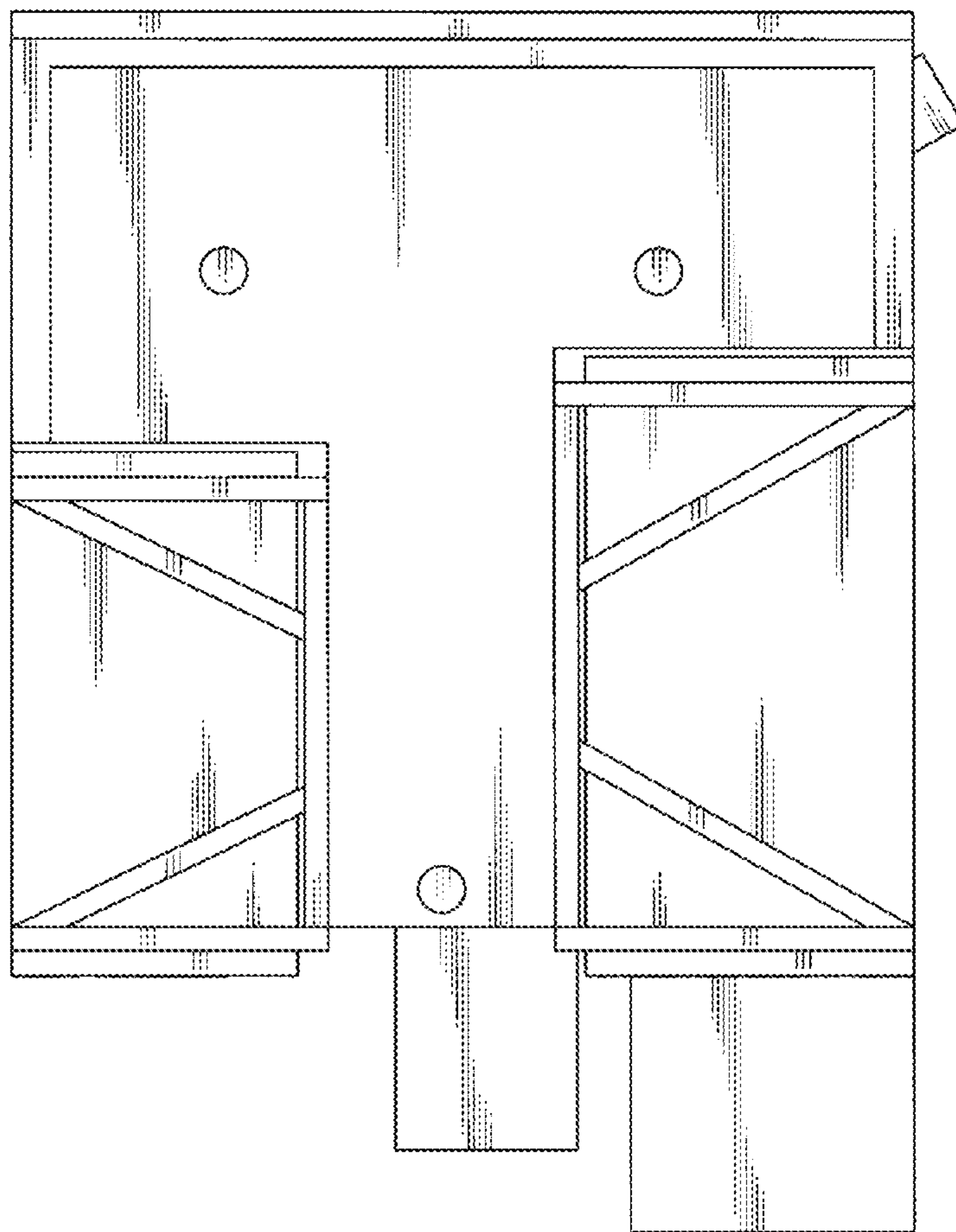
