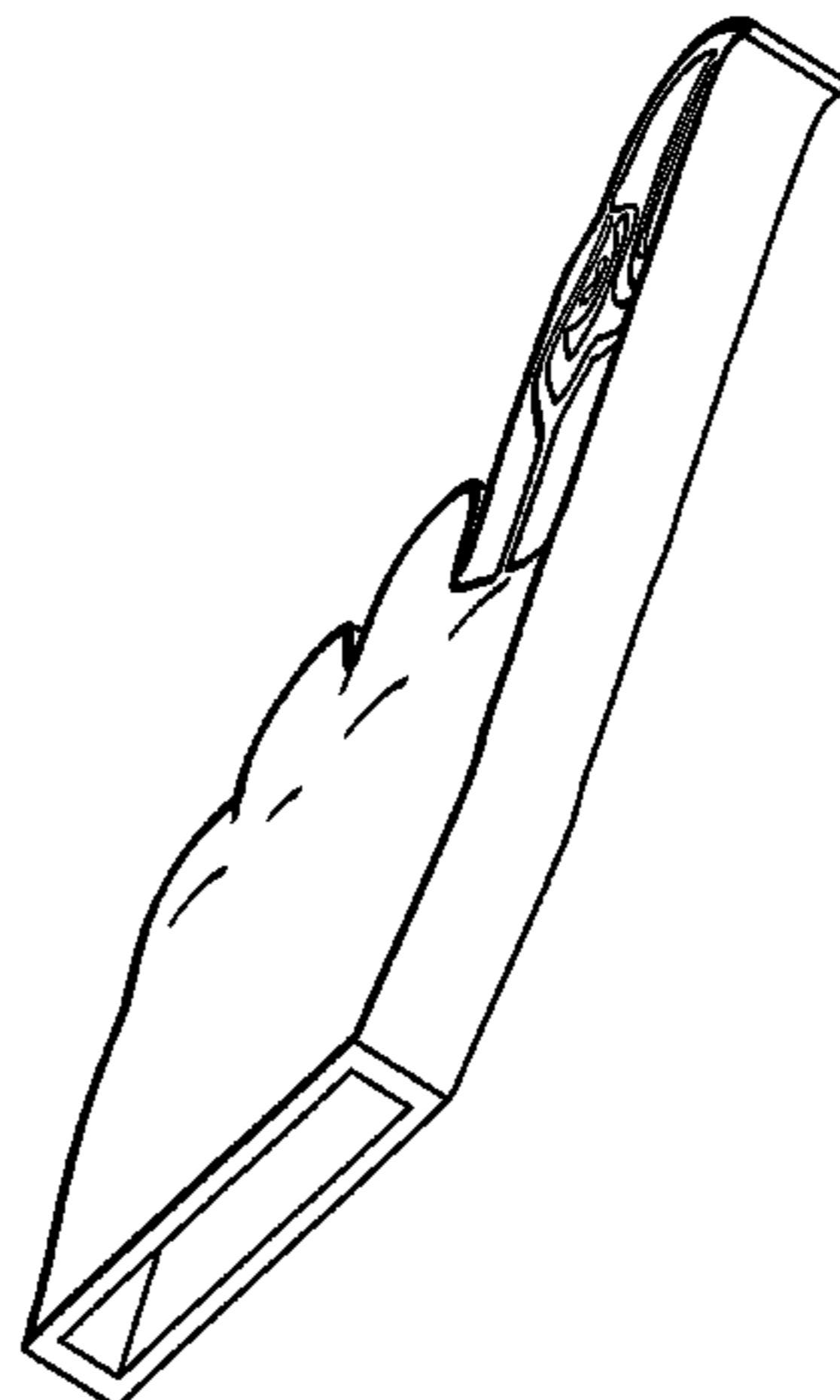
(57) **CLAIM**

The ornamental design for a hand sign, as shown and described.

DESCRIPTION

FIG. 1 is a right-side elevational view of a first embodiment of a left-hand hand sign according to the invention;
 FIG. 2 is a left-side elevational view of the left-hand hand sign of FIG. 1;
 FIG. 3 is a reduced scale rear elevational view of the left-hand hand sign of FIG. 1;
 FIG. 4 is a reduced scale top plan view of the left-hand hand sign of FIG. 1;
 FIG. 5 is a reduced scale bottom plan view of the left-hand hand sign of FIG. 1;
 FIG. 6 is a reduced scale front elevational view of the left-hand hand sign of FIG. 1;
 FIG. 7 is a perspective view from below the rear of the left side of the left-hand hand sign of FIG. 2;
 FIG. 8 is a perspective view from above the front of the left side of the left-hand hand sign of FIG. 2;
 FIG. 9 is a left-side elevational view of a second embodiment of a right-hand hand sign according to the invention;
 FIG. 10 is a right-side elevational view of the right-hand hand sign of FIG. 9;
 FIG. 11 is a reduced scale front elevational view of the right-hand hand sign of FIG. 9;
 FIG. 12 is a reduced scale top plan view of the right-hand hand sign of FIG. 9;
 FIG. 13 is a reduced scale bottom plan view of the right-hand hand sign of FIG. 9;
 FIG. 14 is a reduced scale rear elevational view of the right-hand hand sign of FIG. 9;
 FIG. 15 is a perspective view from below the rear of the right side of the right-hand hand sign of FIG. 10; and,
 FIG. 16 is a perspective view from above the front of the right side of the right-hand hand sign of FIG. 10.

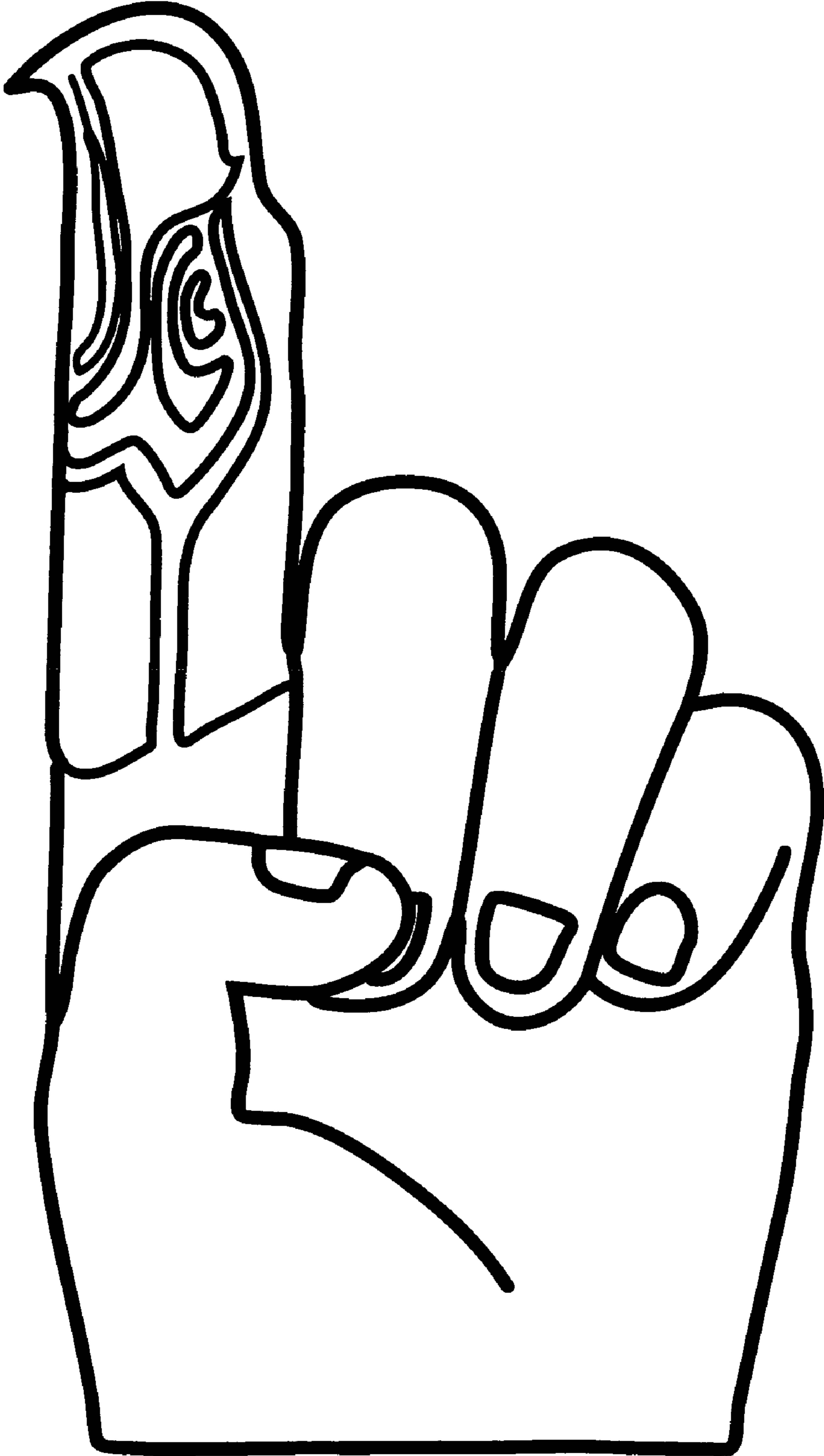

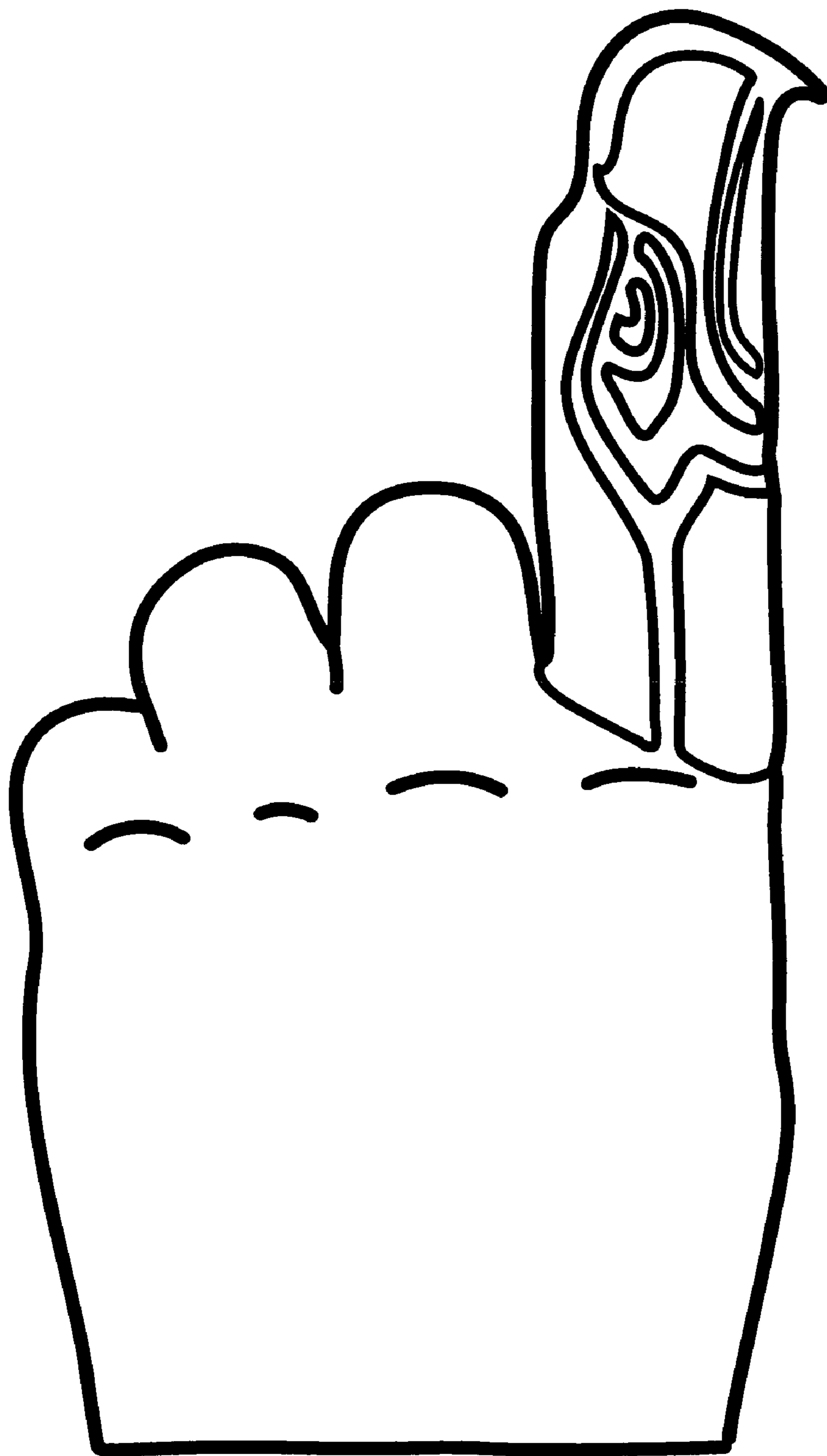

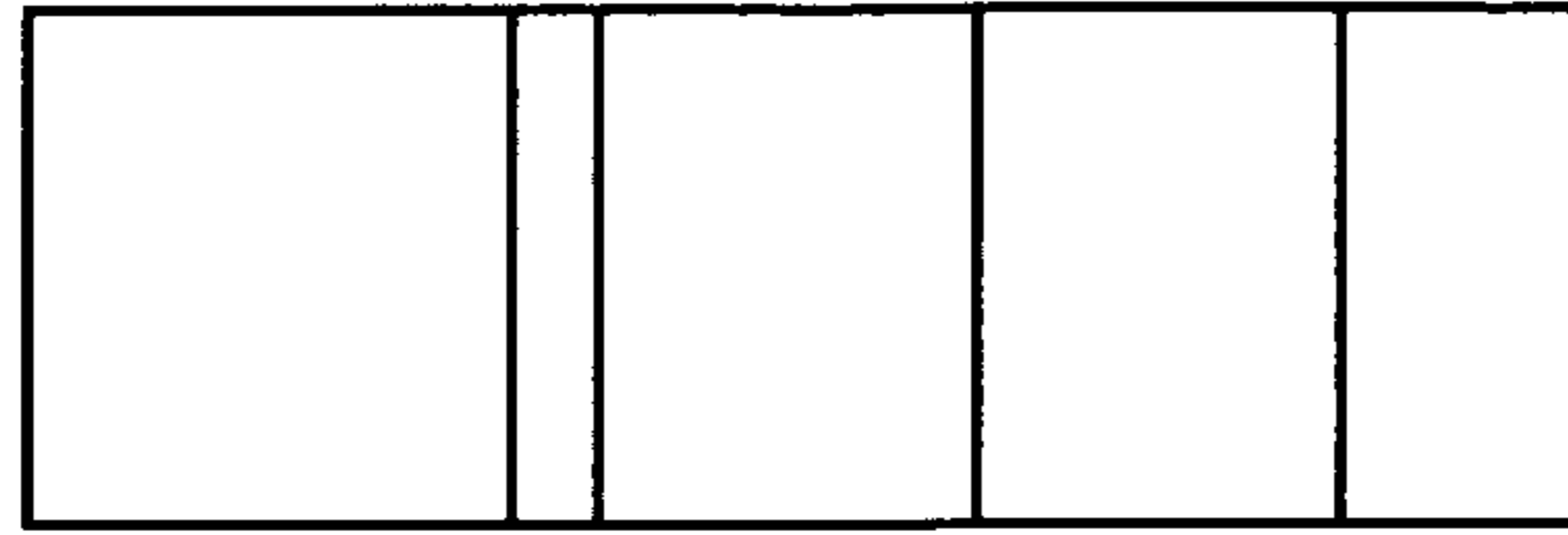

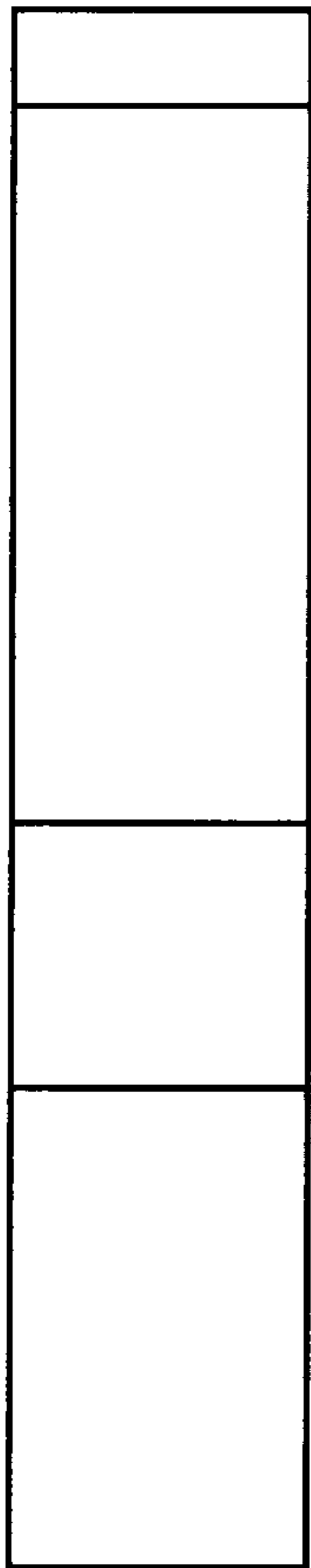

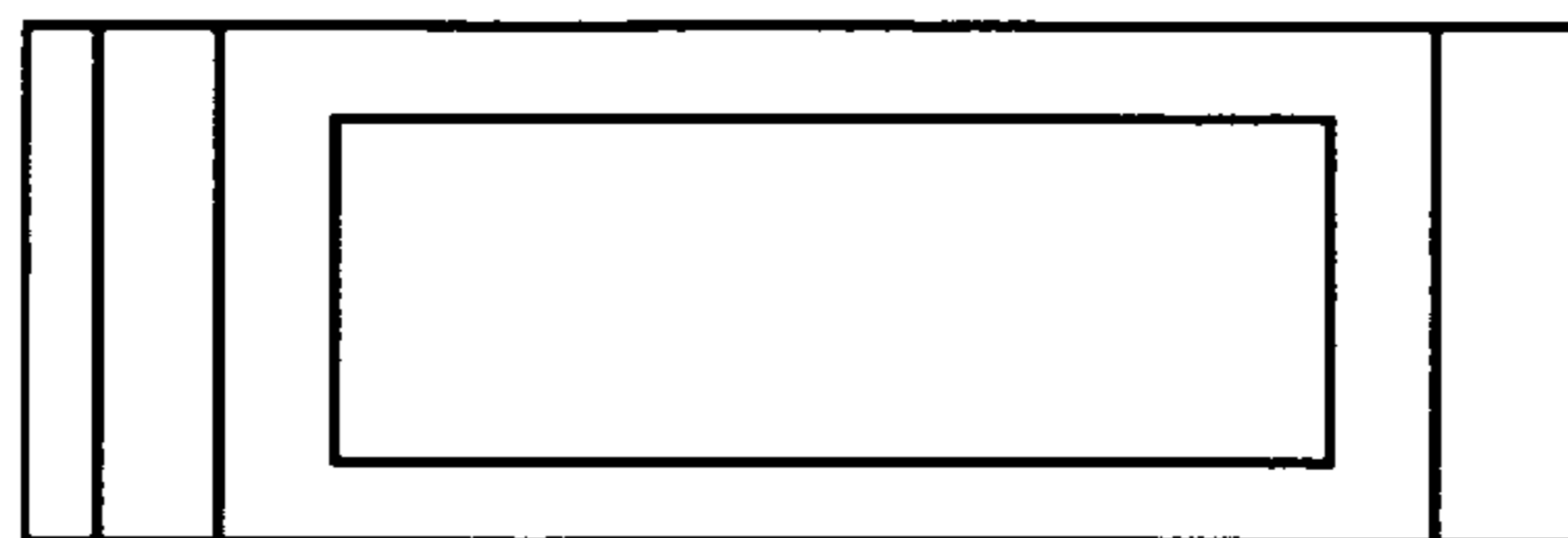

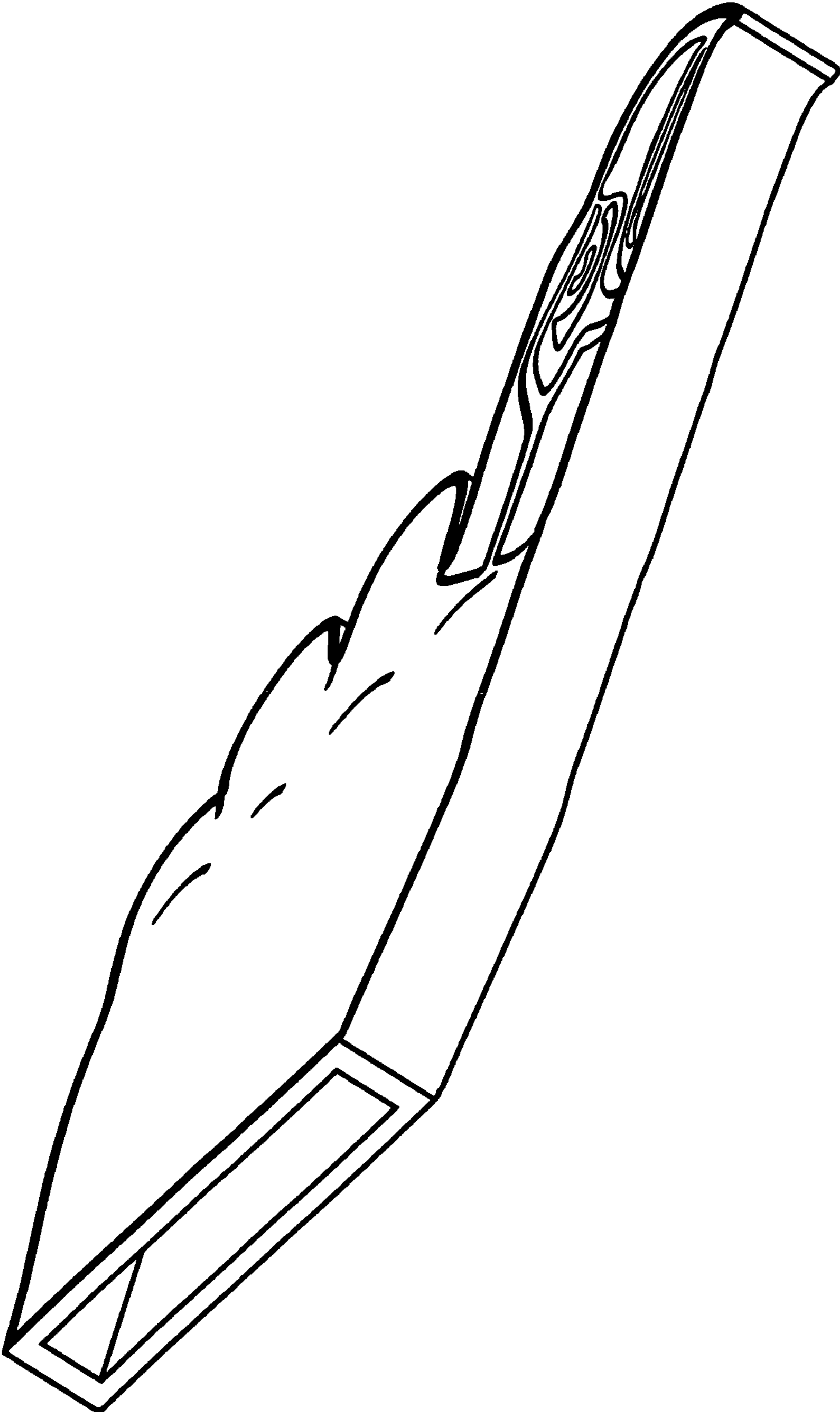

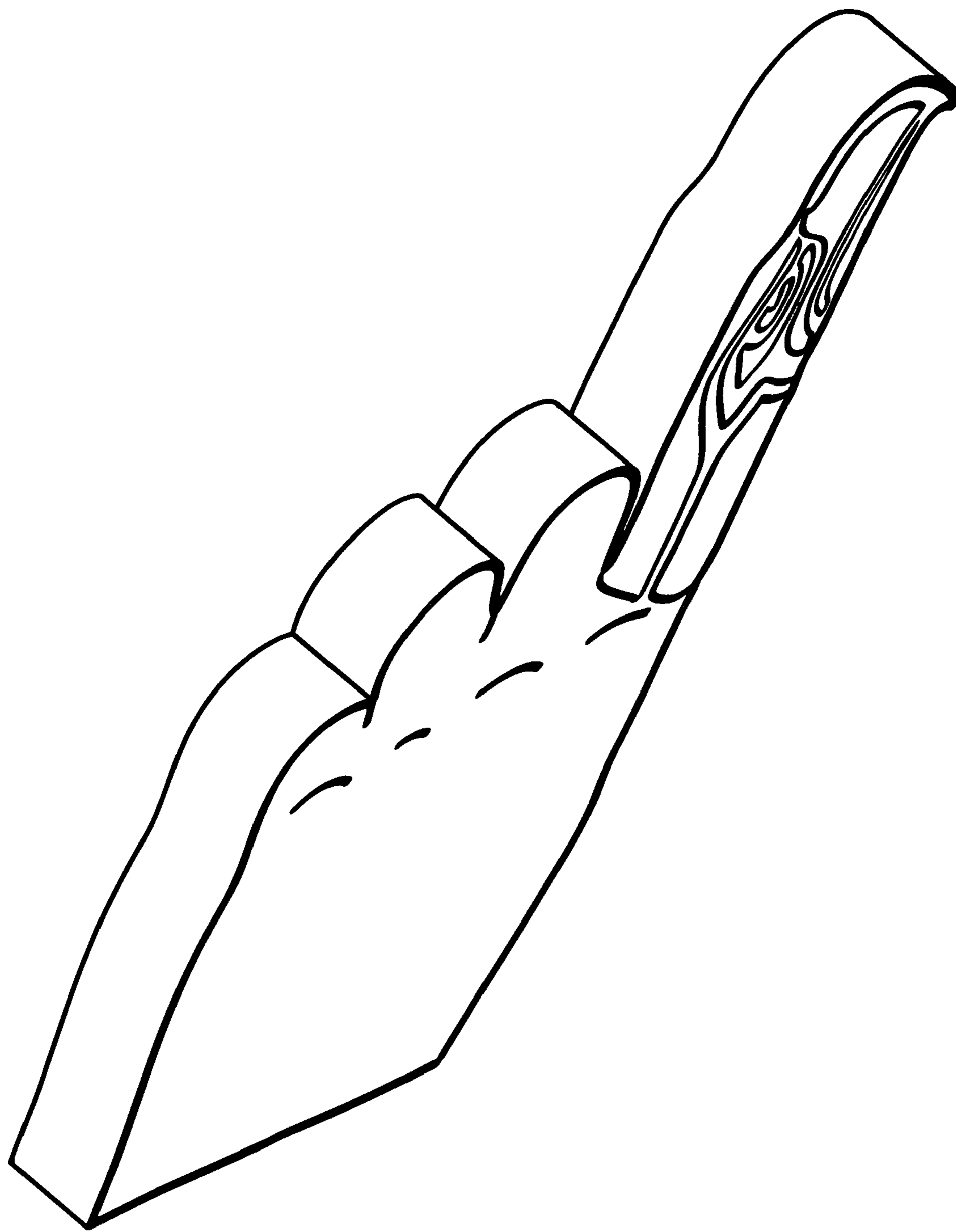

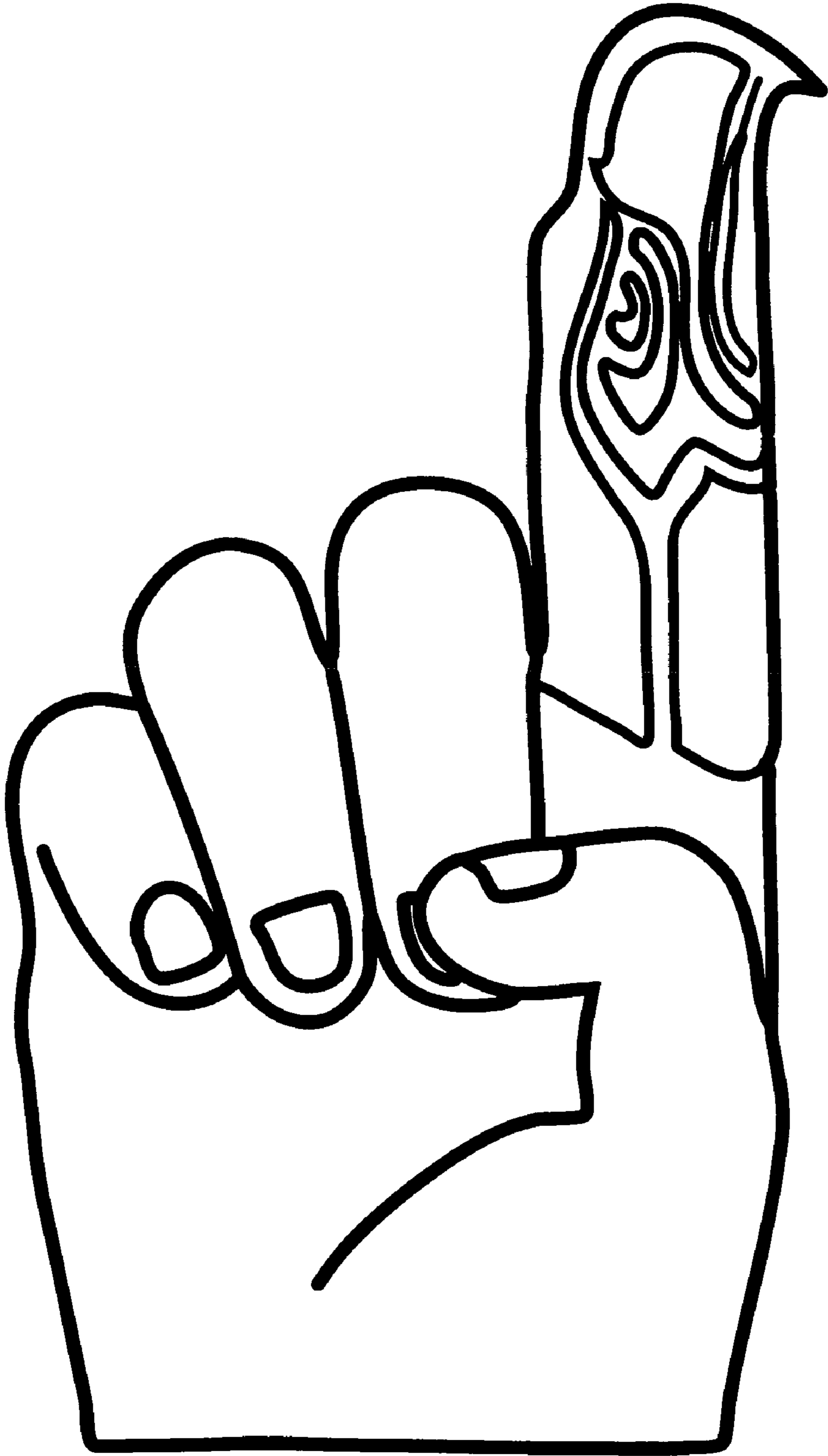

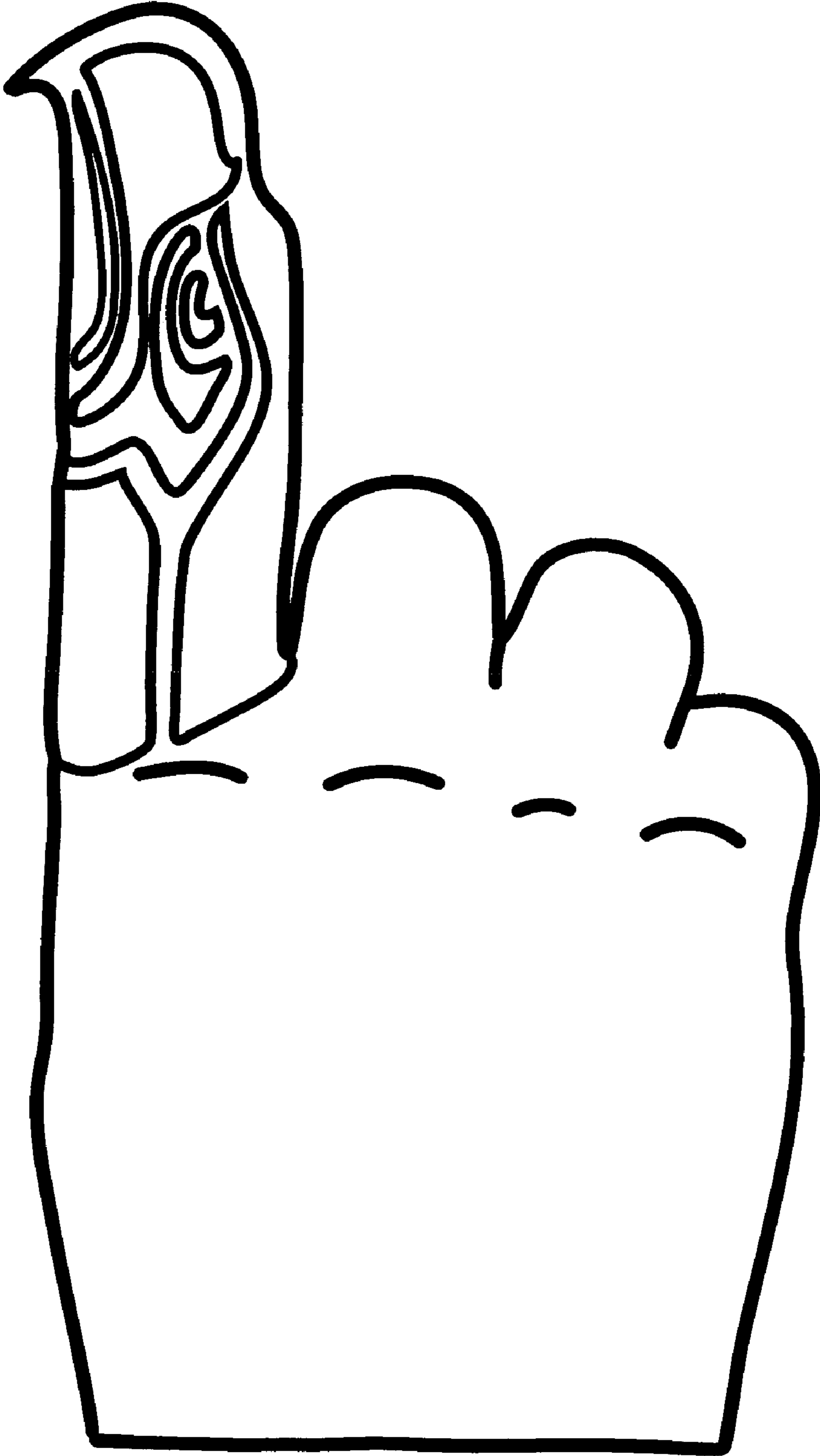

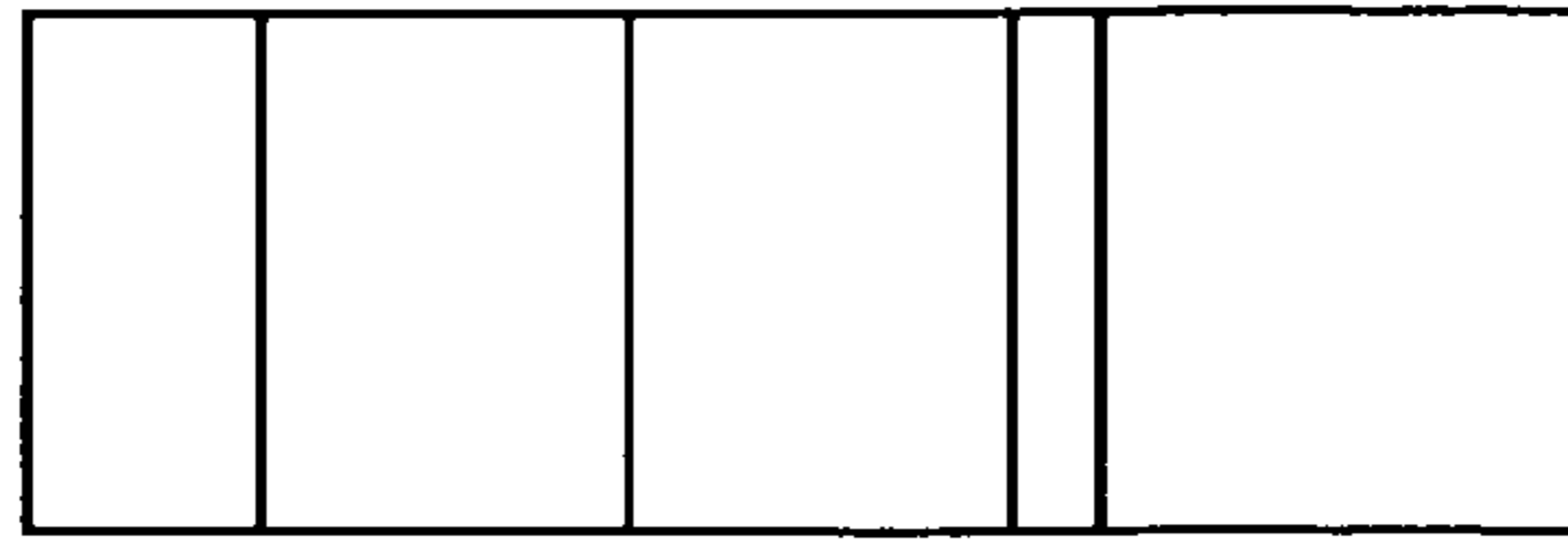

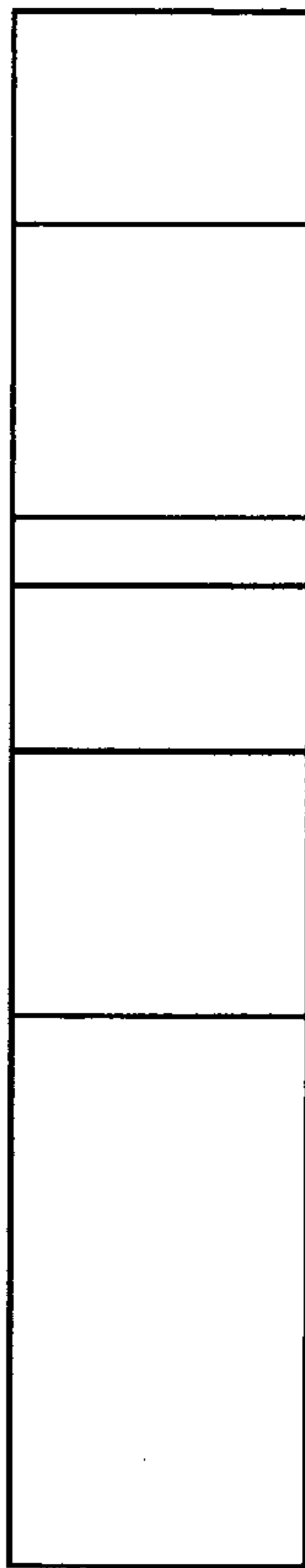

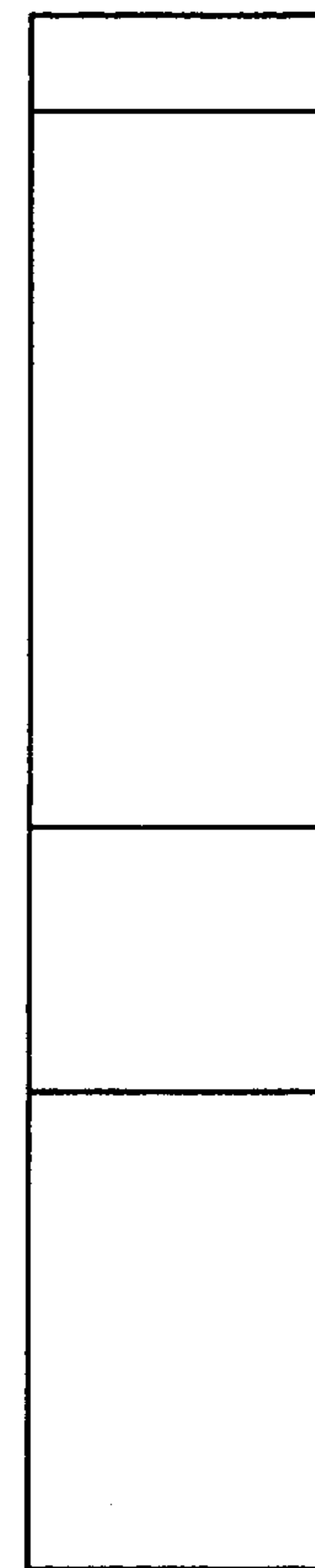

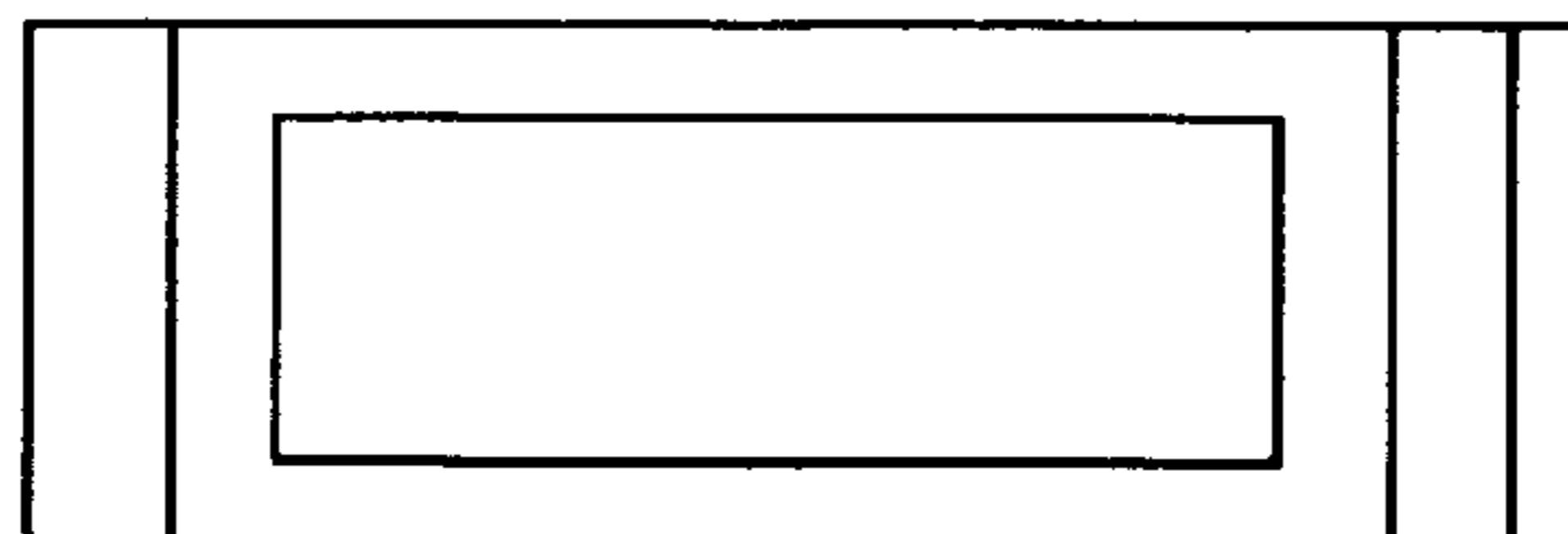

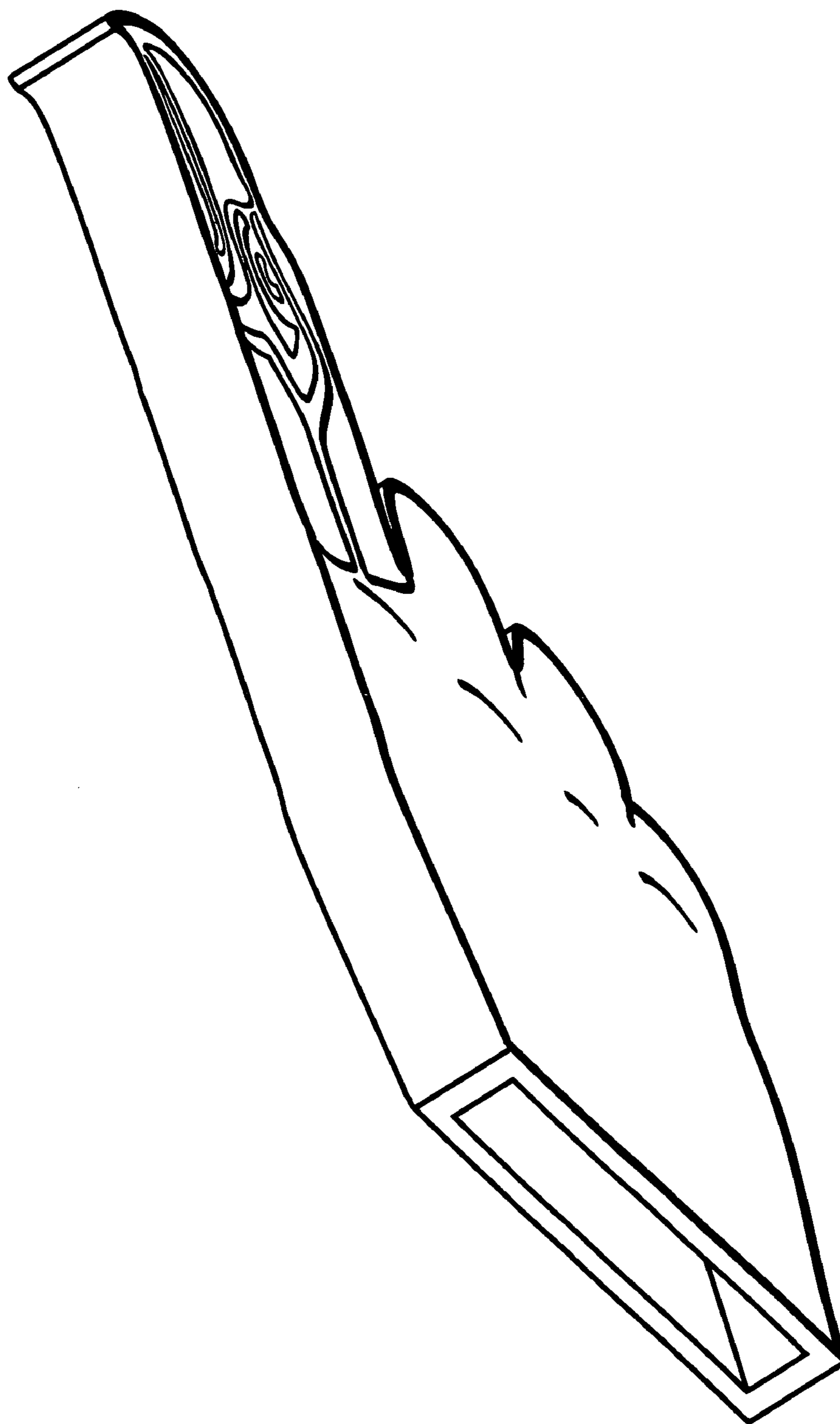

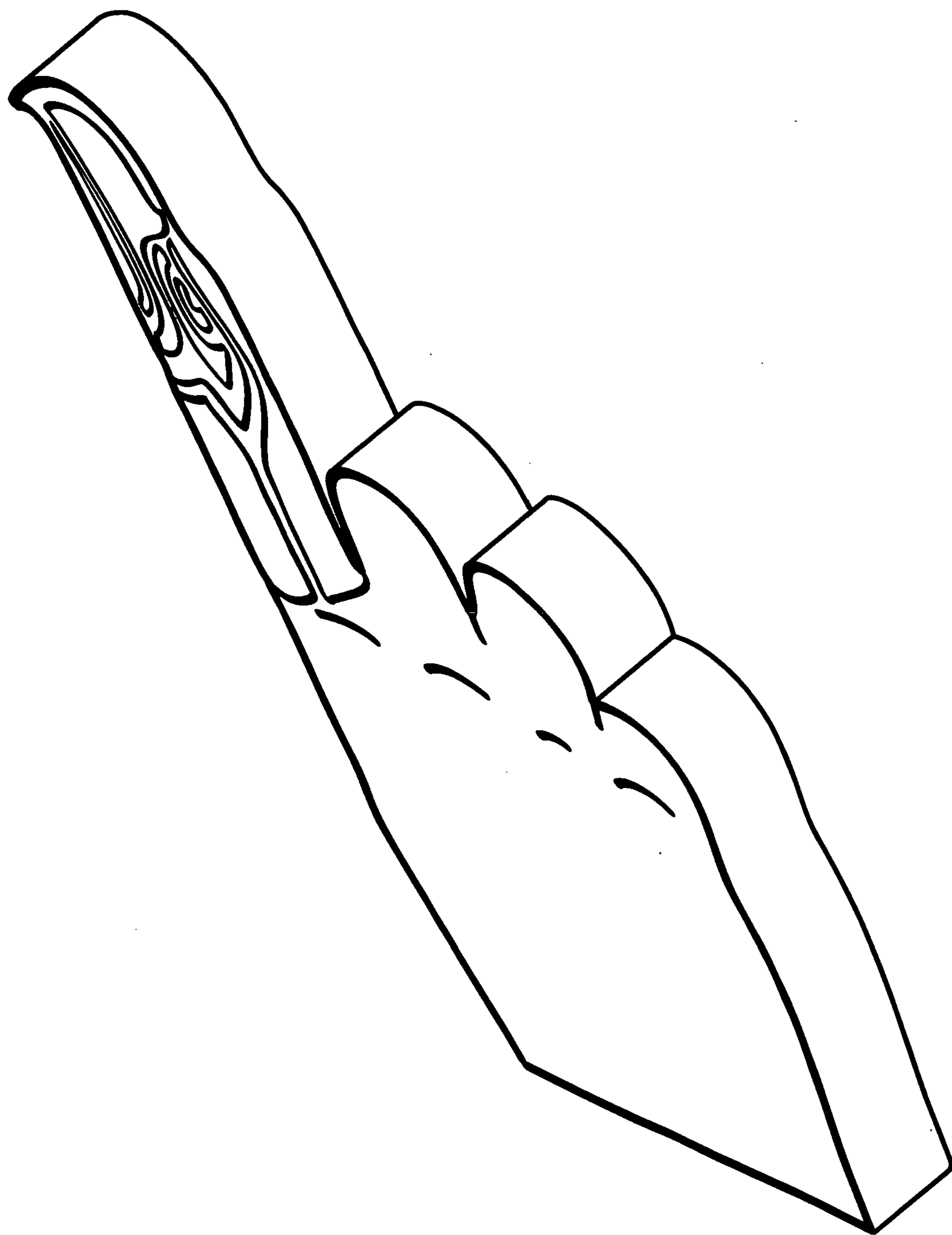
