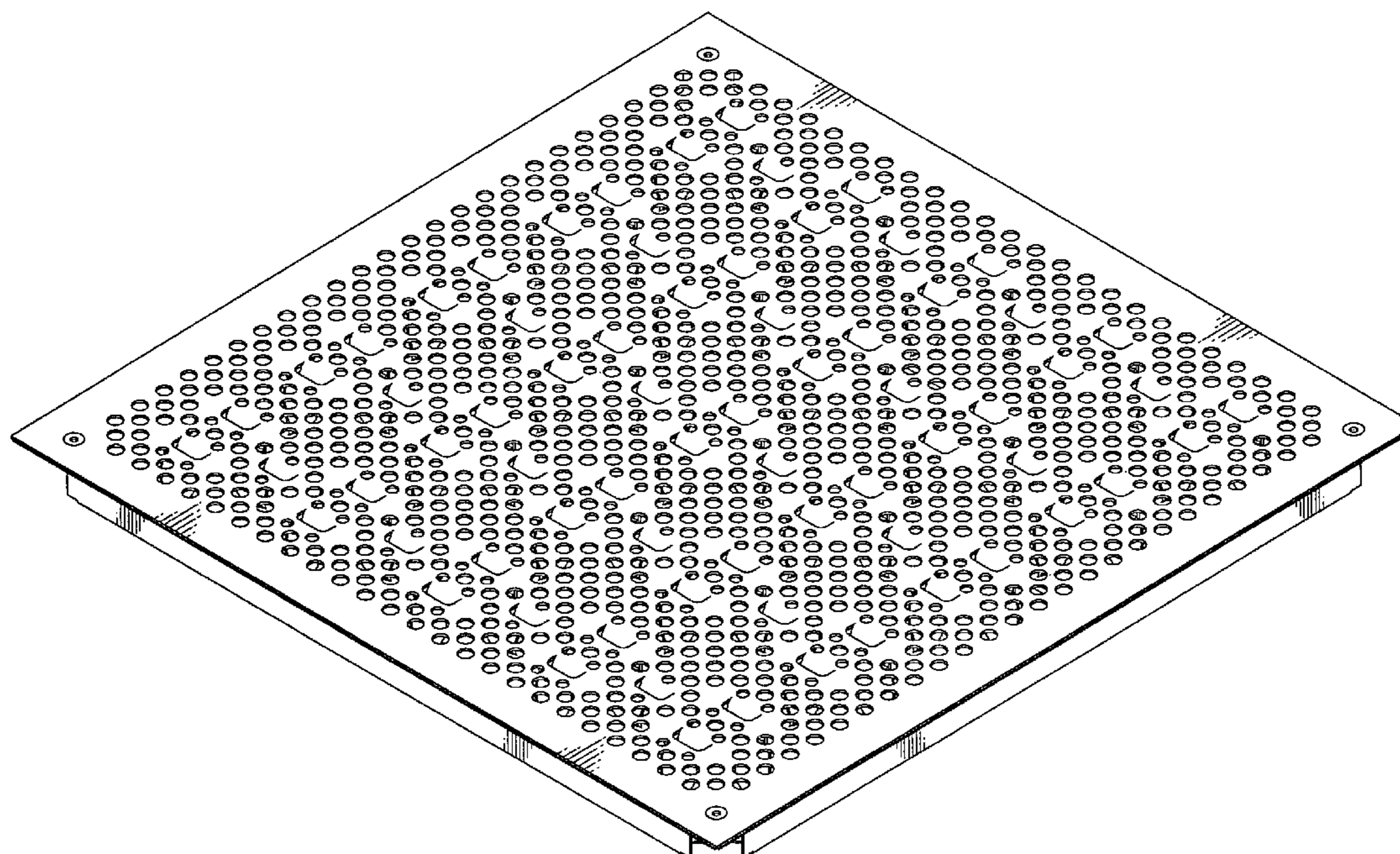
(57) **CLAIM**

The ornamental design for an access floor panel, as shown and
described.

DESCRIPTION

FIG. 1 is a top perspective view of an access floor panel showing our new design;
 FIG. 2 is a front view thereof, the rear view being a mirror image of the front view;
 FIG. 3 is a top view thereof;
 FIG. 4 is a right-side view thereof, the left-side view being a mirror image of the right-side view;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a bottom perspective view thereof;
 FIG. 7 is a partial cross-sectional view thereof taken along lines 7-7 in FIG. 3;
 FIG. 8 is a top perspective view of a second embodiment of the access floor panel shown in FIG. 1;
 FIG. 9 is a front view thereof, the rear view being a mirror image of the front view;
 FIG. 10 is a top view thereof;
 FIG. 11 is a right-side view thereof, the left-side view being a mirror image of the right-side view;
 FIG. 12 is a bottom view thereof;
 FIG. 13 is a bottom perspective view thereof; and,
 FIG. 14 is a partial cross-sectional view thereof taken along lines 14-14 in FIG. 10.

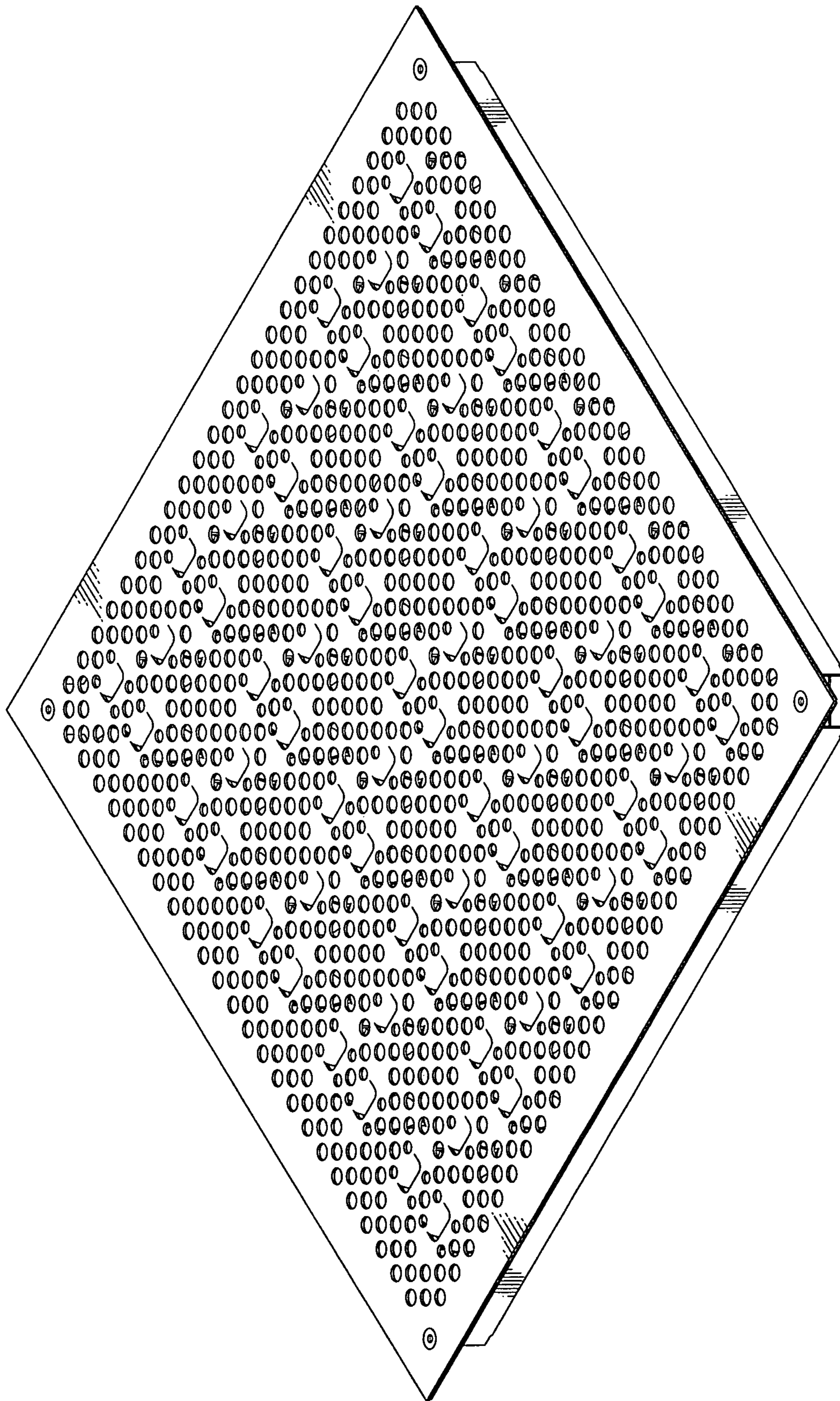

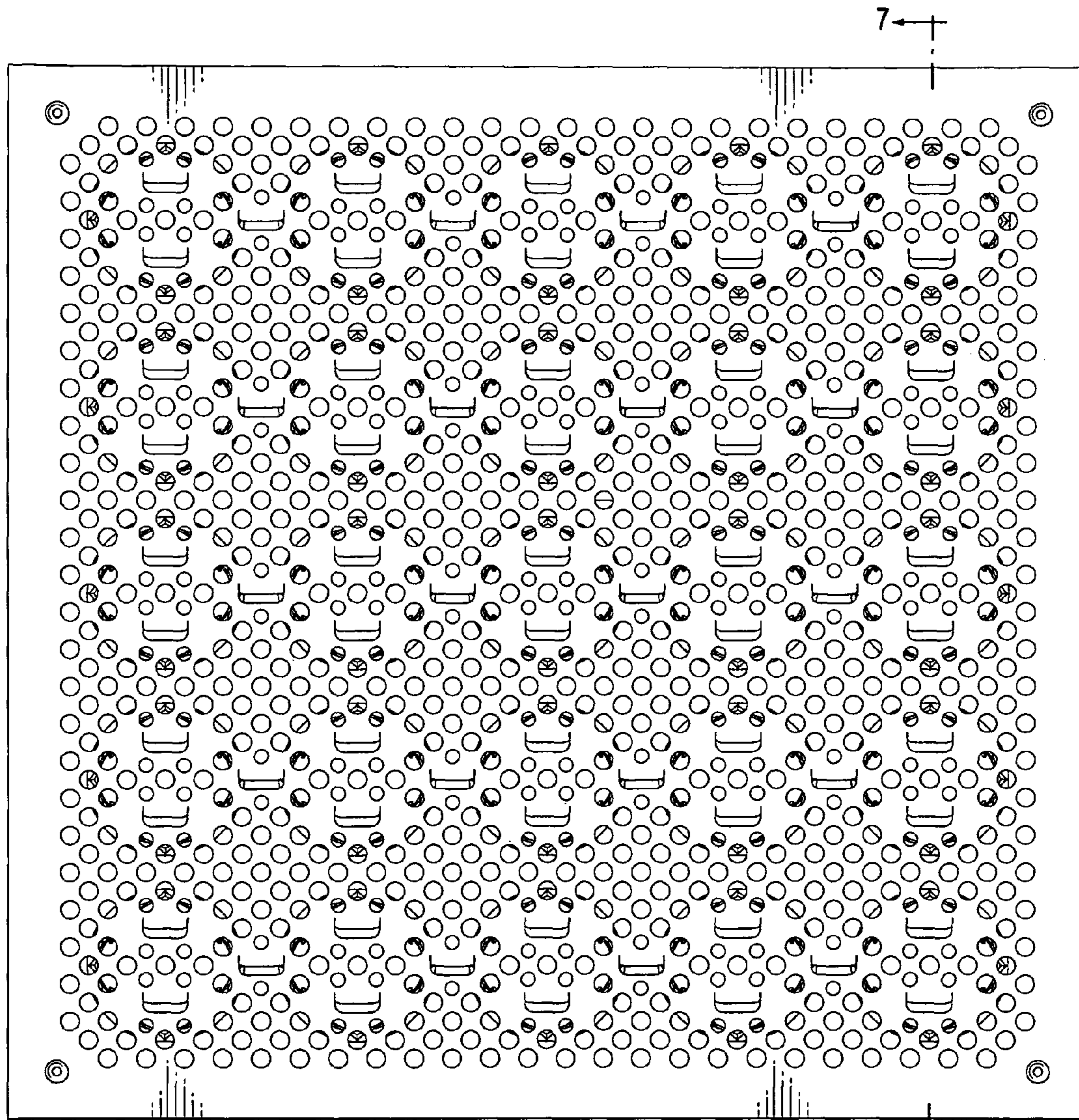

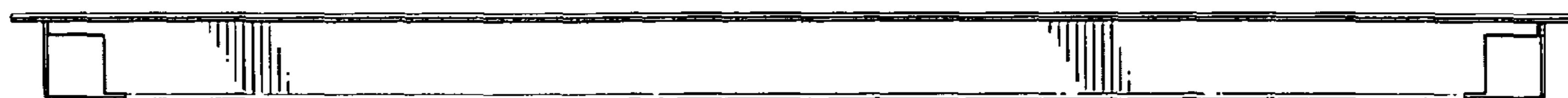

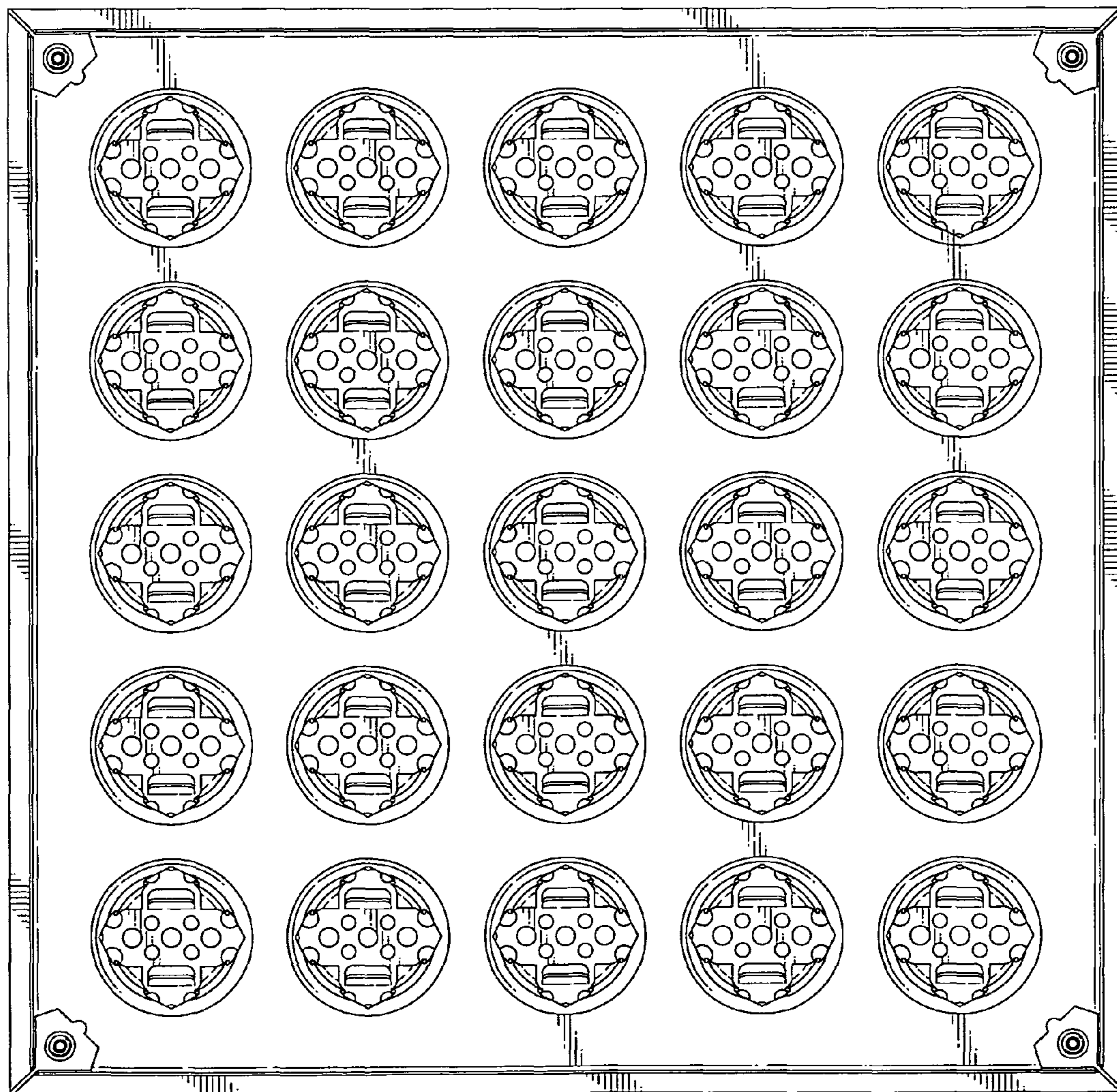

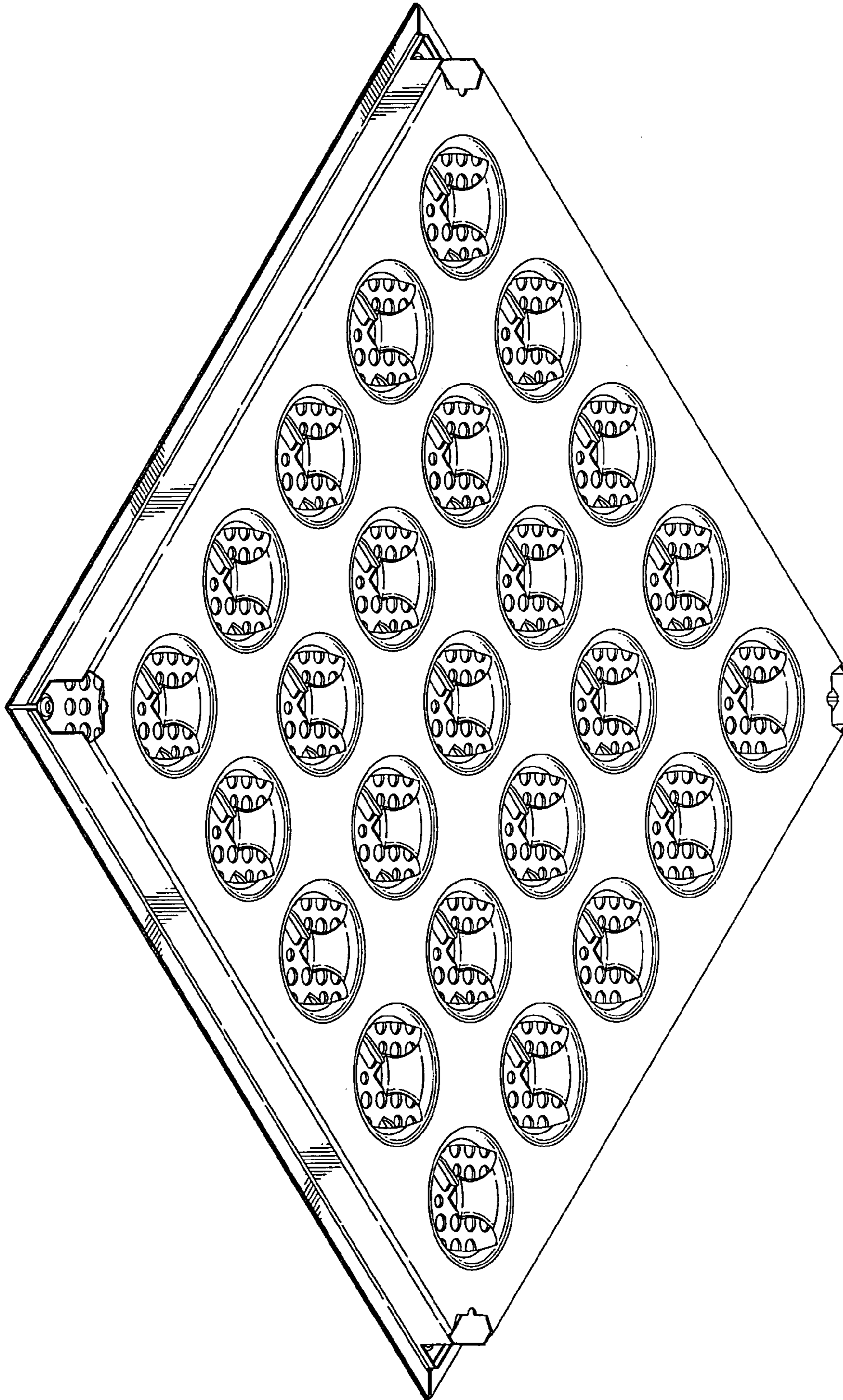

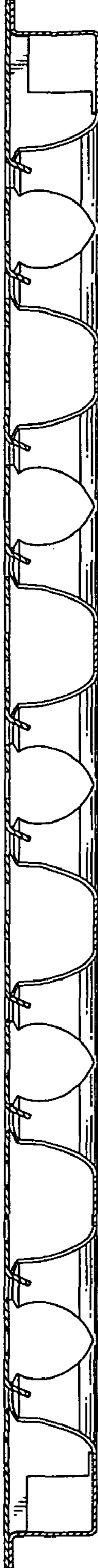

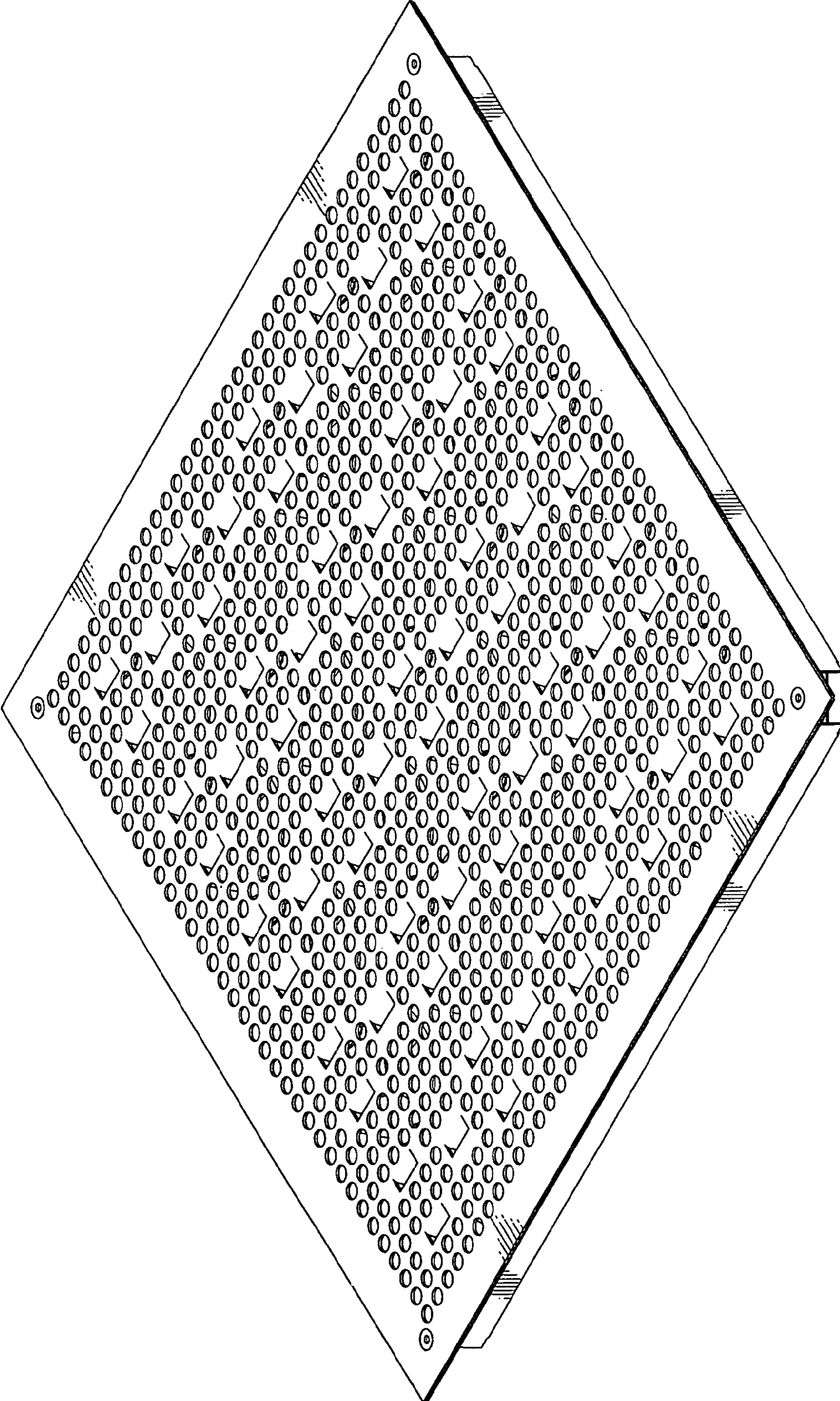

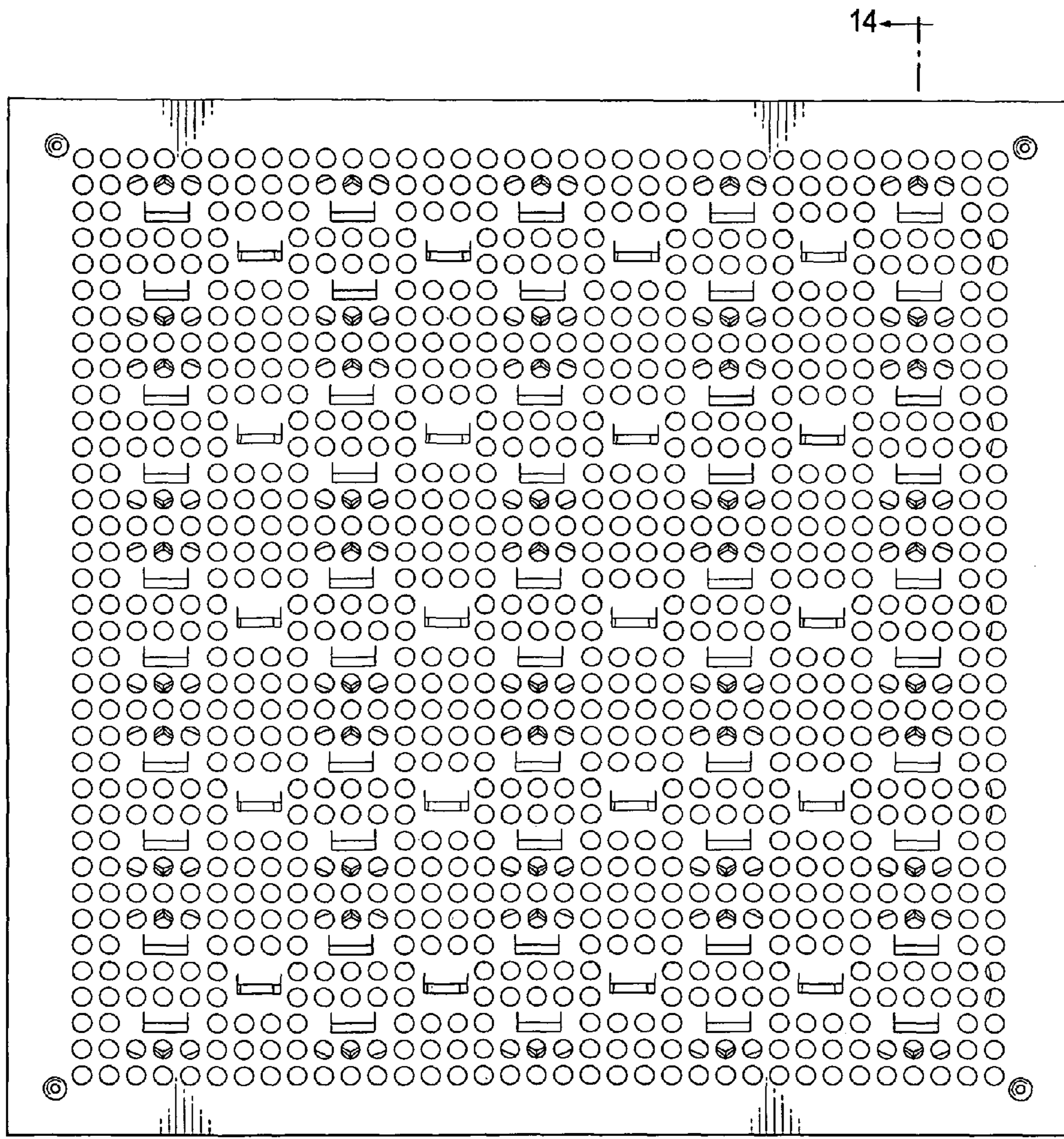

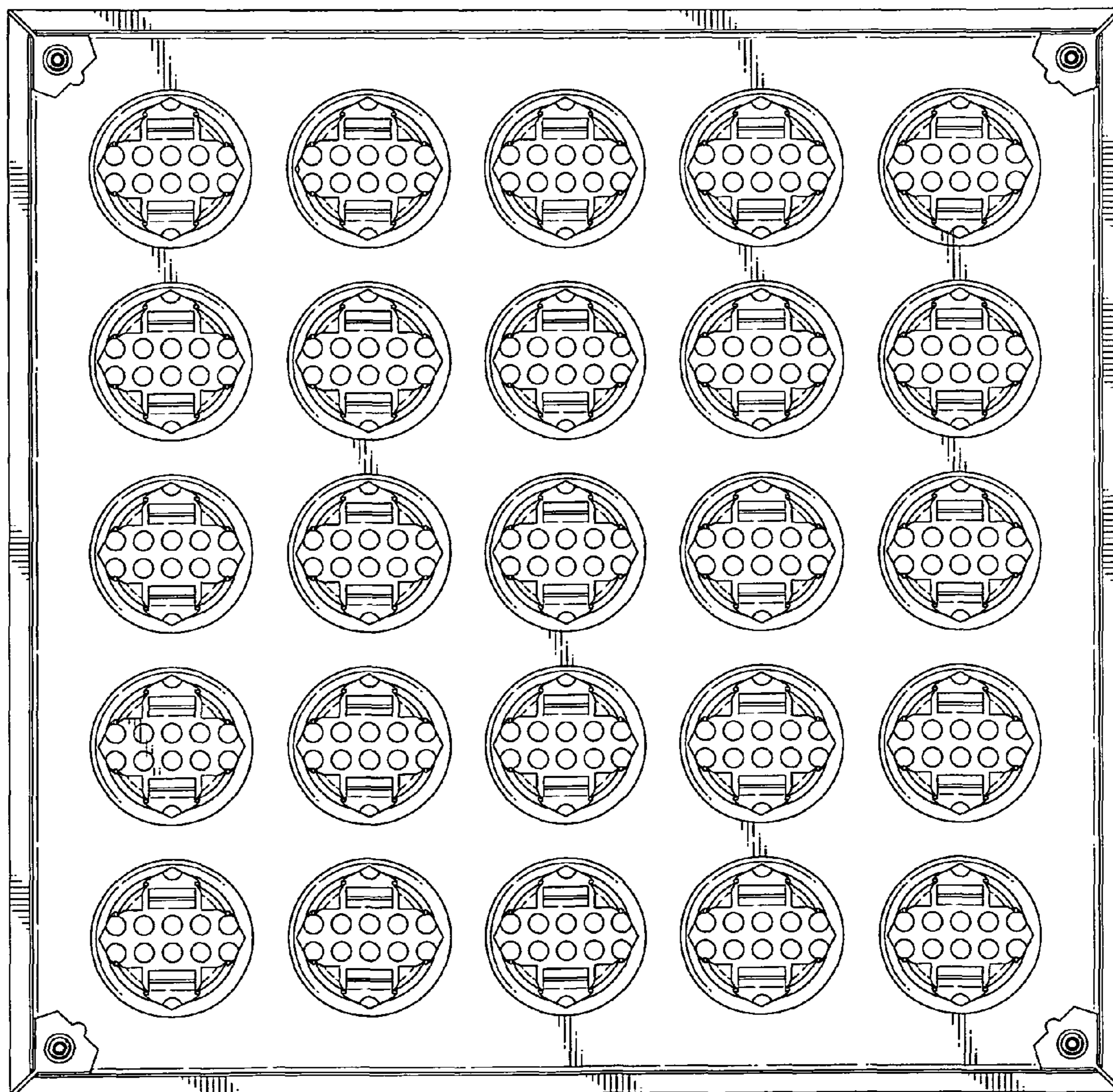

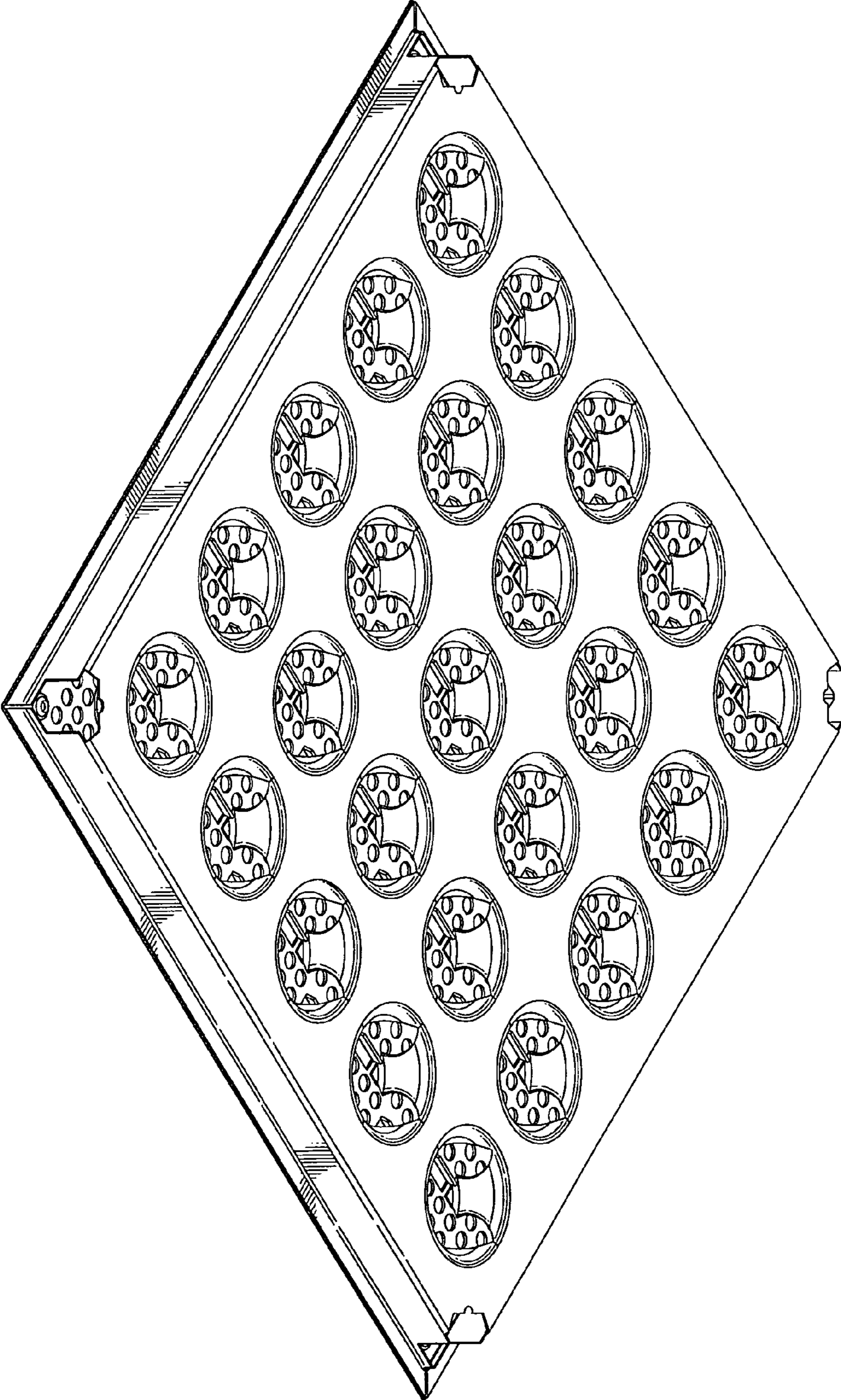

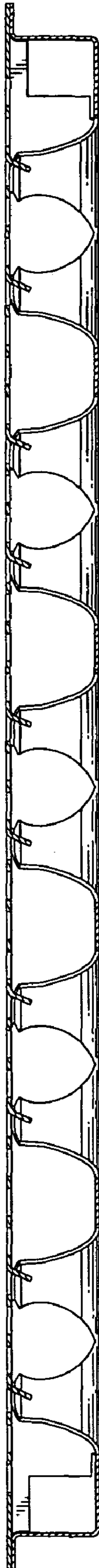
