(57) **CLAIM**

We claim the ornamental design for a recycling storage container, as shown and described.

DESCRIPTION

FIG. 1 is a front view showing an embodiment of our new design for recycling storage container;

FIG. 2 is a perspective view showing our new design shown in FIG. 1;

FIG. 3 is a right side view showing our new design shown in FIG. 1, the left side view being identical;

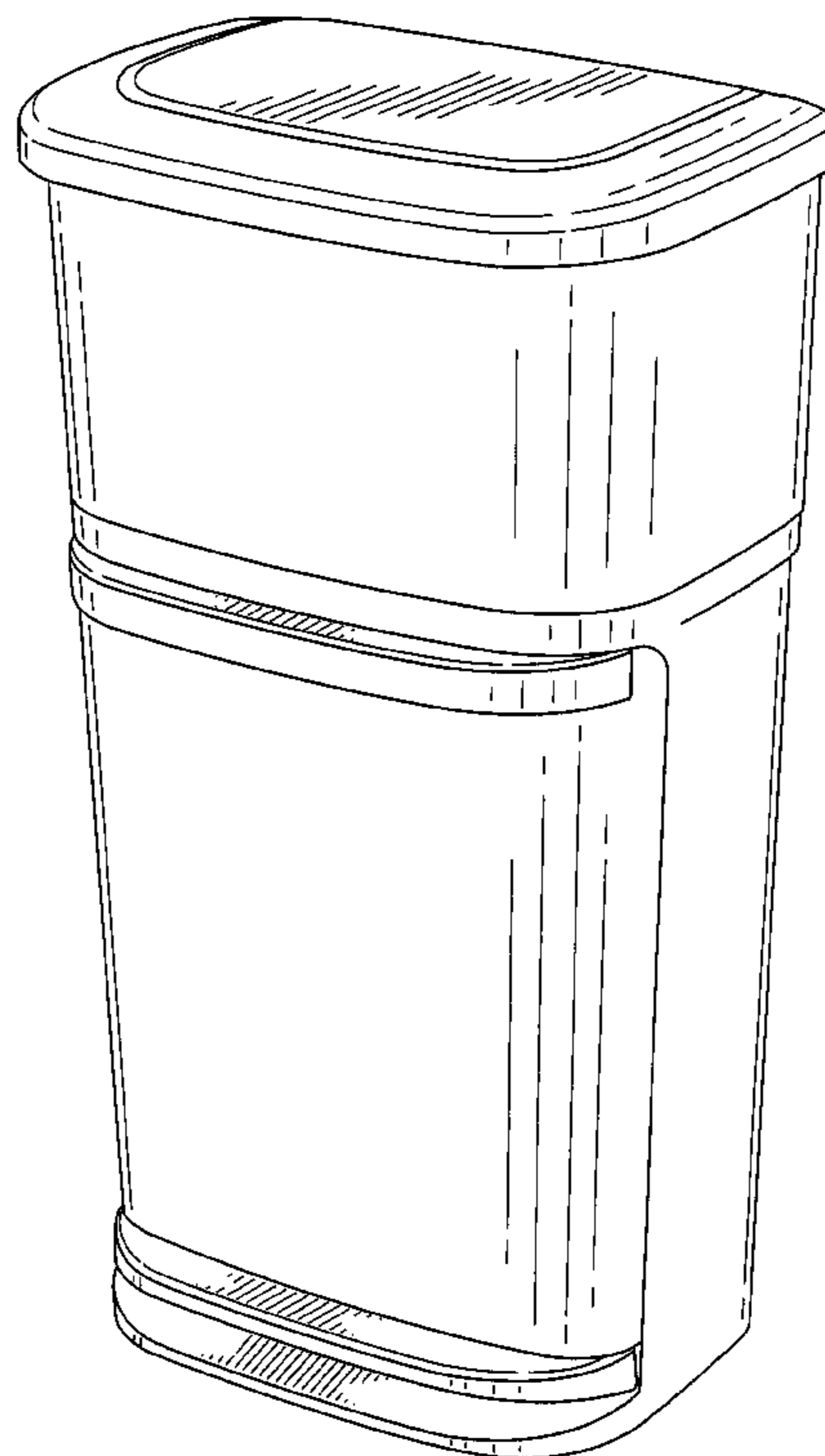
FIG. 4 is a back view showing our new design shown in FIG. 1;

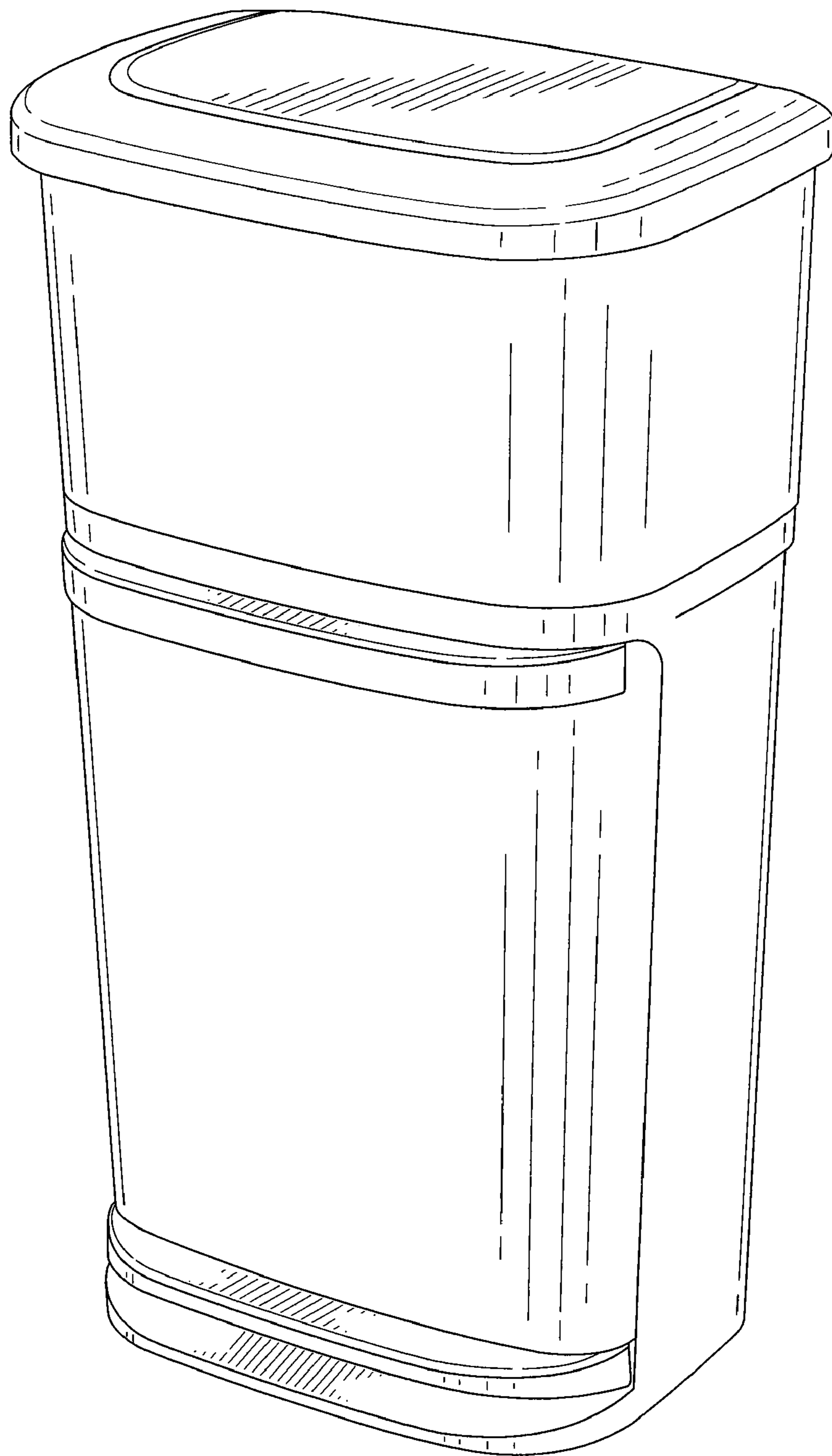

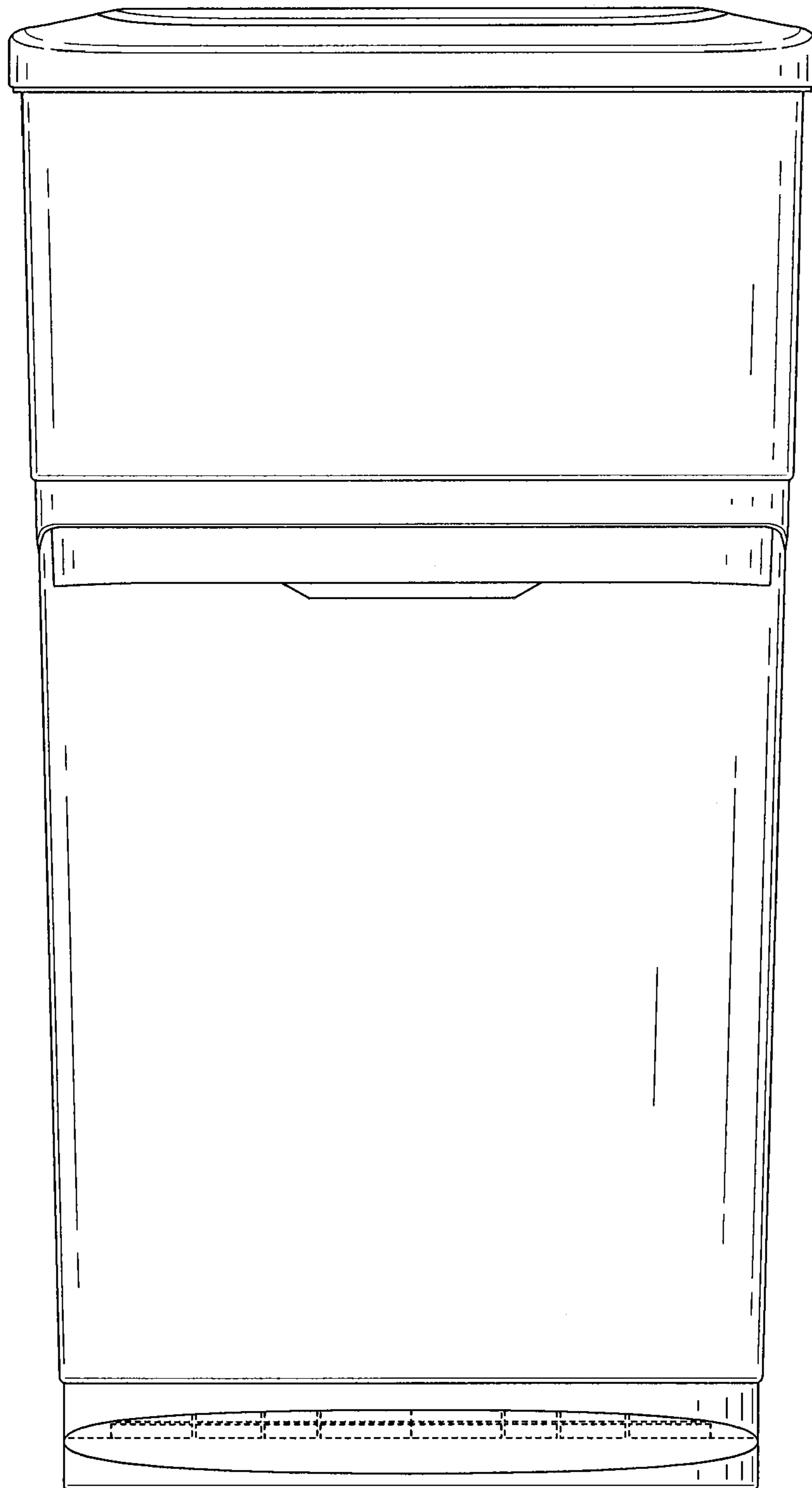

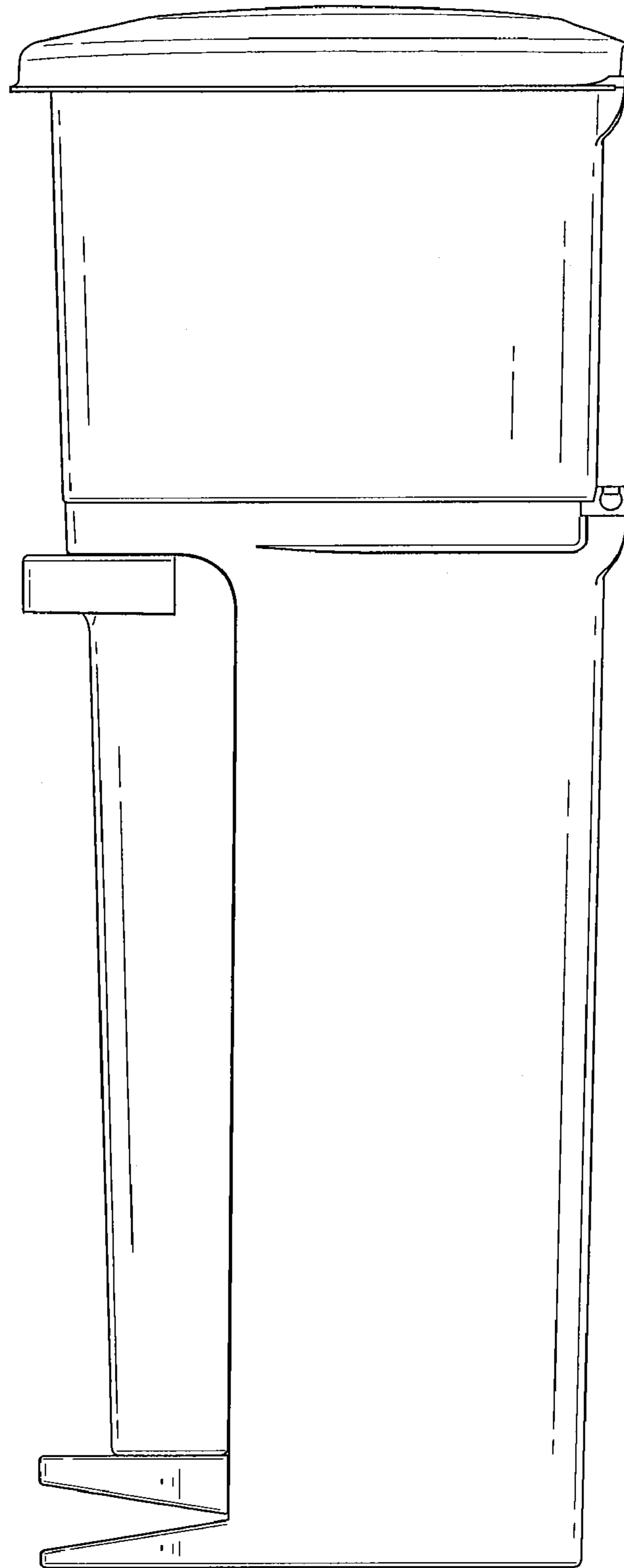

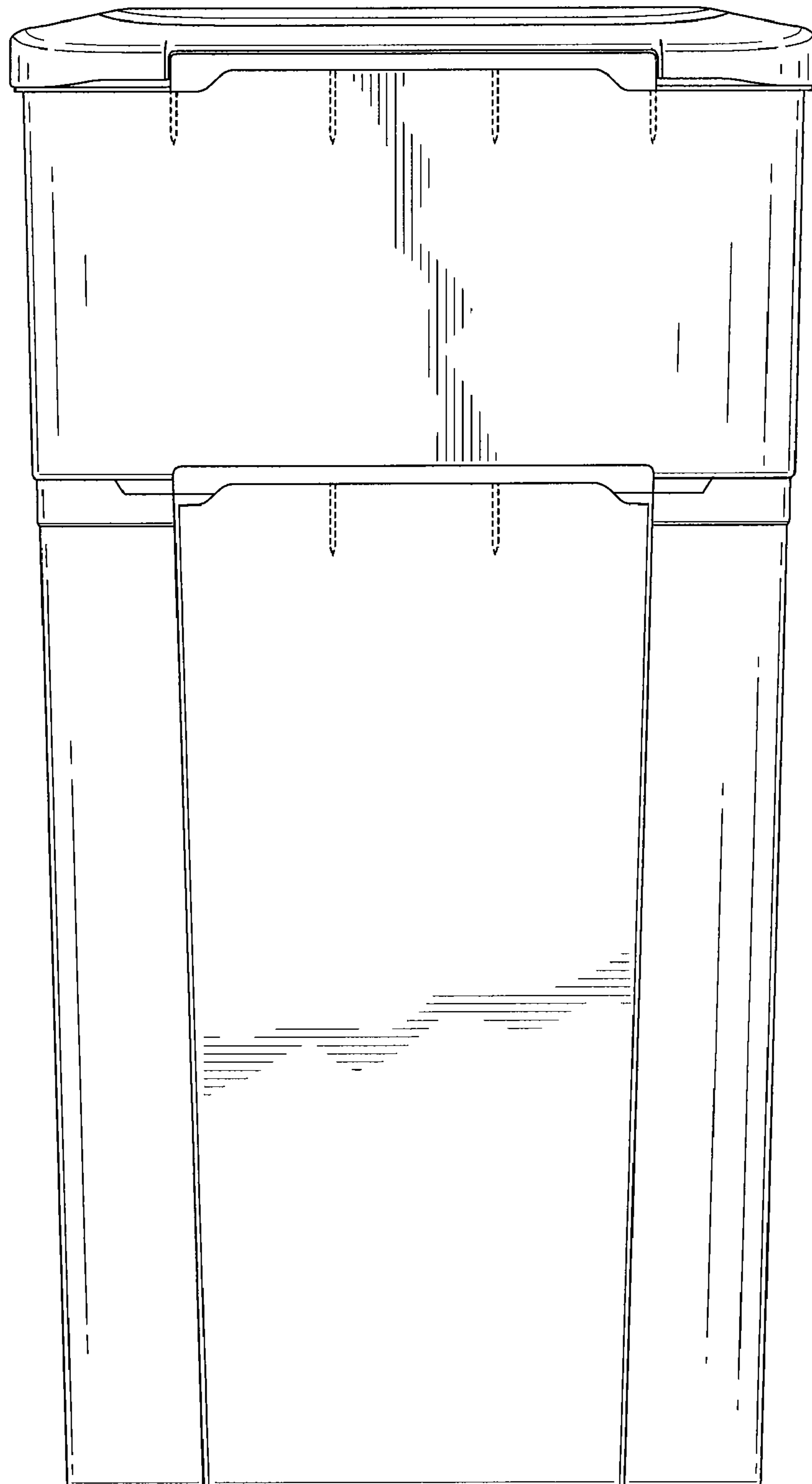

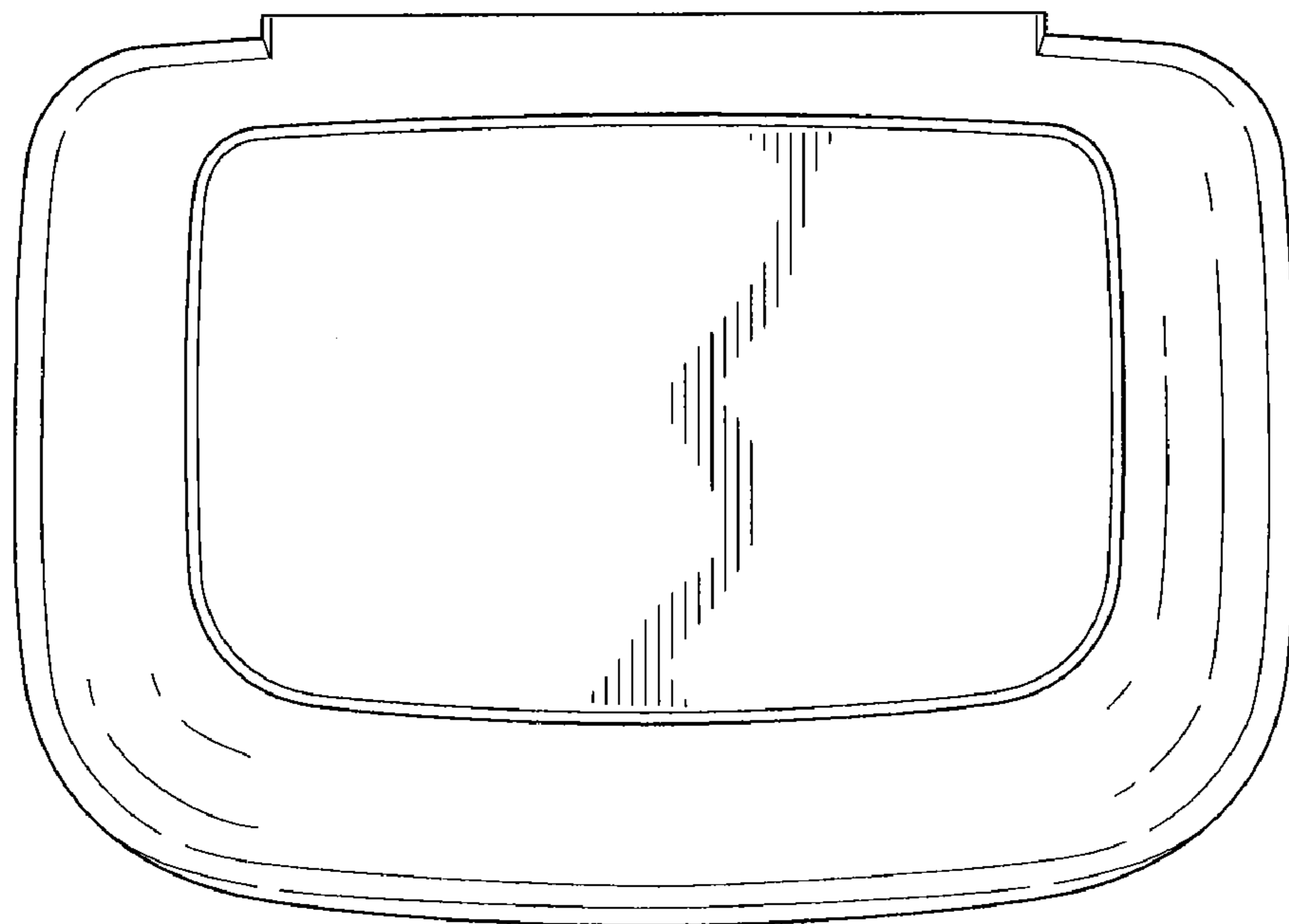

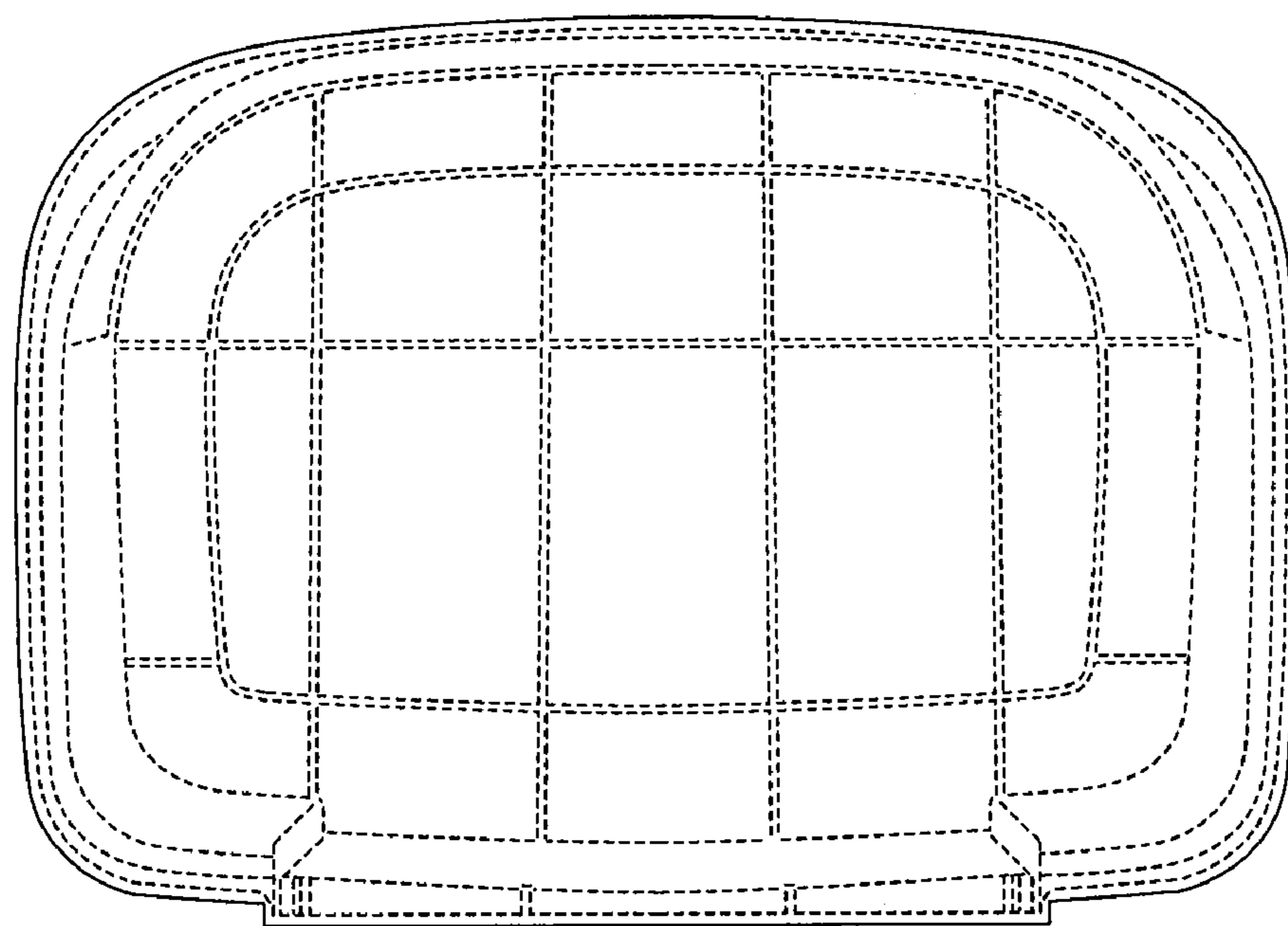
