(57) **CLAIM**

I claim the ornamental design for a refrigerated wine barrel,
substantially as shown and described.

dance with the present design.

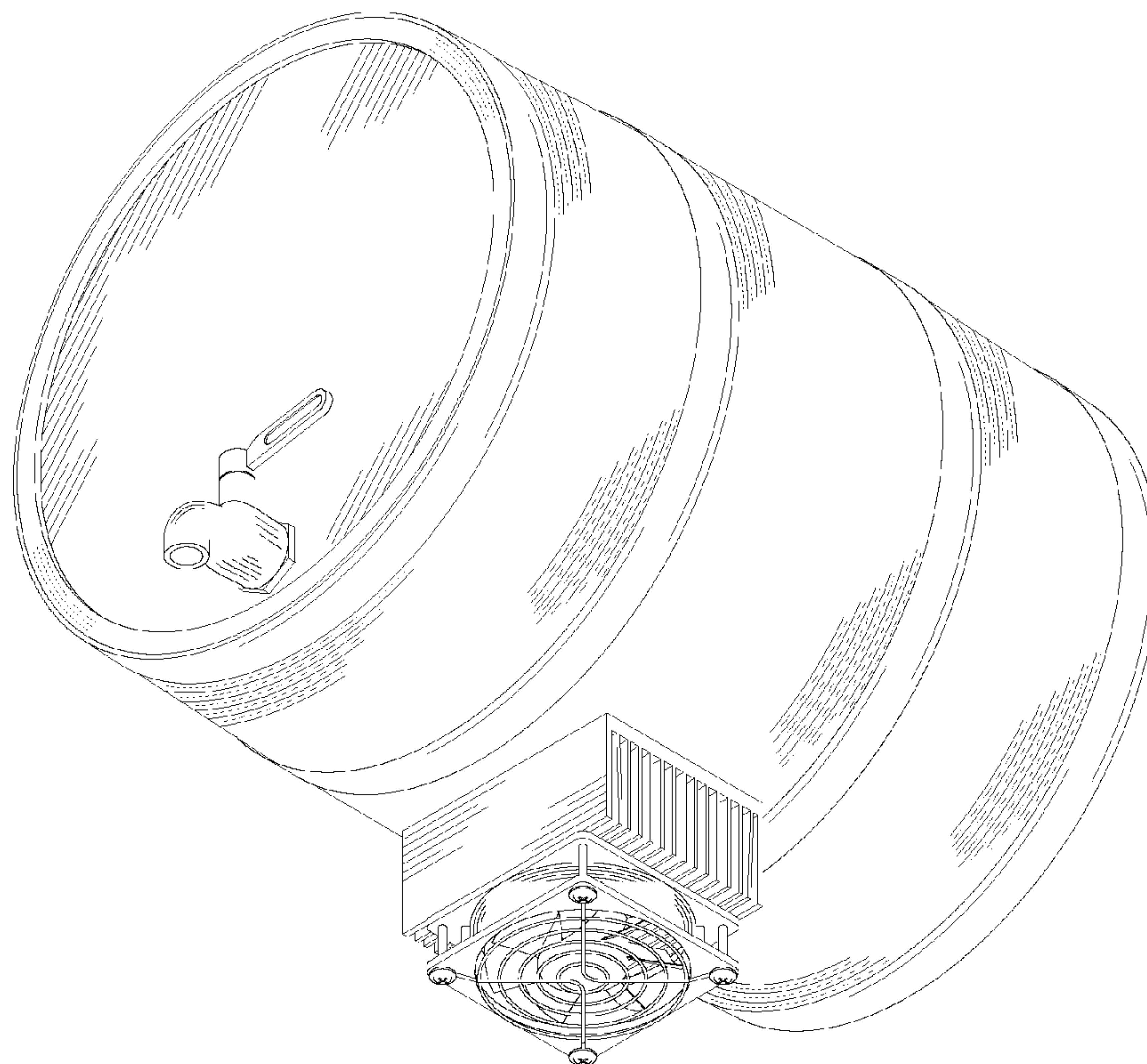
FIG. 4 is a left-side view of the refrigerated wine barrel in

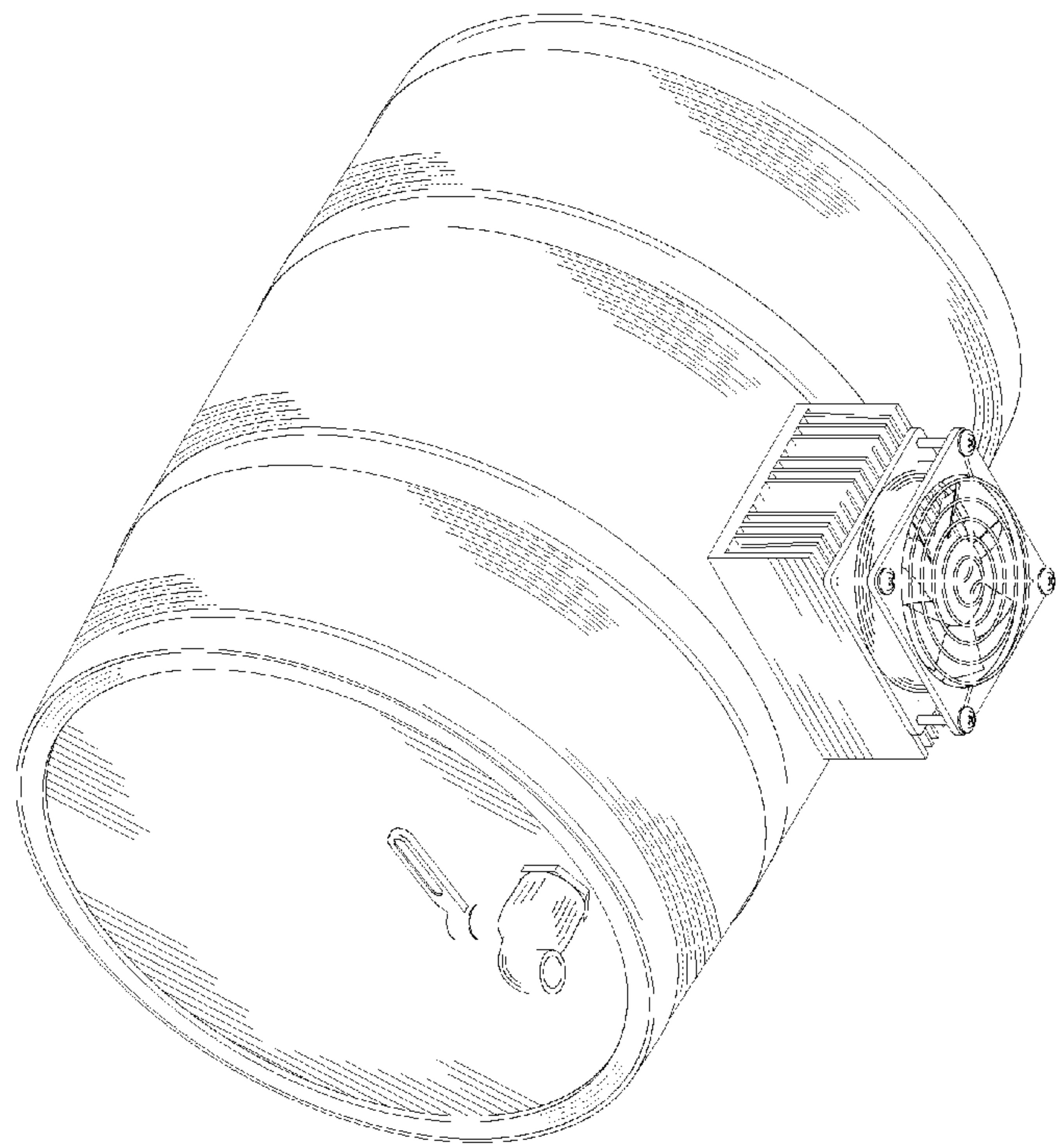

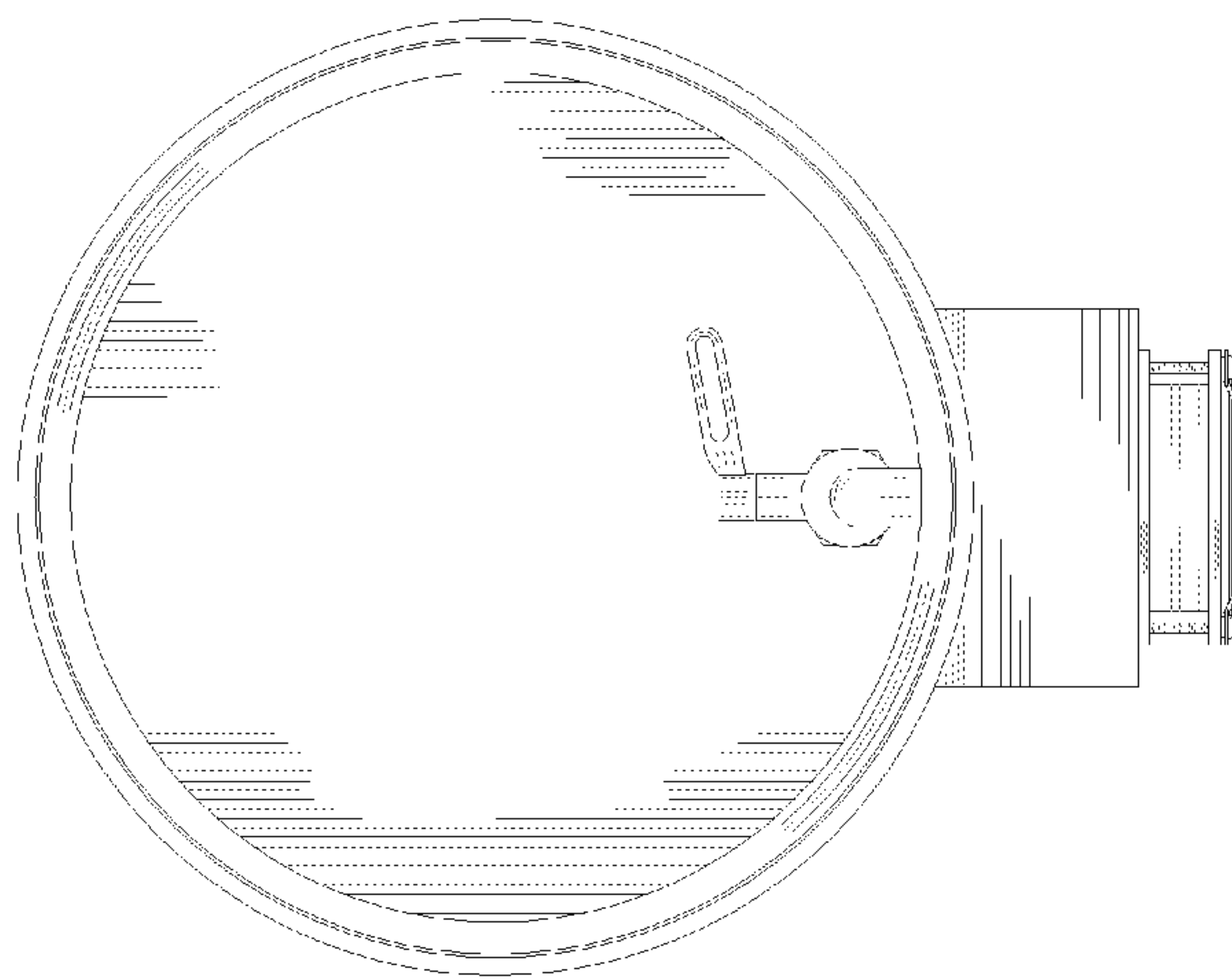

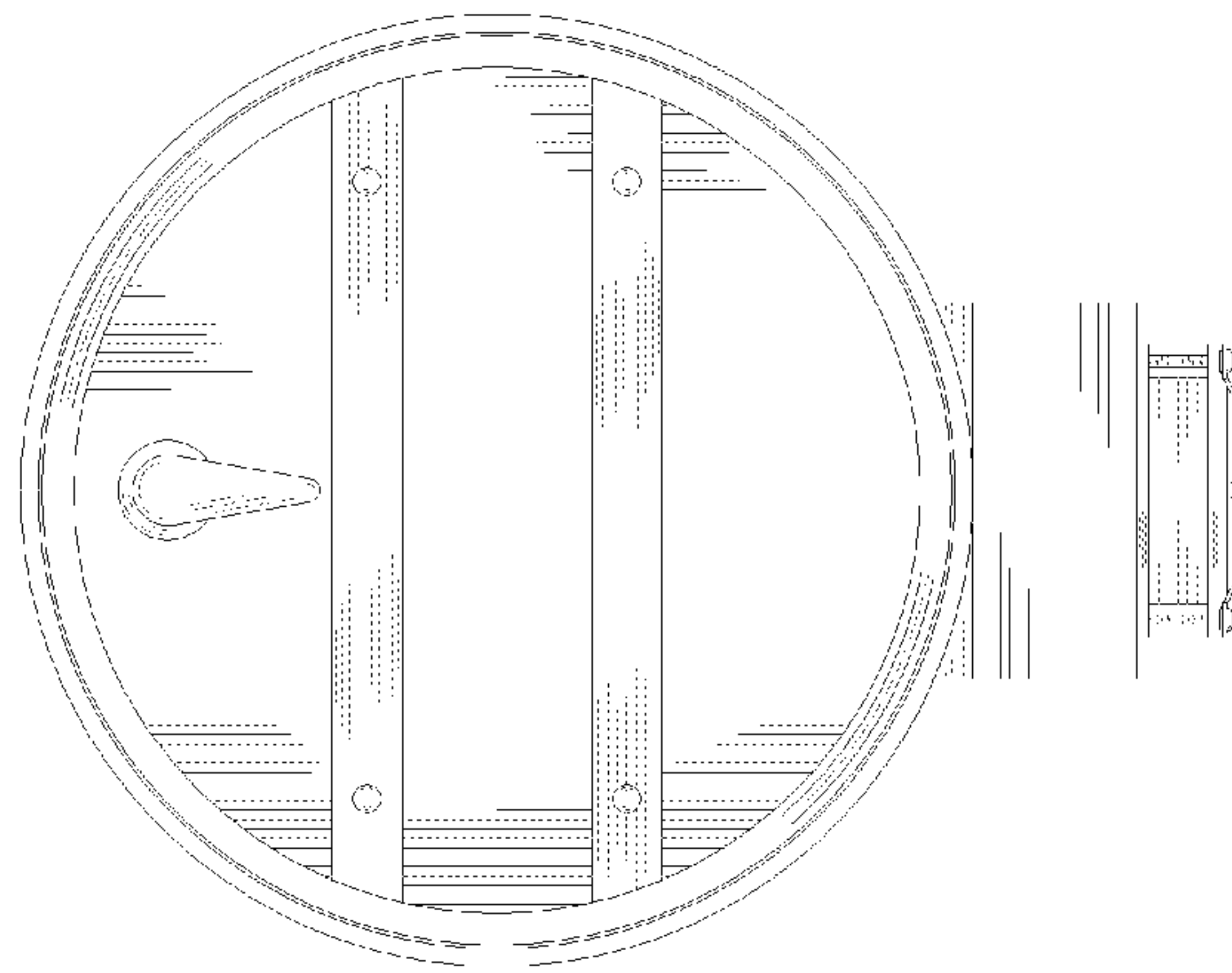

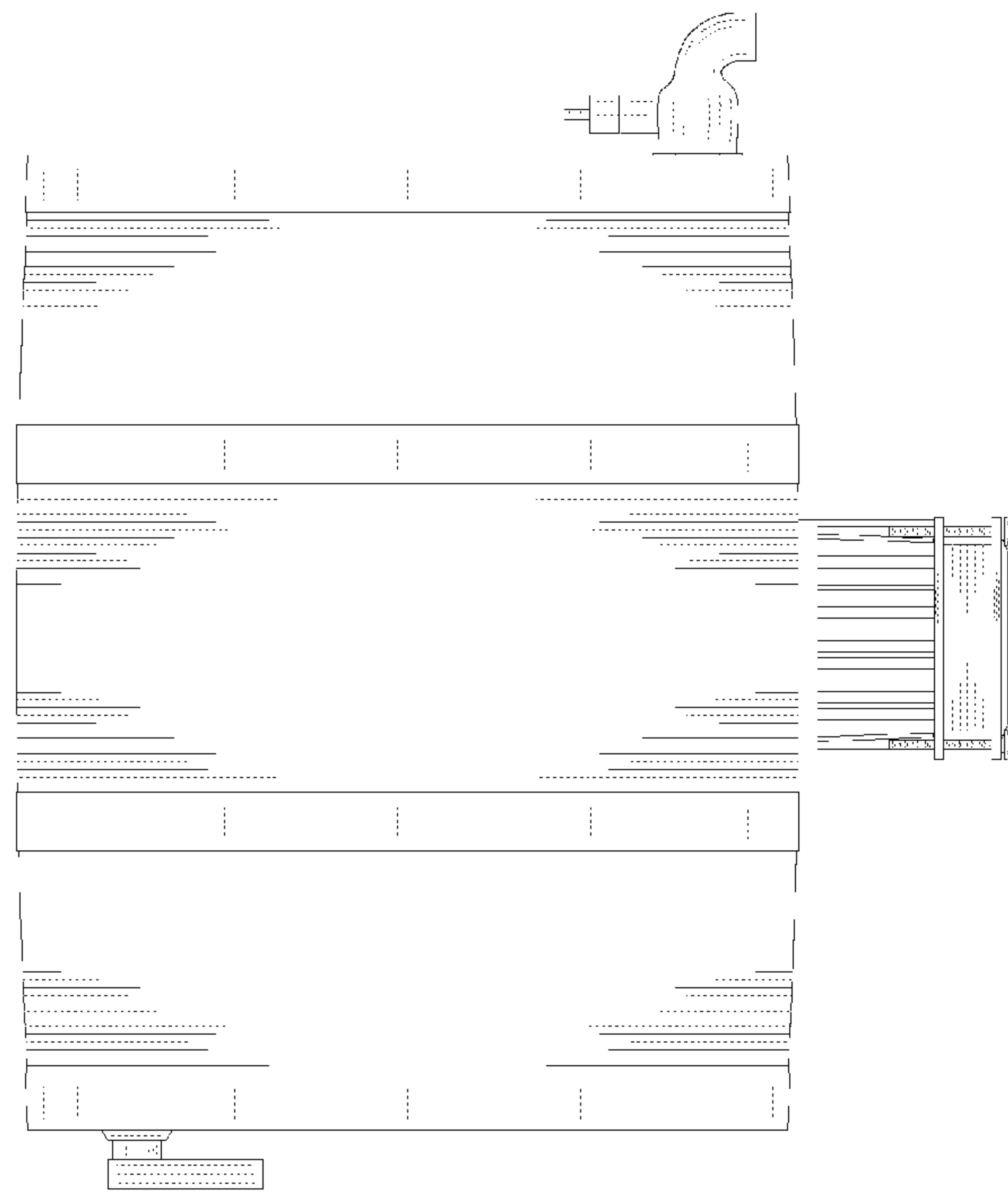

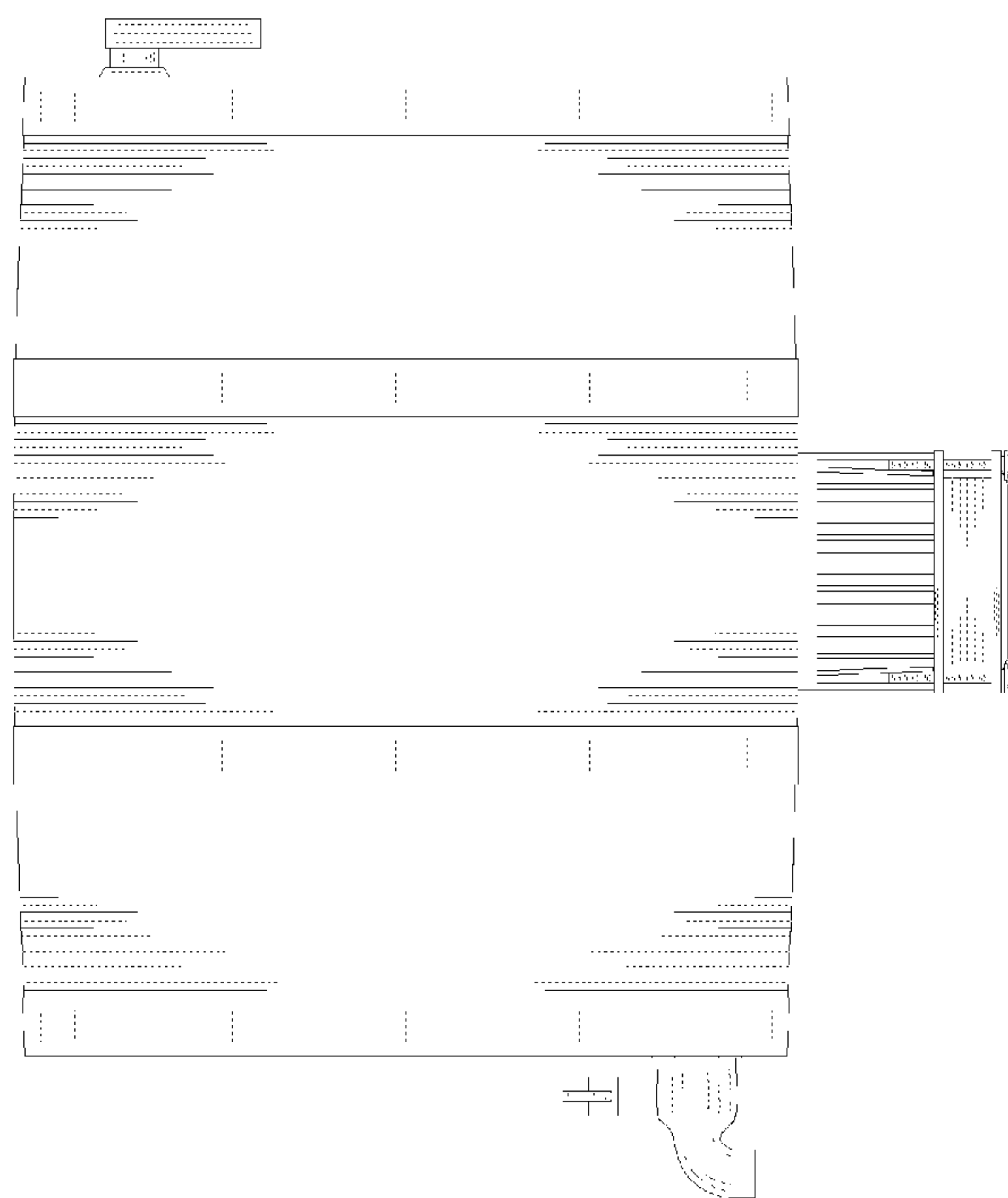

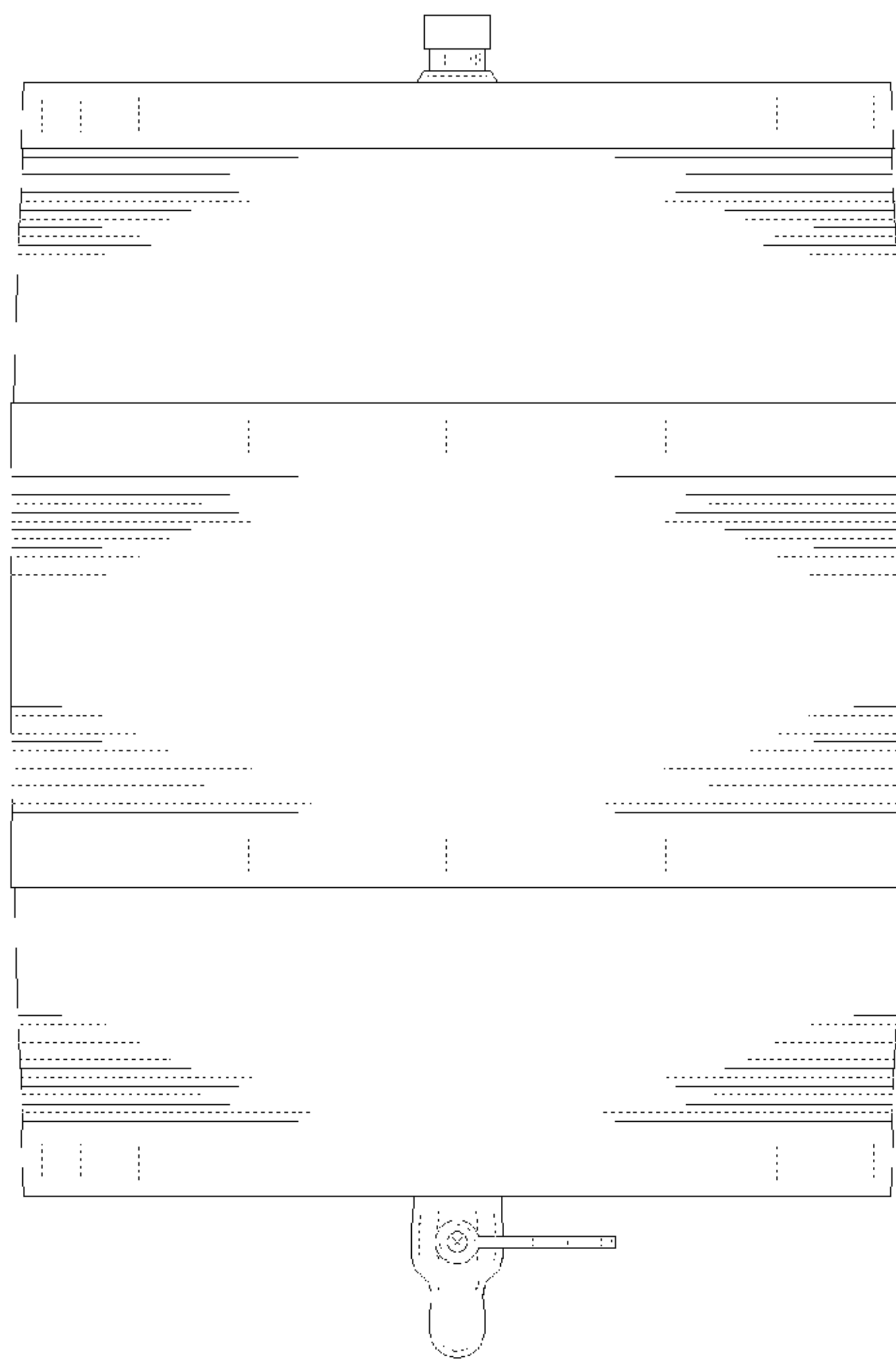

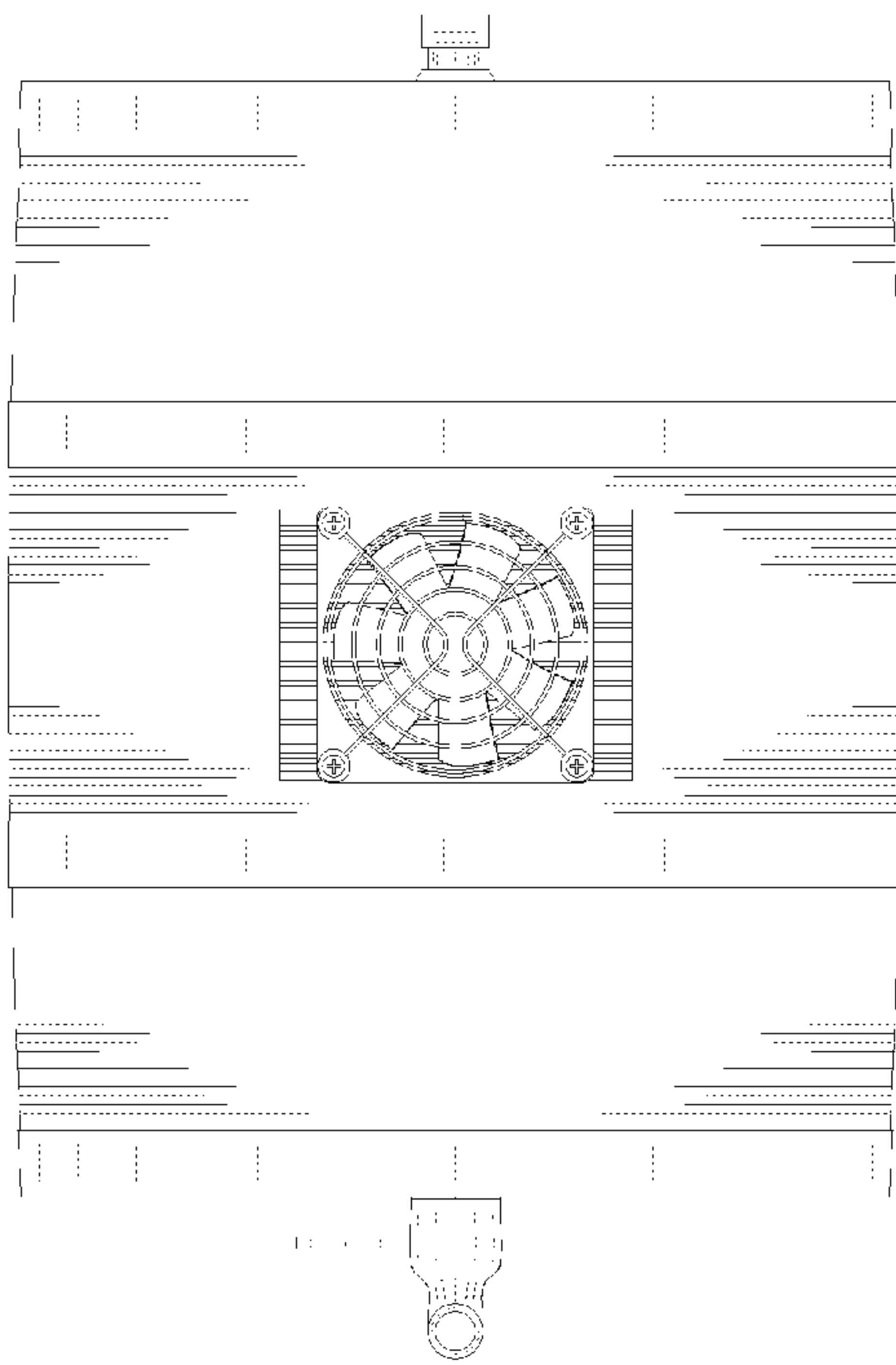
