(57) **CLAIM**

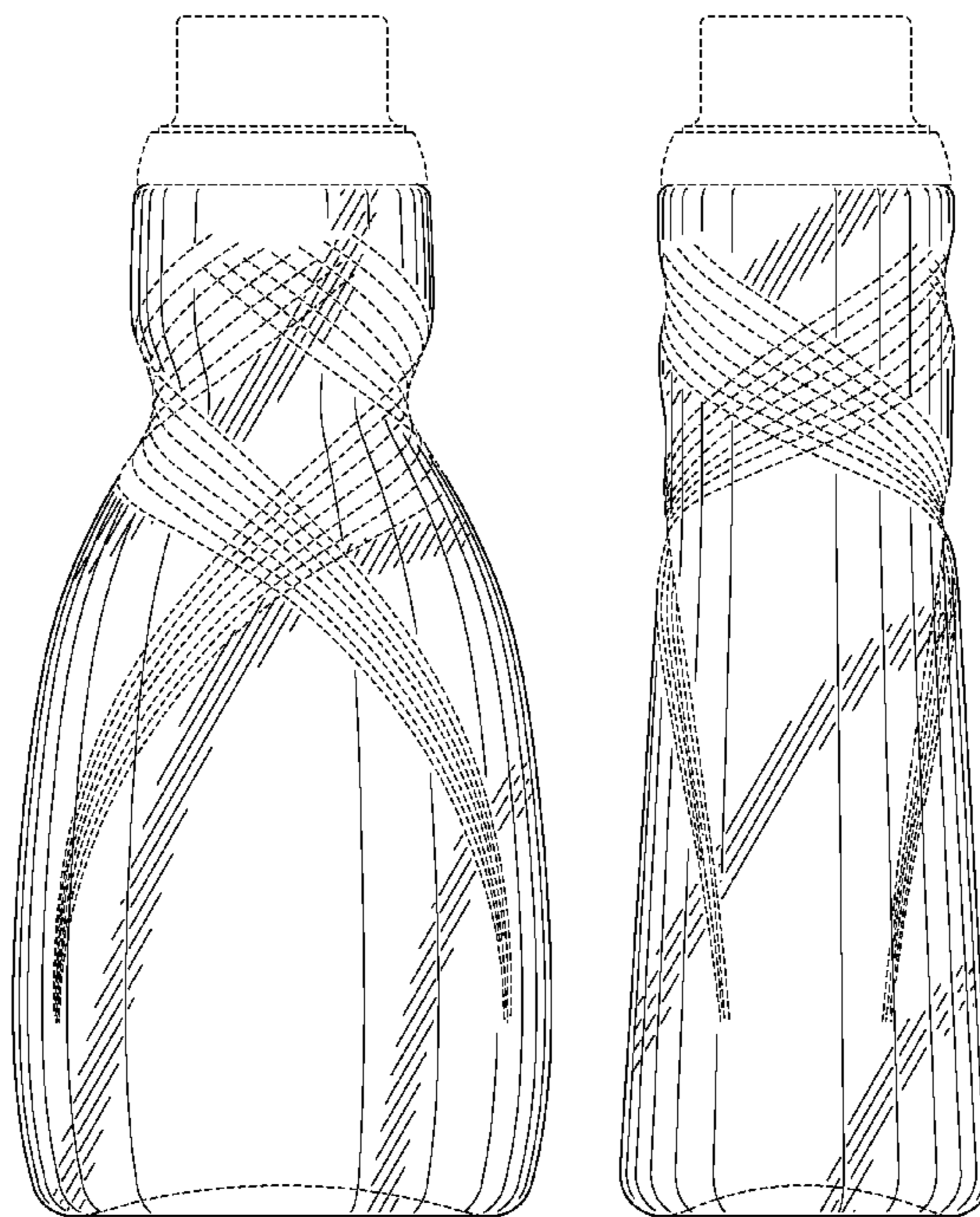
The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a container showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;

FIG. 5 is an opposite side view thereof;  
FIG. 6 is a bottom plan view thereof;

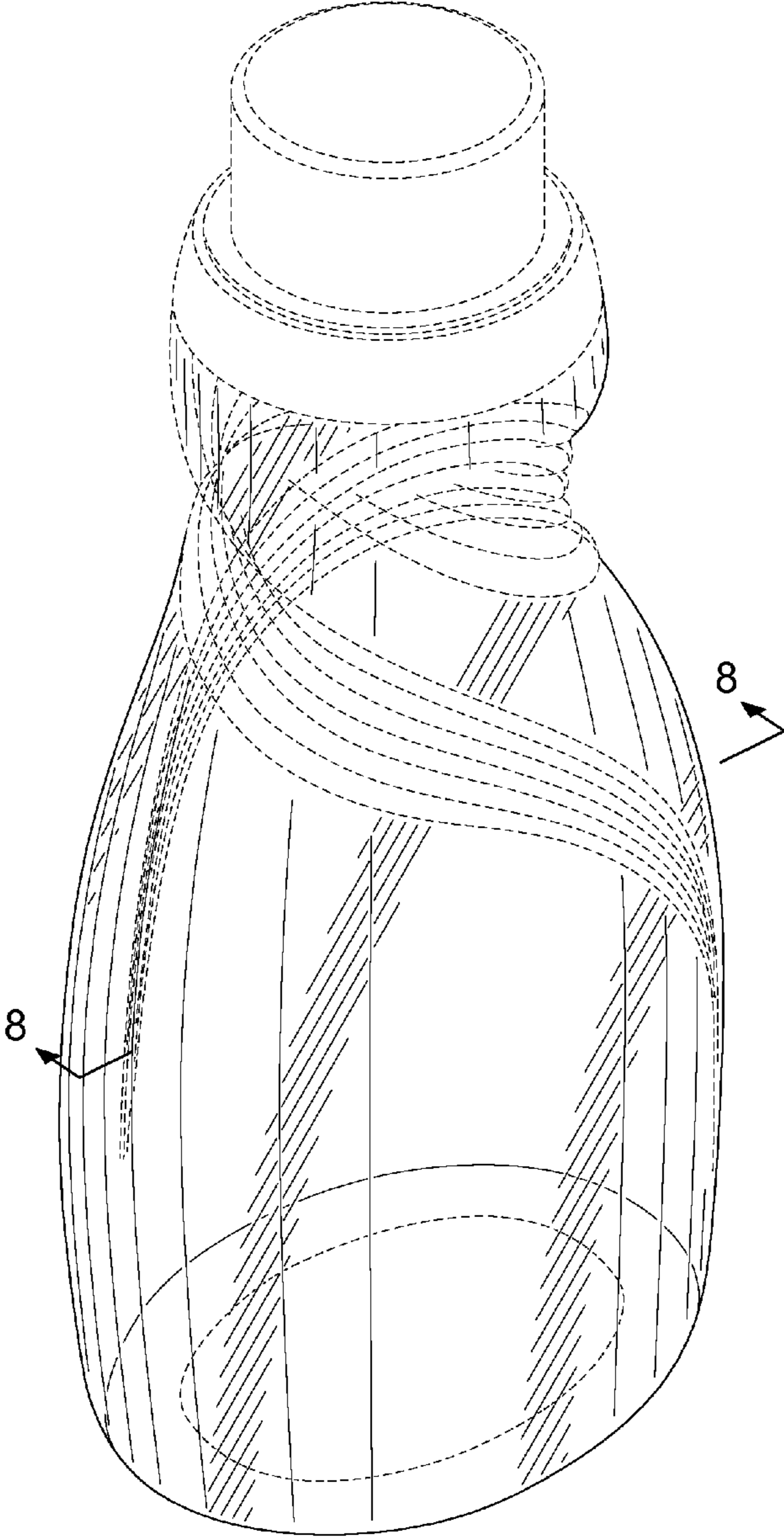

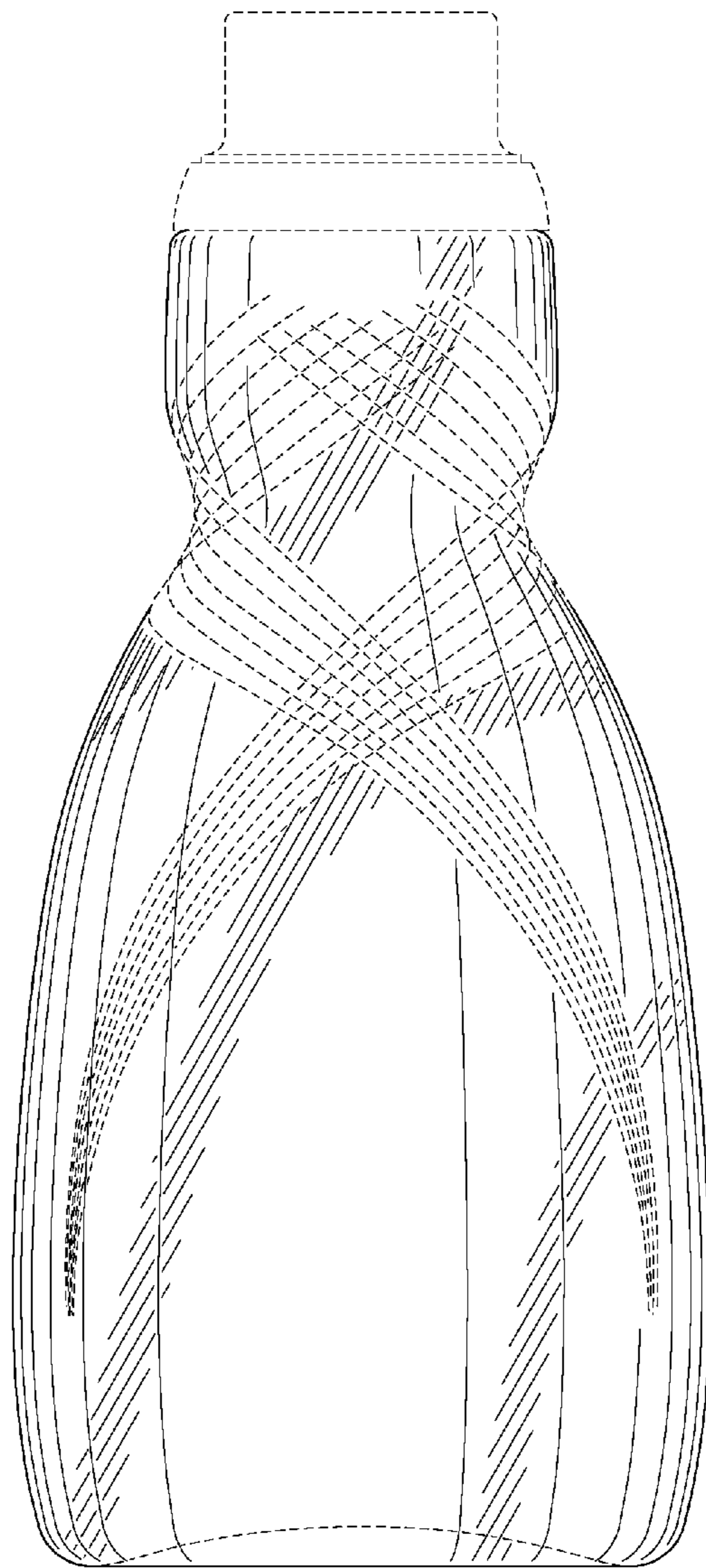

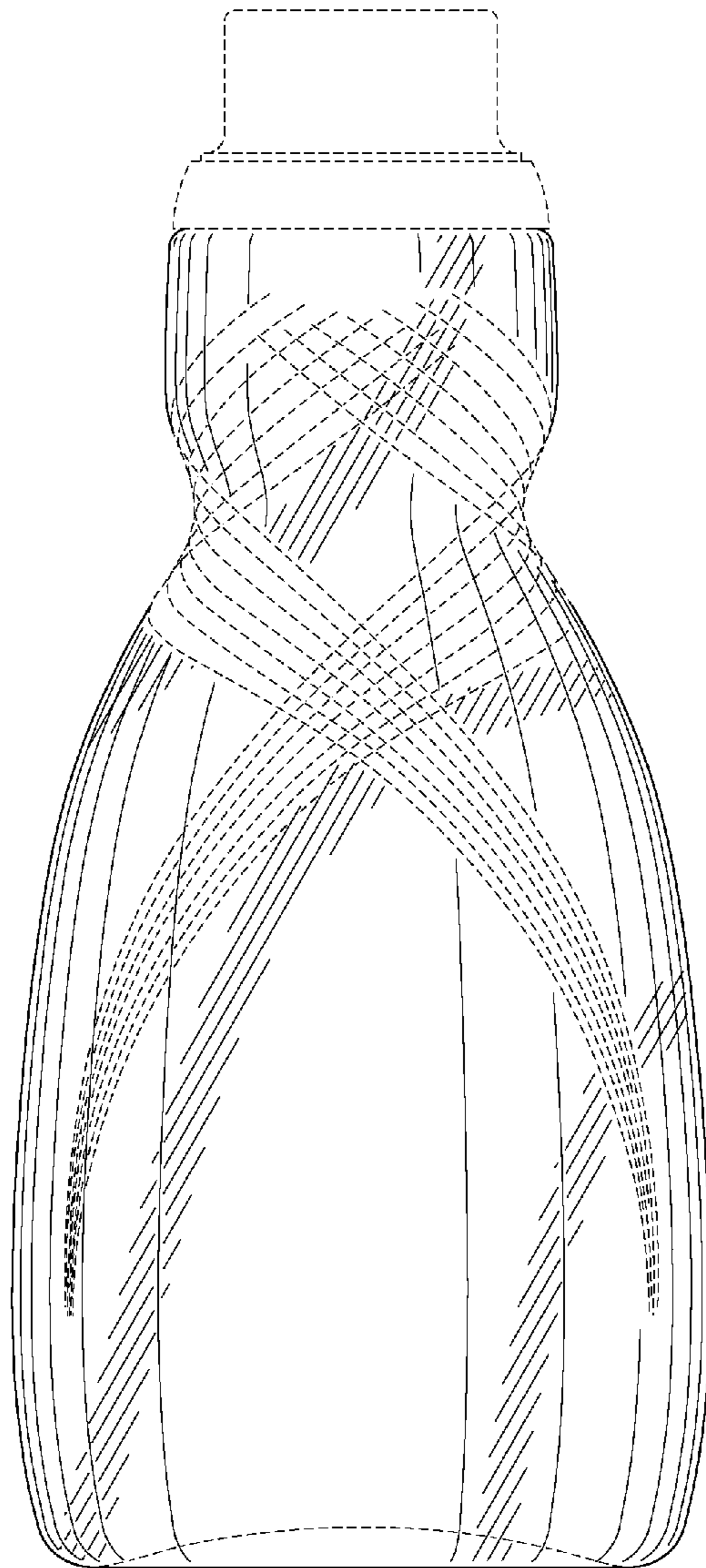

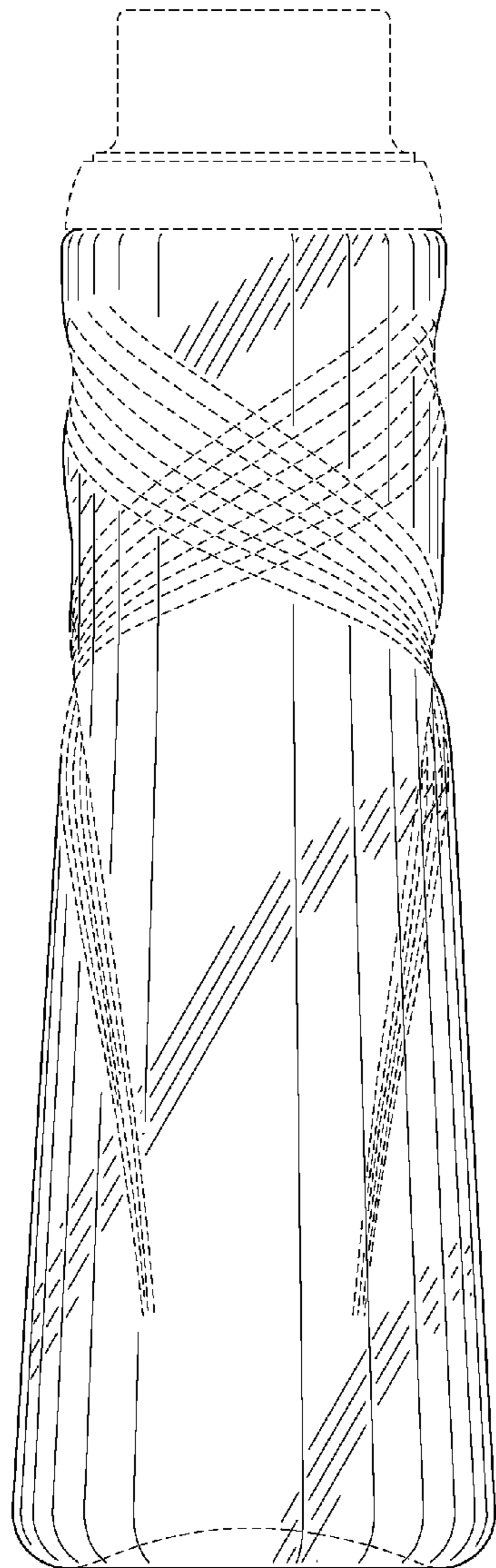

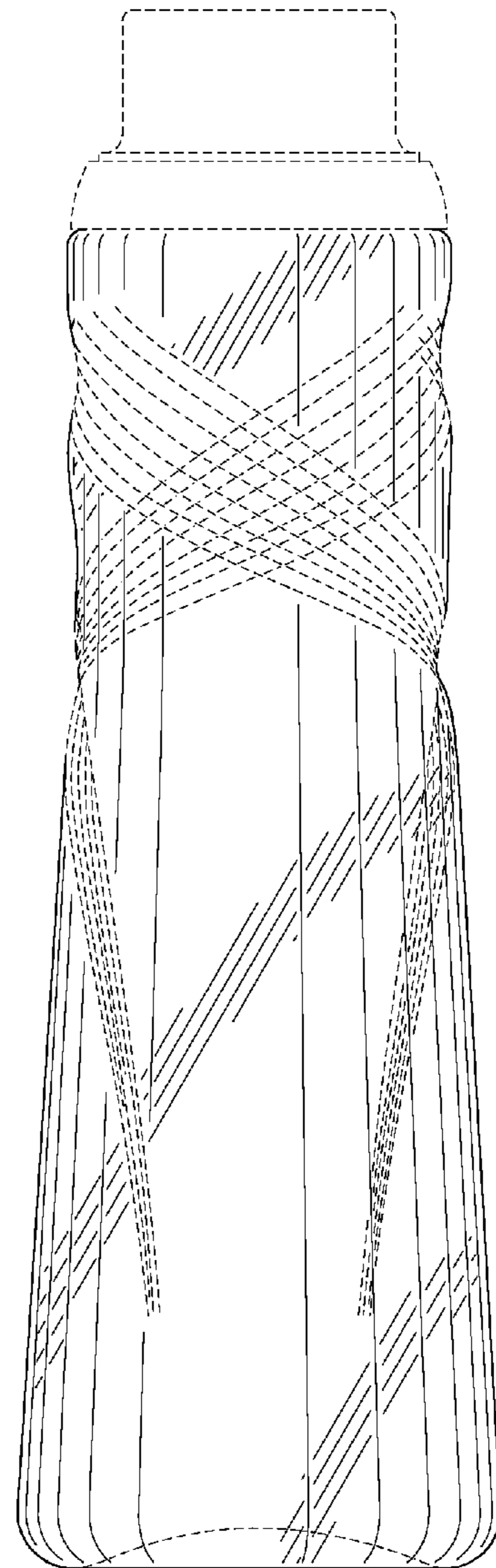

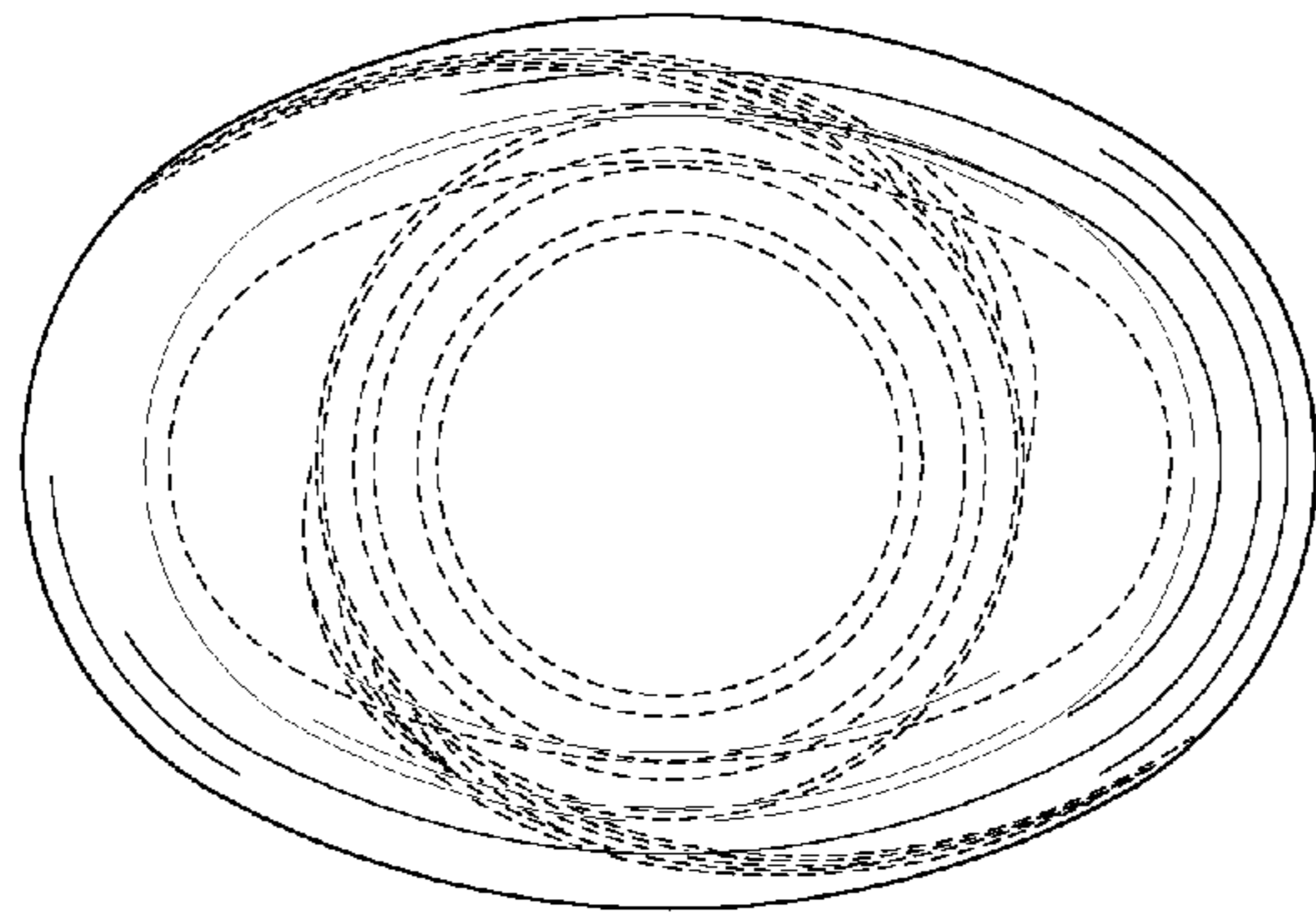

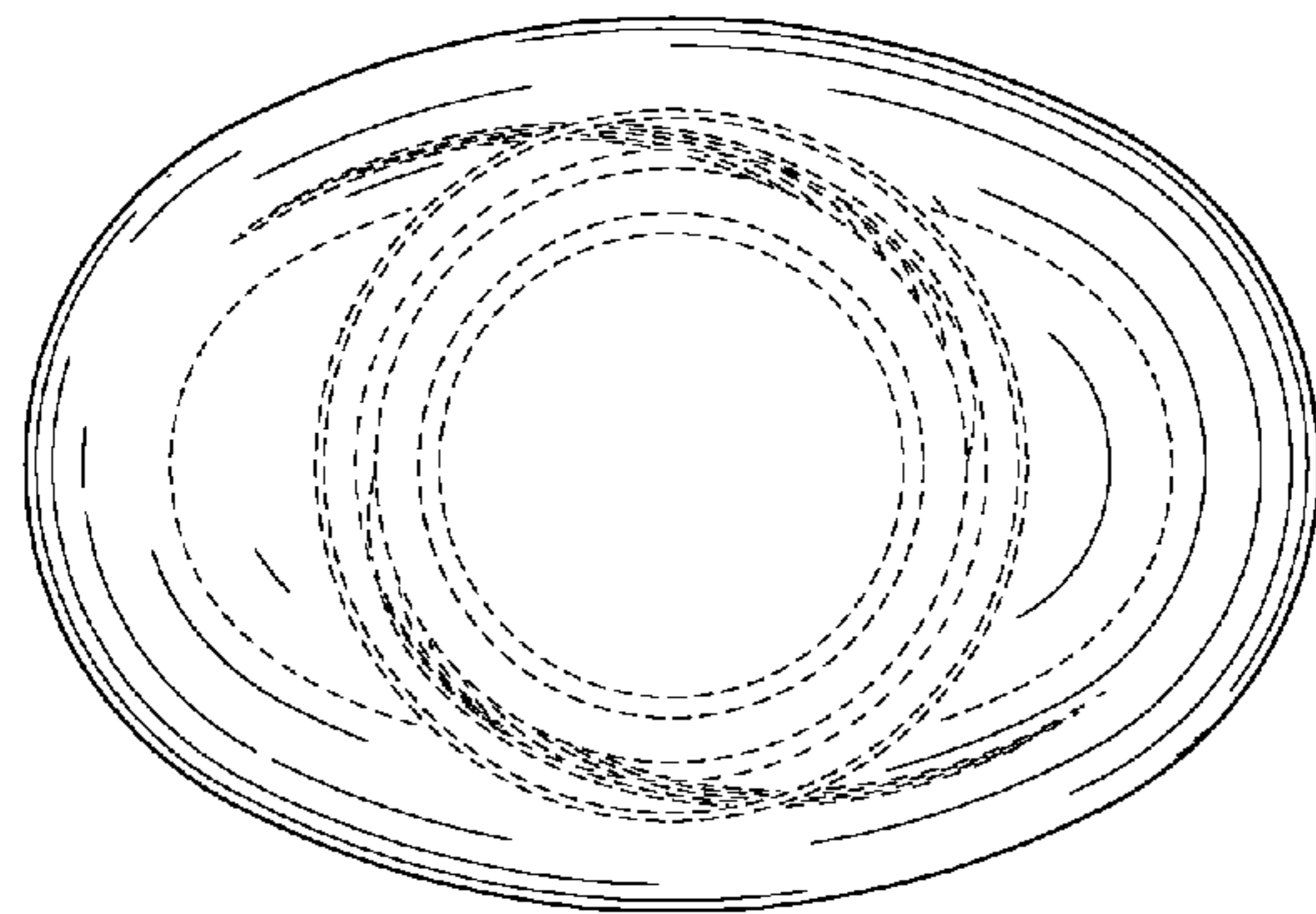

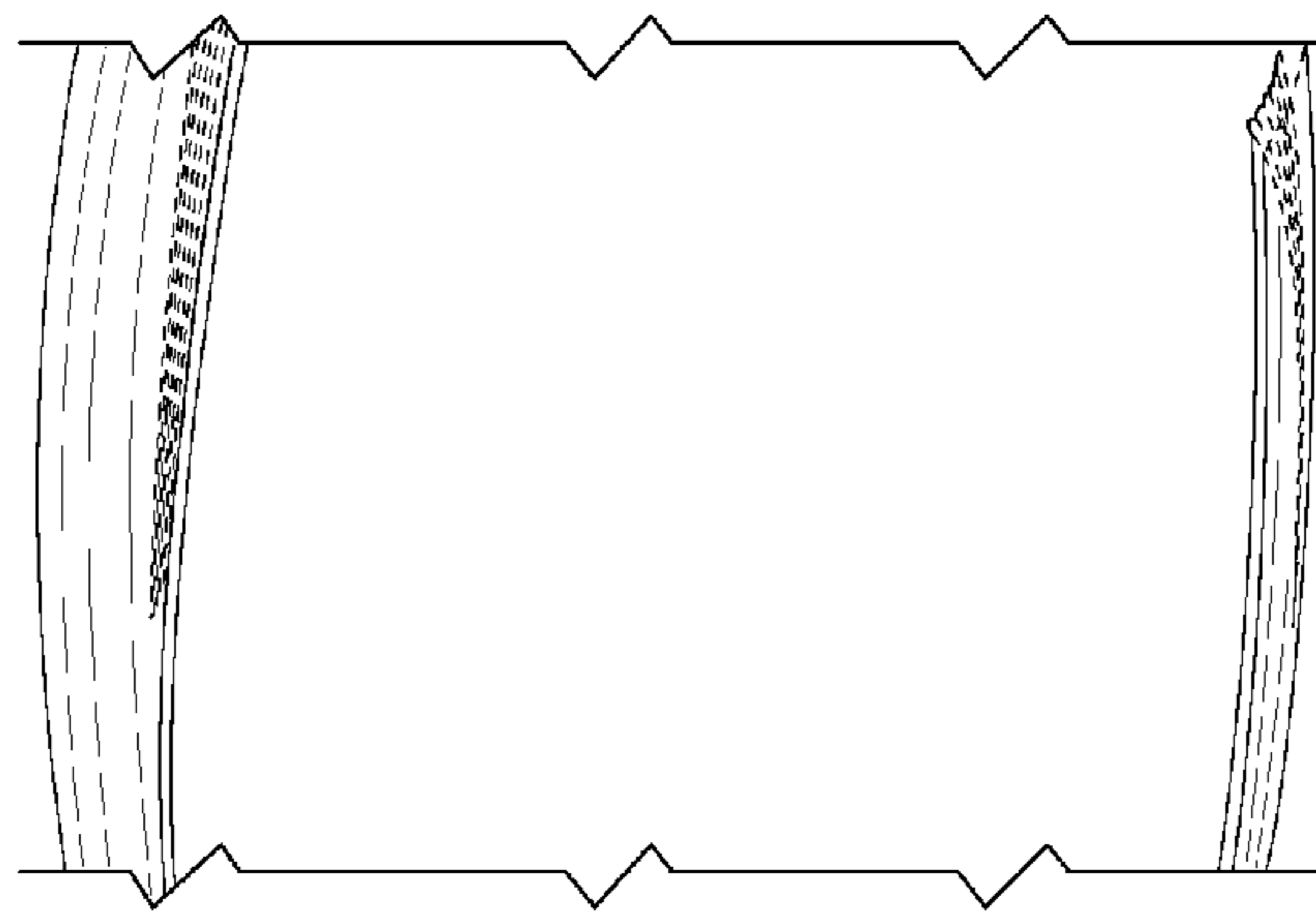
