**DESCRIPTION**

FIG. 1 is a first isometric view of an embodiment showing my design;

FIG. 2 is an isometric view of a right side thereof, a left side thereof being a substantially mirror image of the right side;

FIG. 3 is an isometric bottom view thereof;

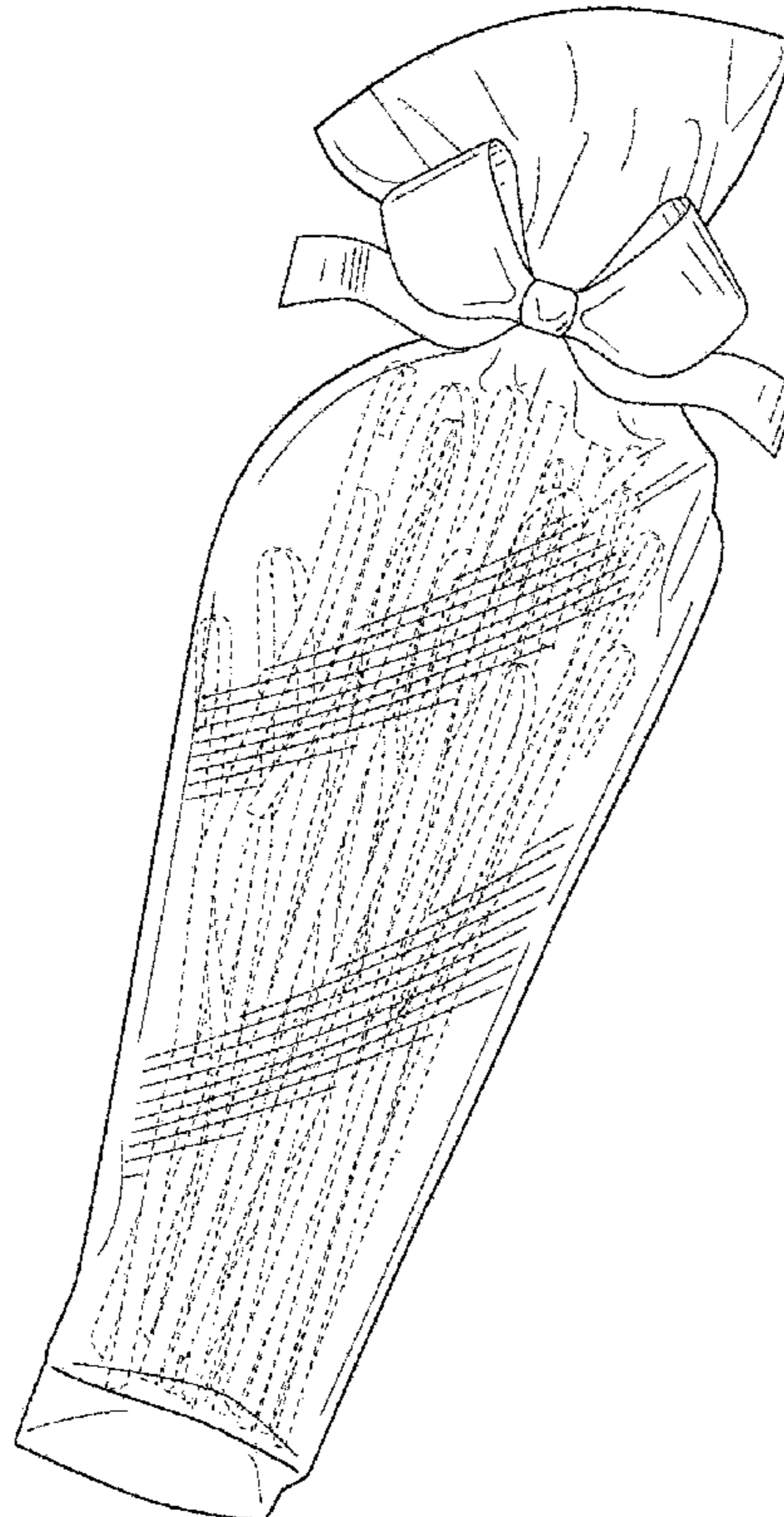
FIG. 4 is an isometric top view thereof;

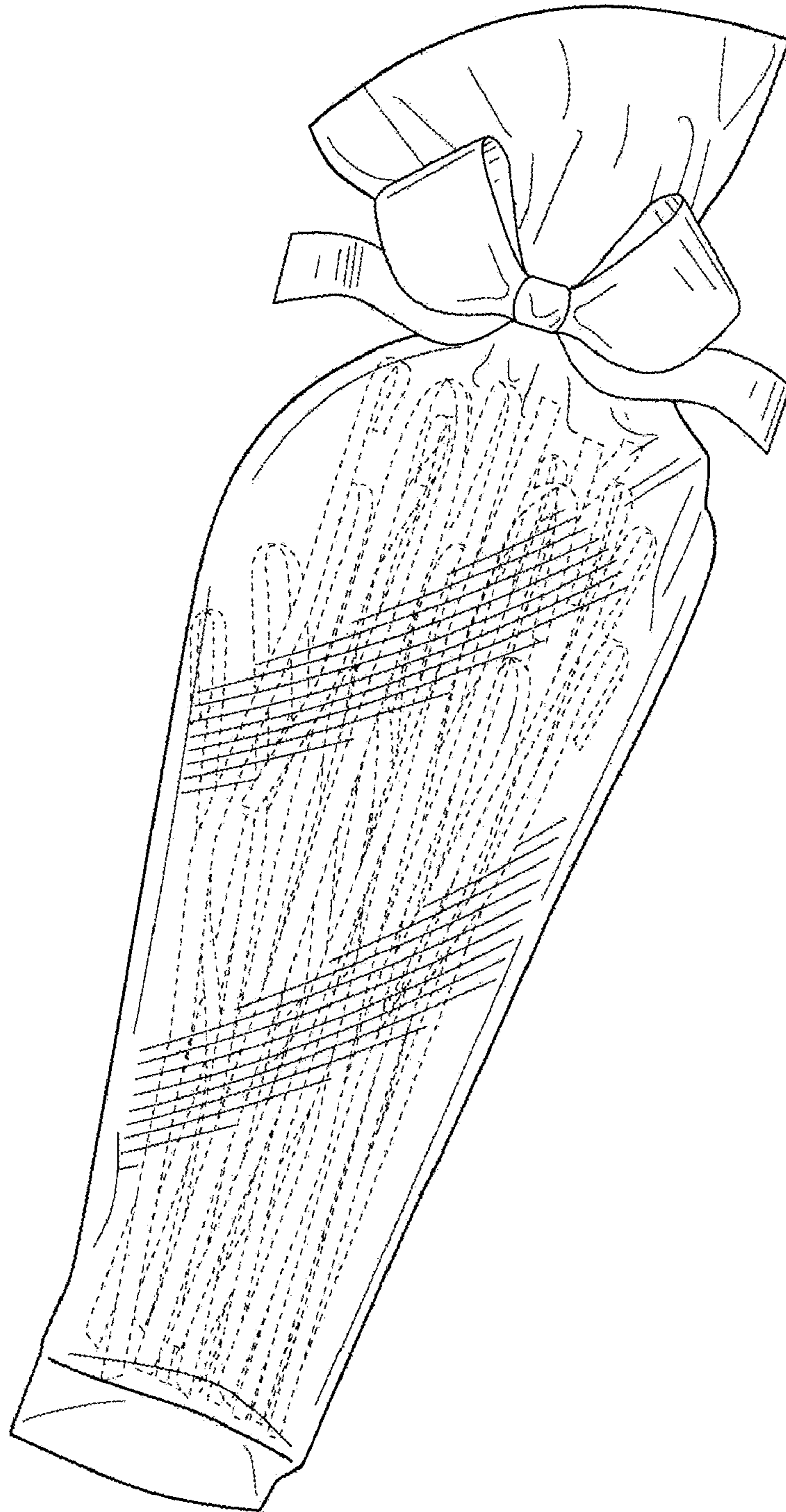

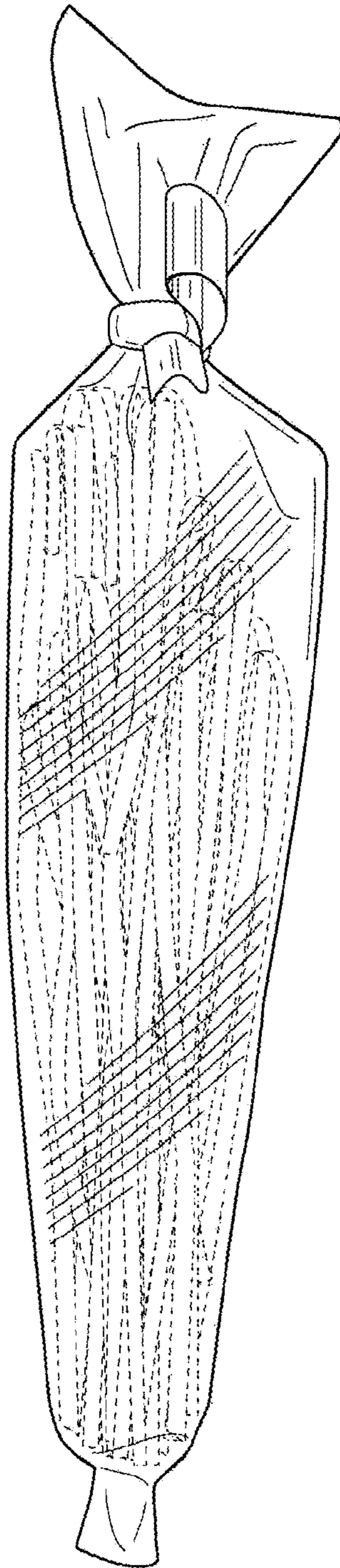
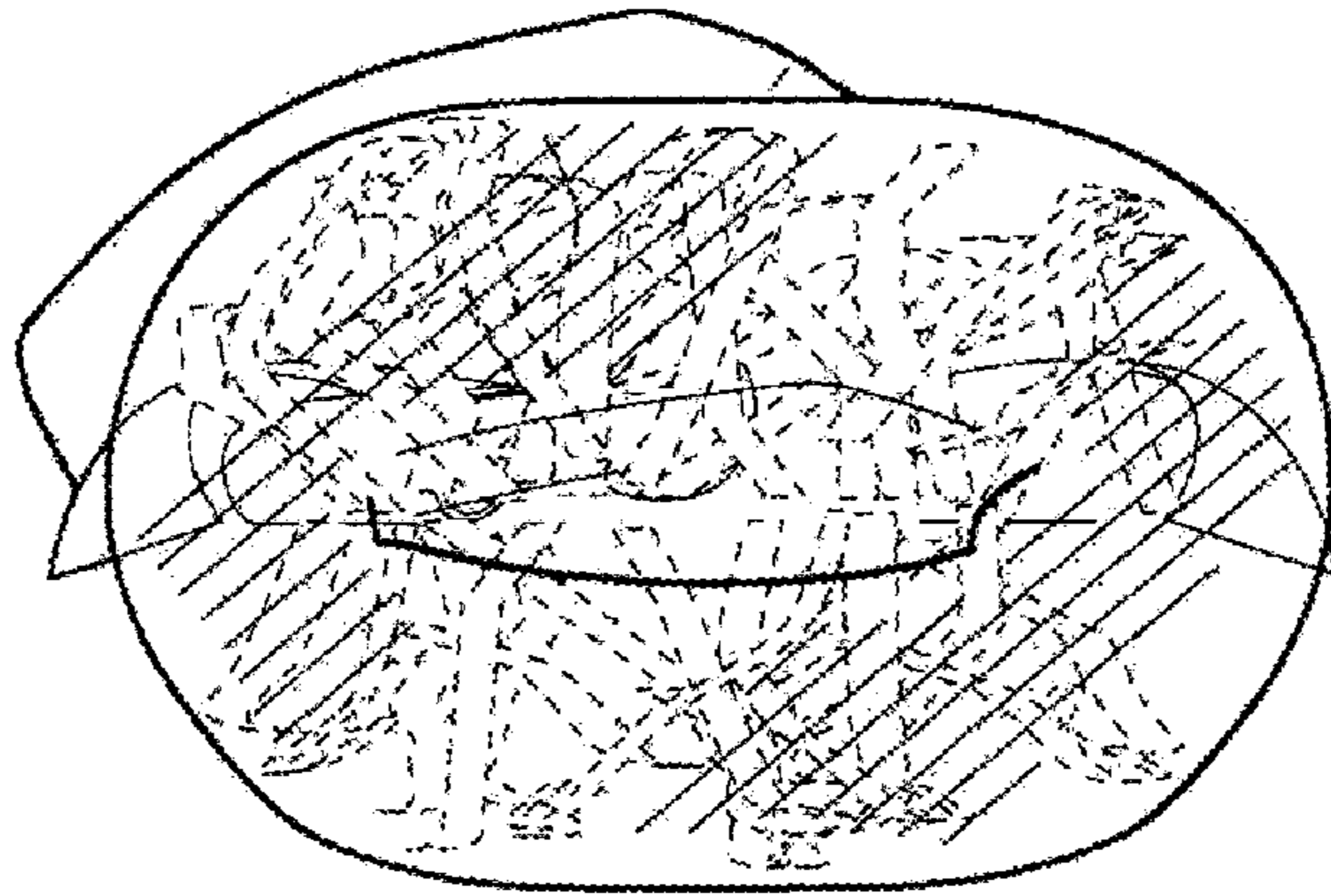
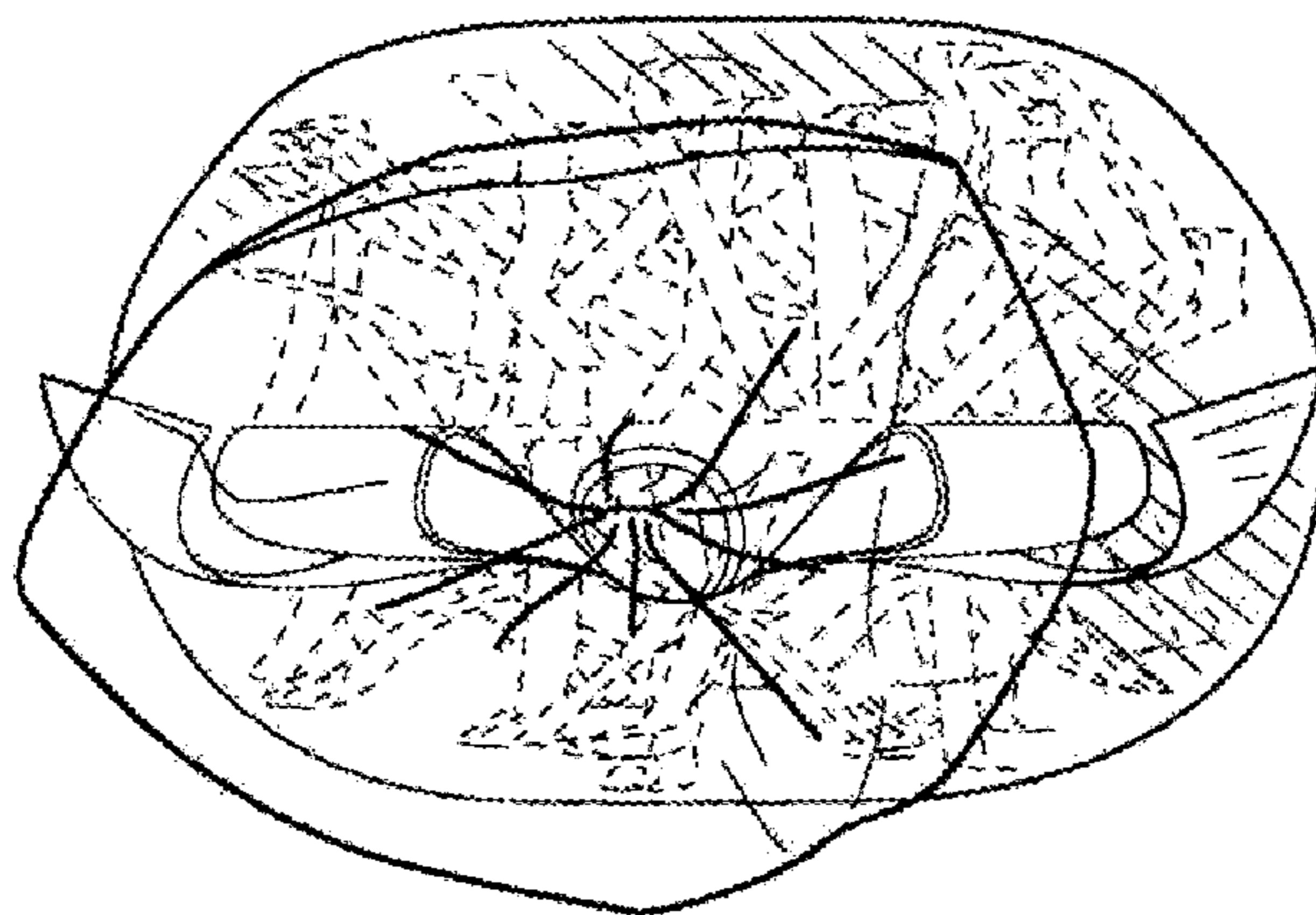

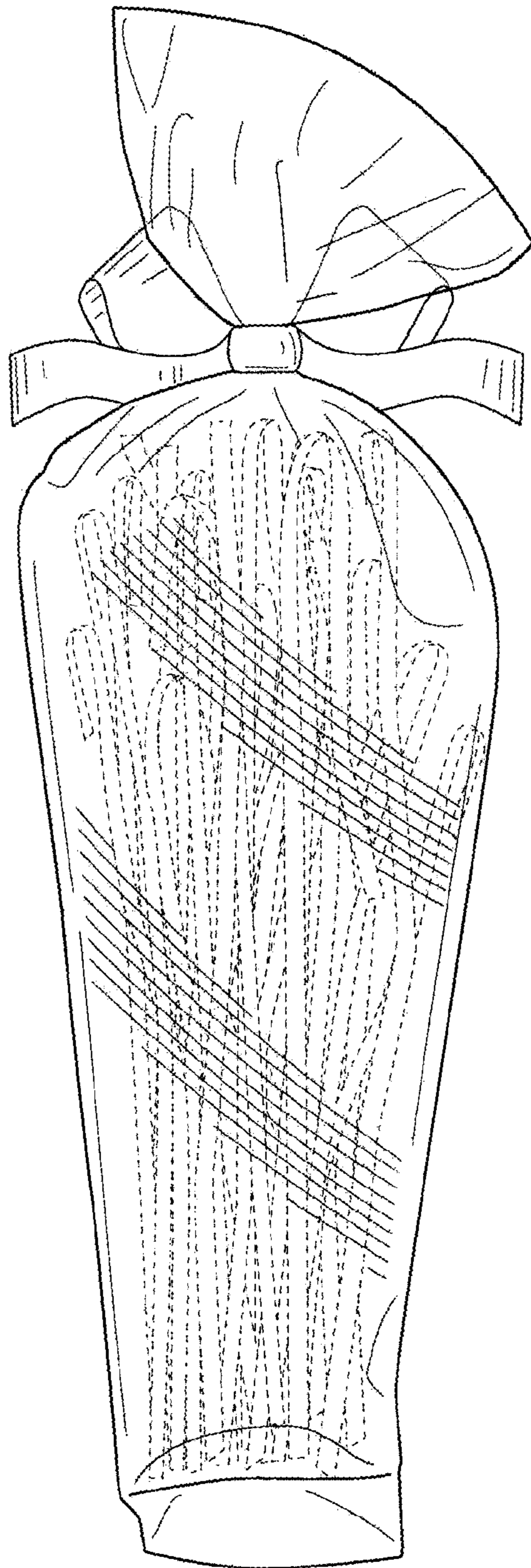

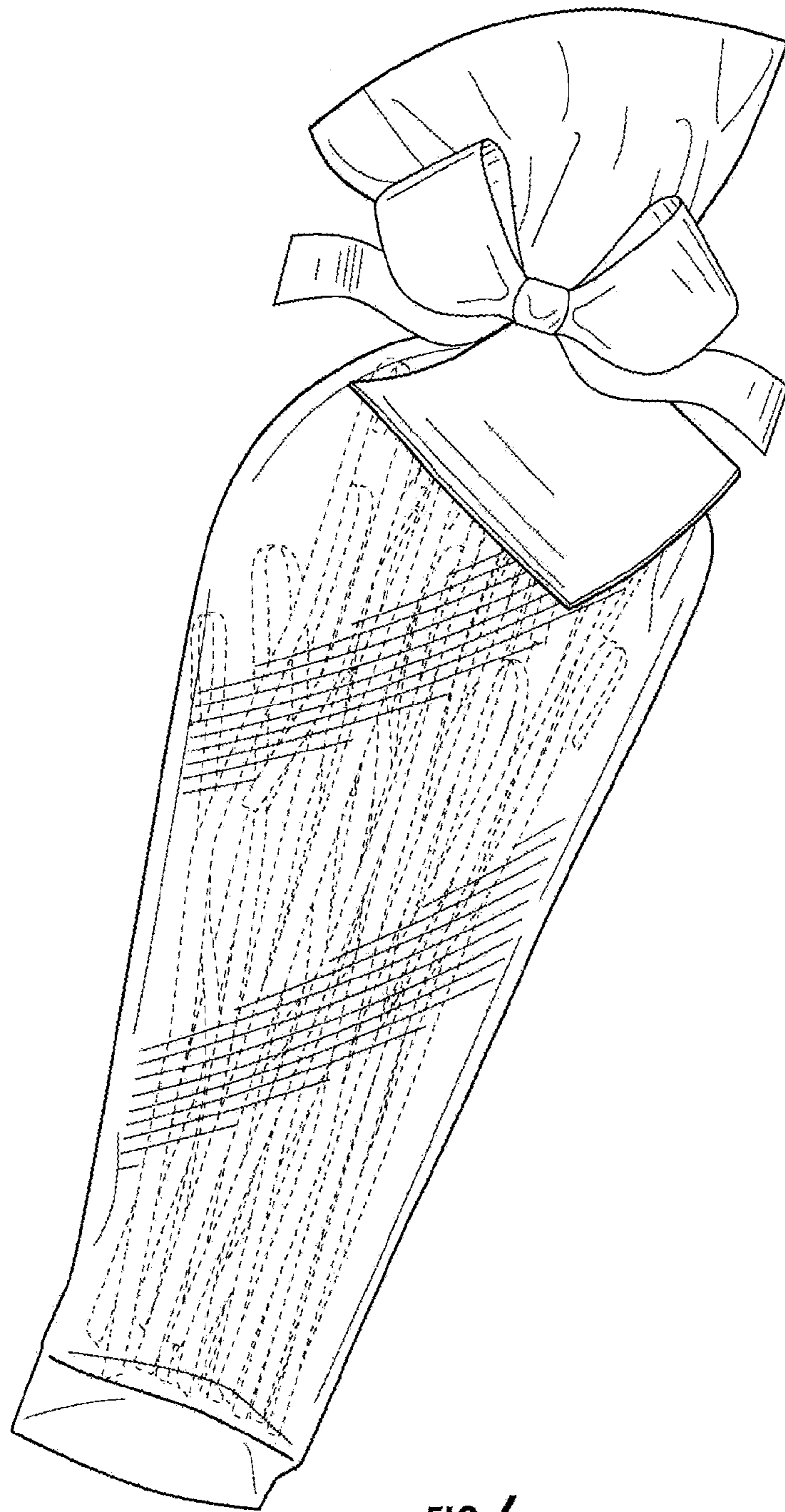
