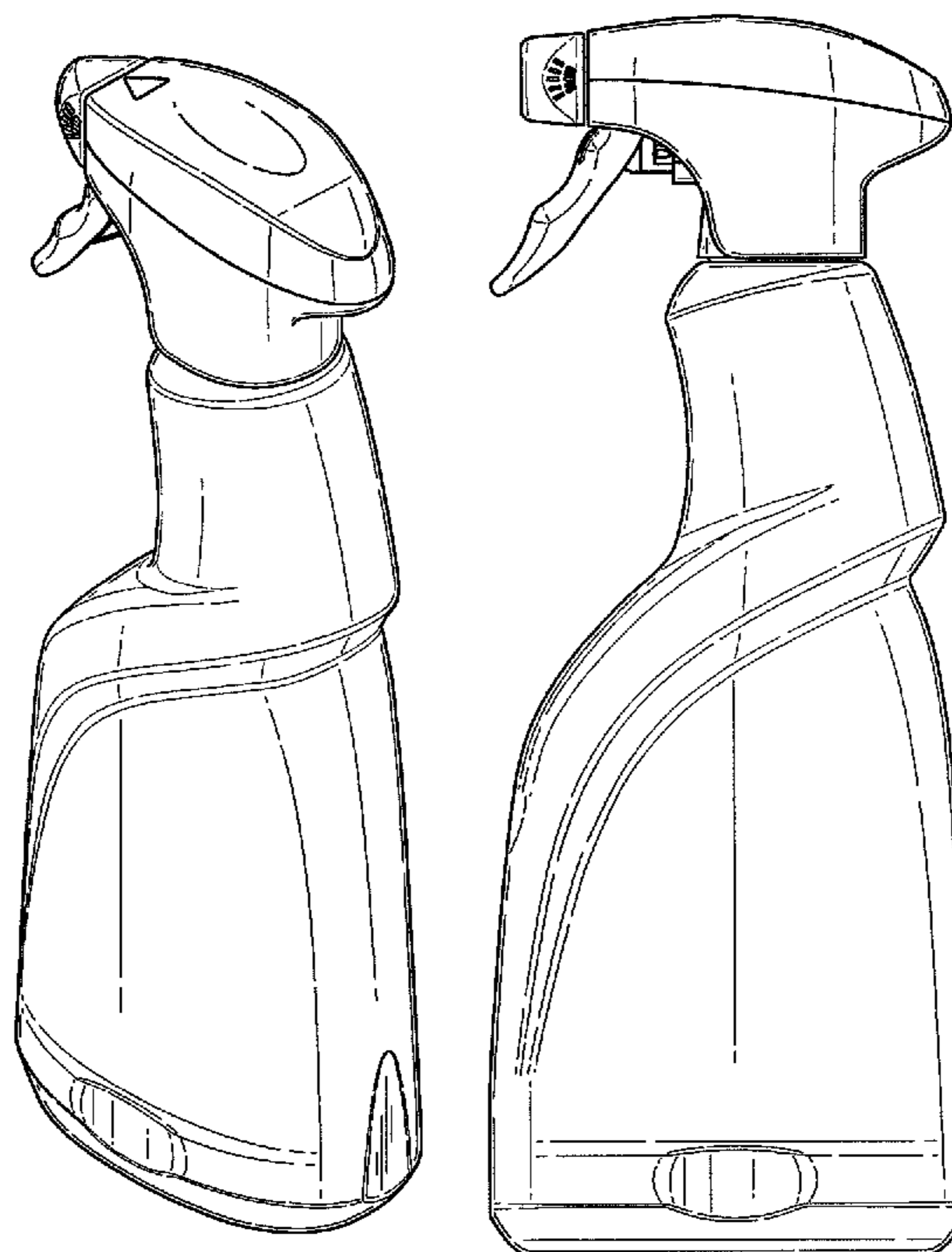
(57) **CLAIM**

The ornamental design for a trigger spray bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and rear perspective view of the trigger spray bottle showing my new design;
FIG. 2 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

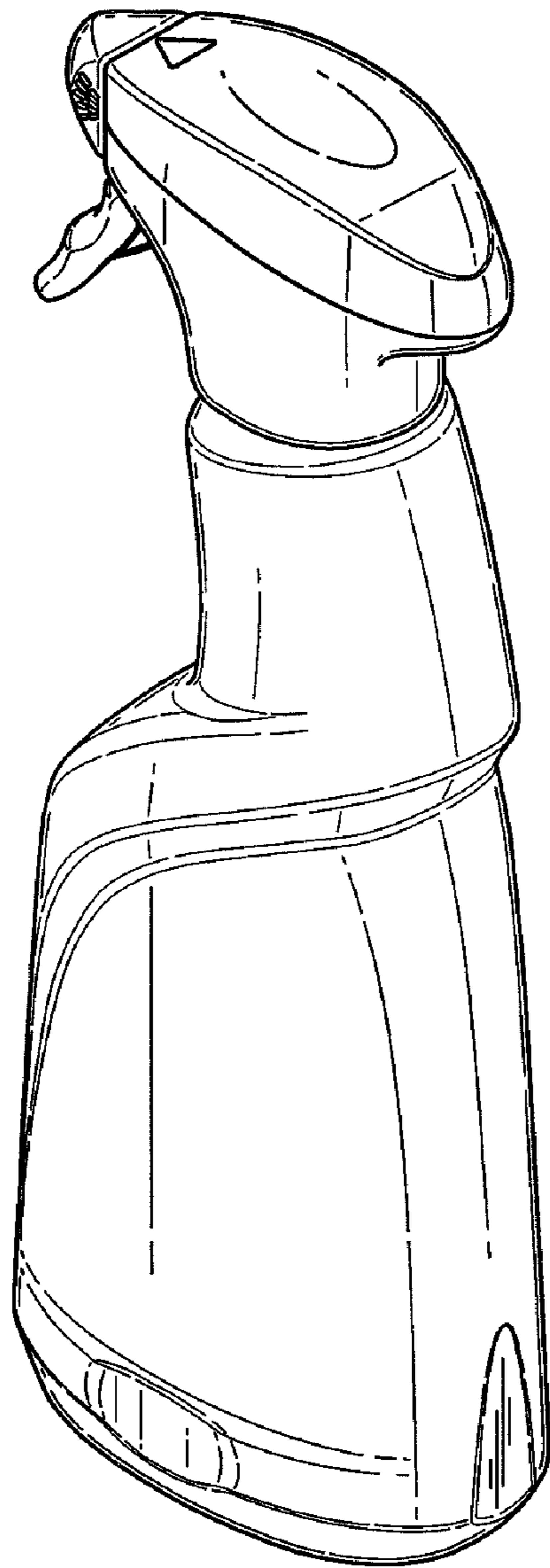

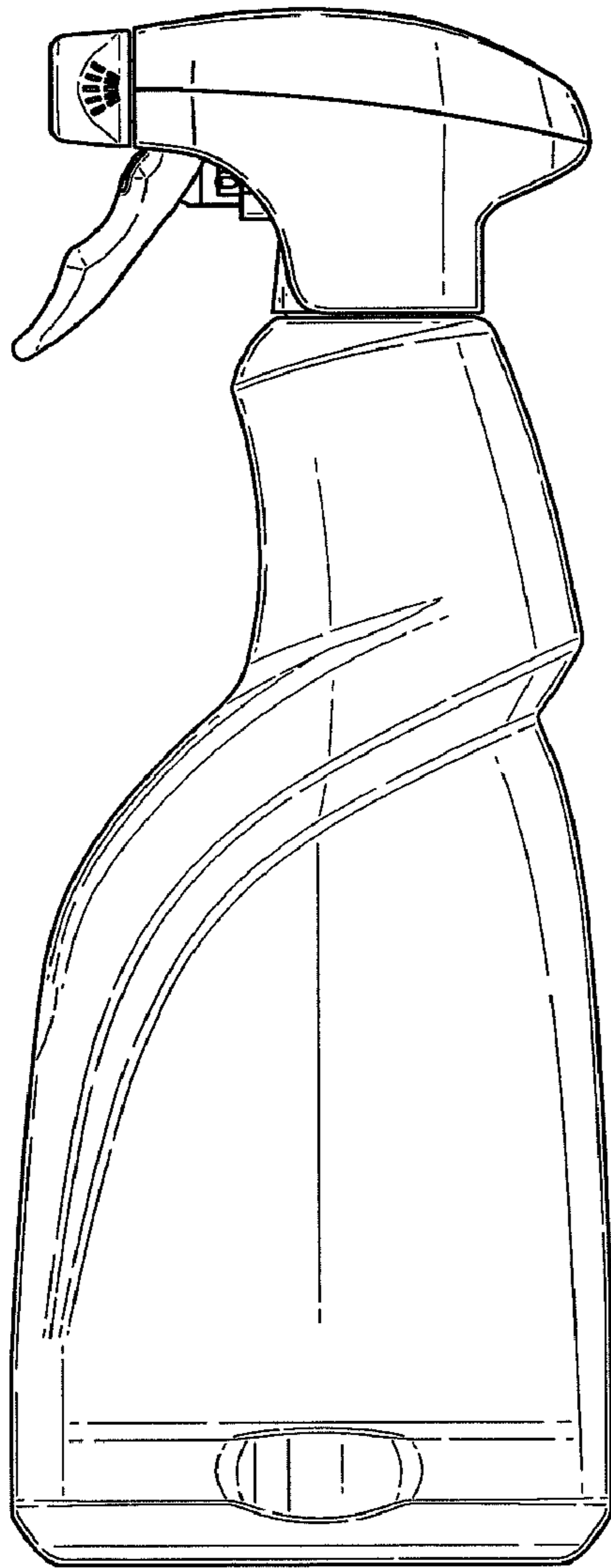

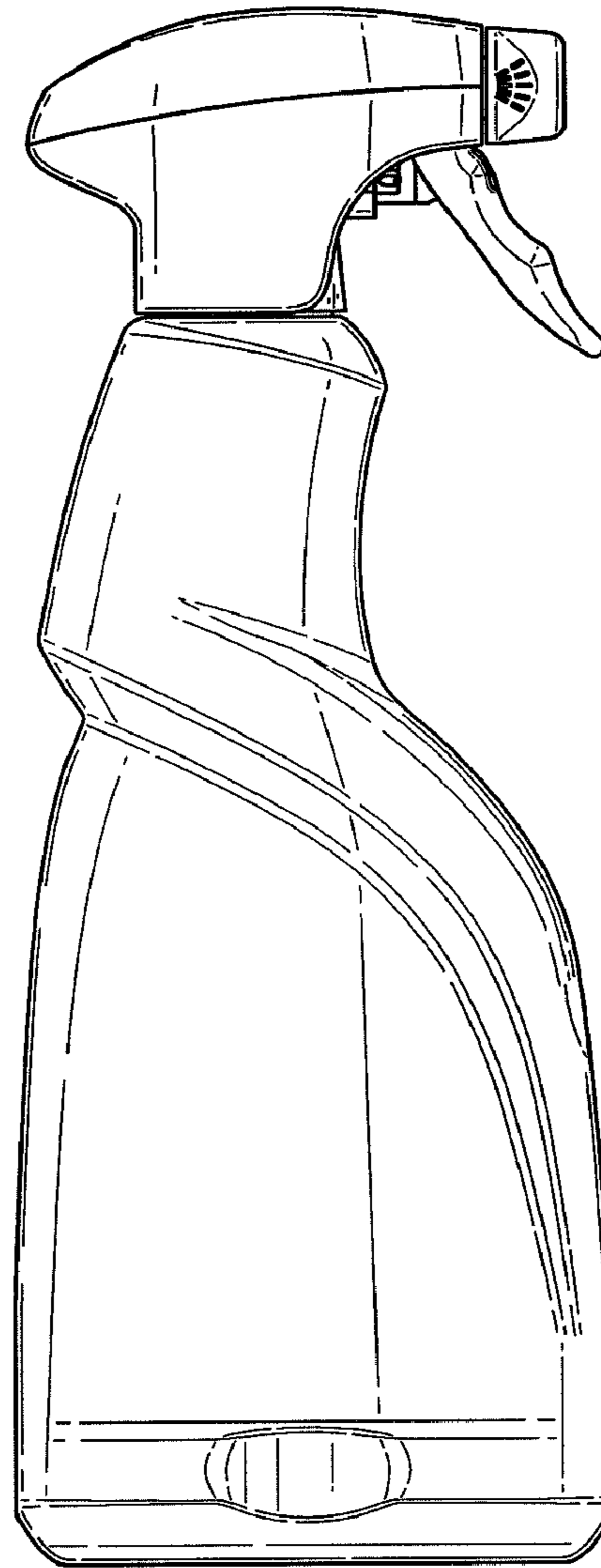

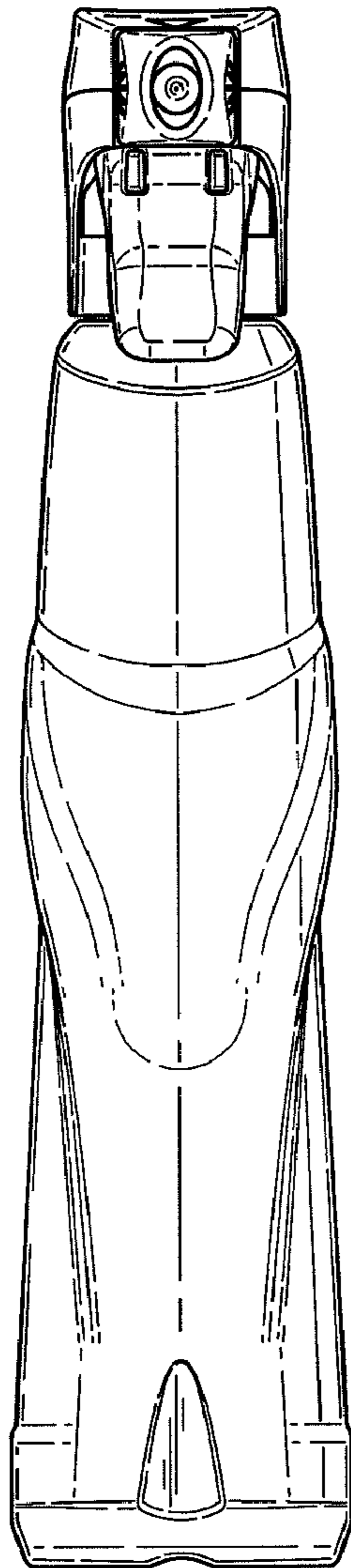

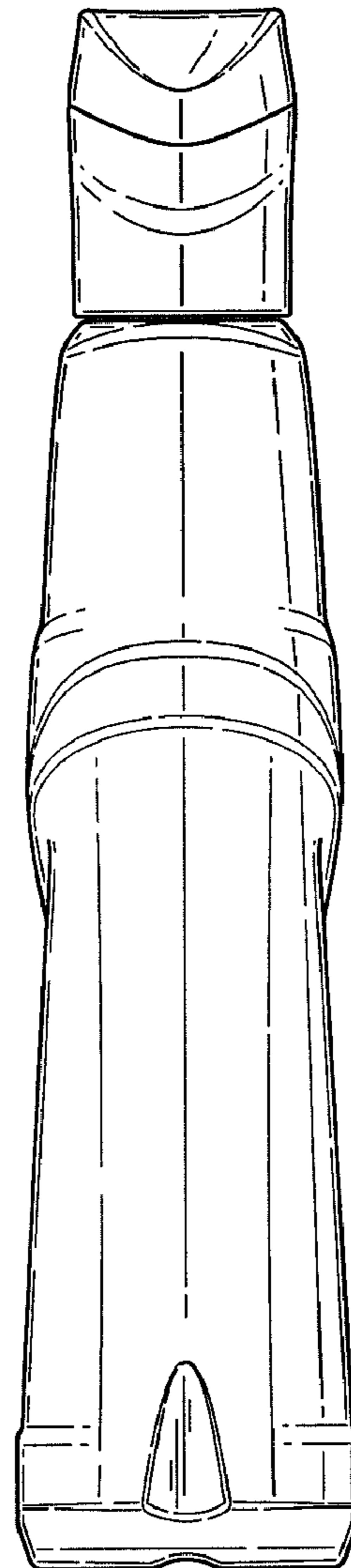

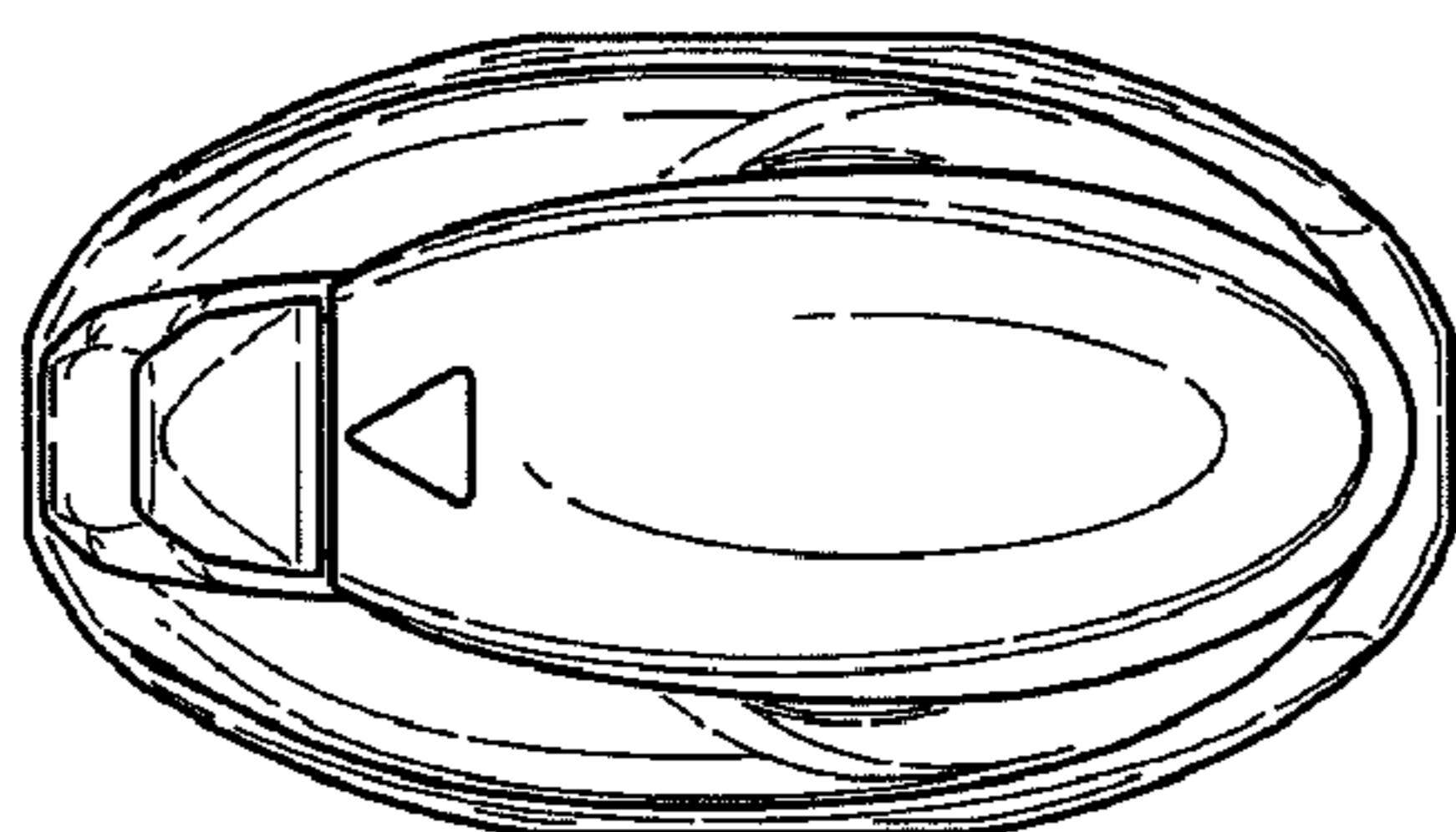

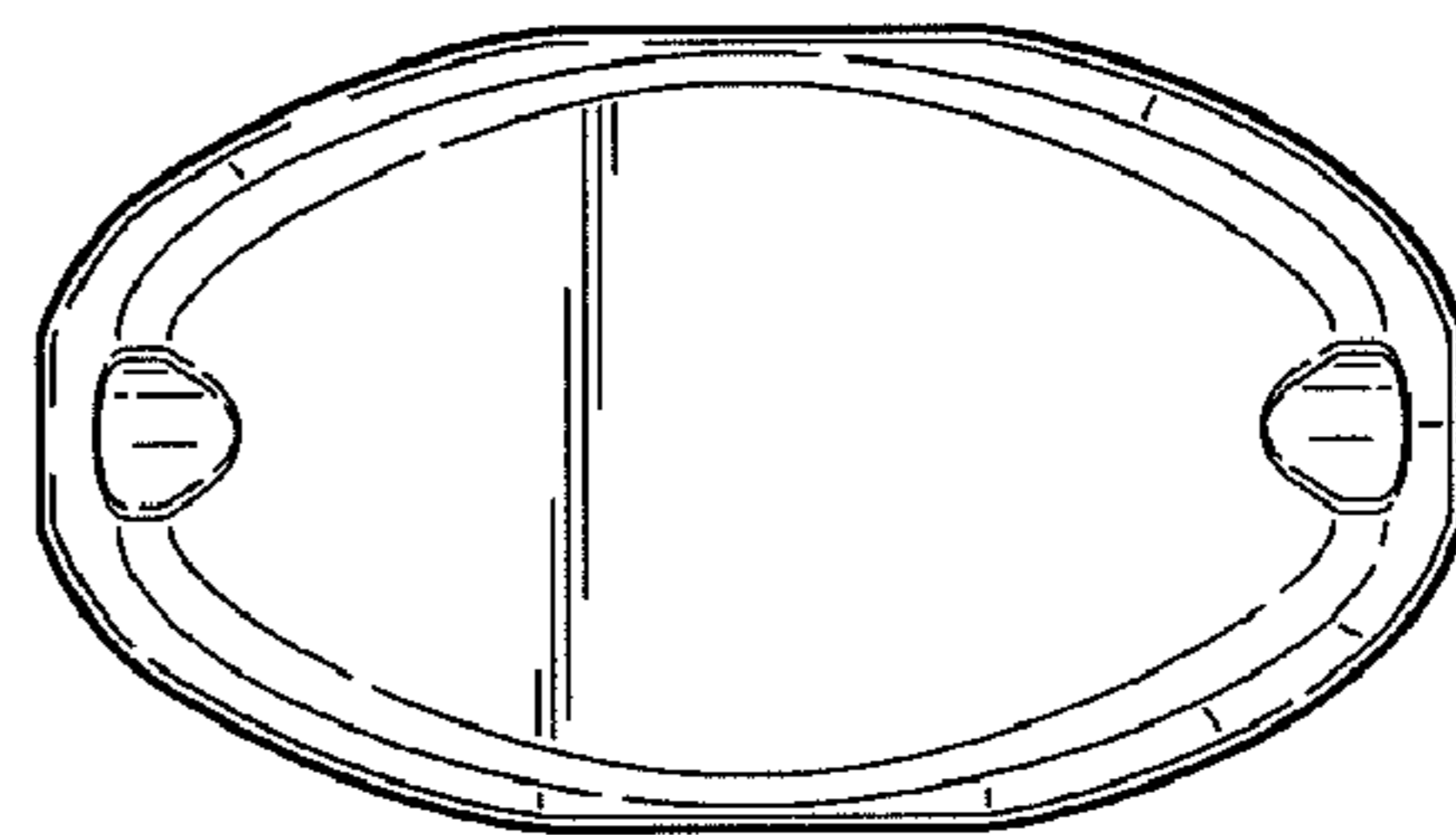
