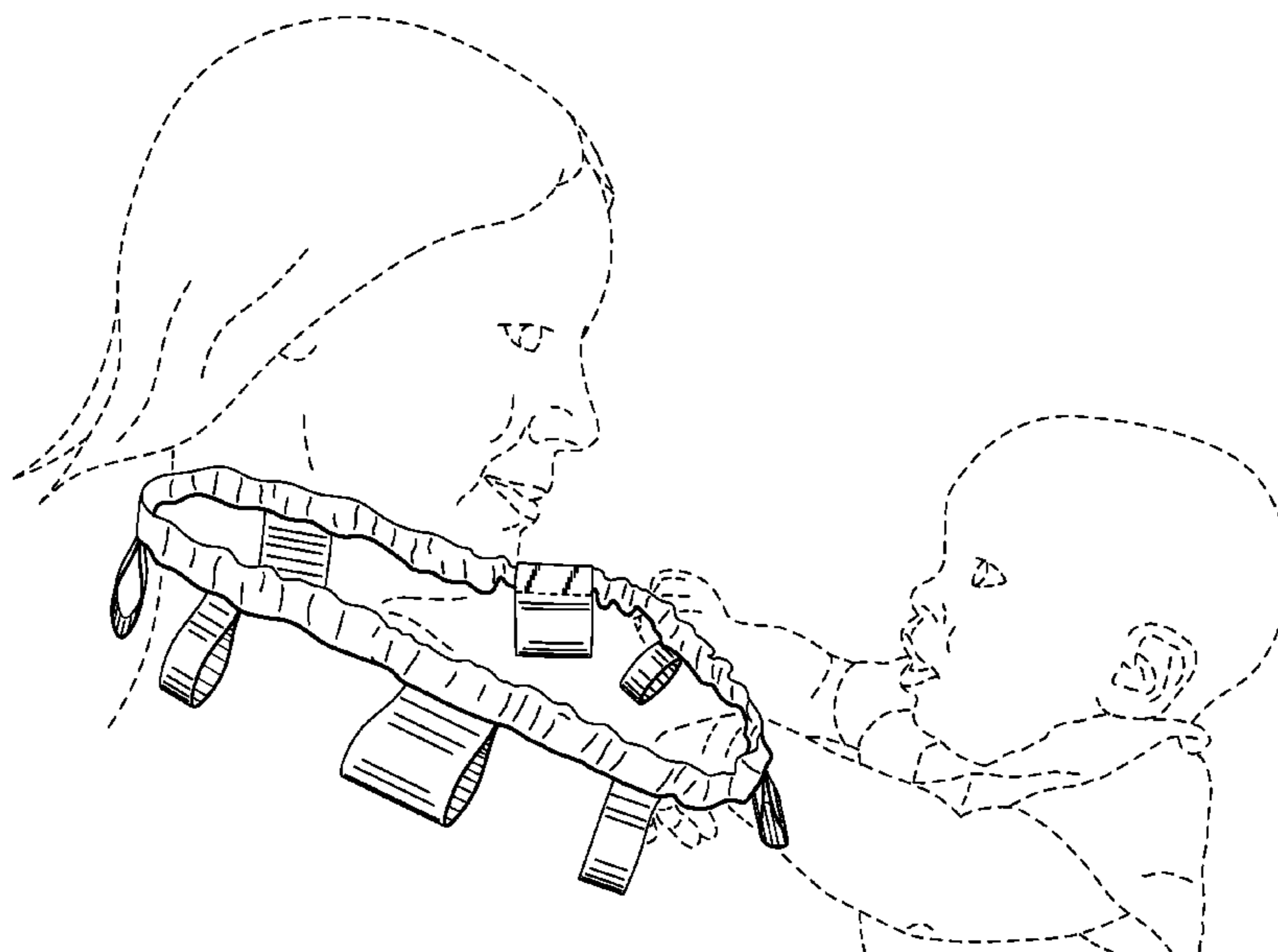
(57) **CLAIM**

What is claimed is the ornamental design for a baby-entertaining necklace, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a baby-entertaining necklace, showing my new design in use in a stretched out condition; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right-side elevational view thereof; and, FIG. 7 is a left-side elevational view thereof. The broken lines showing a mother and baby in FIG. 1 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

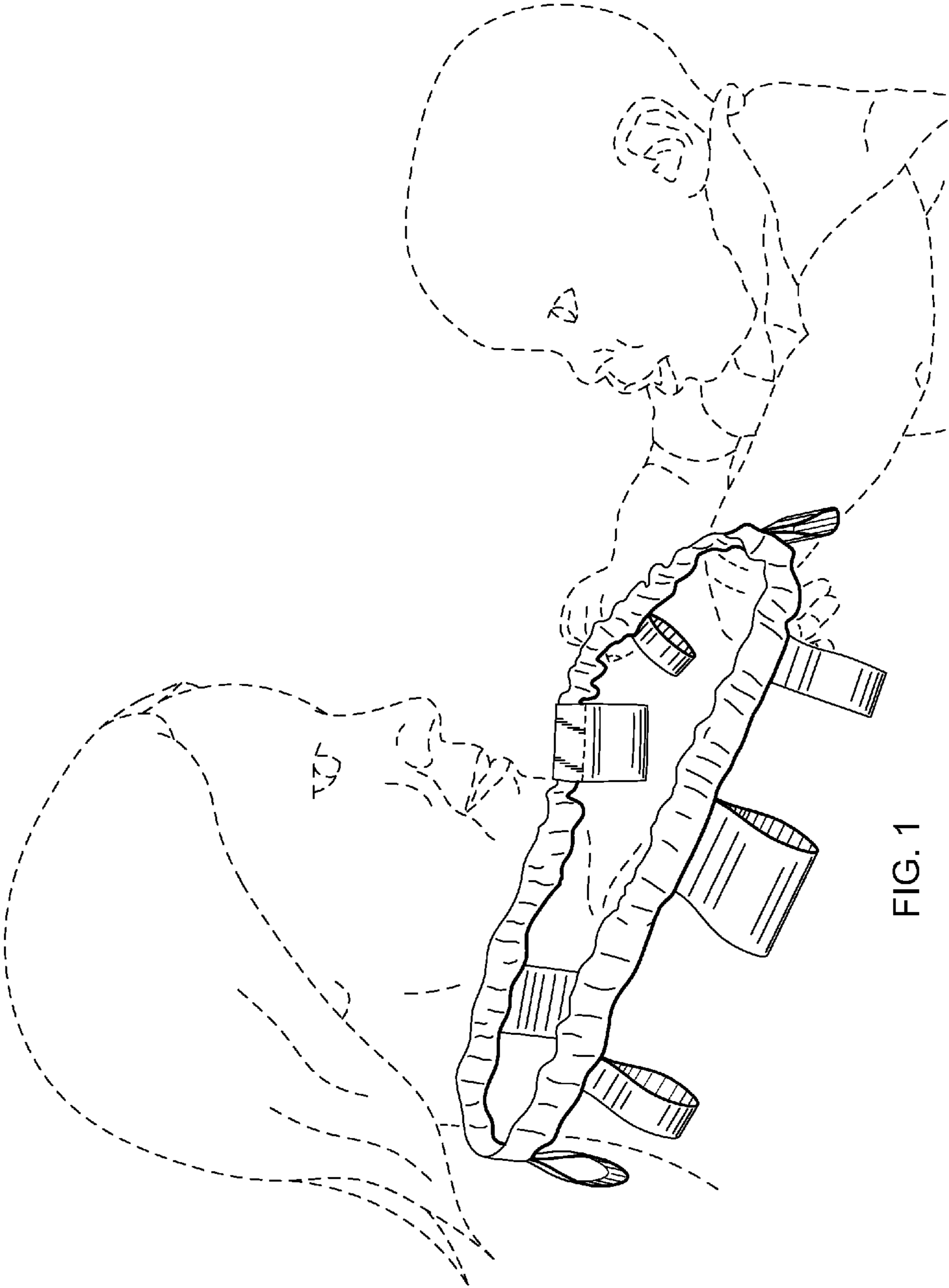

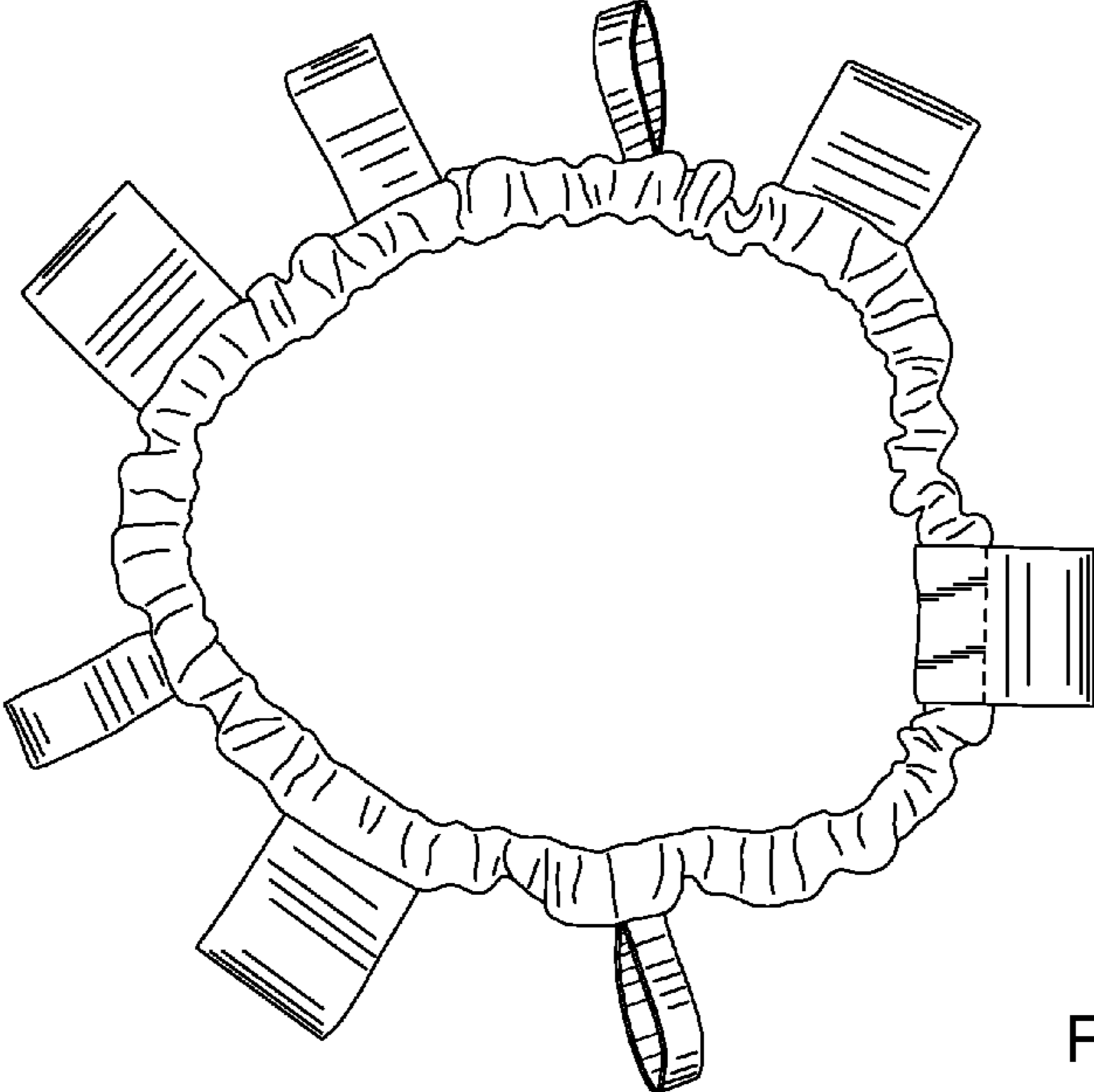

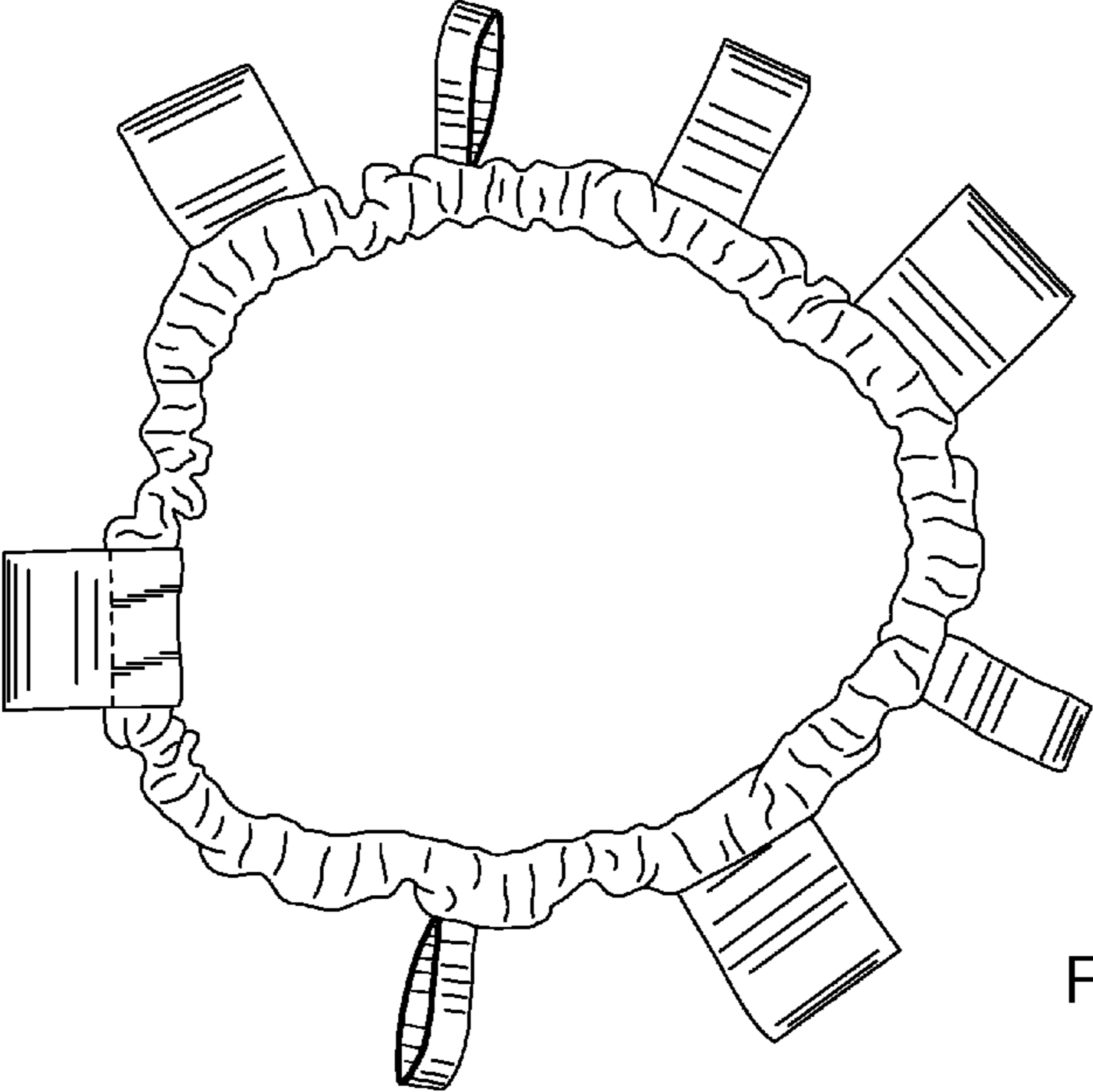
