The ornamental design for a vehicle grille, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle grille showing our new design;

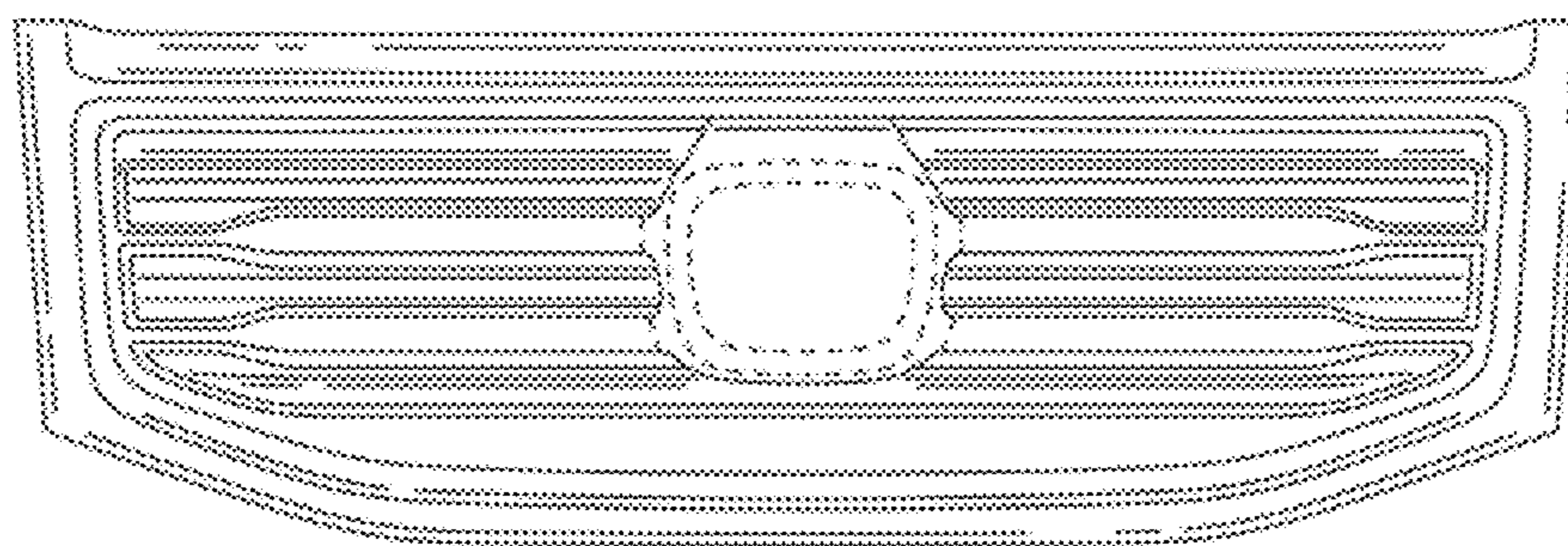
FIG. 2 is a front elevational view thereof;

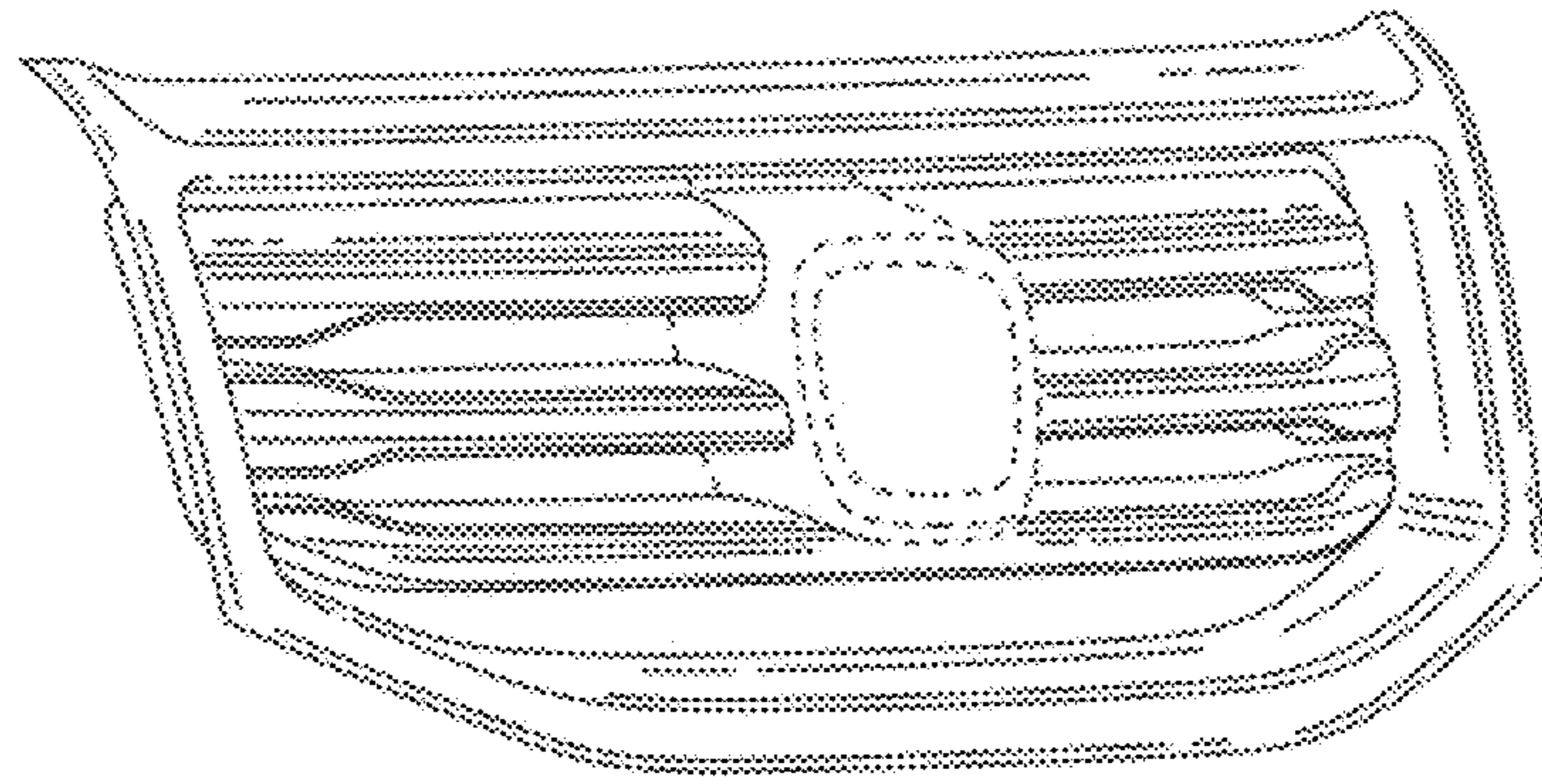

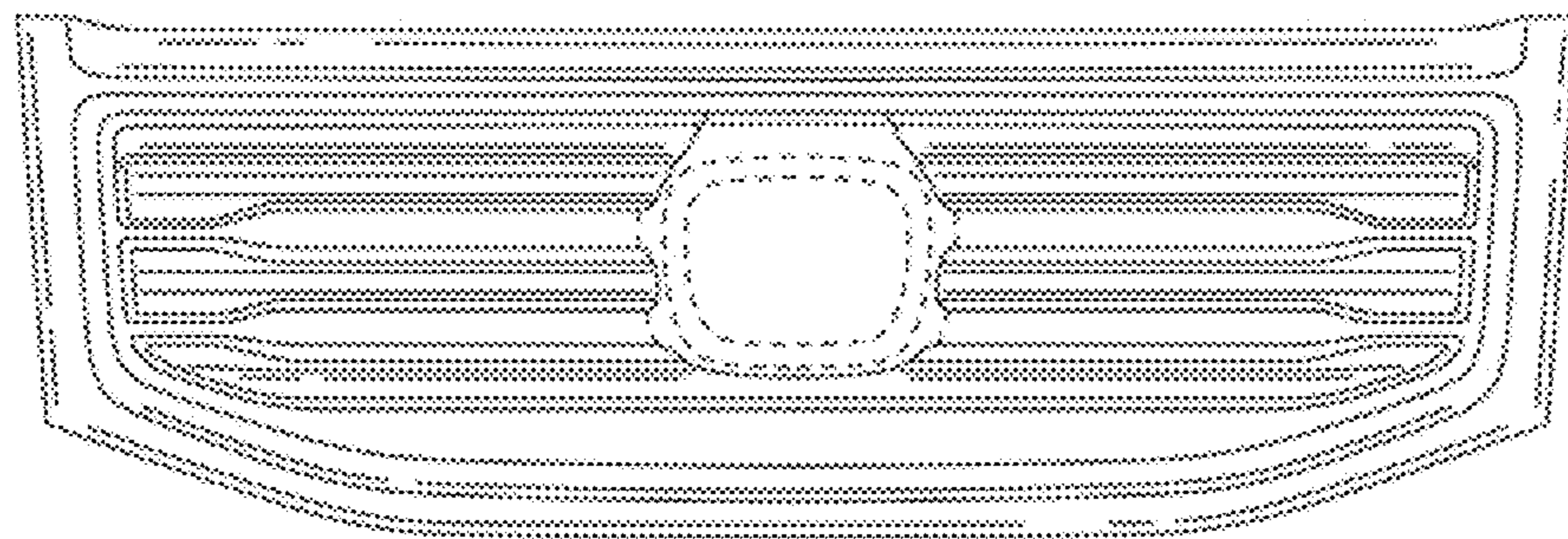

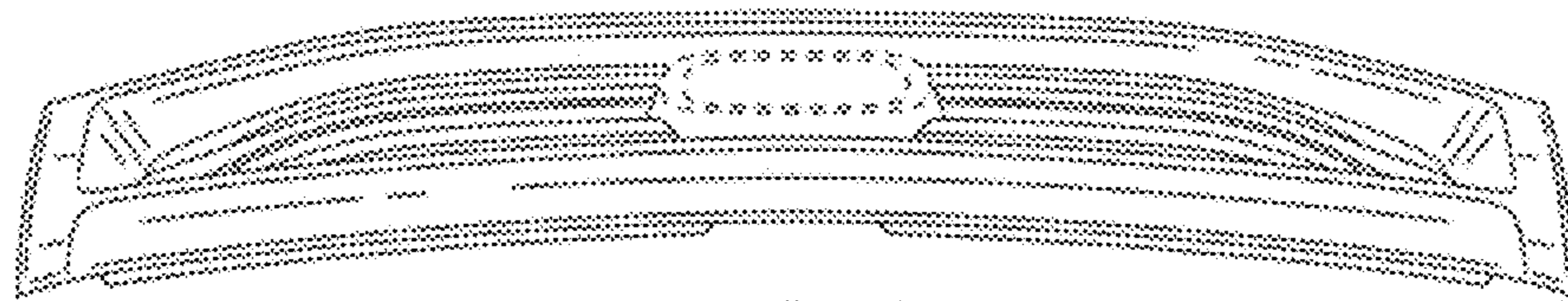

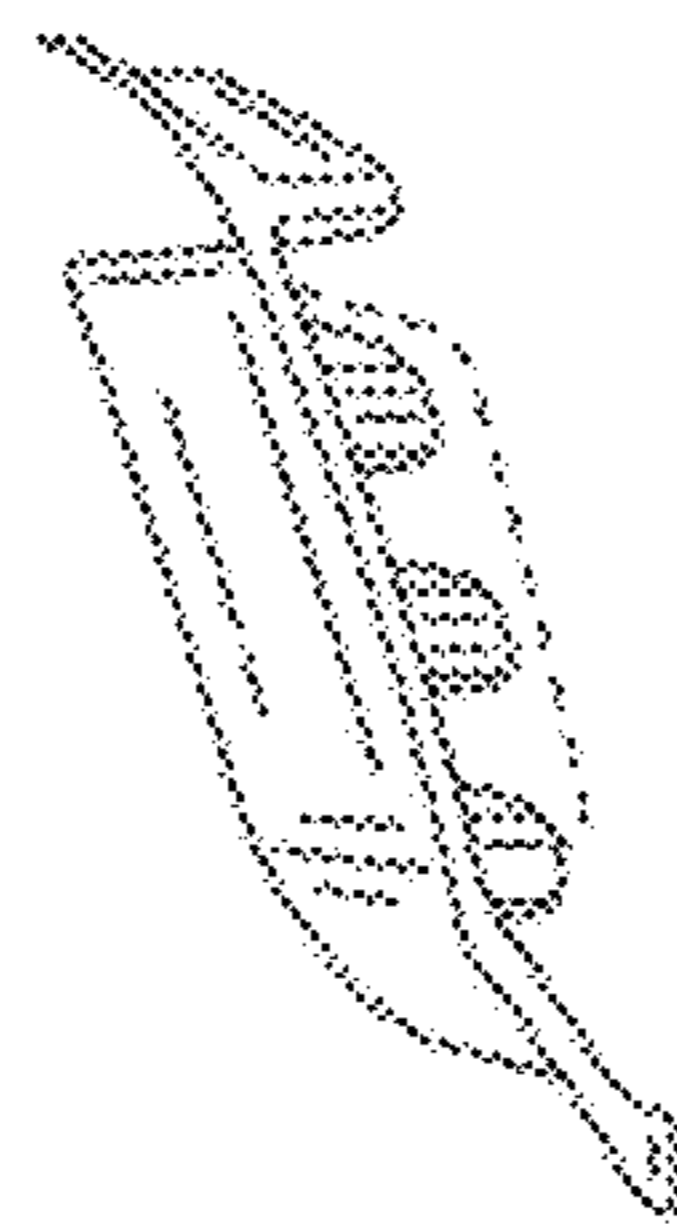
