(57) **CLAIM**

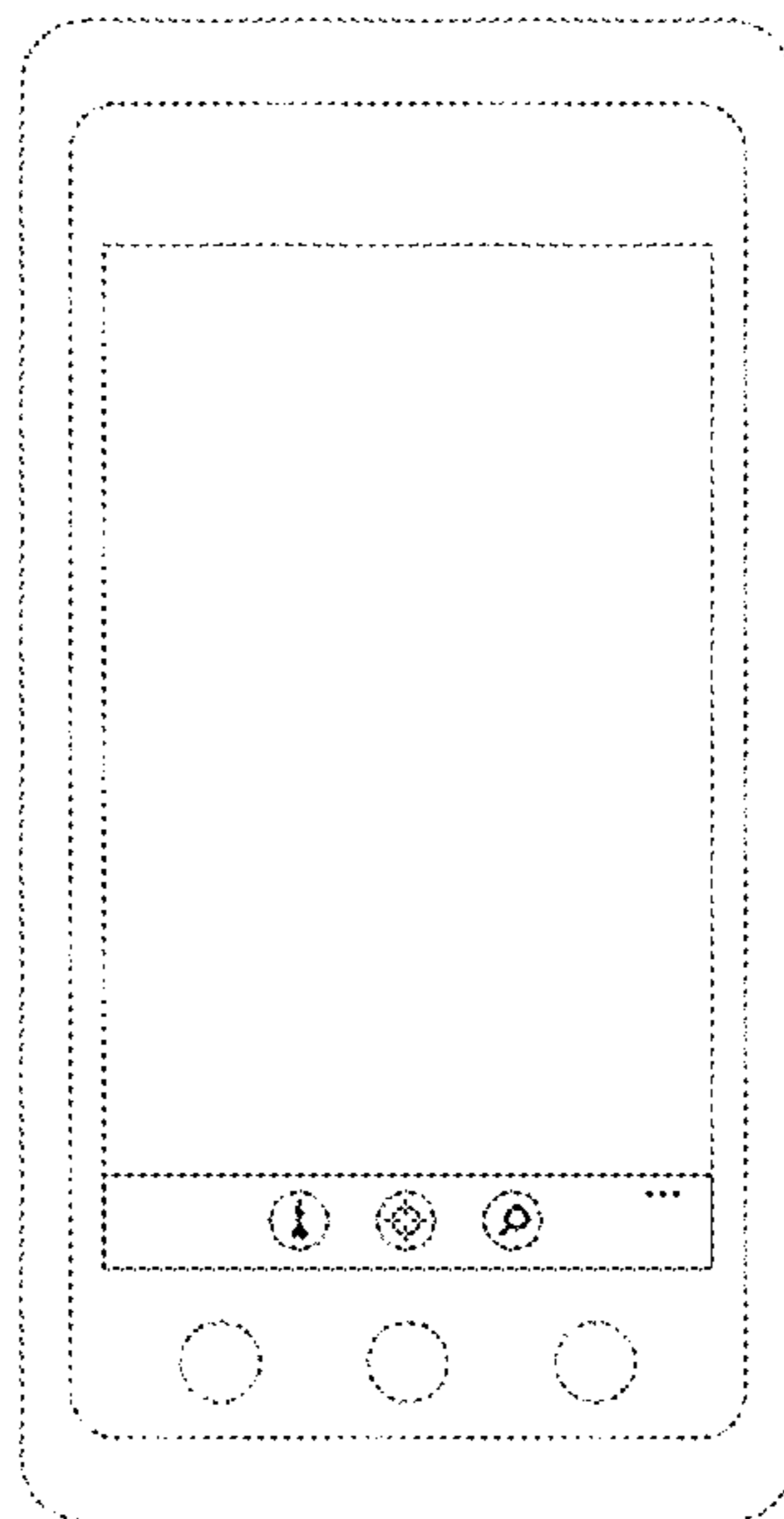
The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing our new design; and, FIG. 2 is a front view of the display screen with graphical user interface of FIG. 1 shown on a device.

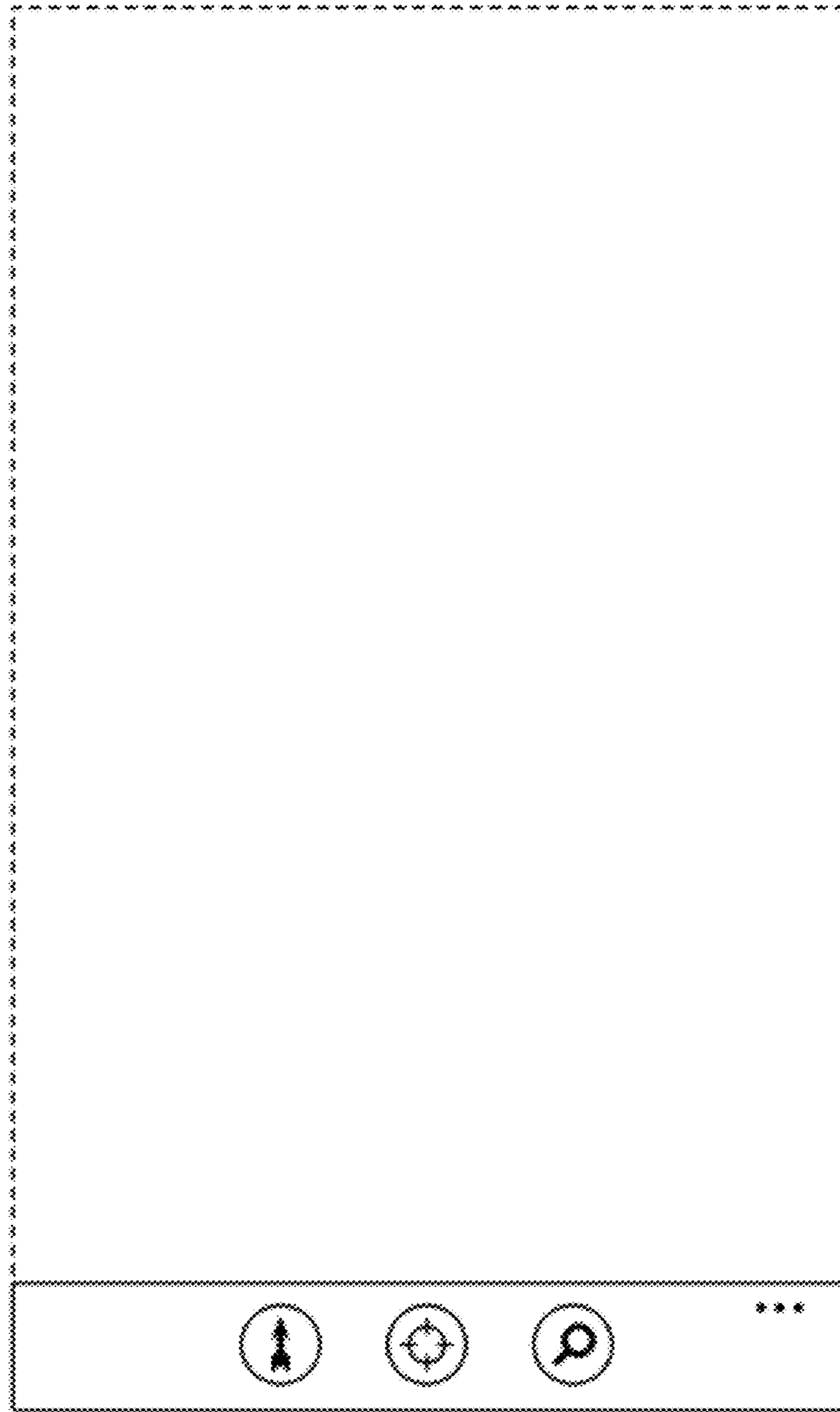

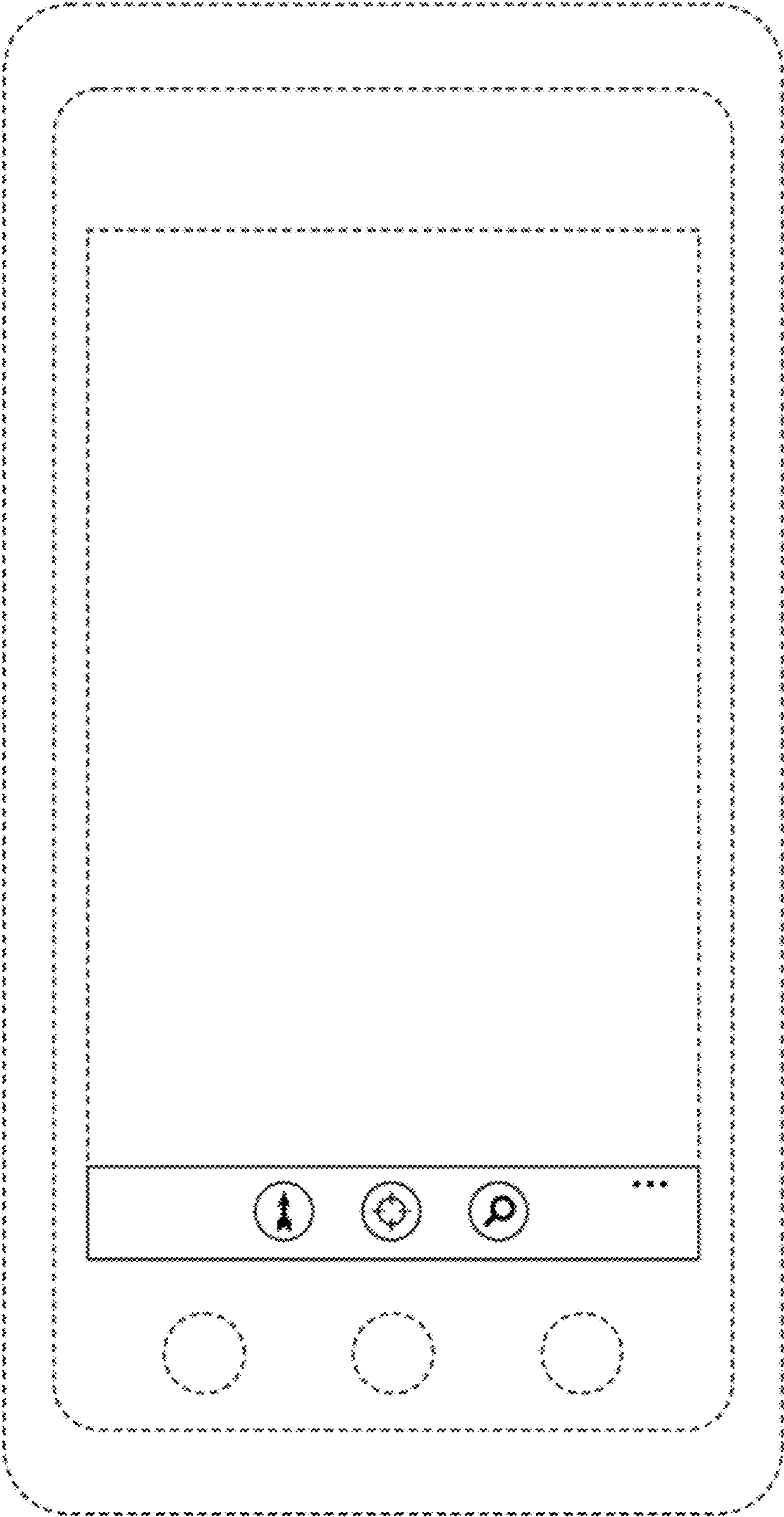
