FIG. 9 is the fourth image thereof; and,

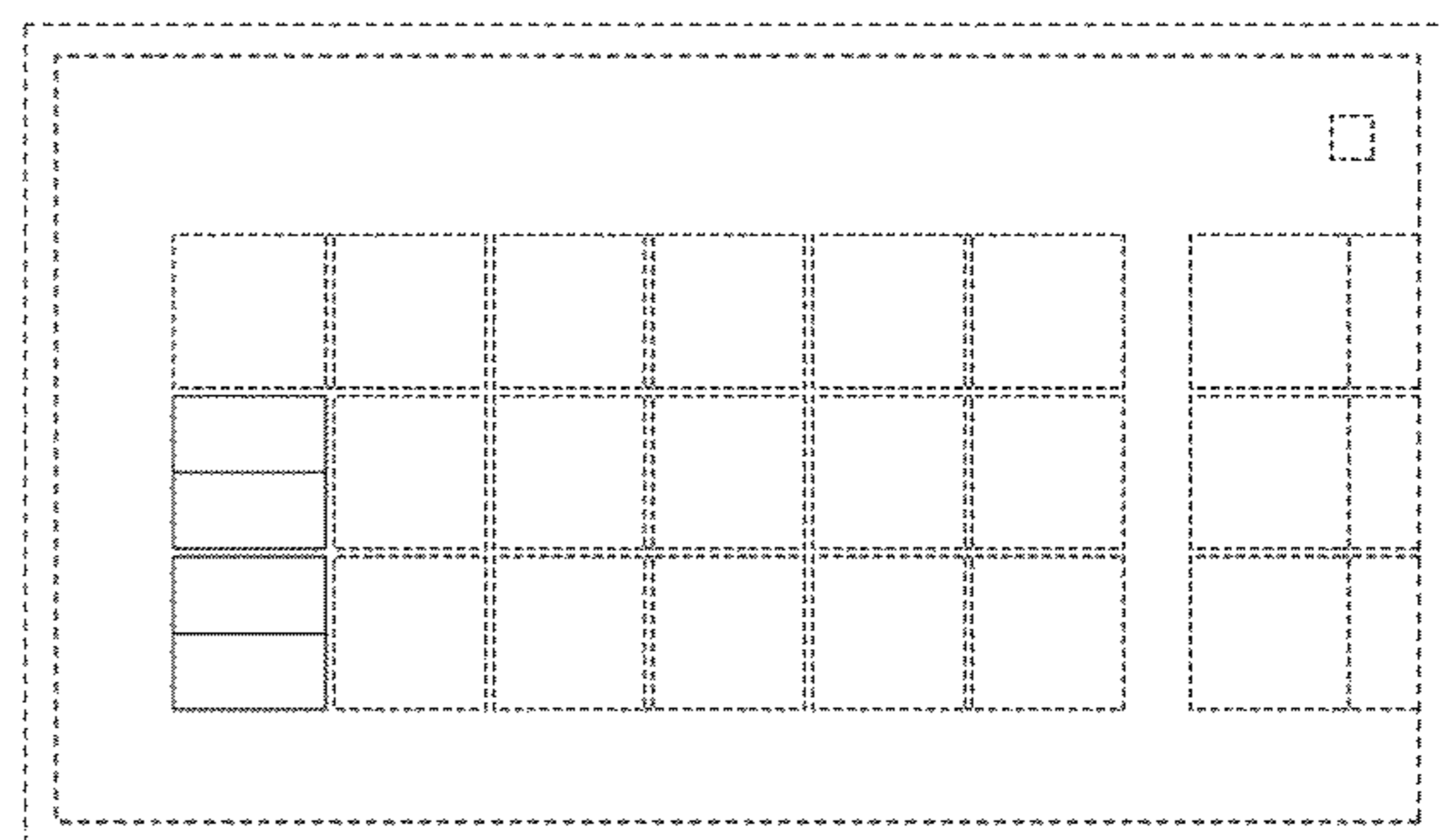
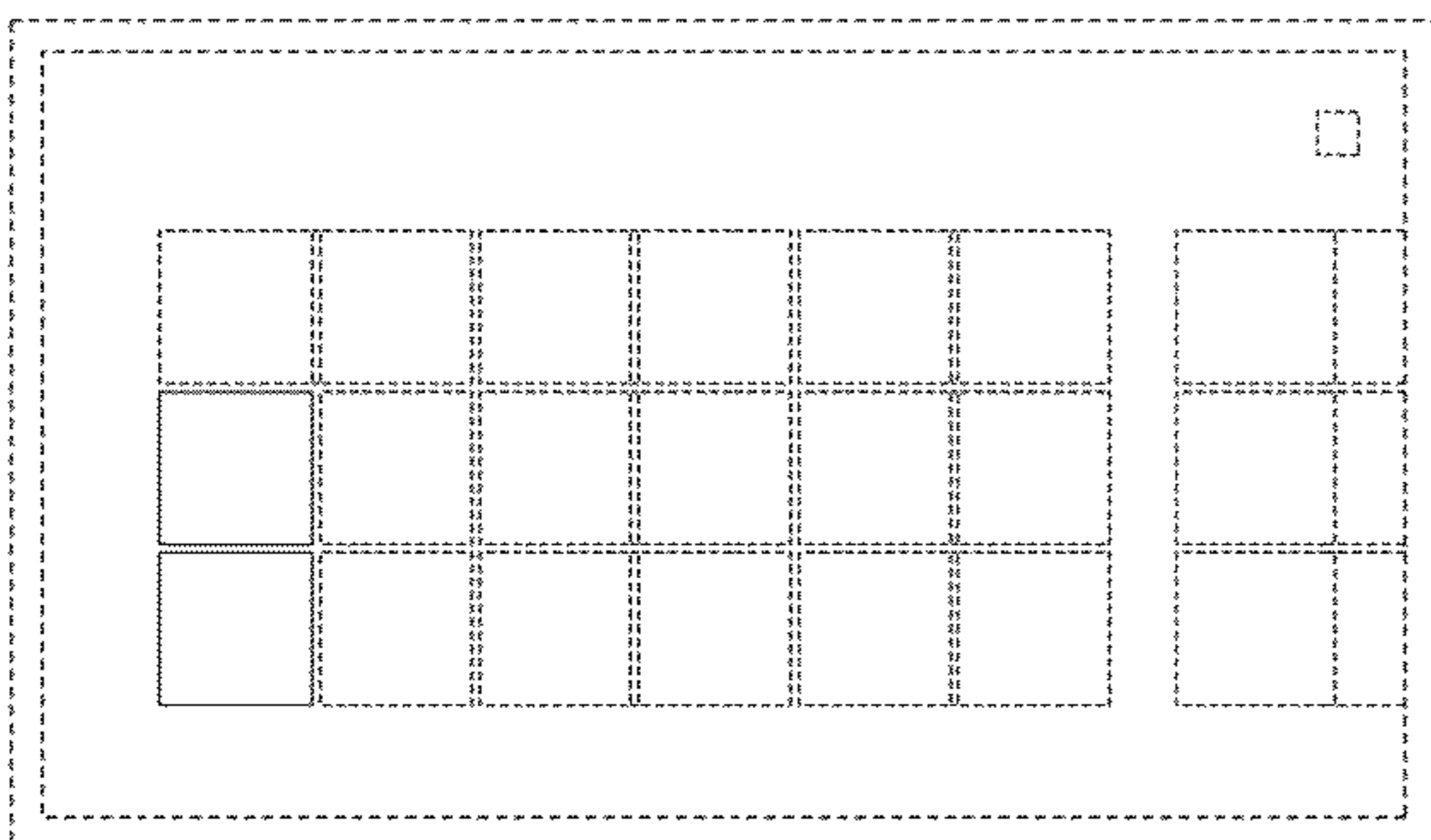
FIG. 10 is the fifth image thereof.

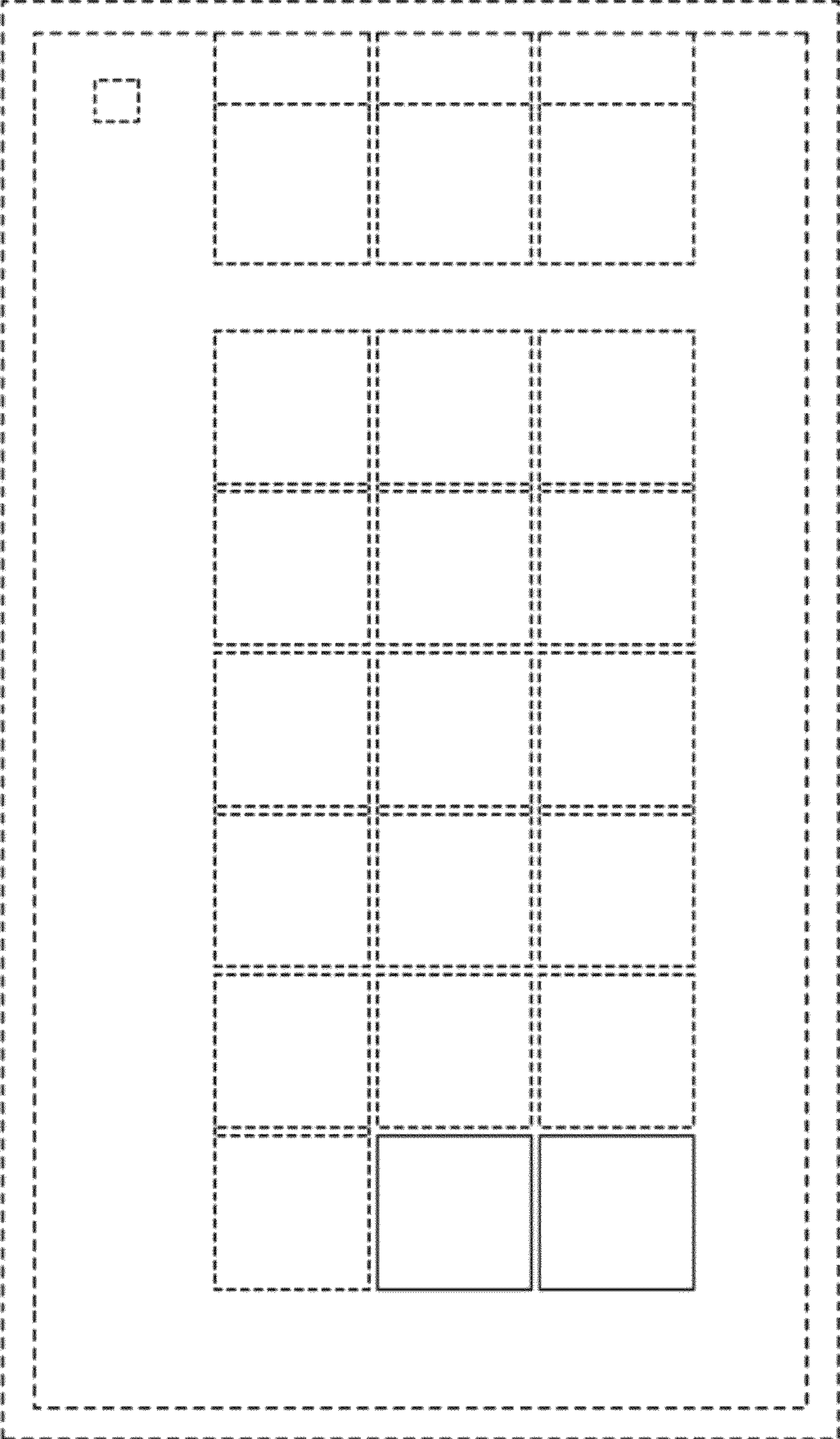

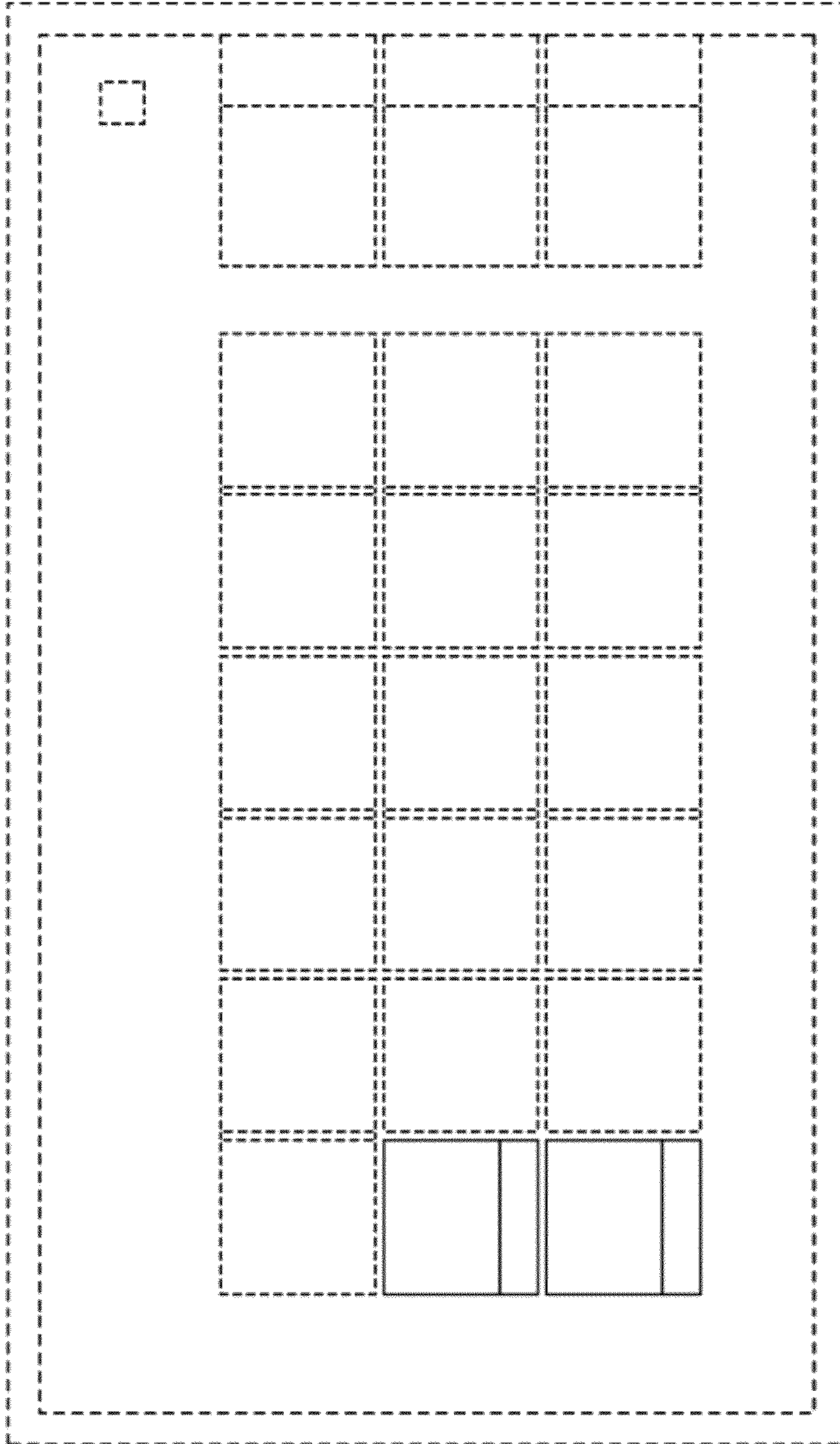

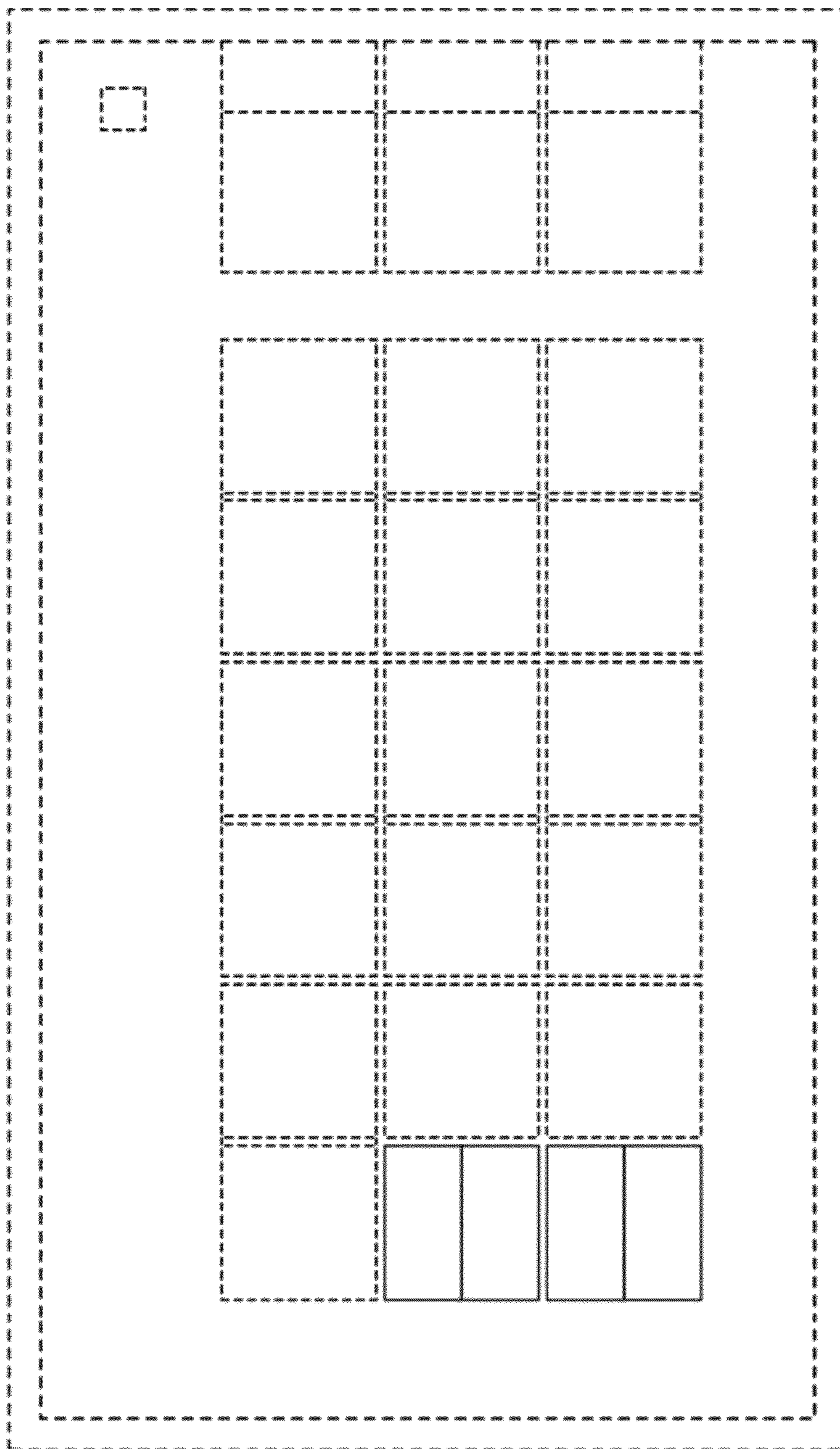

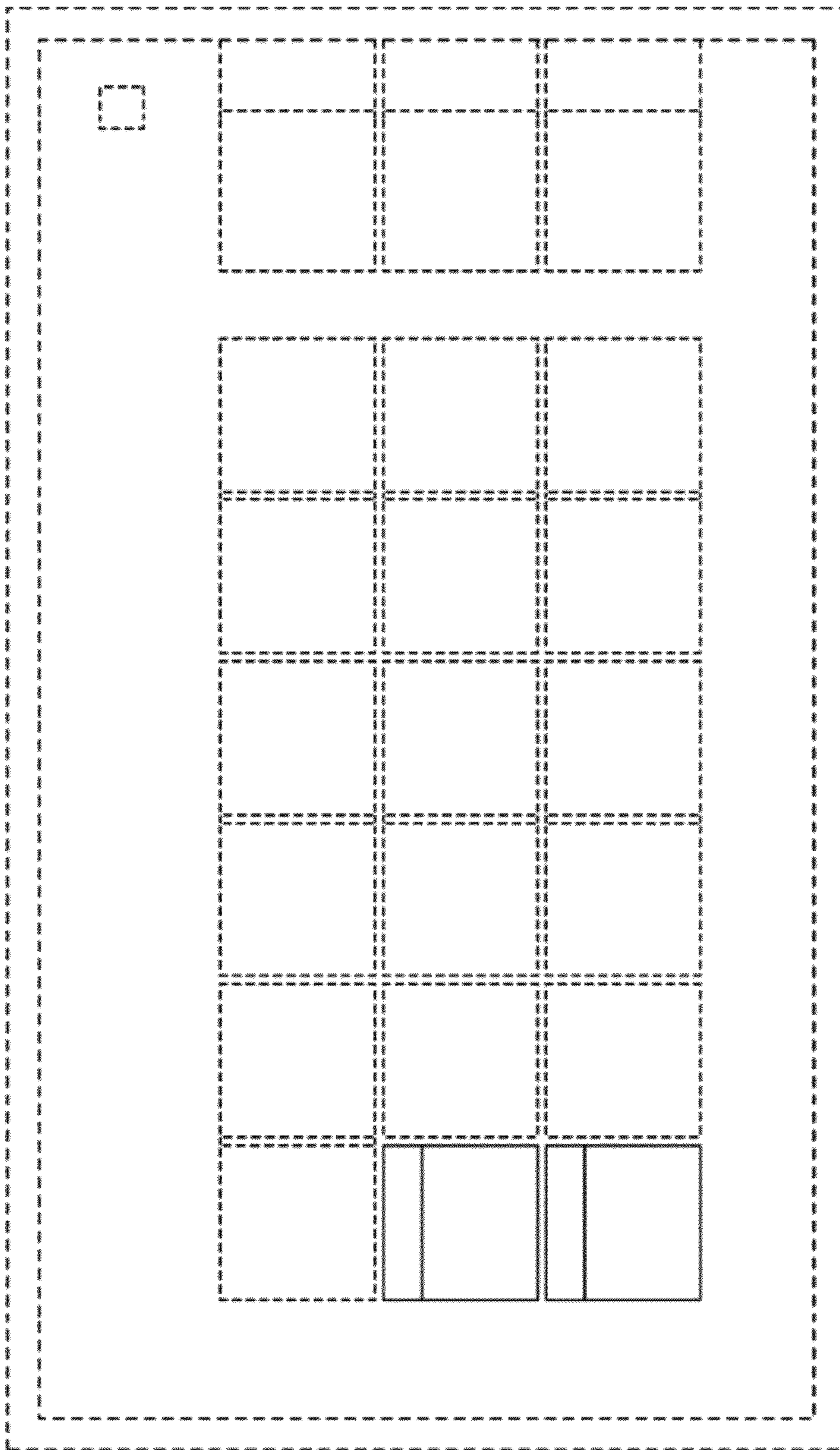

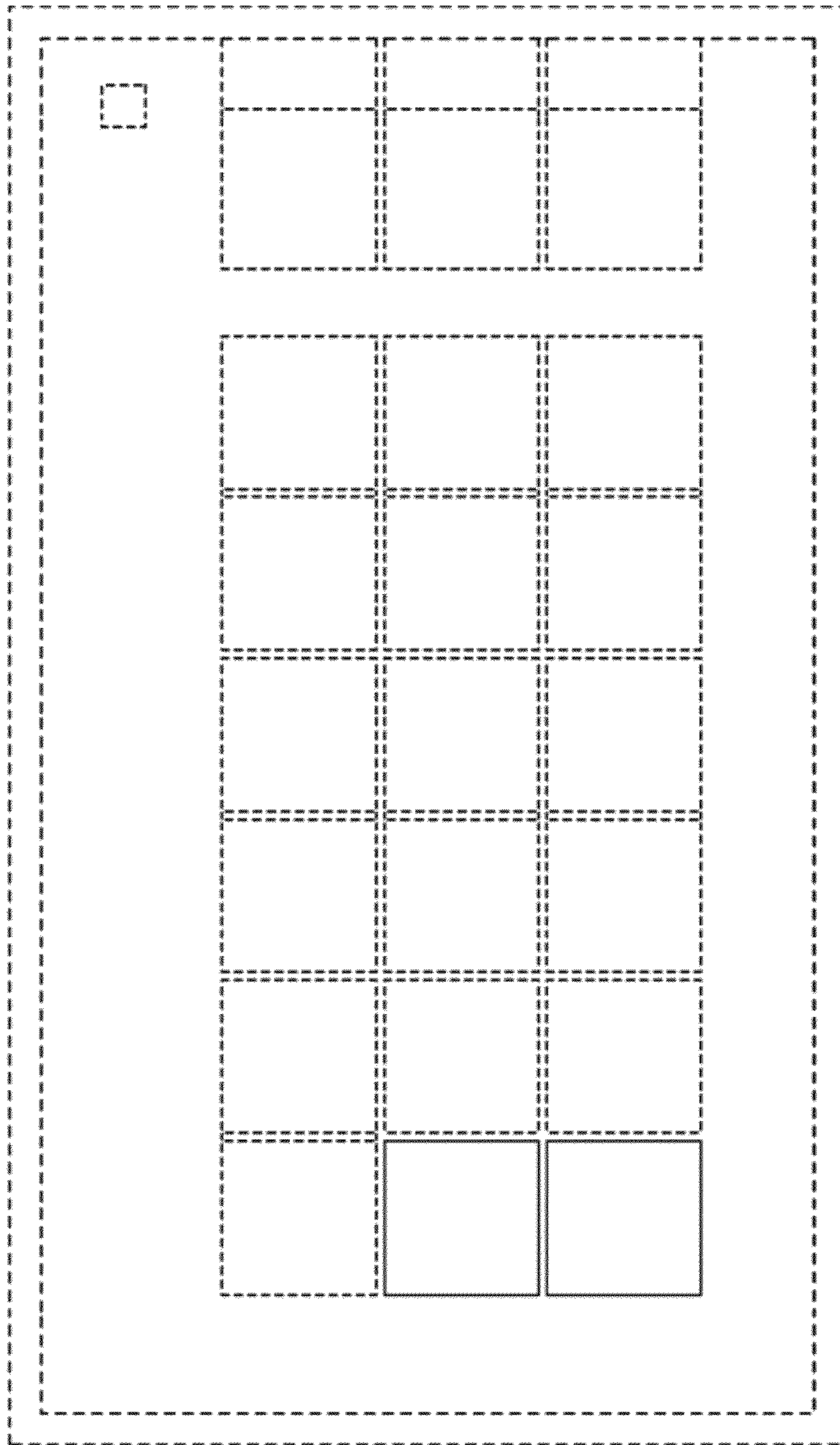

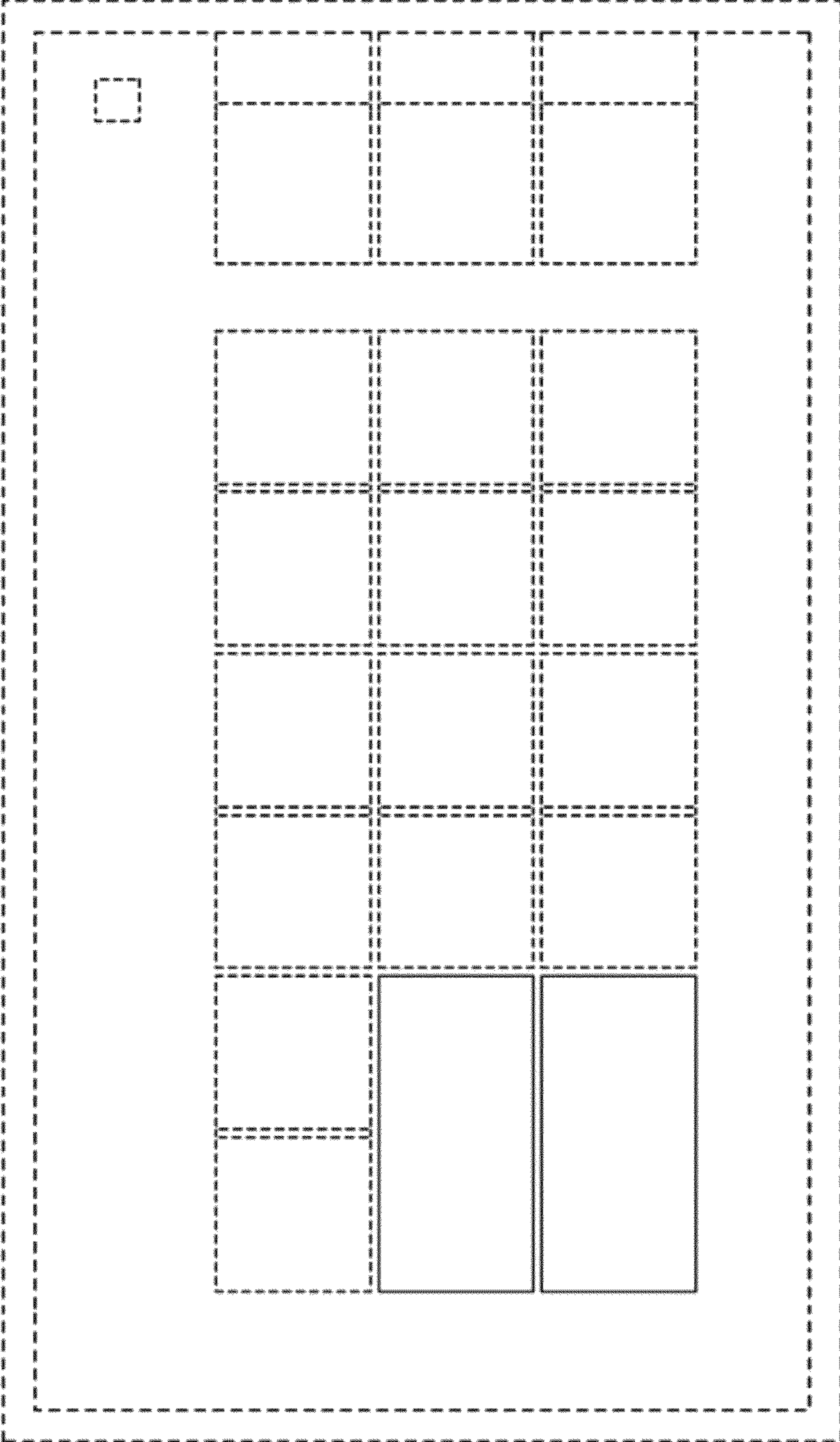

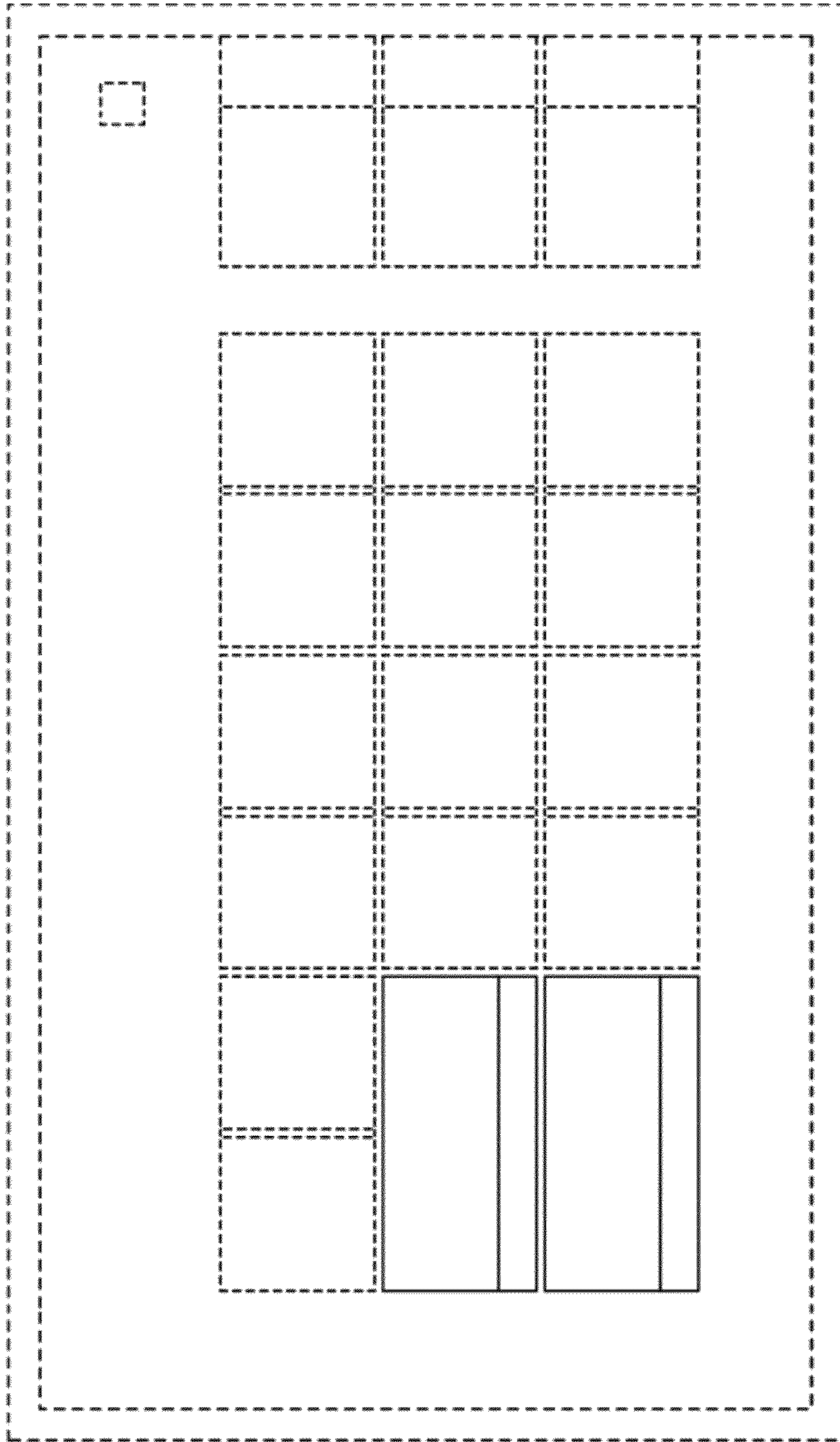

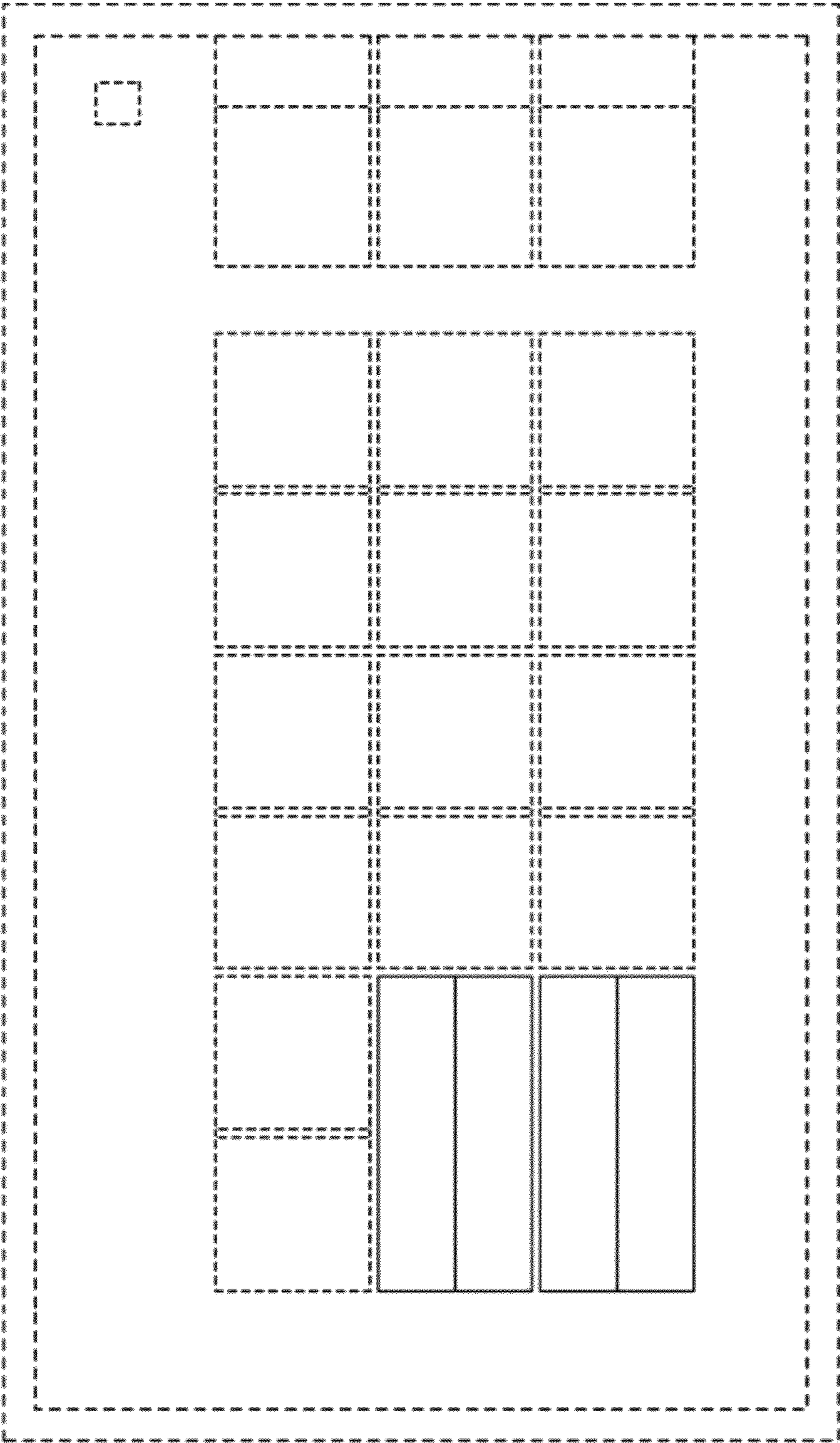

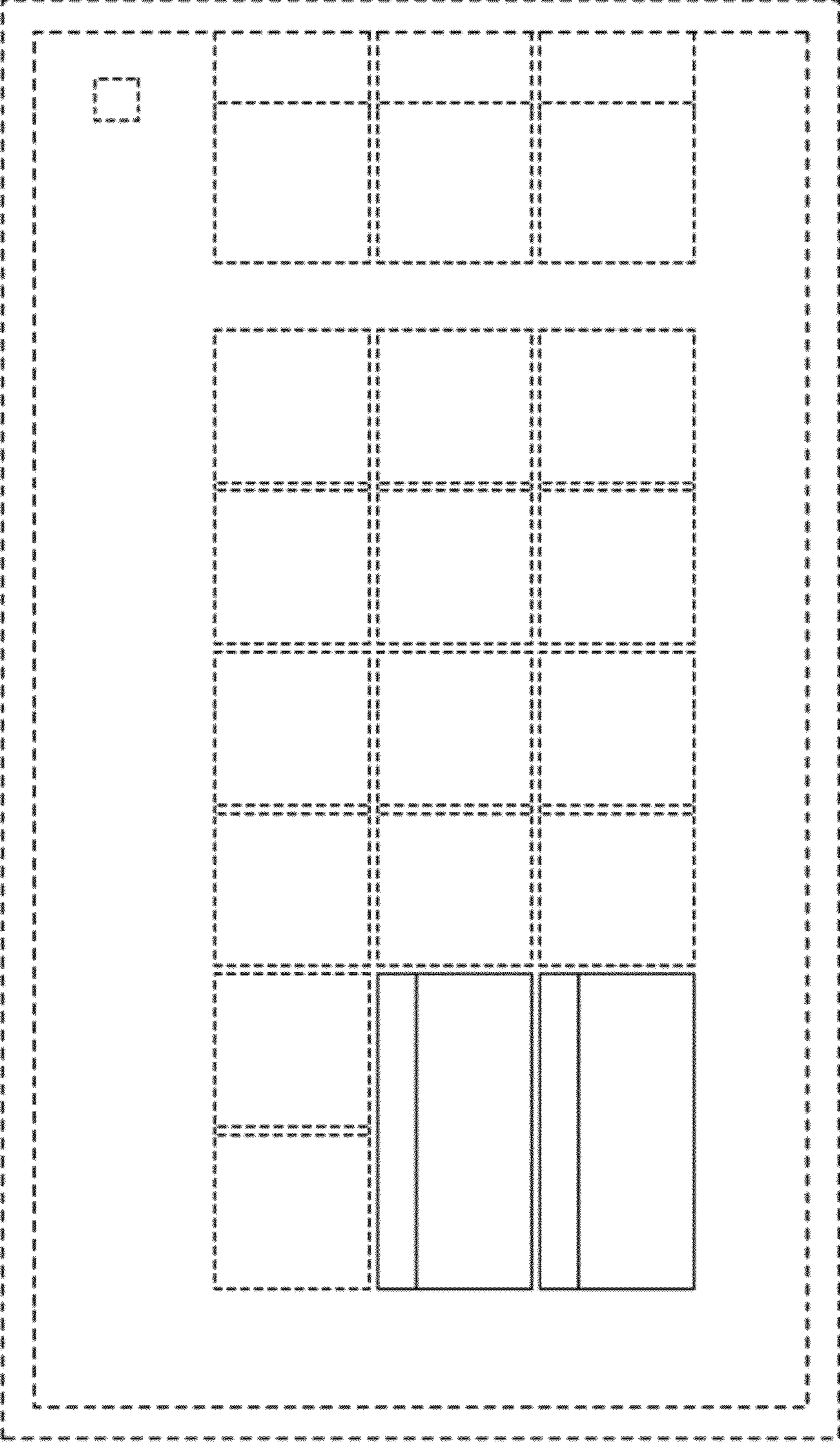

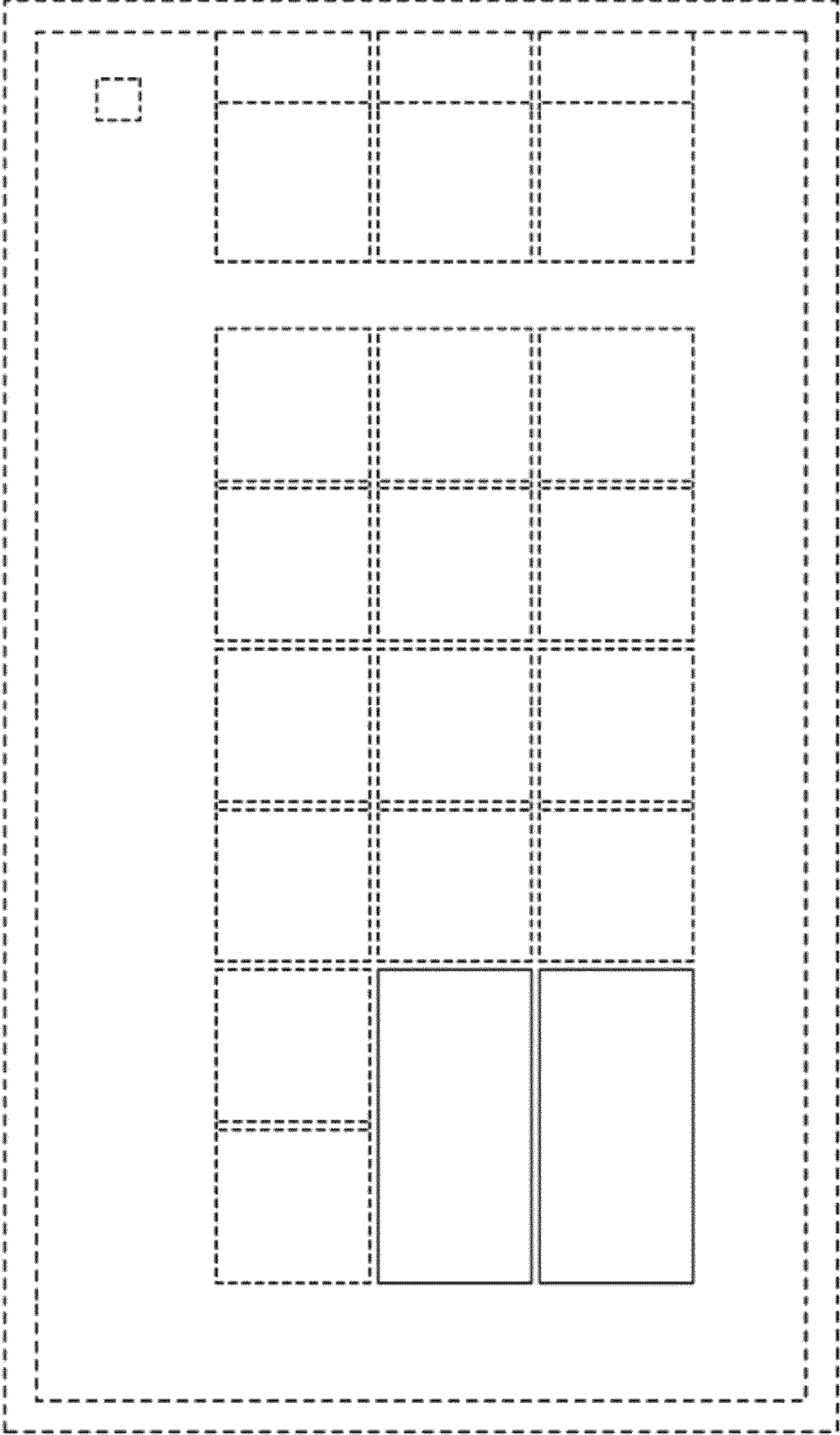
