The design for a mixer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the mixer showing the back, left side and top of the mixer.

FIG. 2 is a front elevation of the mixer shown in FIG. 1.

FIG. 3 is a right side elevation of the mixer.

FIG. 4 is a left side elevation of the mixer.

FIG. 5 is a back view of the mixer.

FIG. 6 is a top plan view of the mixer; and,

FIG. 7 is a bottom view of the mixer.

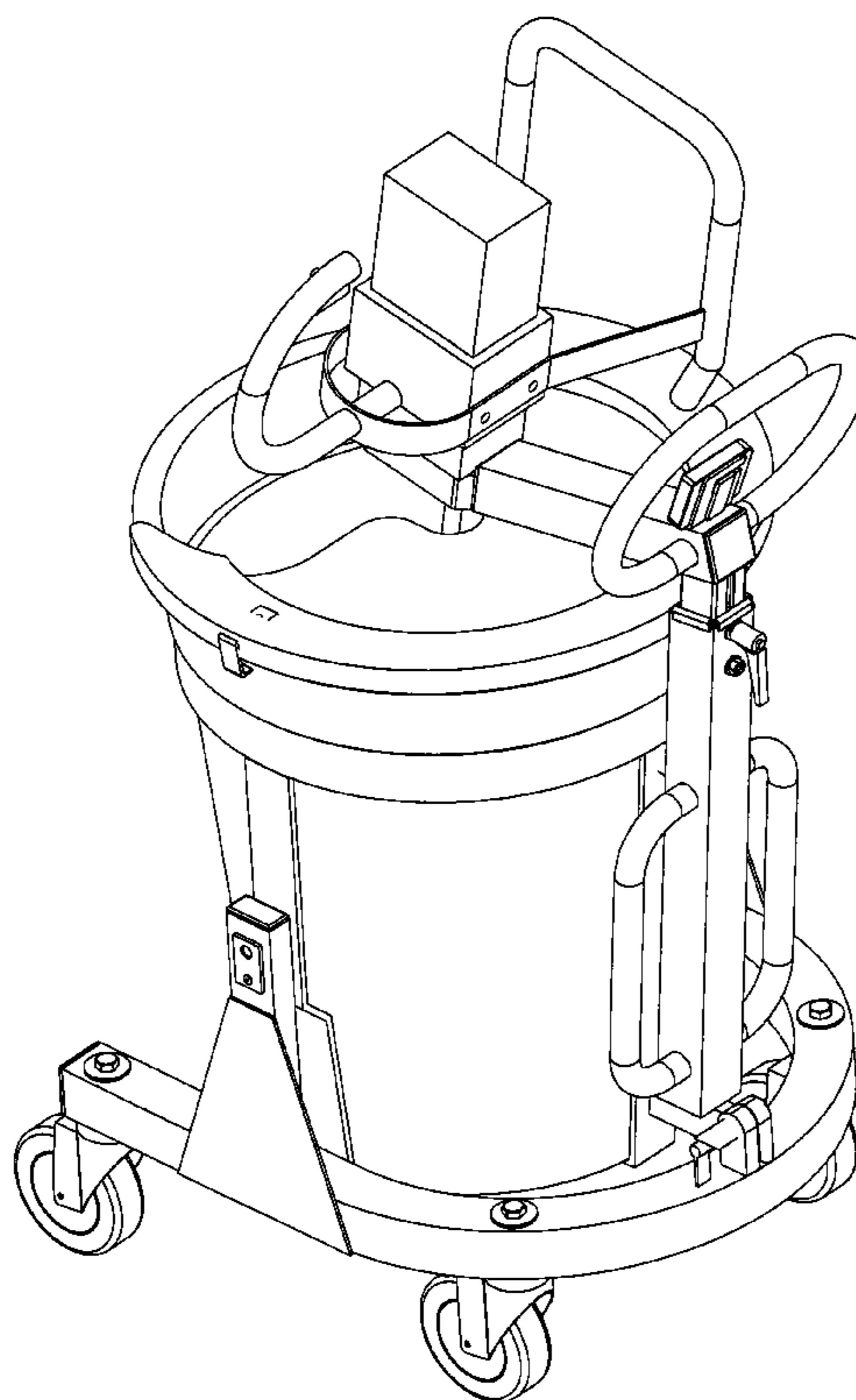

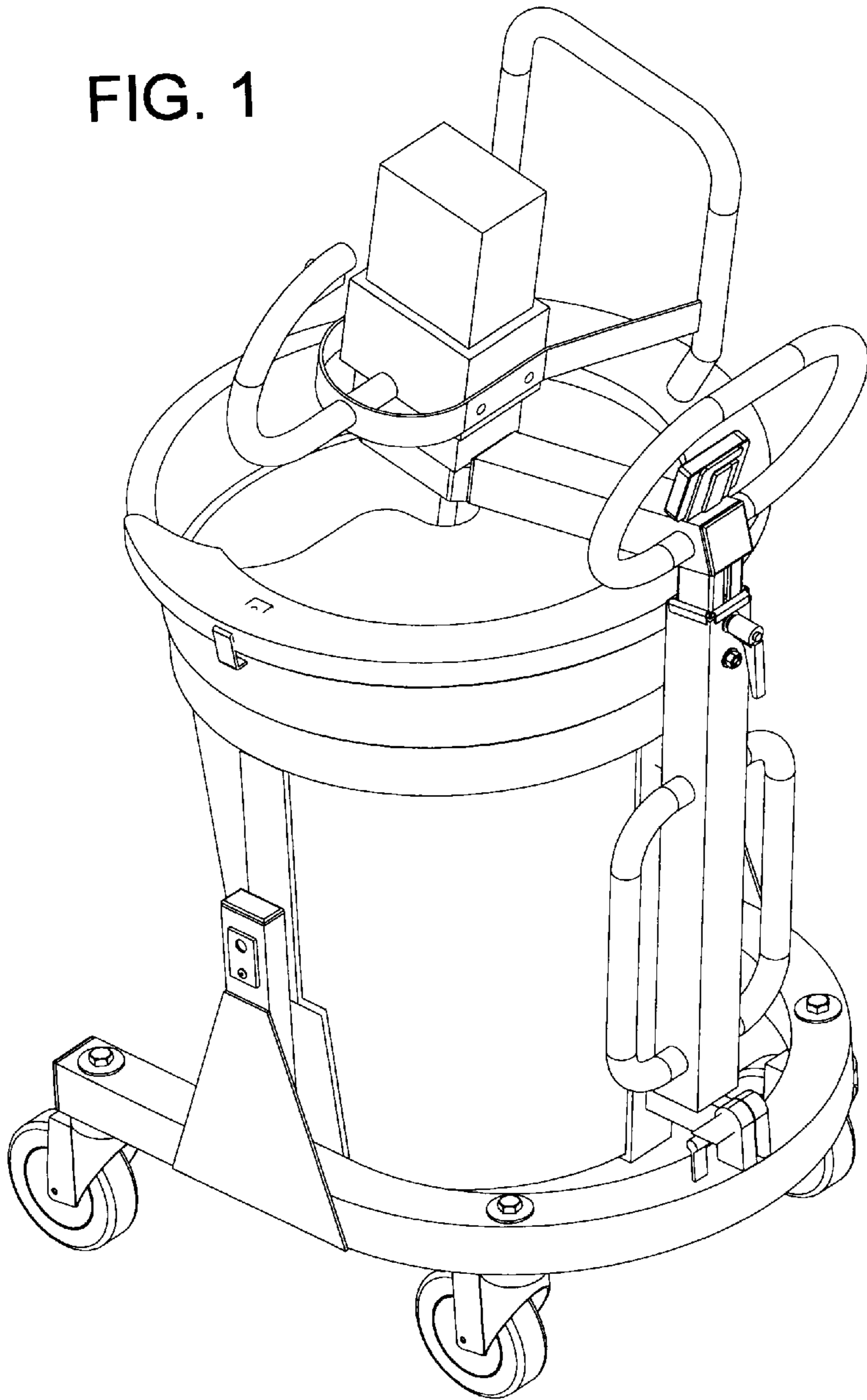
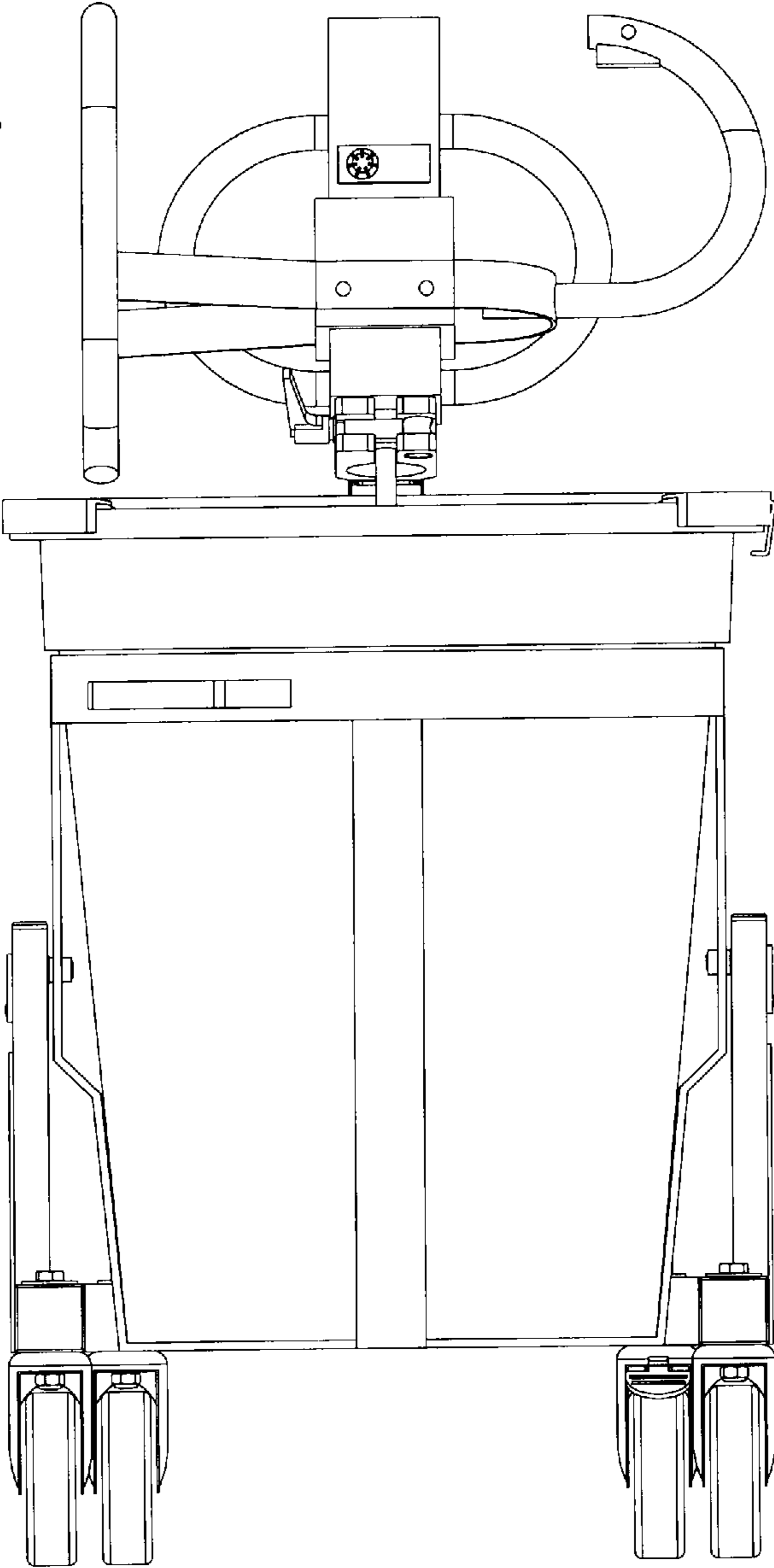

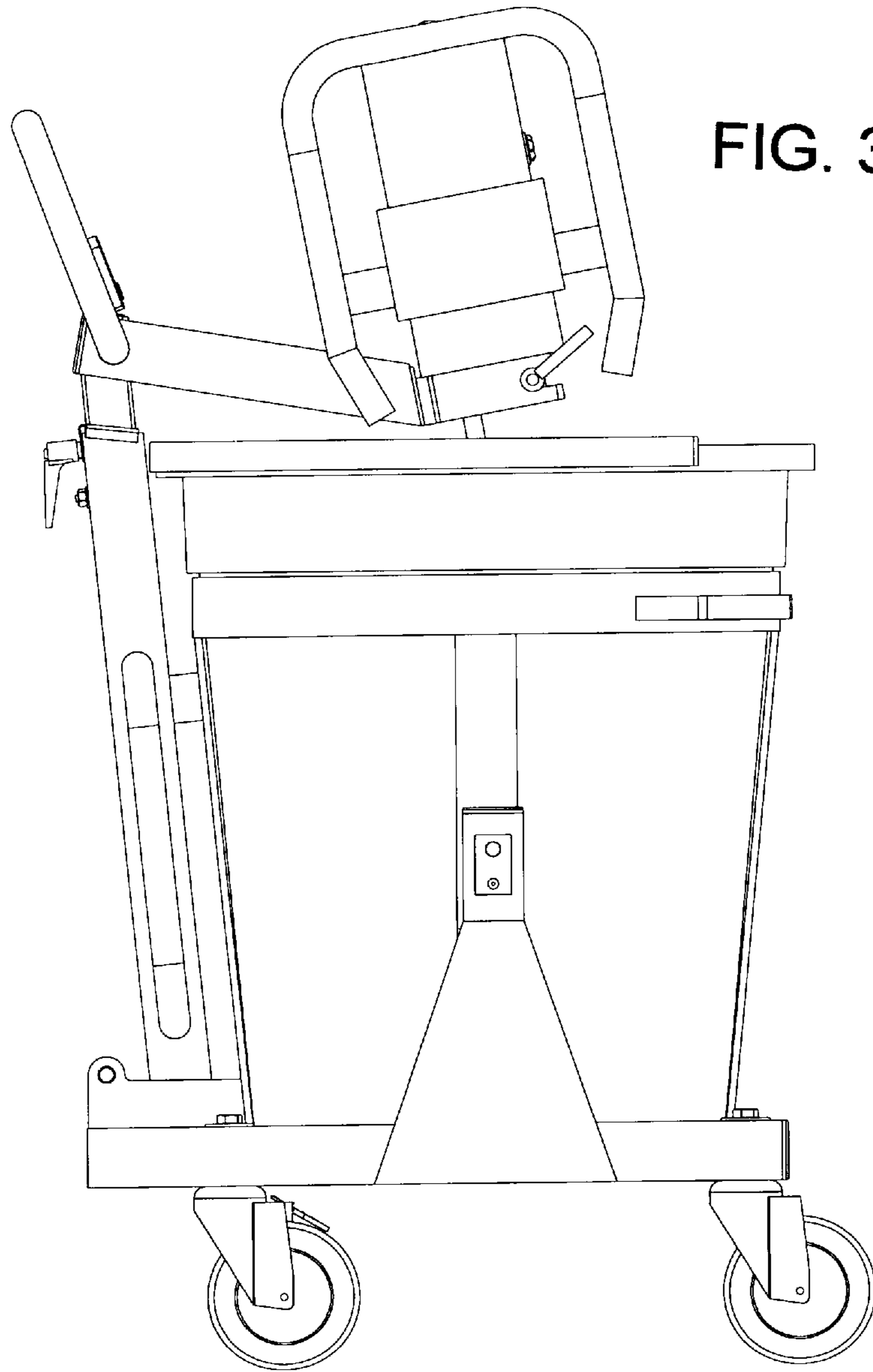
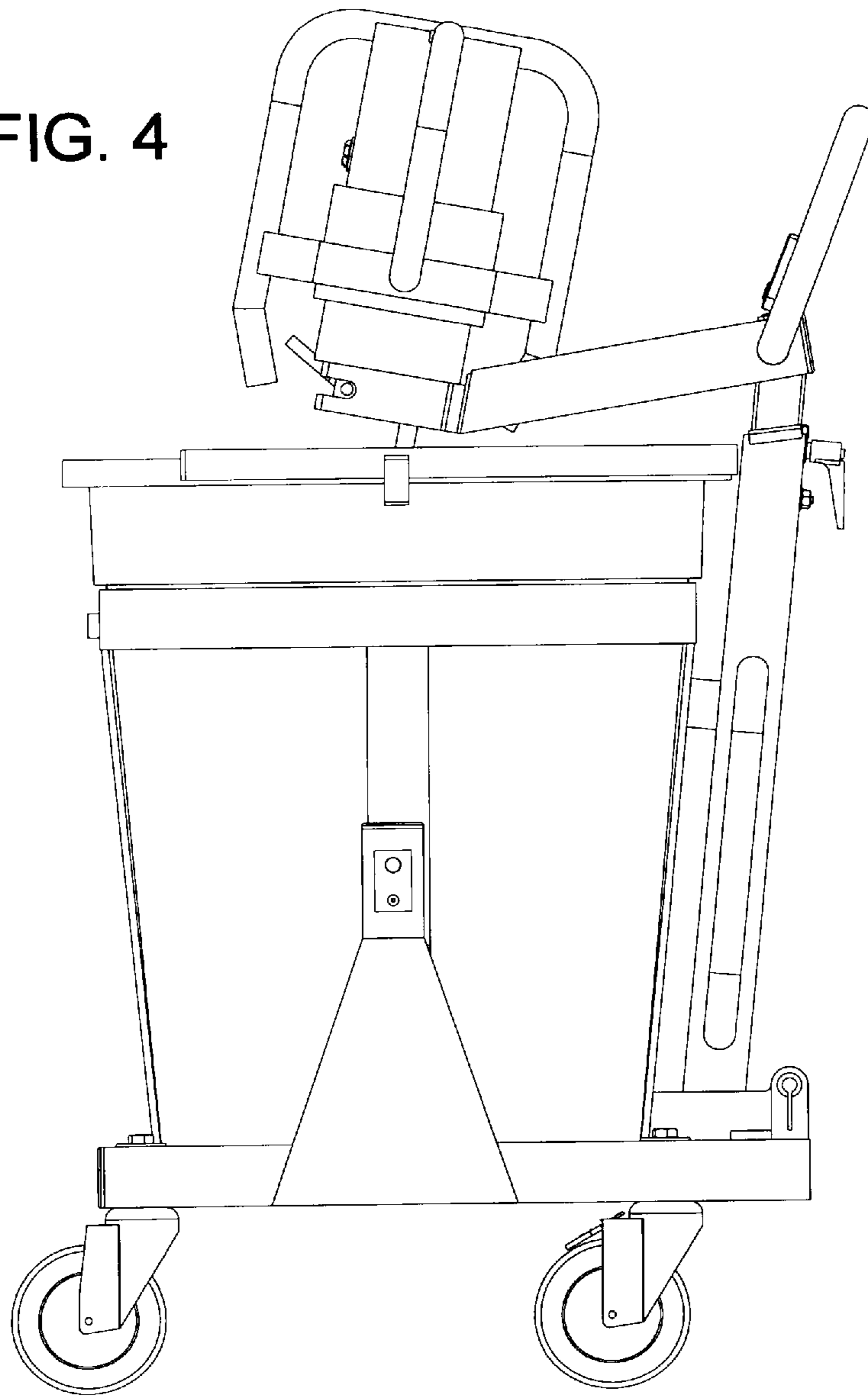

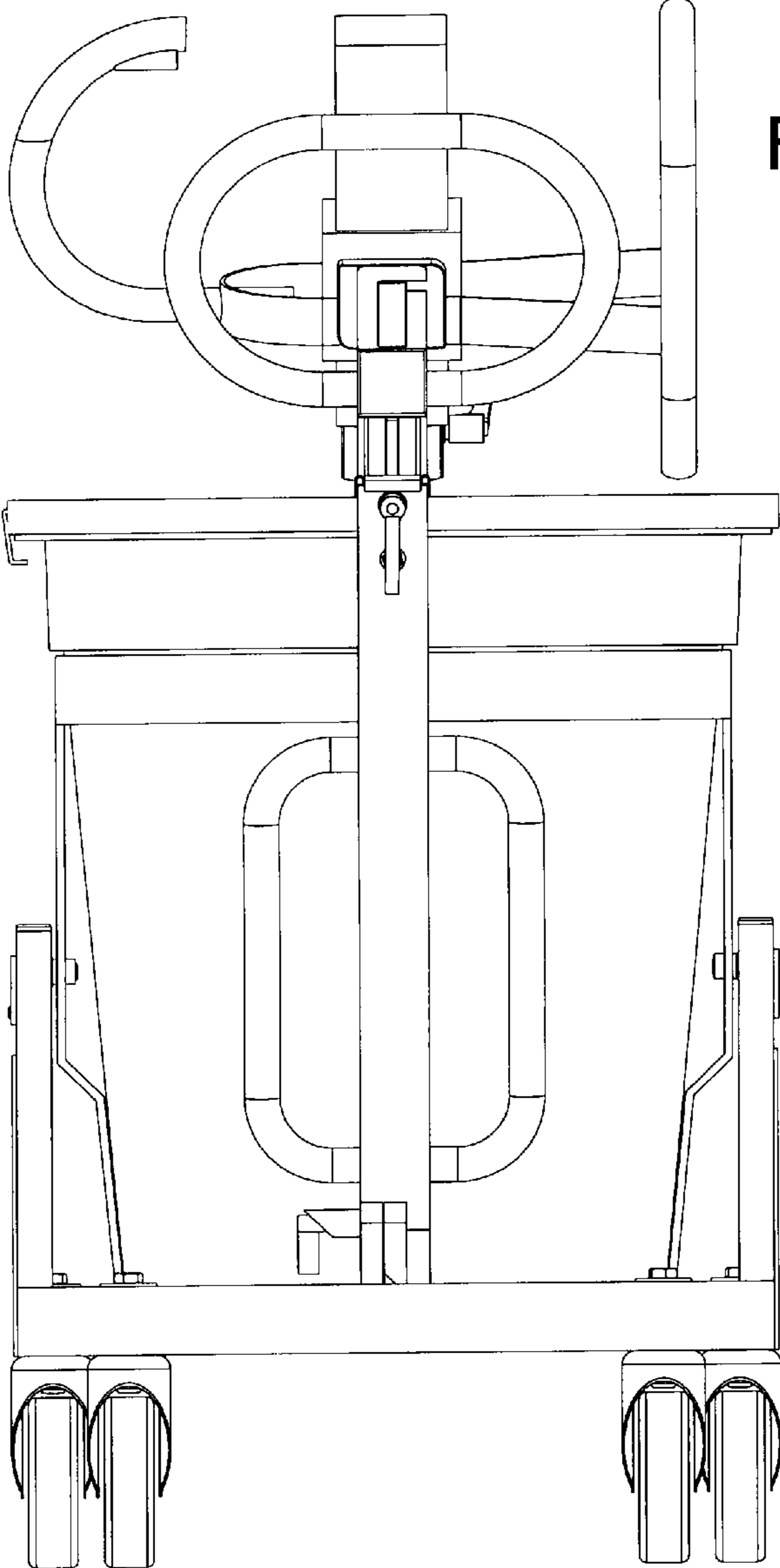

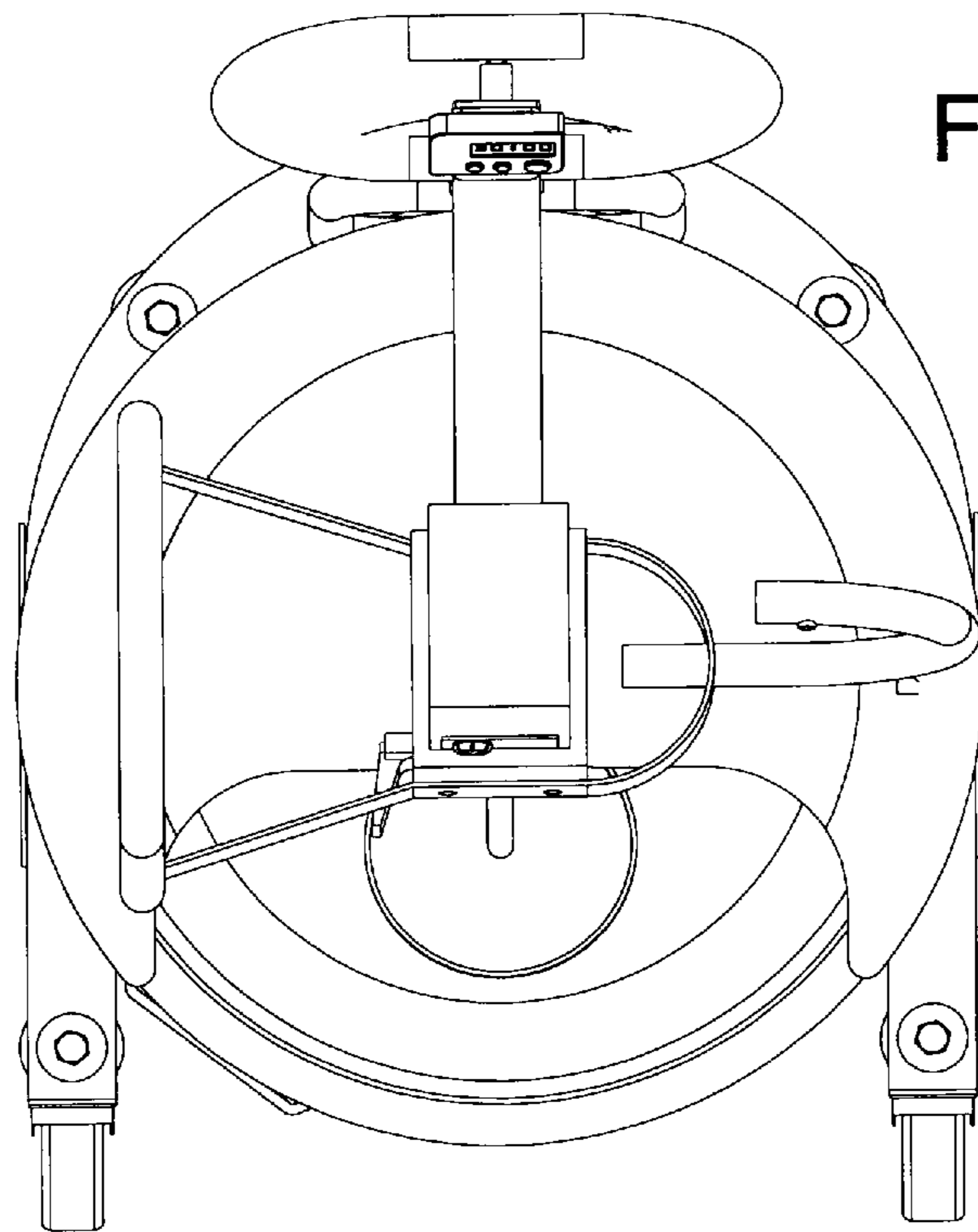

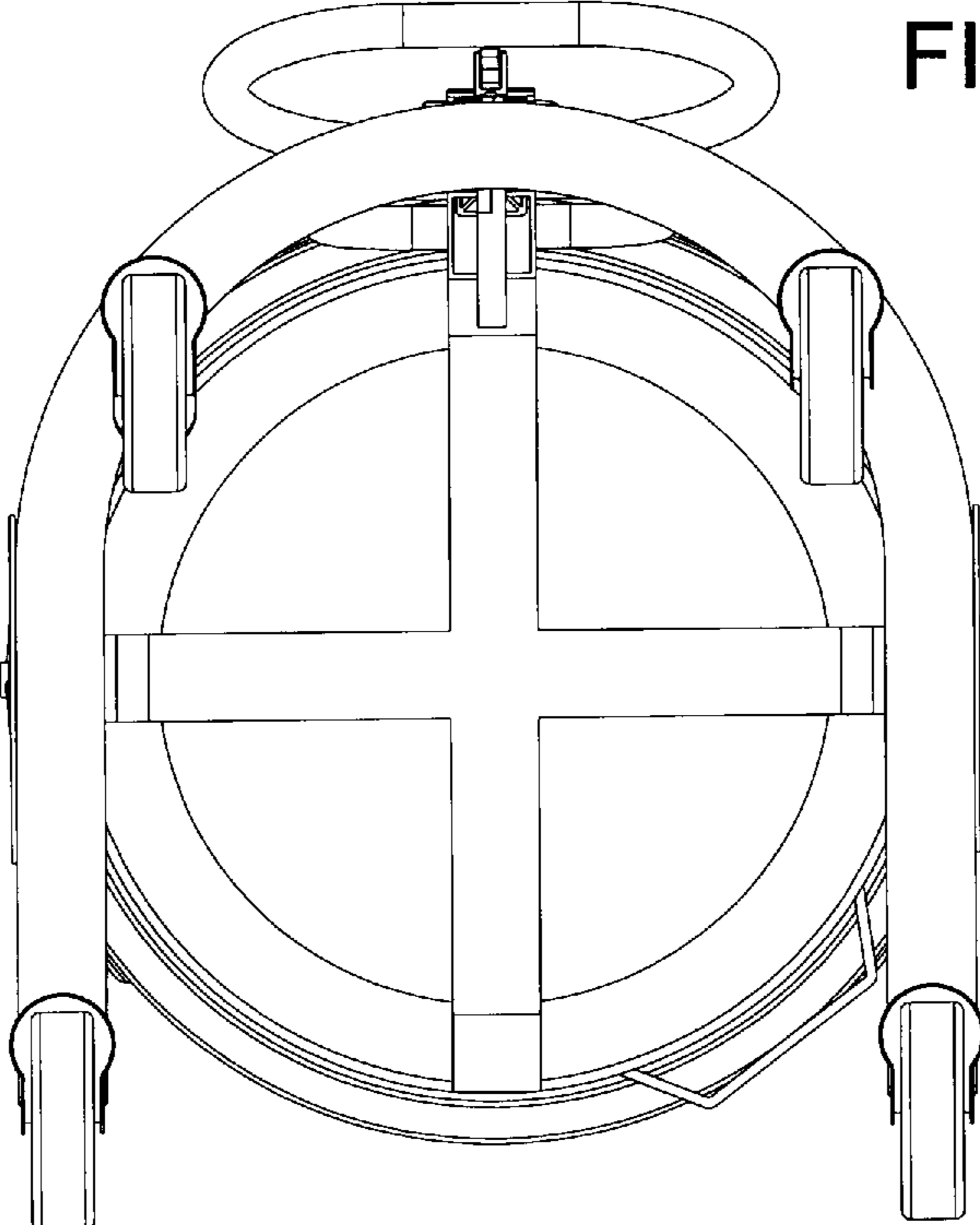
