FIG. 2 is a rear view of a second embodiment of our new design of the label support sheet;

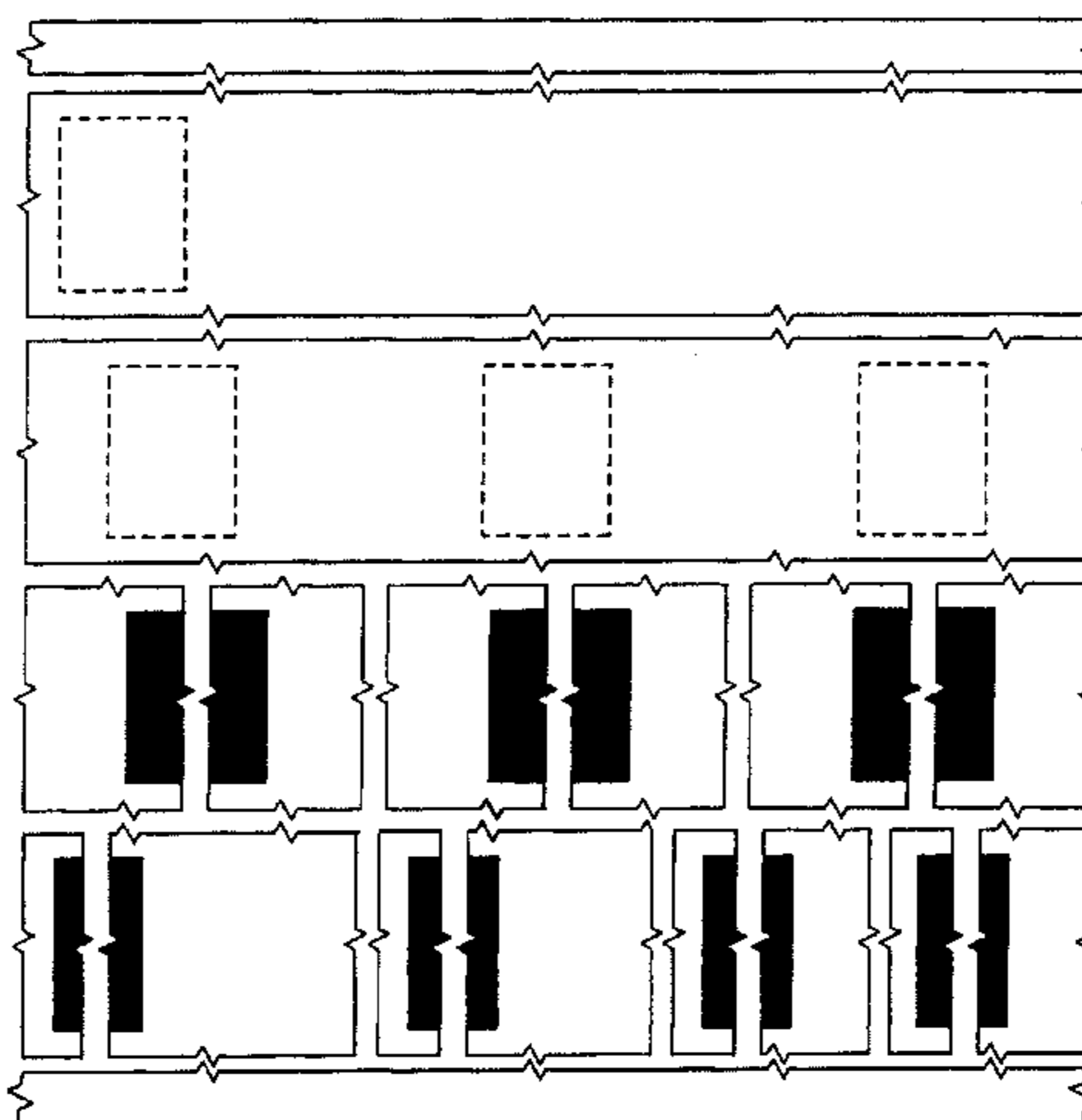
FIG. 3 is a front view of the first embodiment of the label support sheet of FIG. 1; and,

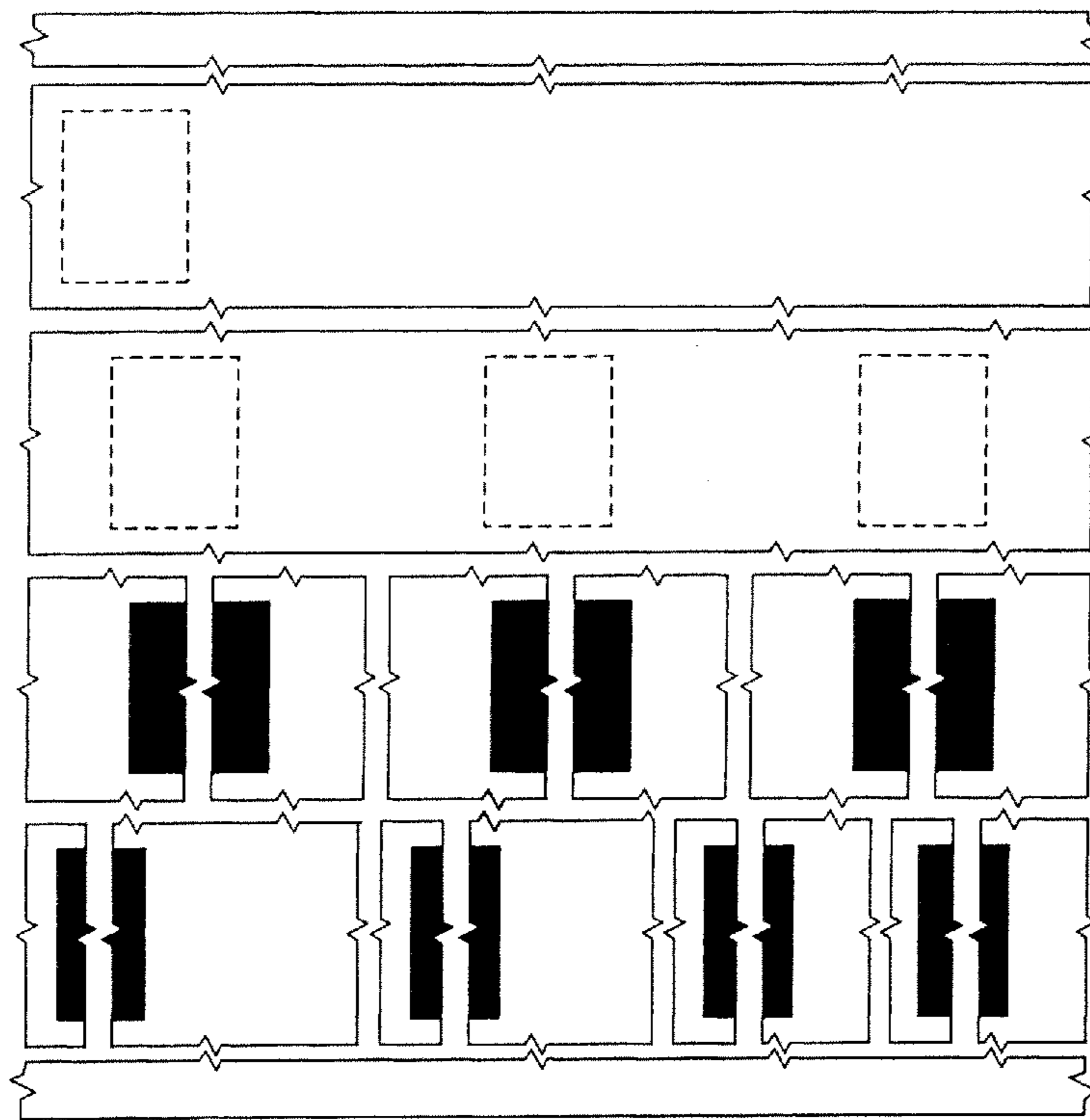

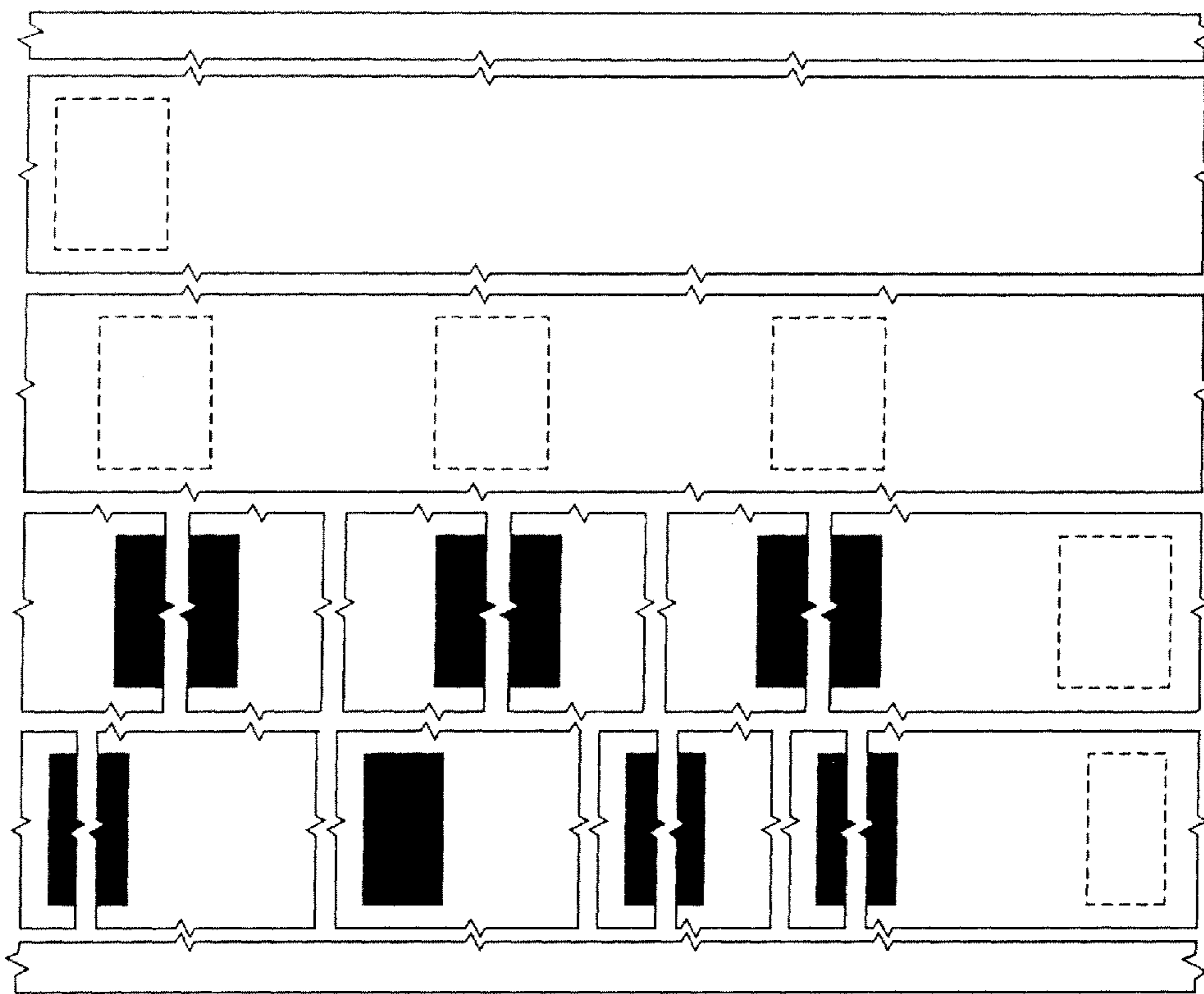

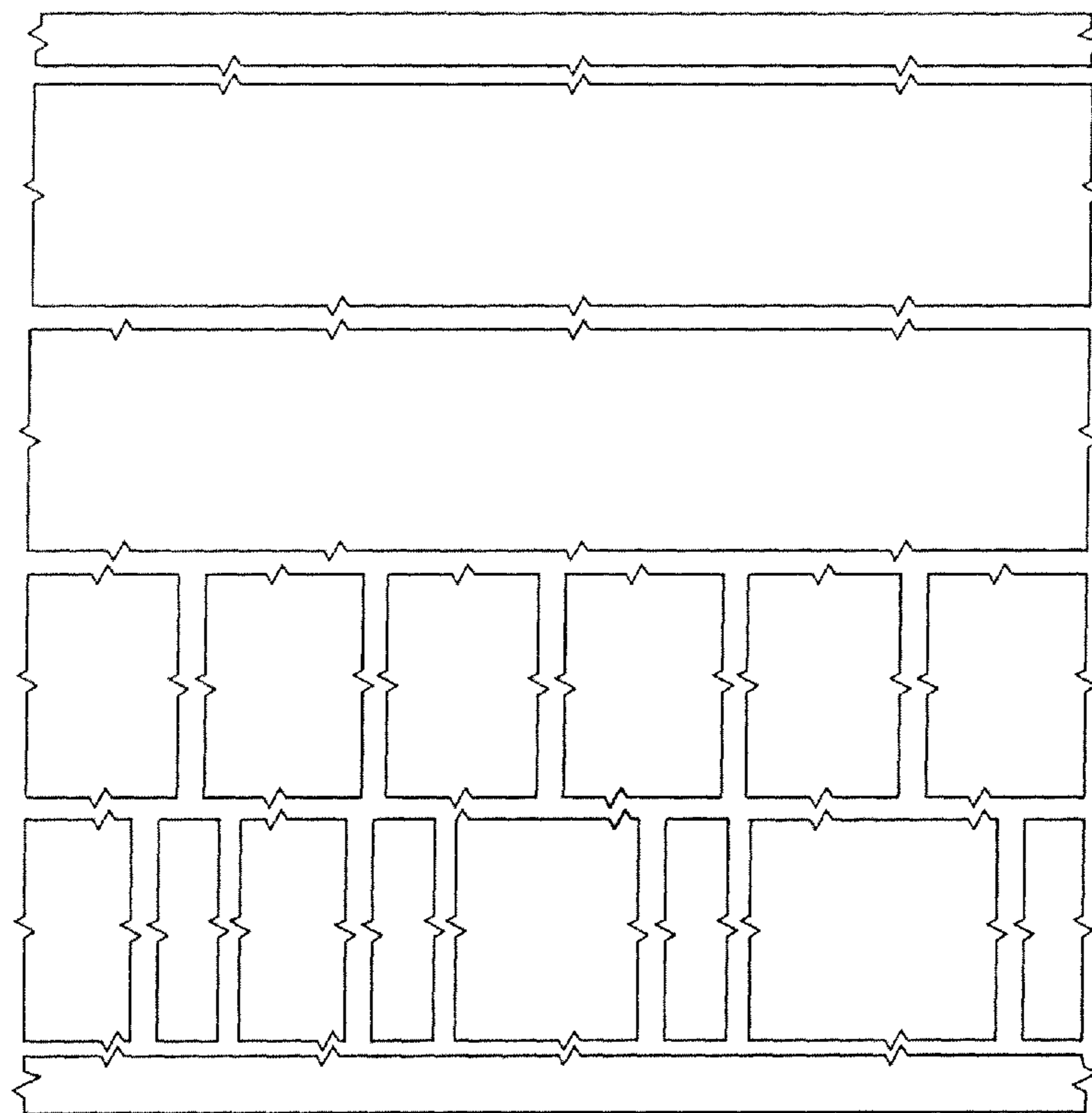

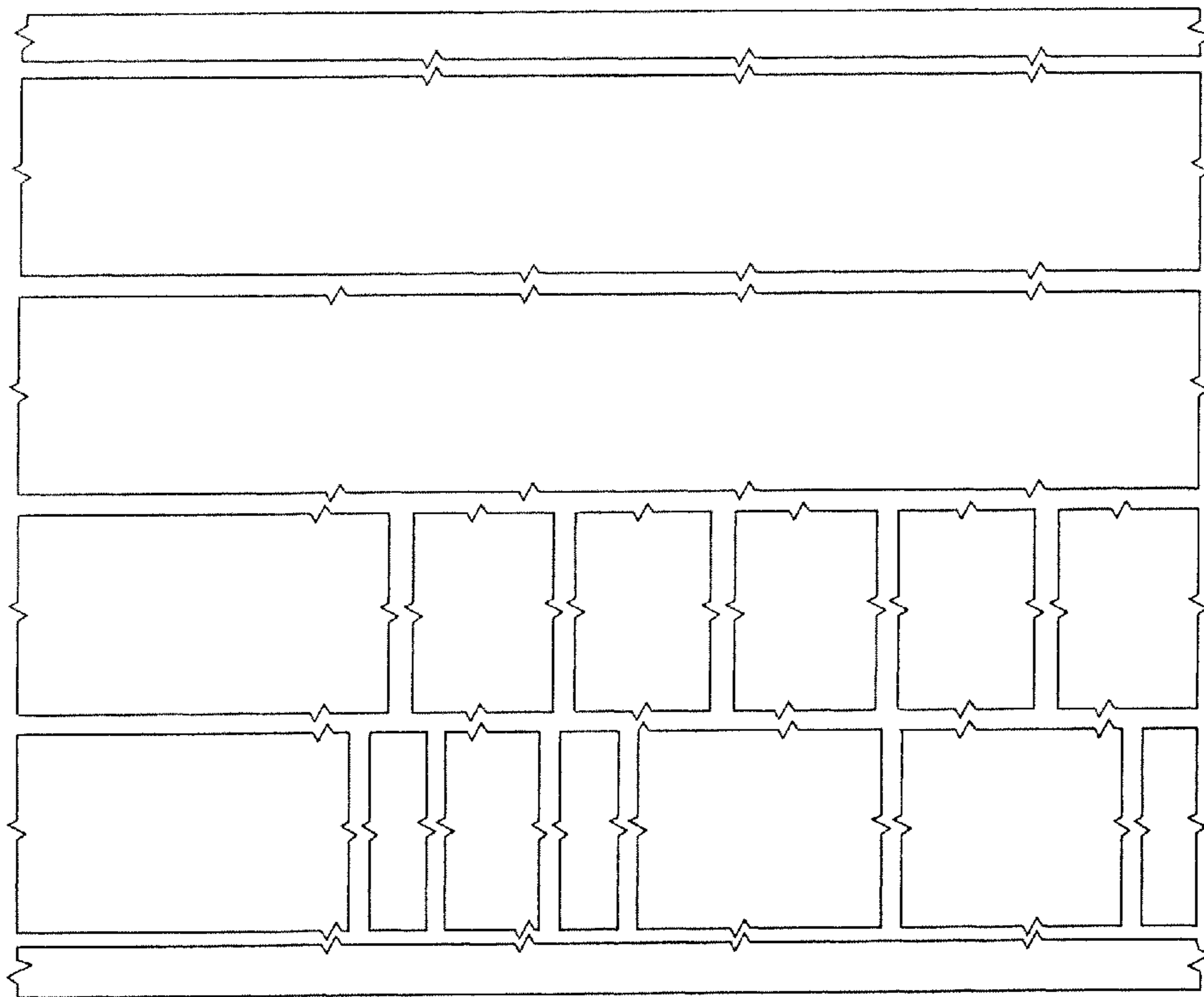
