The ornamental design for a pedestal humidifier, as shown and described.

DESCRIPTION

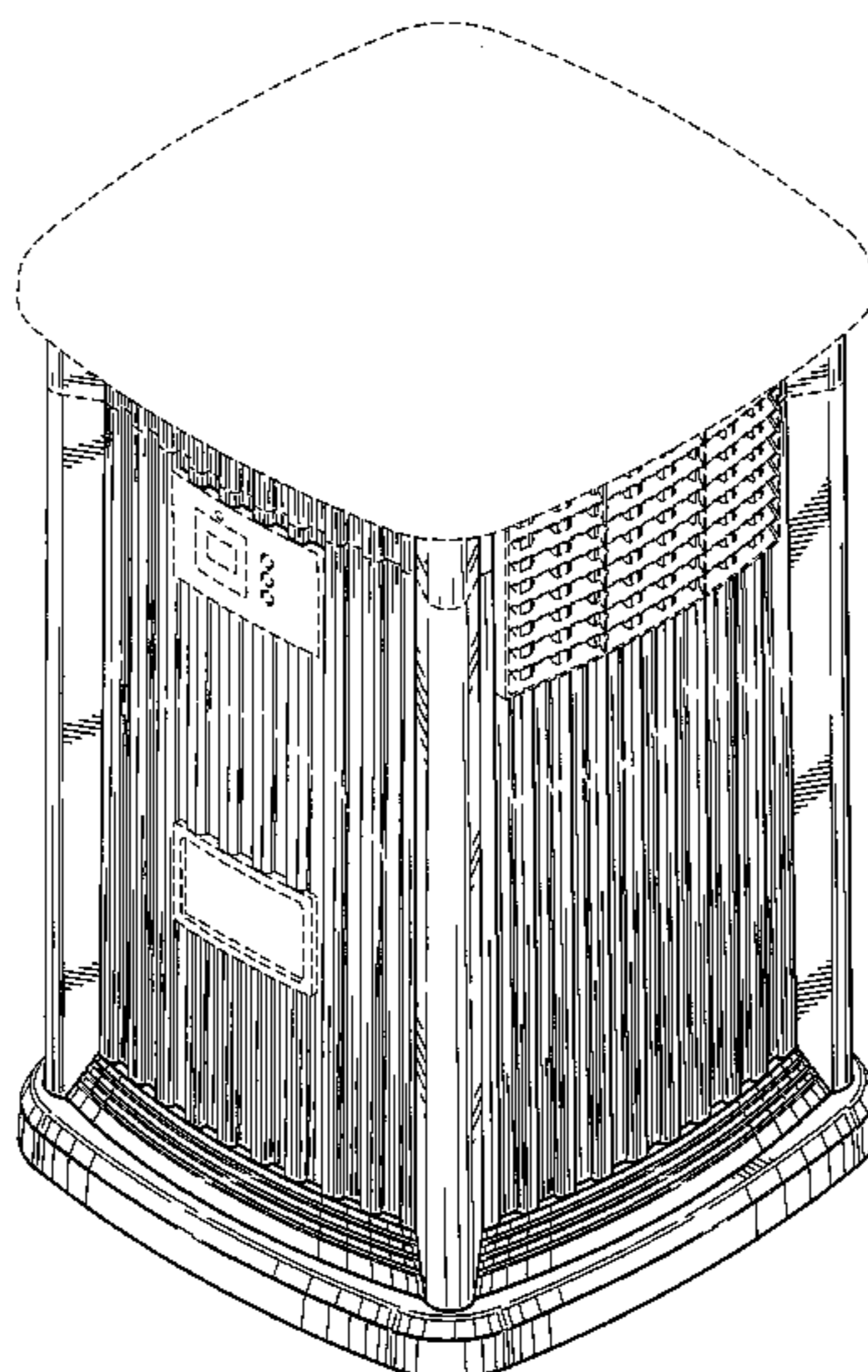
FIG. 1 is a perspective view from the top, front, and right of the pedestal humidifier;
FIG. 2 is a perspective view from the top, rear, and left side of the pedestal humidifier of FIG. 1;
FIG. 3 is a front elevation view of the pedestal humidifier of FIG. 1;
FIG. 4 is a right side elevation view of the pedestal humidifier of FIG. 1, the left side being a mirror image thereof;
FIG. 5 is a rear elevation view of the pedestal humidifier of FIG. 1;
FIG. 6 is a top view of the pedestal humidifier of FIG. 1; and,
FIG. 7 is a bottom view of the pedestal humidifier of FIG. 1.
The portions of the pedestal humidifier shown in broken lines depict environmental subject matter only and form no part of the claimed design.

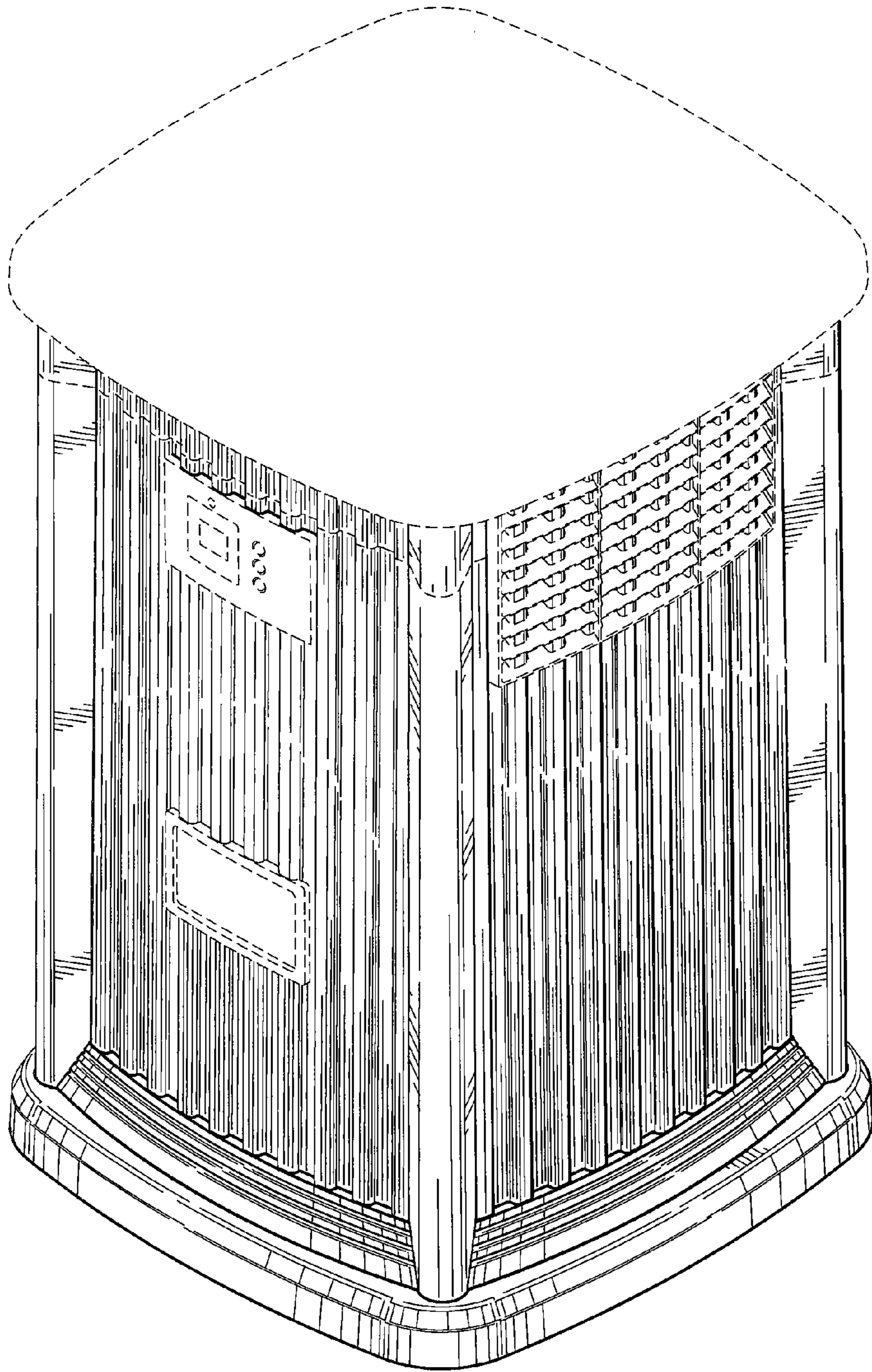

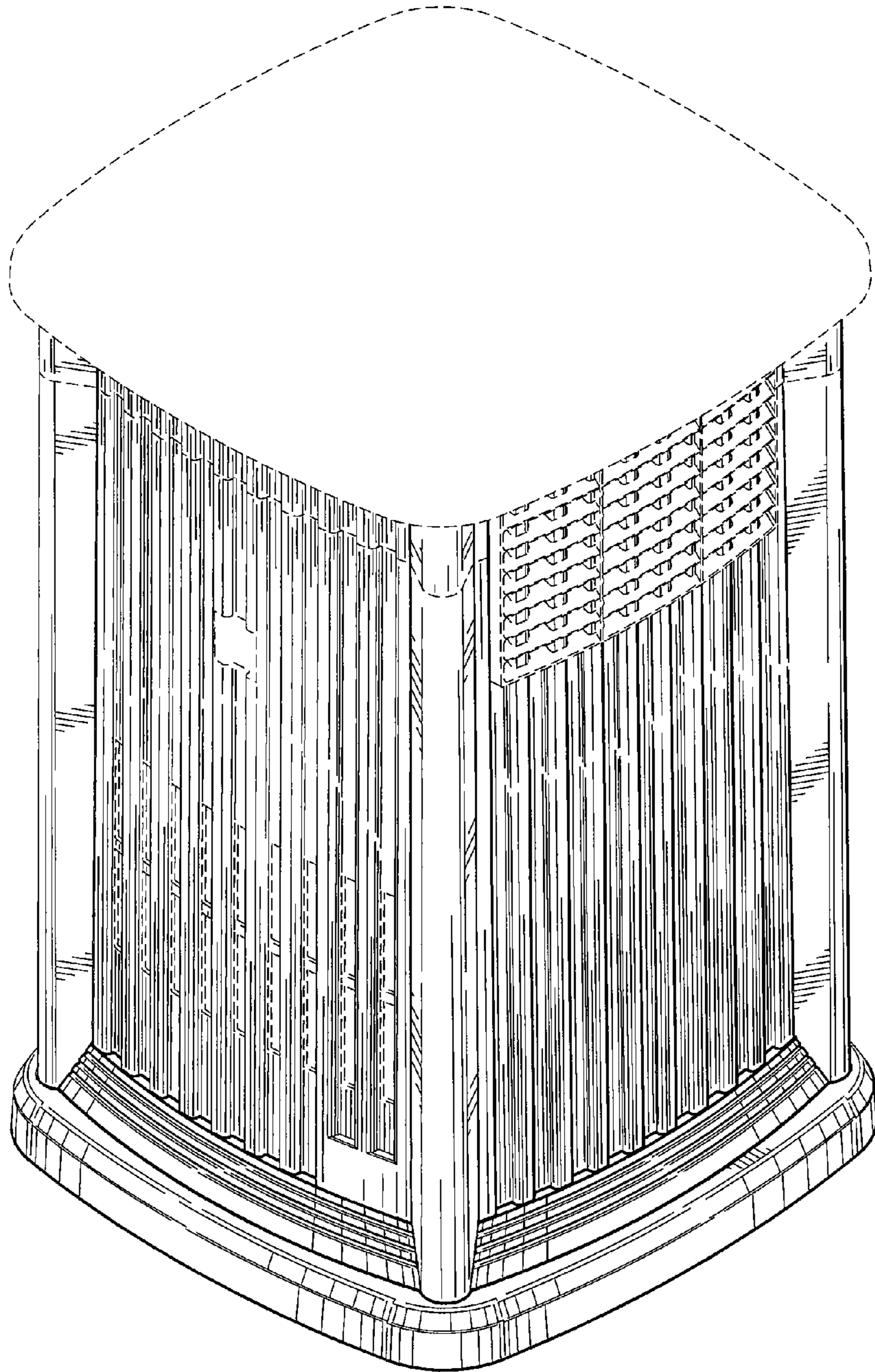

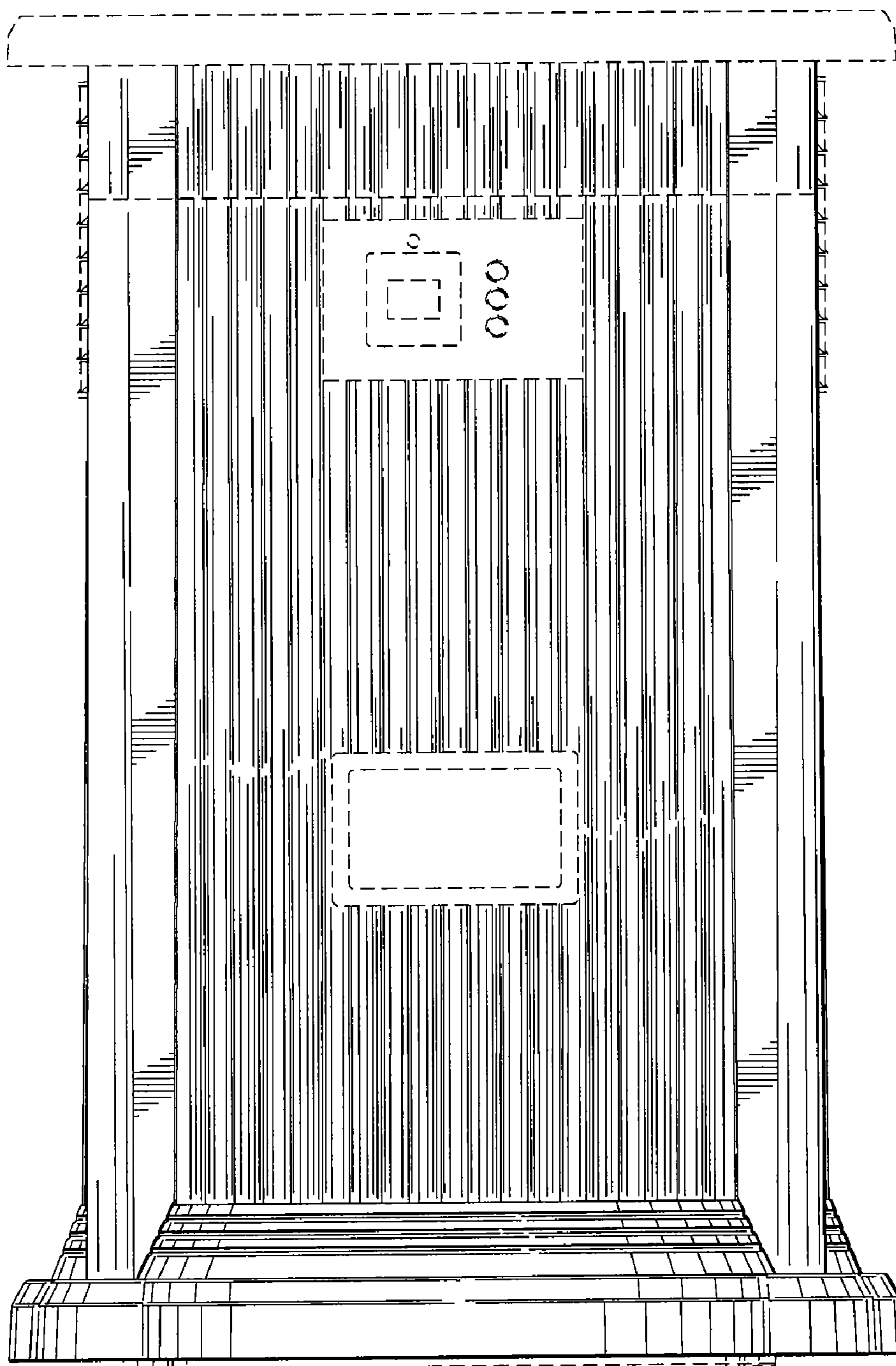

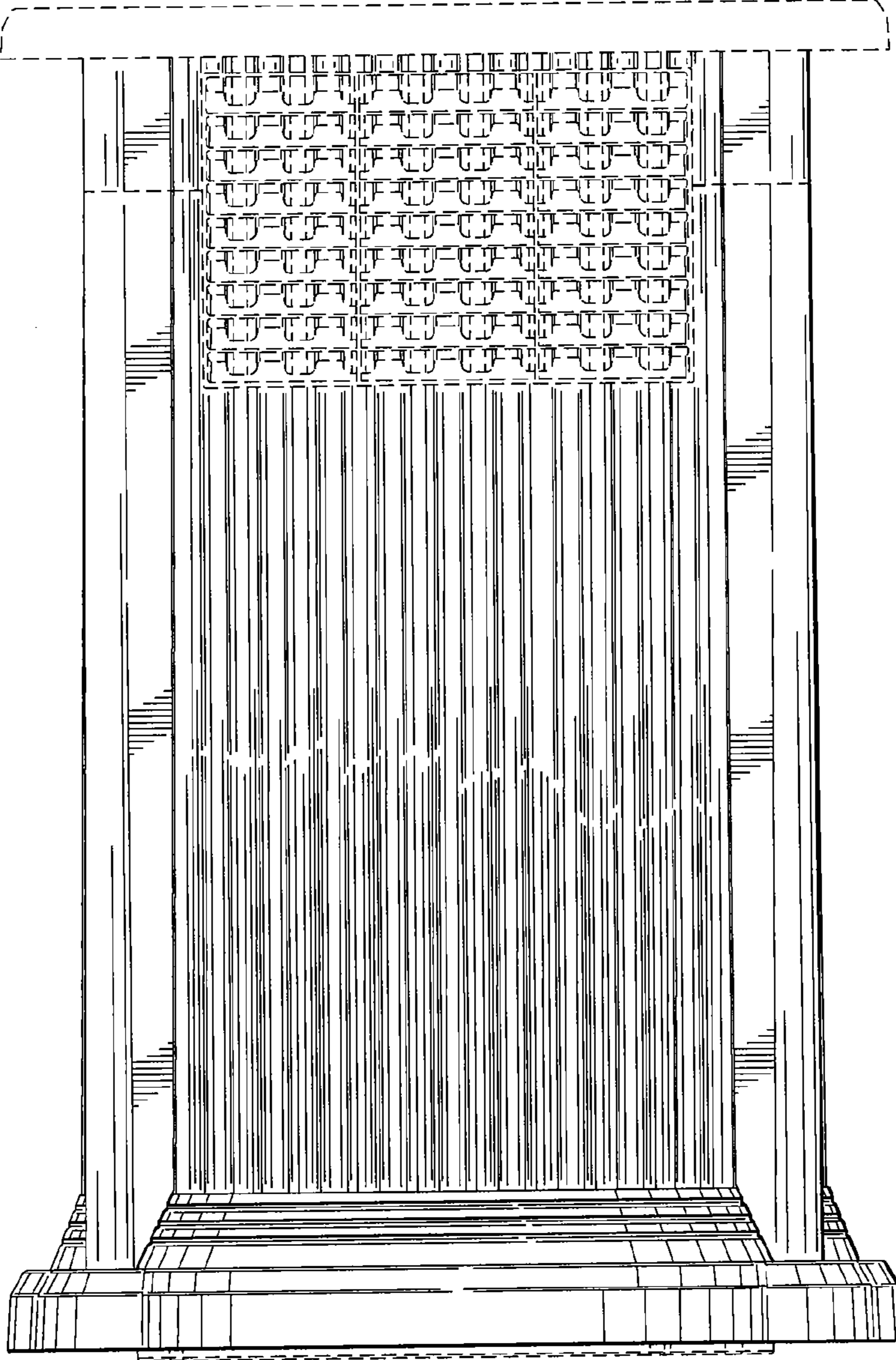

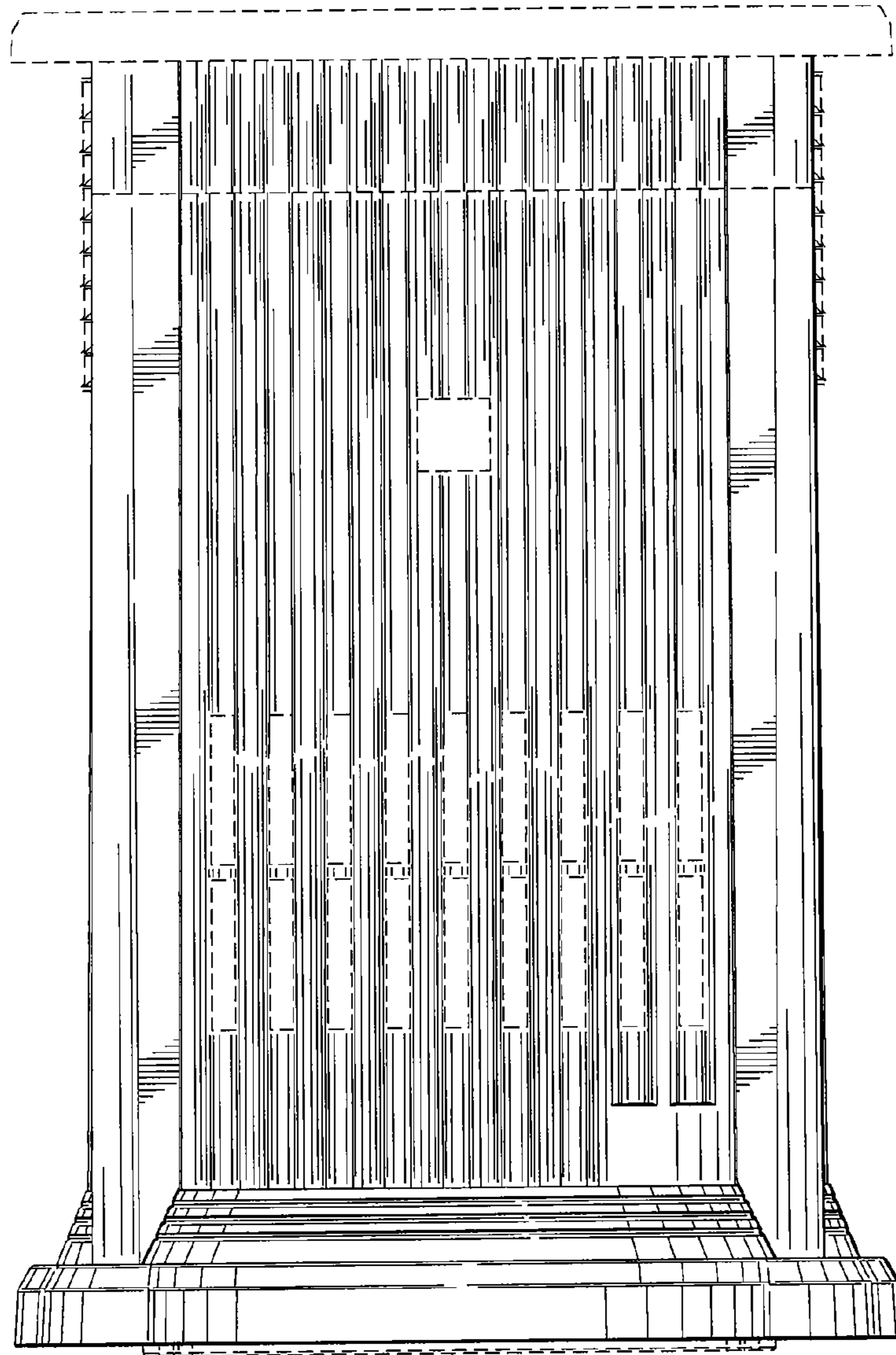

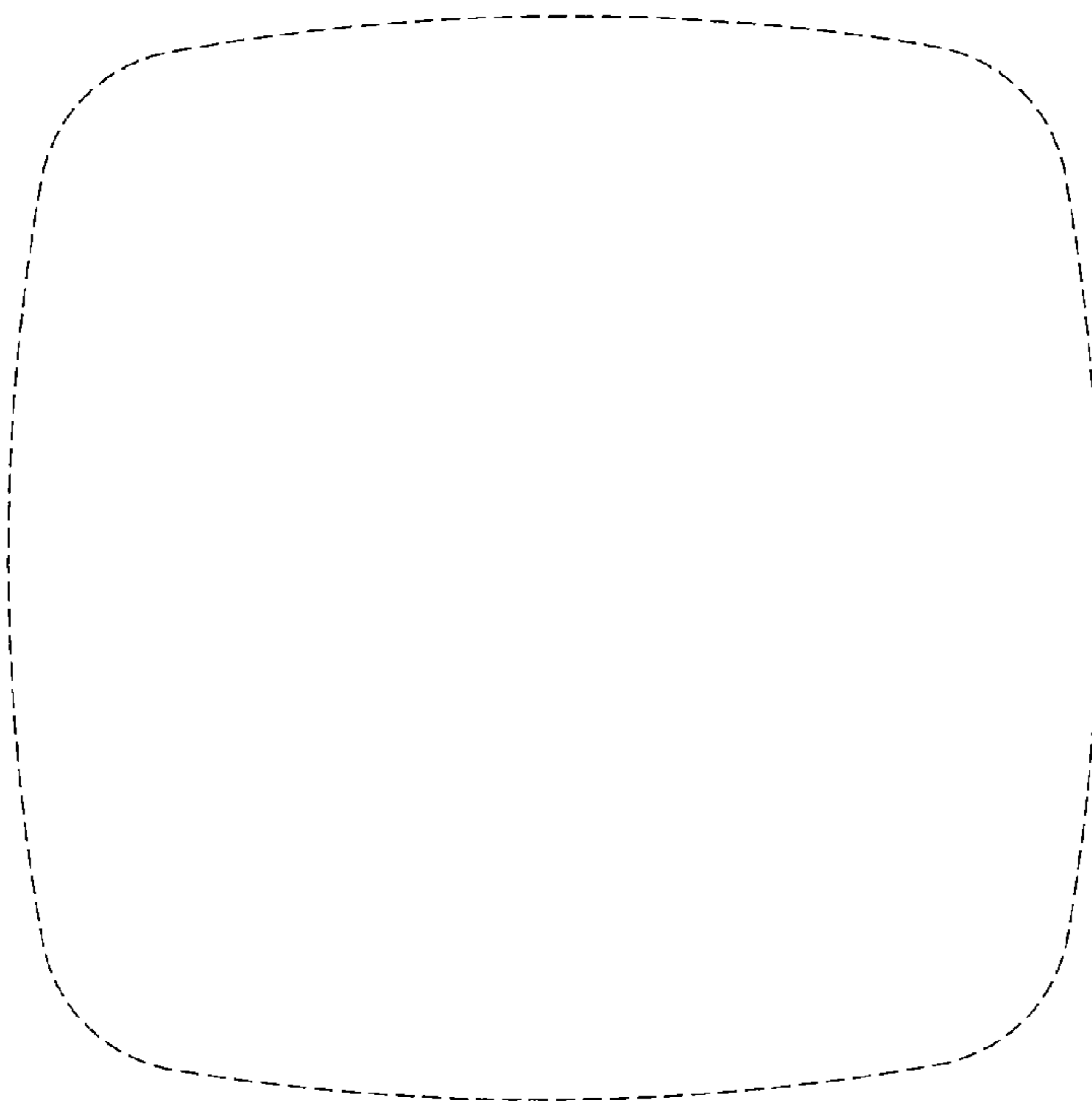

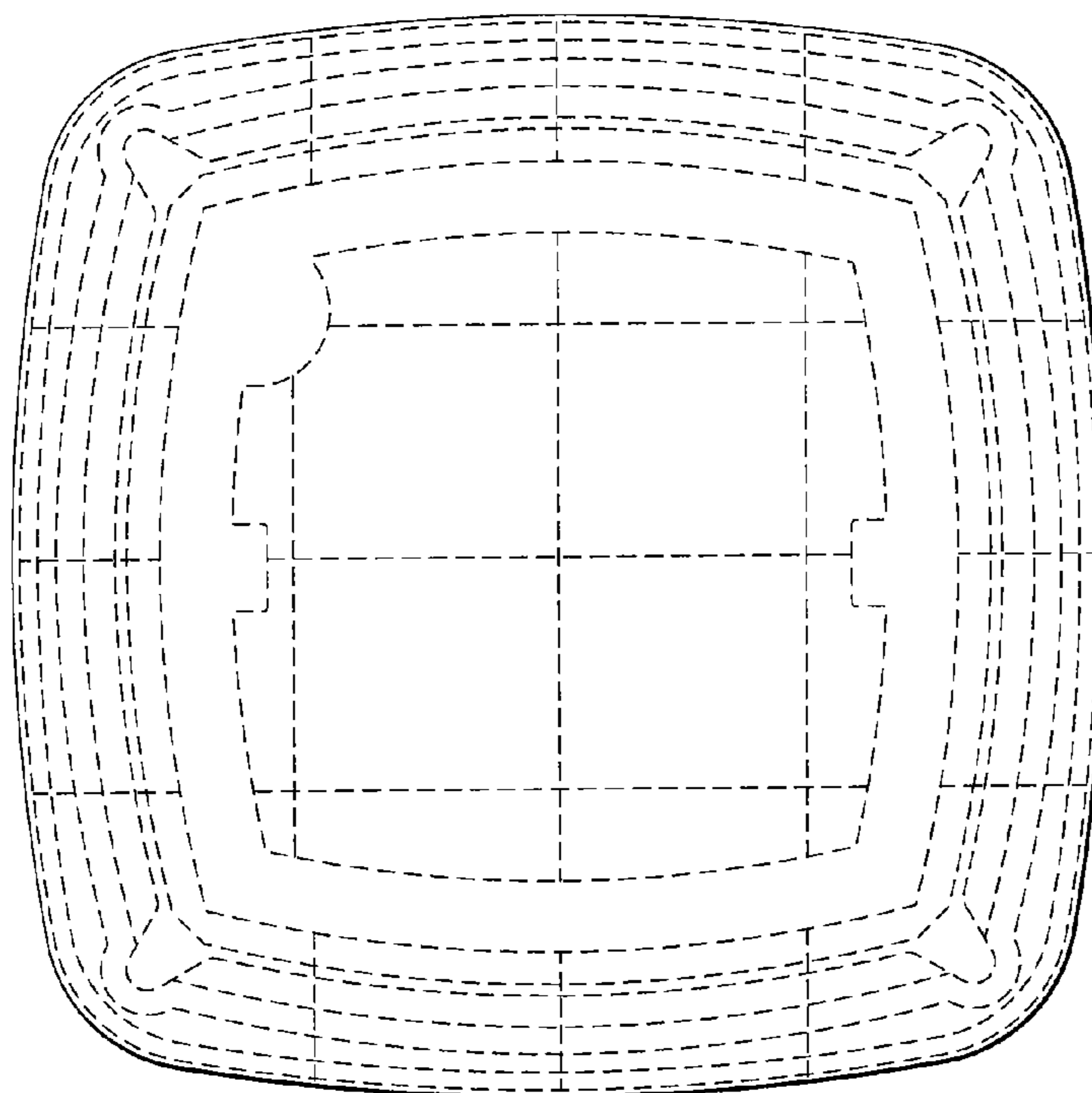
