The ornamental design for a handle for medical device, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a handle for medical device according to the present invention;

FIG. 2 is a right side perspective view of the handle for medical device of FIG. 1;

FIG. 3 is a front perspective view of the handle for medical device of FIG. 1;

FIG. 4 is a rear perspective view of the handle for medical device of FIG. 1;

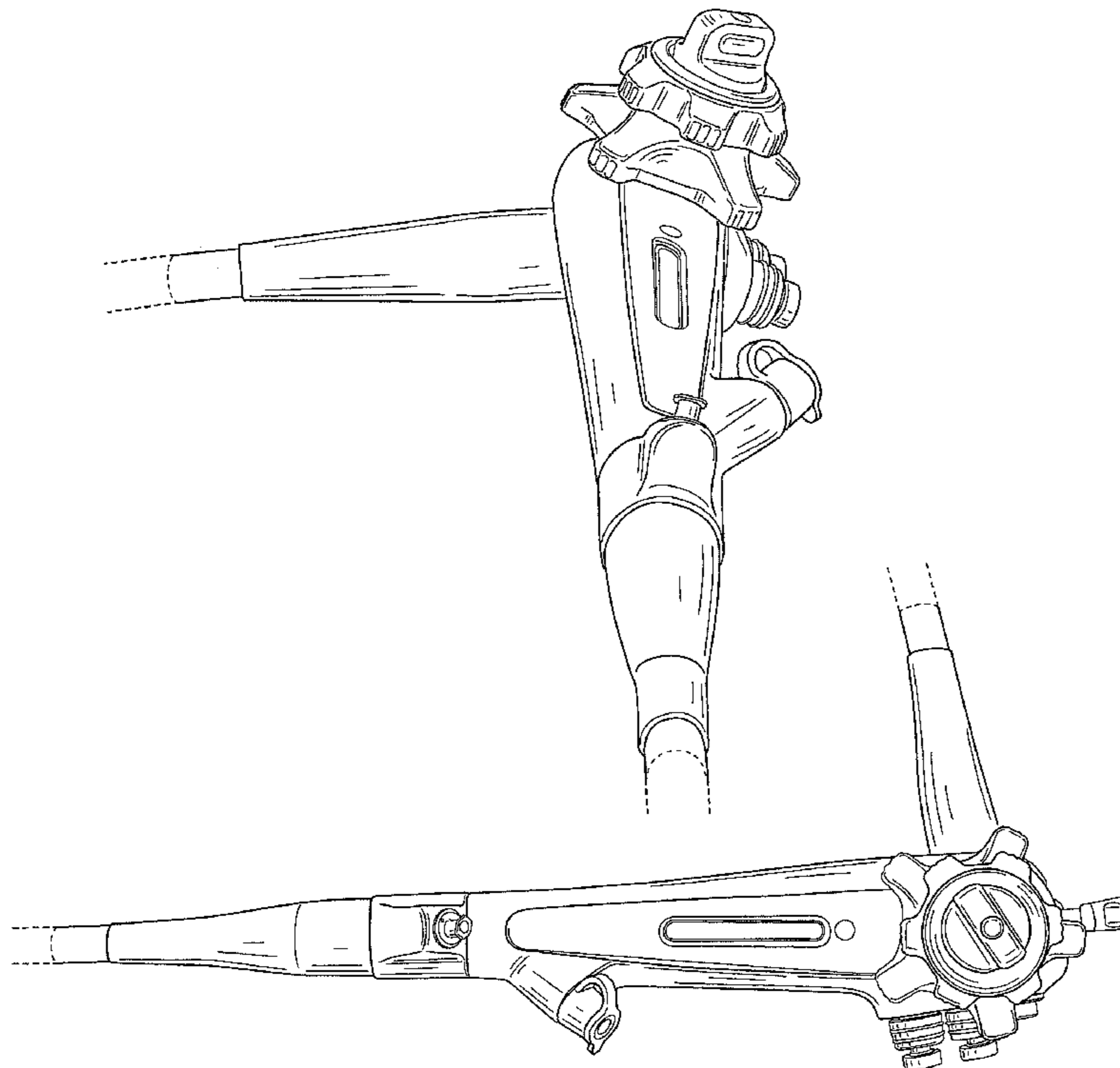
FIG. 5 is a top perspective view of the handle for medical device of FIG. 1;

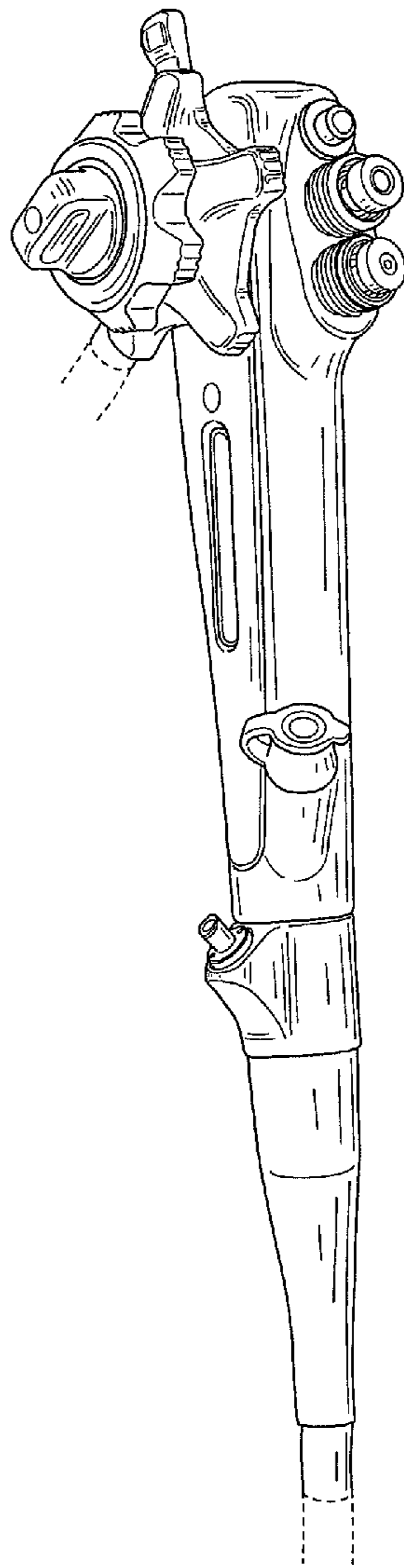

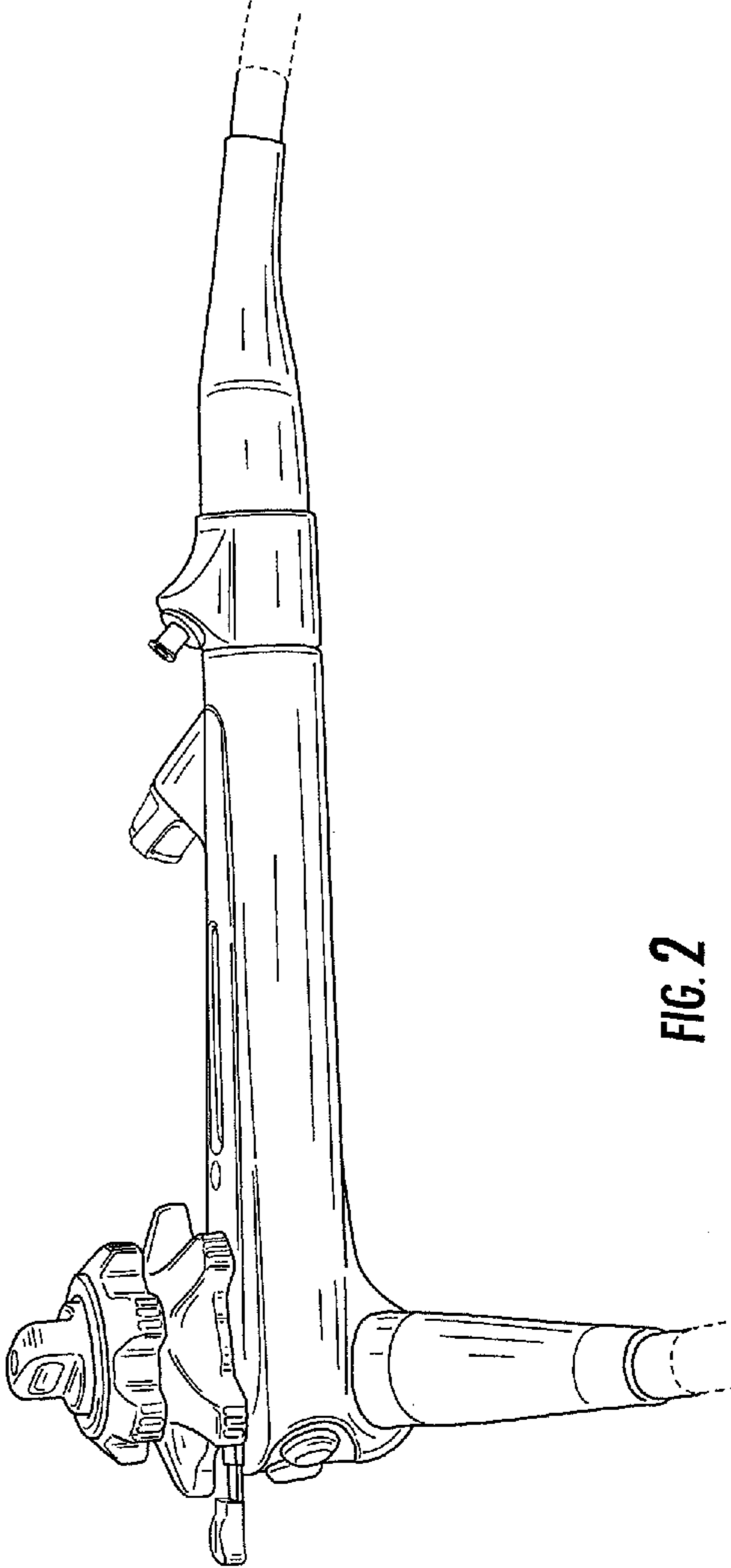

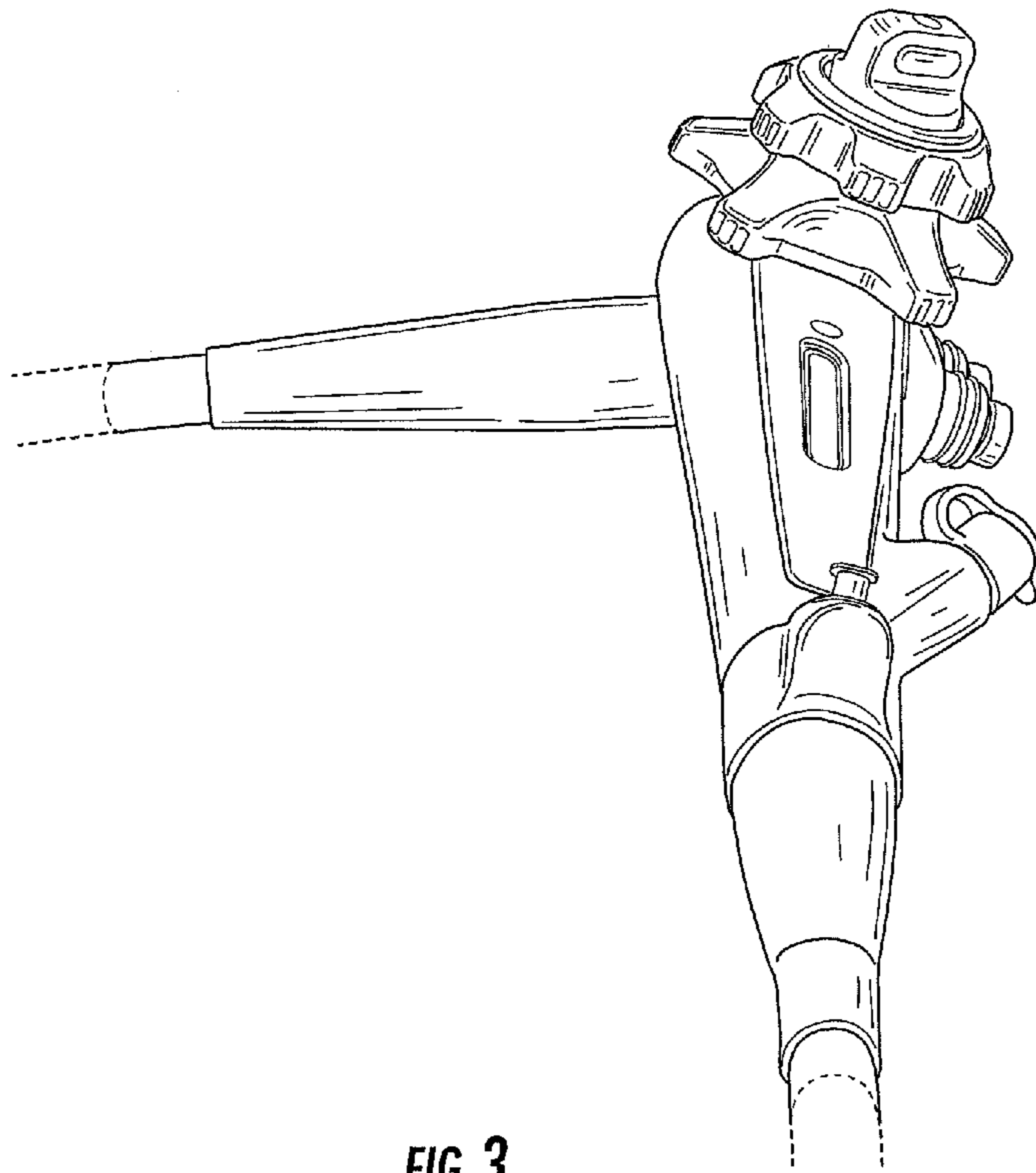

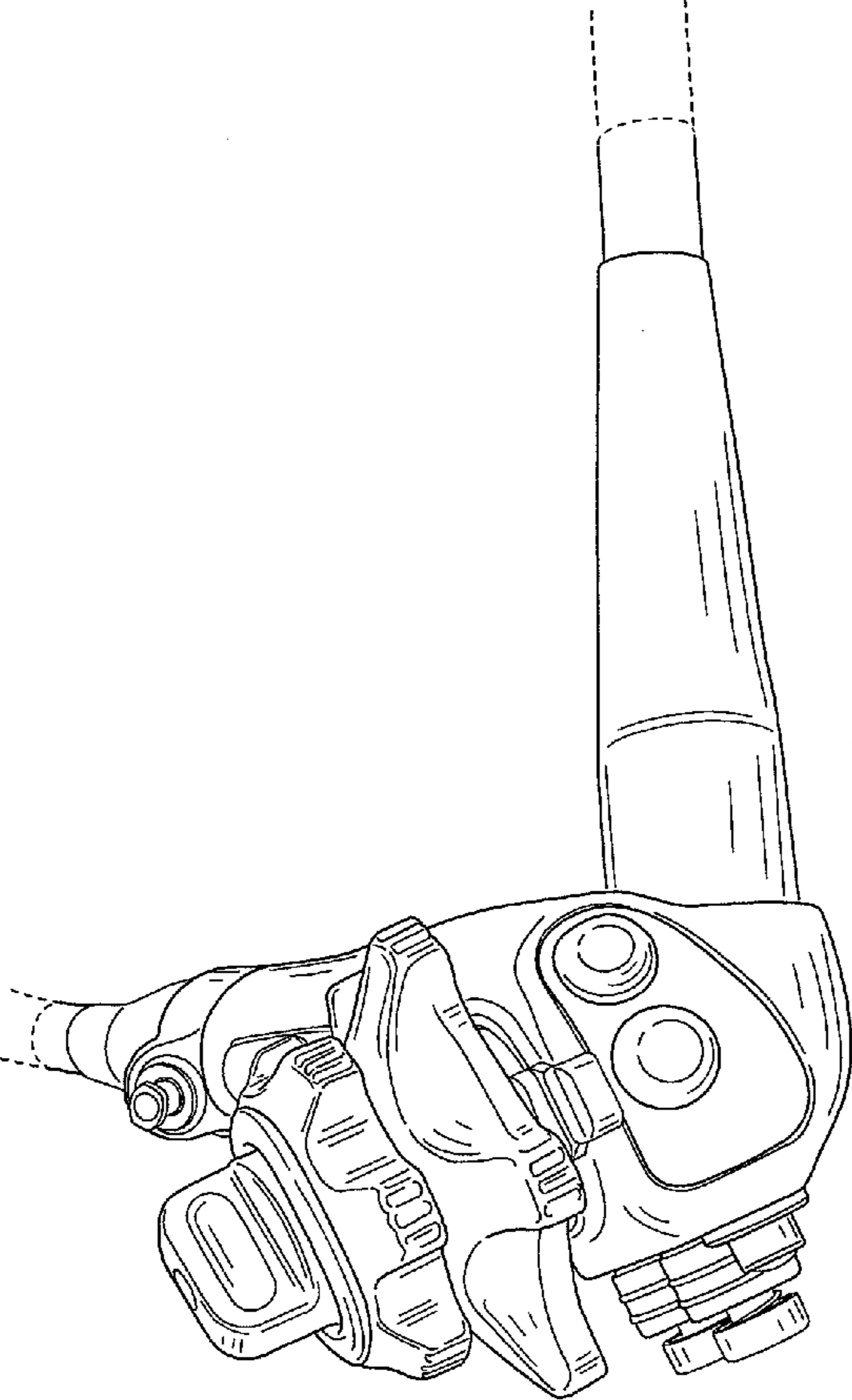

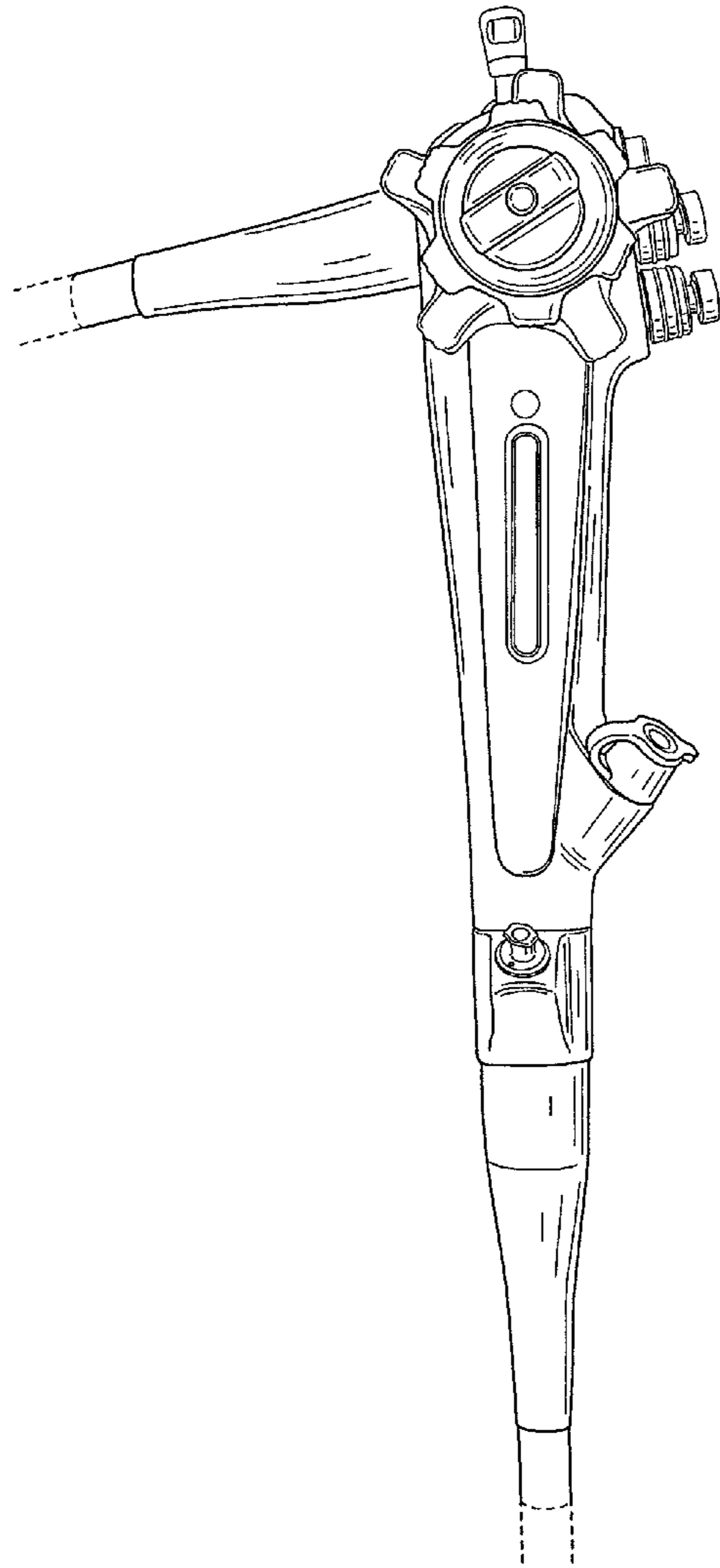

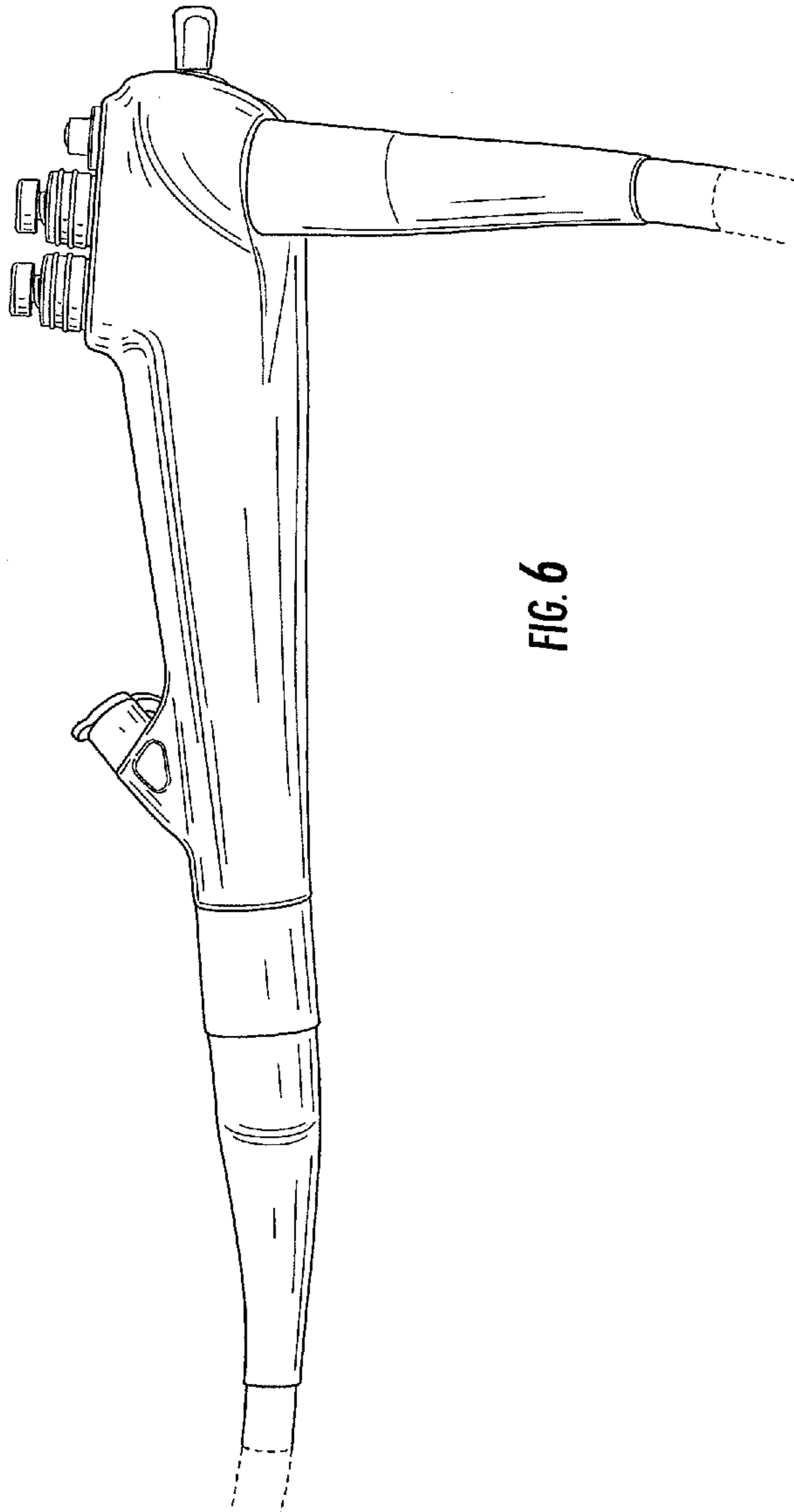

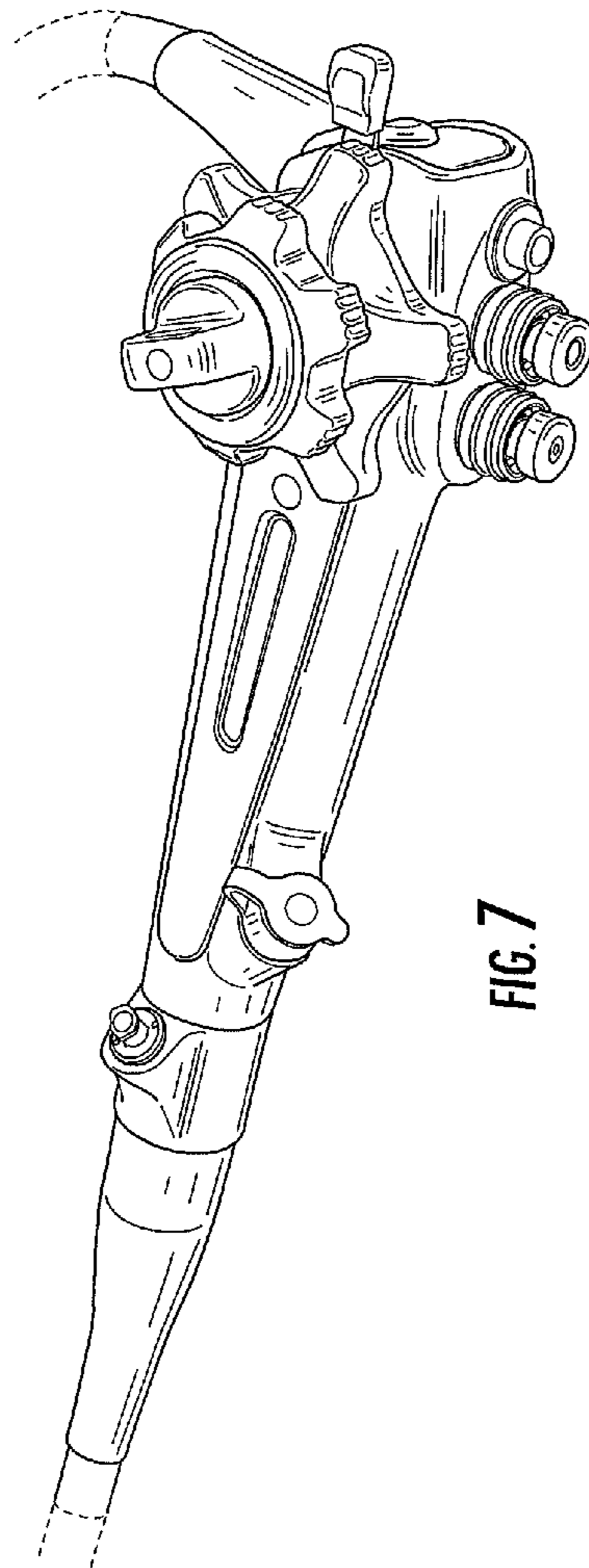
