(57) **CLAIM**

The ornamental design for a skin massage roller, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a skin massage roller showing my new design;

FIG. 2 is a rear, bottom and right side perspective view thereof;

FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image of FIG. 3;

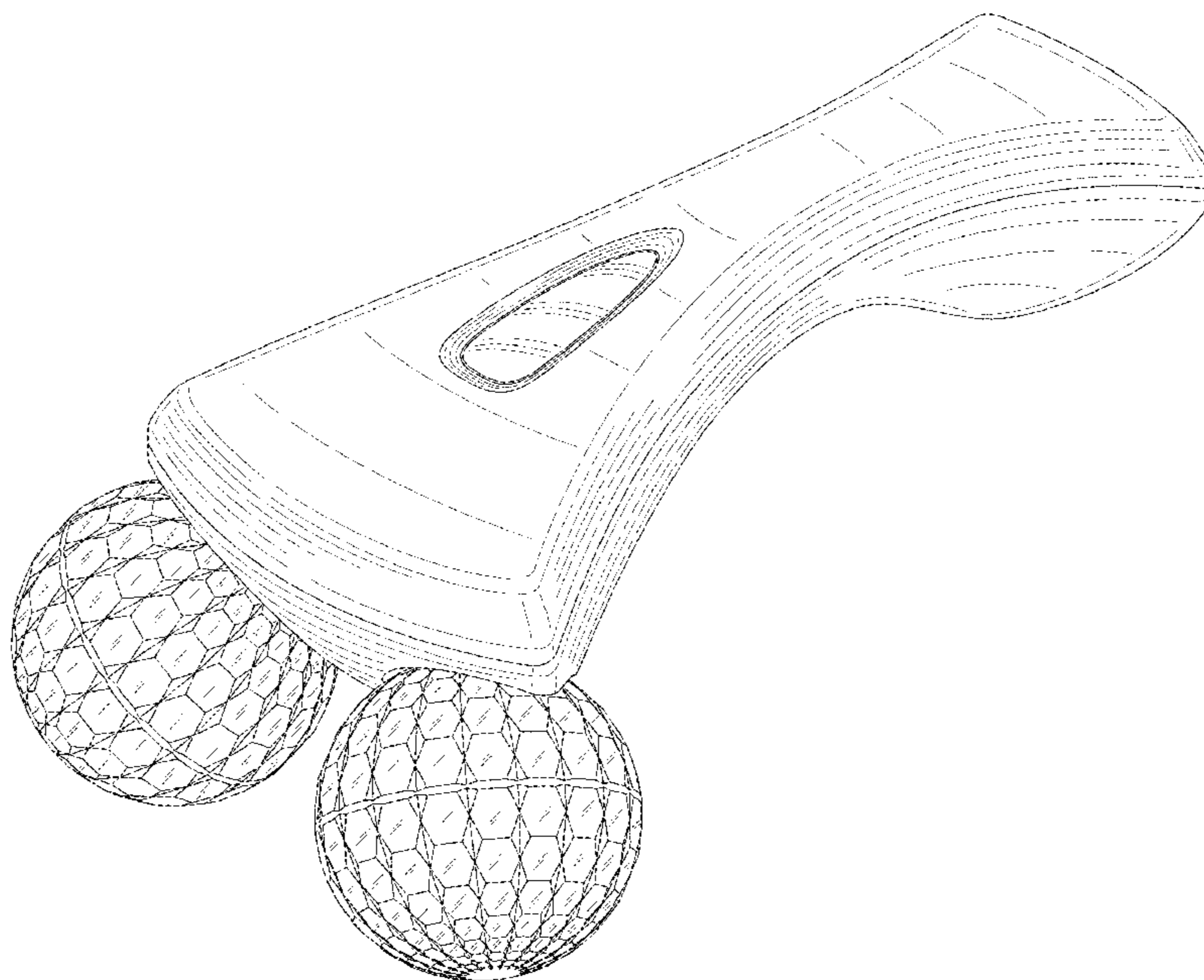
FIG. 4 is a top plan view thereof;

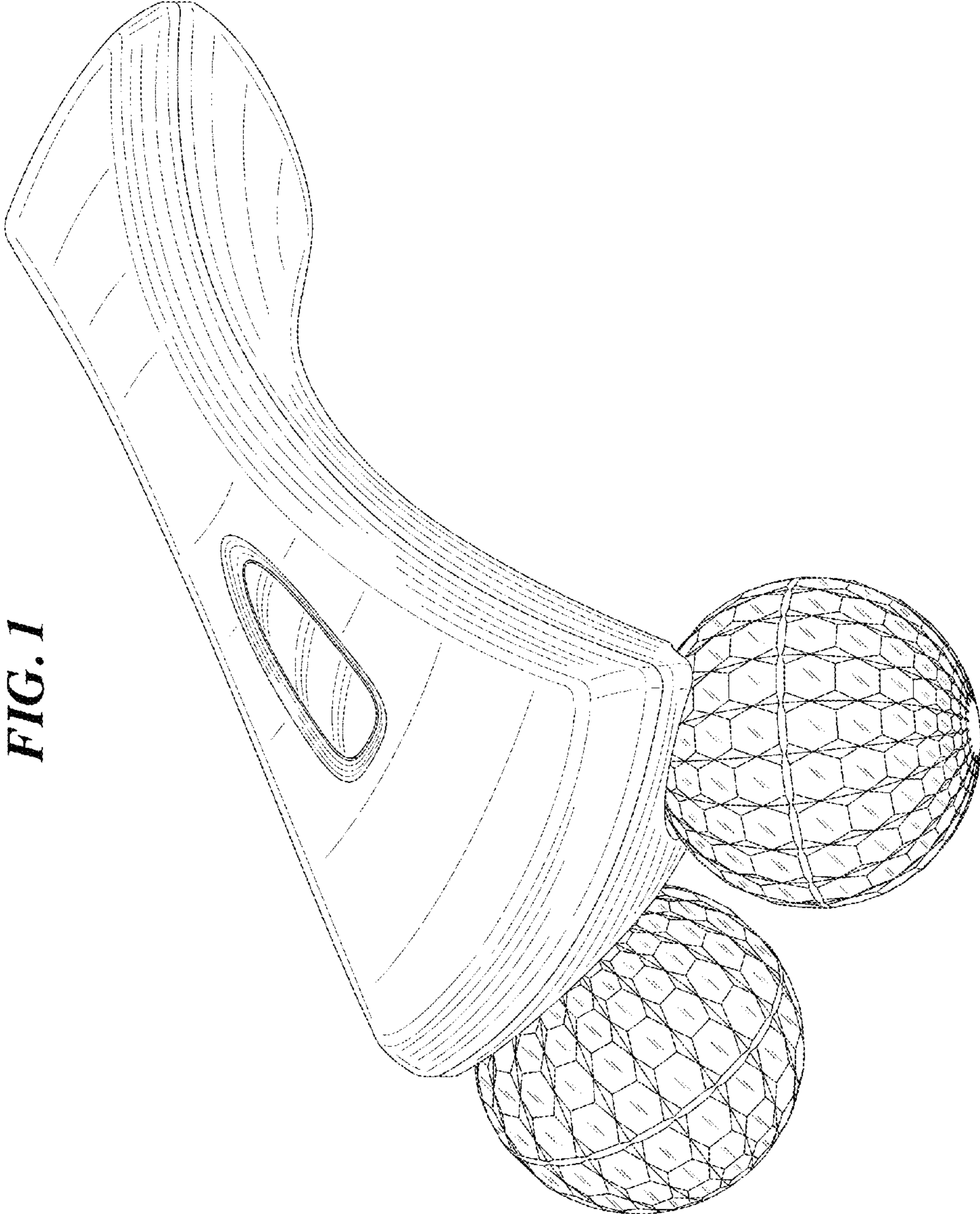

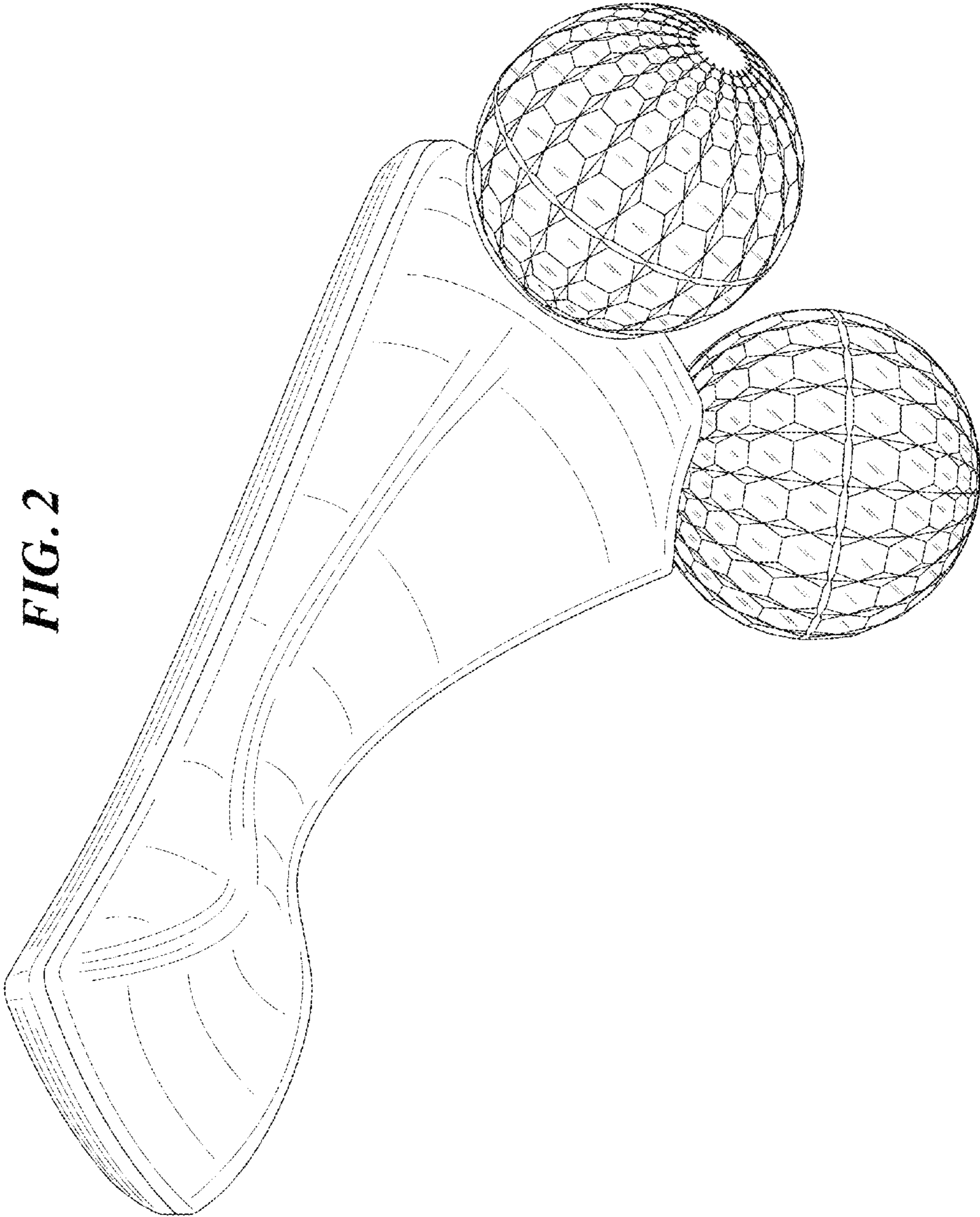

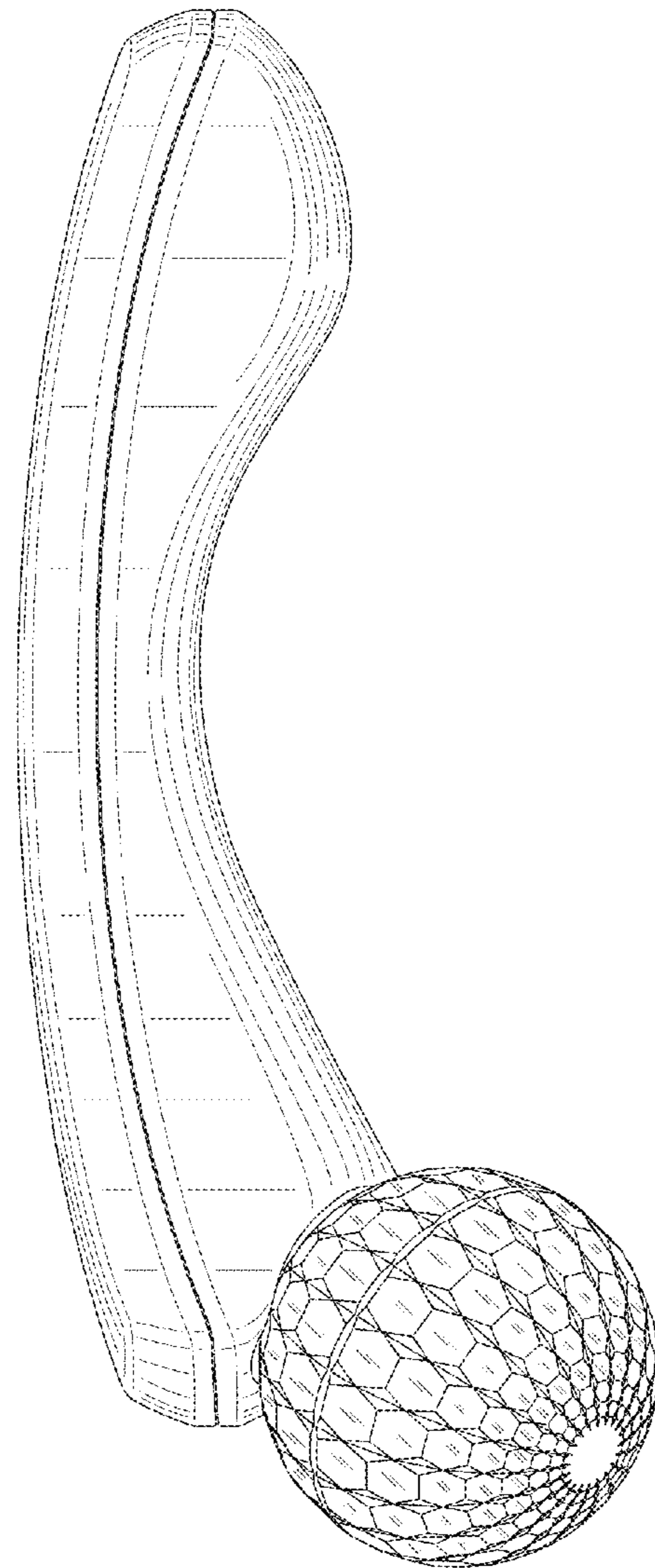

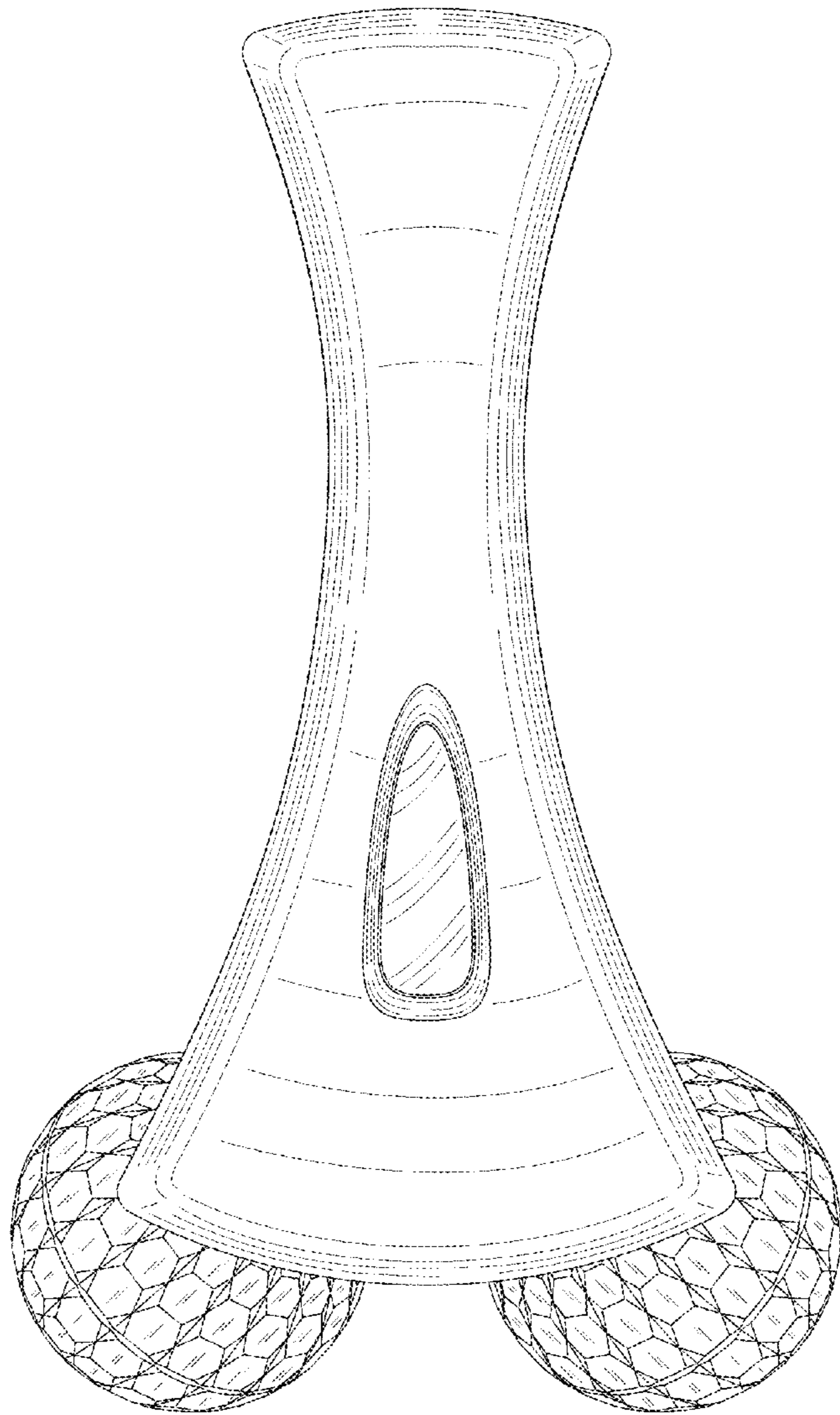

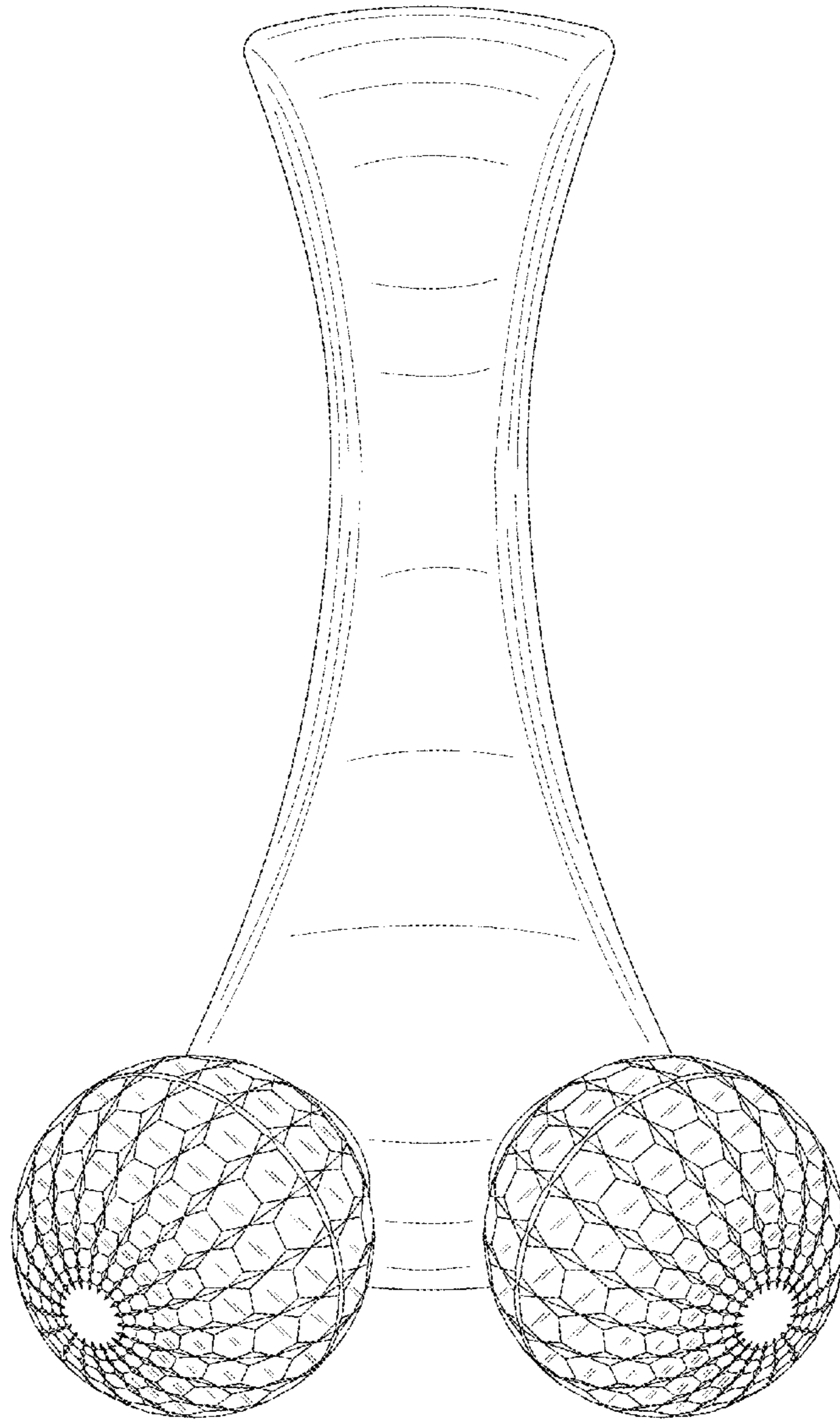

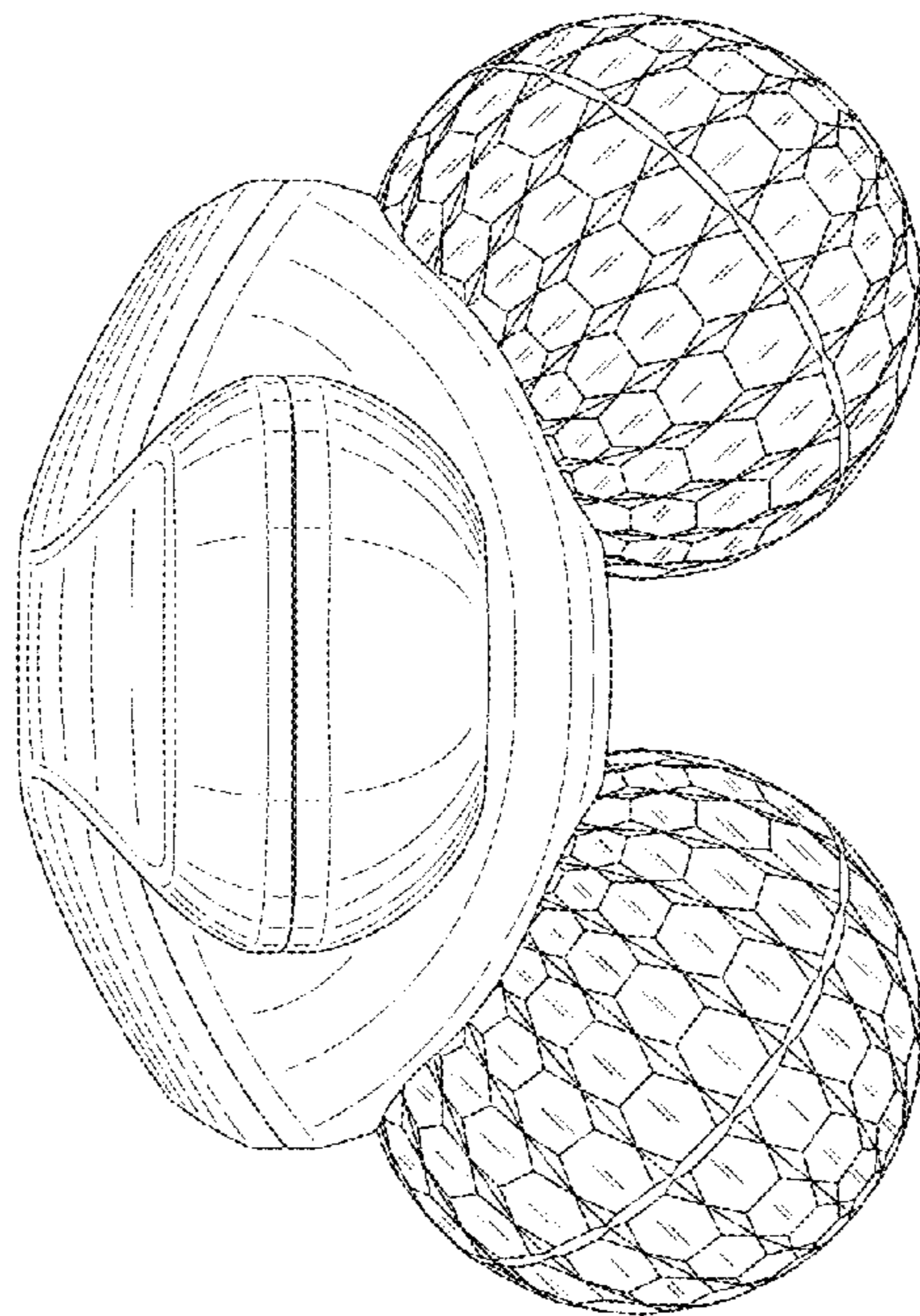
