(57) **CLAIM**

I claim the ornamental design for an infant hairpiece, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an infant hairpiece shown being worn;
 FIG. 2 is a front and top perspective view of the infant hairpiece;
 FIG. 3 is a front elevation view of the infant hairpiece;
 FIG. 4 is a back elevation view of the infant hairpiece;
 FIG. 5 is a bottom view of the infant hairpiece;
 FIG. 6 is a top view of the infant hairpiece;
 FIG. 7 is a left side view of the infant hairpiece; and,
 FIG. 8 is a right side view of the infant hairpiece.

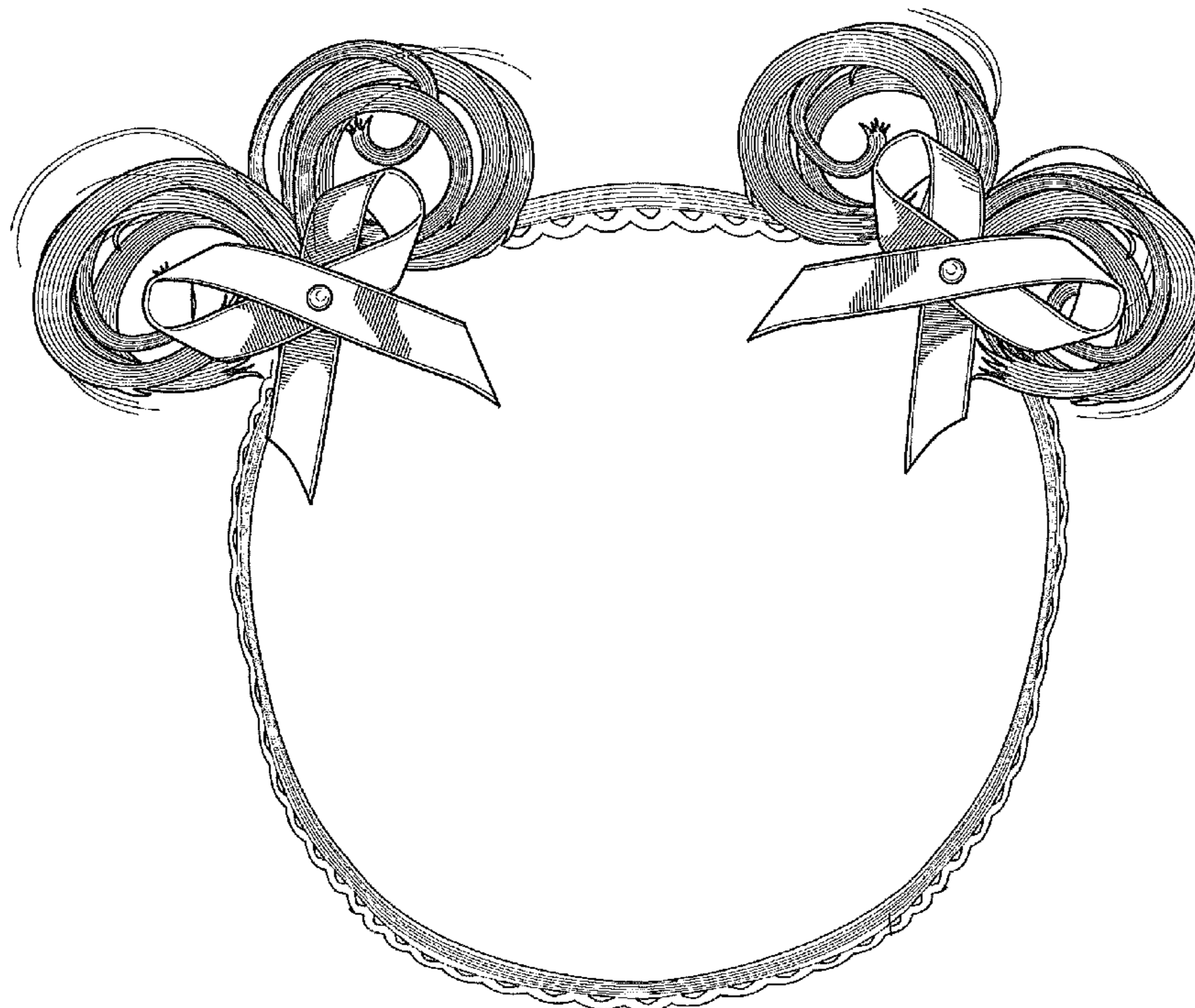

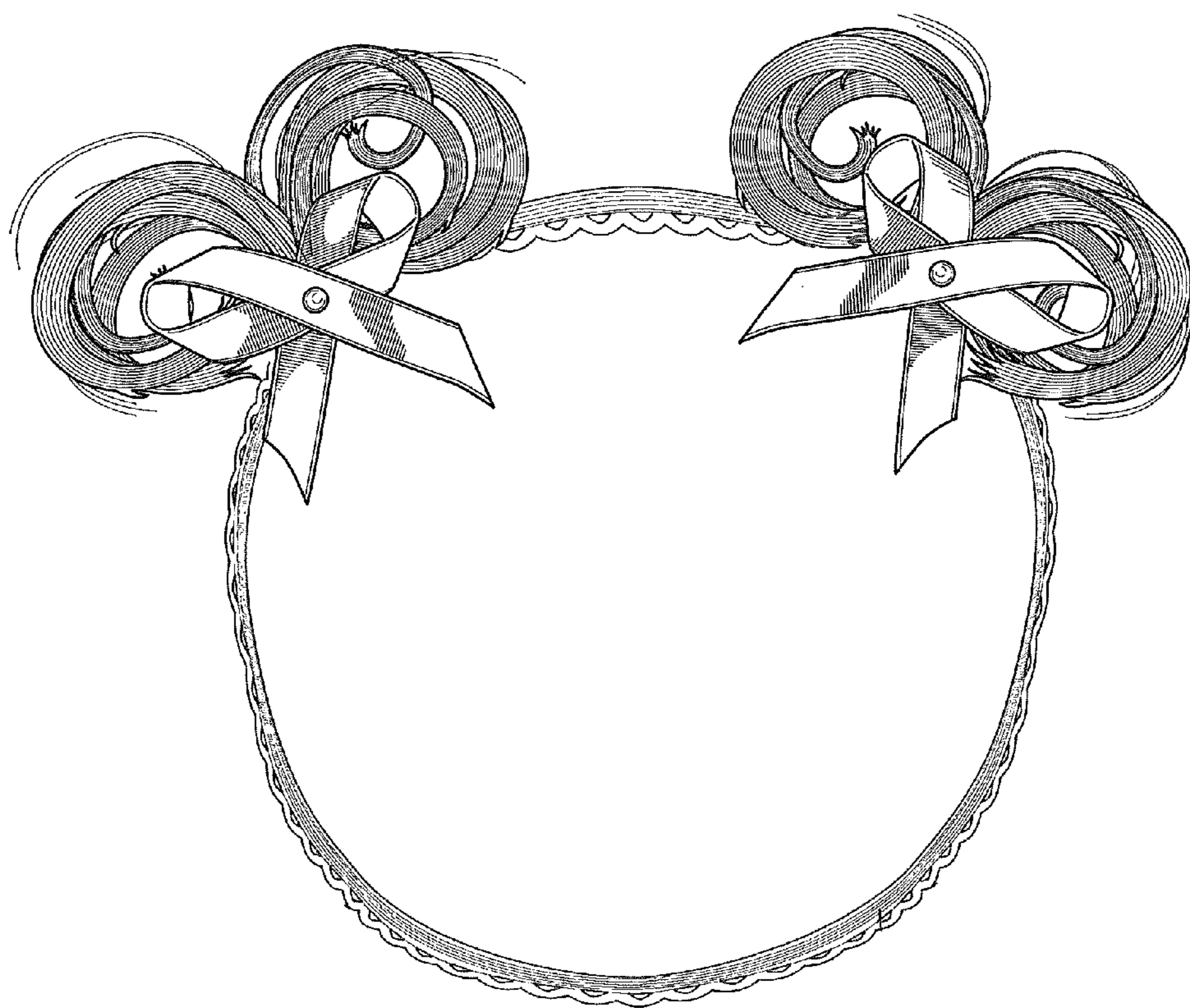

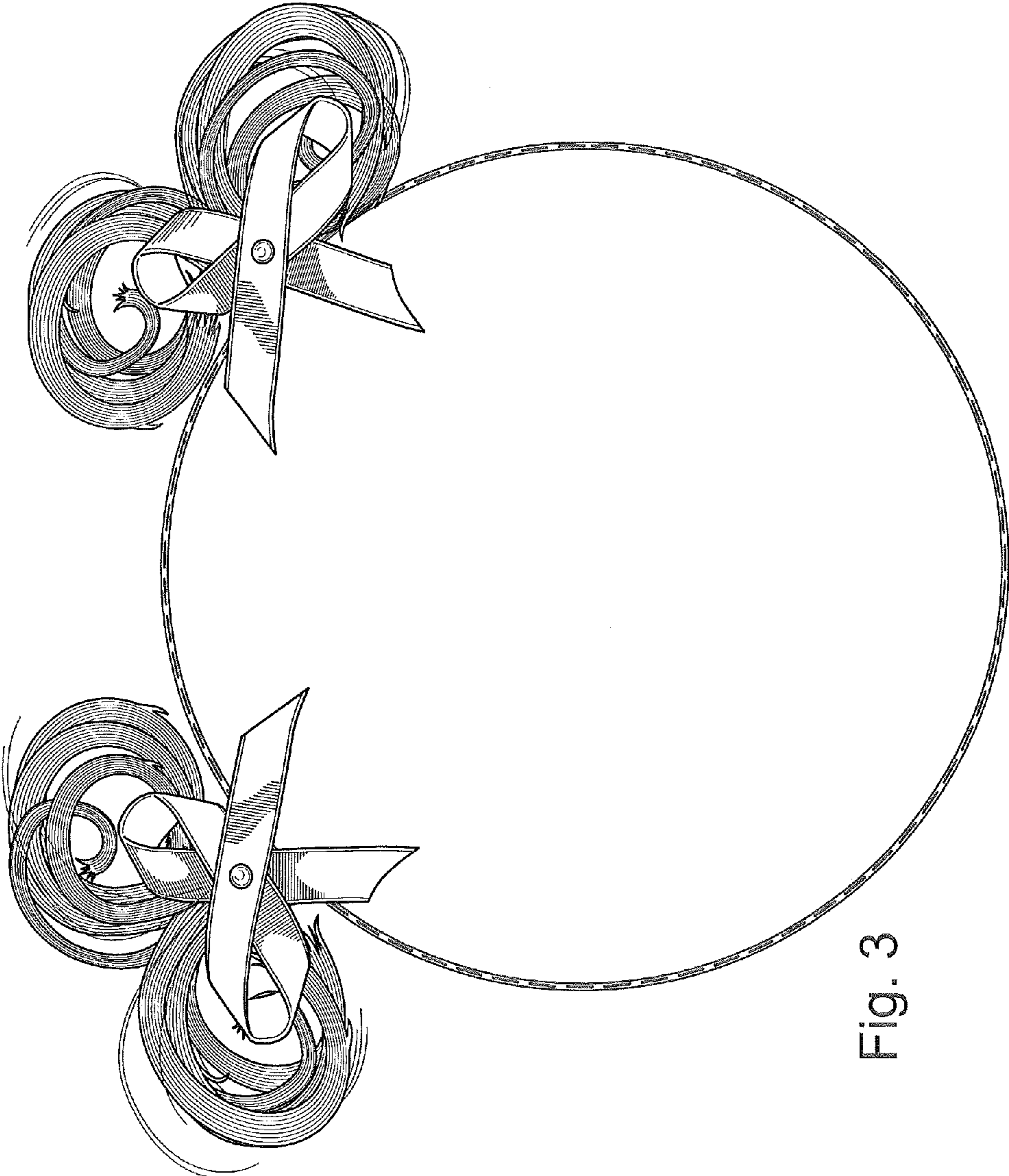

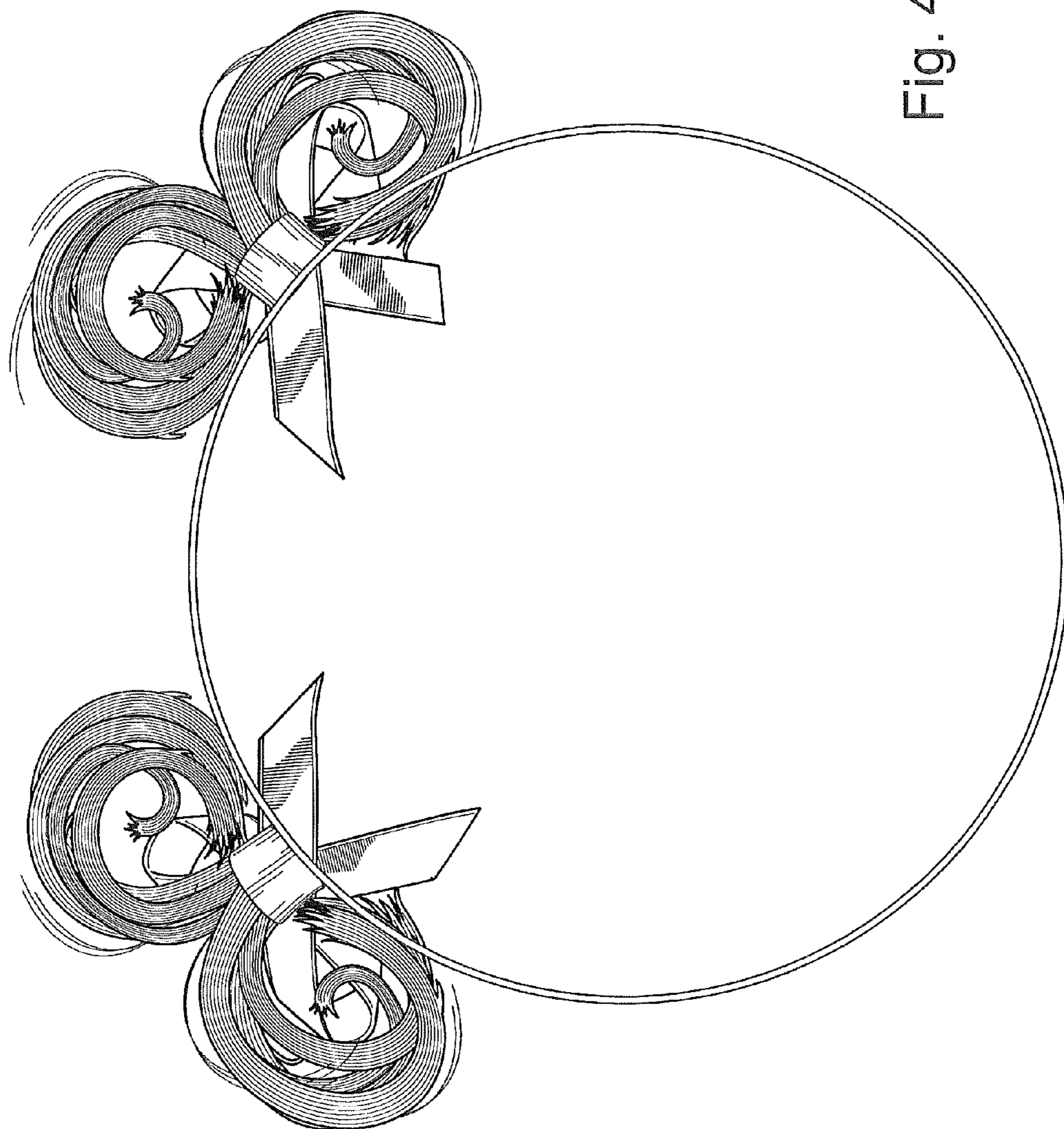

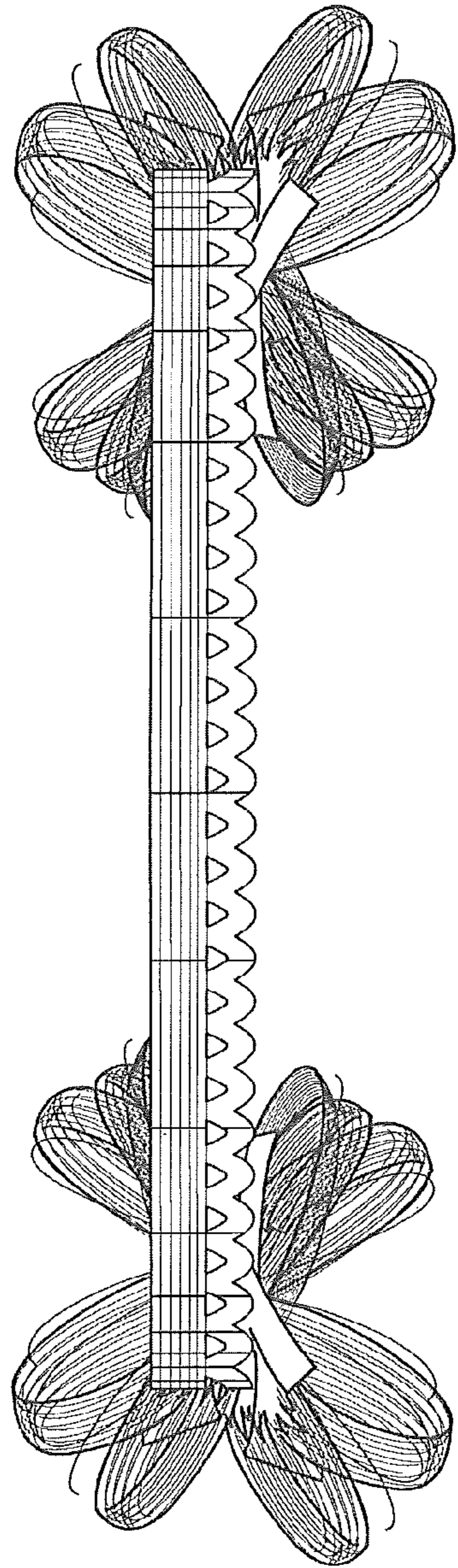

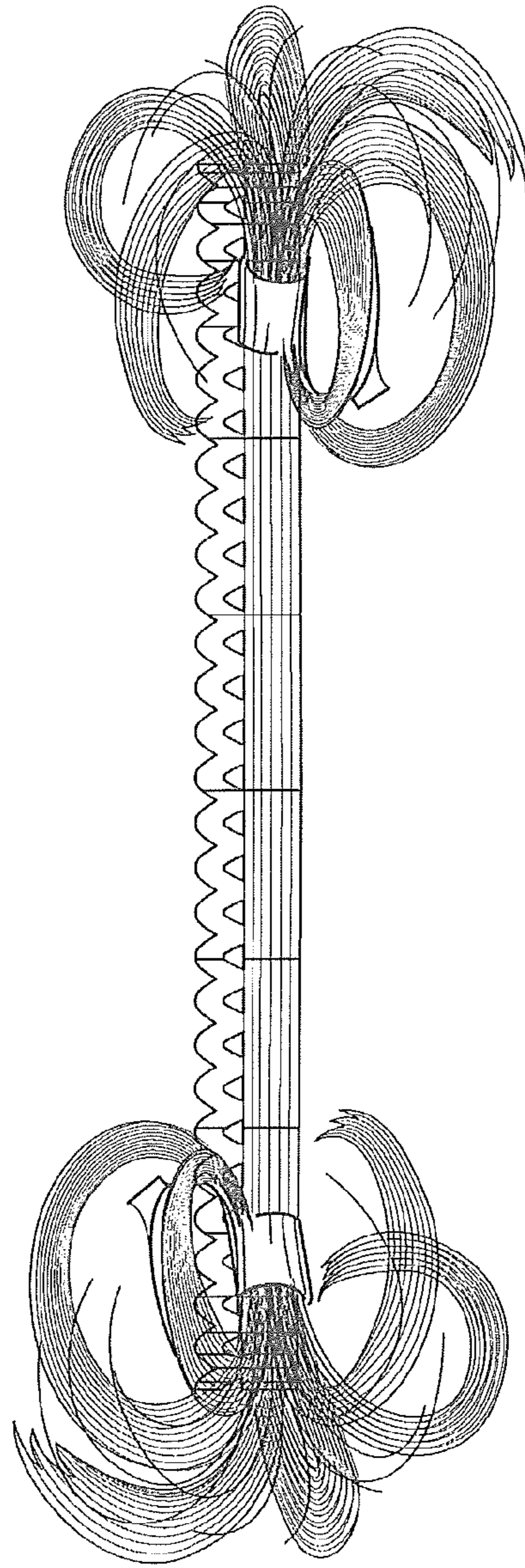

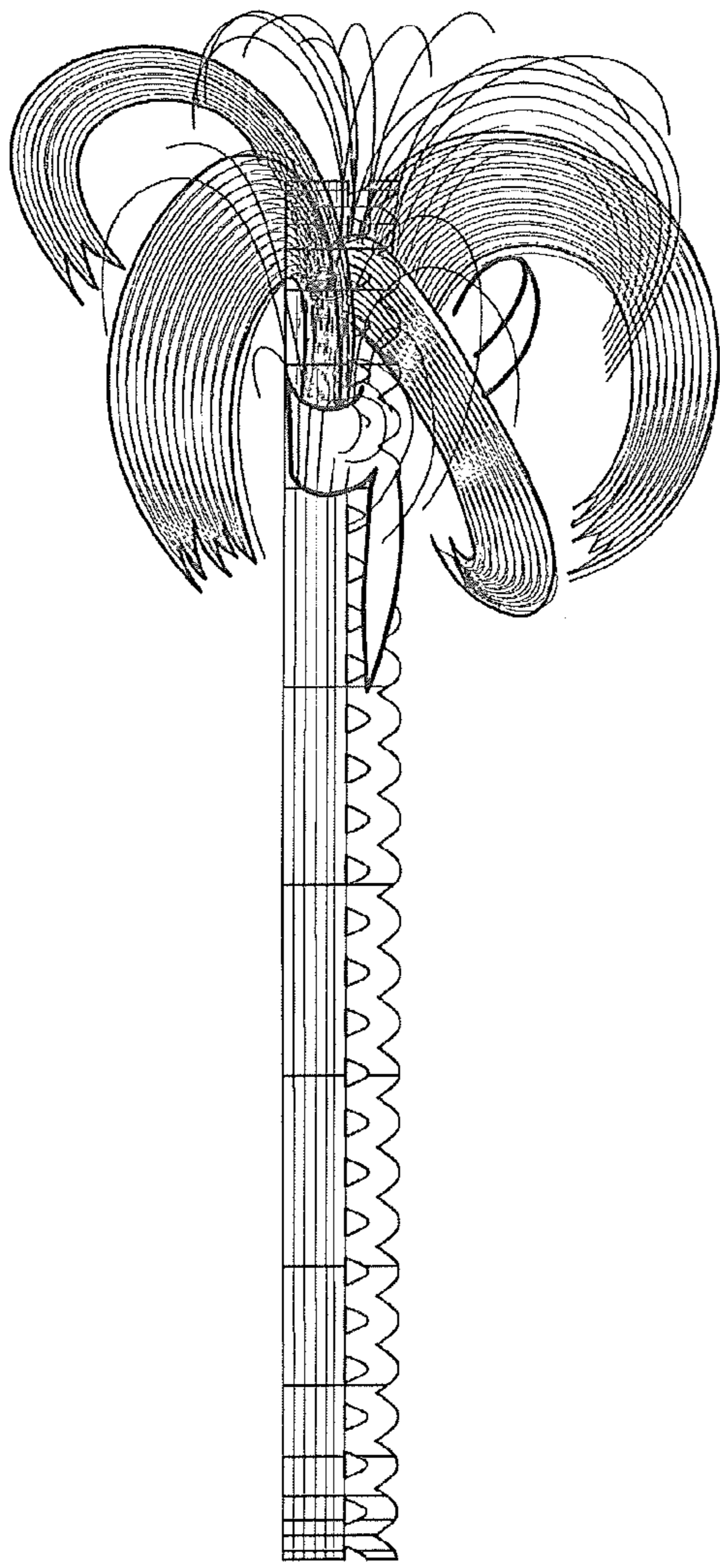

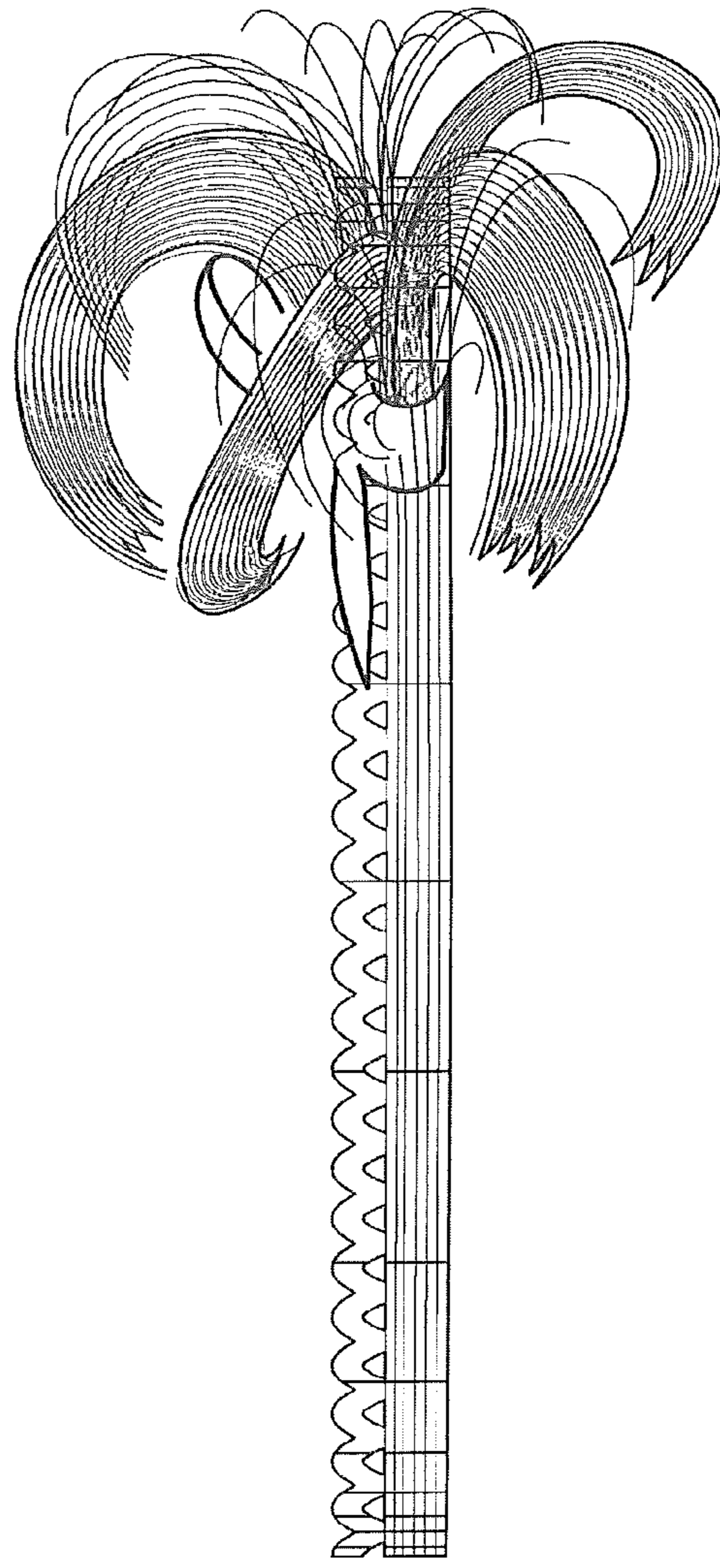
