(57) **CLAIM**

I claim the ornamental design for a mitt for massaging horses, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the mitt for massaging horses;

FIG. 2 is a front view of the mitt for massaging horses;

FIG. 3 is a rear view of the mitt for massaging horses;

FIG. 4 is a right side view of the mitt for massaging horses;

FIG. 5 is a left side view of the mitt for massaging horses;

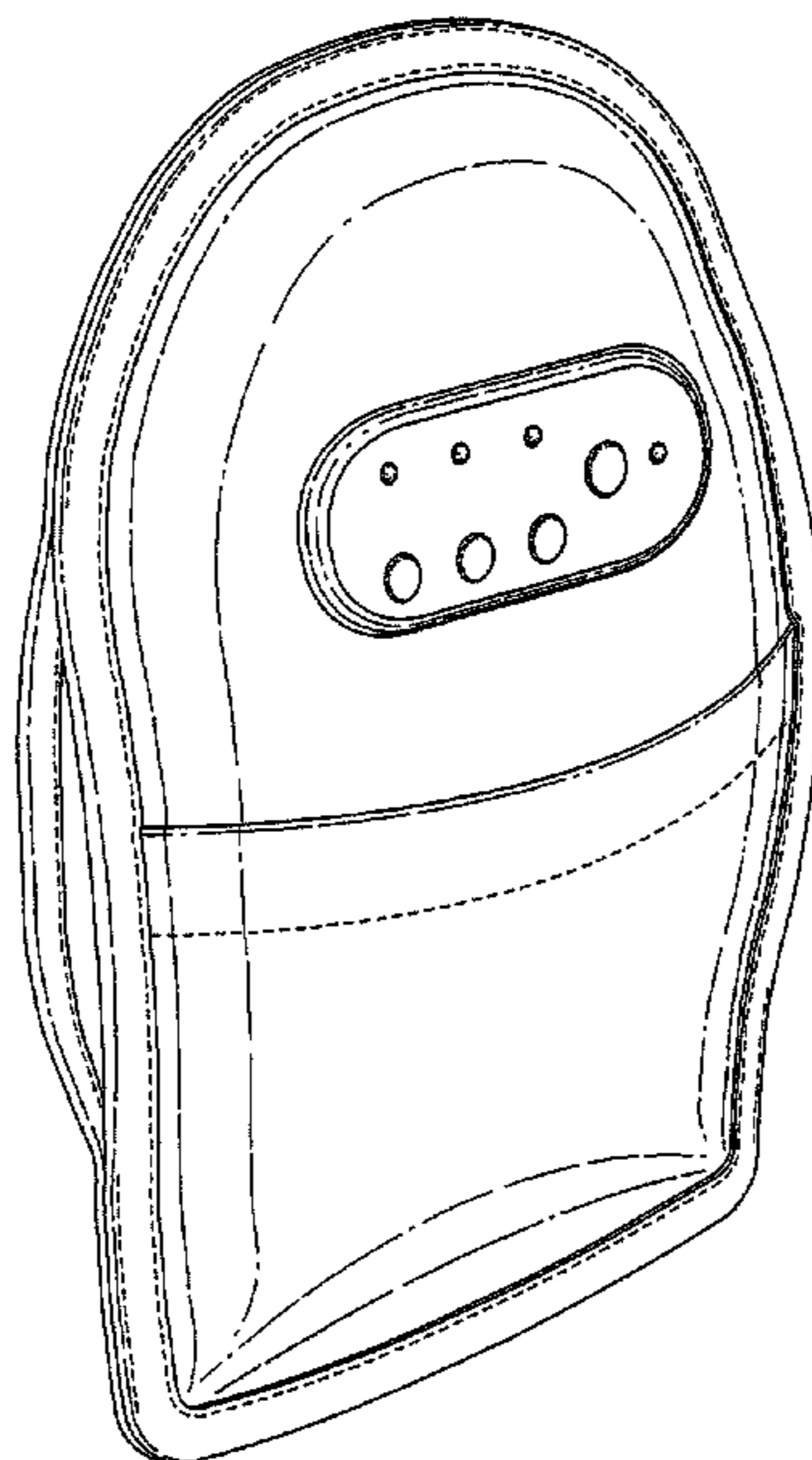
FIG. 6 is a top view of the mitt for massaging horses; and,

FIG. 7 is a bottom view of the mitt for massaging horses.

The uniformly spaced broken lines running along portions of the mitt border and horizontally across the front of the mitt are not claimed.

The broken lines represent stitching and form part of the claimed design.

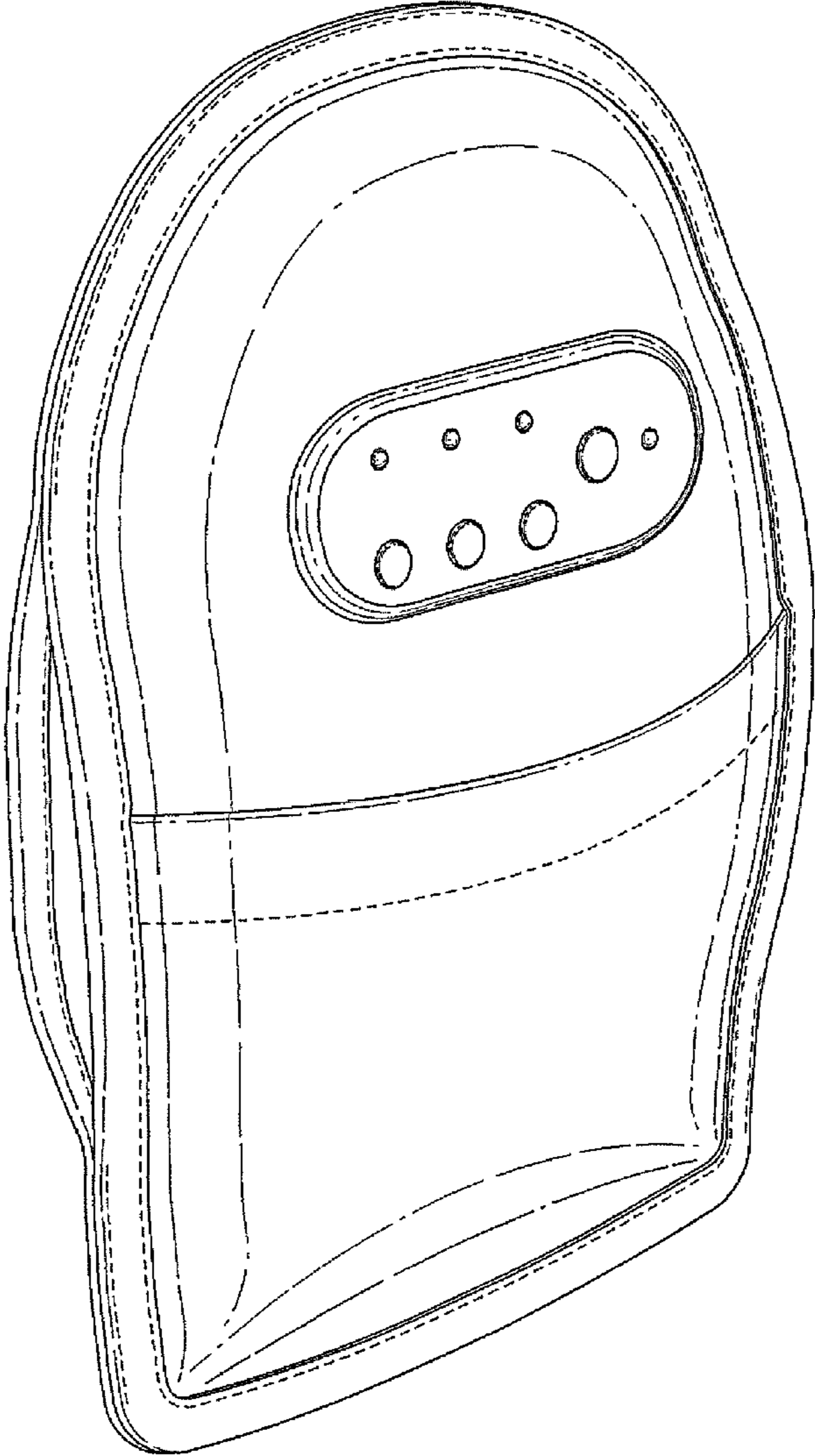

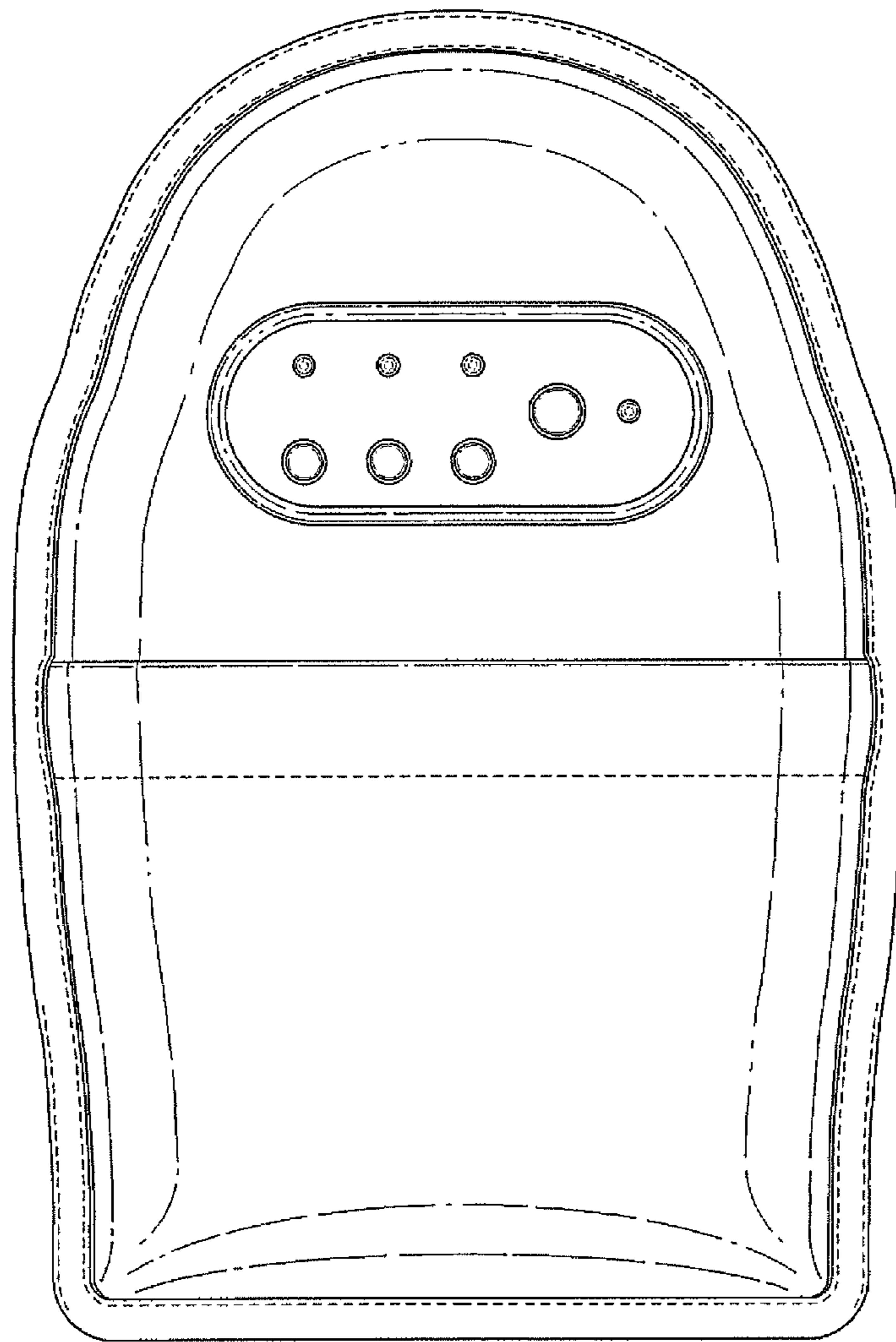

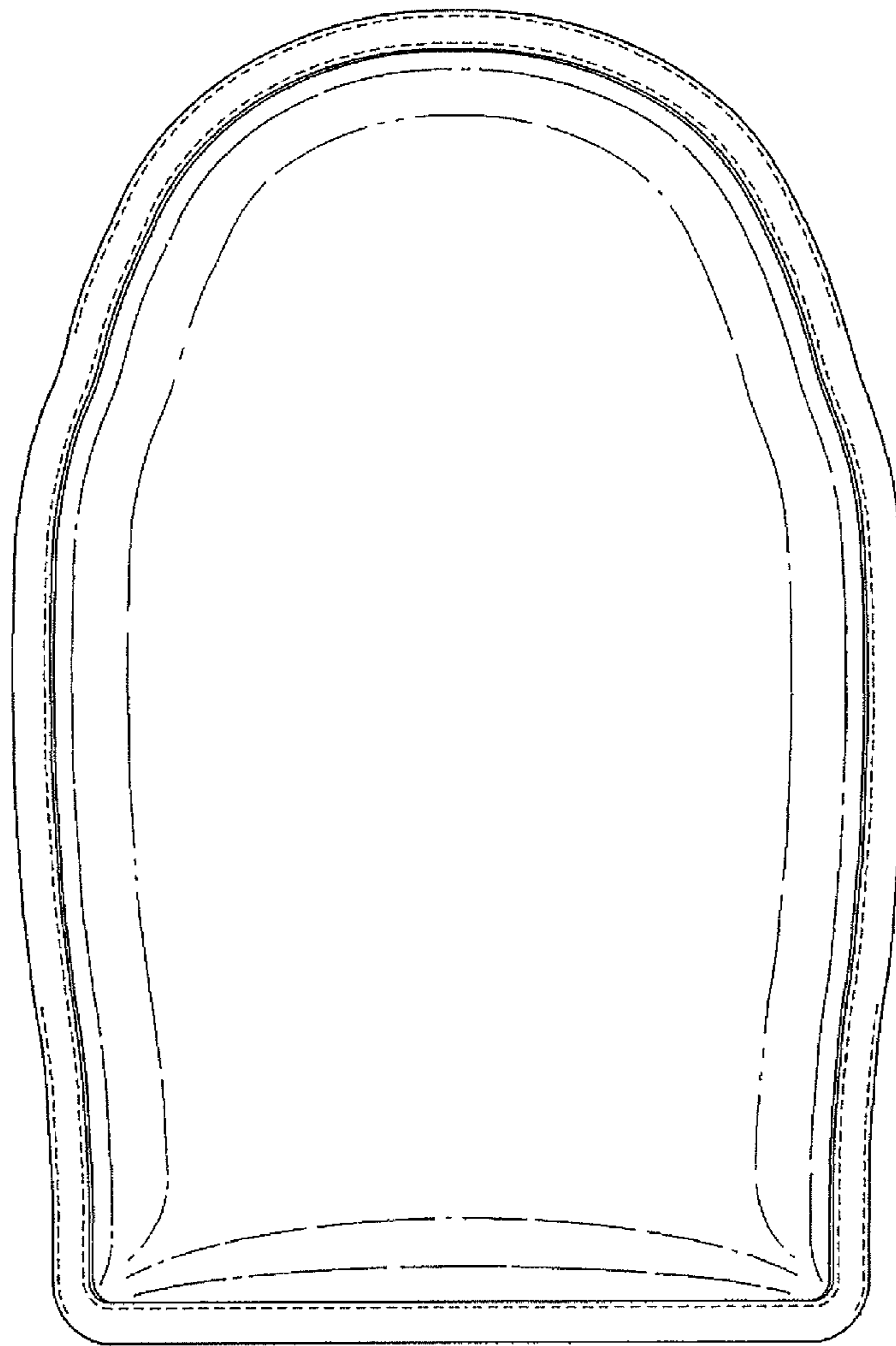

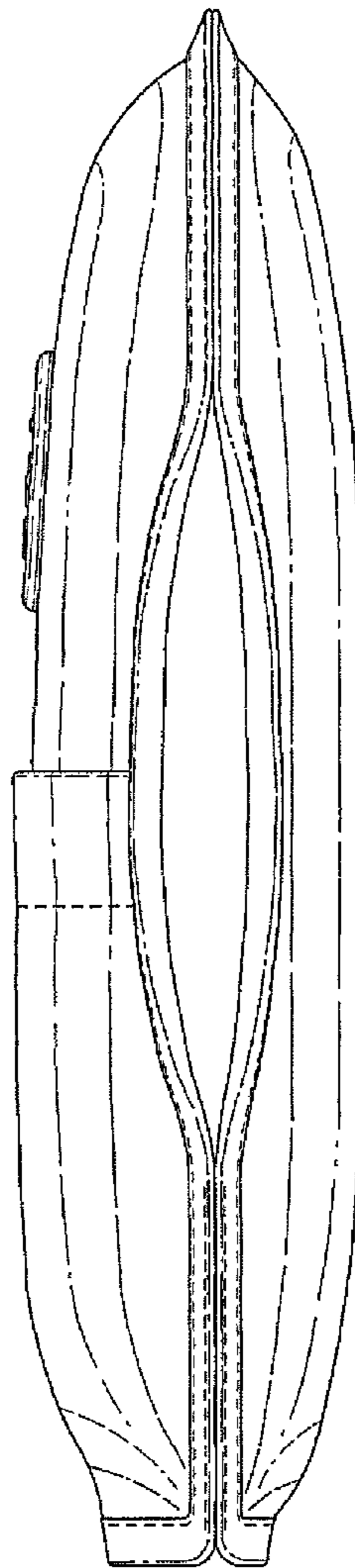

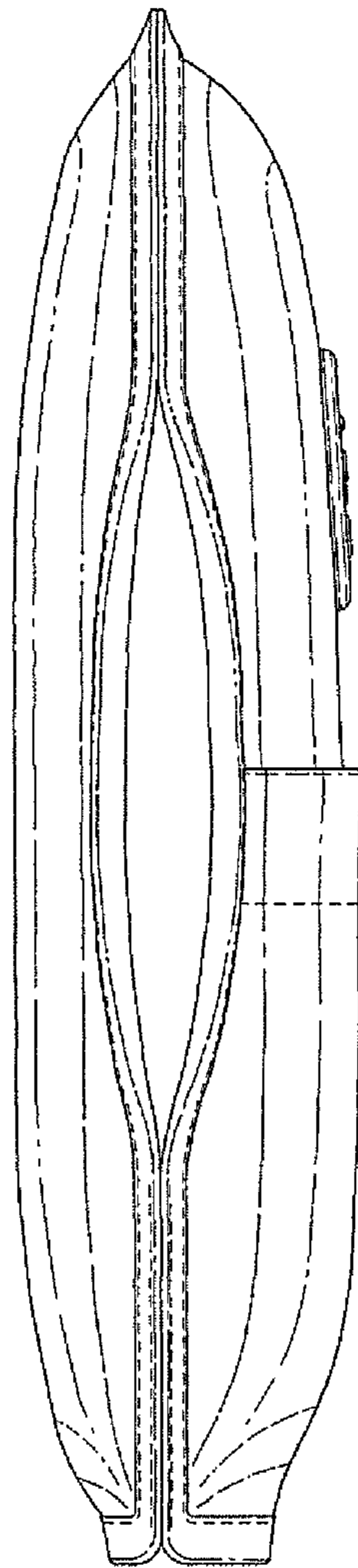

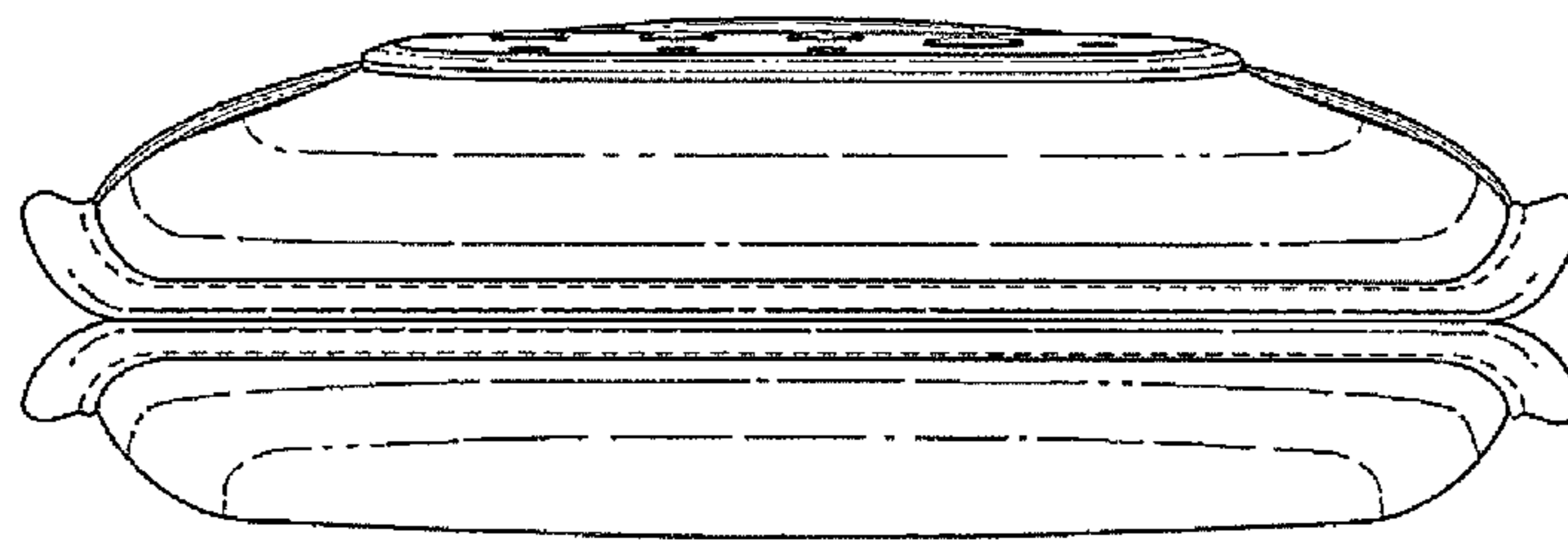

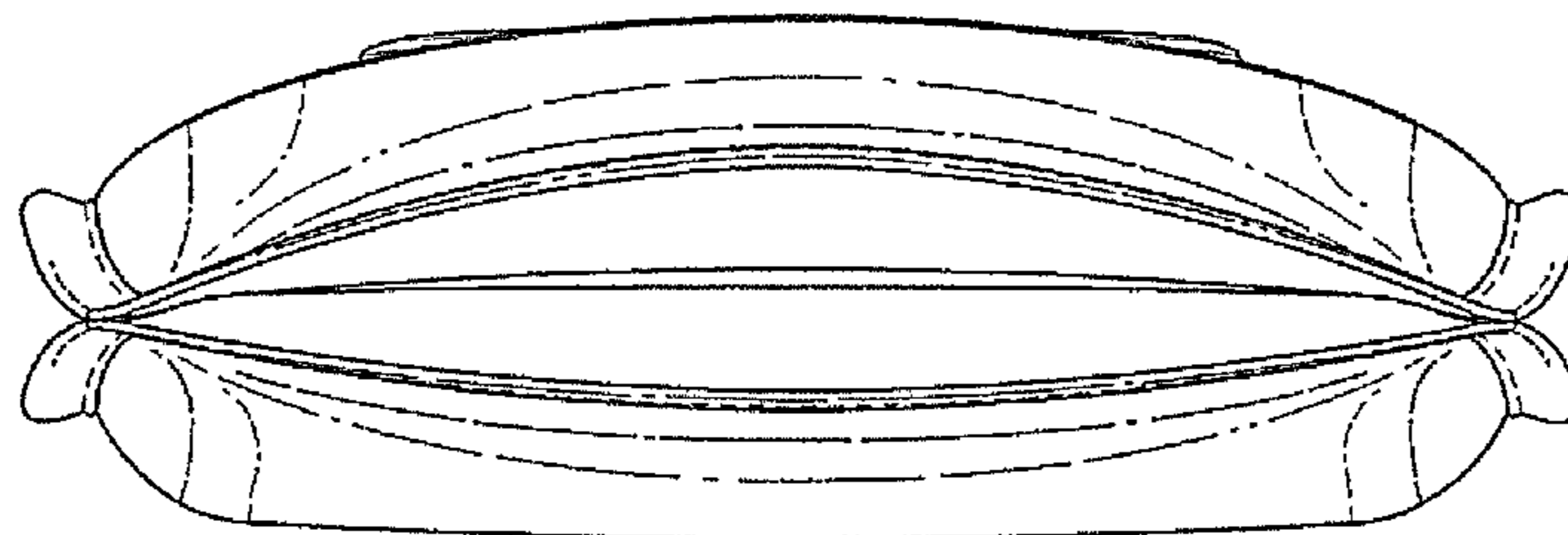
