(57) **CLAIM**

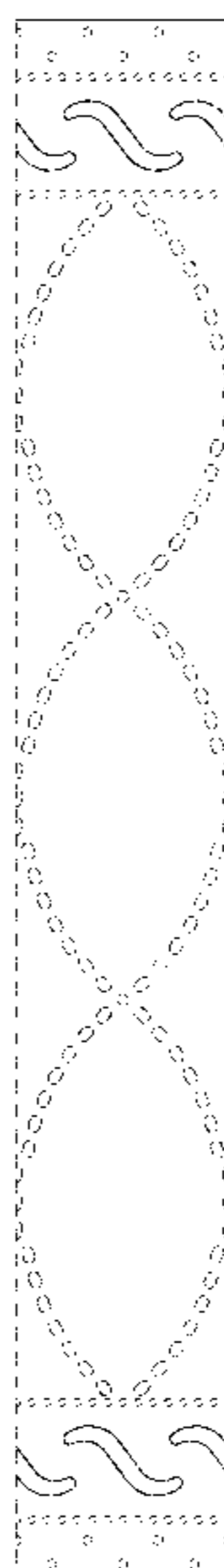
The ornamental design for a paper towel, as shown and described.
