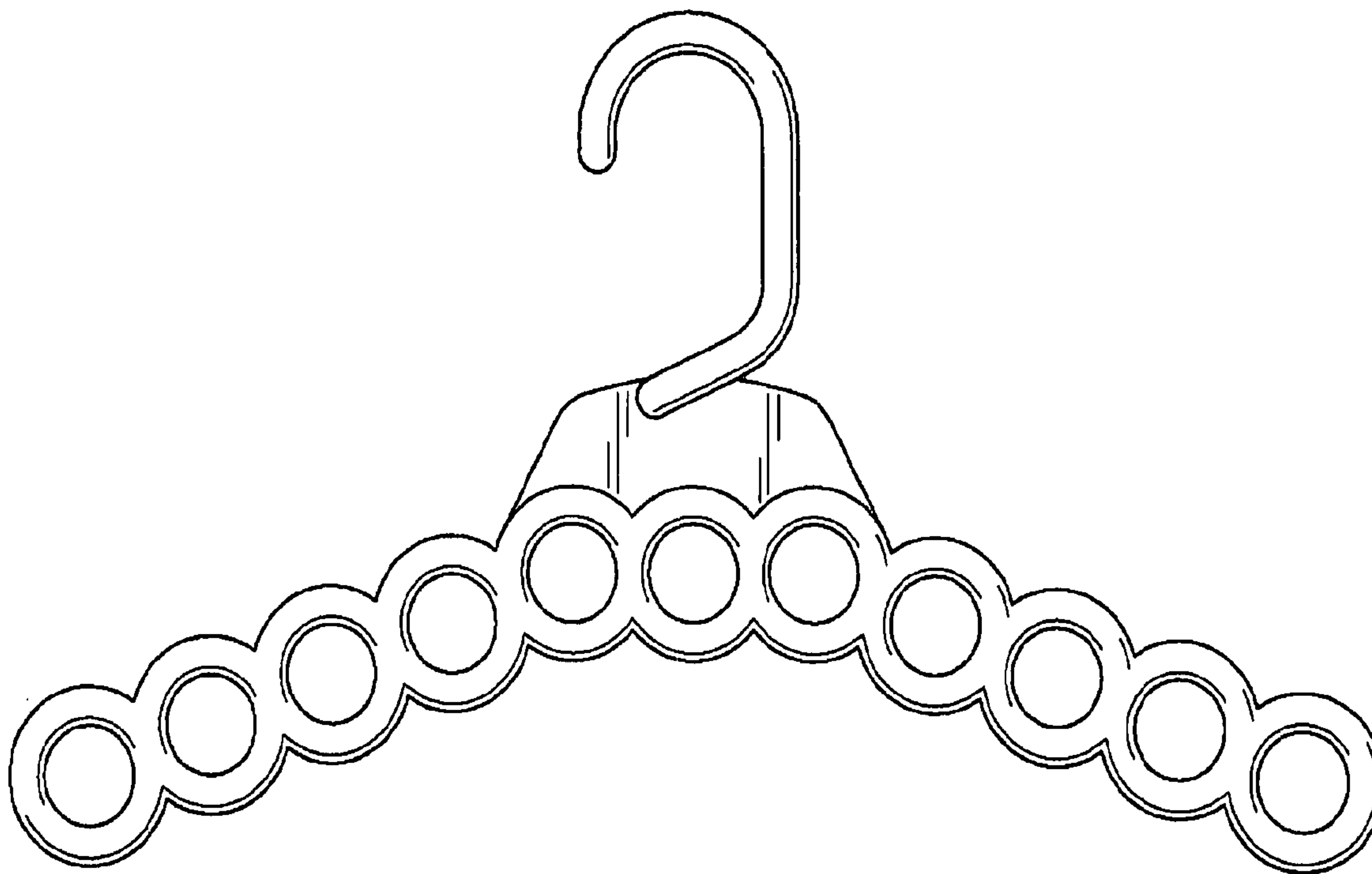
FIG. 2 is a bottom plan view thereof.

FIG. 2 is a top plan view thereof; and,

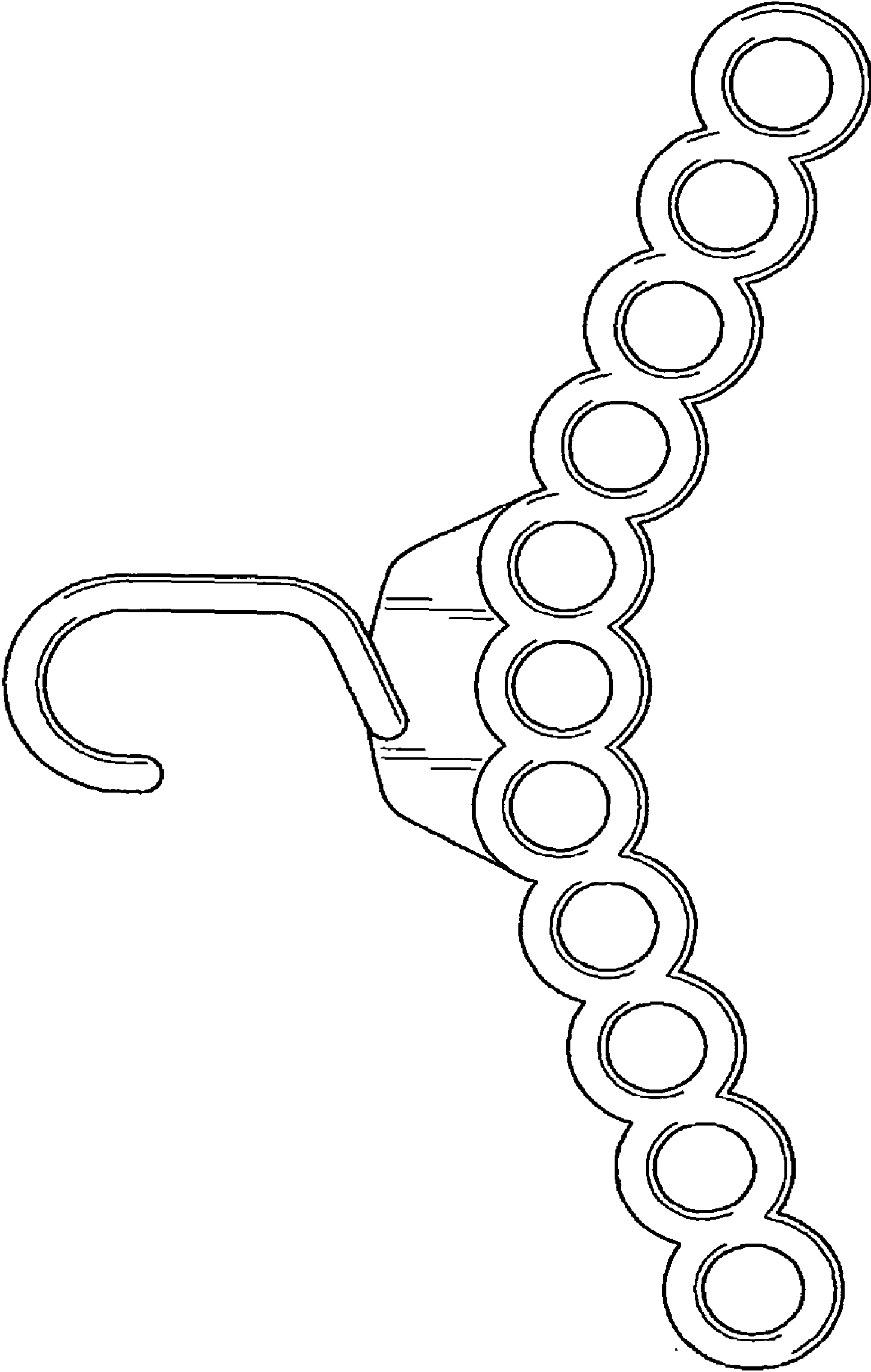

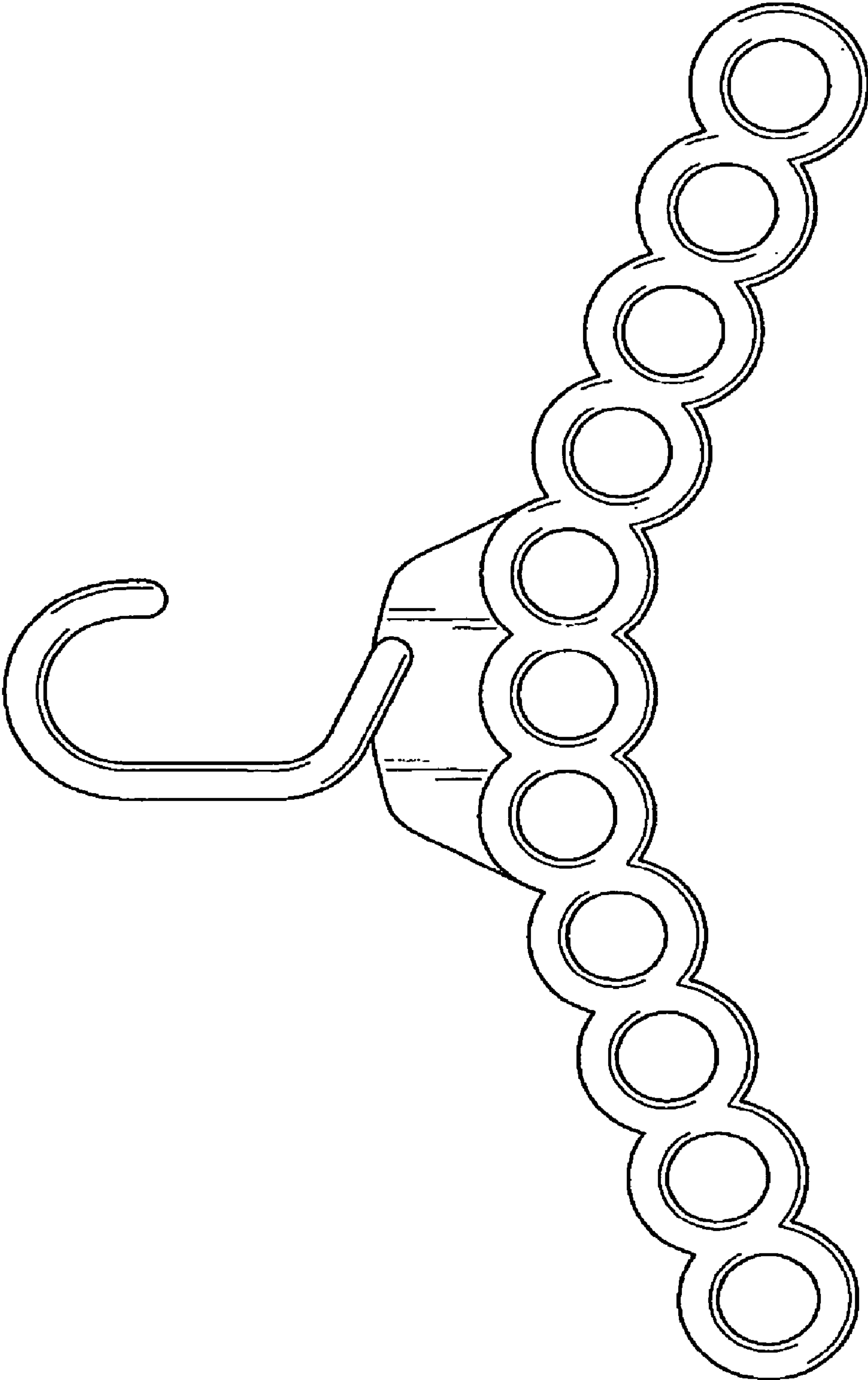
