DESCRIPTION

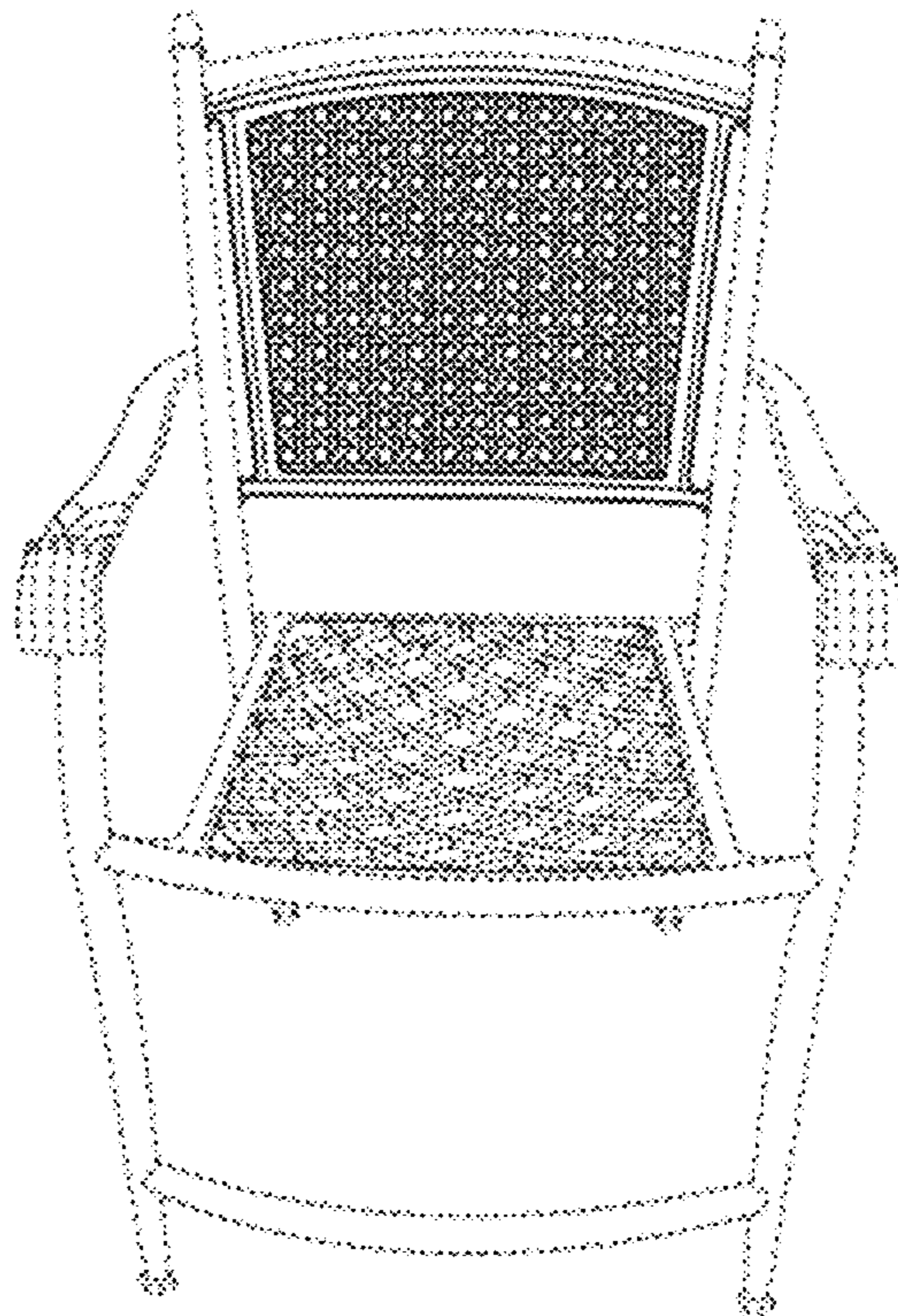
FIG. 1 is a front perspective view of the rattan chair back of the present design;

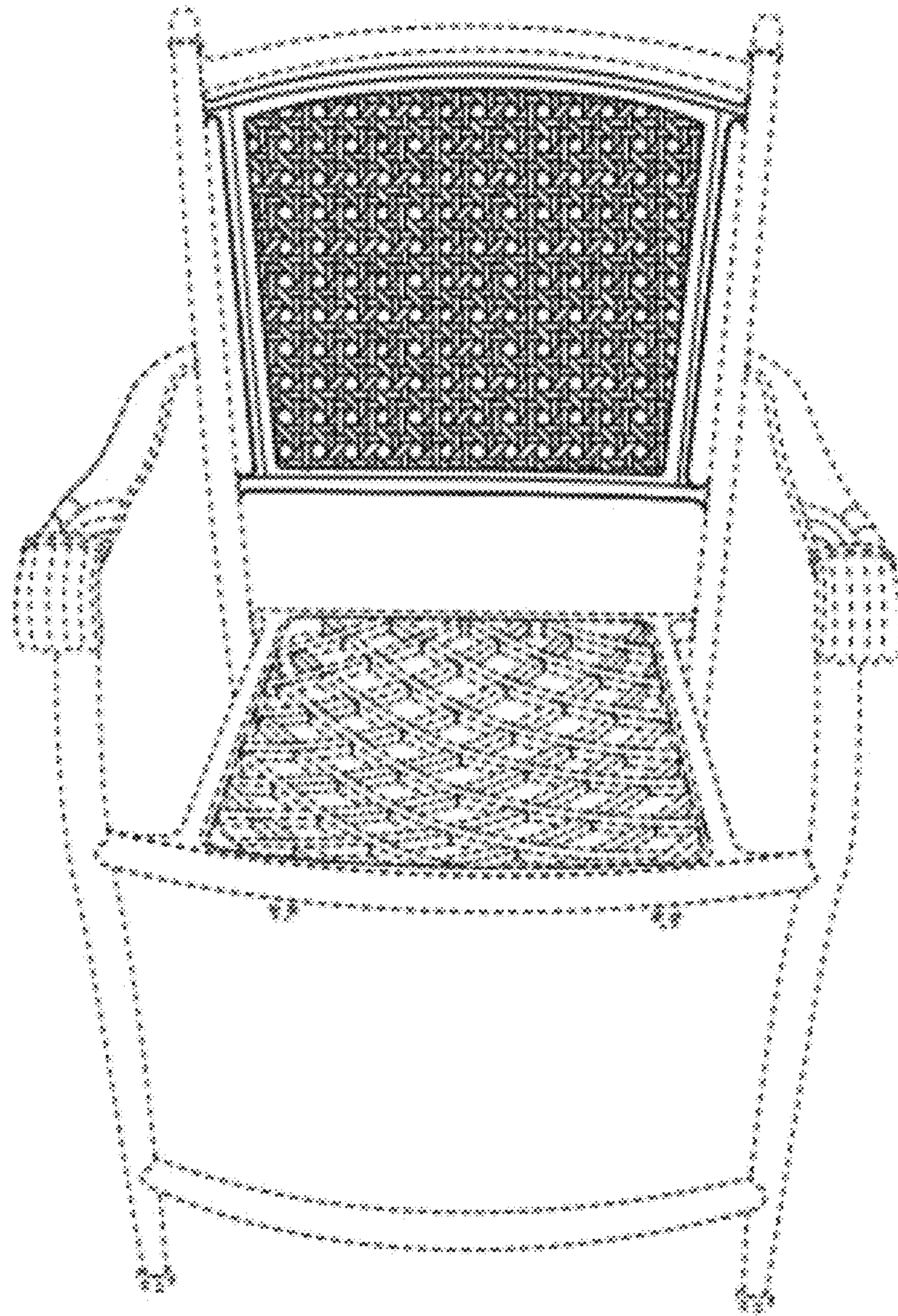

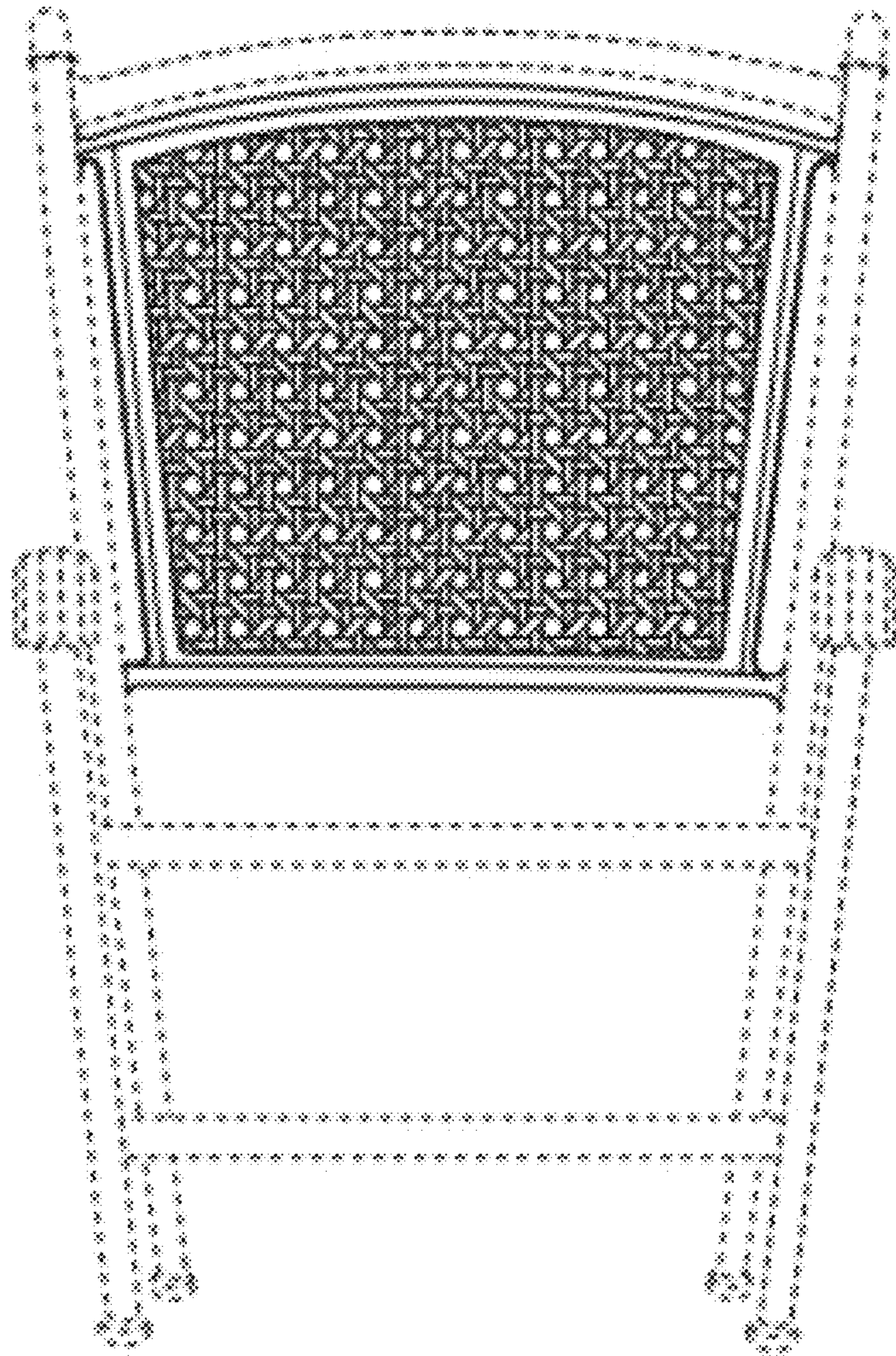

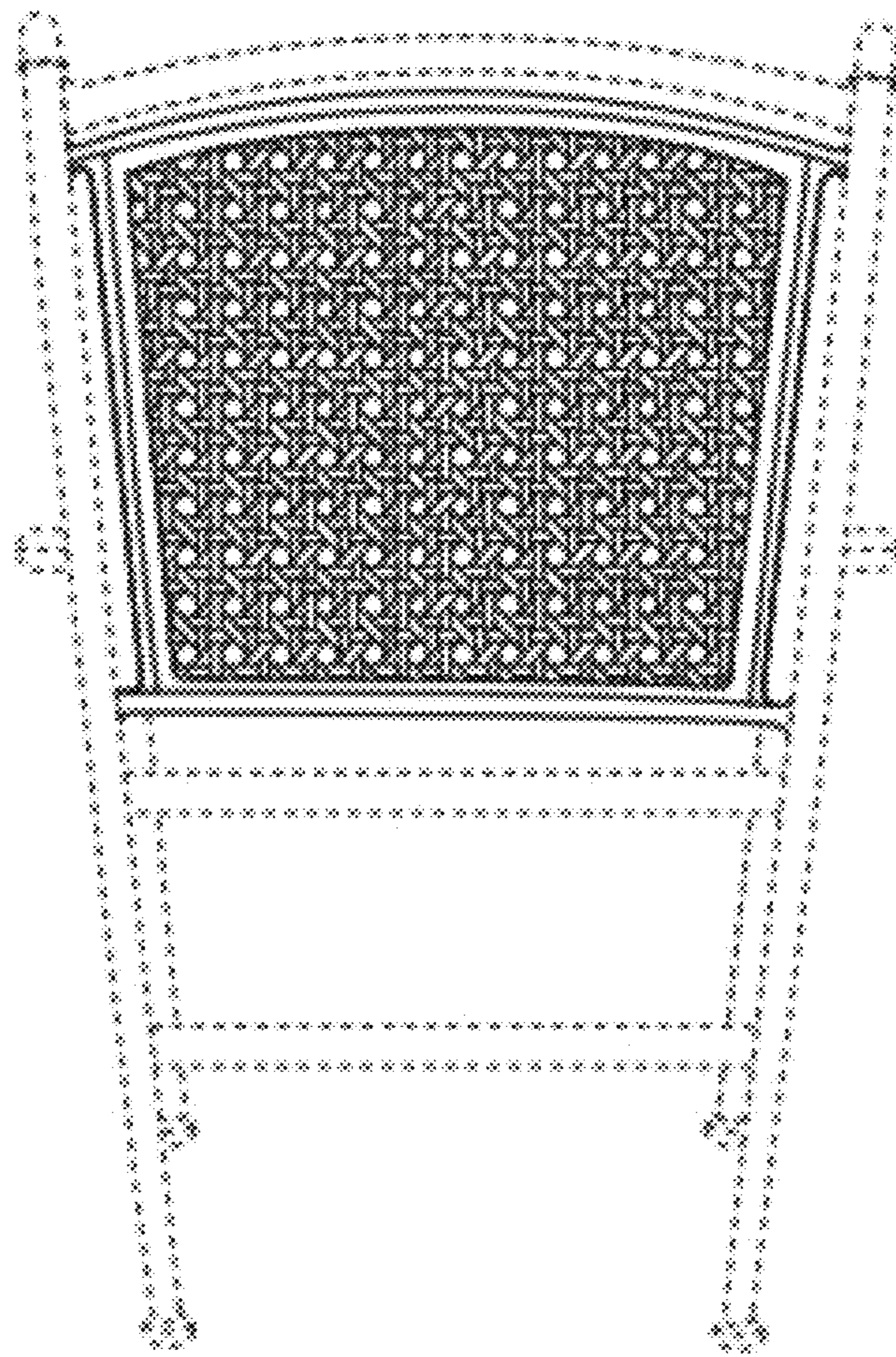

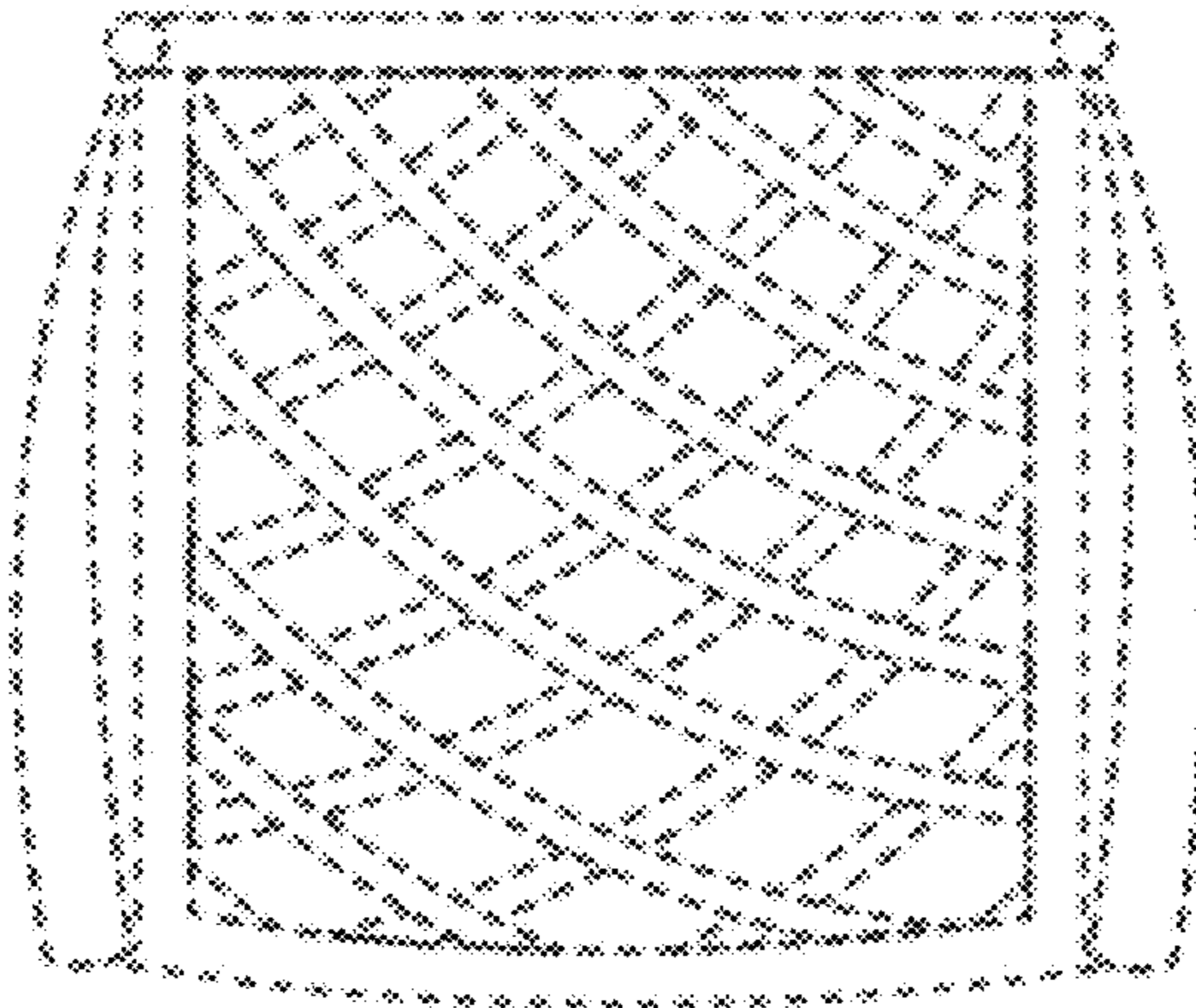

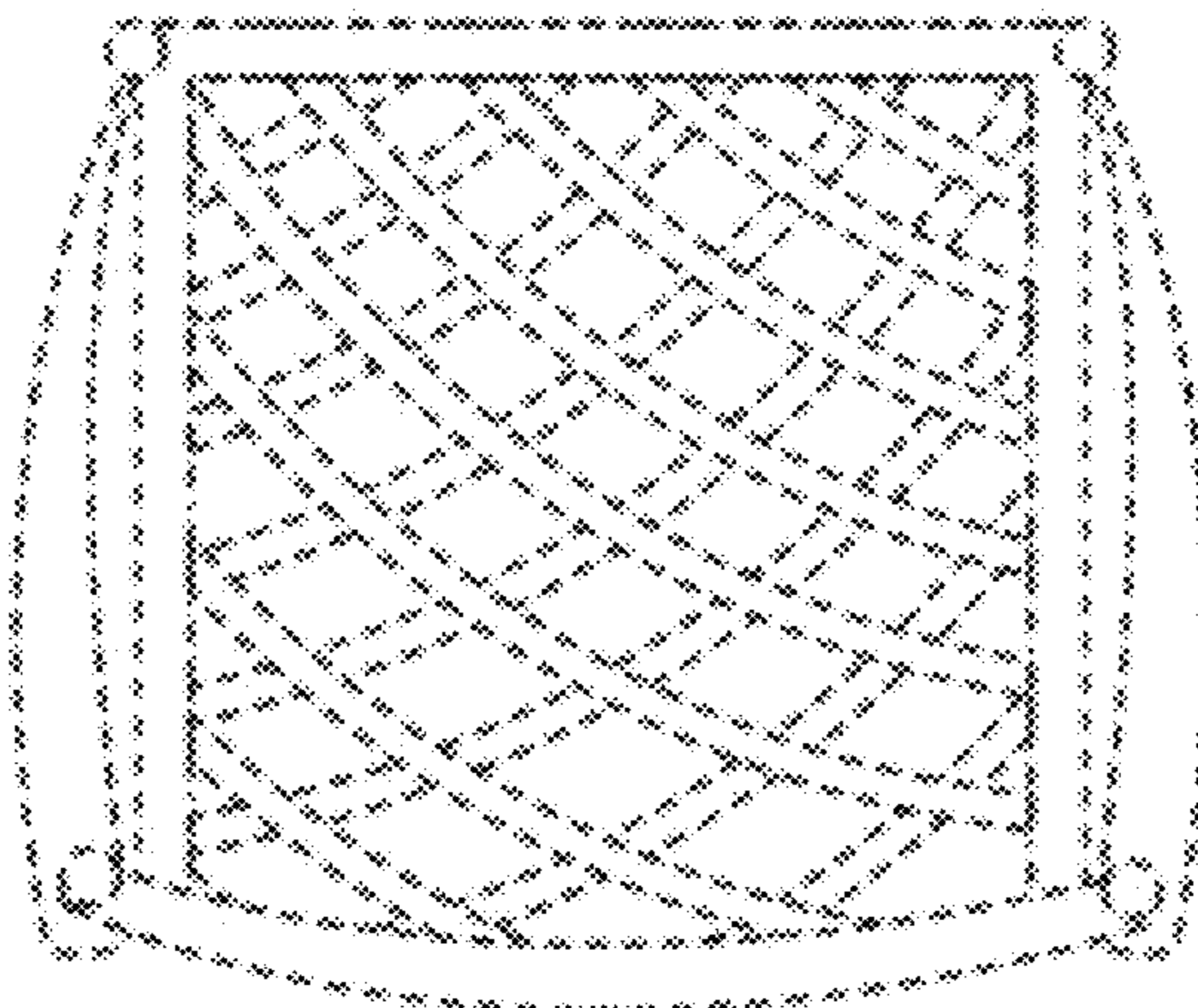

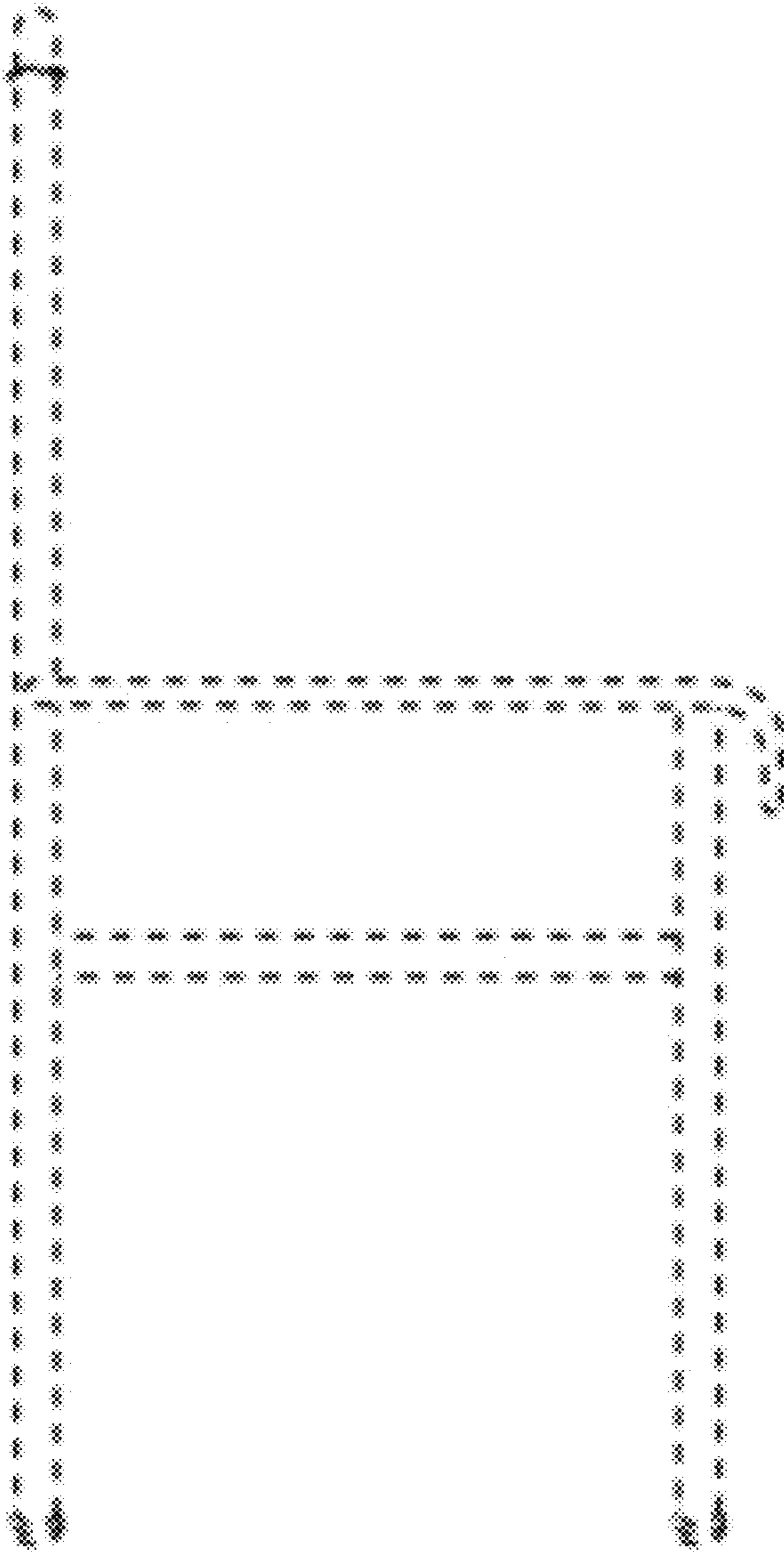
