The ornamental design for a rim on a circular pan, as shown and described.

DESCRIPTION

FIG. 1 is a top side perspective view of a rim on a circular pan in accordance with the invention shown;

FIG. 2 is a left side view of the rim on a circular pan from FIG. 1;

FIG. 3 is a right side view of the rim on a circular pan from FIG. 1;

FIG. 4 is a front side view of the rim on a circular pan from FIG. 1;

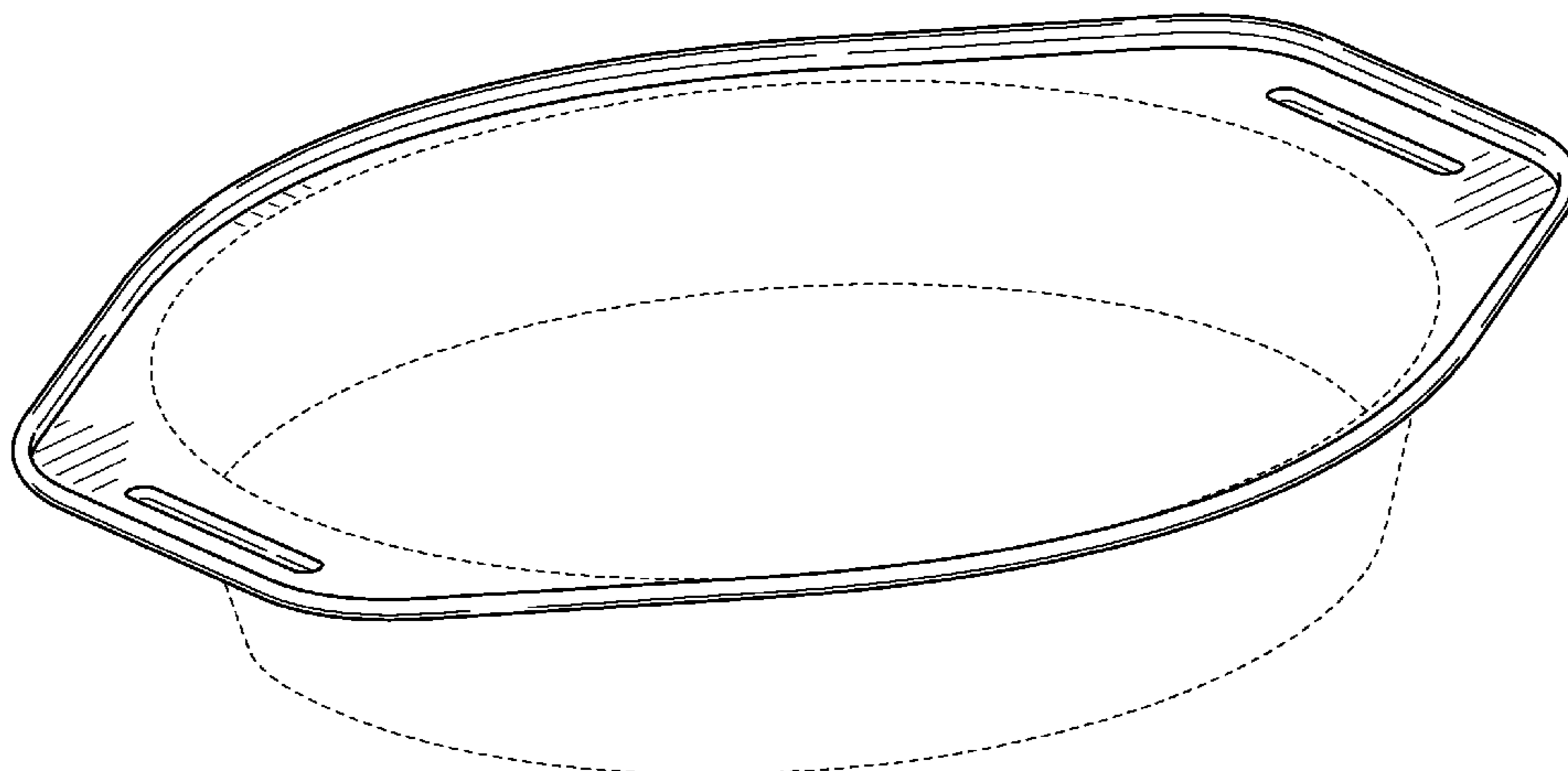
FIG. 5 is a back side view of the rim on a circular pan from FIG. 1;

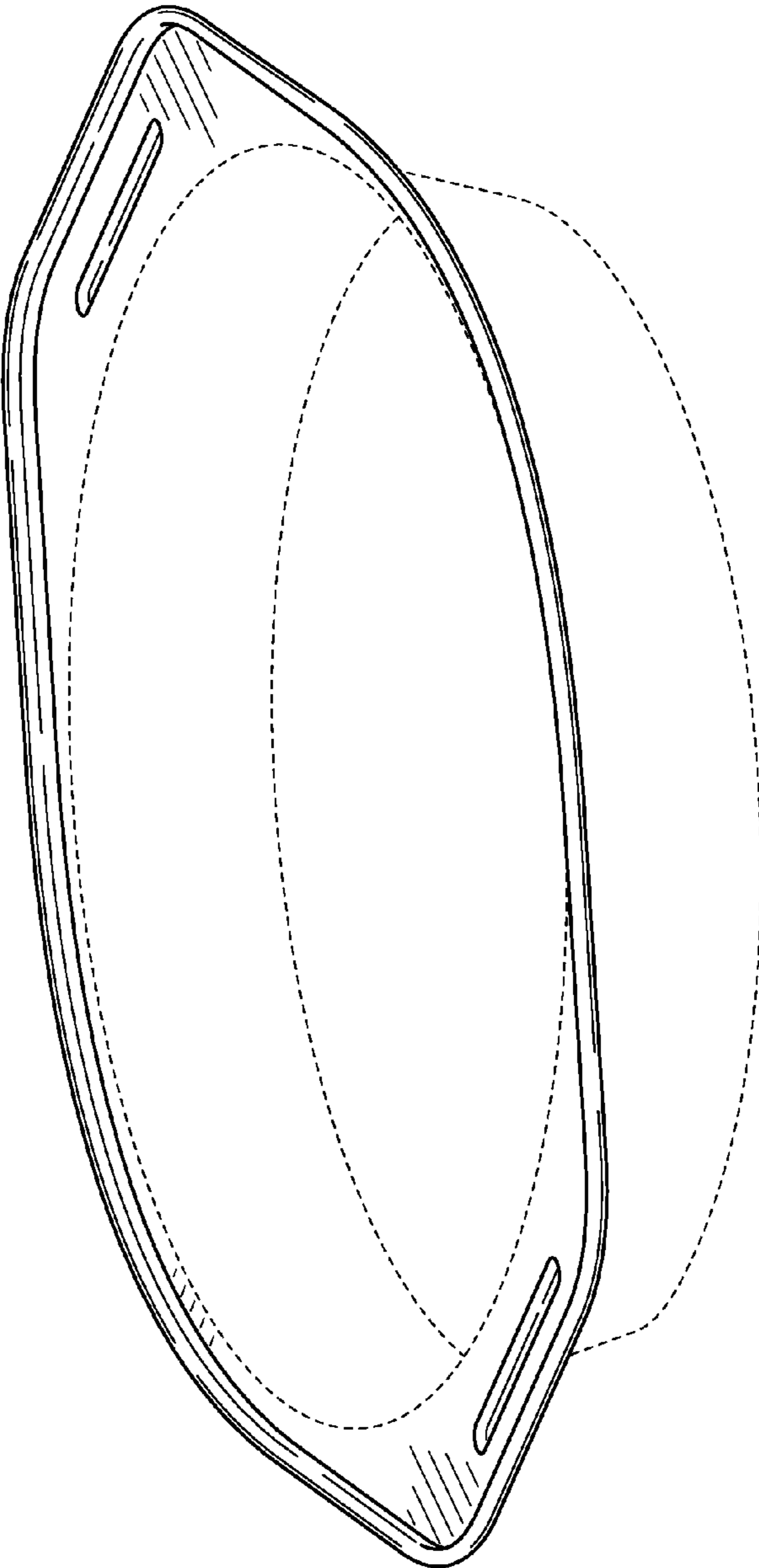

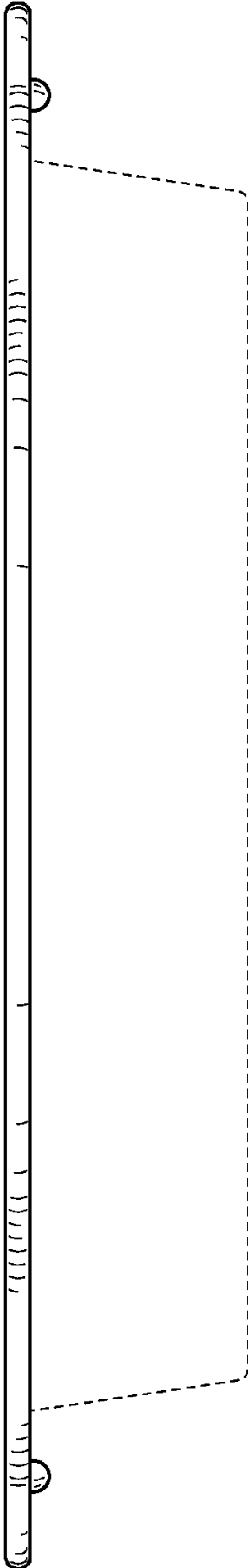

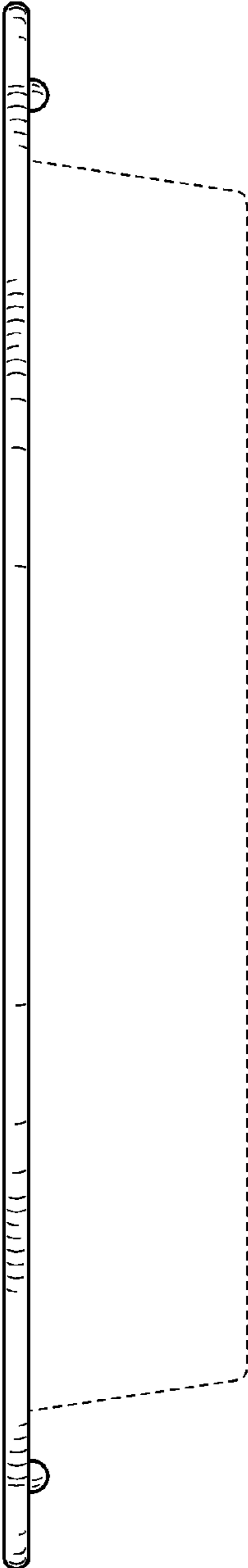

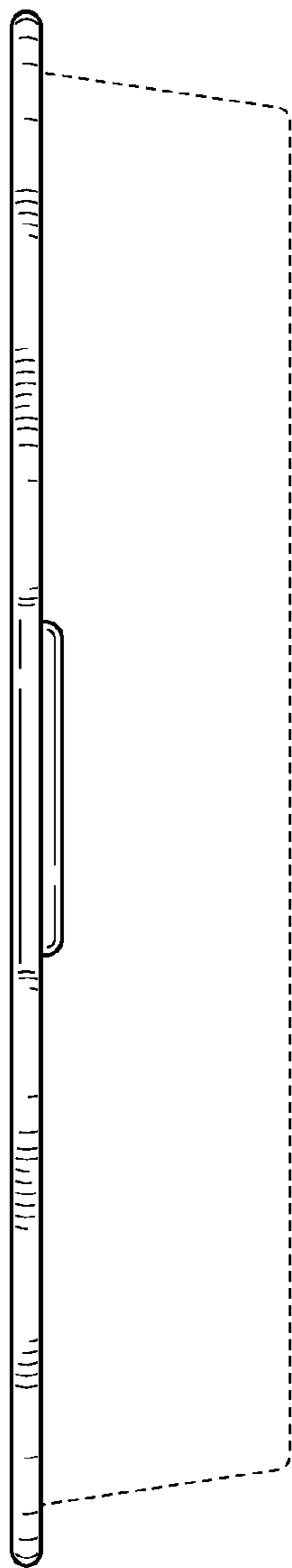

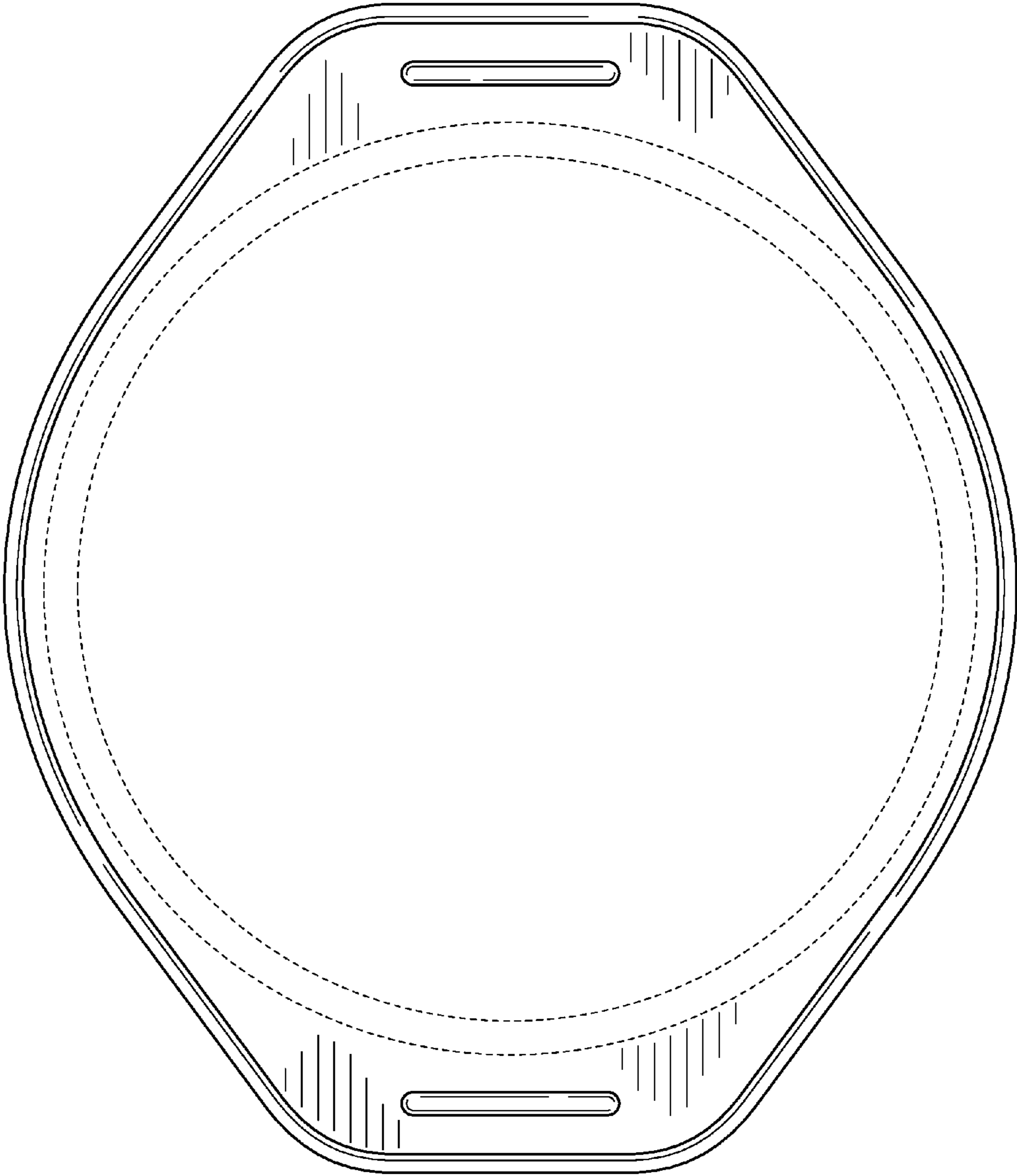
