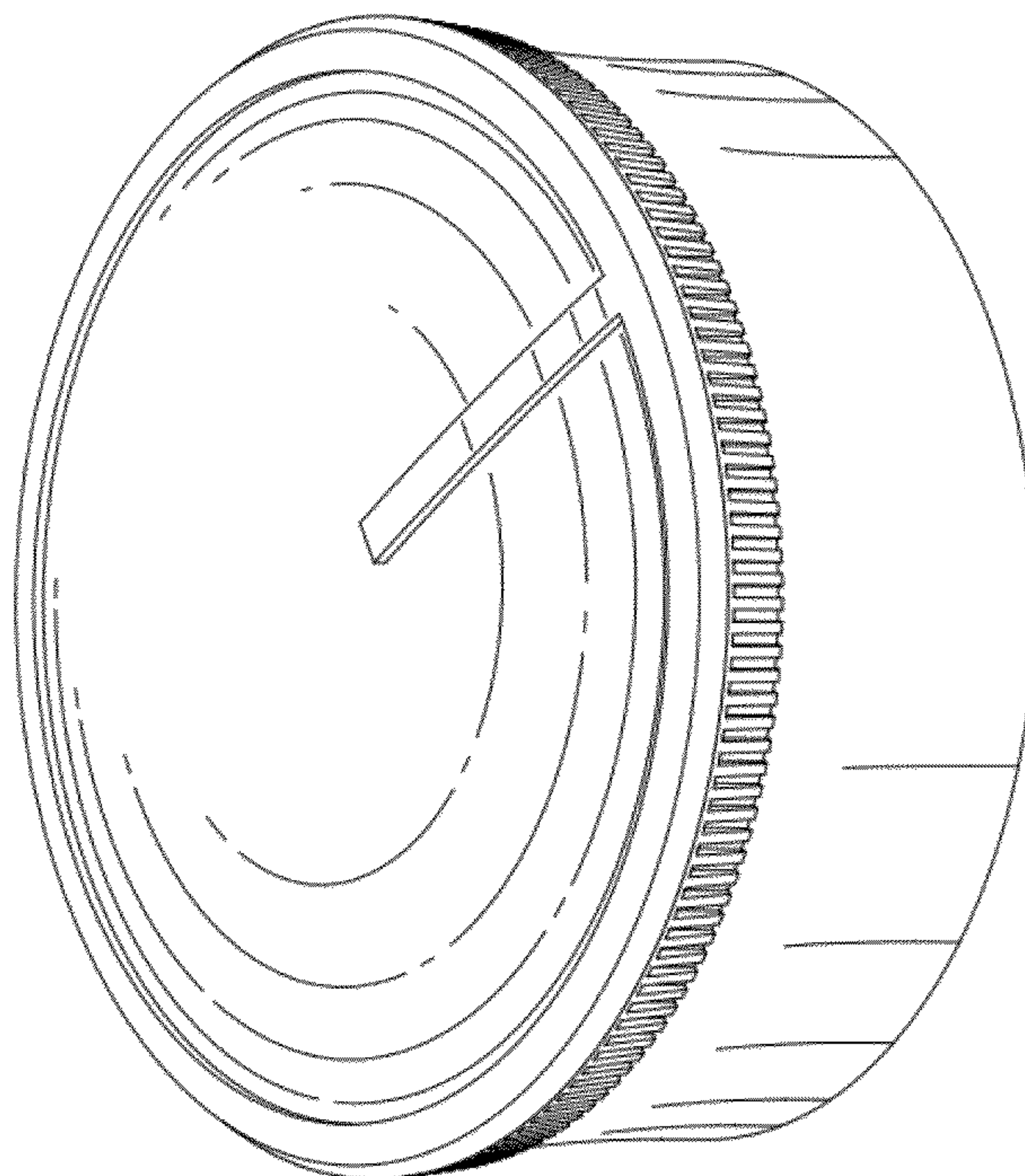
(57) **CLAIM**

We claim the ornamental design for an appliance knob, as
shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an appliance knob show-
ing our new design;
FIG. 2 is a front elevation view of the appliance knob of FIG.
1;
FIG. 3 is a rear elevation view of the appliance knob of FIG.
1;
FIG. 4 is a top plan view of the appliance knob of FIG. 1;
FIG. 5 is a bottom plan view of the appliance knob of FIG. 1;
and,
FIG. 6 is a first side elevation view of the appliance knob of
FIG. 1, with the second side elevation view being a mirror
image of the first side elevation view.

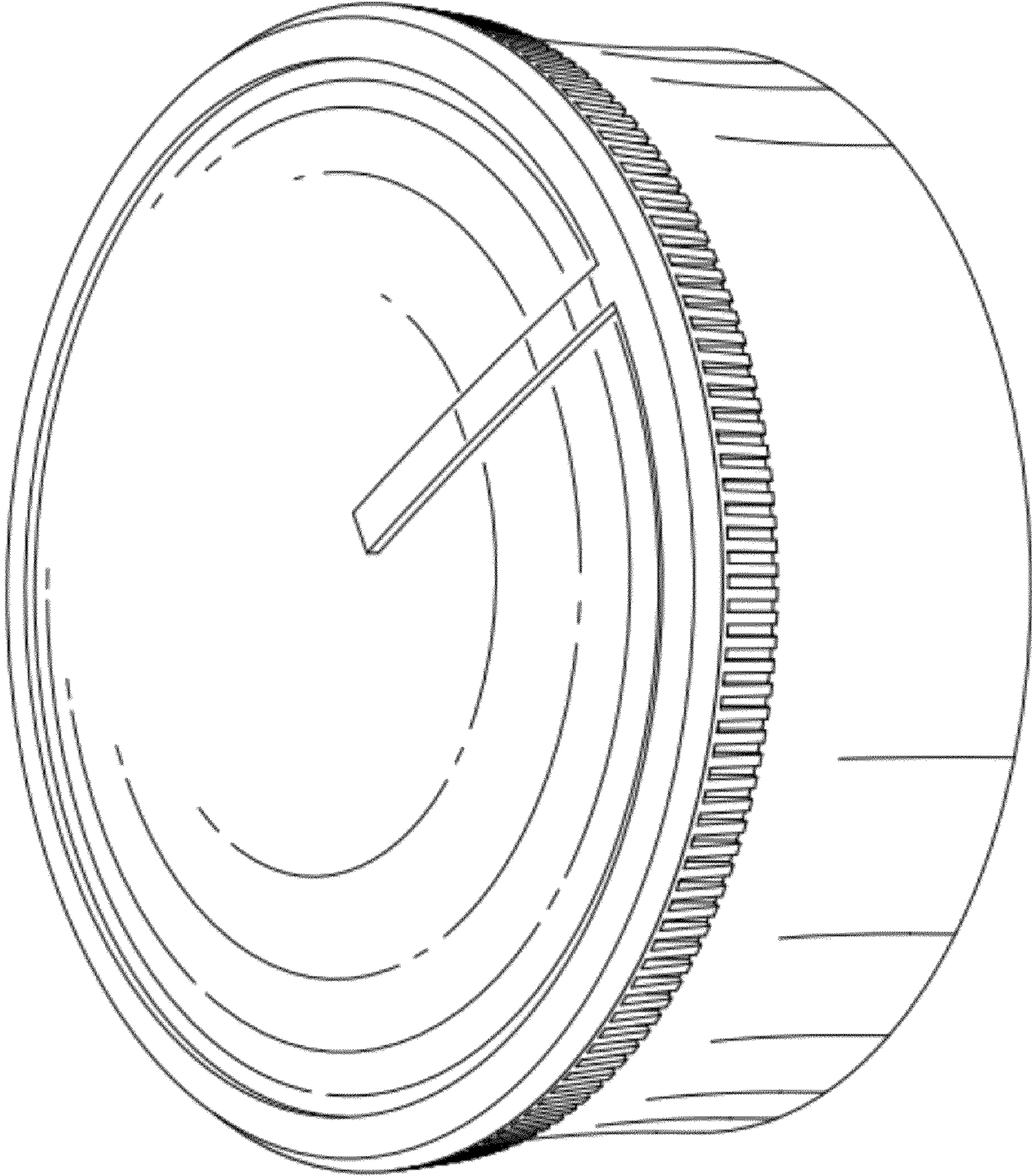

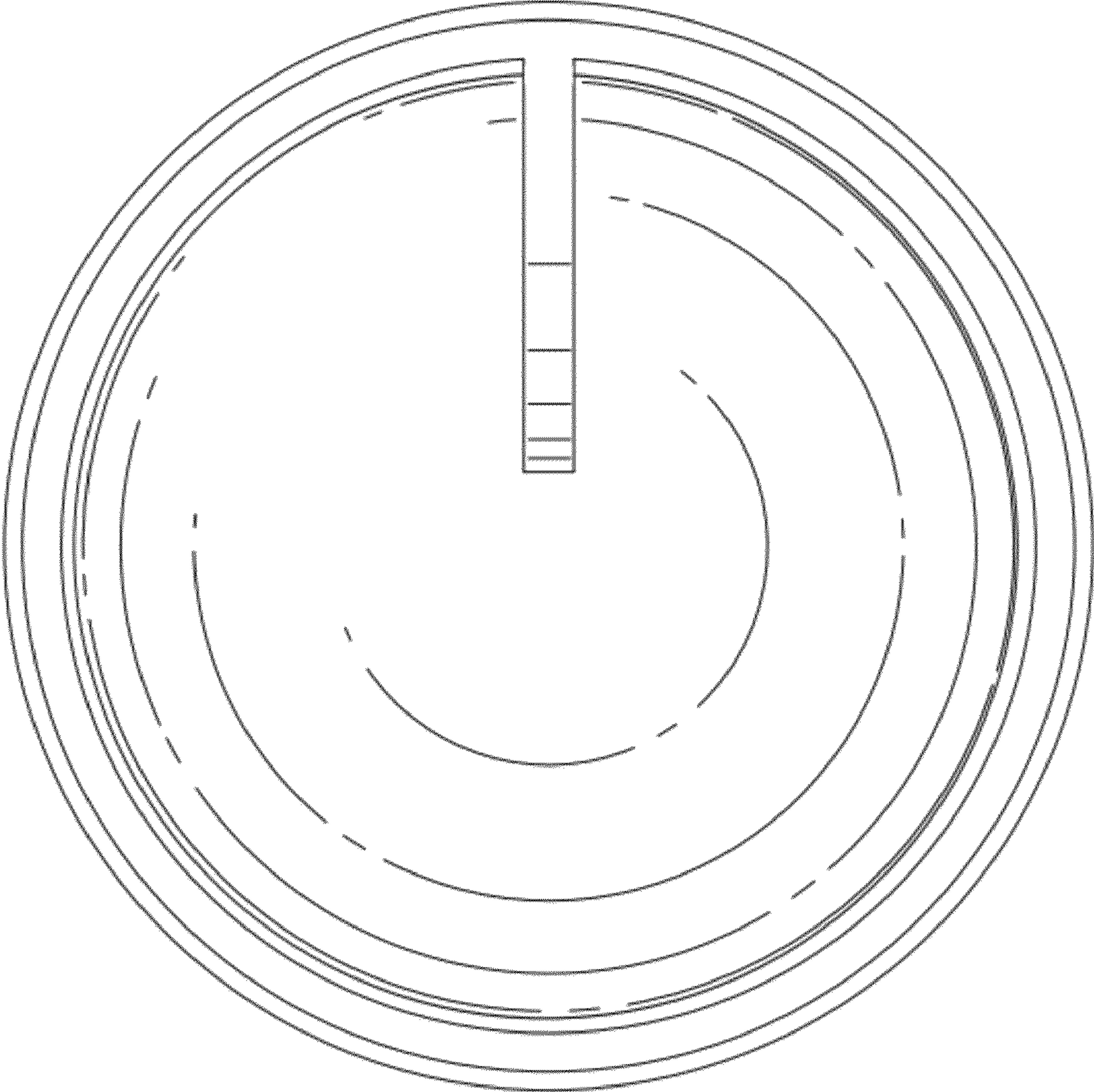

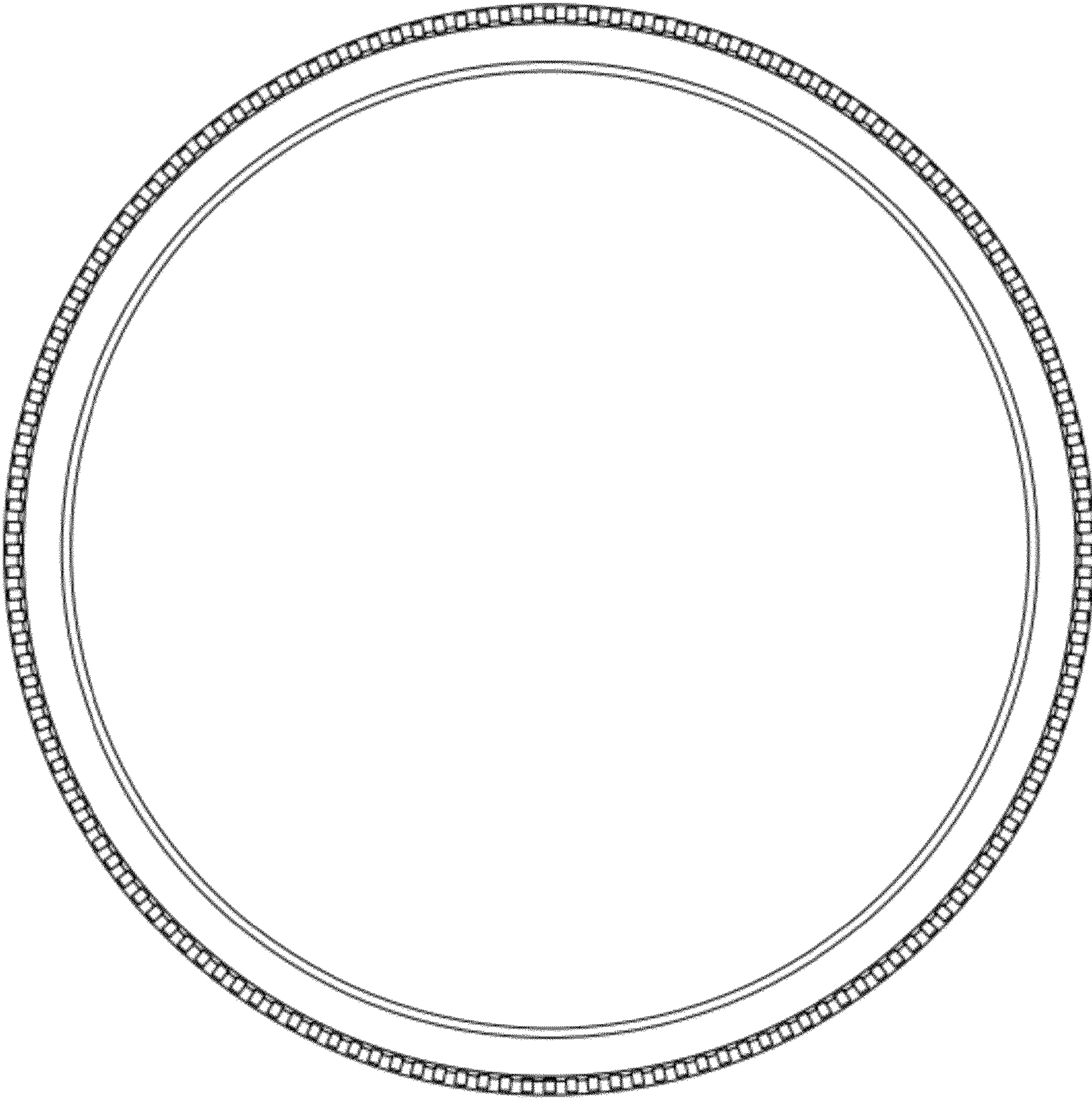

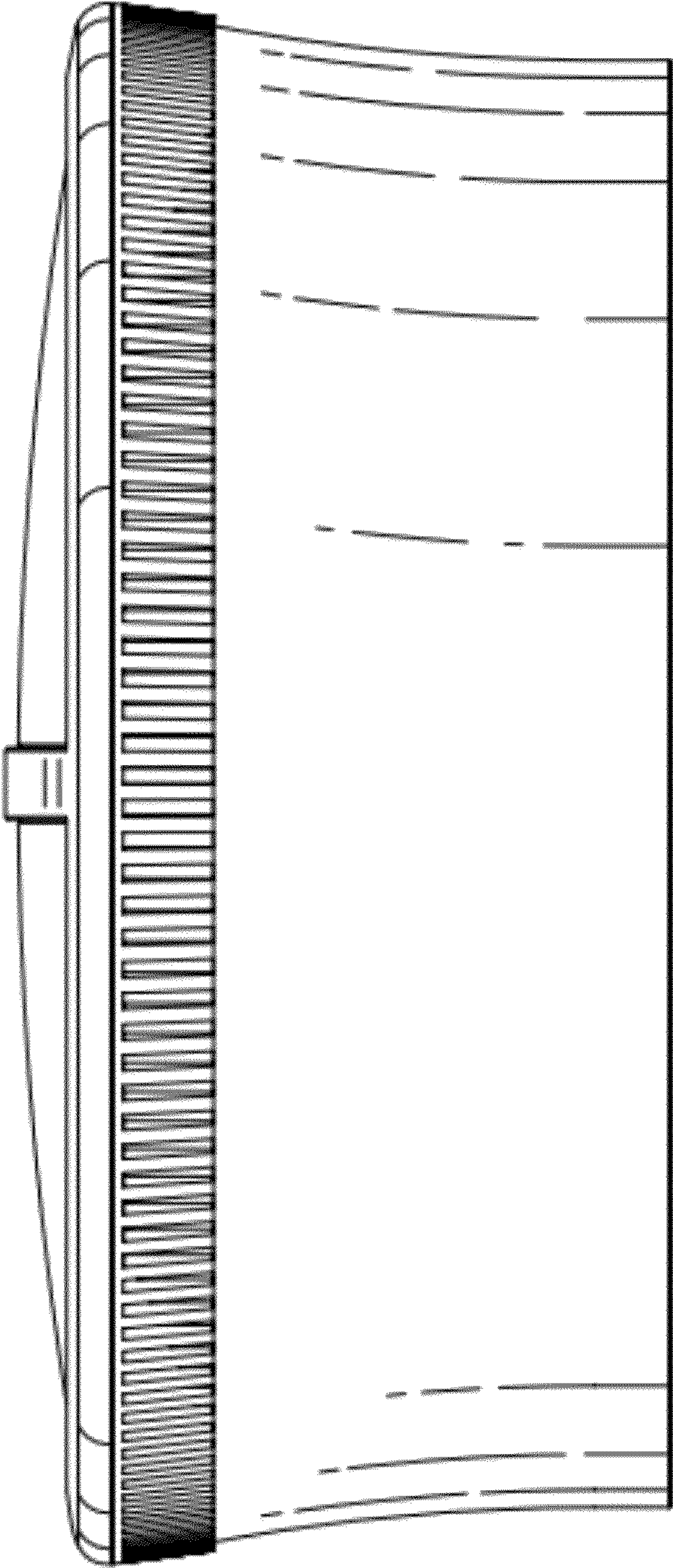

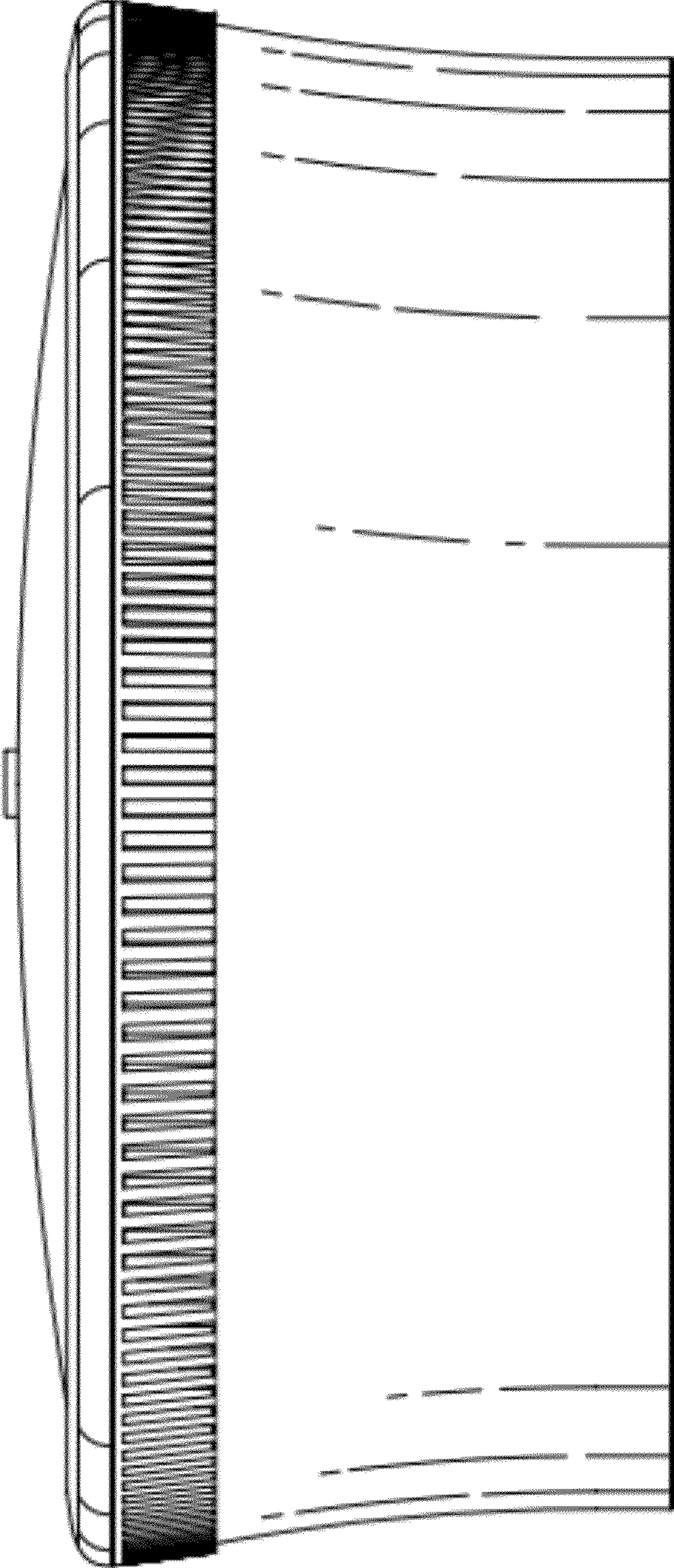

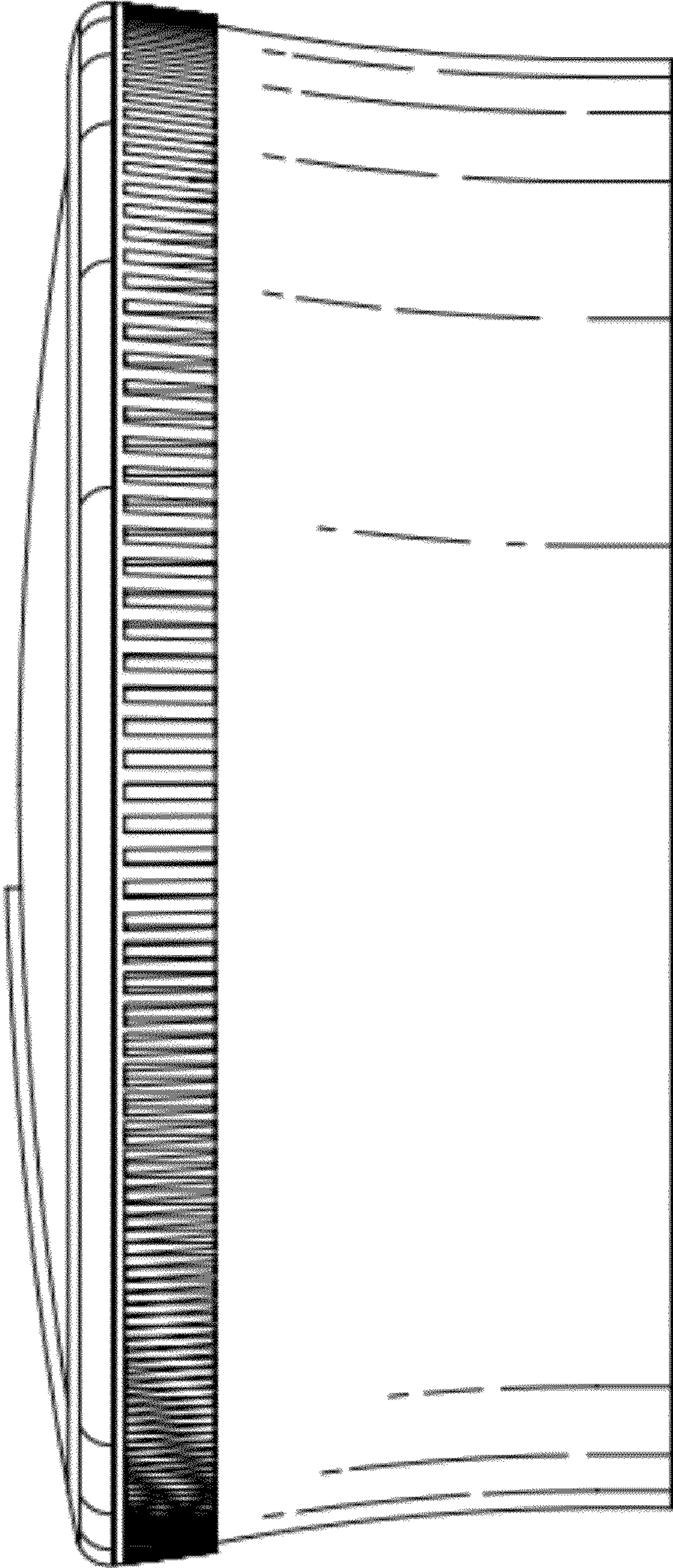
