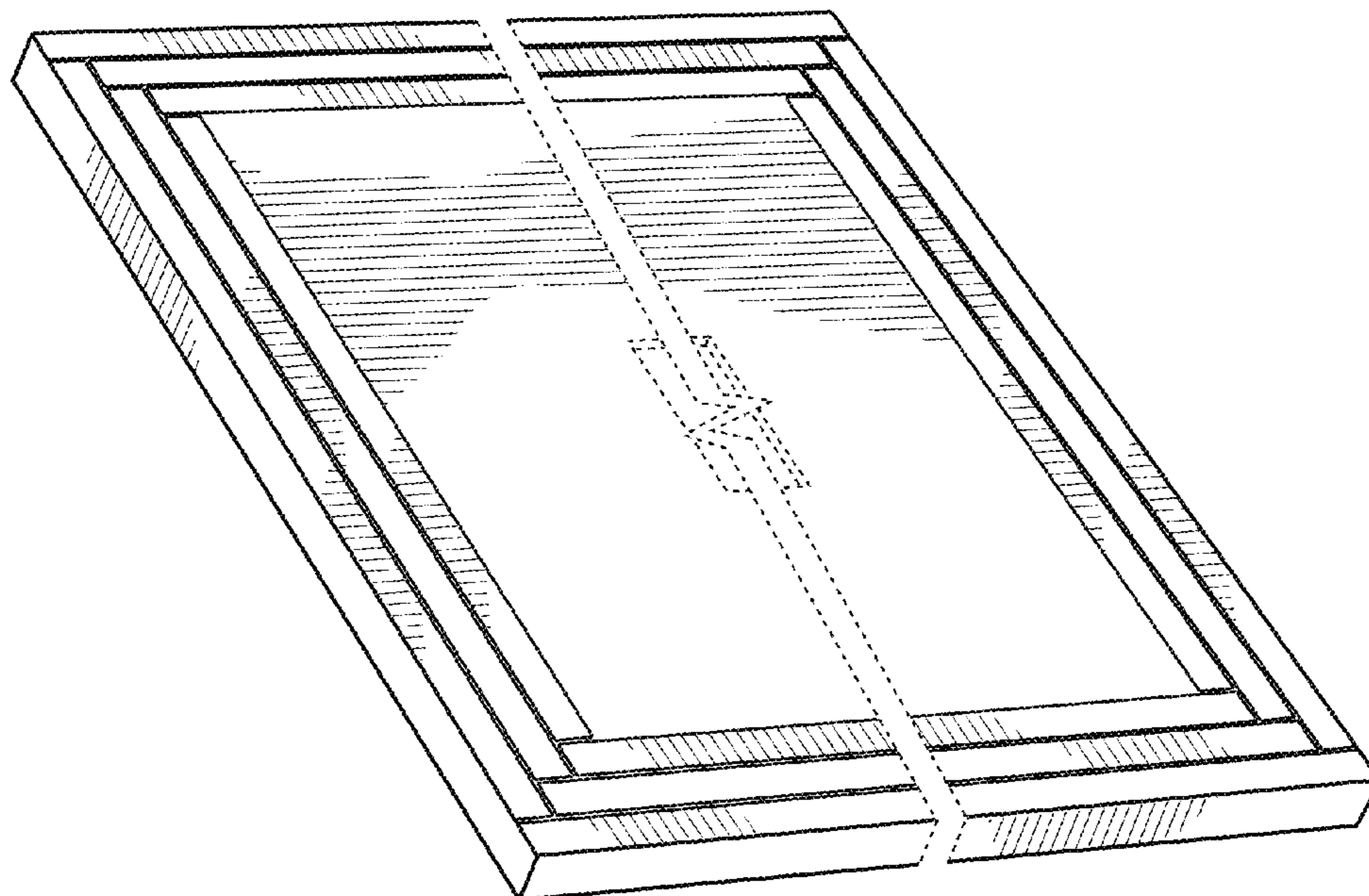
(57) **CLAIM**

The ornamental design for a wall plate, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wall plate showing my new design, the two parallel central broken lines are indicative of indeterminate width forms no part of the claimed design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; the bottom plan view being a mirror image thereof; and, FIG. 5 is a right side elevational view thereof; the left side elevational view being a mirror image thereof. The broken-line disclosure in the views represents portions of the article in which the claimed design is embodied, but which form no part of the claimed design.

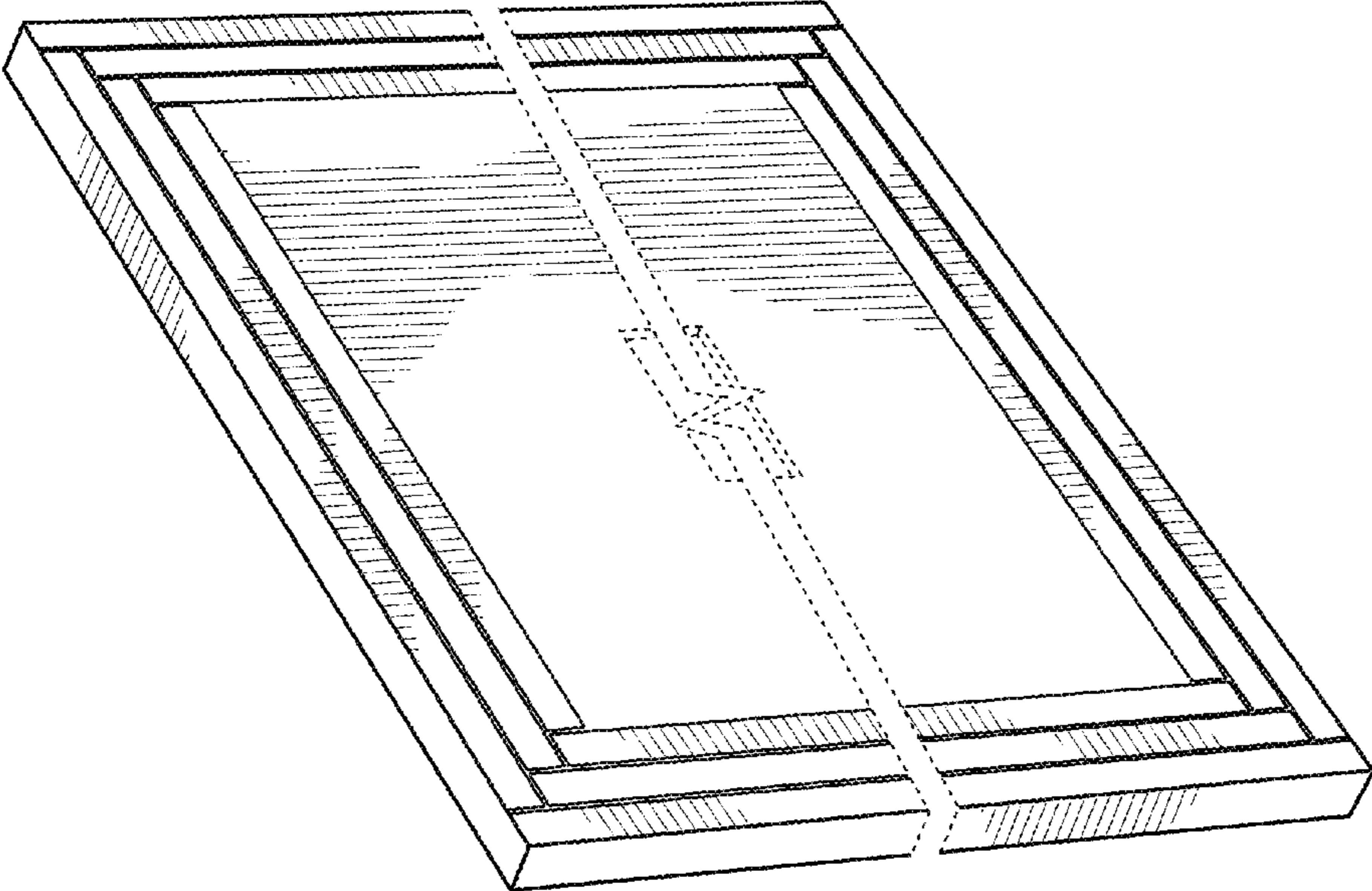

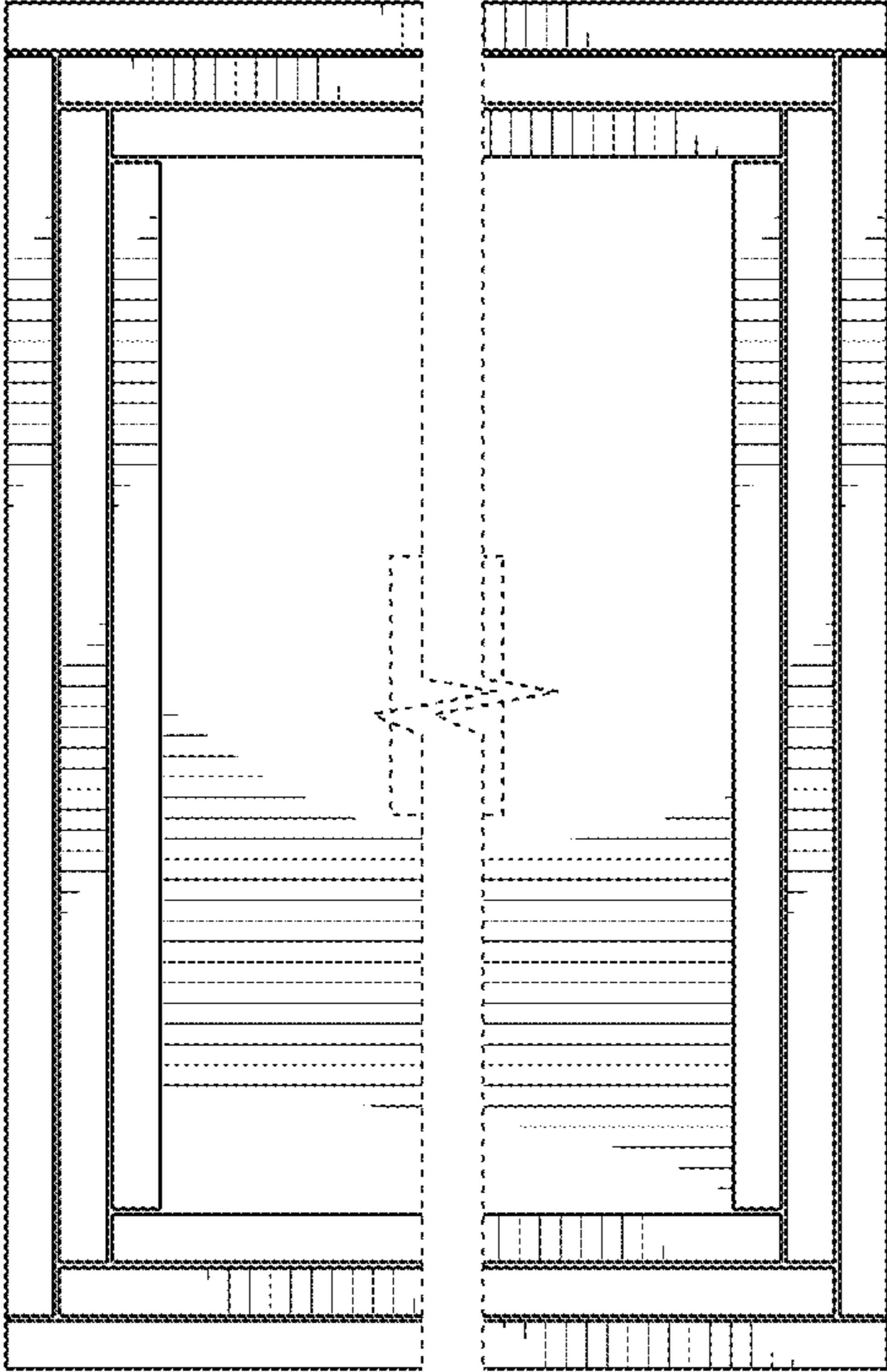

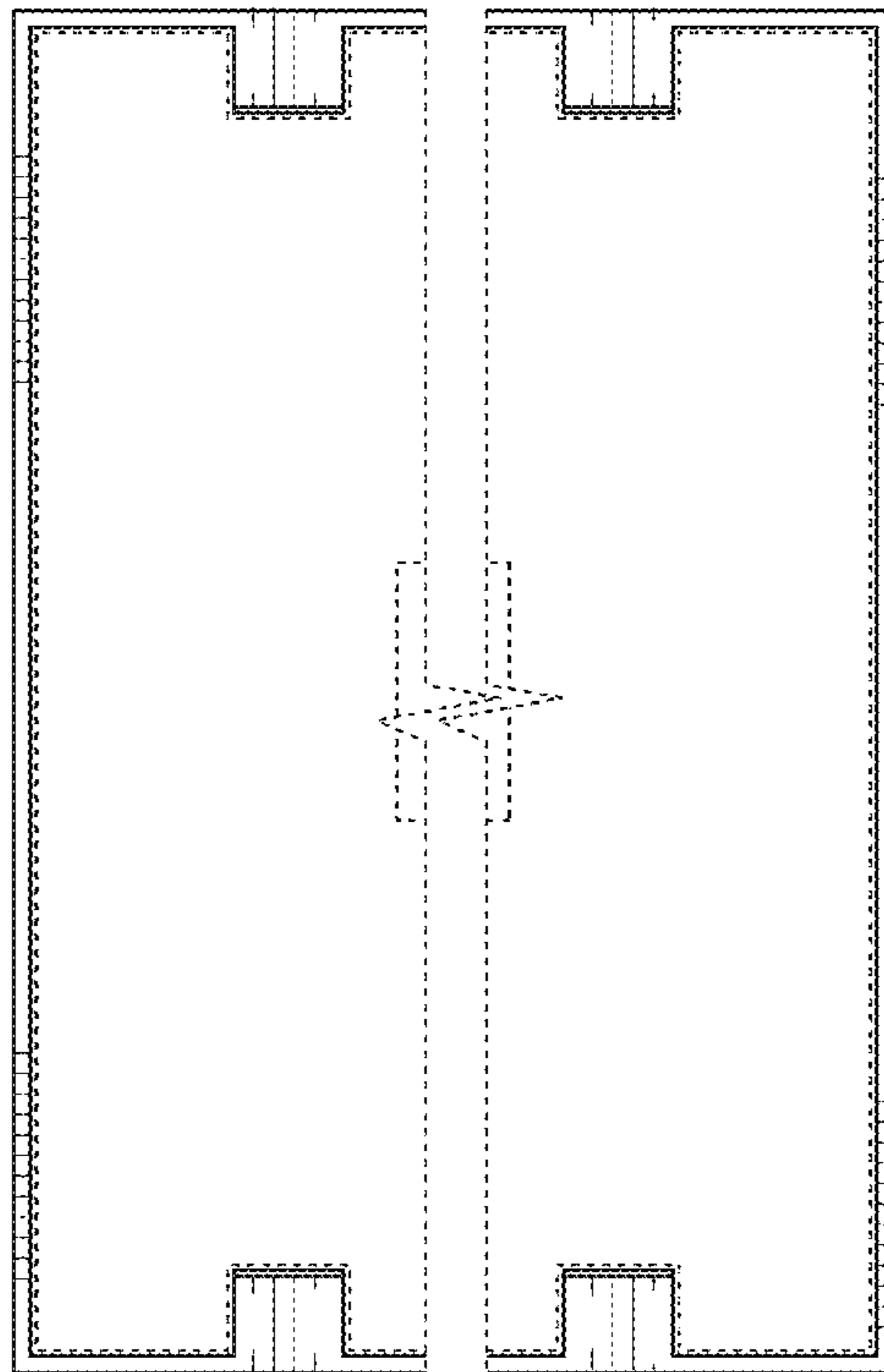

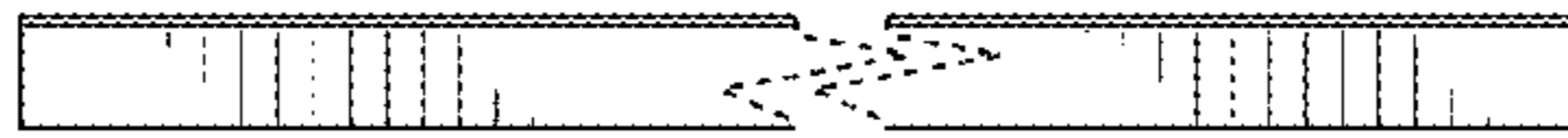
