We claim the ornamental design for a bottle, as shown and
described.

DESCRIPTION

FIG. 1 is a top/right/front perspective view of a bottle
("Heat");

FIG. 2 is a bottom/left/rear perspective view thereof;

FIG. 3 is a front elevational view thereof, for which a rear
elevational view would be a mirror image thereof;

FIG. 4 is a left side elevational view thereof;

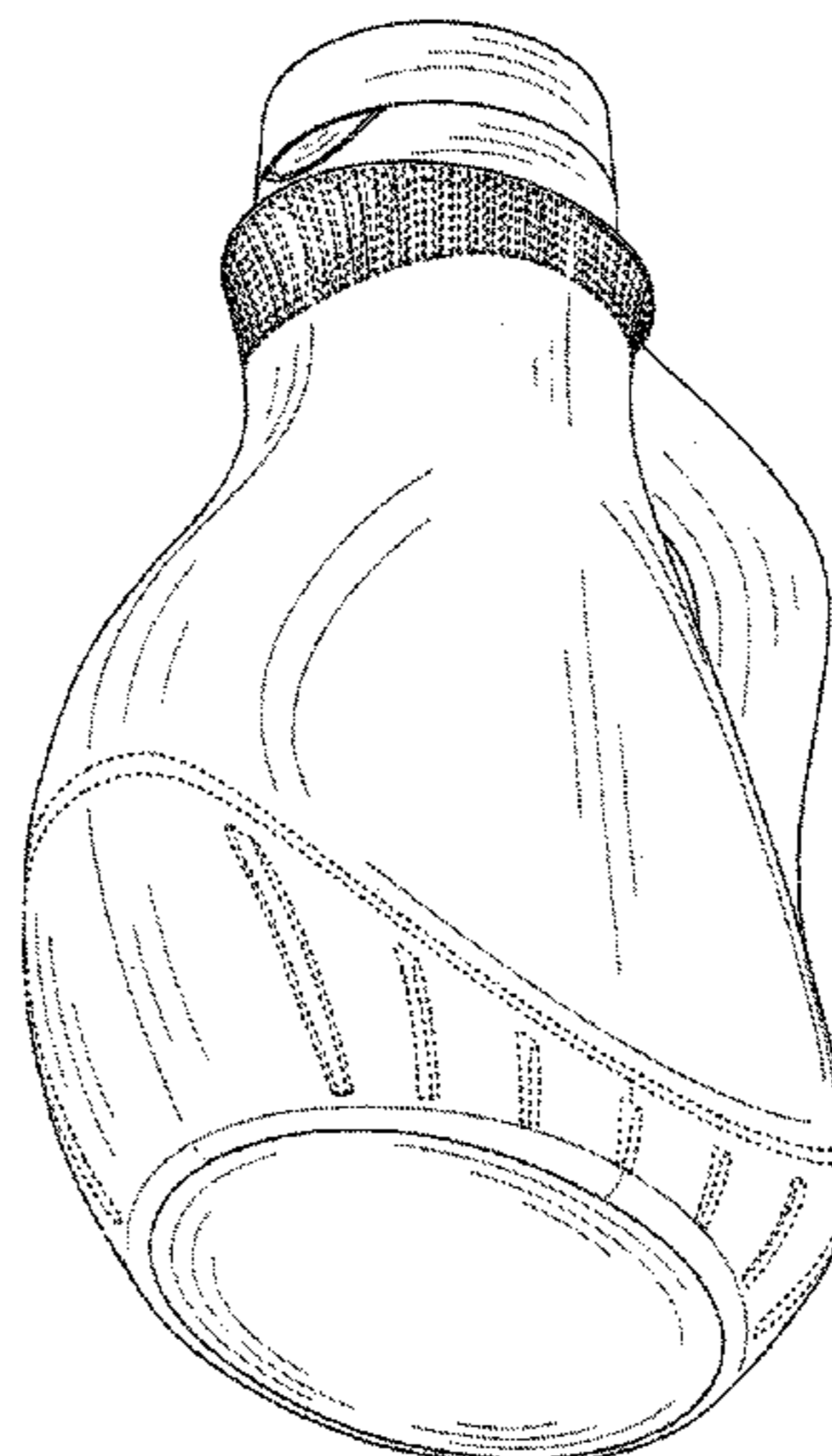
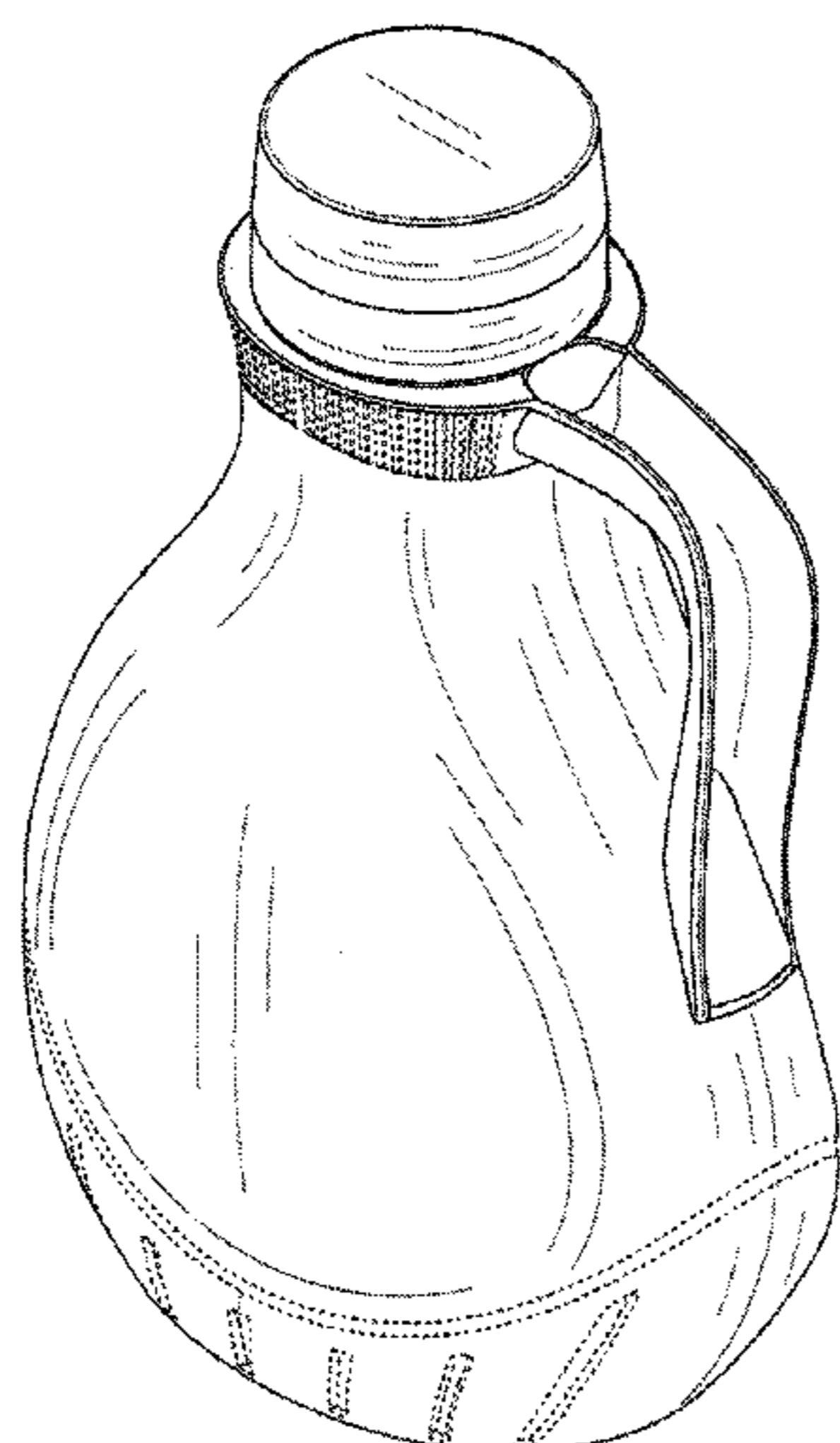
FIG. 5 is a right side elevational view thereof;

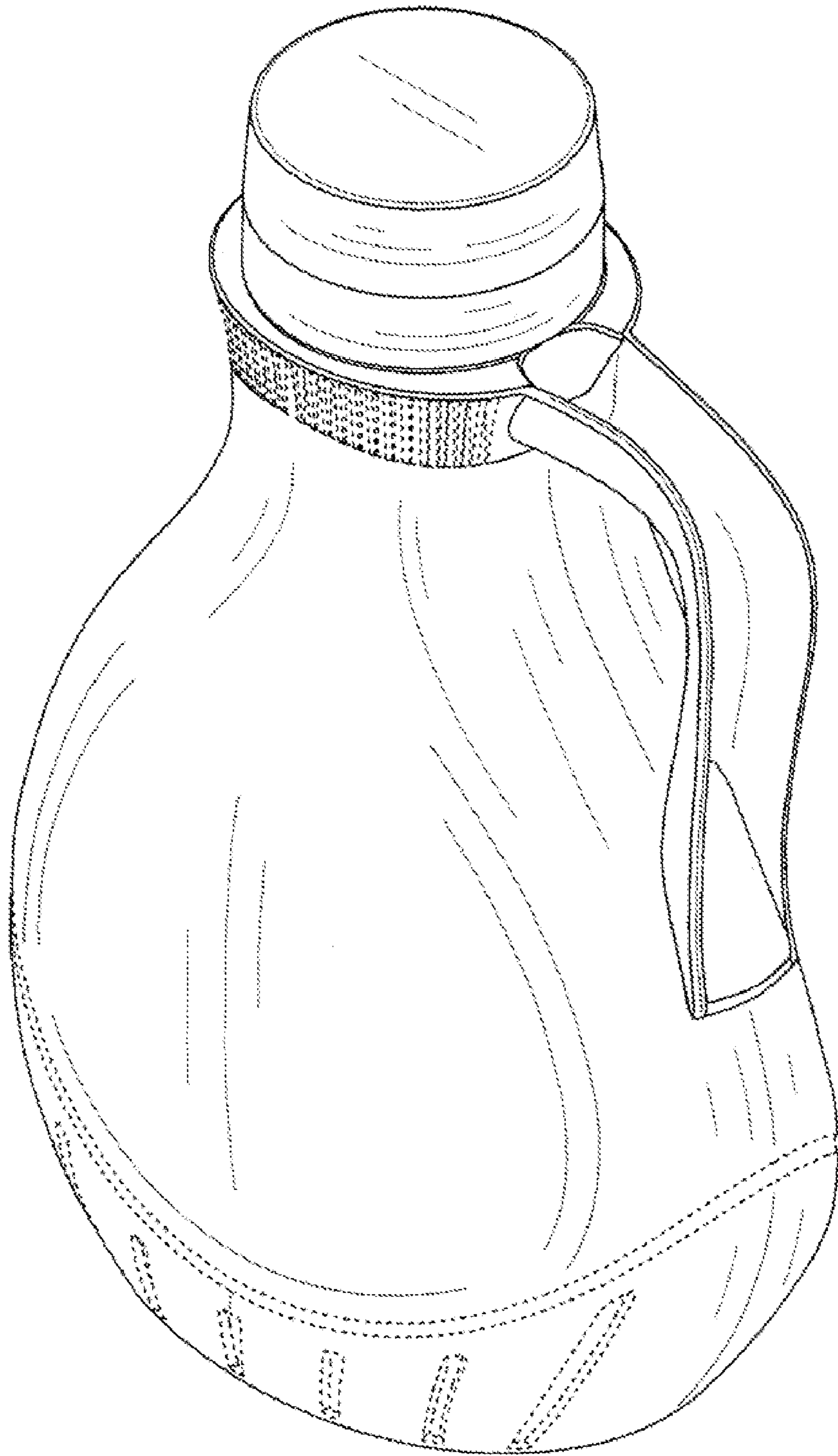

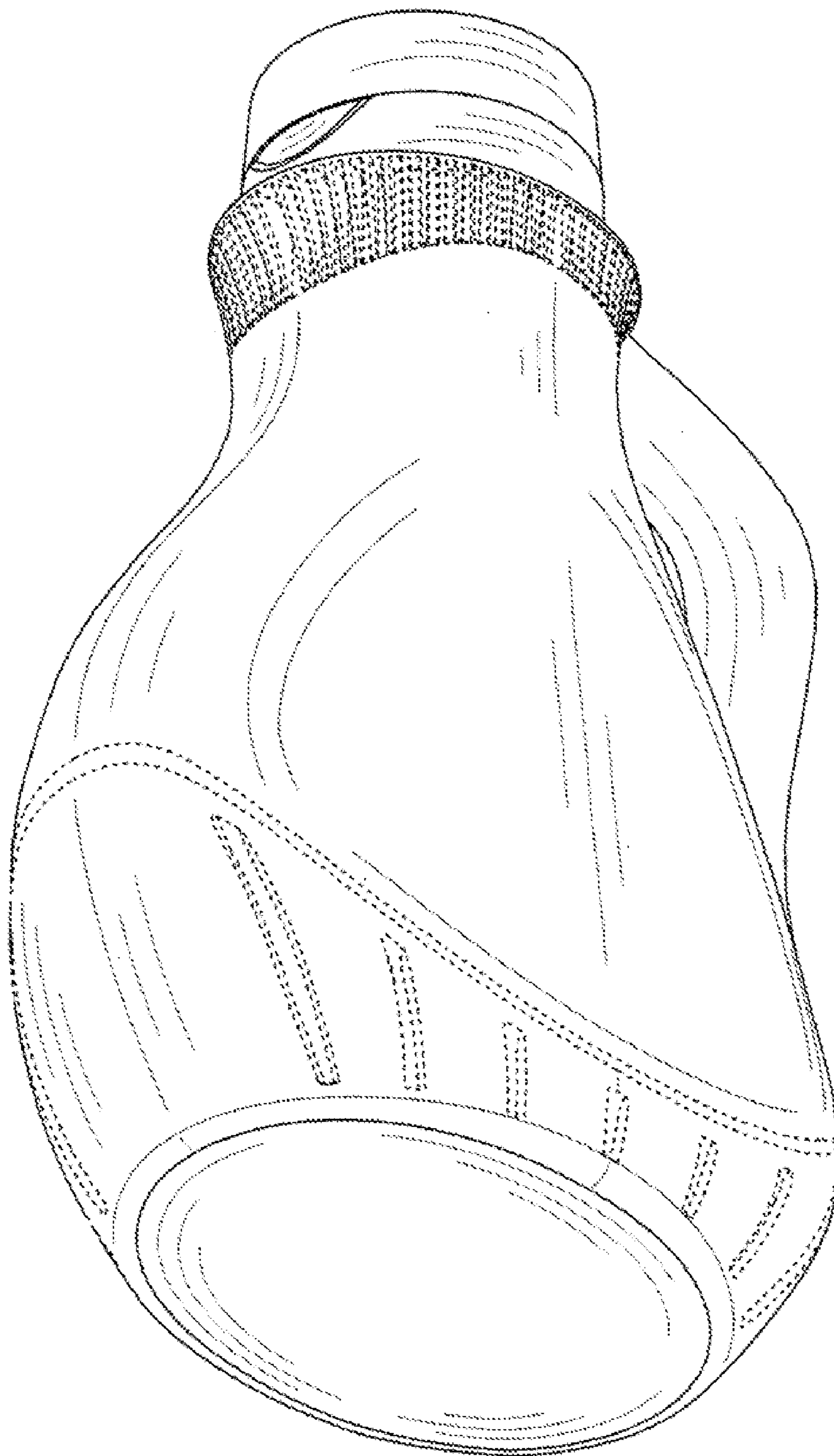

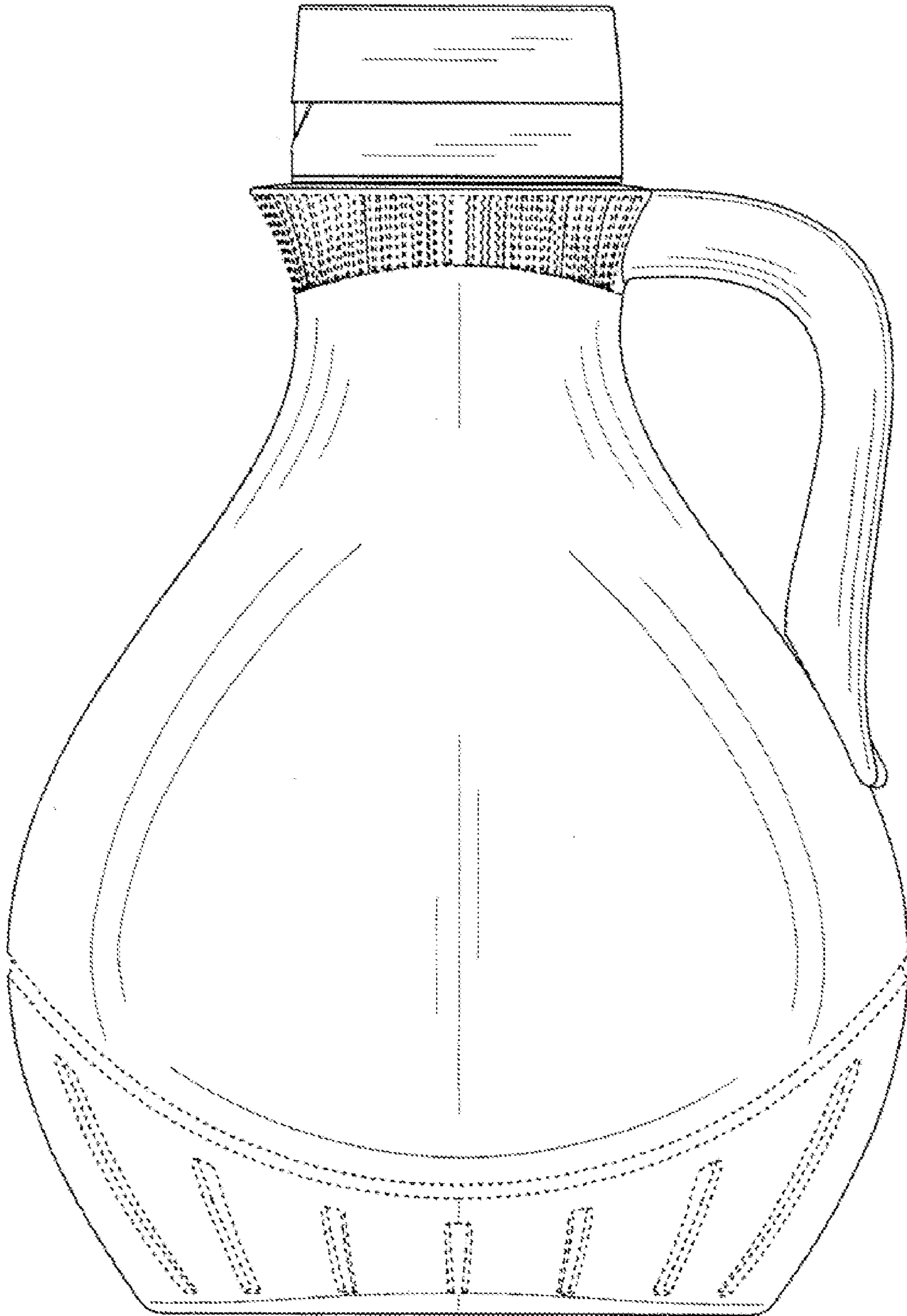

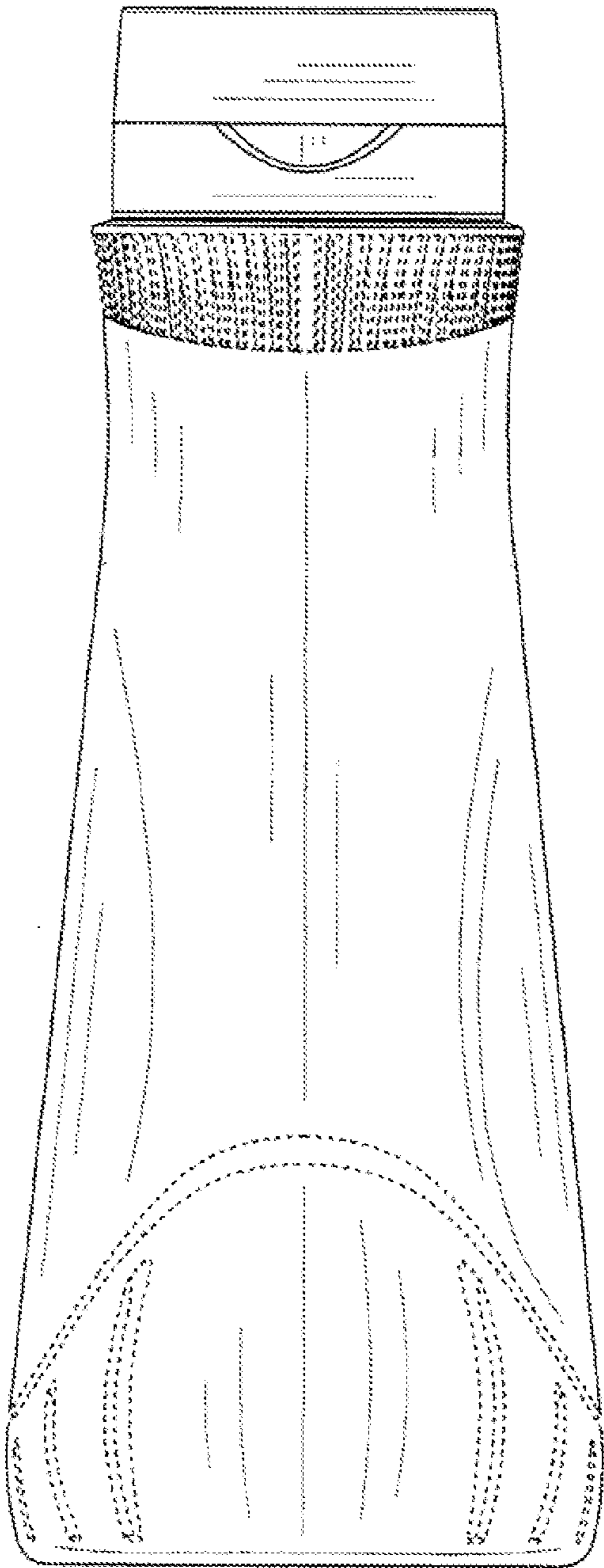

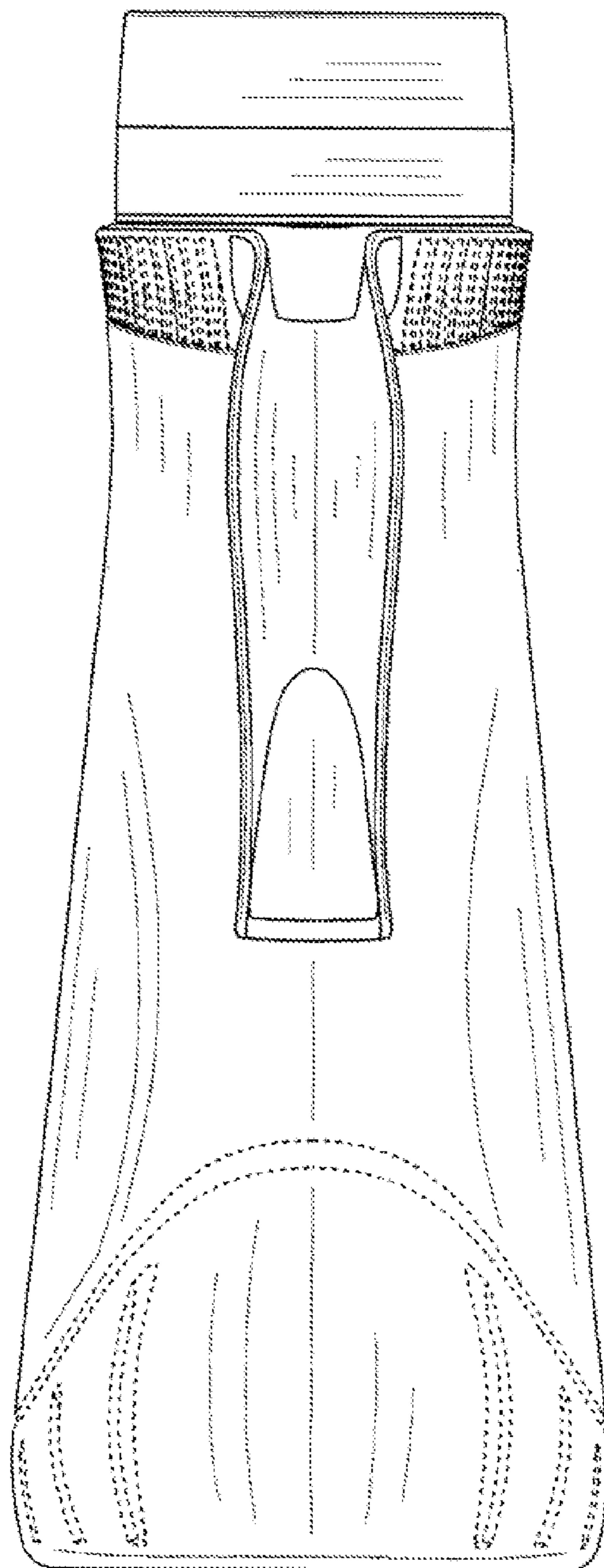

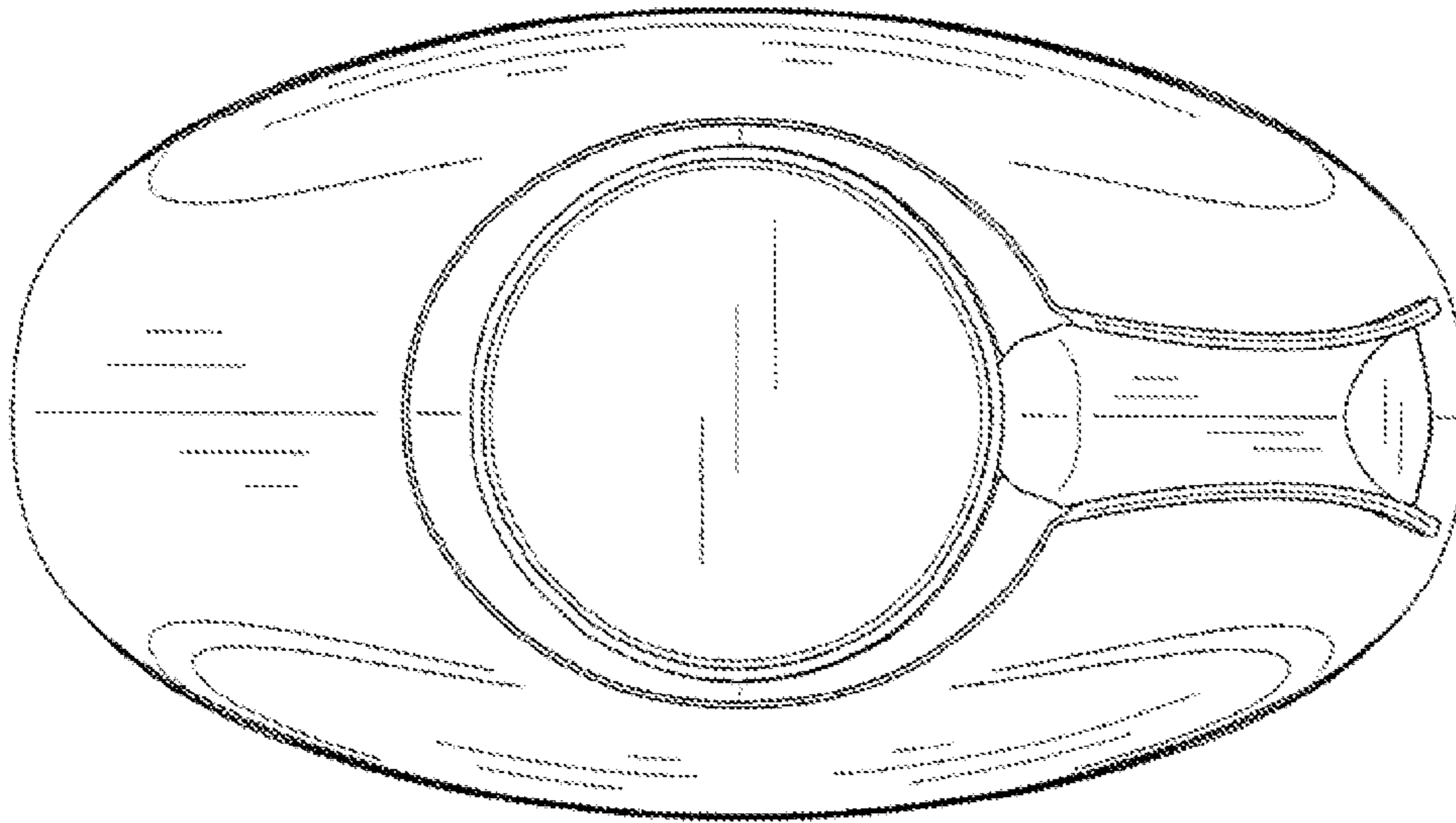

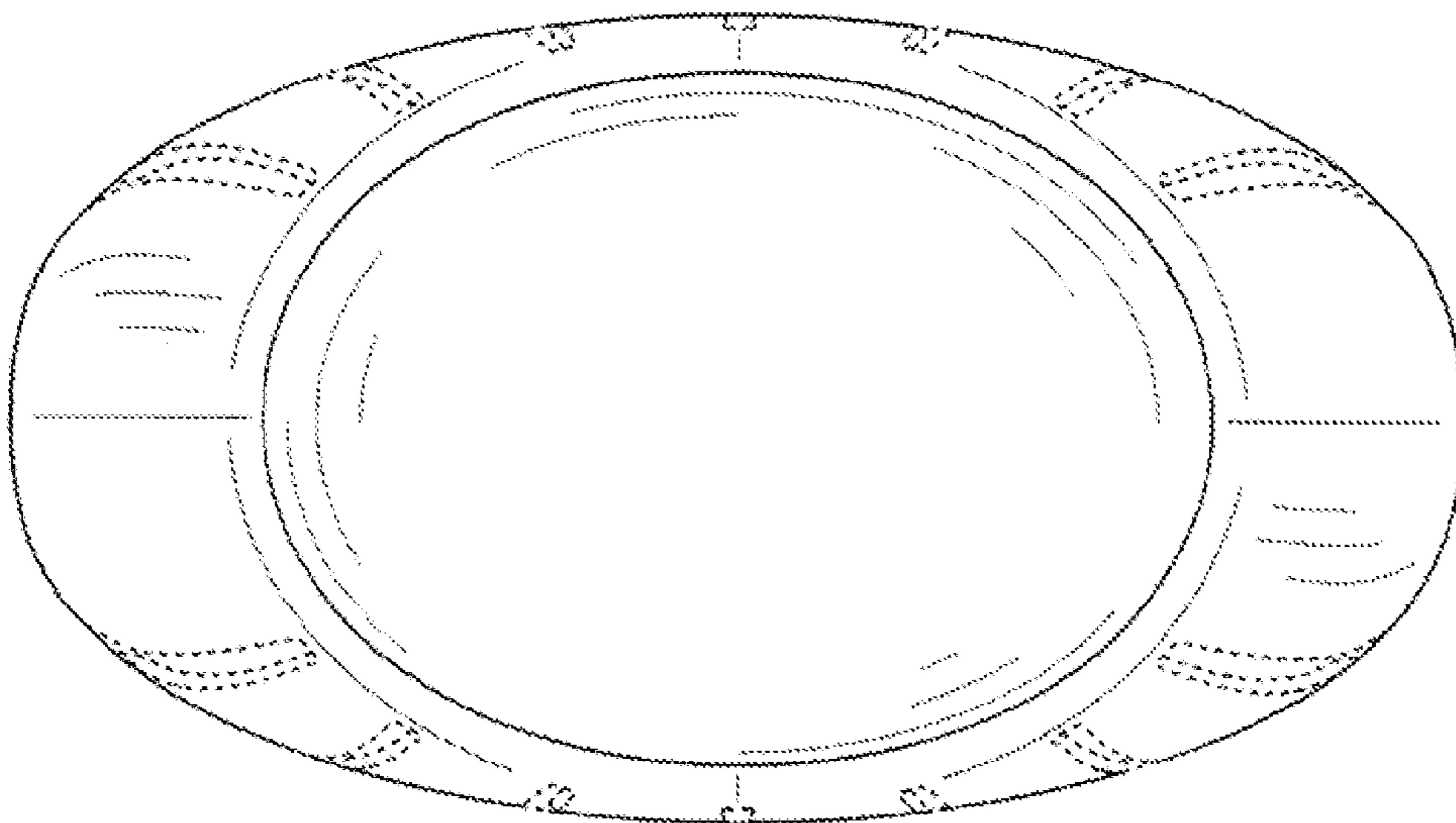
