DESCRIPTION

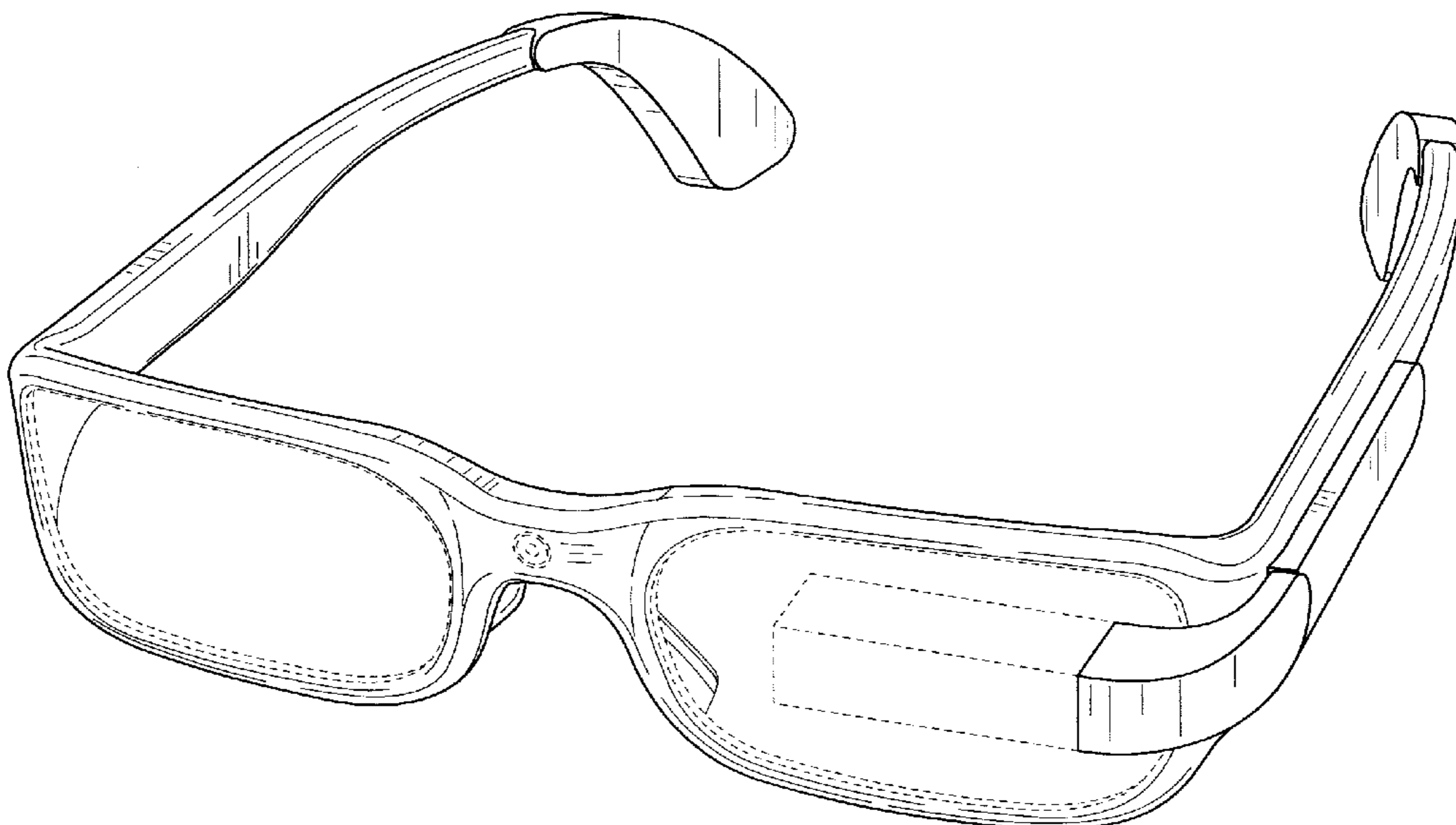
FIG. 1 is a front perspective view of a wearable display device according to a first embodiment of our design;

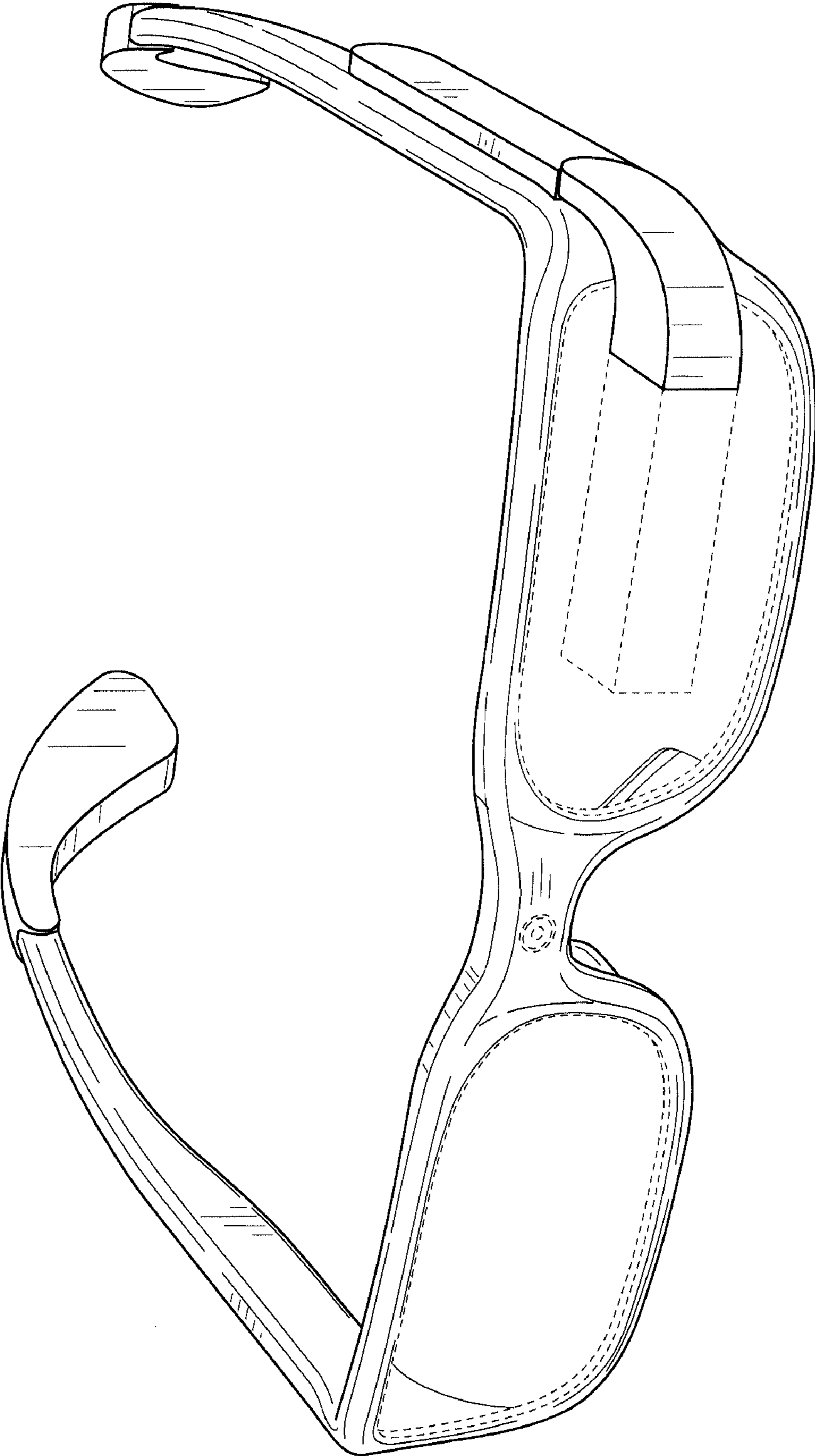

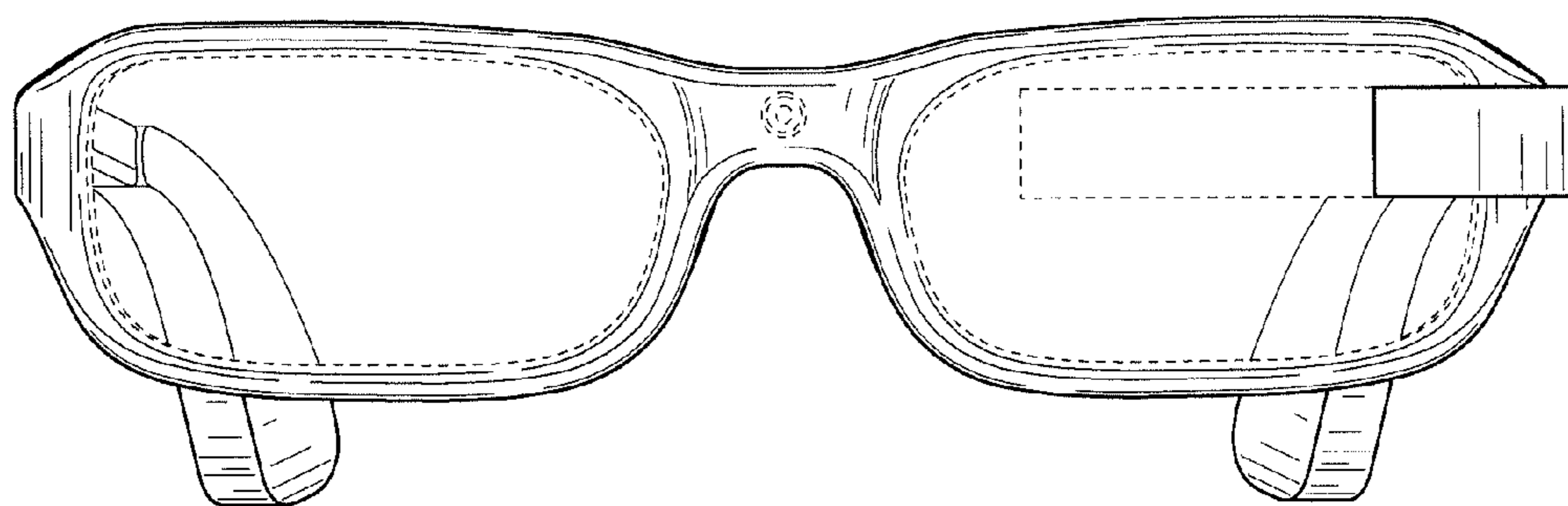

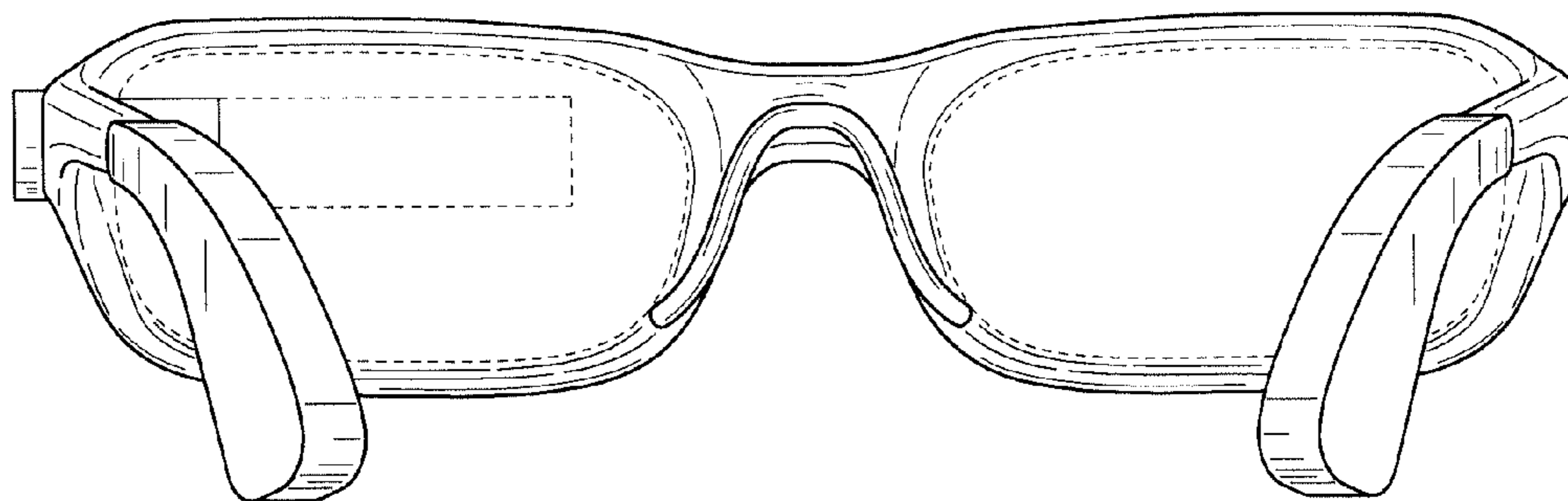

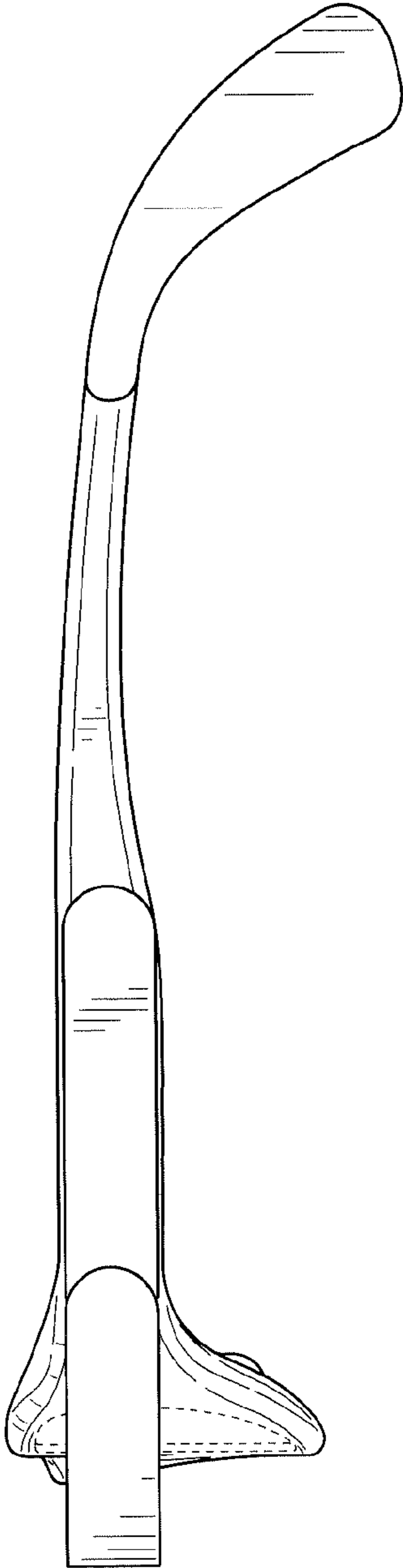

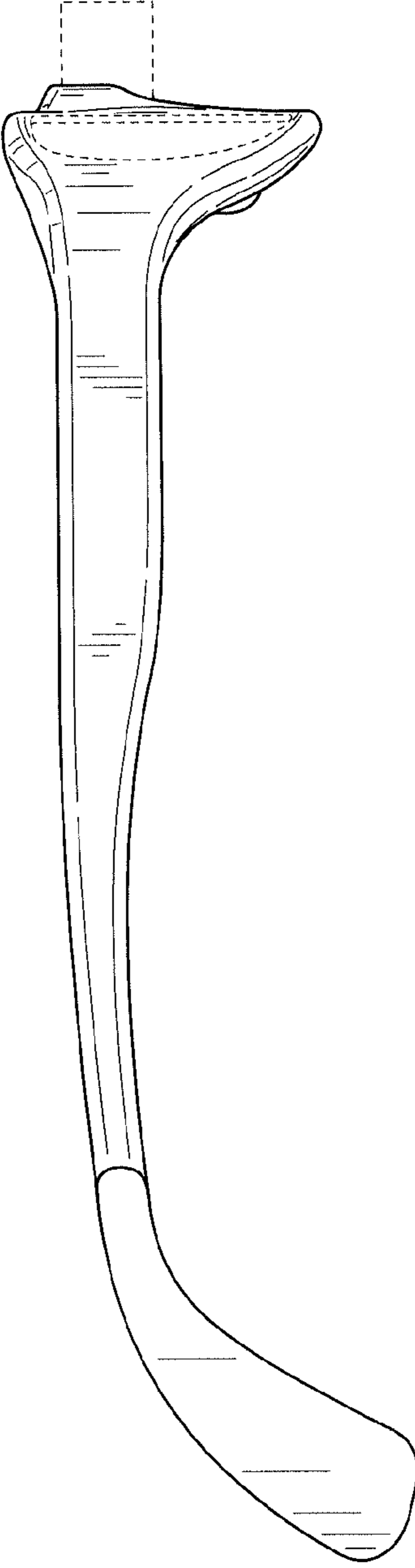

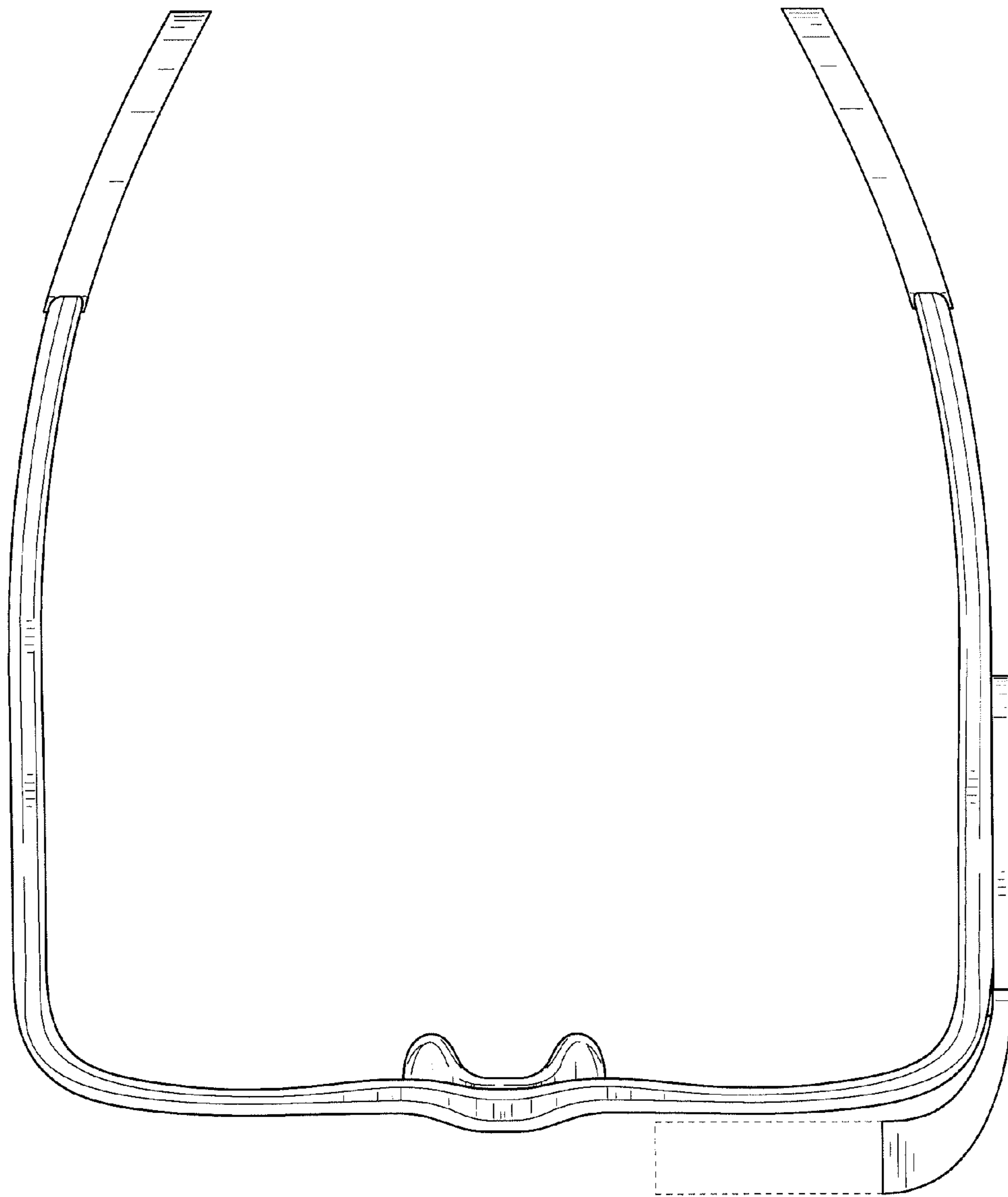

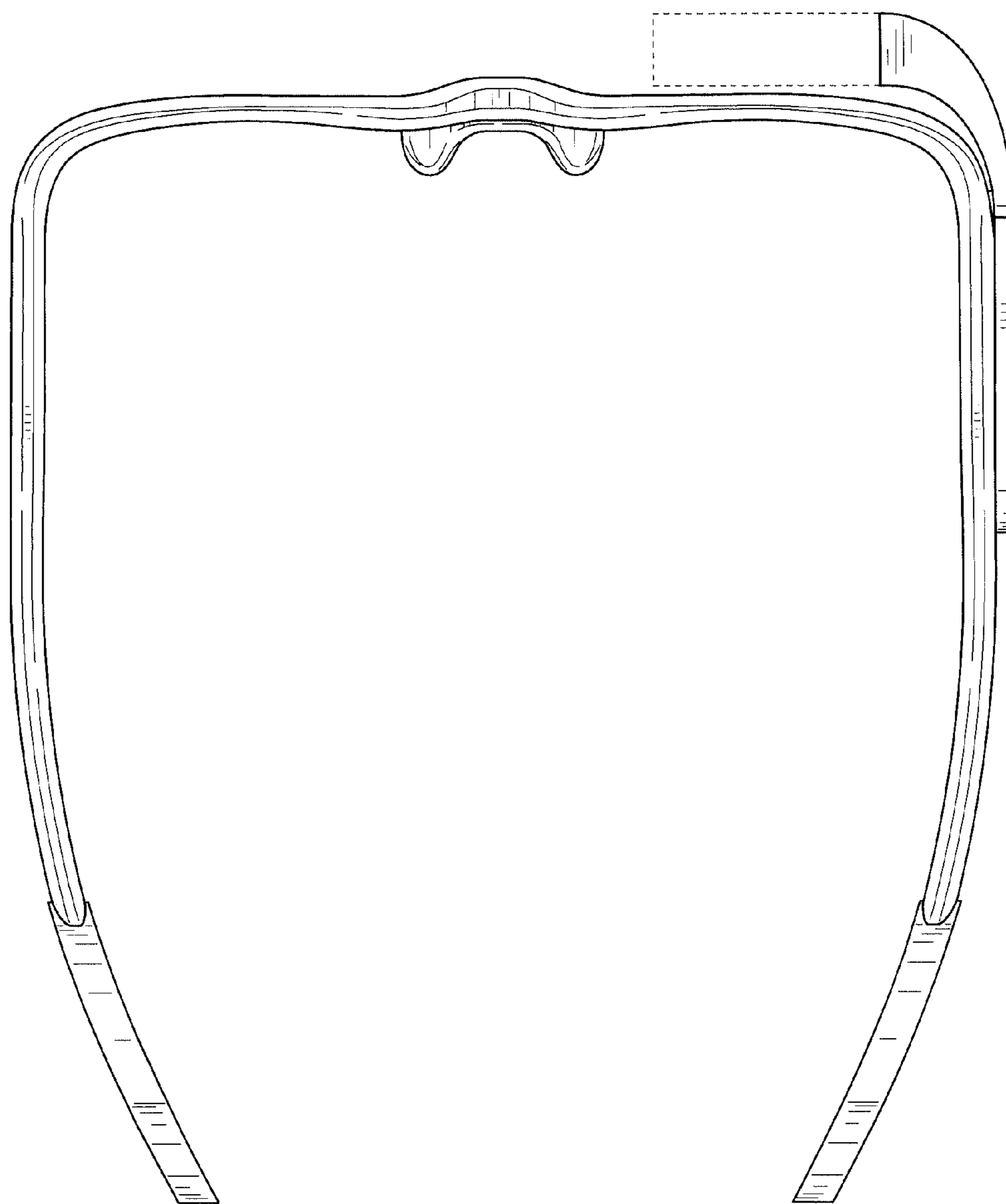
