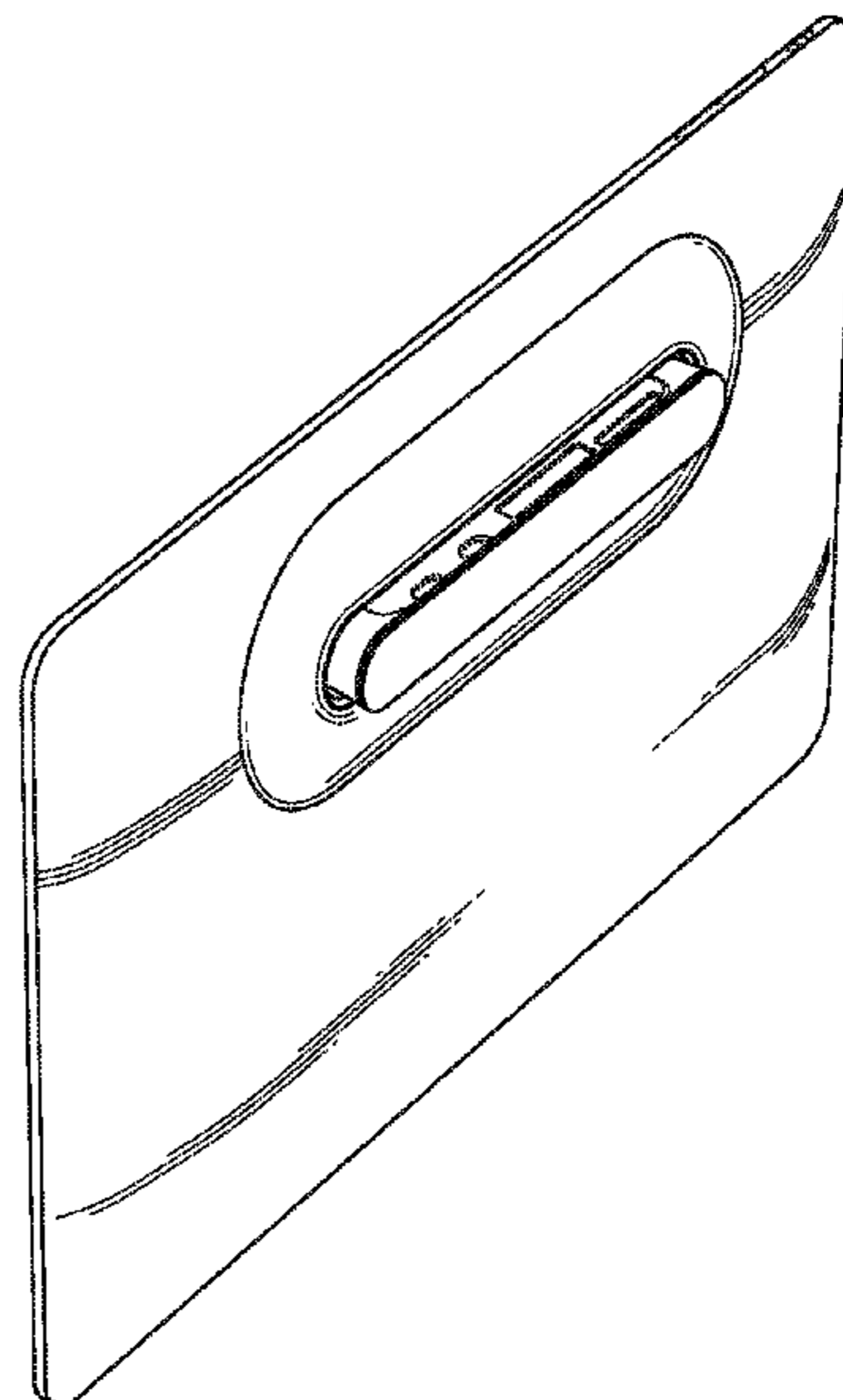
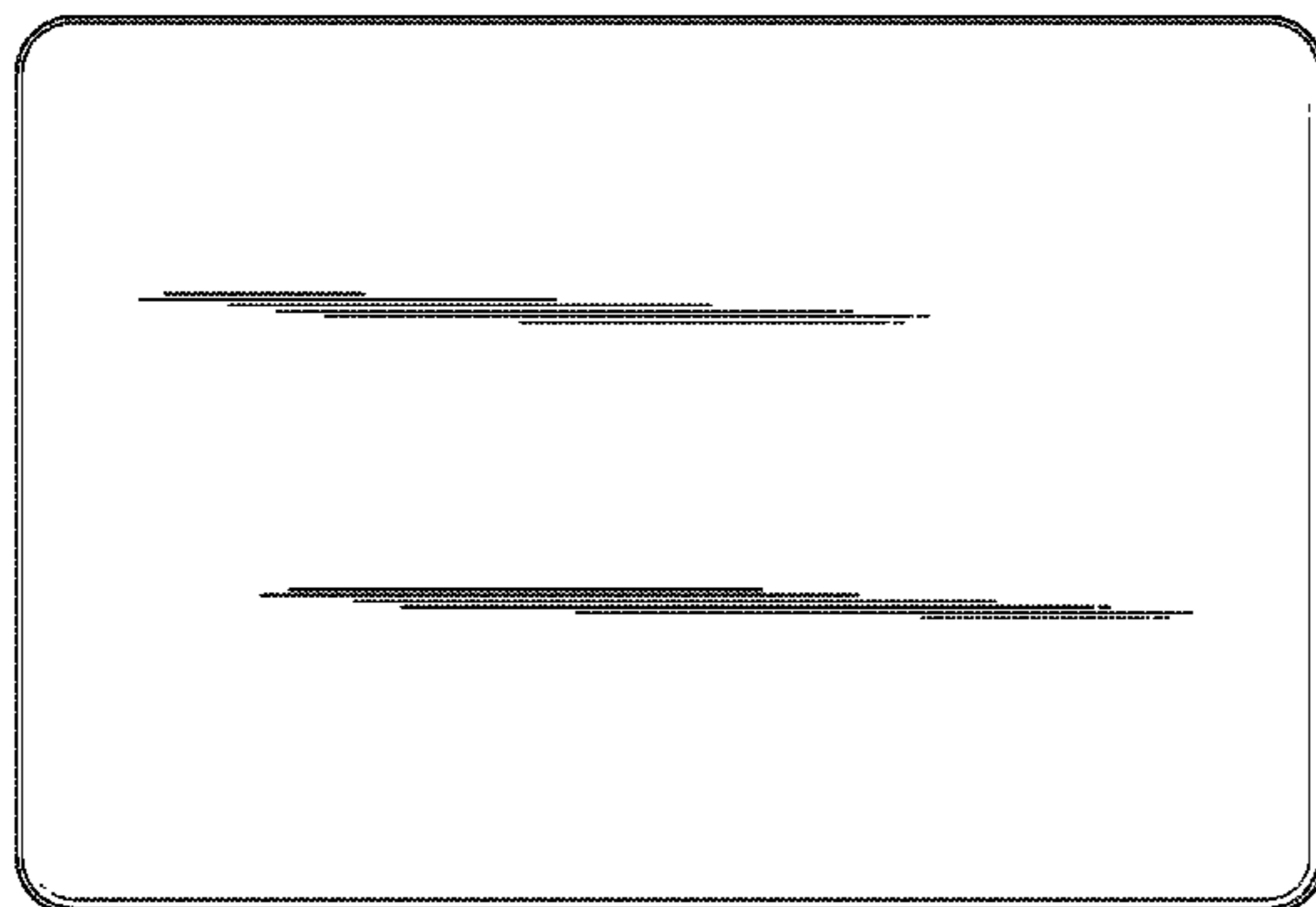
The ornamental design for the portable display device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable display device showing our new design;
FIG. 2 is a front view thereof;

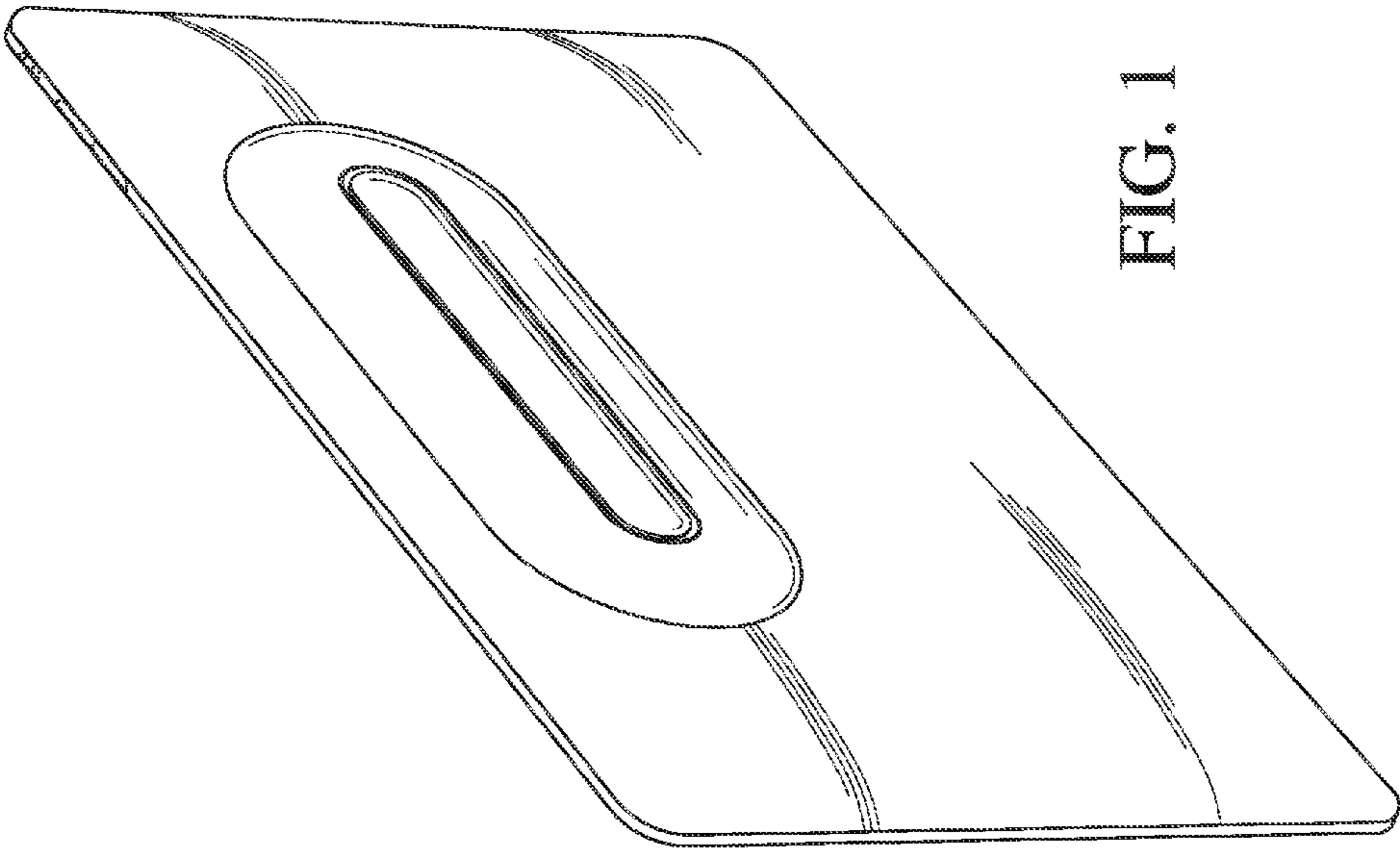

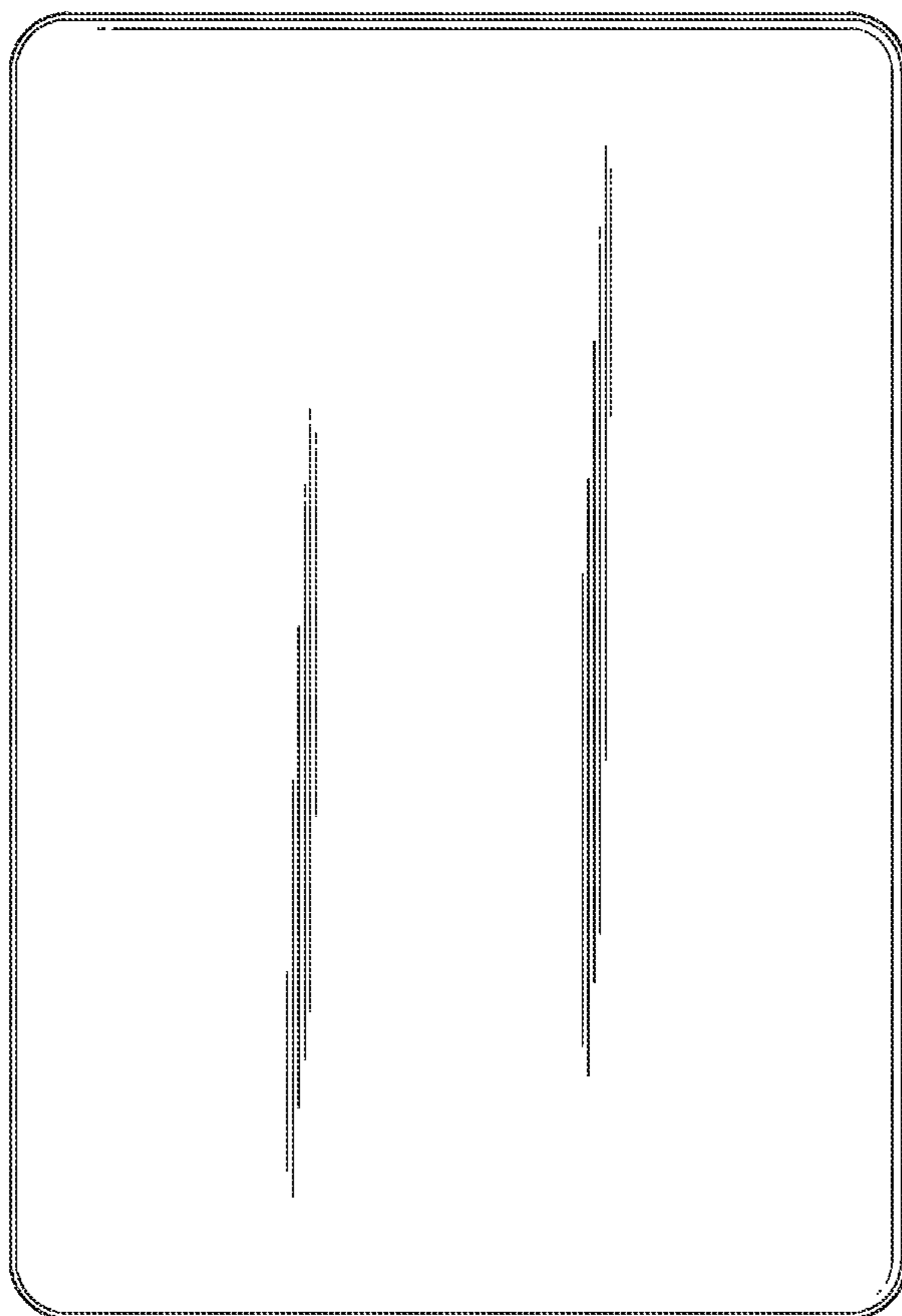

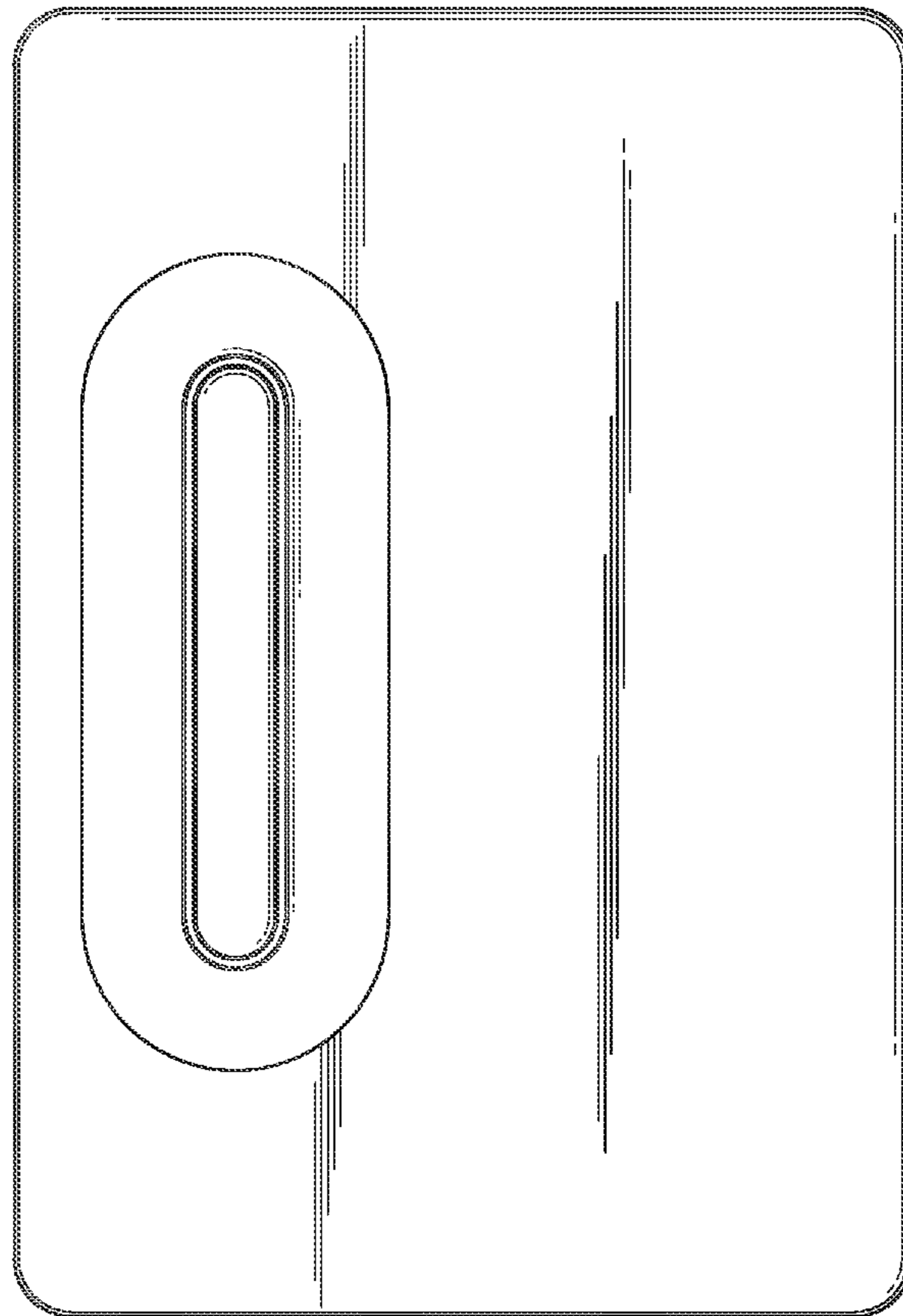

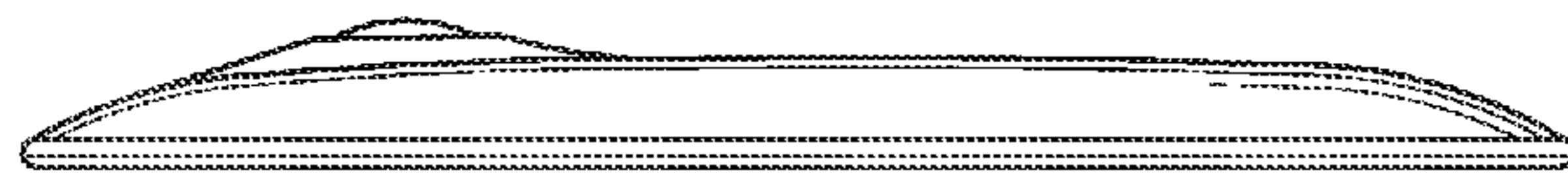

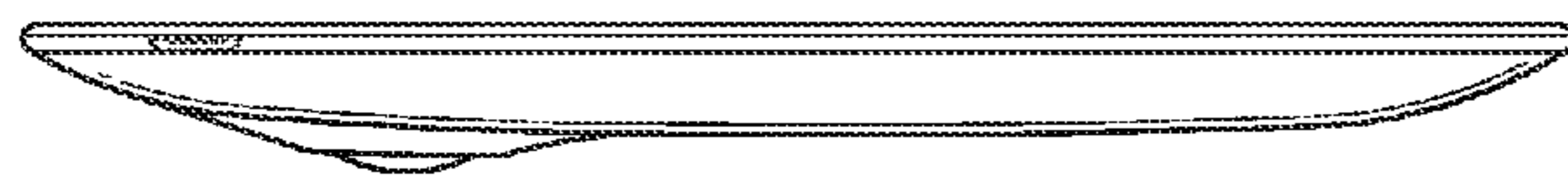

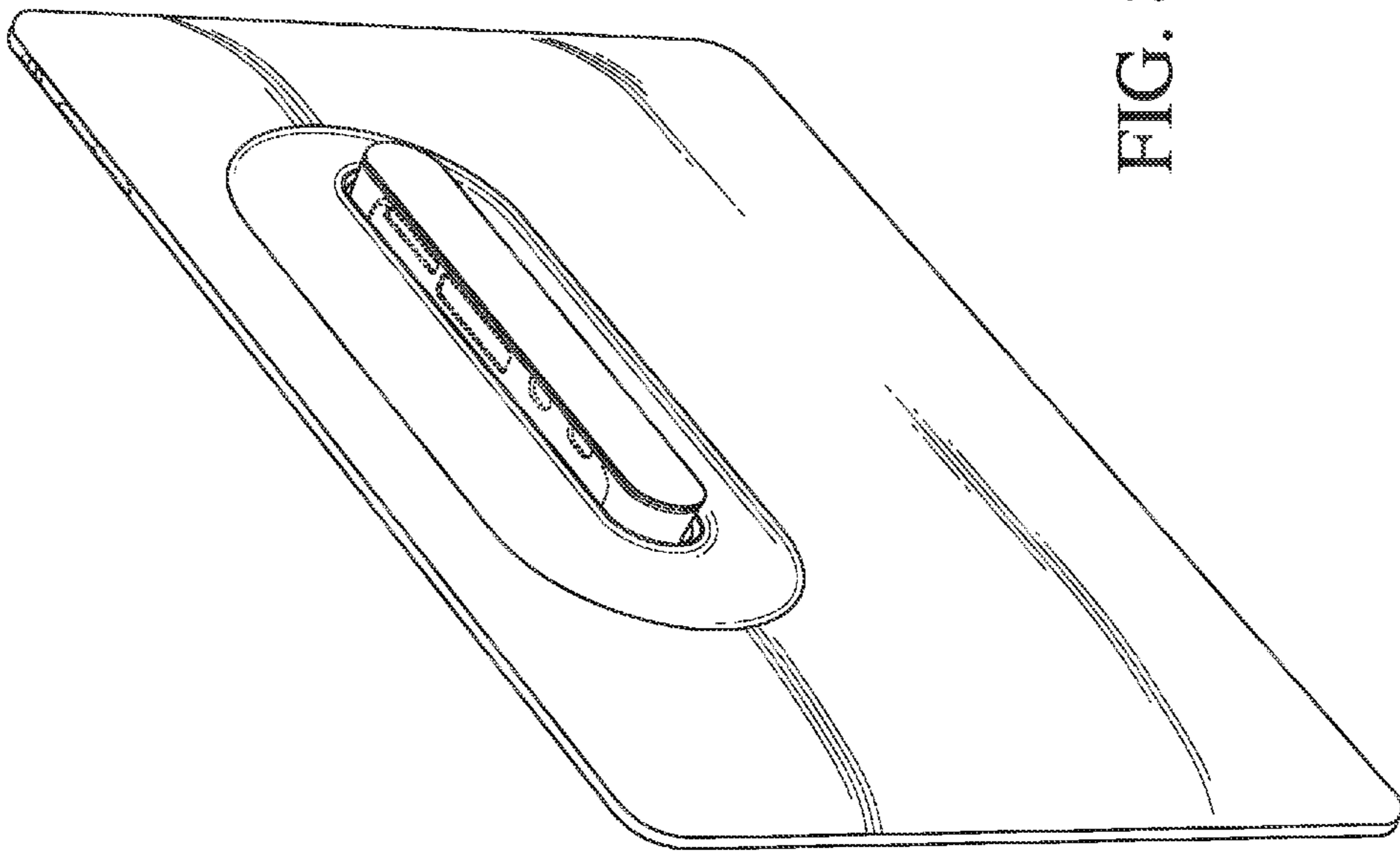

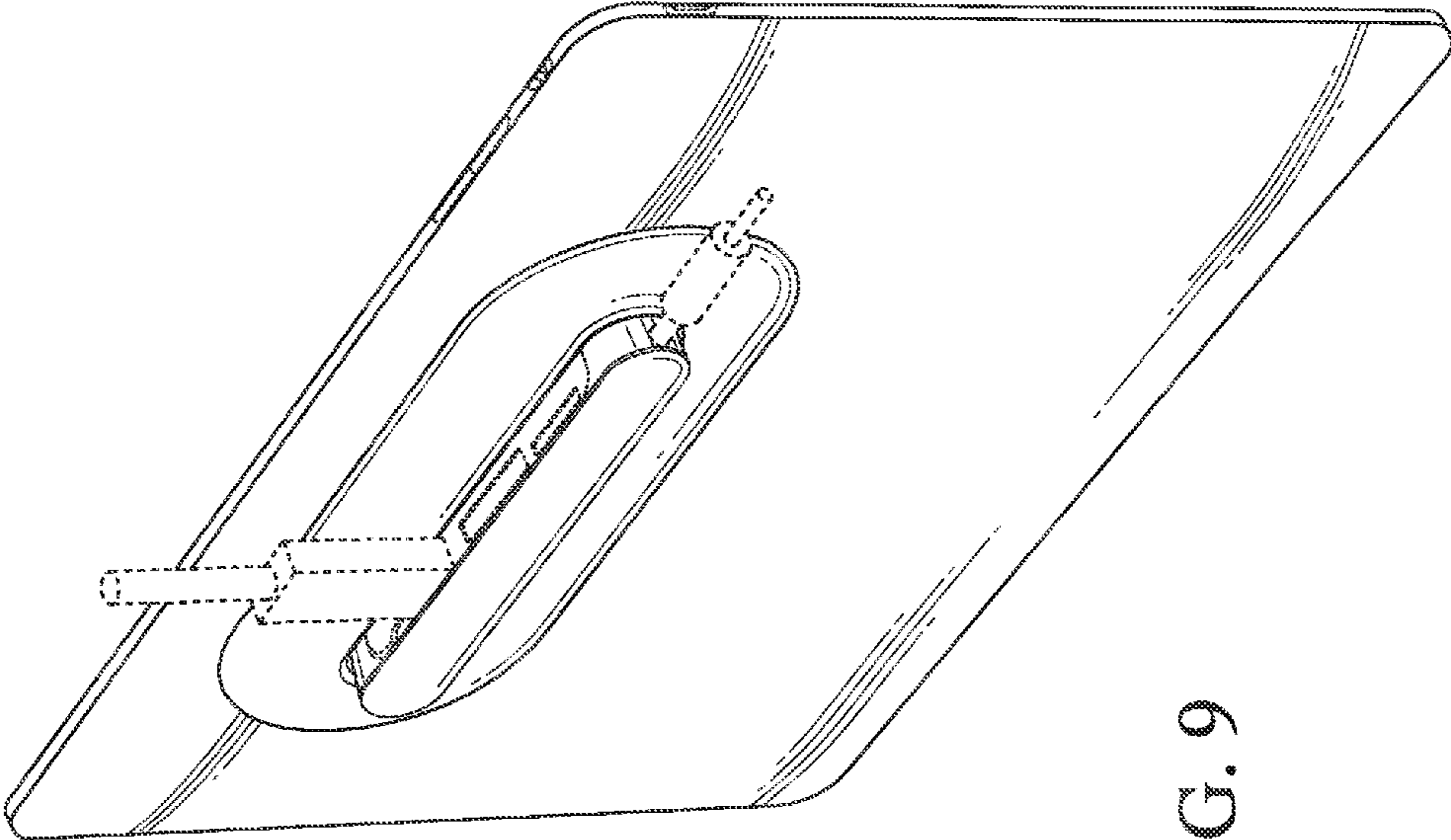
