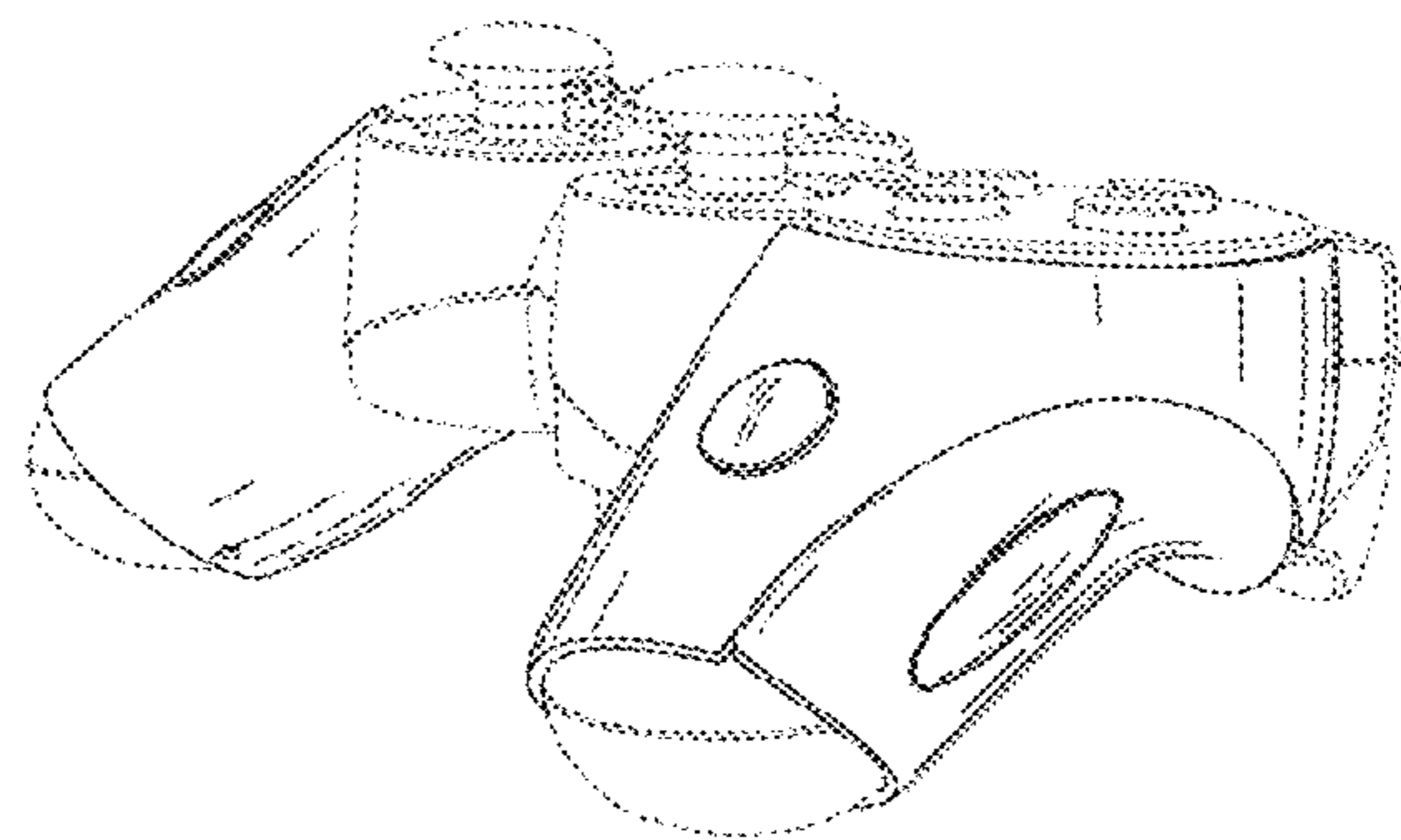
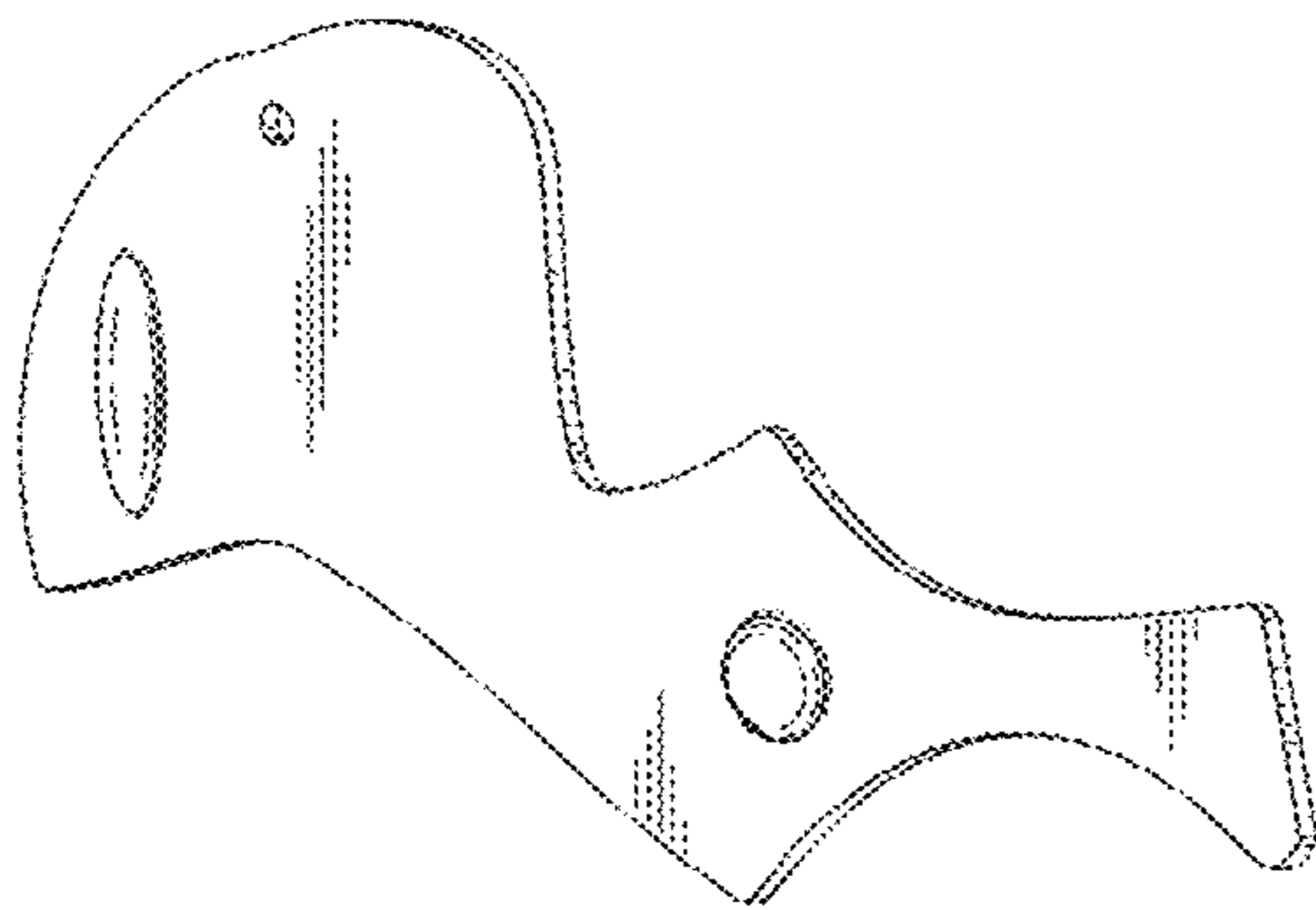
(57) **CLAIM**

The ornamental design for a game controller grip, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the game controller grip; FIG. 2 is a top view; FIG. 3 is a bottom view; FIG. 4 is a front view; FIG. 5 is a back view; FIG. 6 is a left side view; FIG. 7 is a right side view thereof; FIG. 8 is a perspective view of the game controller grip wrapped around a game controller; FIG. 9 is a side view of the game controller grip wrapped around a game controller; and, FIG. 10 is a bottom view of the game controller grip wrapped around a game controller. FIGS. 8-10 disclose the environmental use of the game controller grip shown in FIGS. 1-7. The broken lines showing the game controller are for the purpose of illustrating environmental structure and form no part of the claimed design.

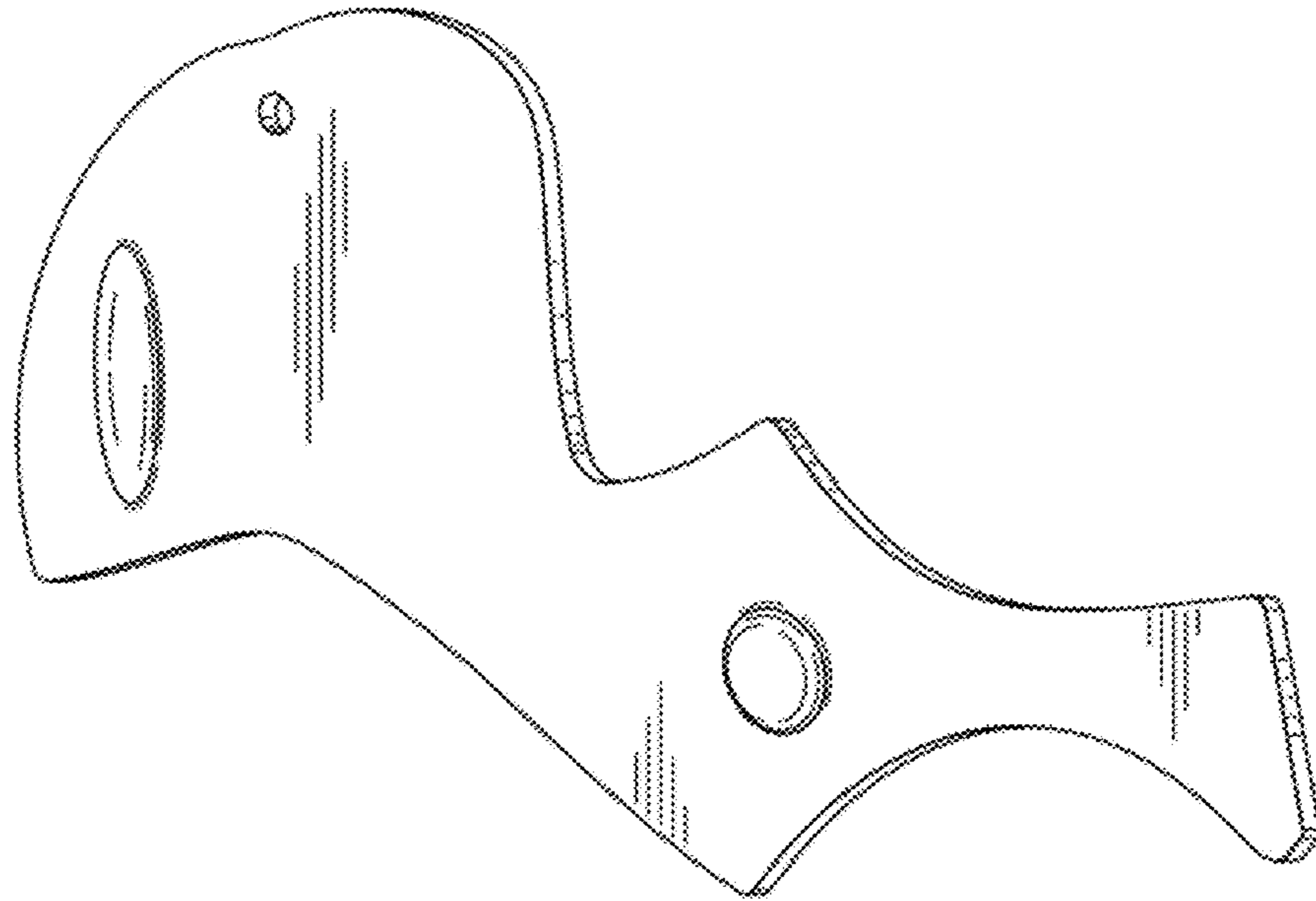

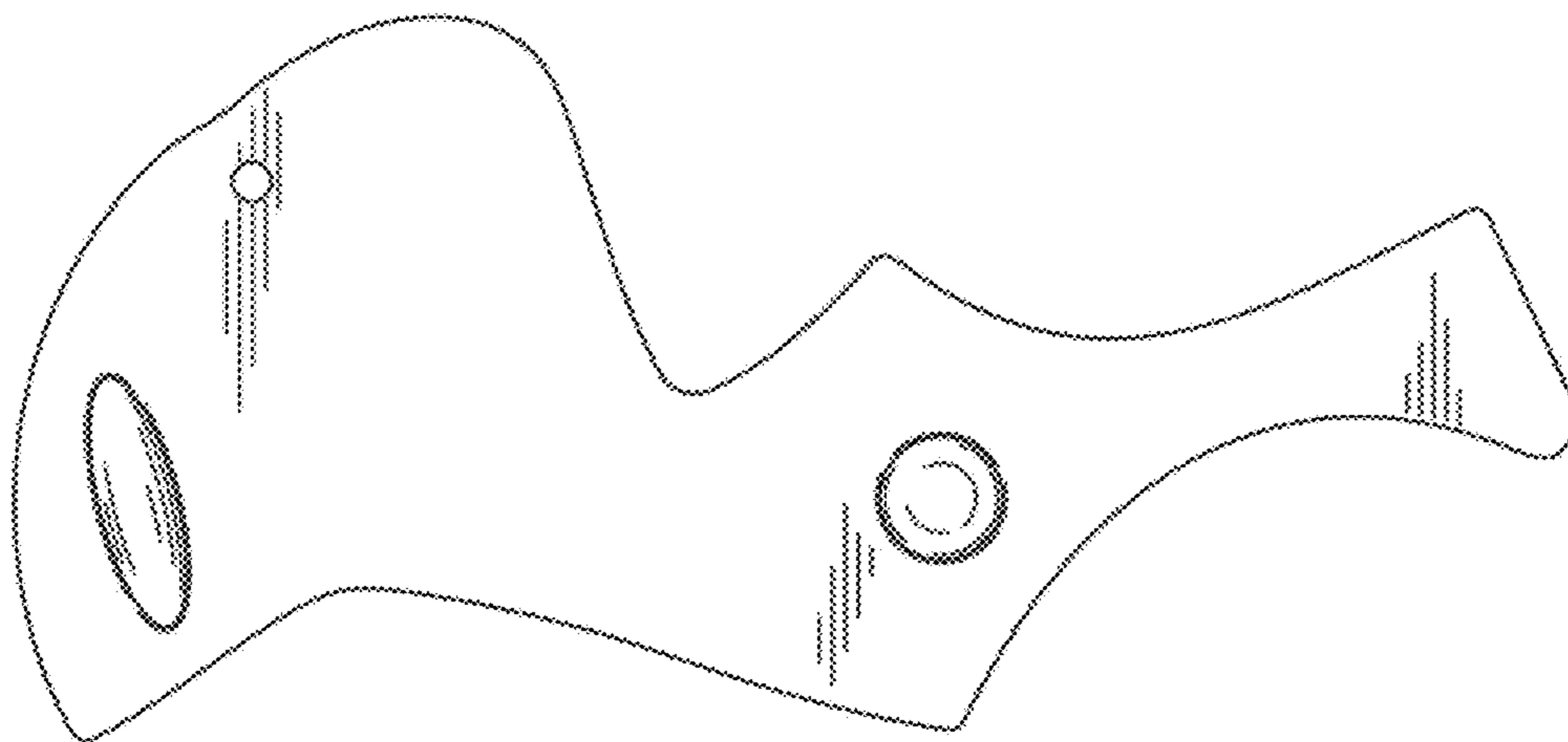

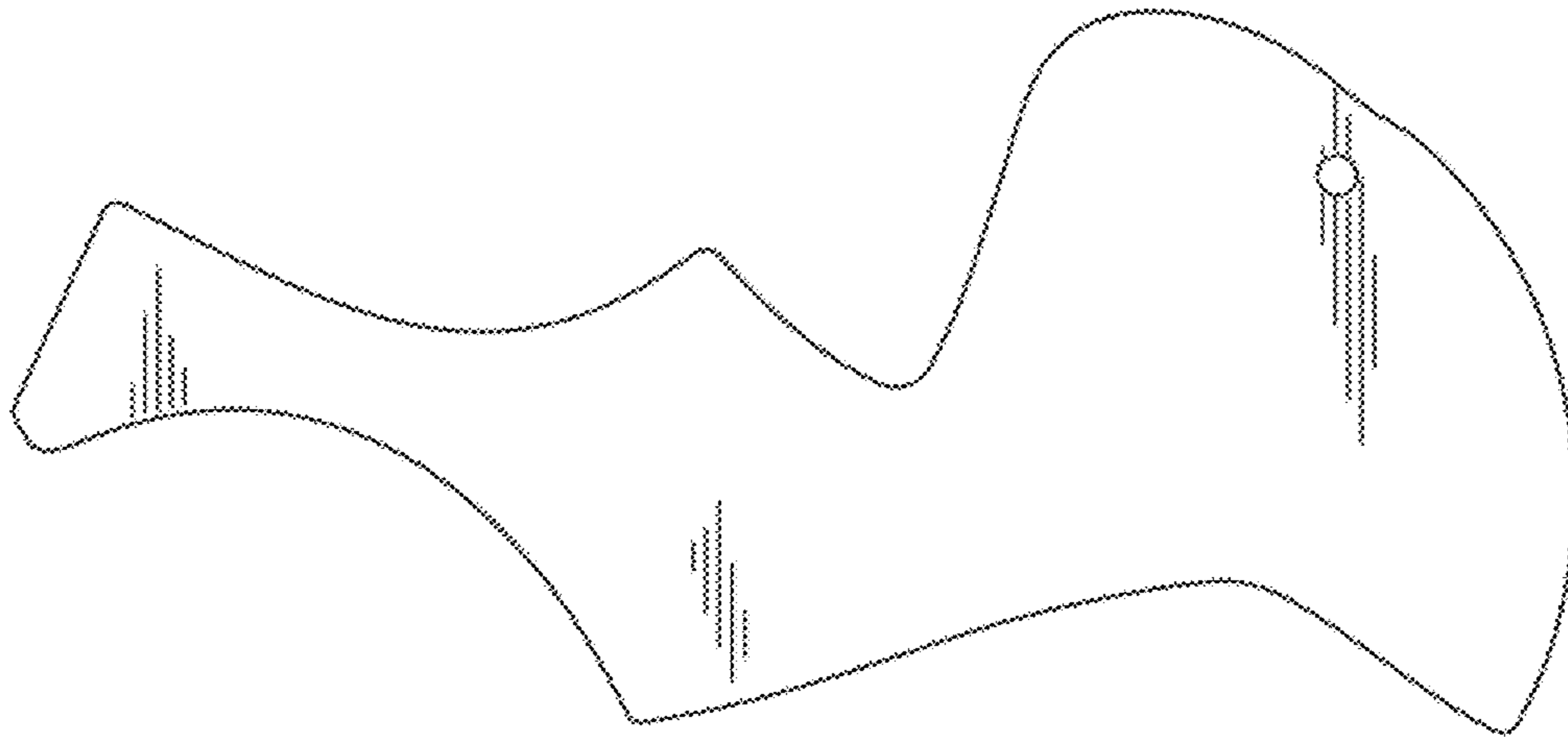

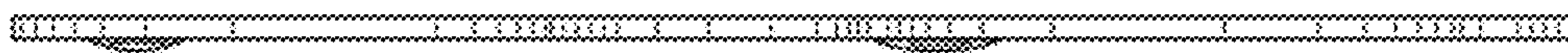

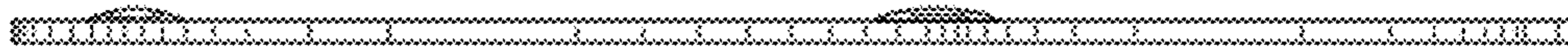

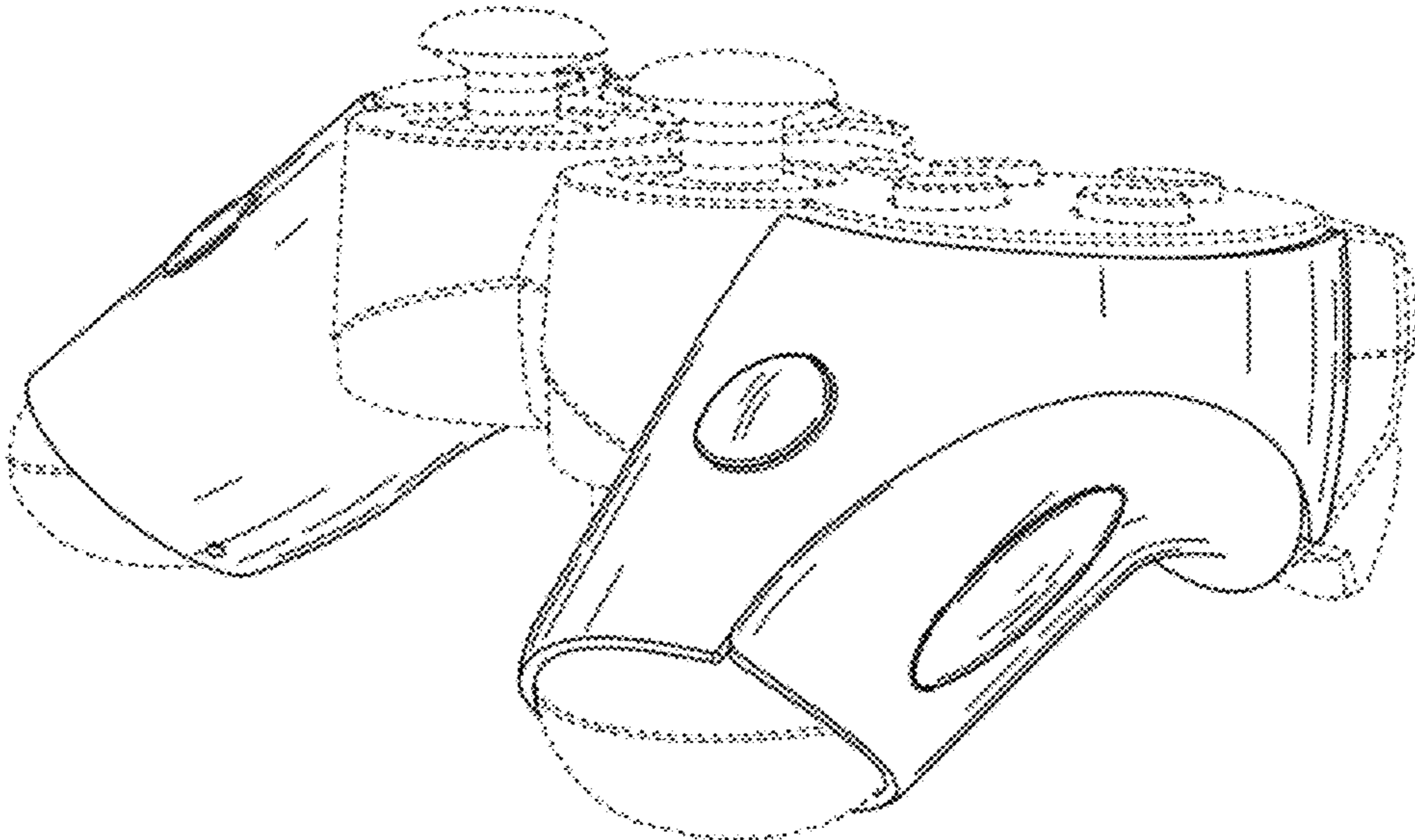

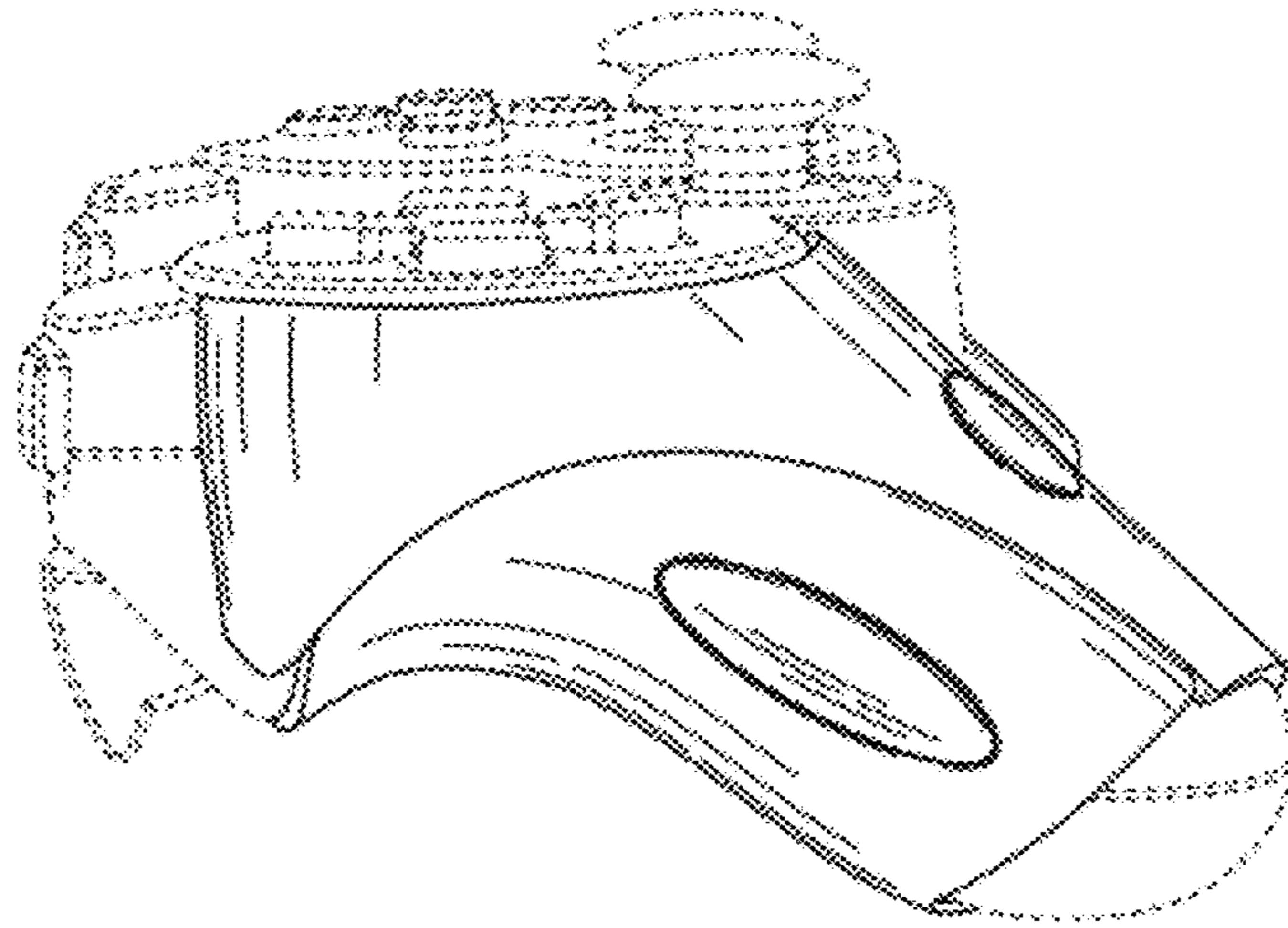

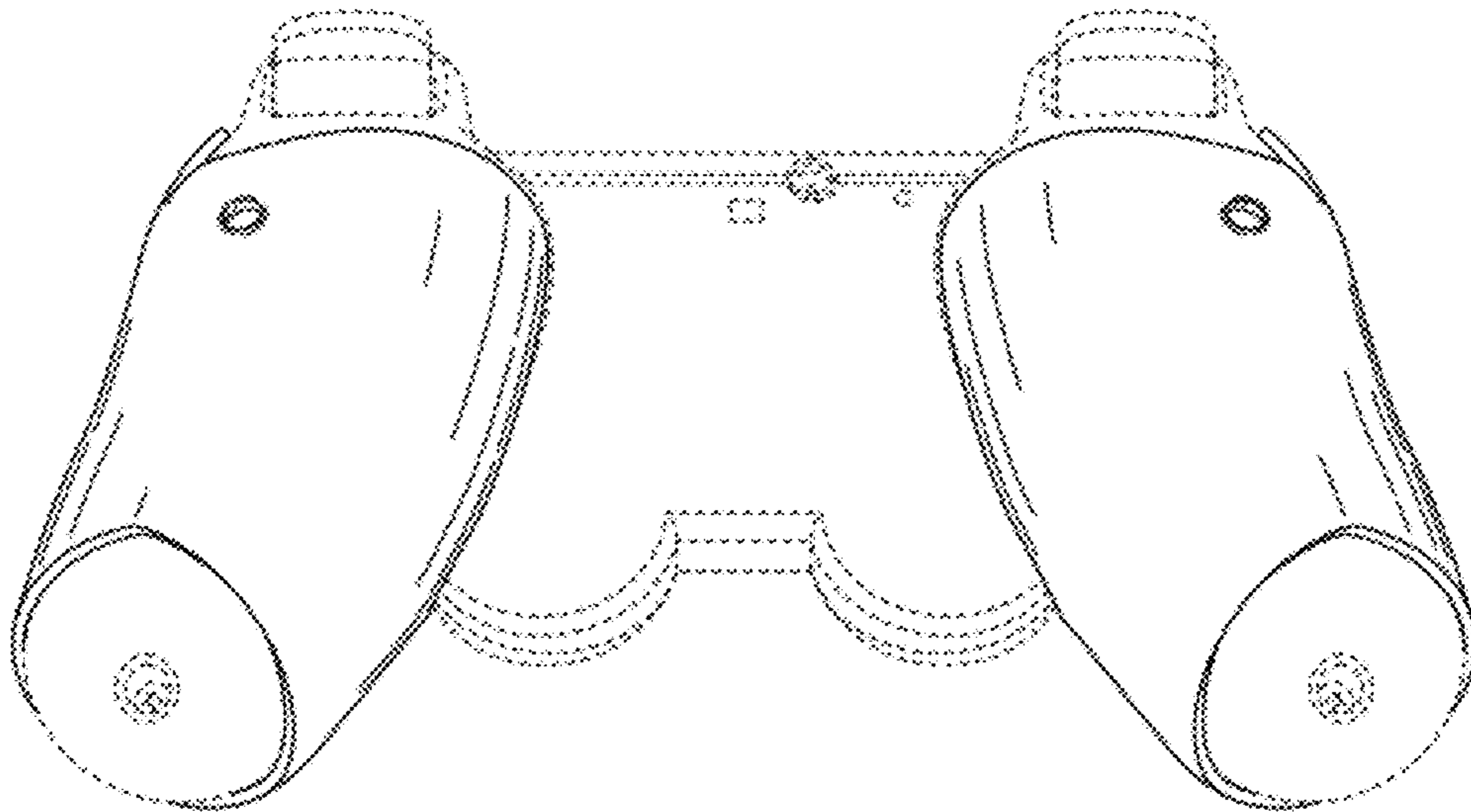
