DESCRIPTION

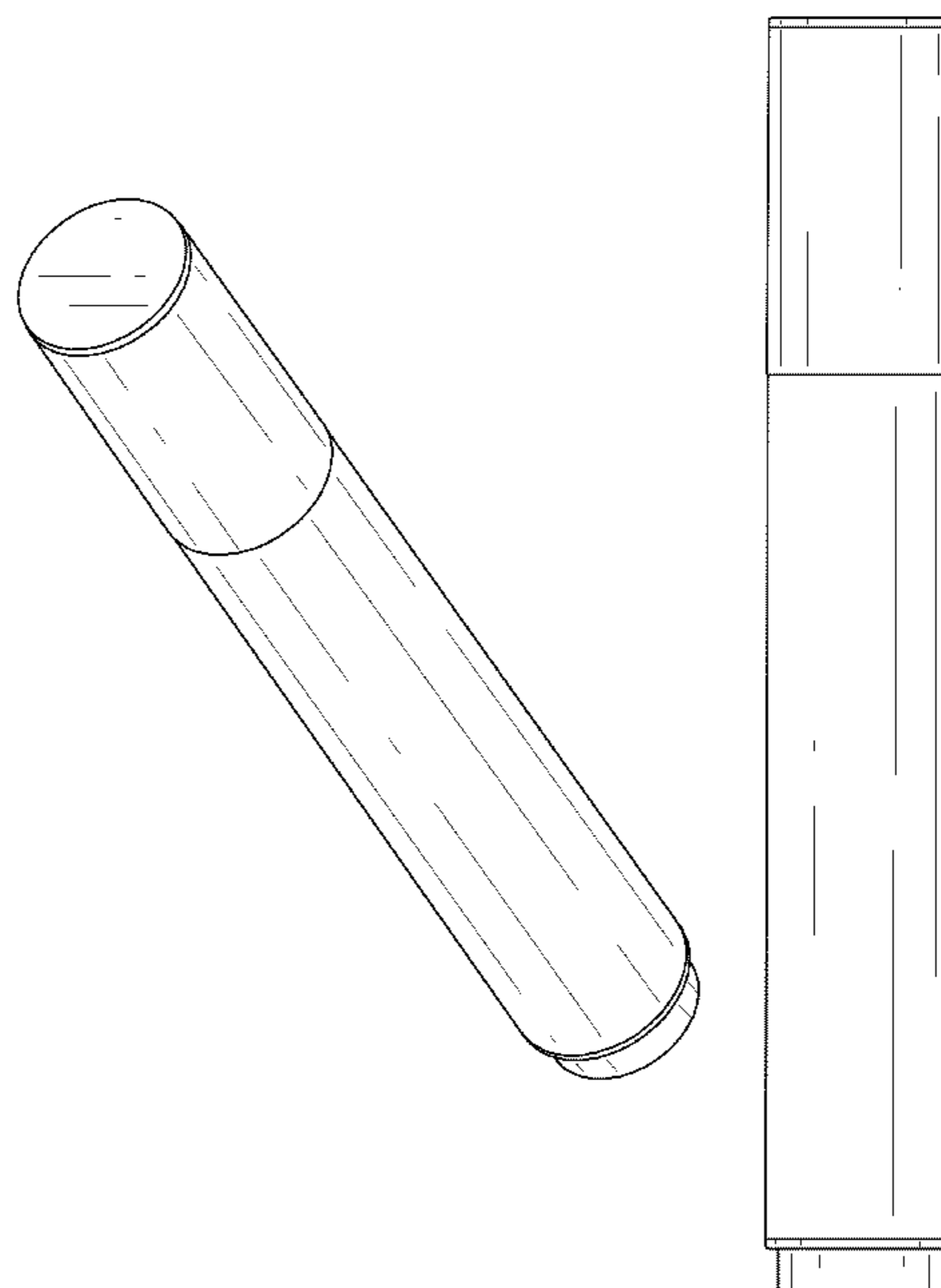
FIG. 1 is an upper front right perspective view of a marker showing my new design;

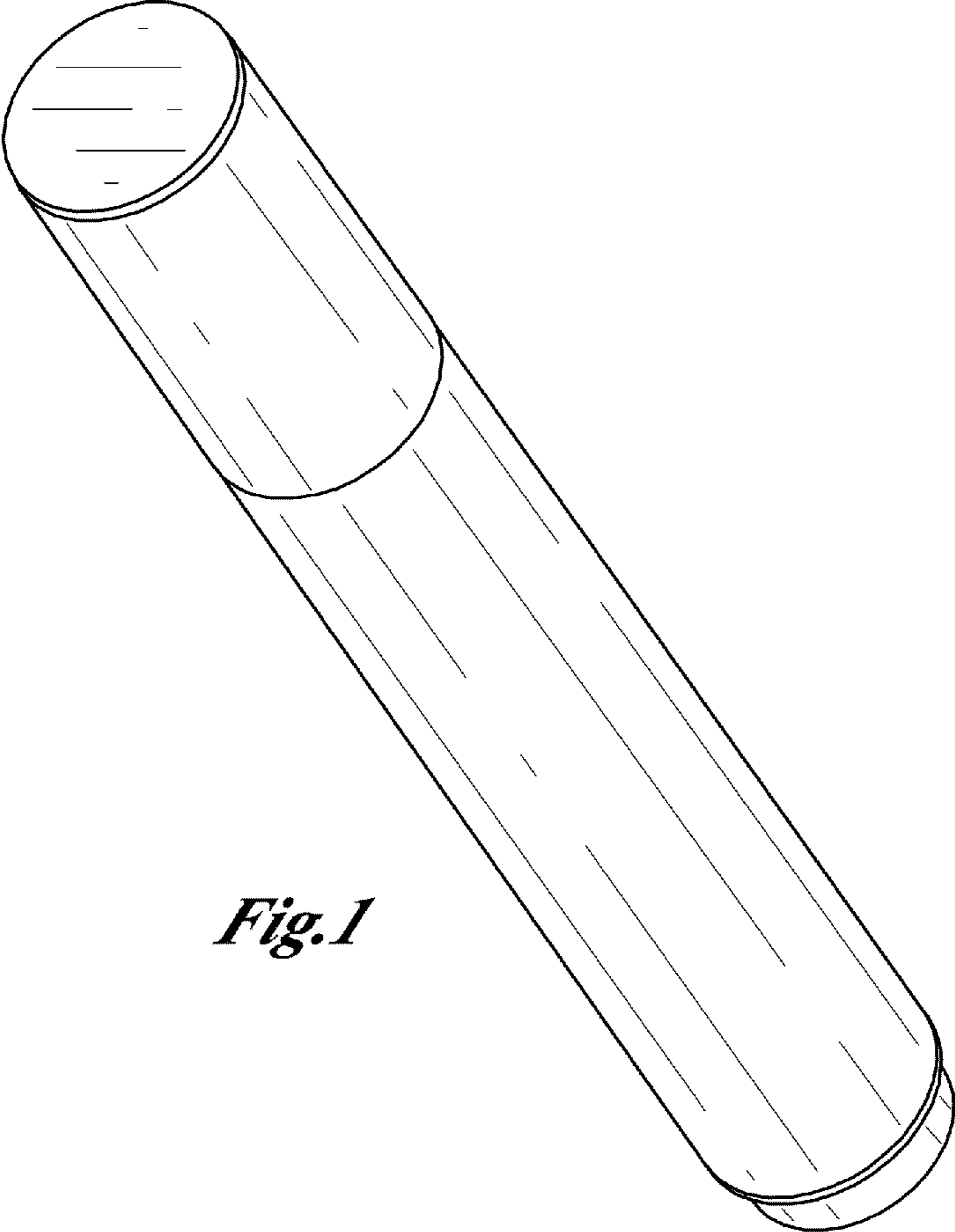

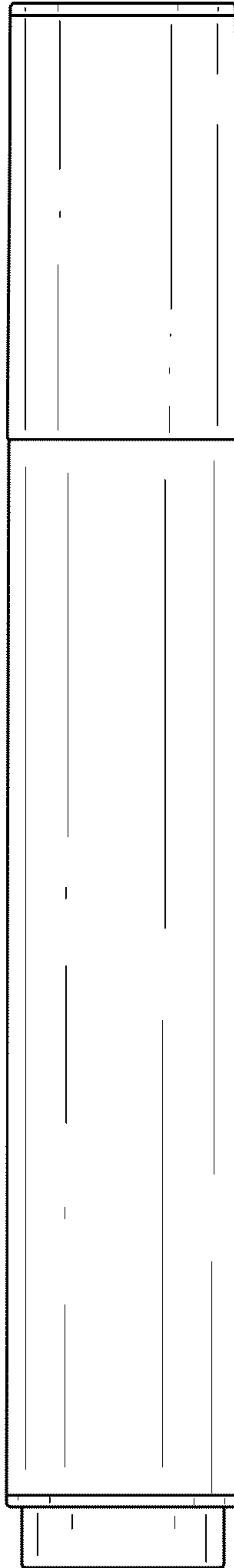

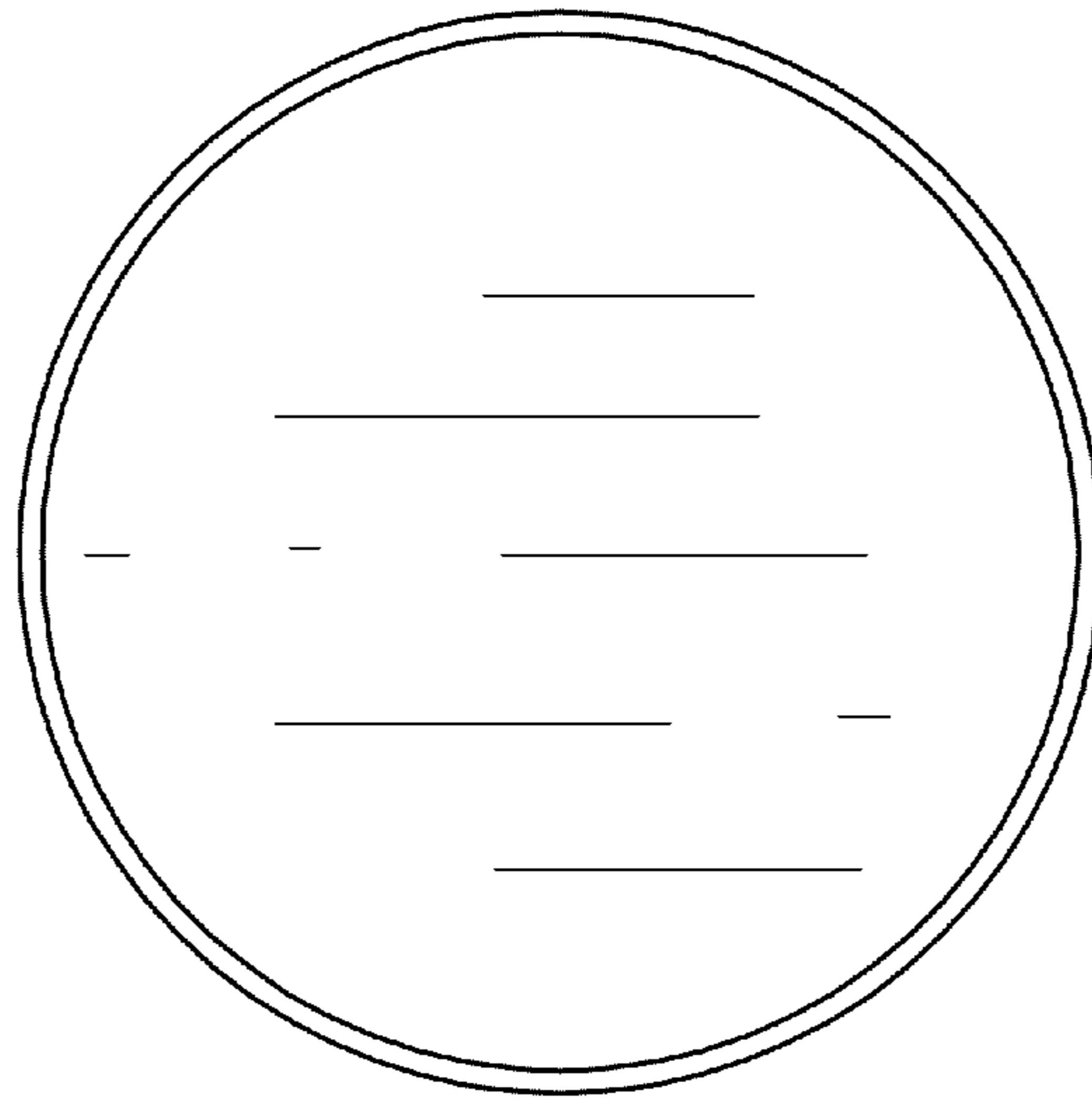

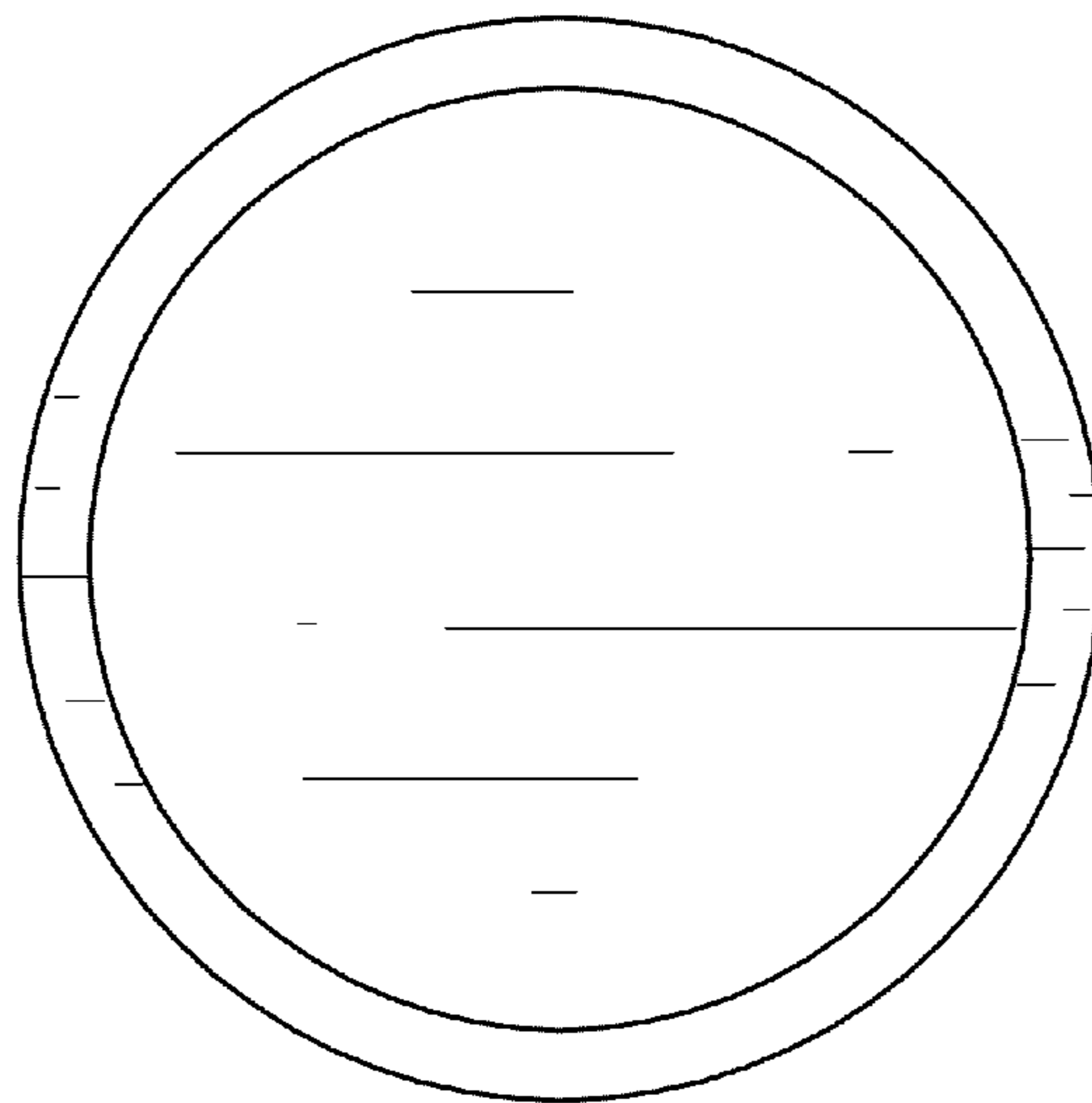
