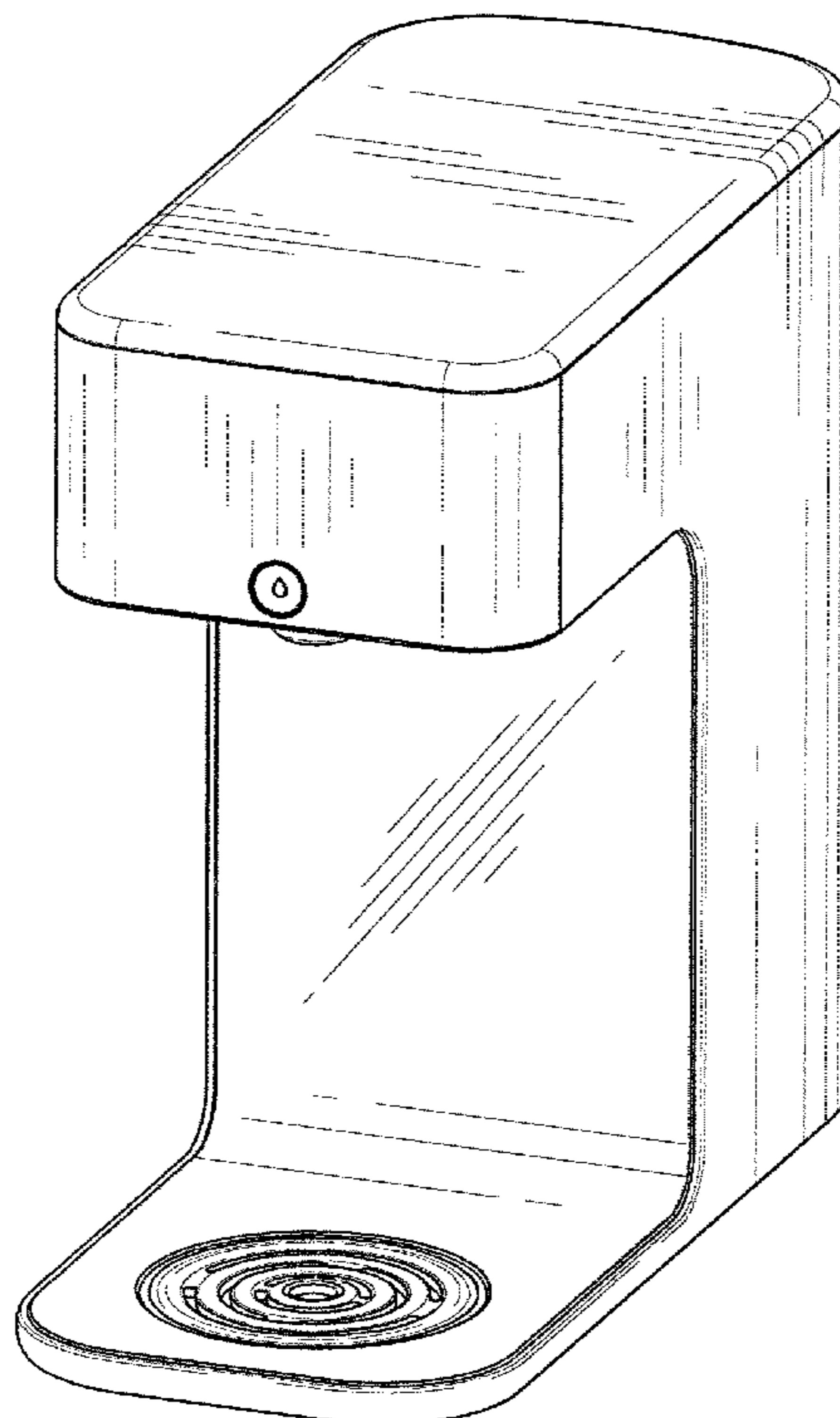
(57) **CLAIM**

The ornamental design for a water purifier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a water purifier showing my new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof, the right side view thereof being a mirror image;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a bottom view thereof.
 The broken line showing of the water purifier in FIG. 3 and FIG. 4 is for the purpose of illustration and forms no part of the claimed design.

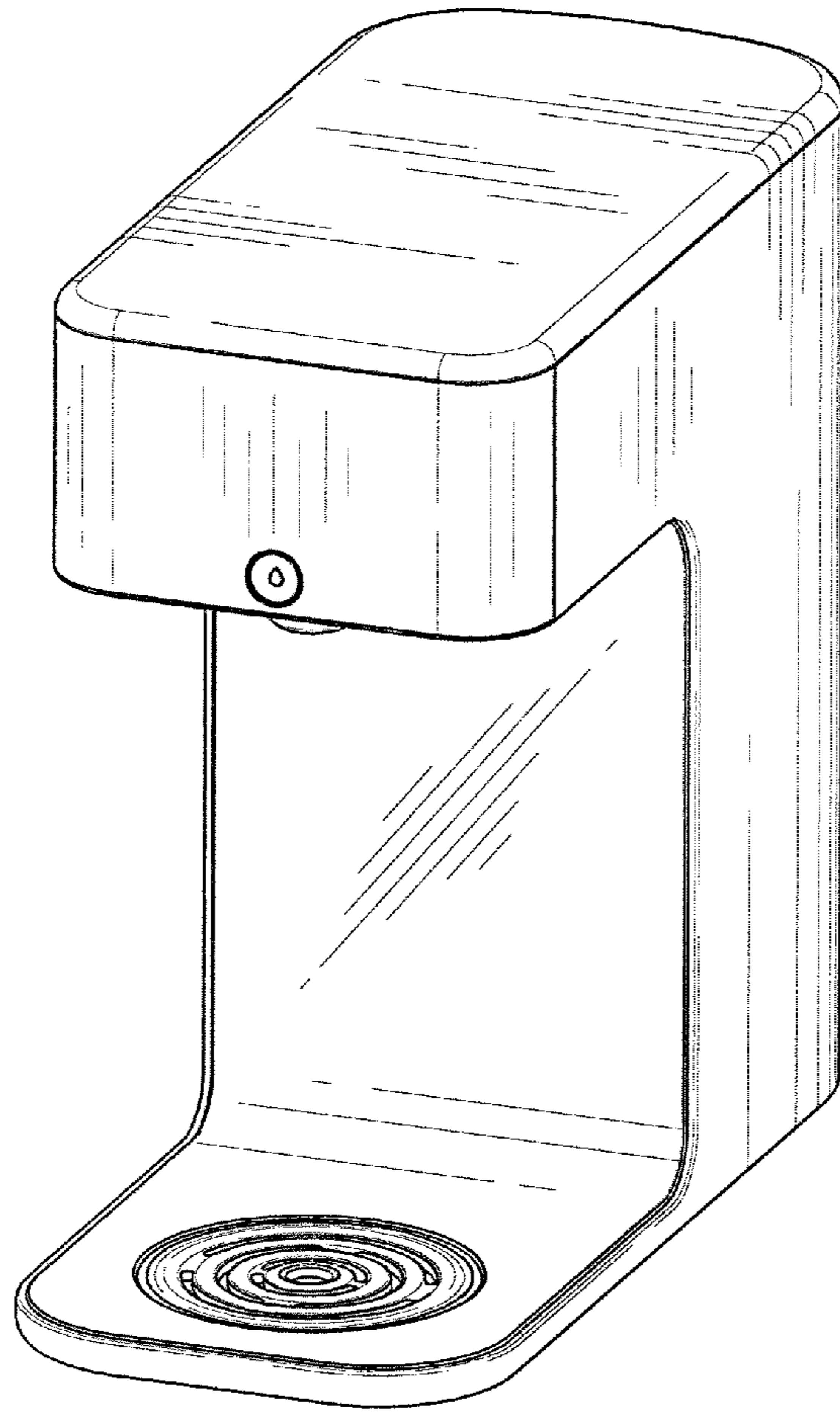

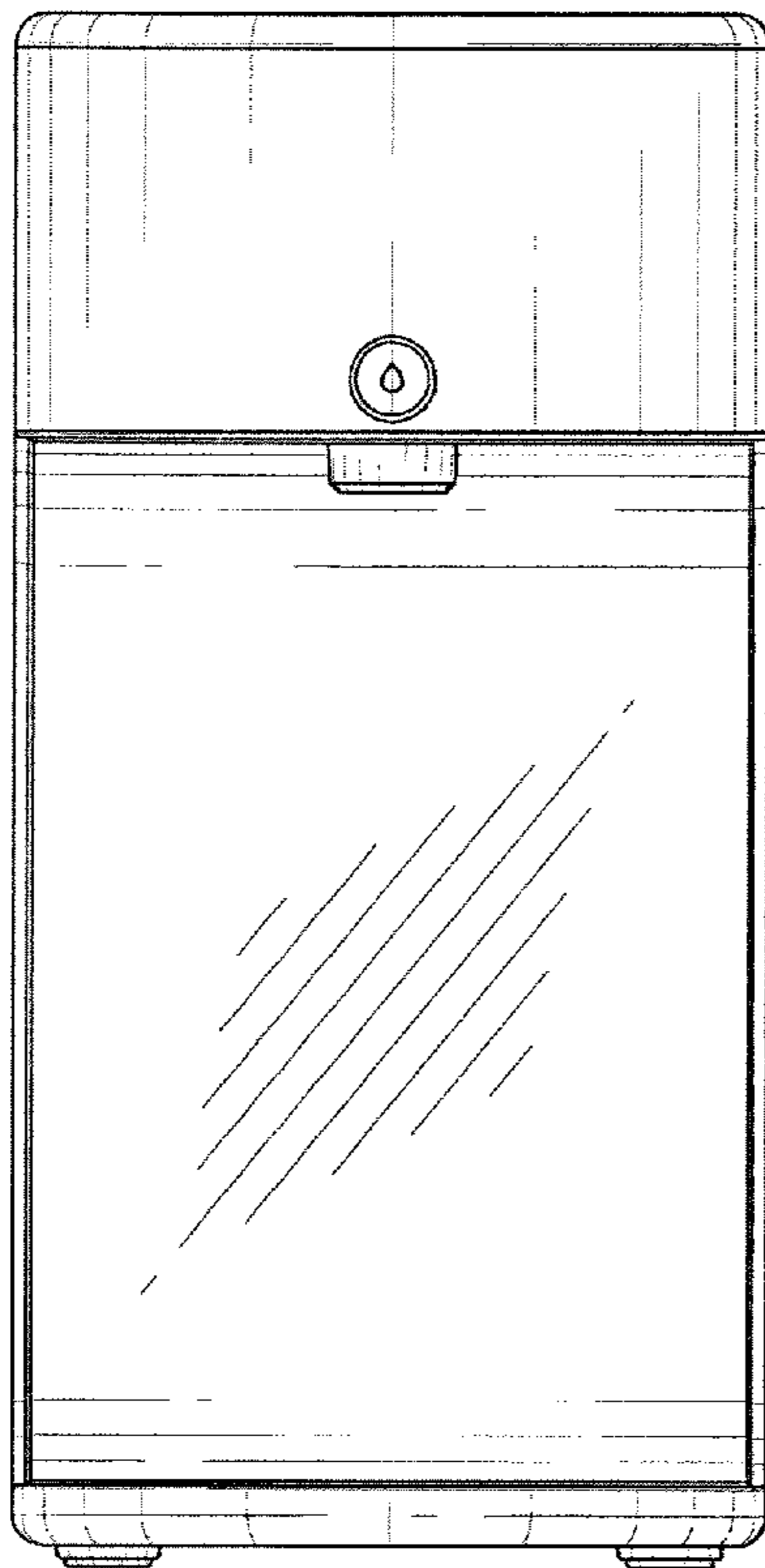

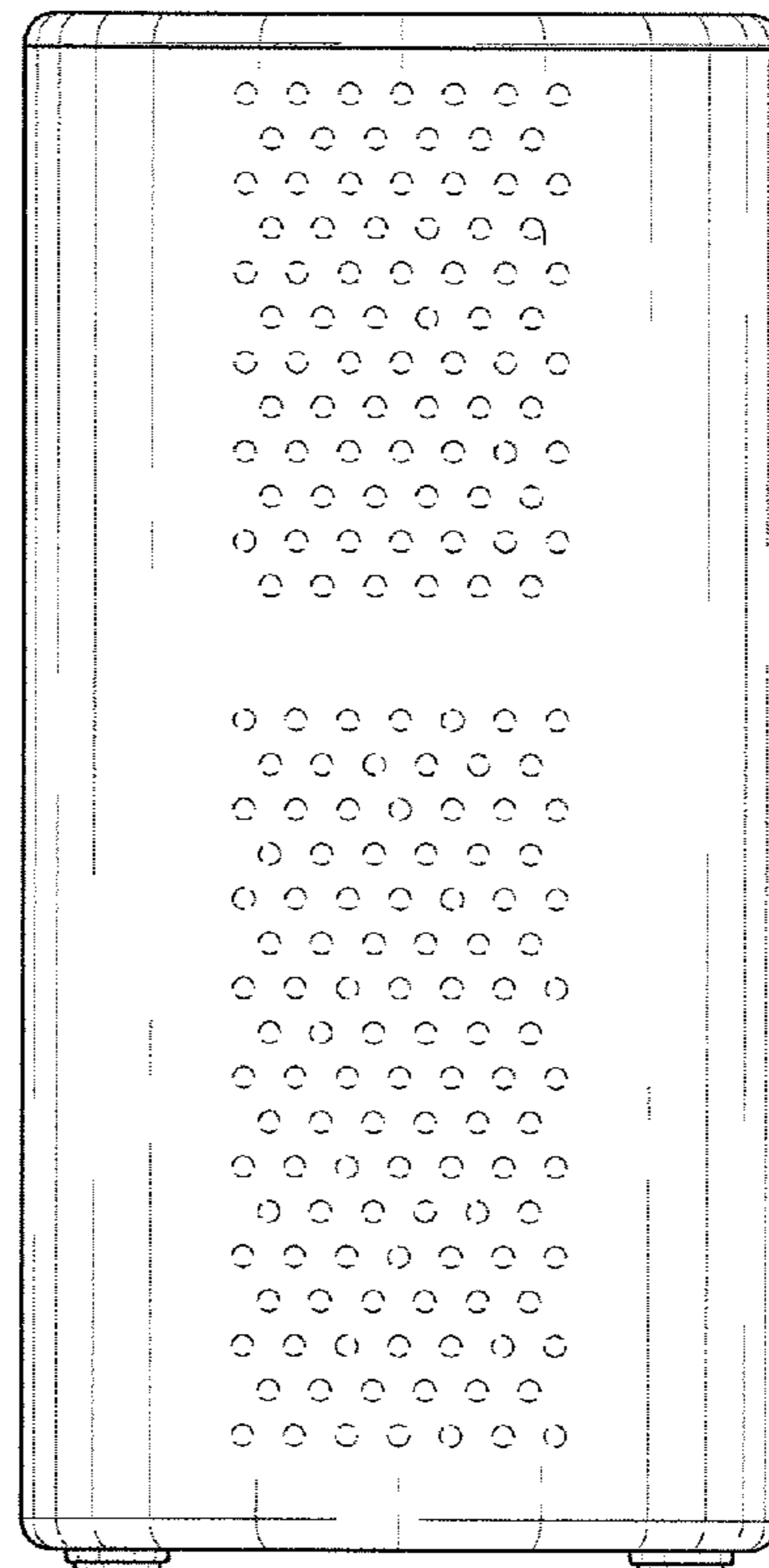

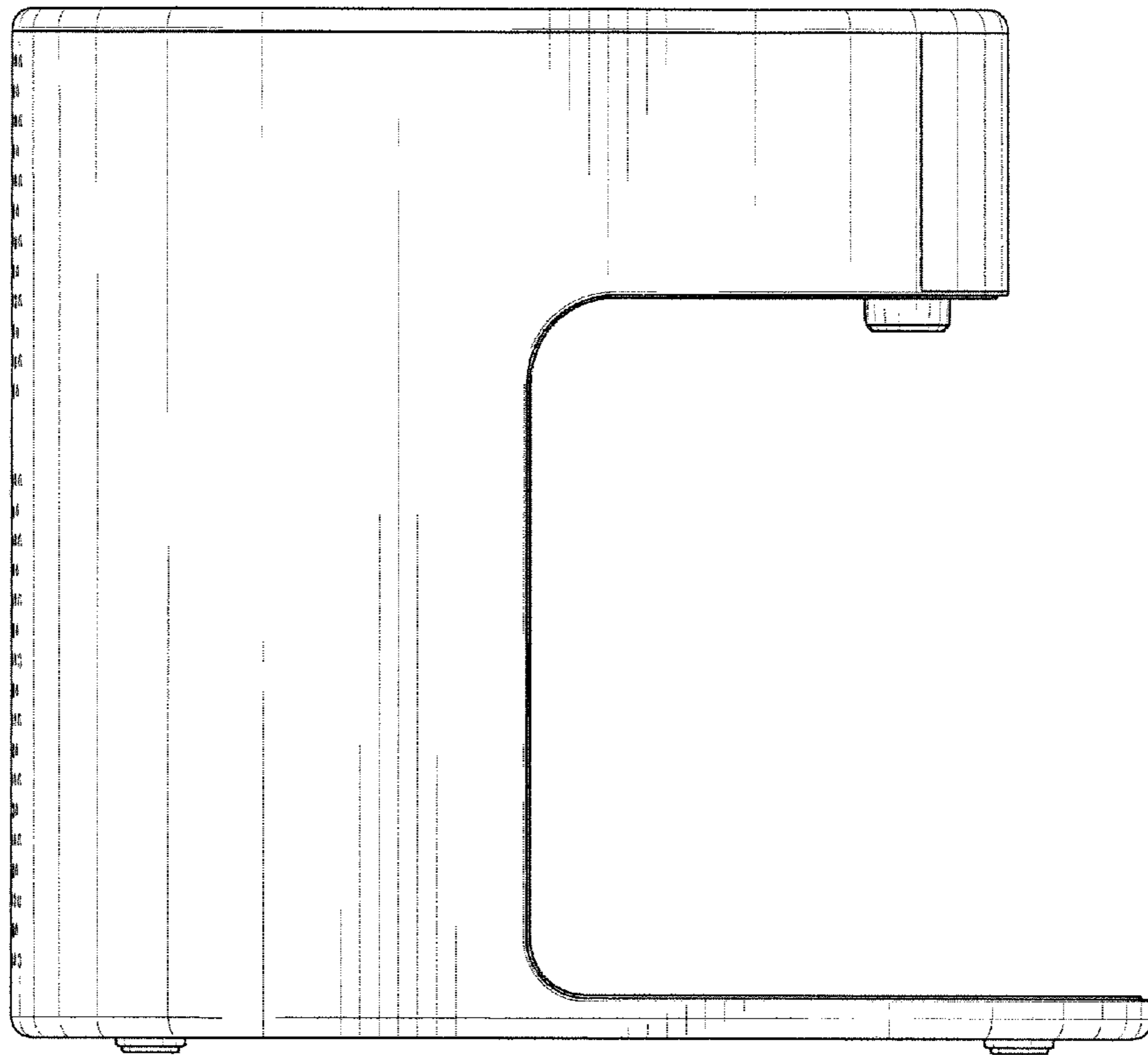

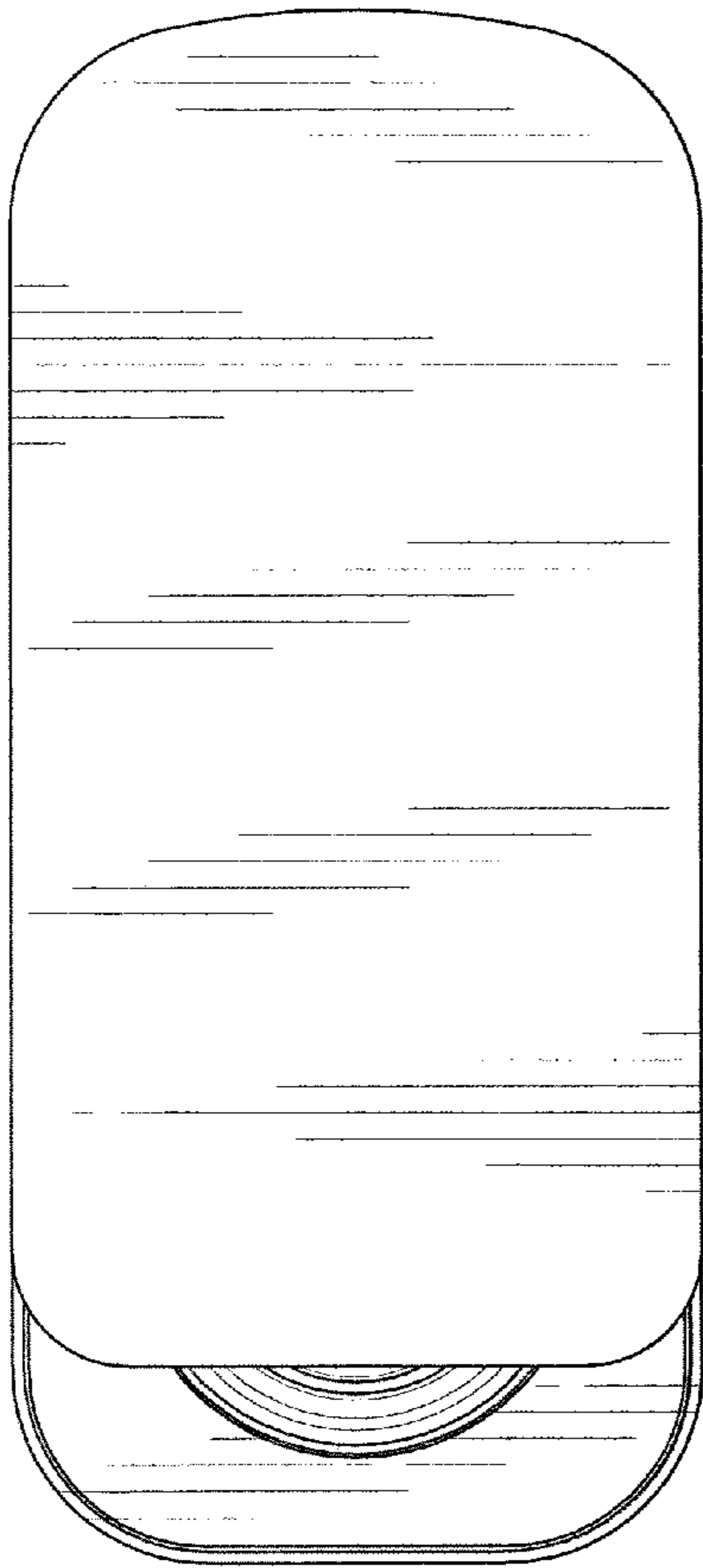

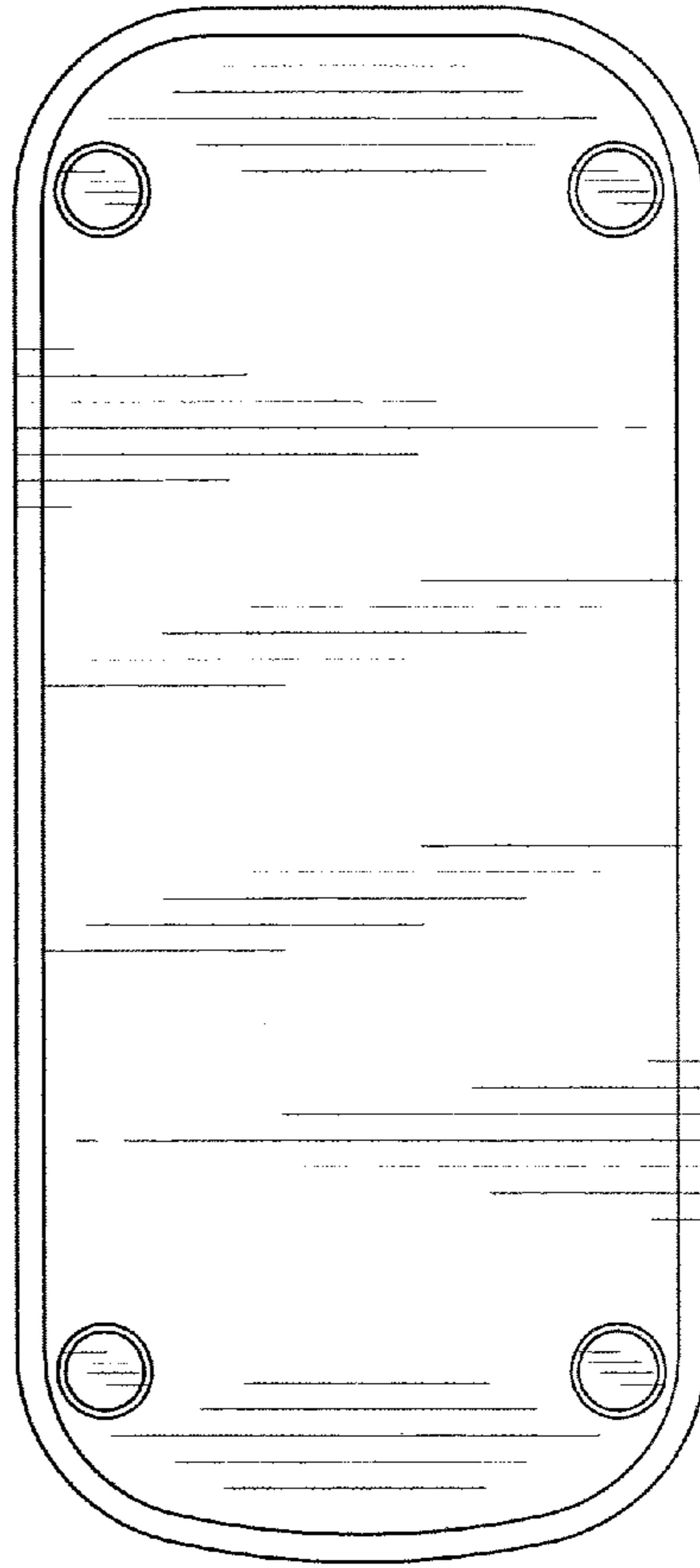
