(57) **CLAIM**

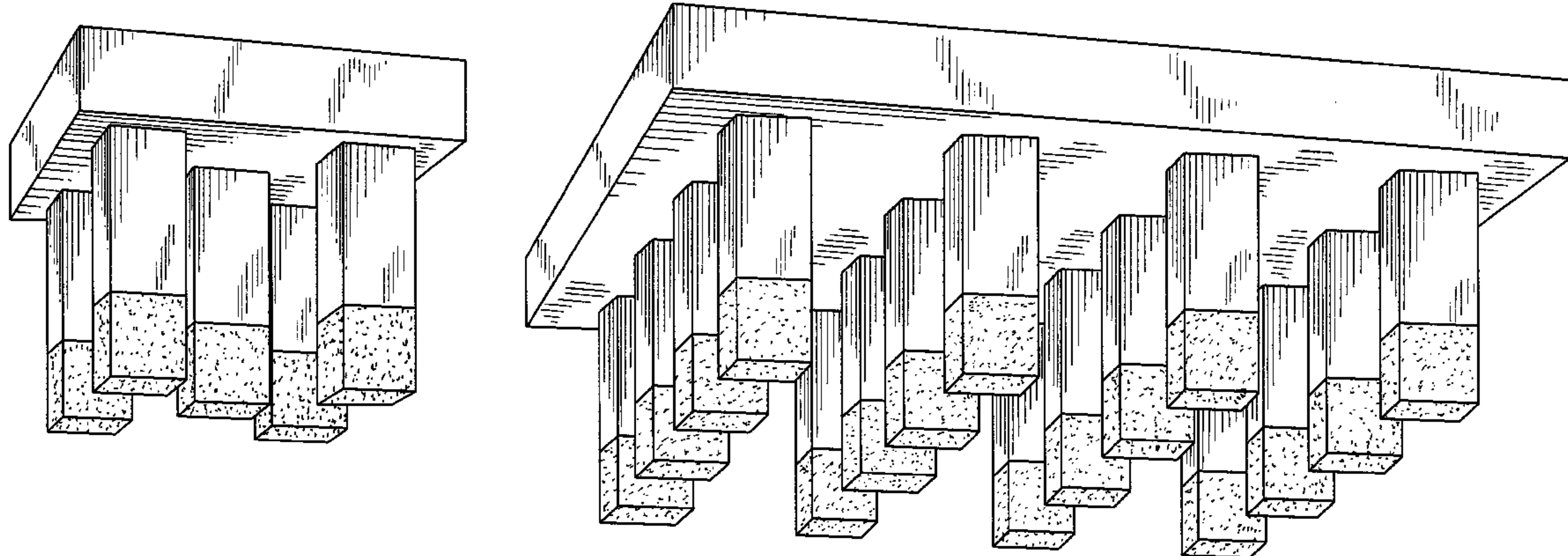
The ornamental design for a light fixture with vertical elements, as shown and described.

**DESCRIPTION**

FIG. 1 is a left, front and bottom perspective view of the light fixture with vertical elements showing my new design; FIG. 2 is a front side elevational view thereof, the left, right and rear side elevational views being the same; FIG. 3 is a bottom plan view thereof, the top plan view not shown as being conventional; FIG. 4 is a left, front and bottom perspective view of a second embodiment of my new design; FIG. 5 is a front side elevational view thereof, the left, right and rear side elevational views being the same; FIG. 6 is a bottom plan view thereof, the top plan view not shown as being conventional; FIG. 7 is a left, front and bottom perspective view of a third embodiment of my new design; FIG. 8 is a front side elevational view thereof, the left, right and rear side elevational views being the same; FIG. 9 is a bottom plan view thereof, the top plan view not shown as being conventional; FIG. 10 is a left, front and bottom perspective view of a fourth embodiment of my new design; FIG. 11 is a front side elevational view thereof, the left, right and rear side elevational views being the same; and, FIG. 12 is a bottom plan view thereof; the top plan view not shown as being conventional.

The top surfaces of each of the embodiments of the light fixture are flat and devoid of surface ornamentation.

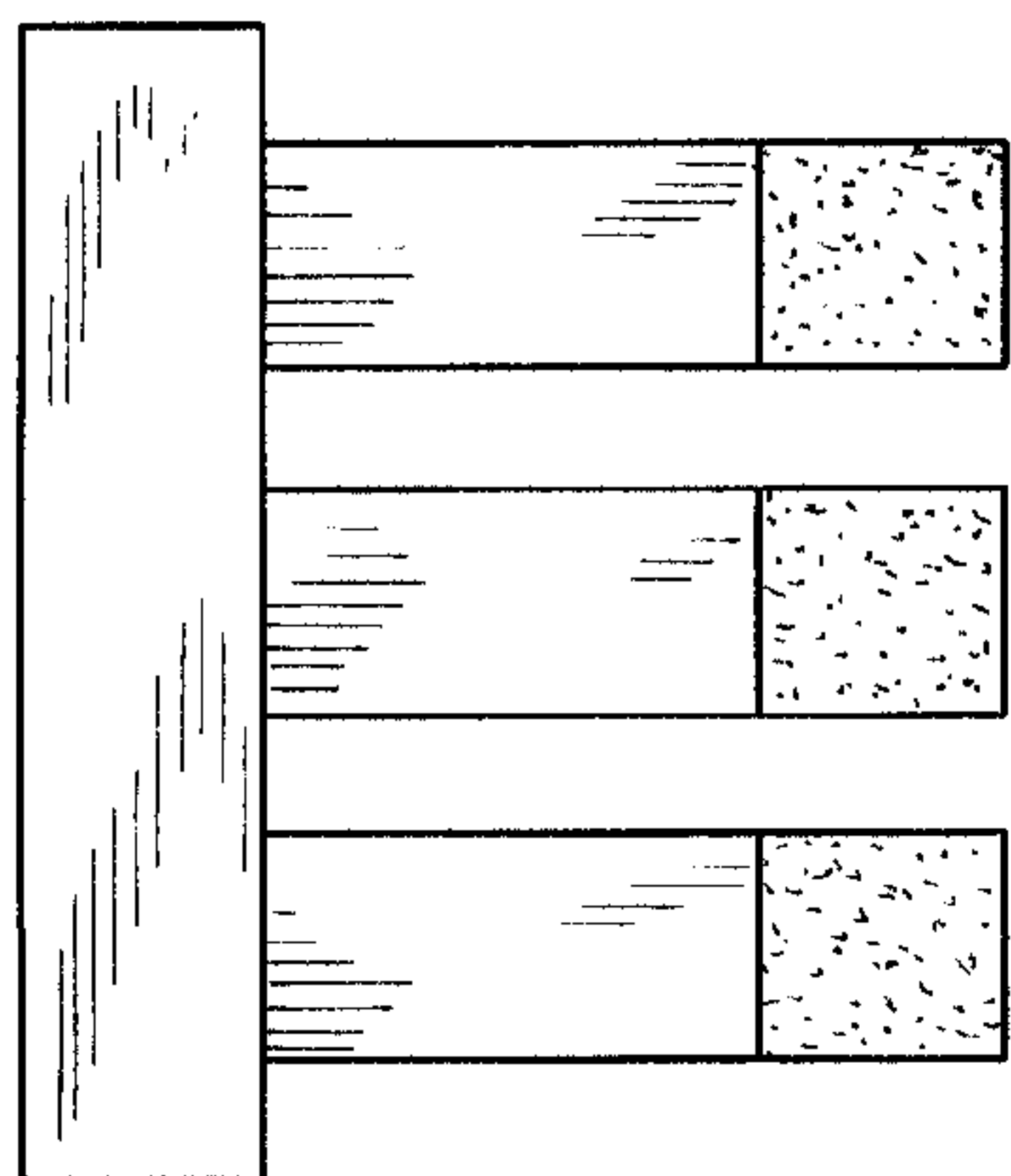

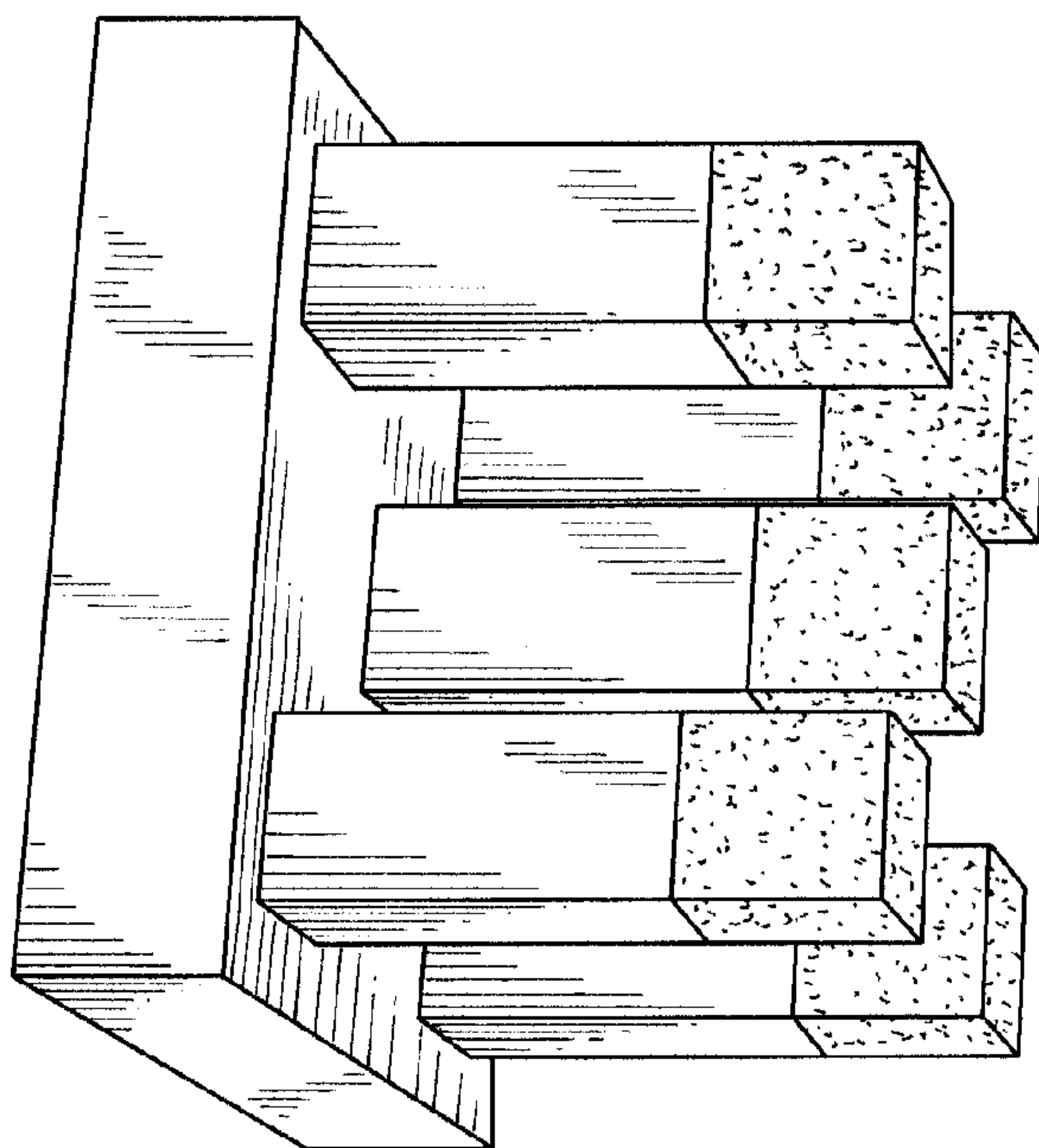

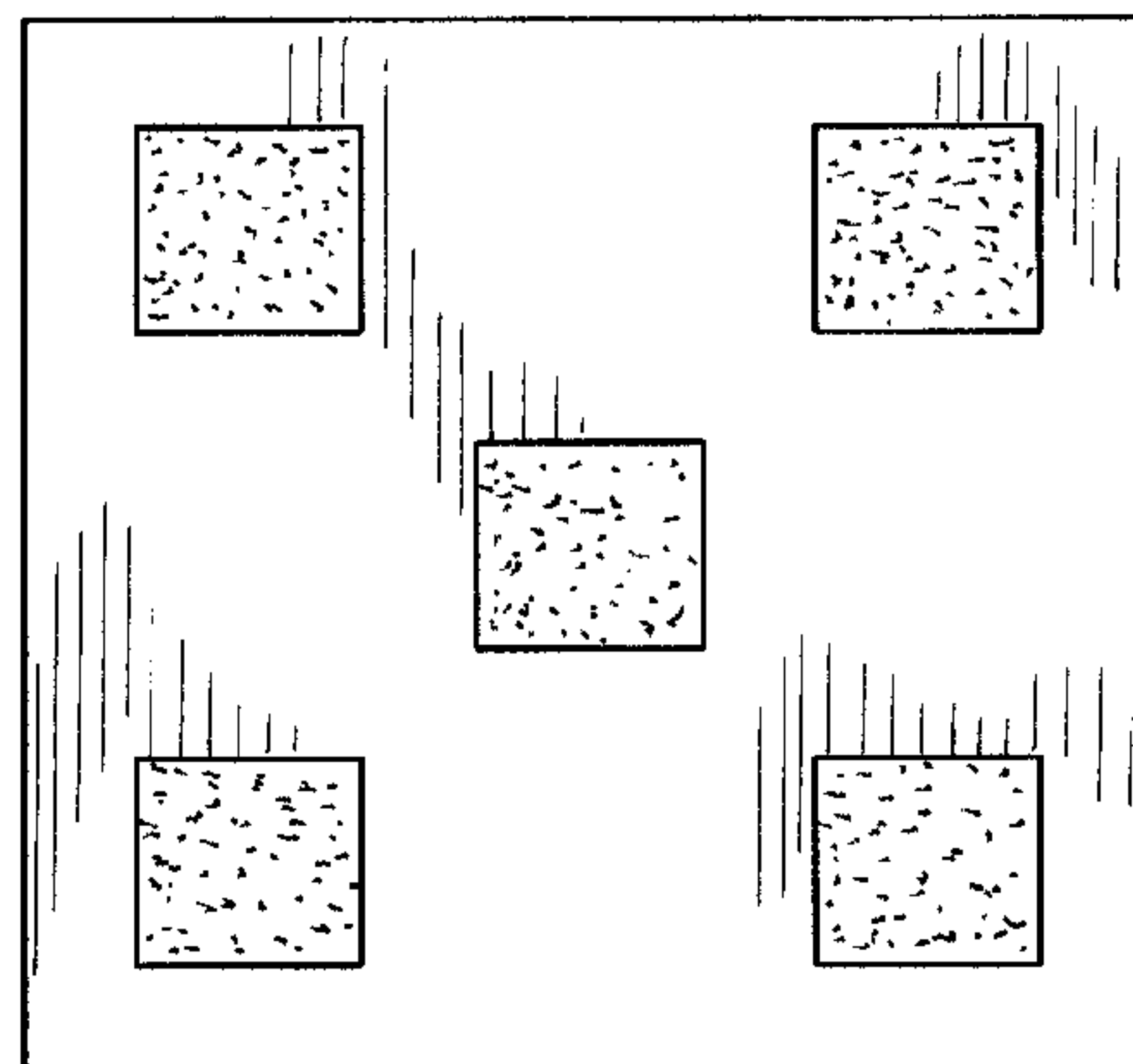

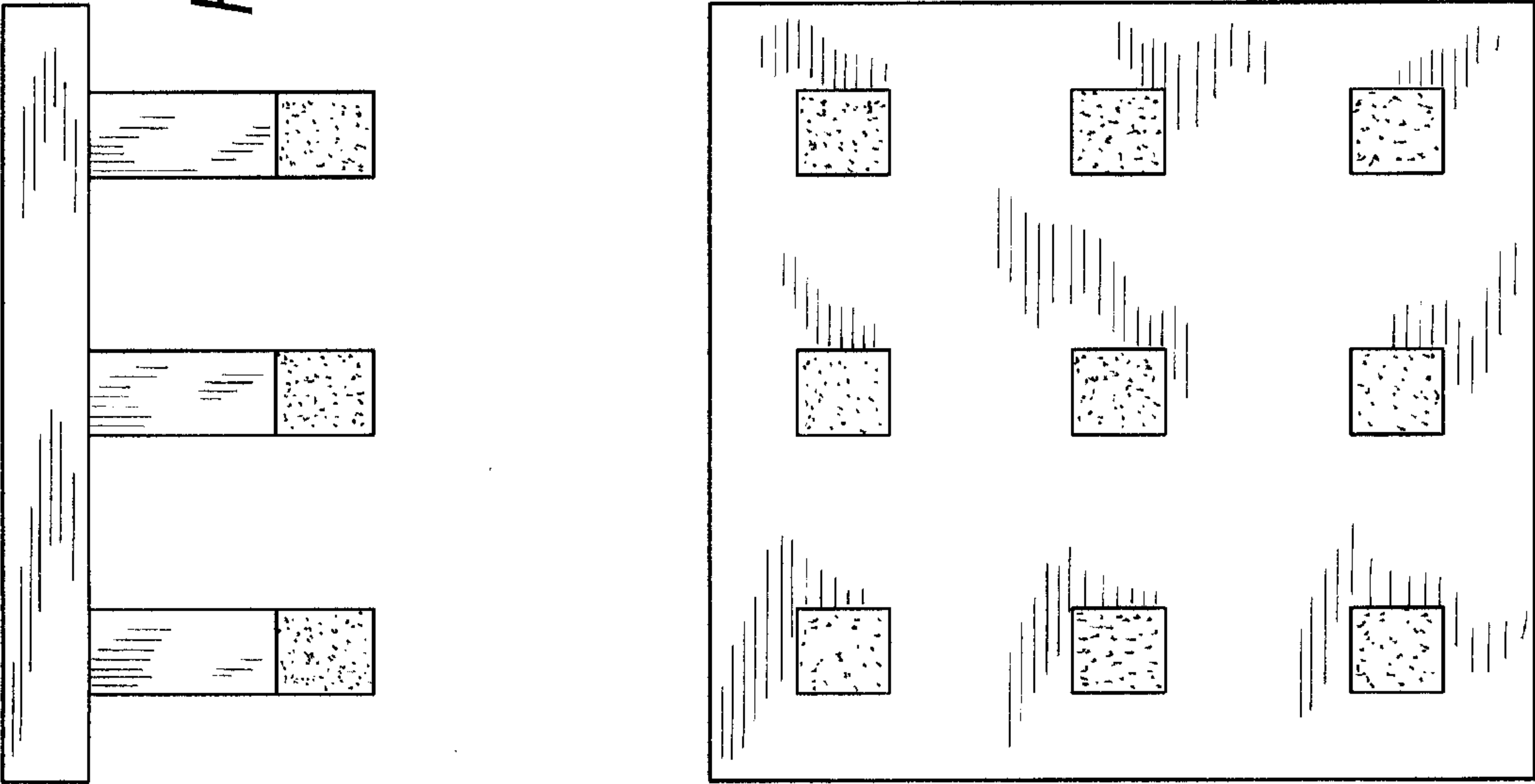

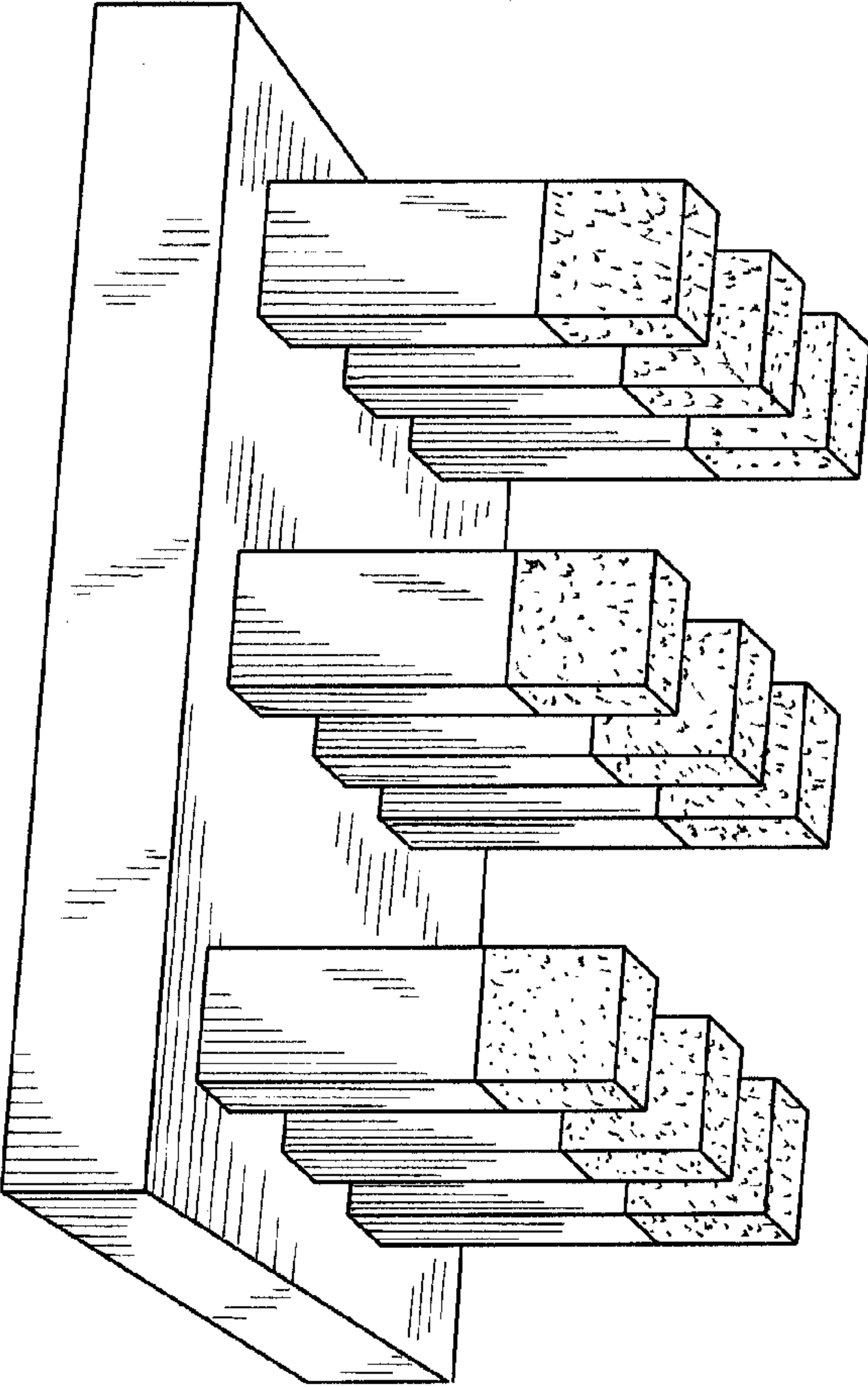
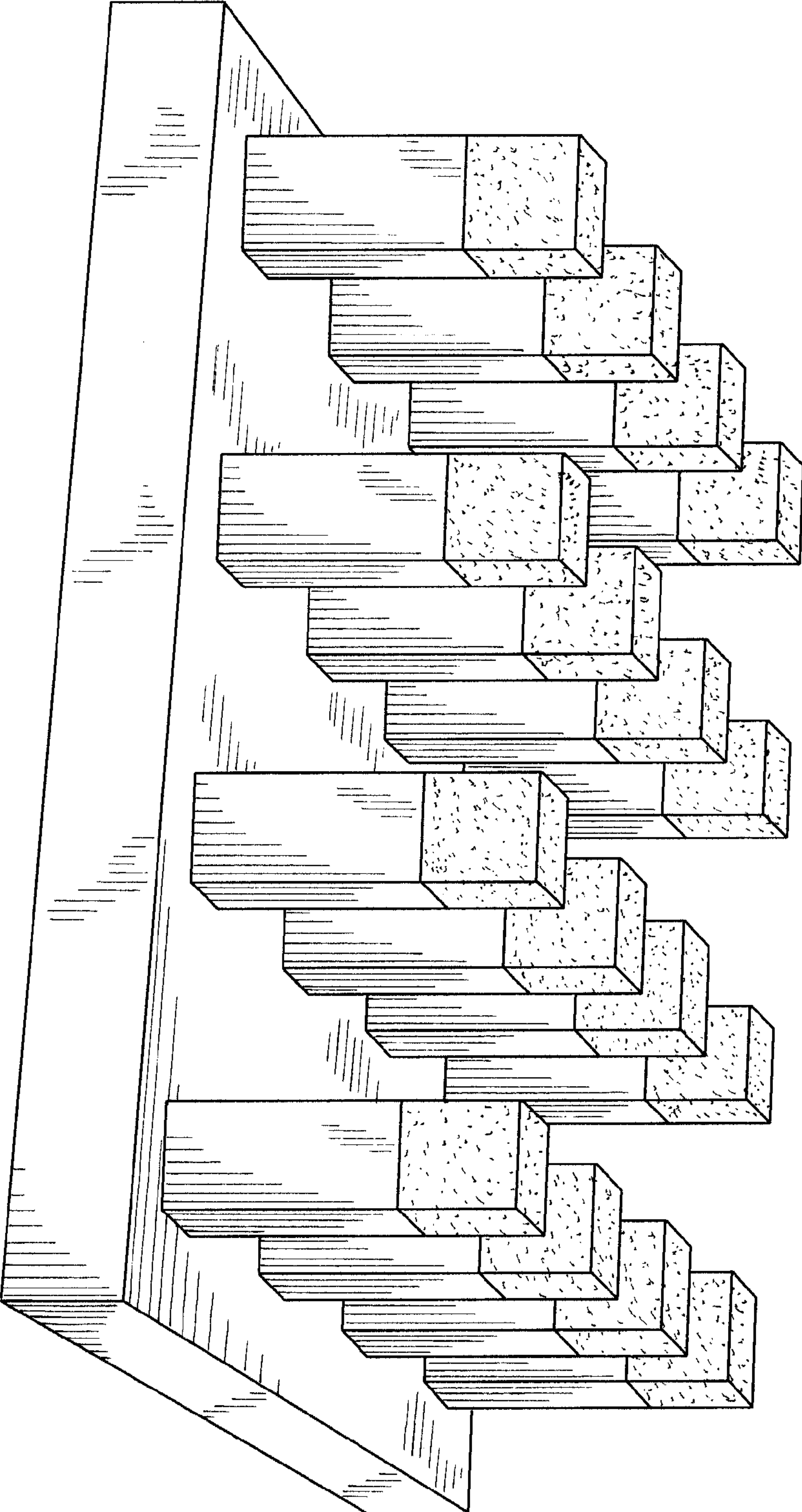

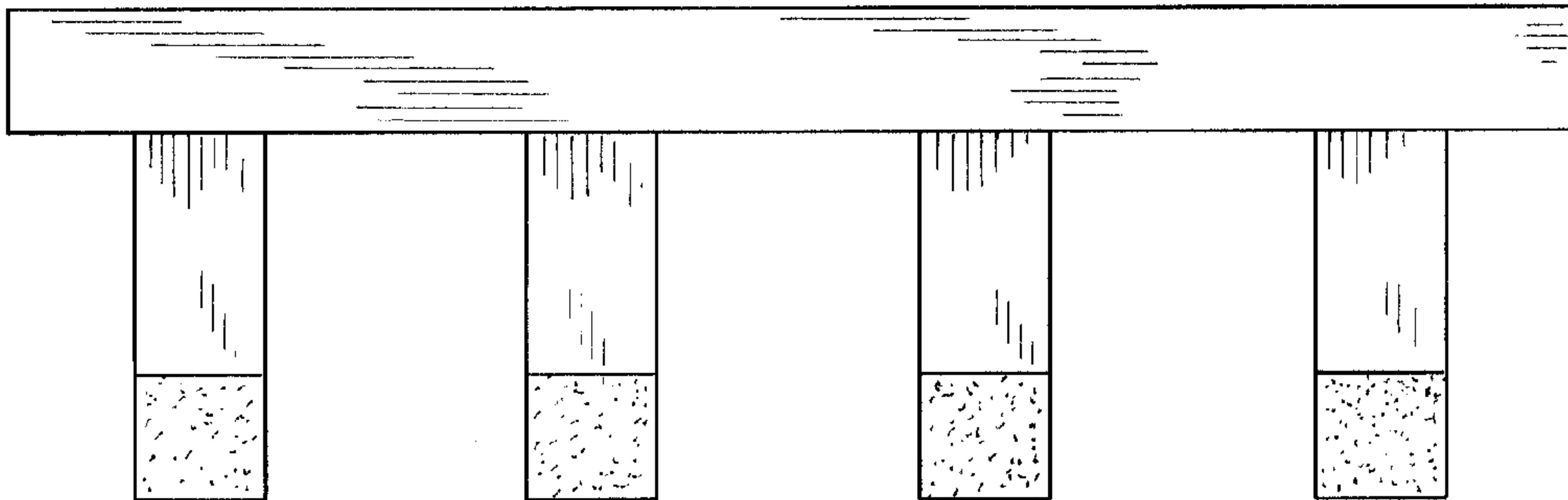

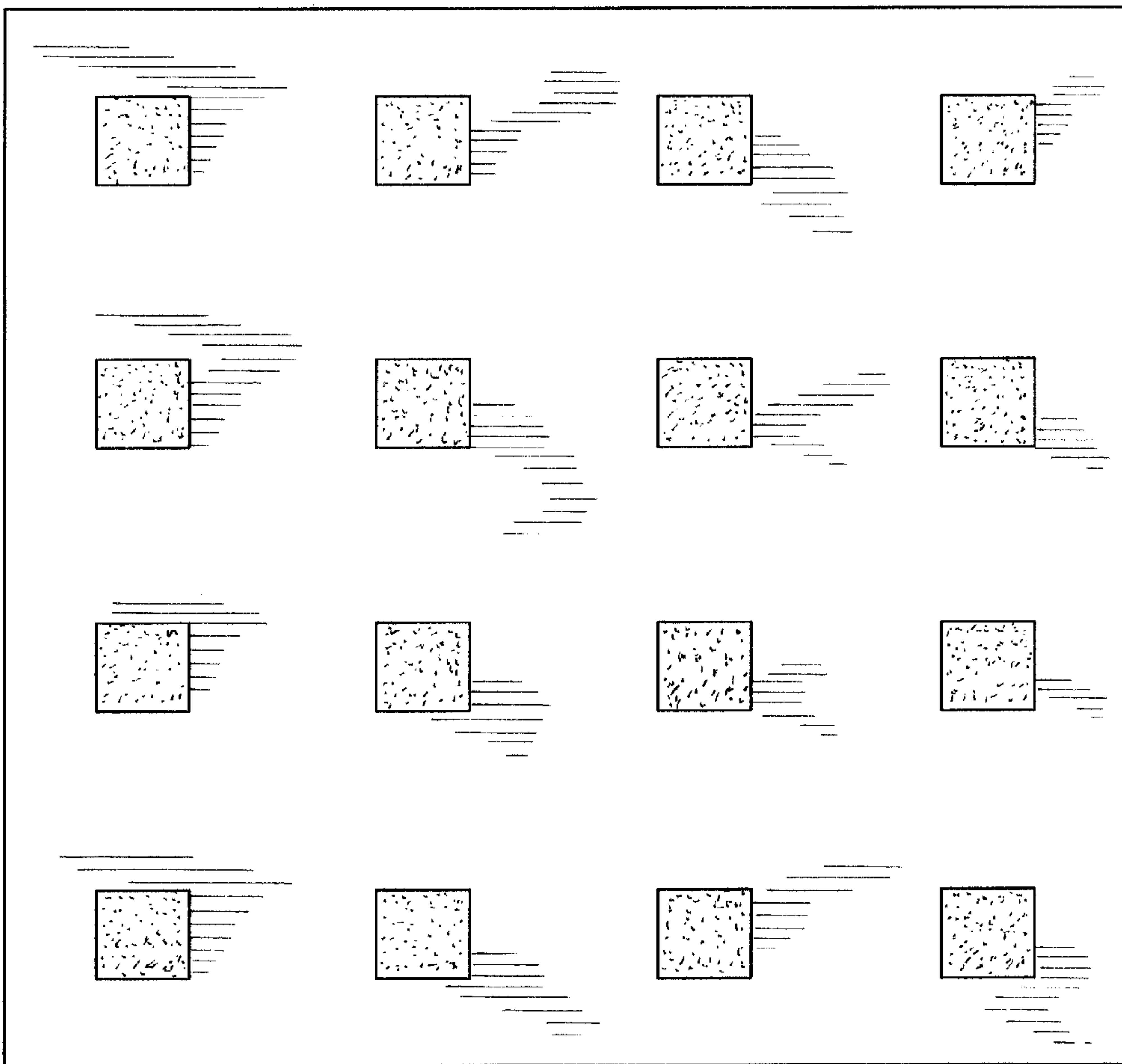
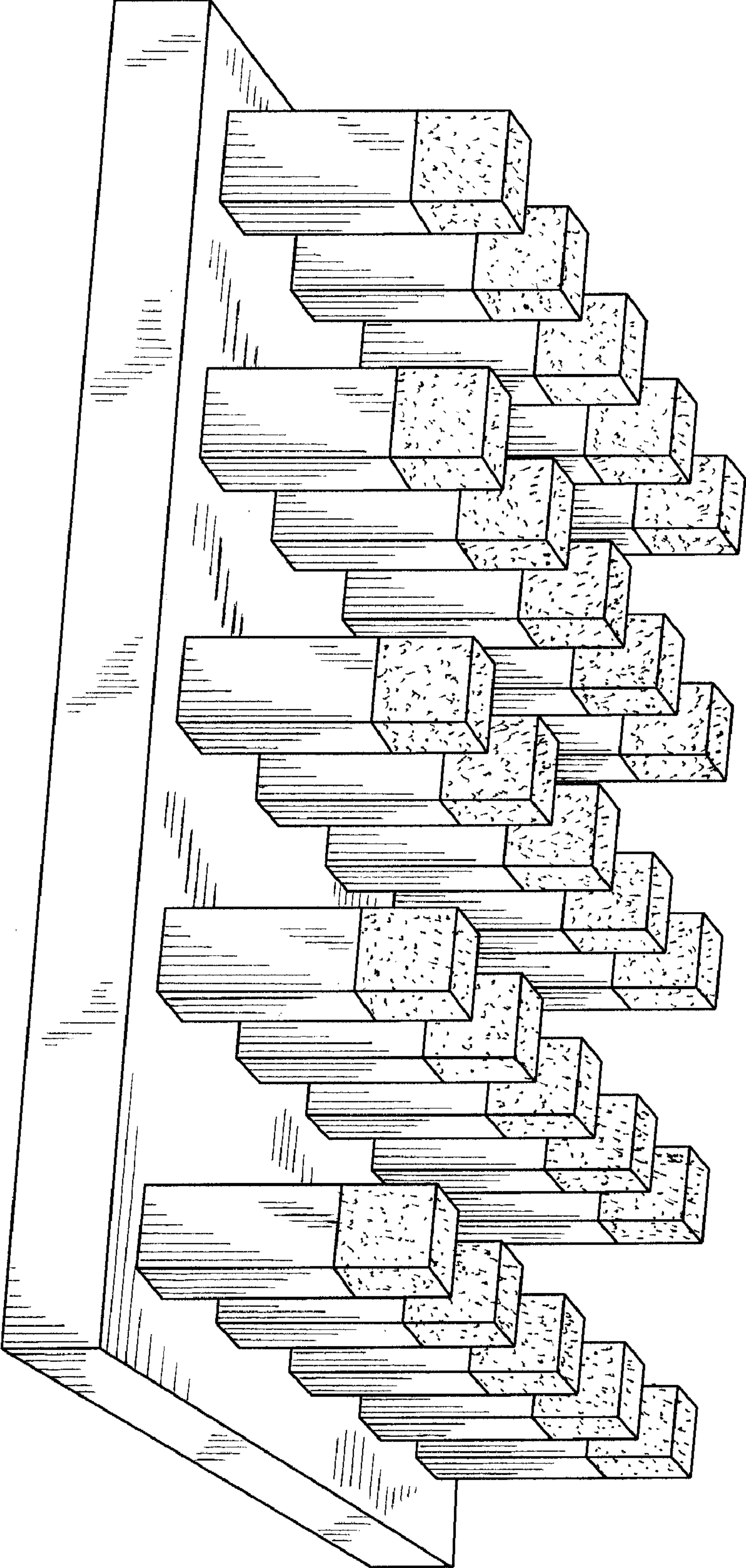

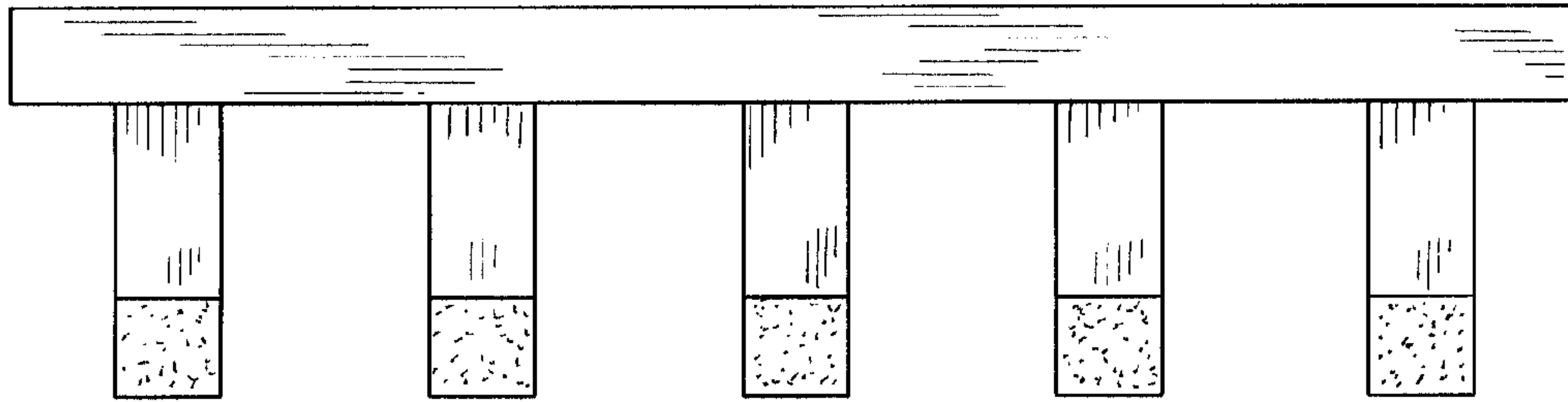

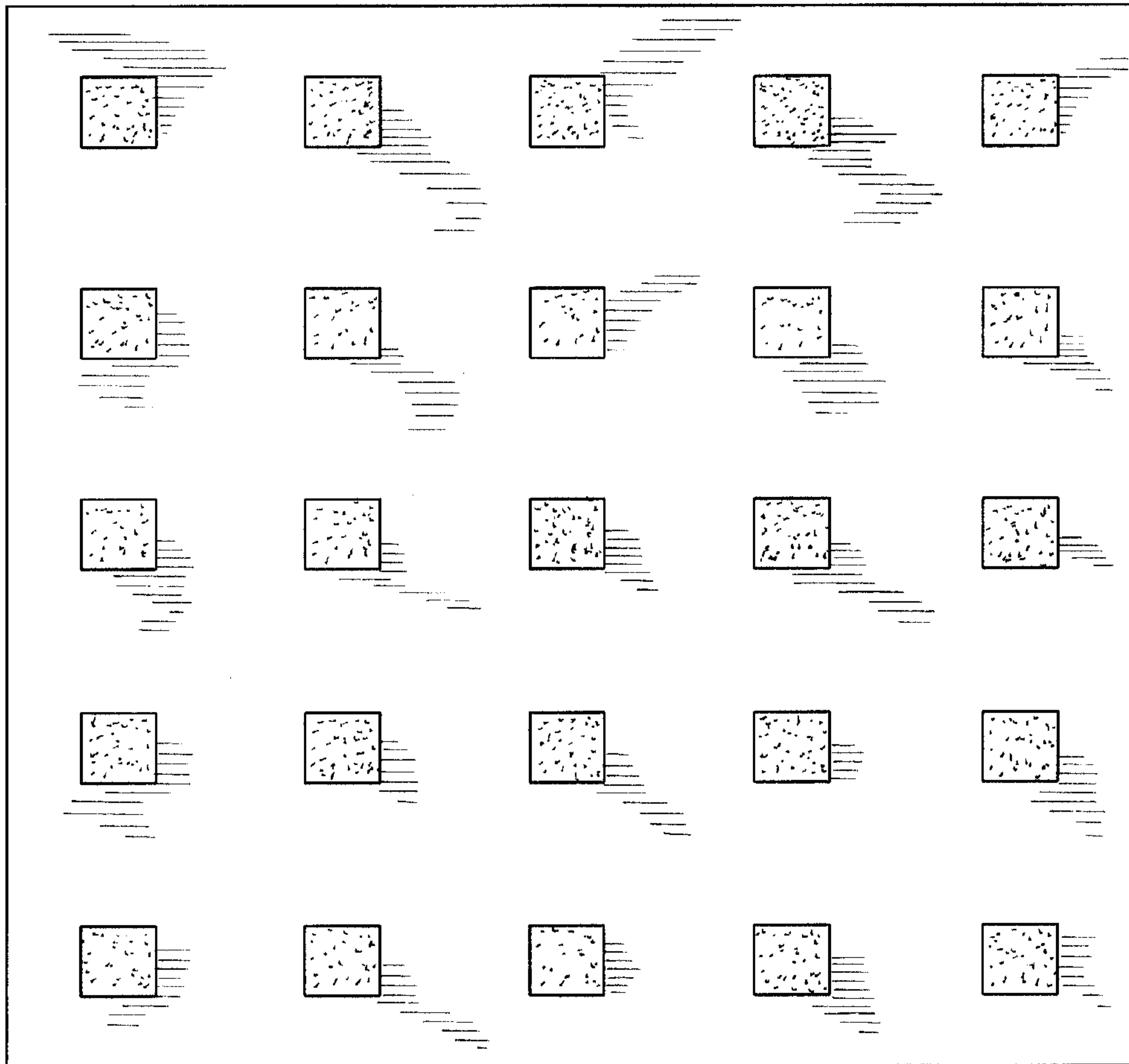
