FIG. 3 is a right side elevation view of the edible treat;

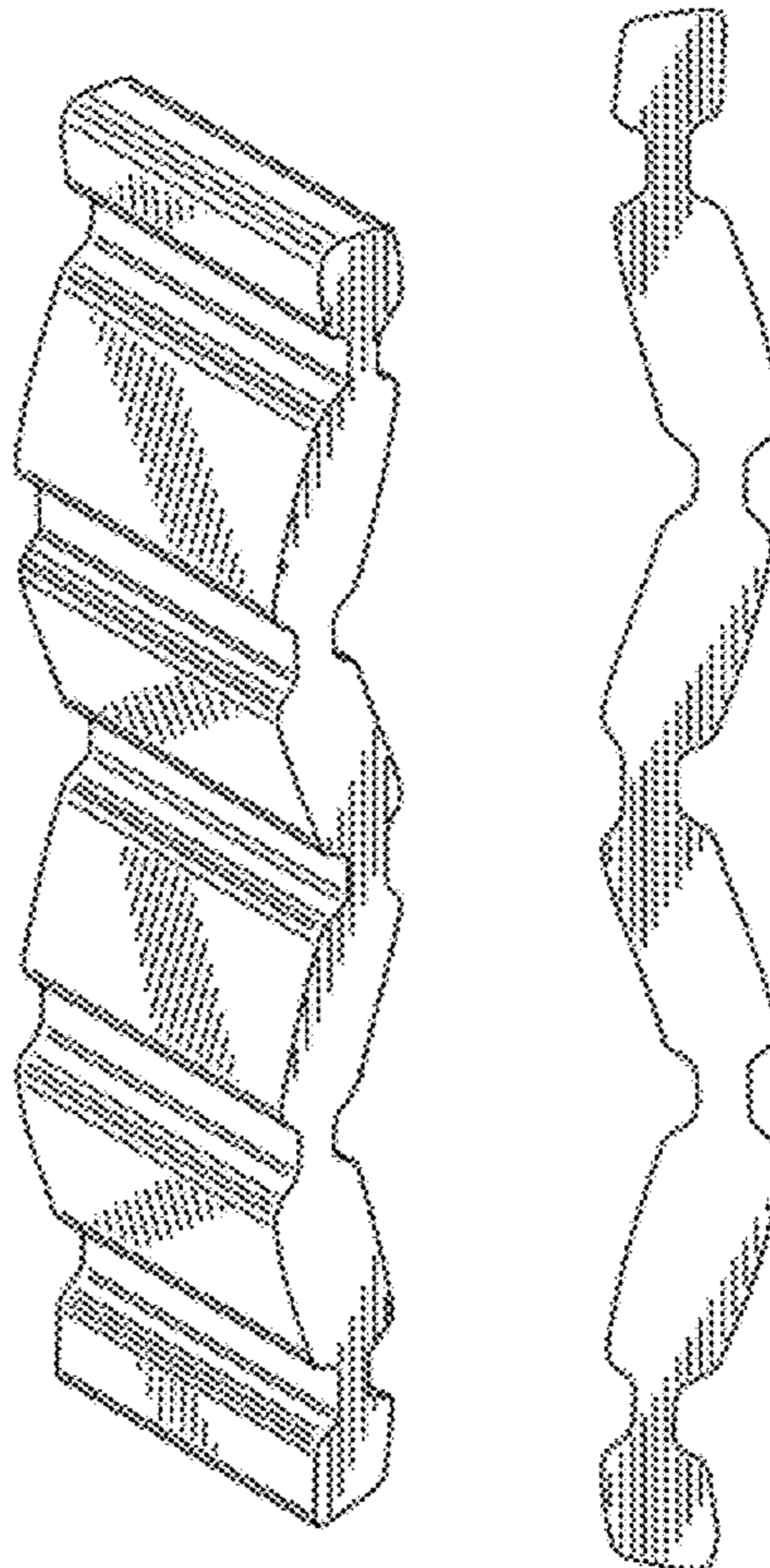
FIG. 4 is a top plan view of the edible treat;

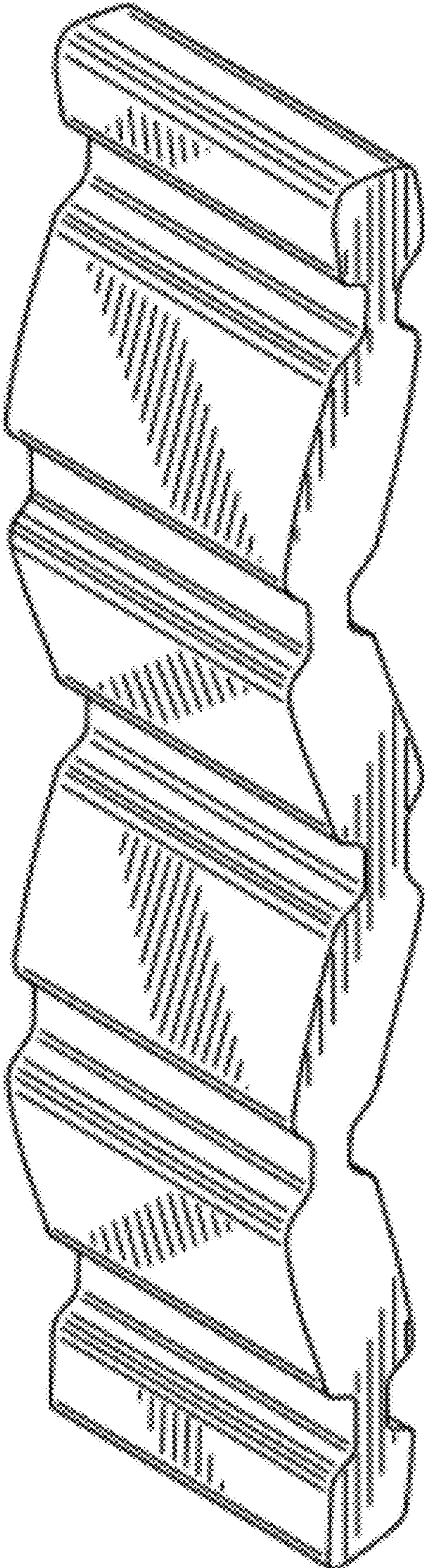

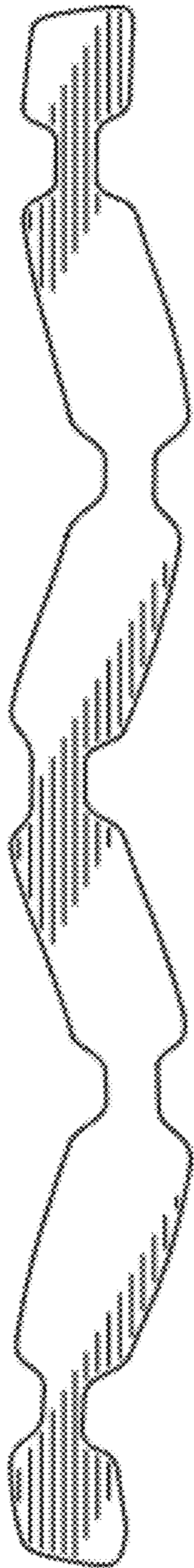

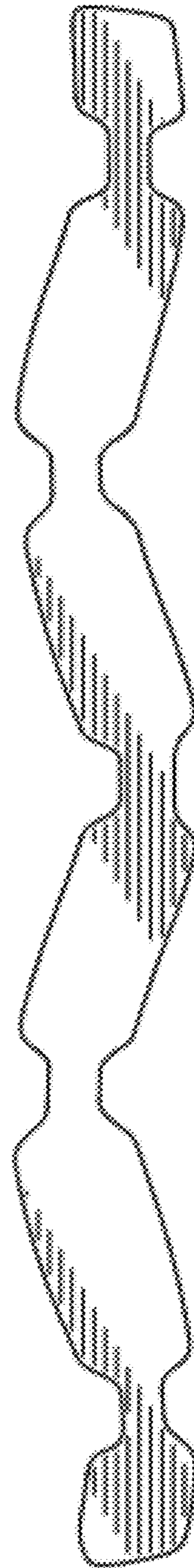

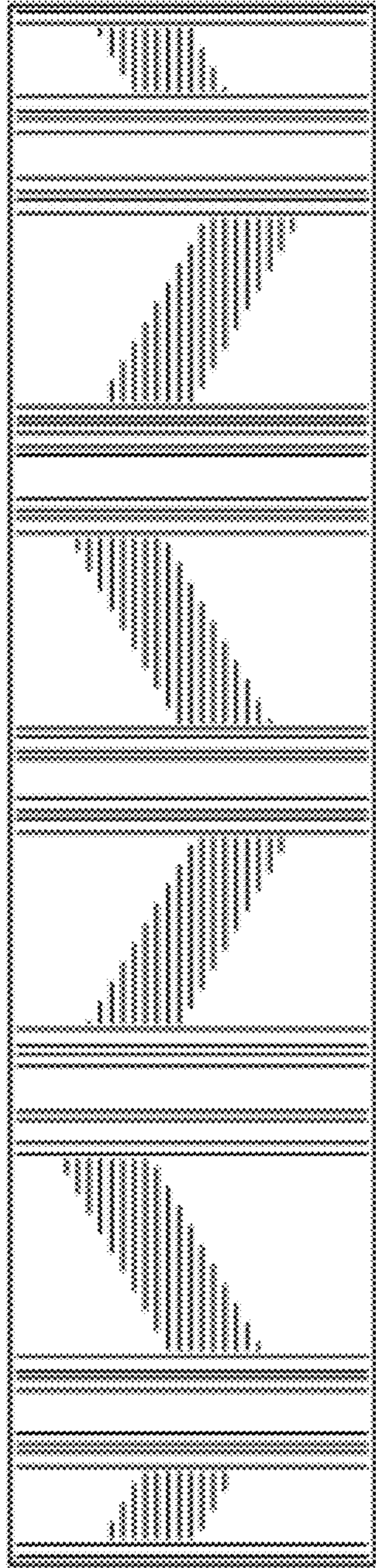

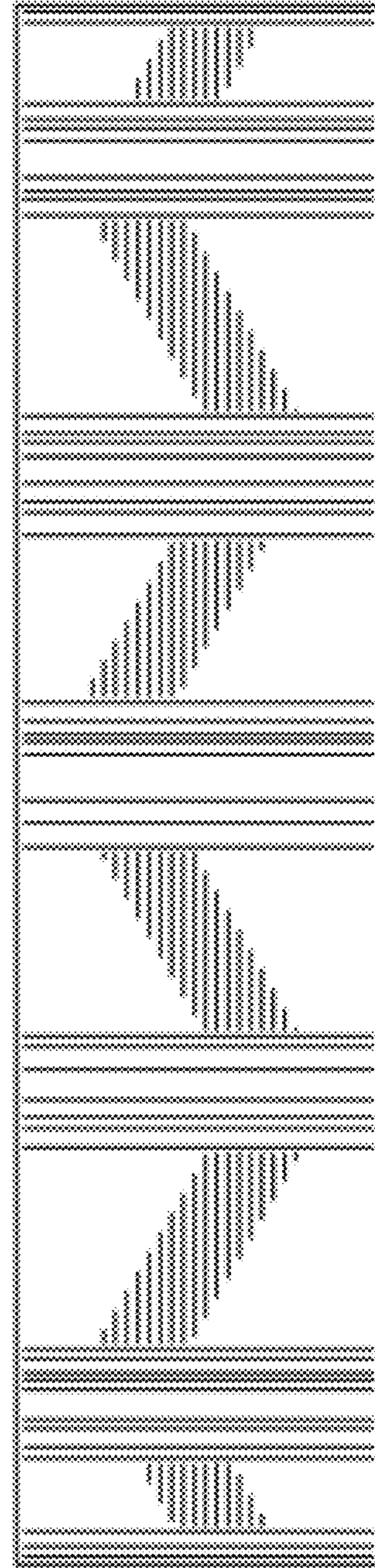

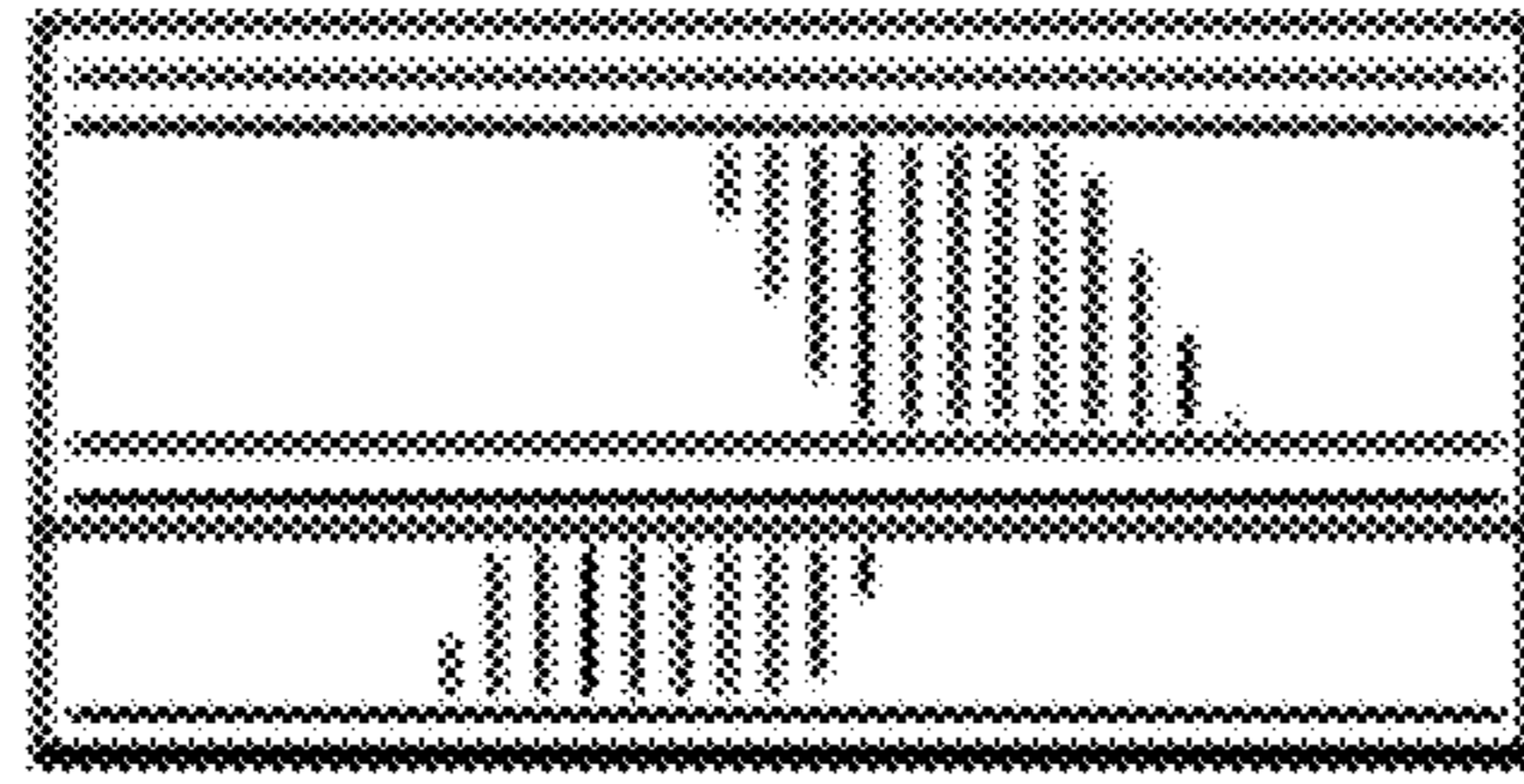

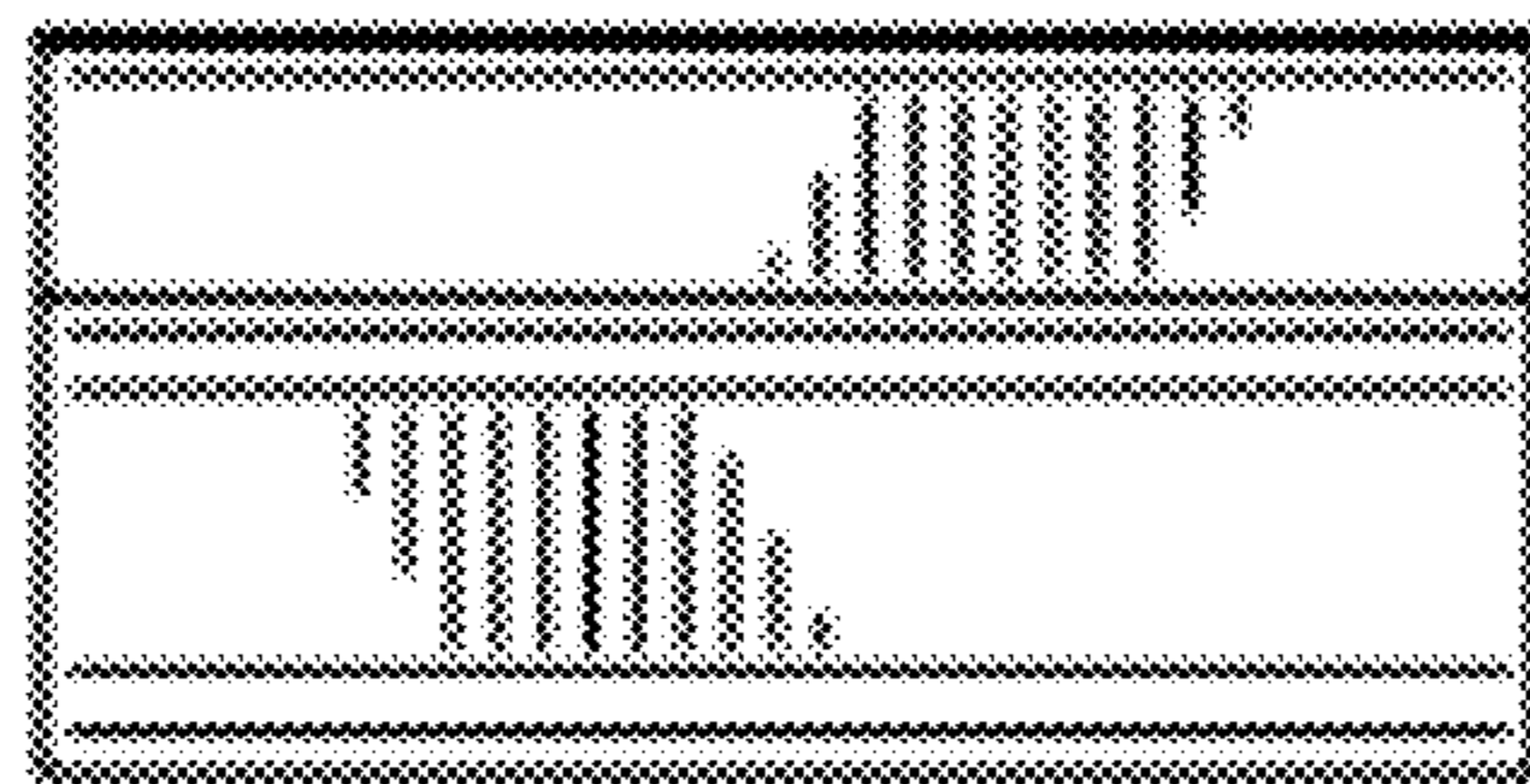
