DESCRIPTION

FIG. 1 is a front left perspective view of a portable beverage
container showing our new design;

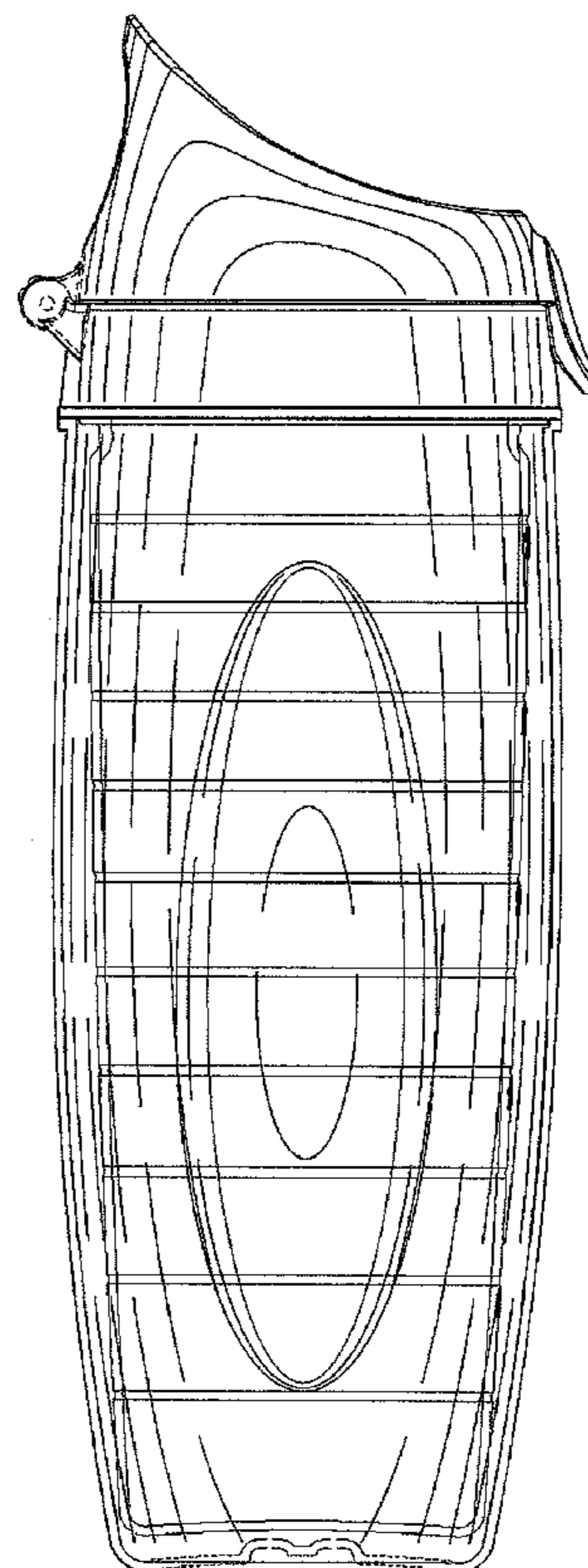
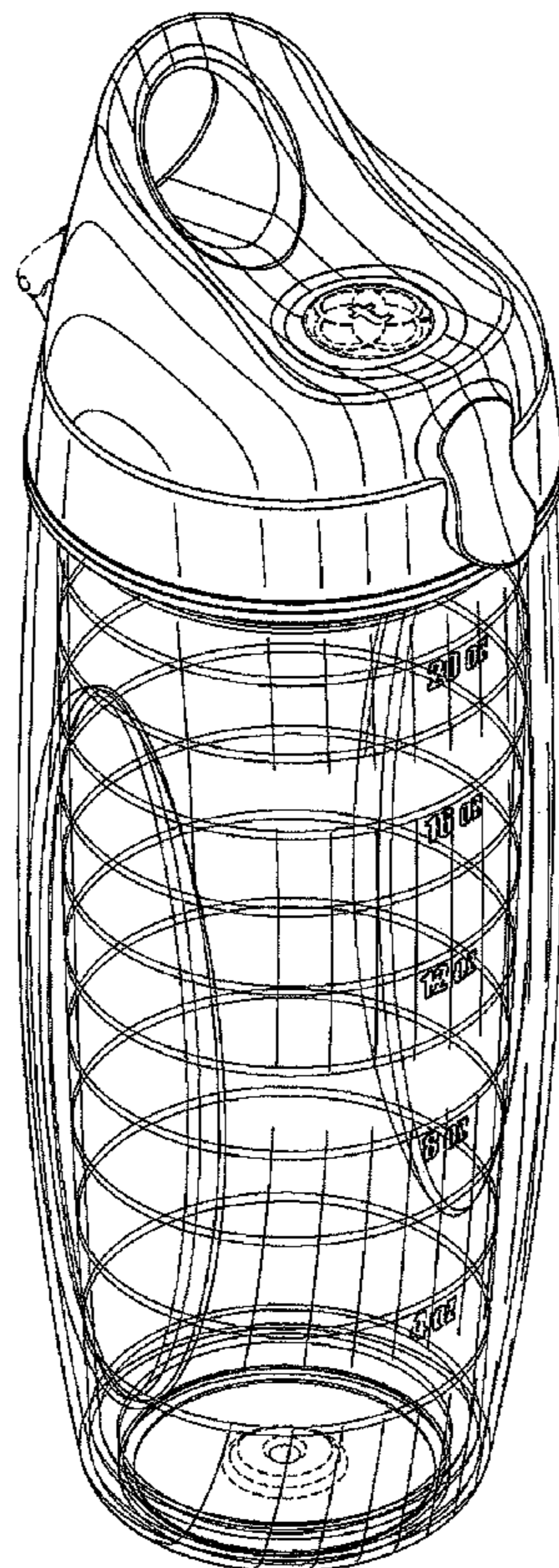

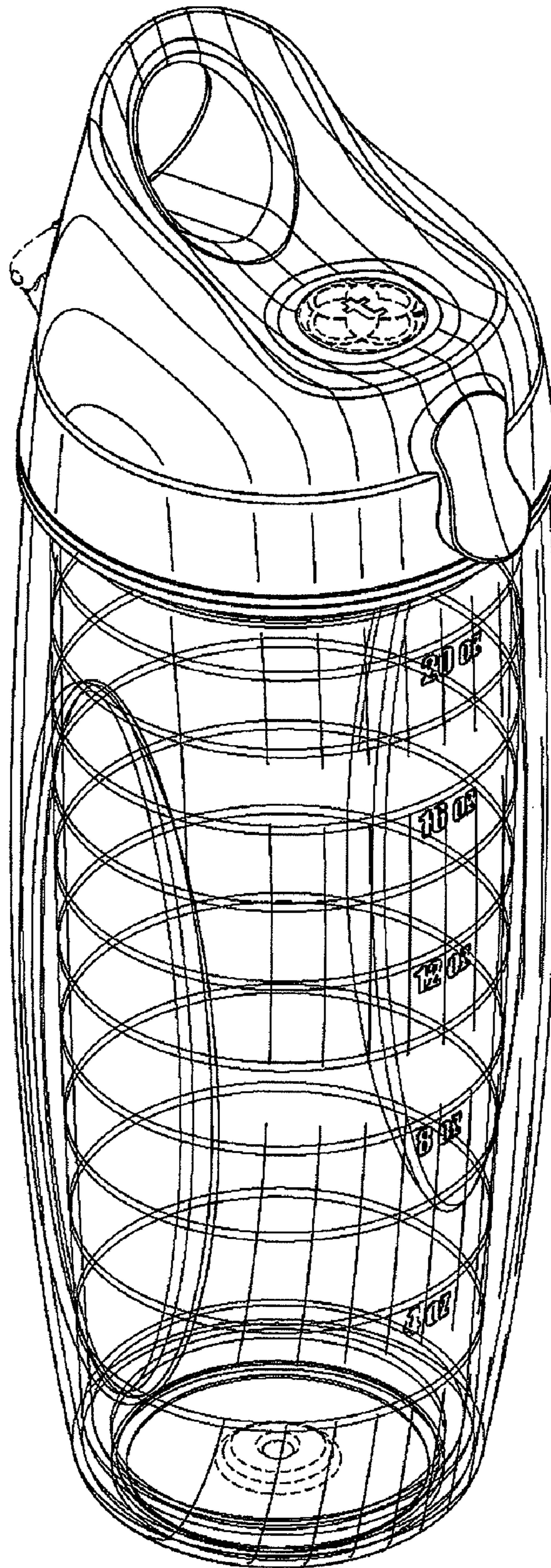

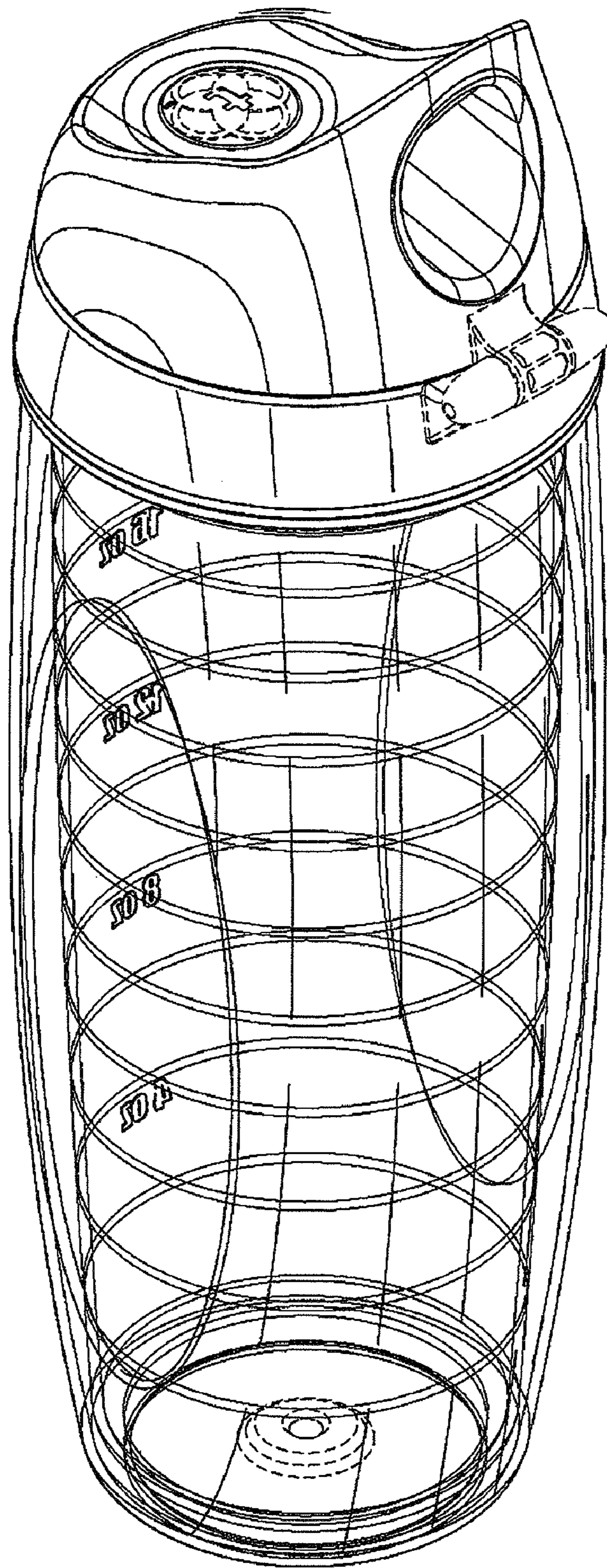

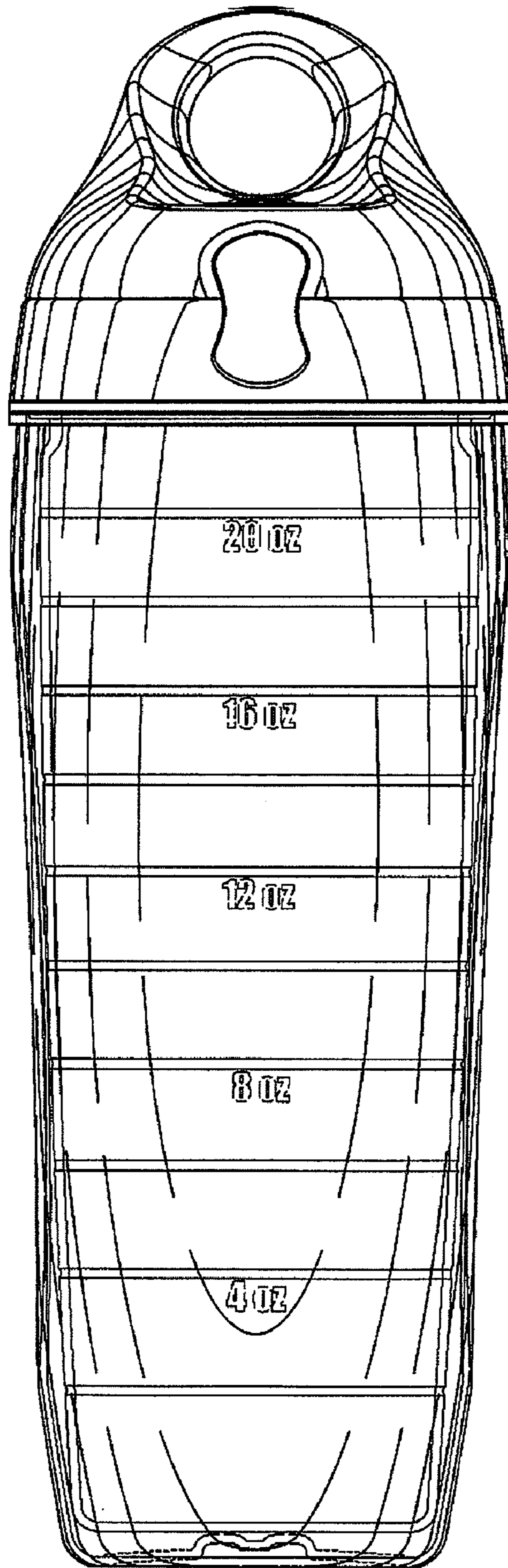

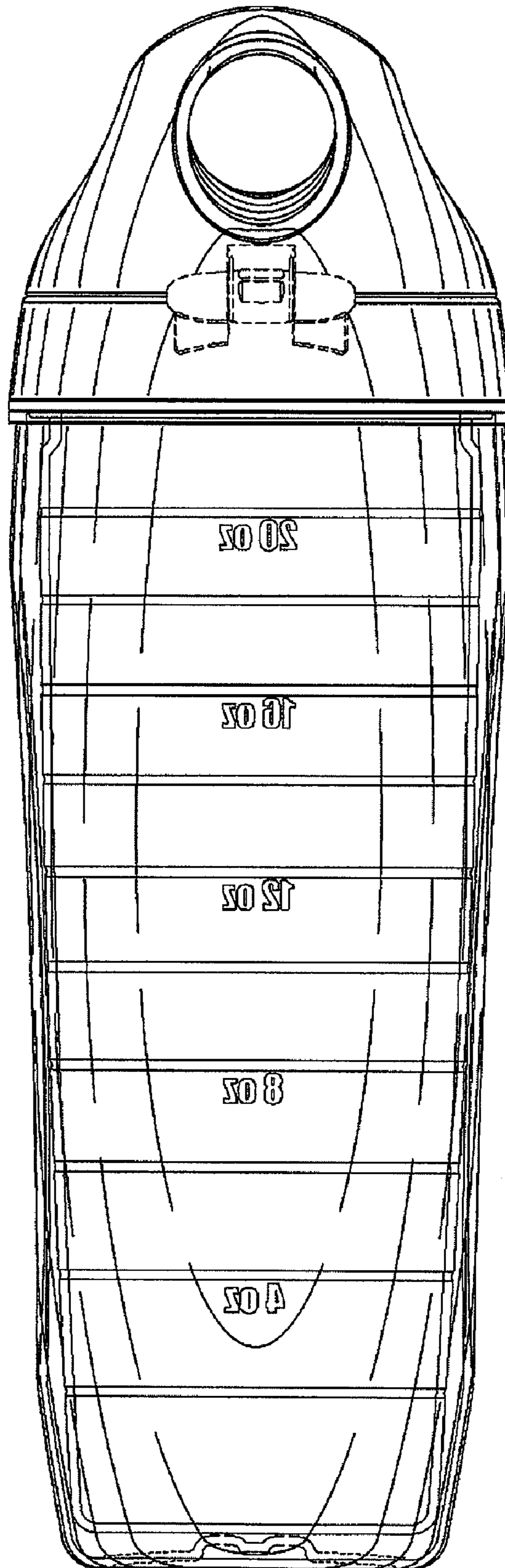

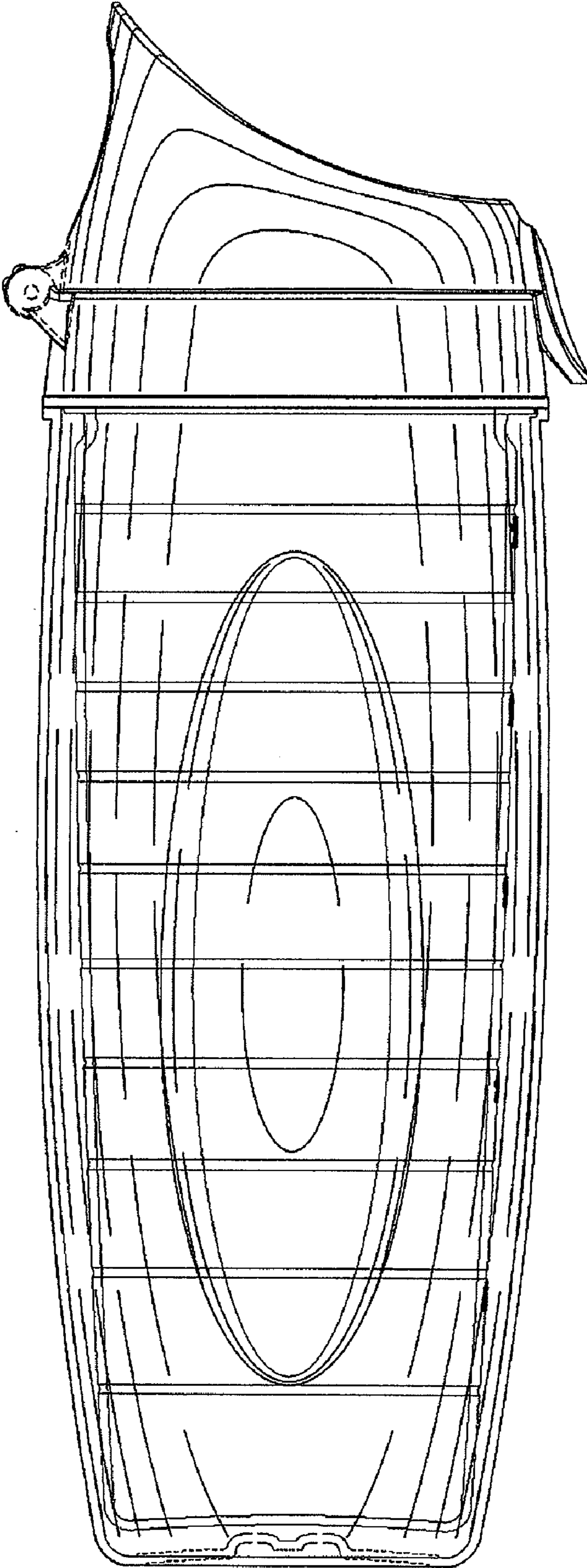

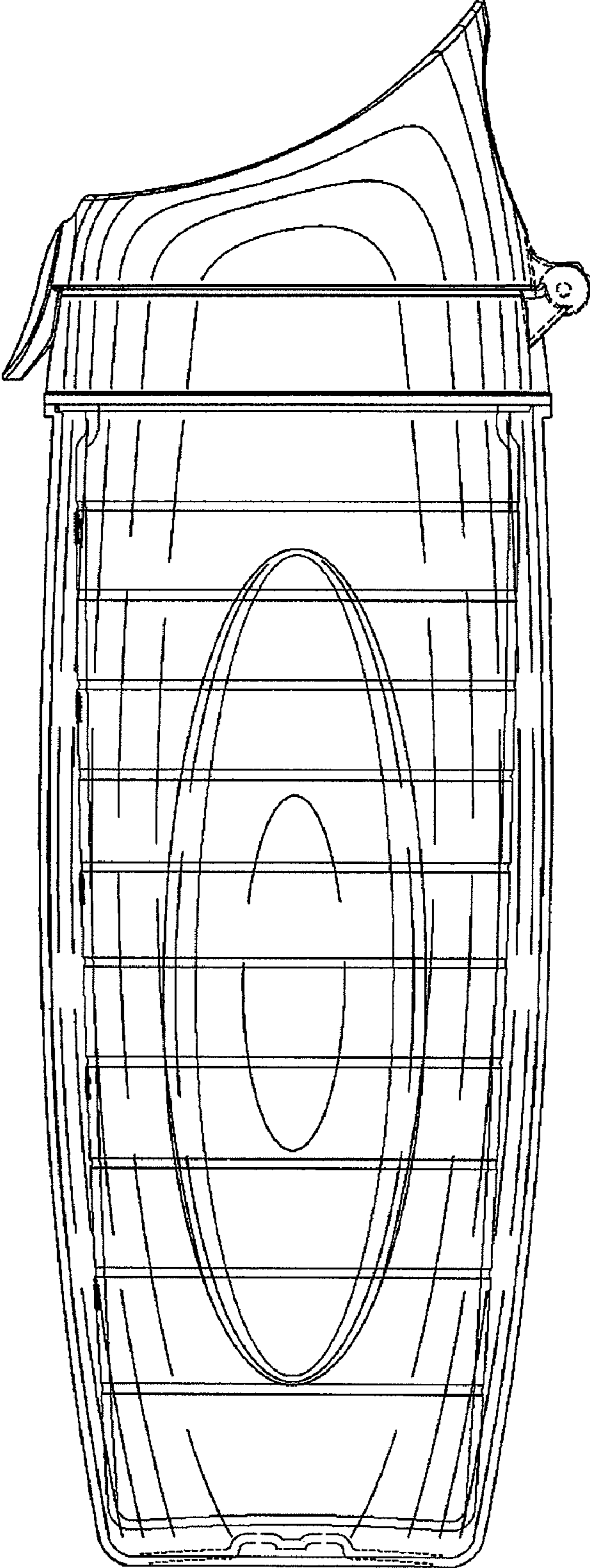

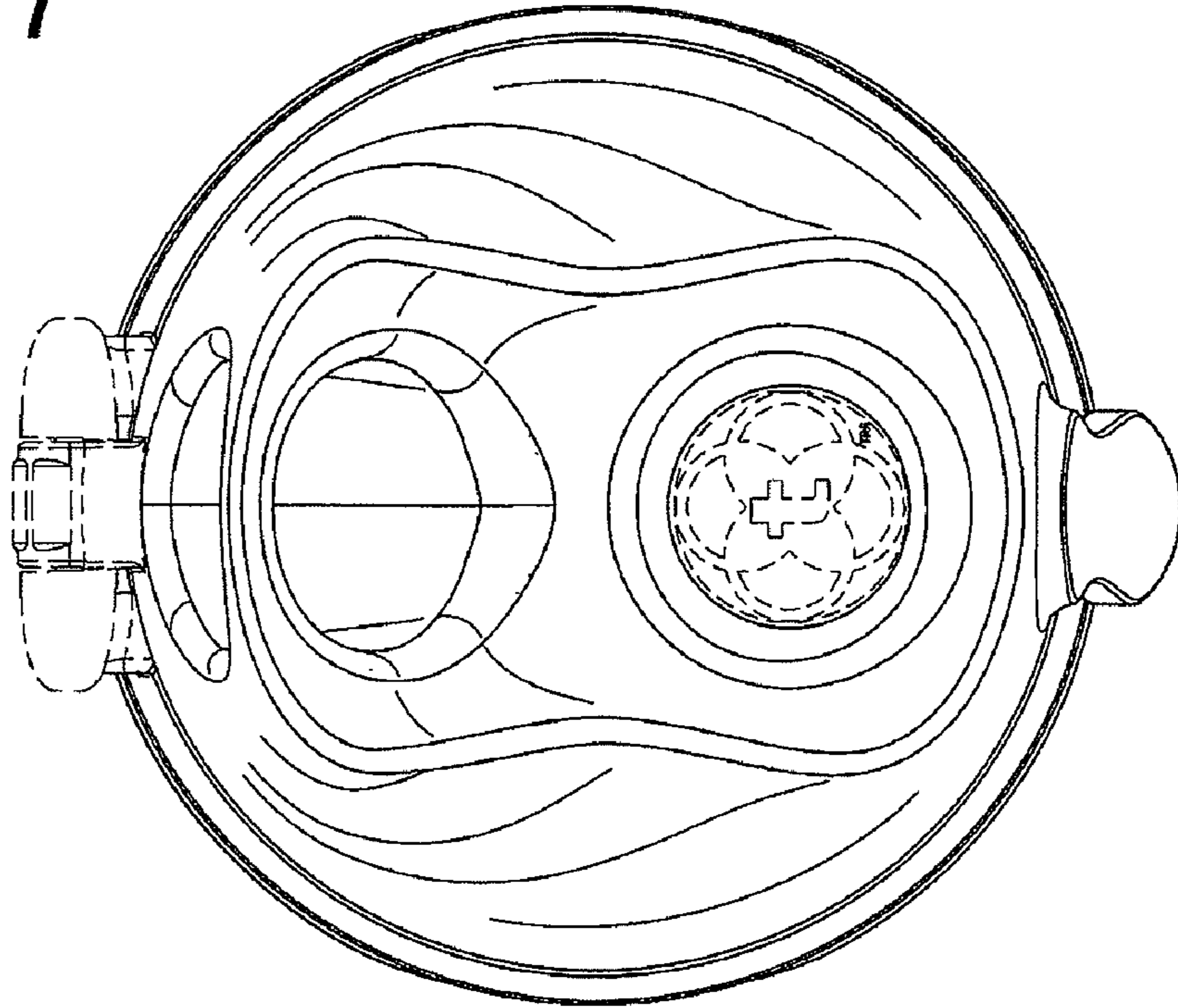
