The phantom lines showing environment are for illustrative purposes only.

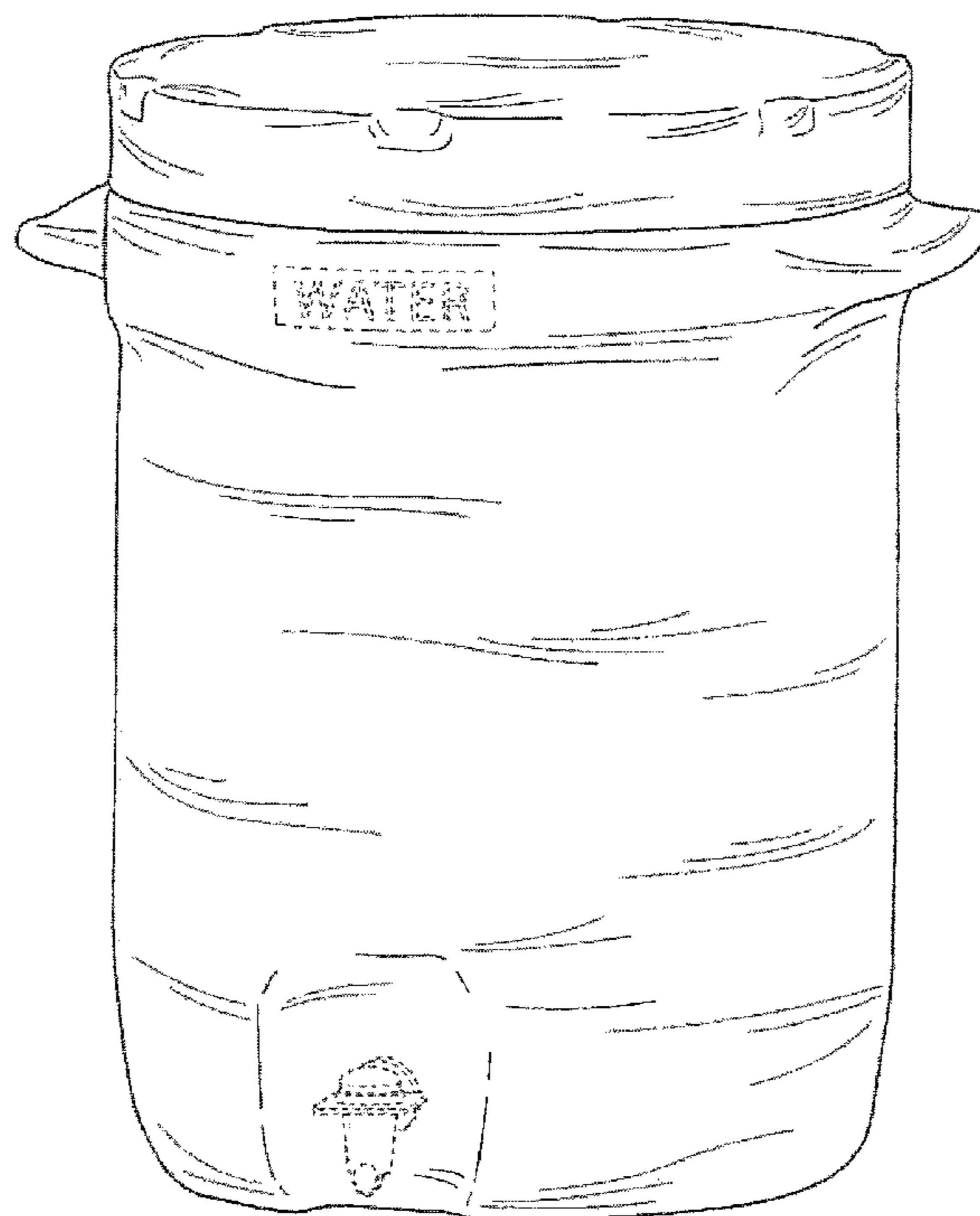

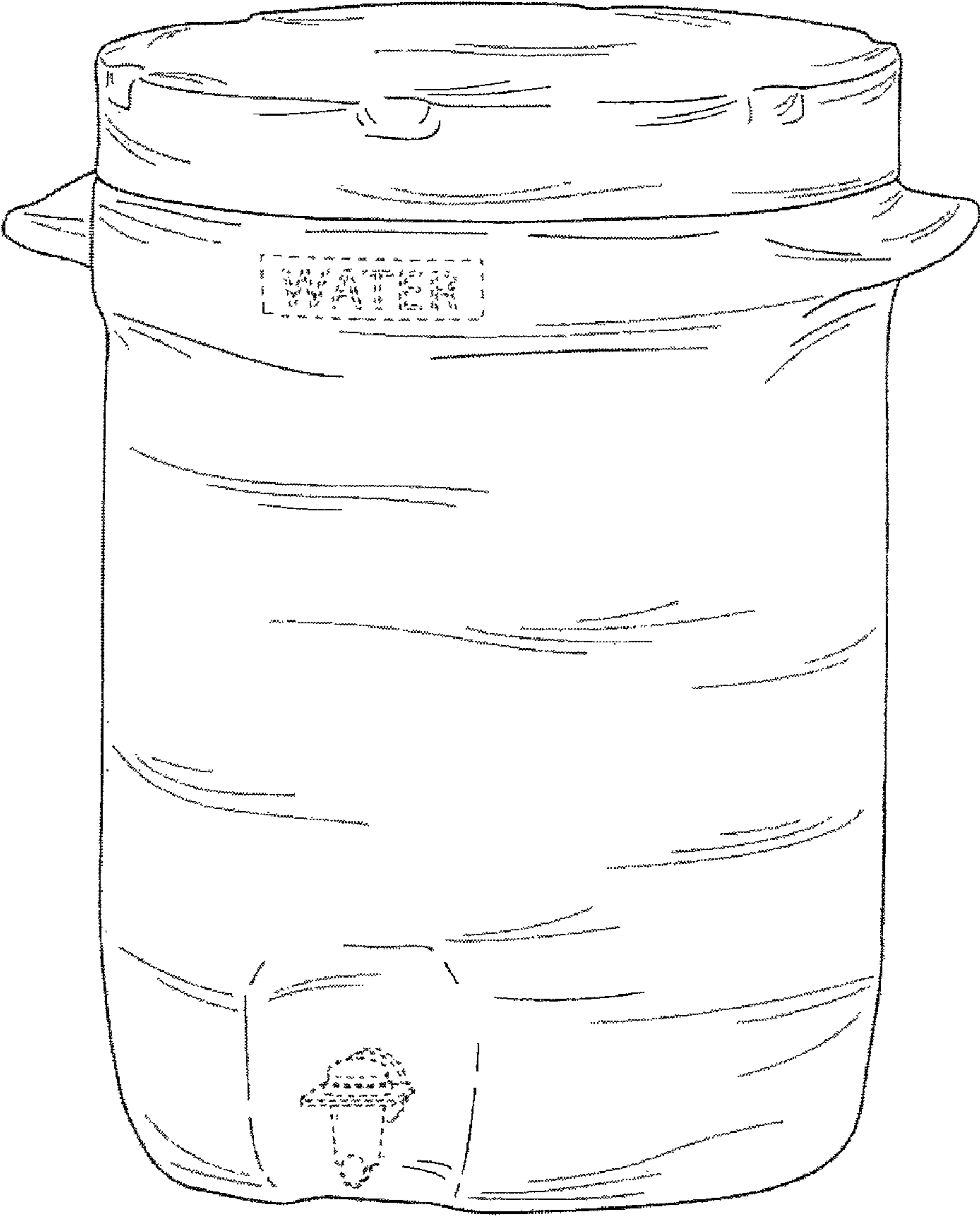

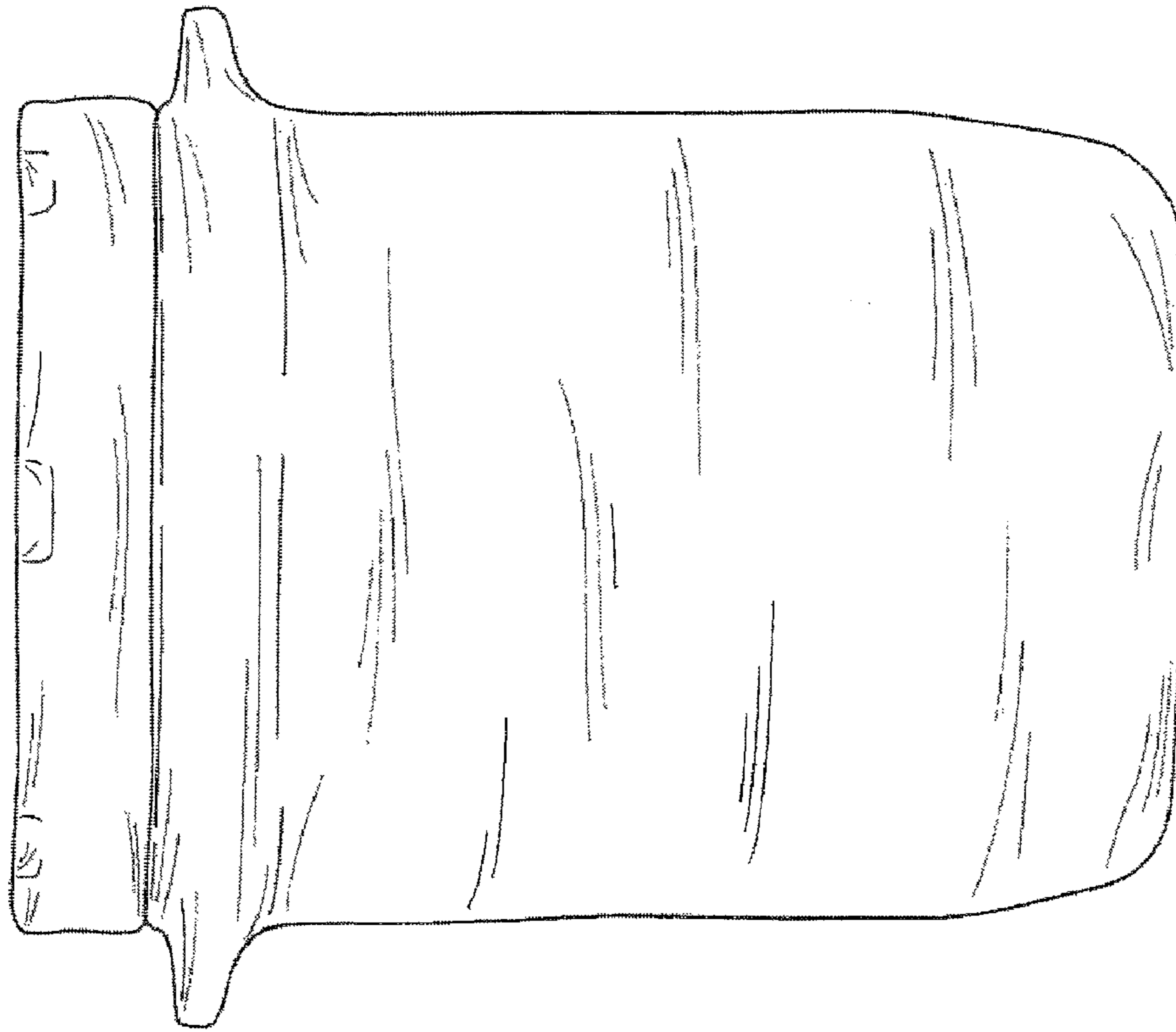

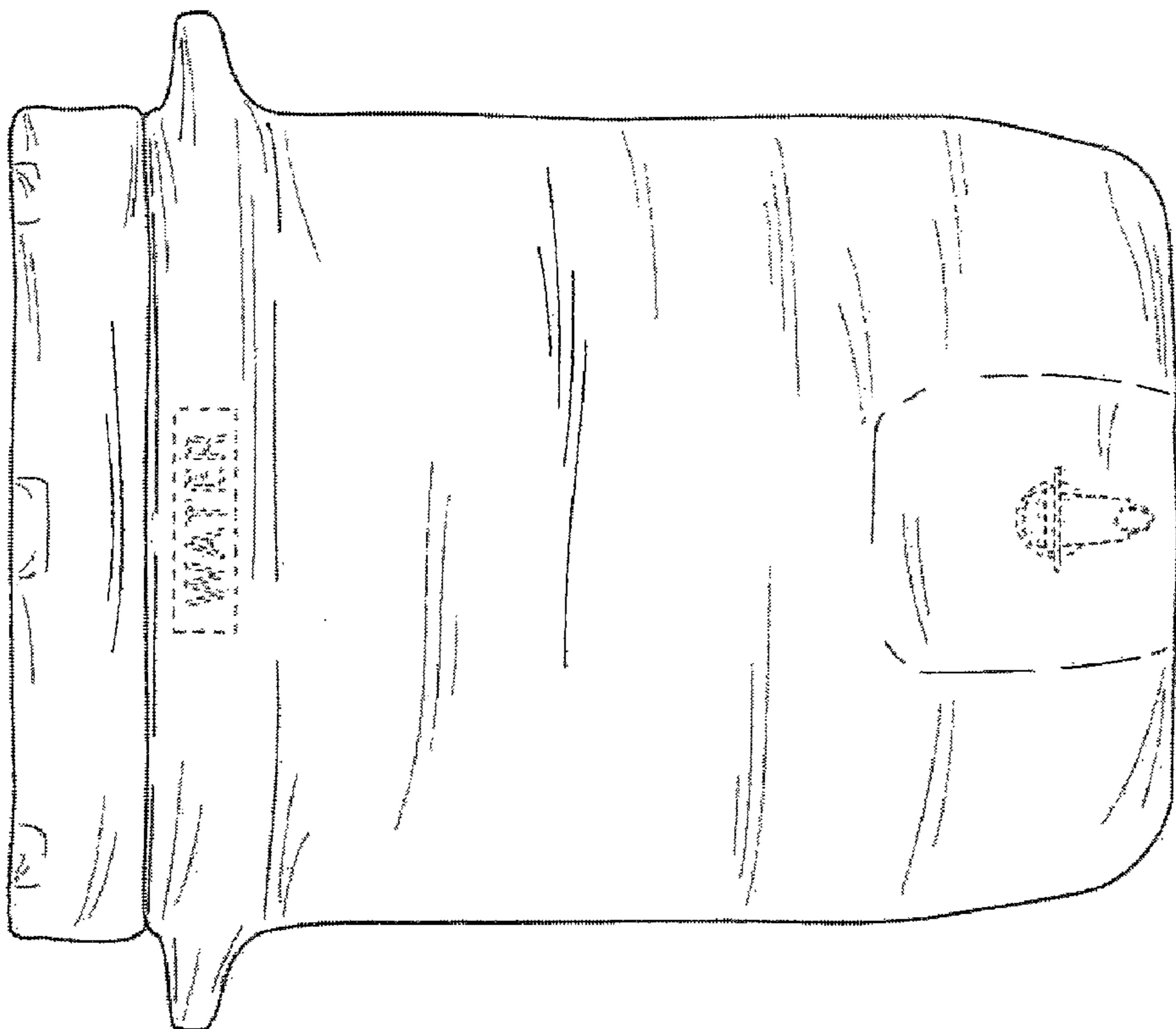

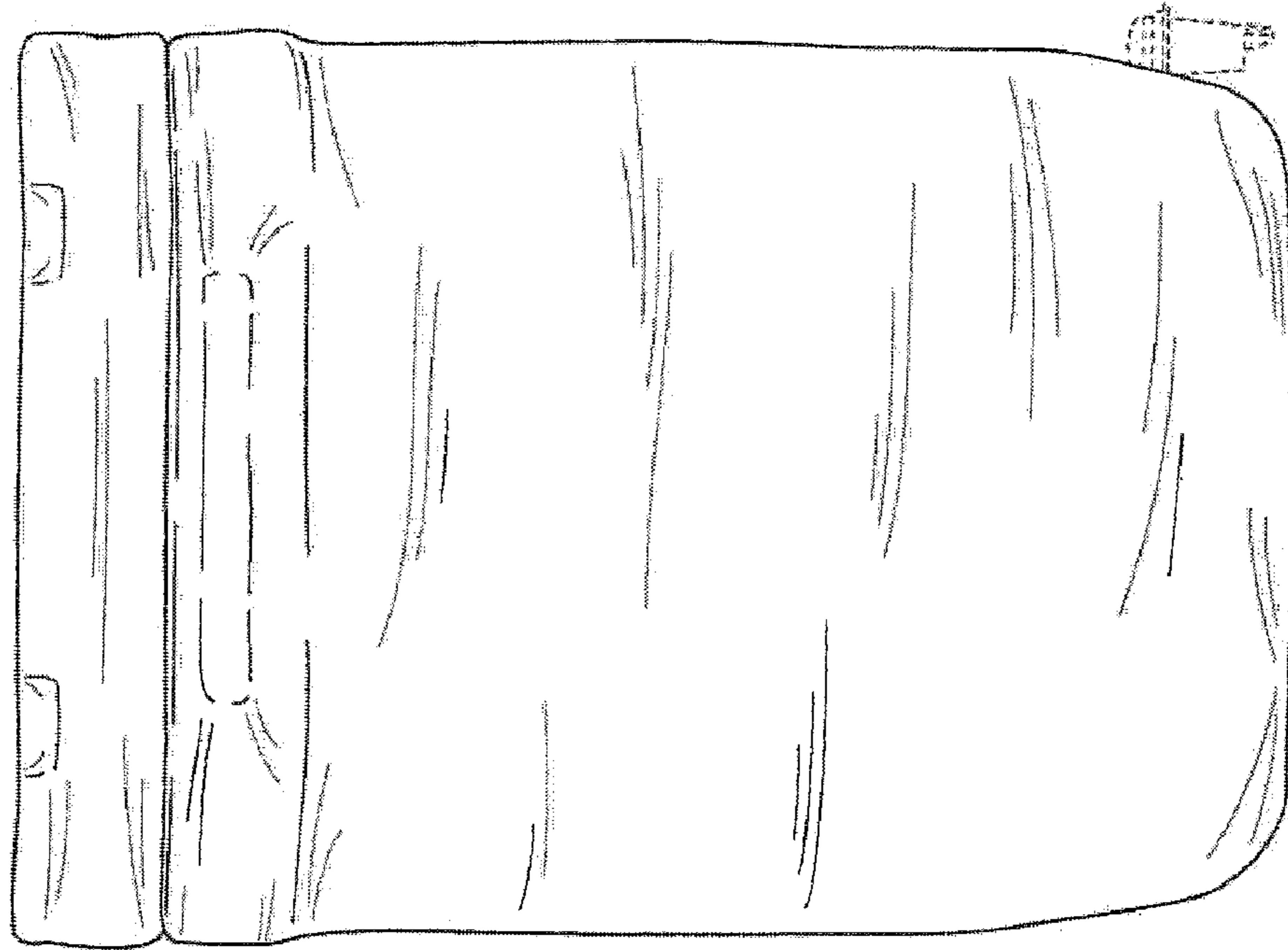

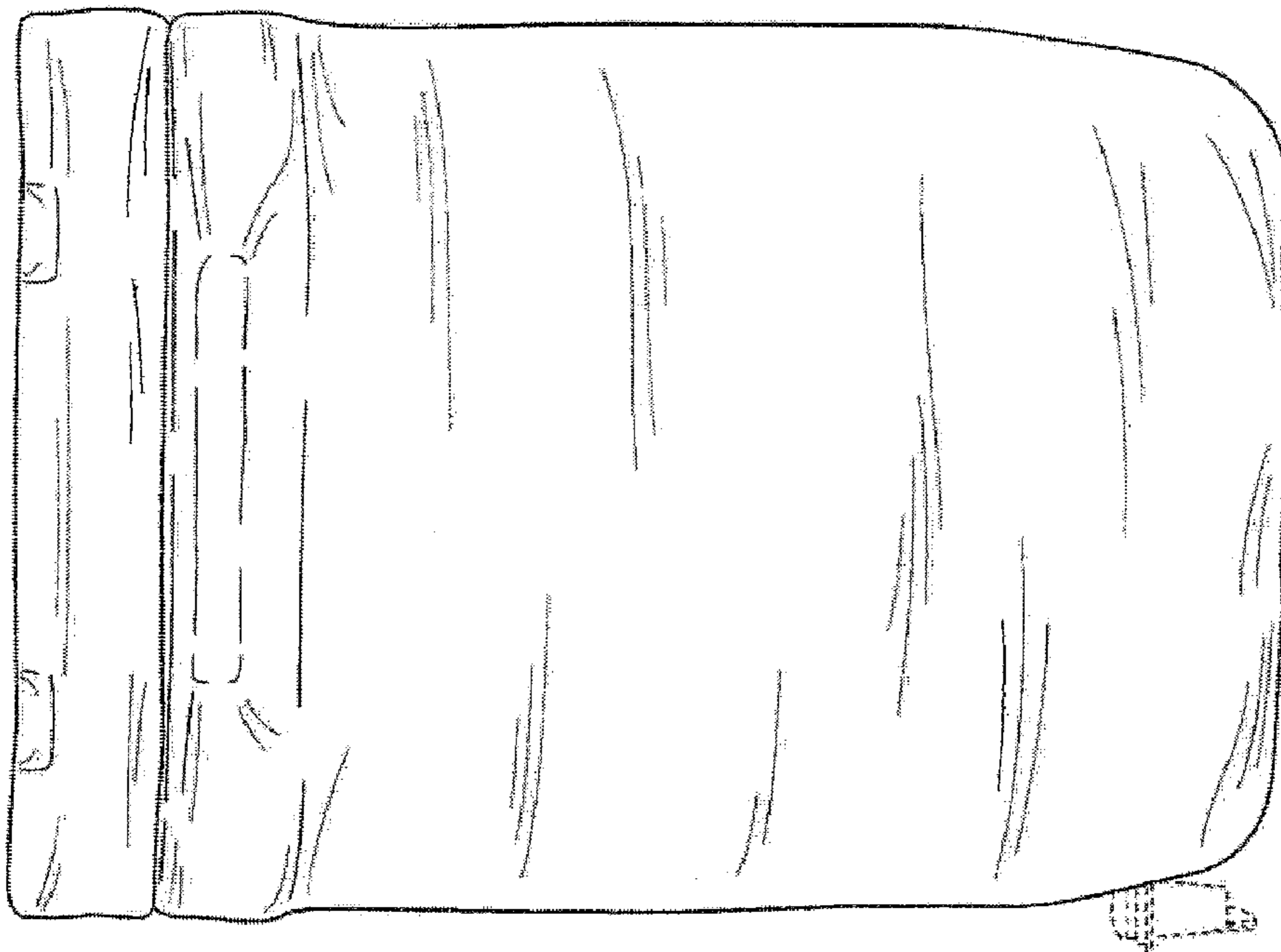

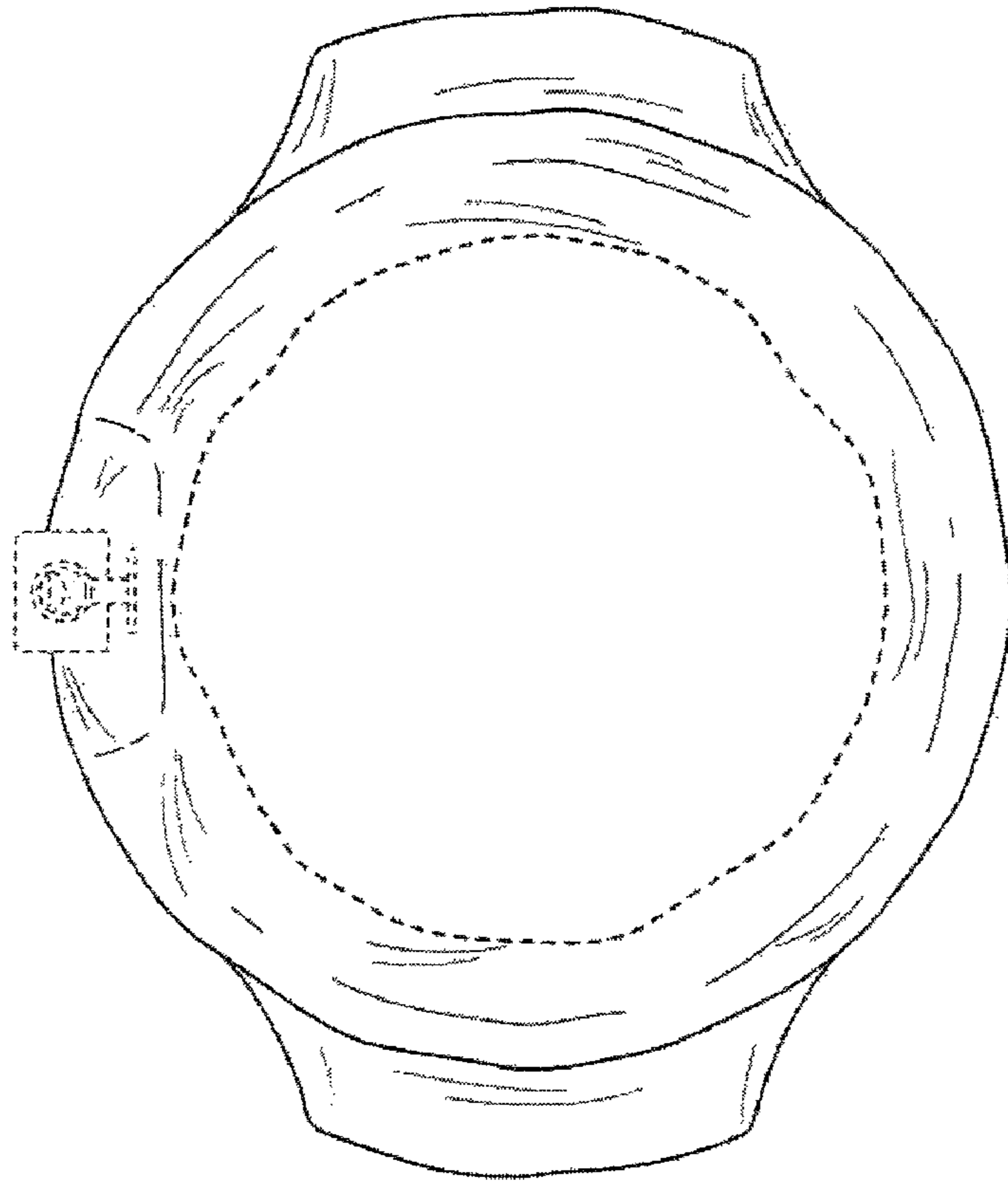

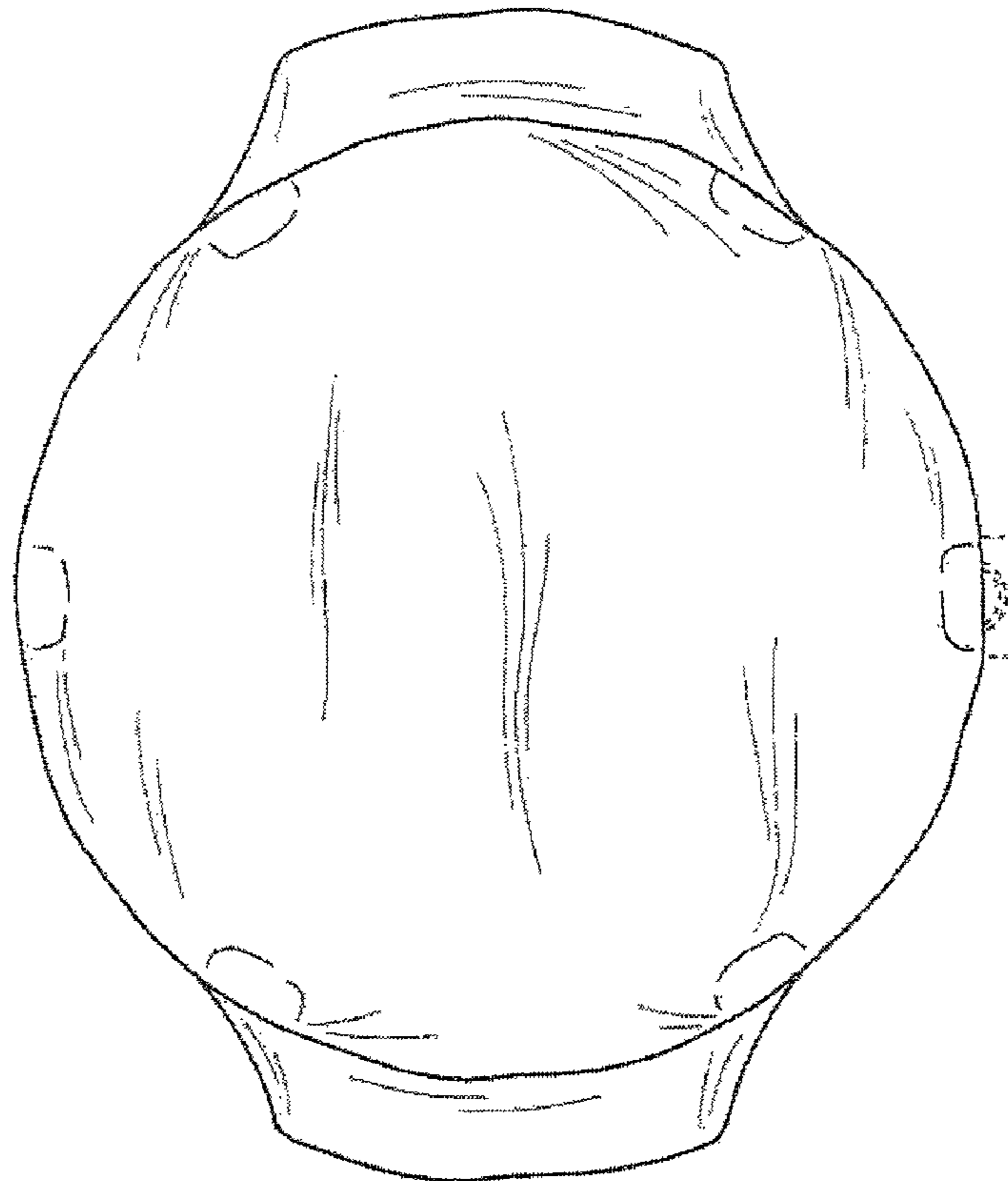

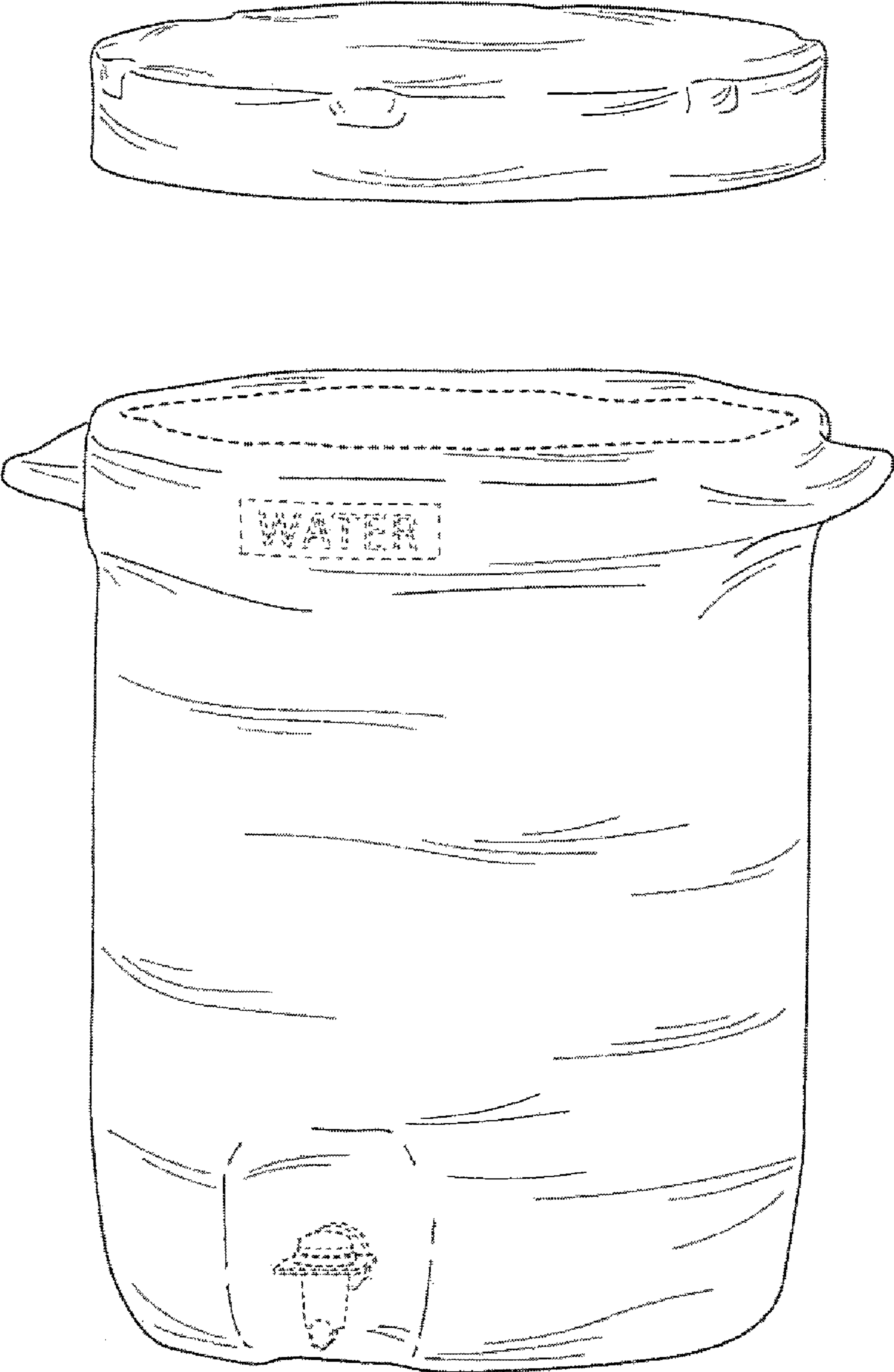
