**DESCRIPTION**

FIG. 1 is a front elevational view of a bottle holder showing my new design;  
FIG. 2 is a side elevational view of the left side thereof;

FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof; and,

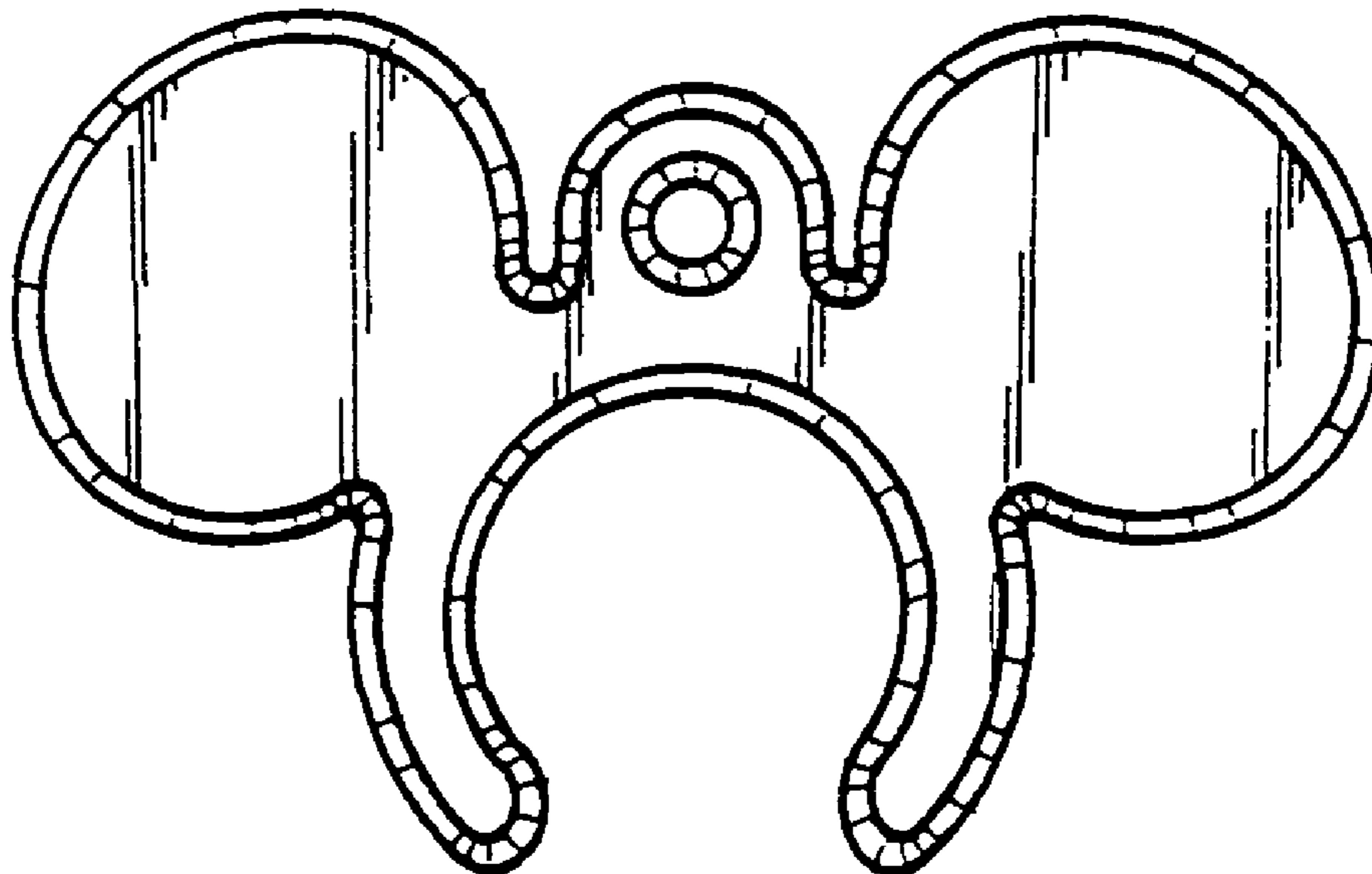

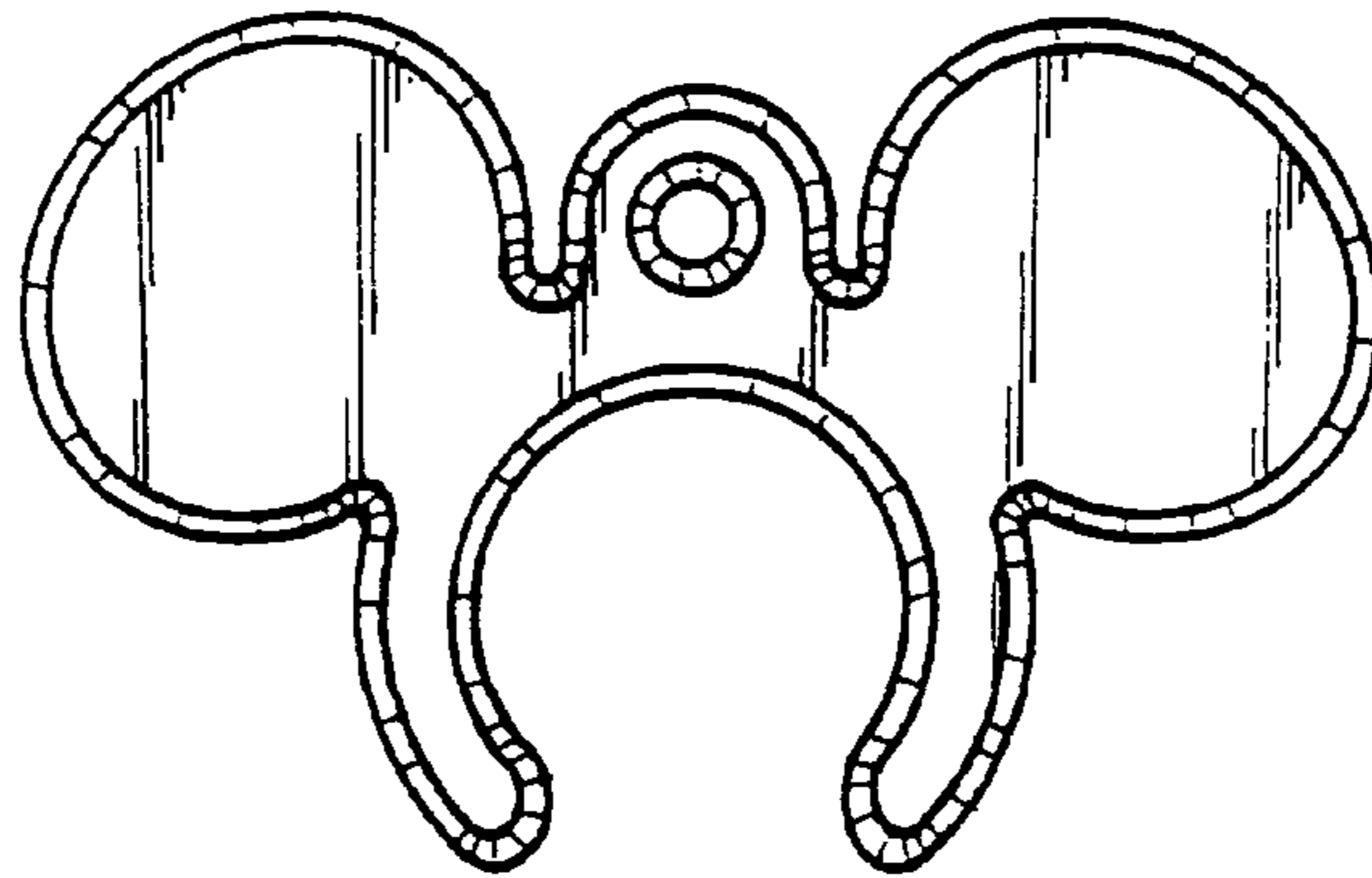

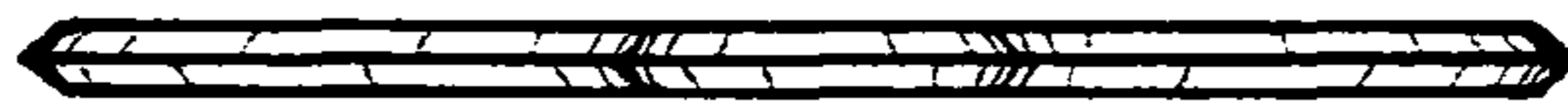

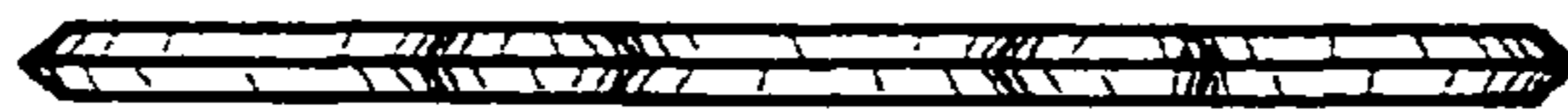

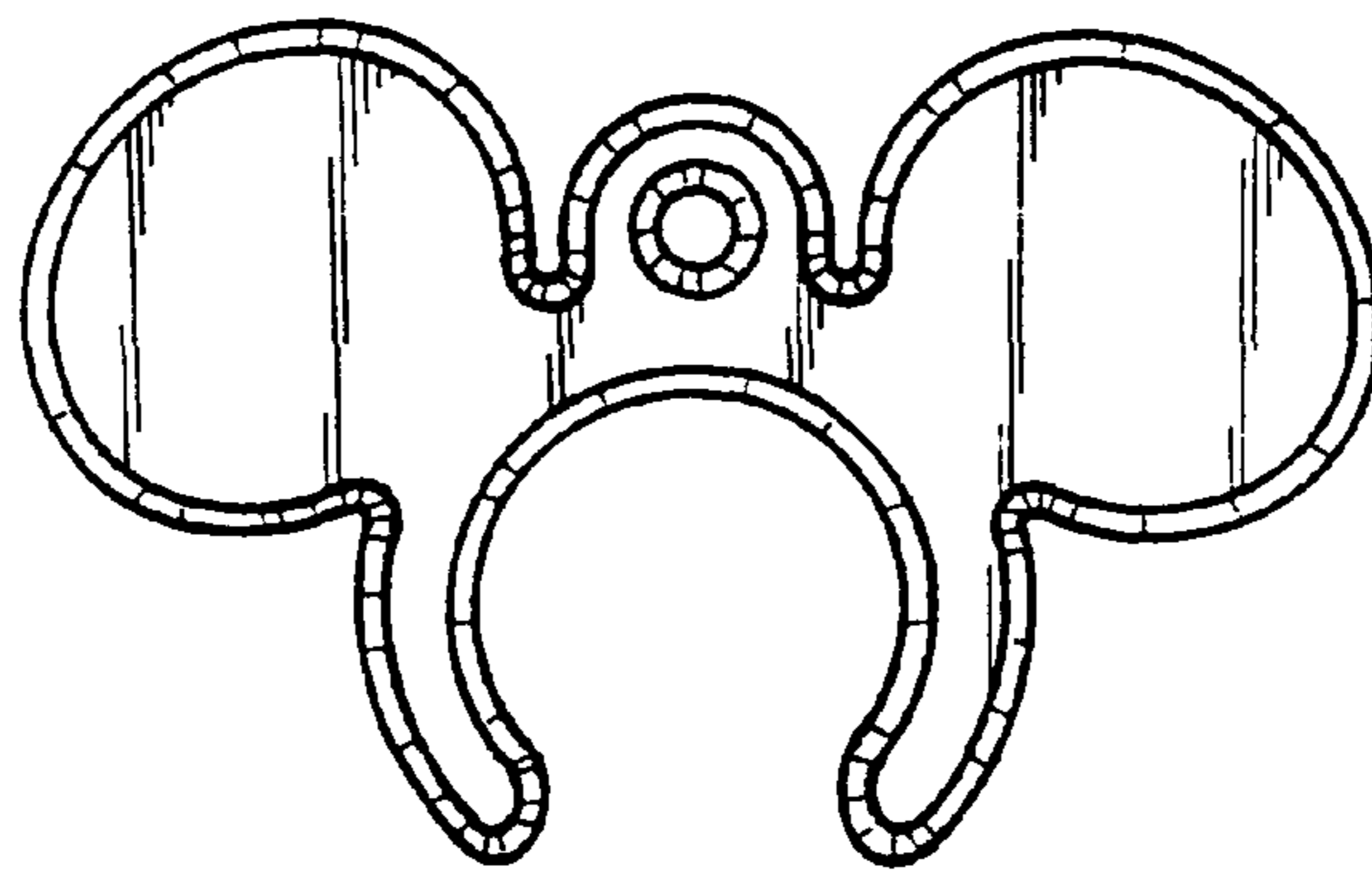
