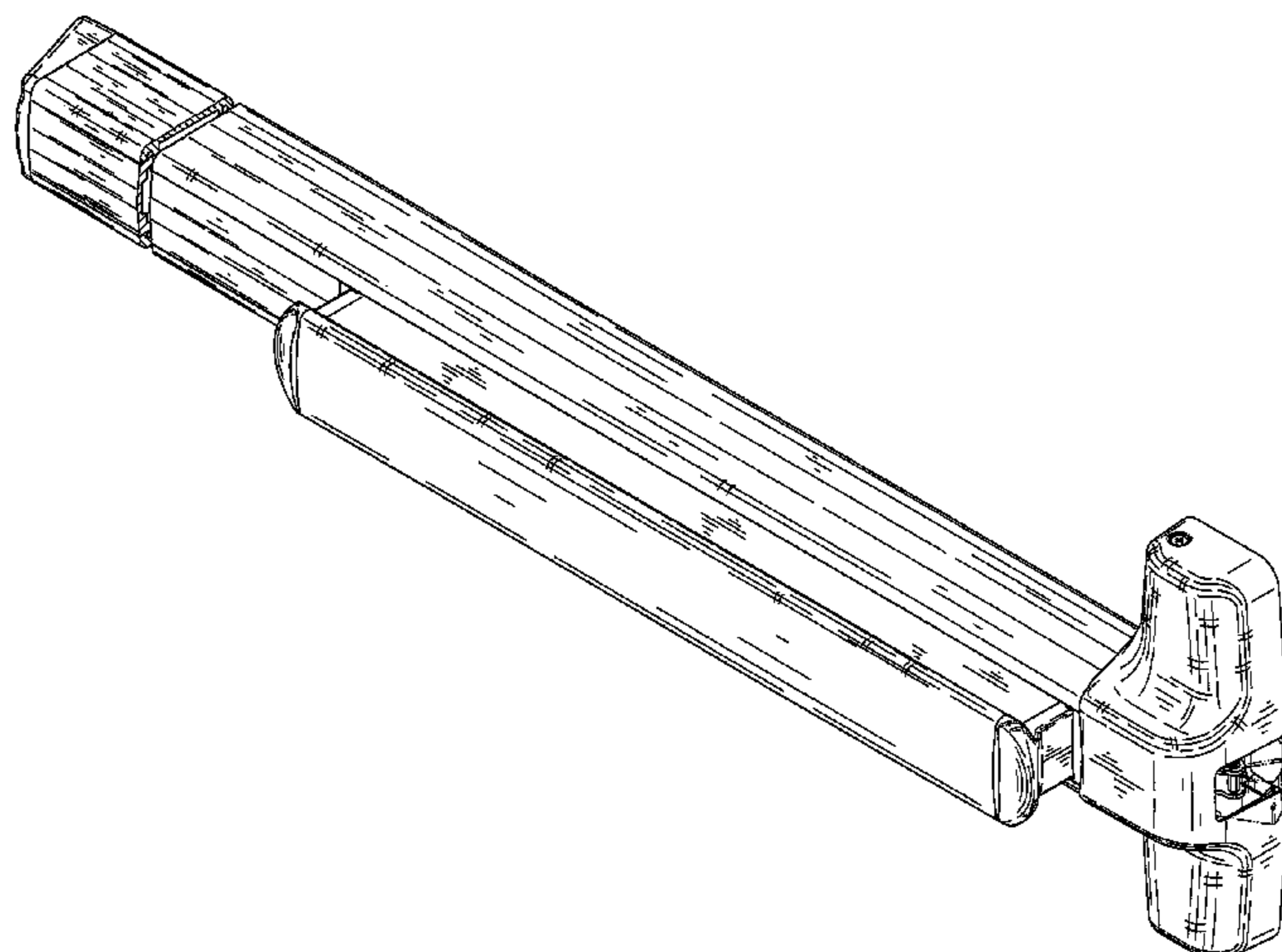
(57) **CLAIM**

The ornamental design for a passageway door lock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a passageway door lock showing my design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof, with the broken lines being for illustrative purposes only and forming no part of the claimed design;
FIG. 4 is a left elevational view thereof;
FIG. 5 is a right elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

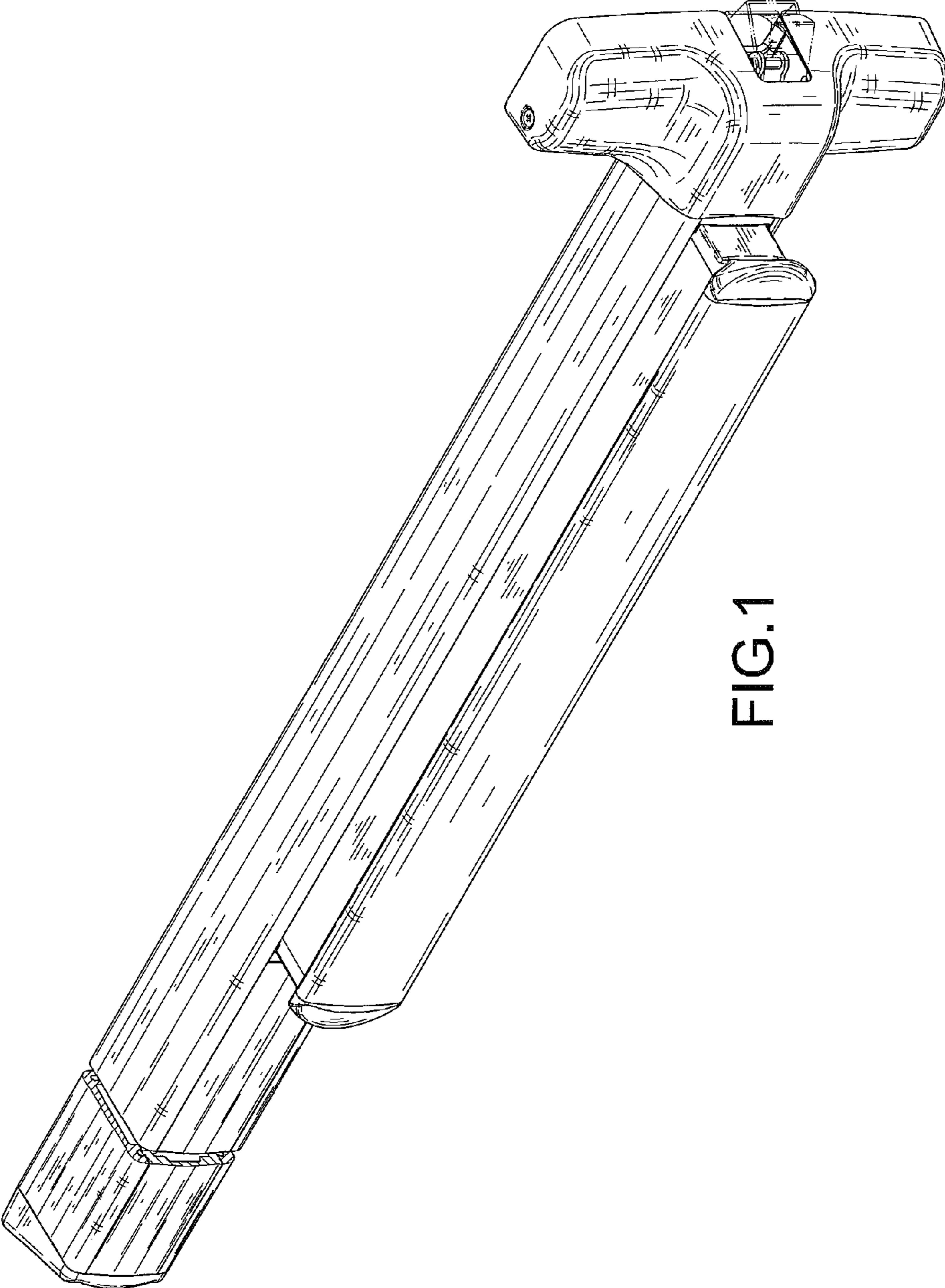

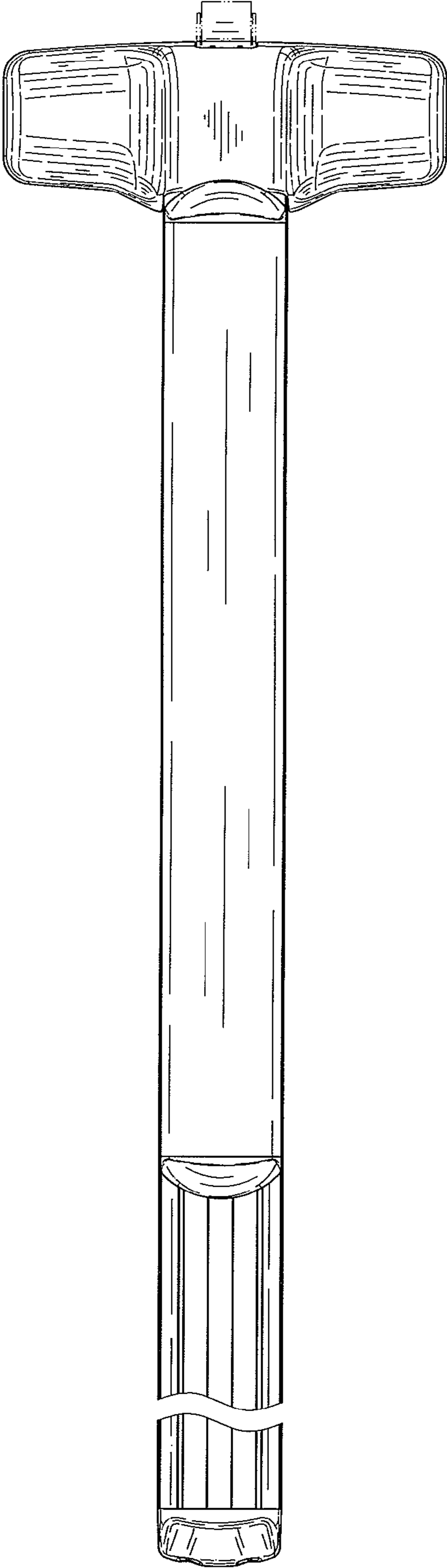

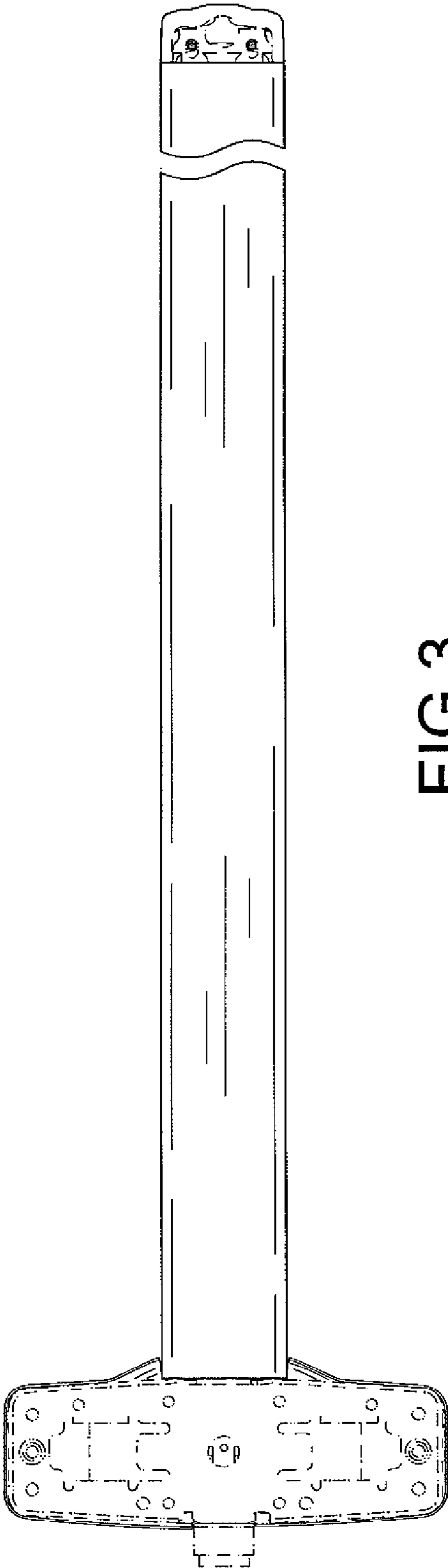

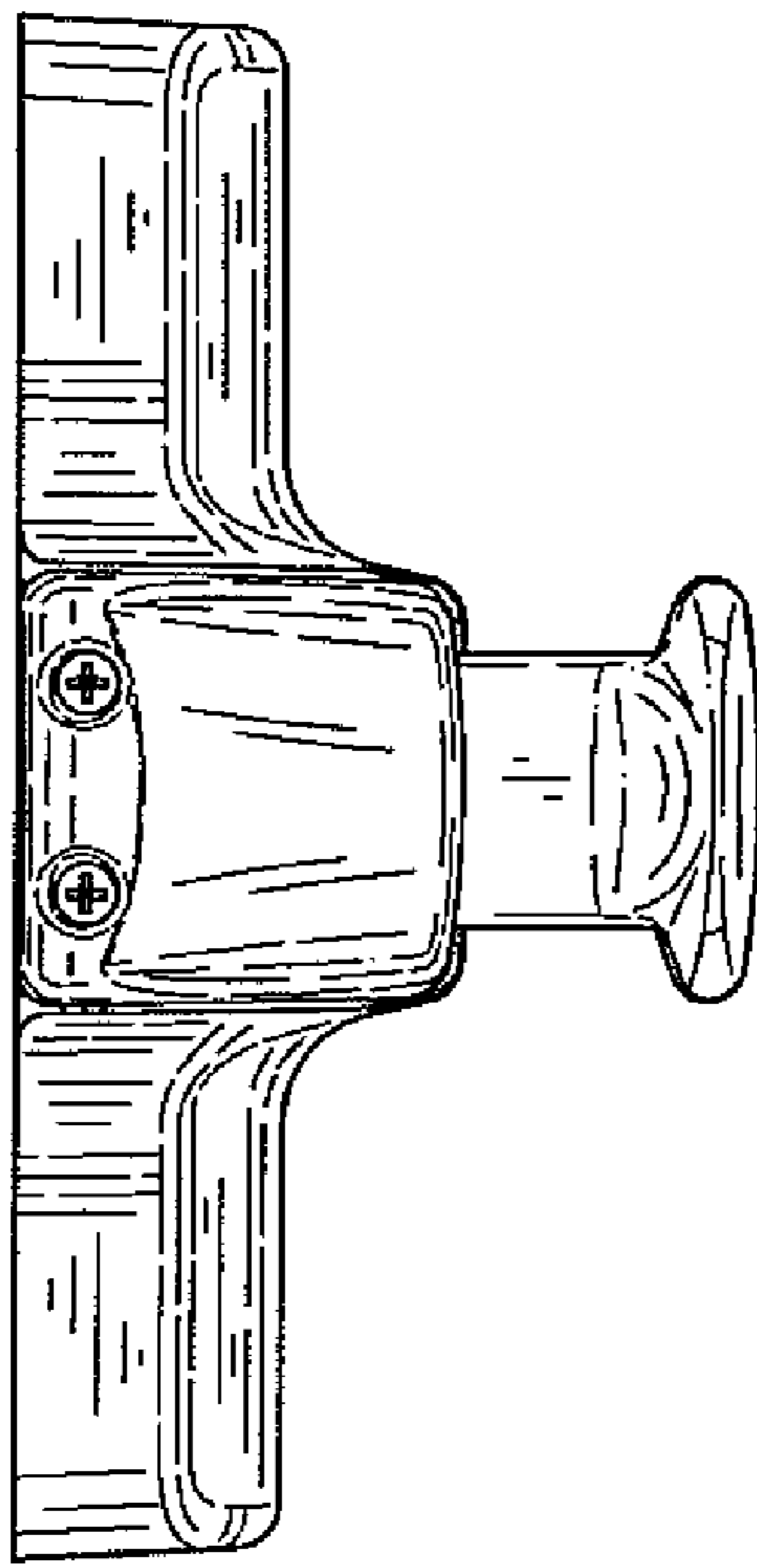

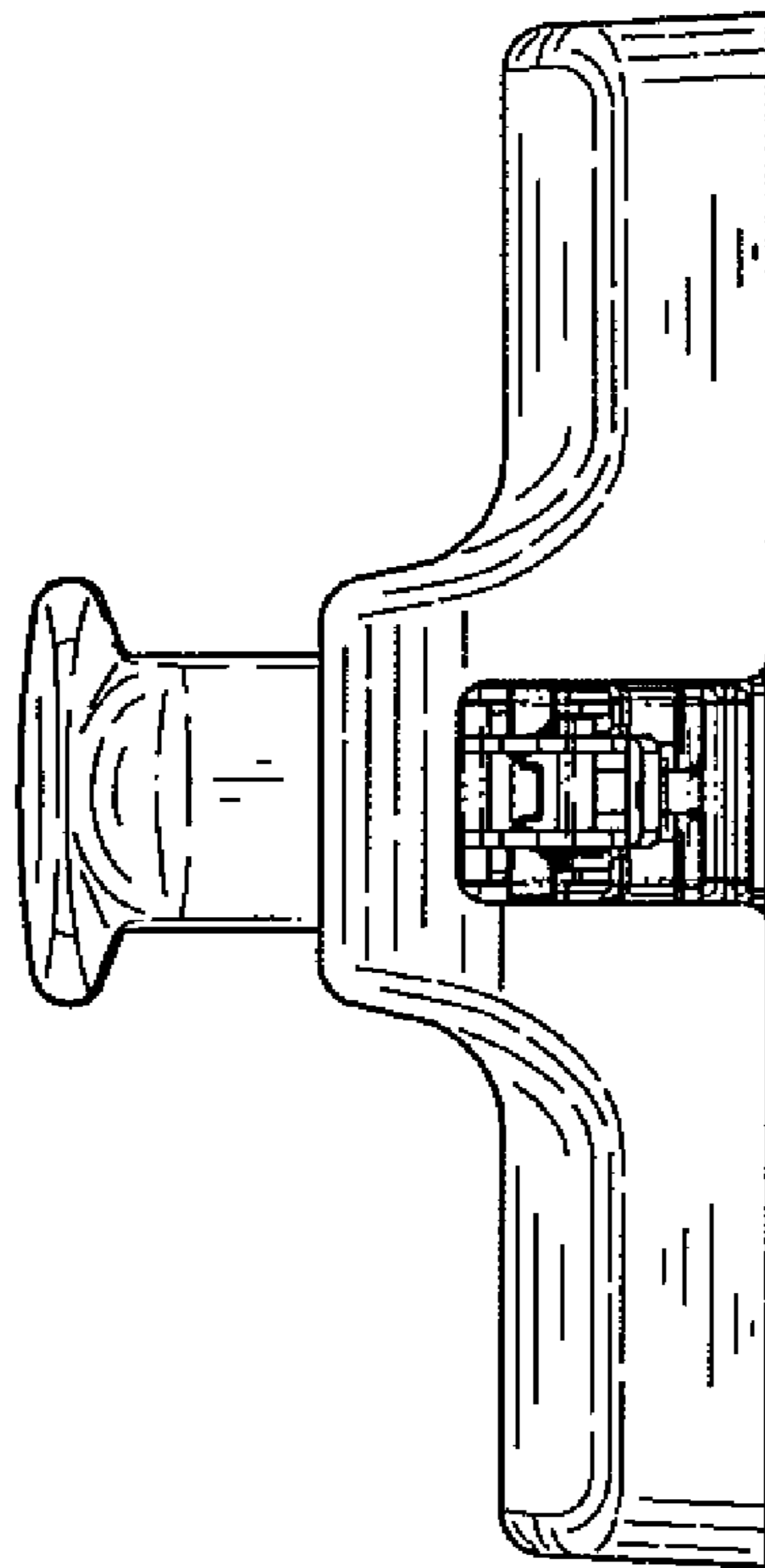

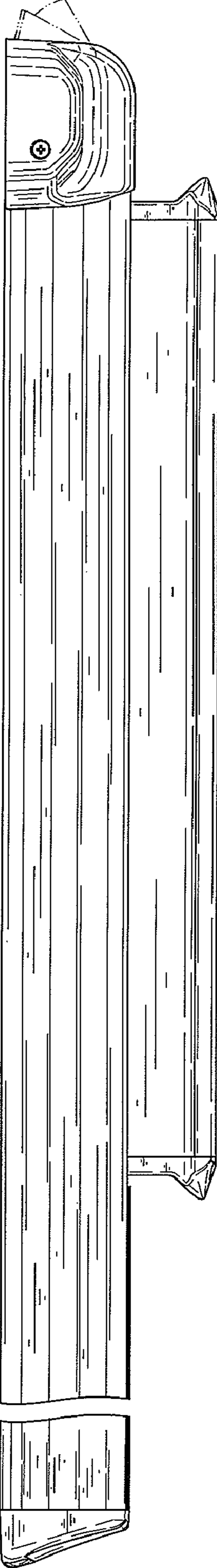

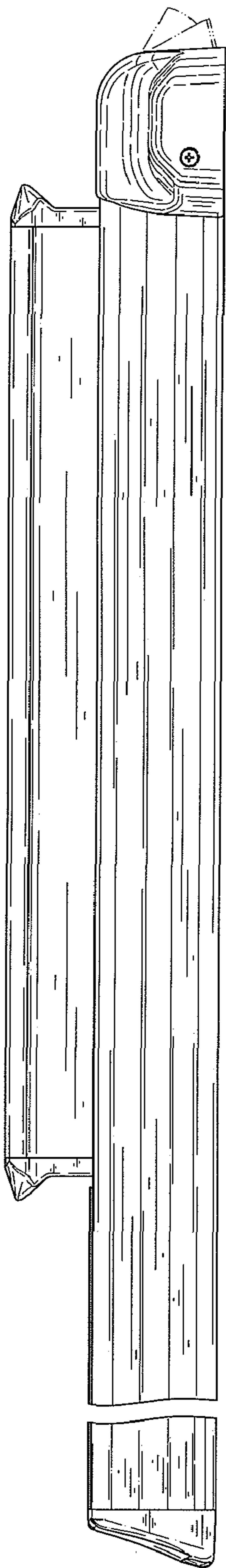
