(57) **CLAIM**

We claim the ornamental design for a LCD television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a LCD television receiver showing our new design;

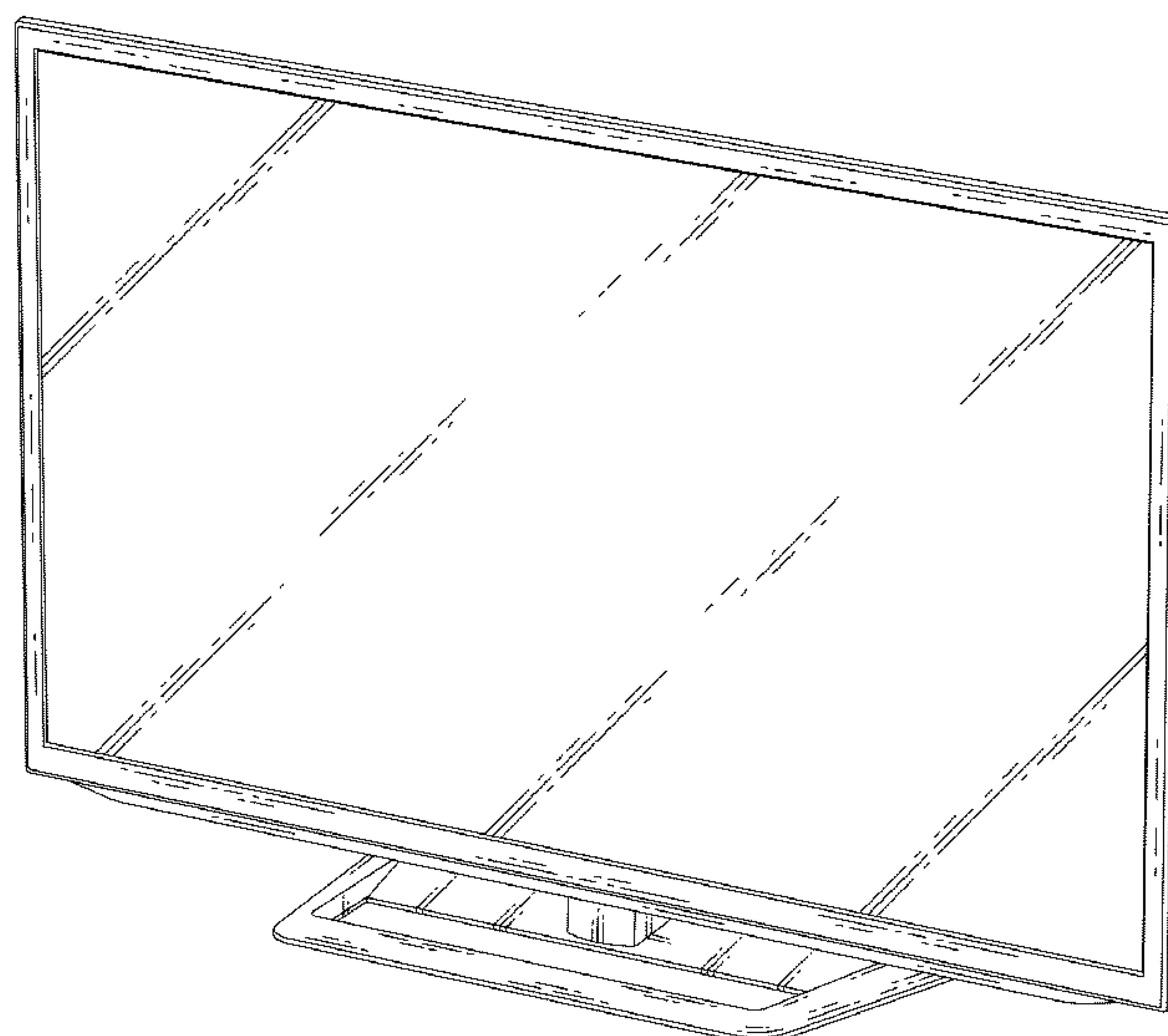

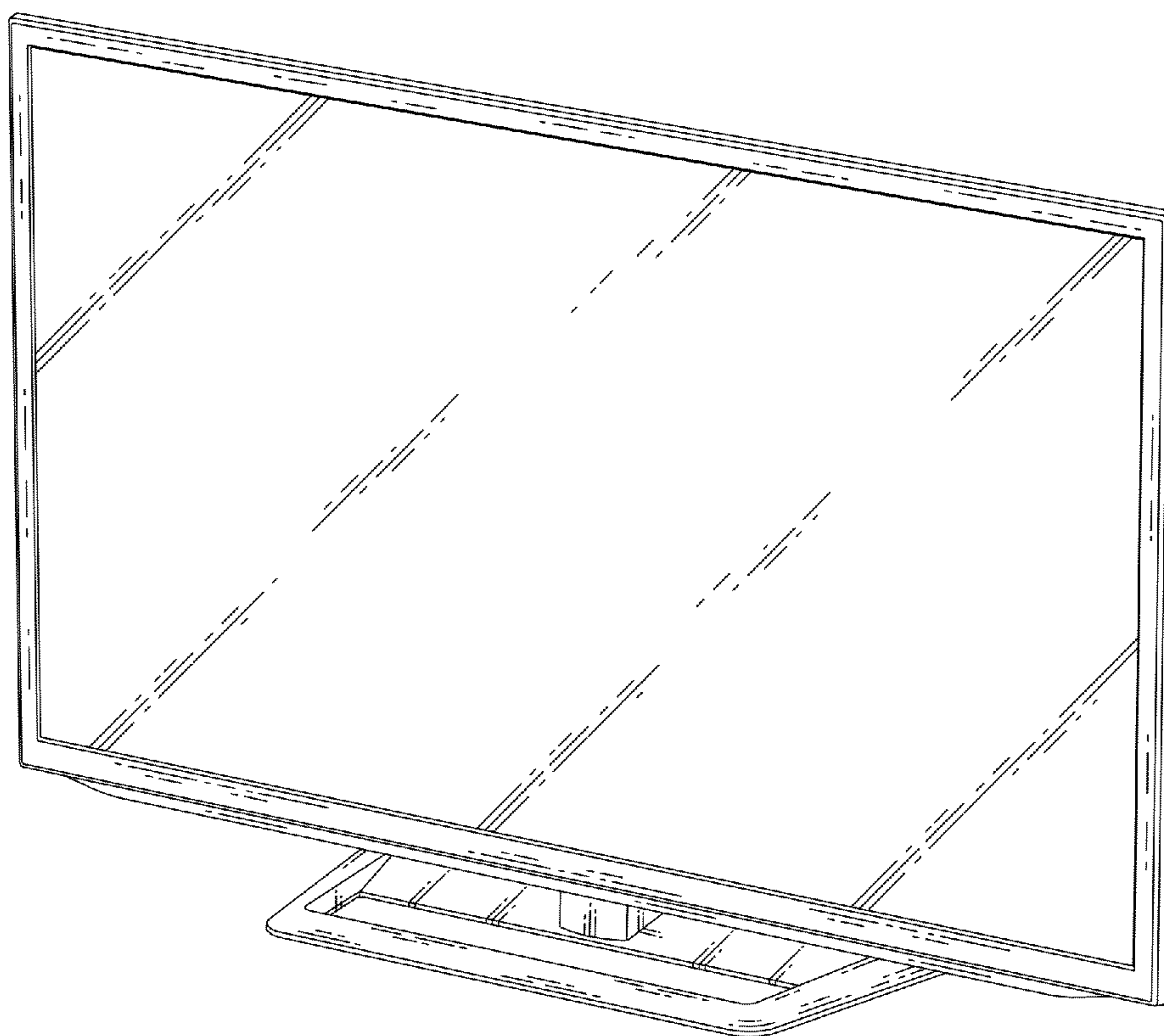

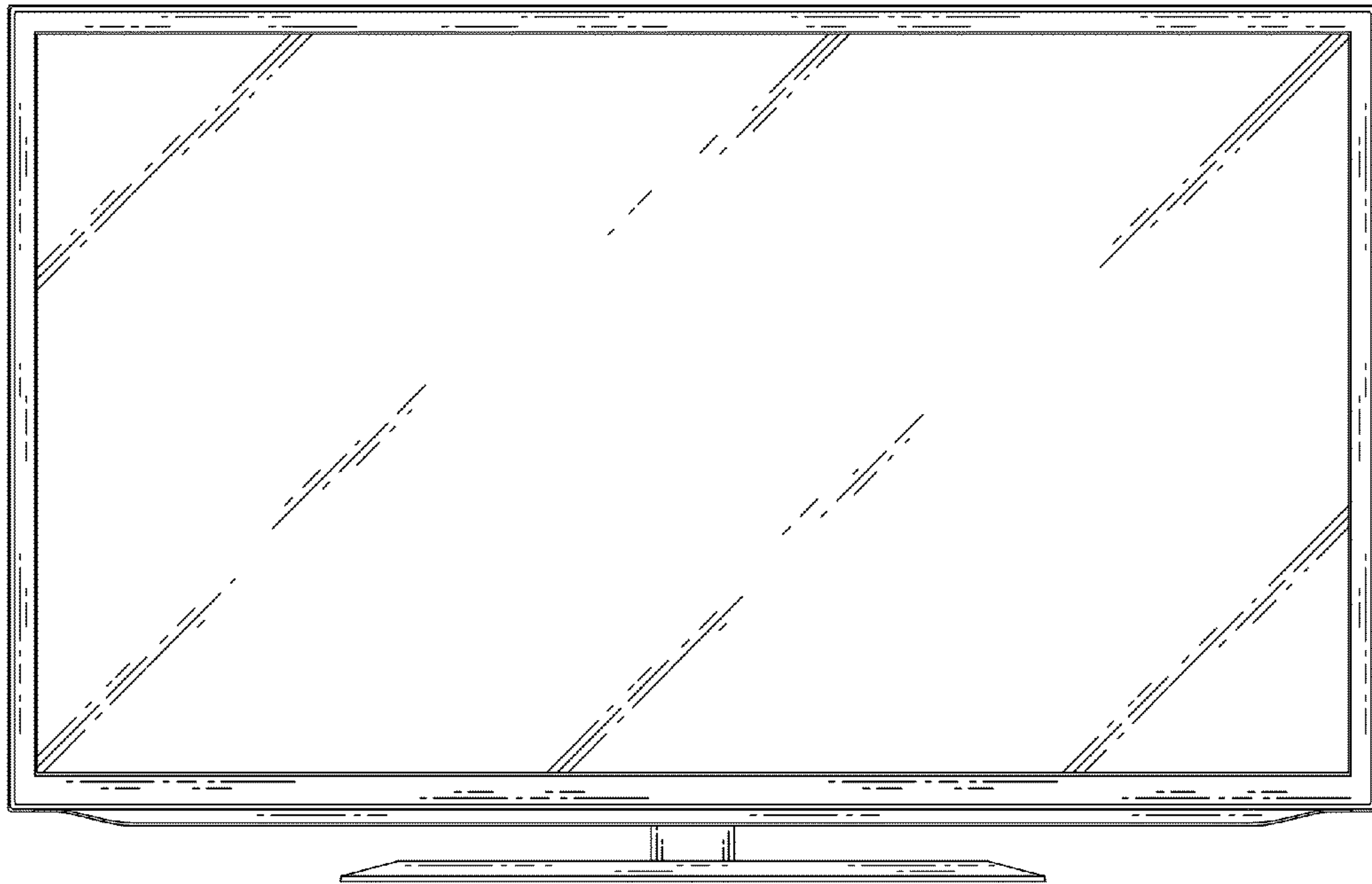

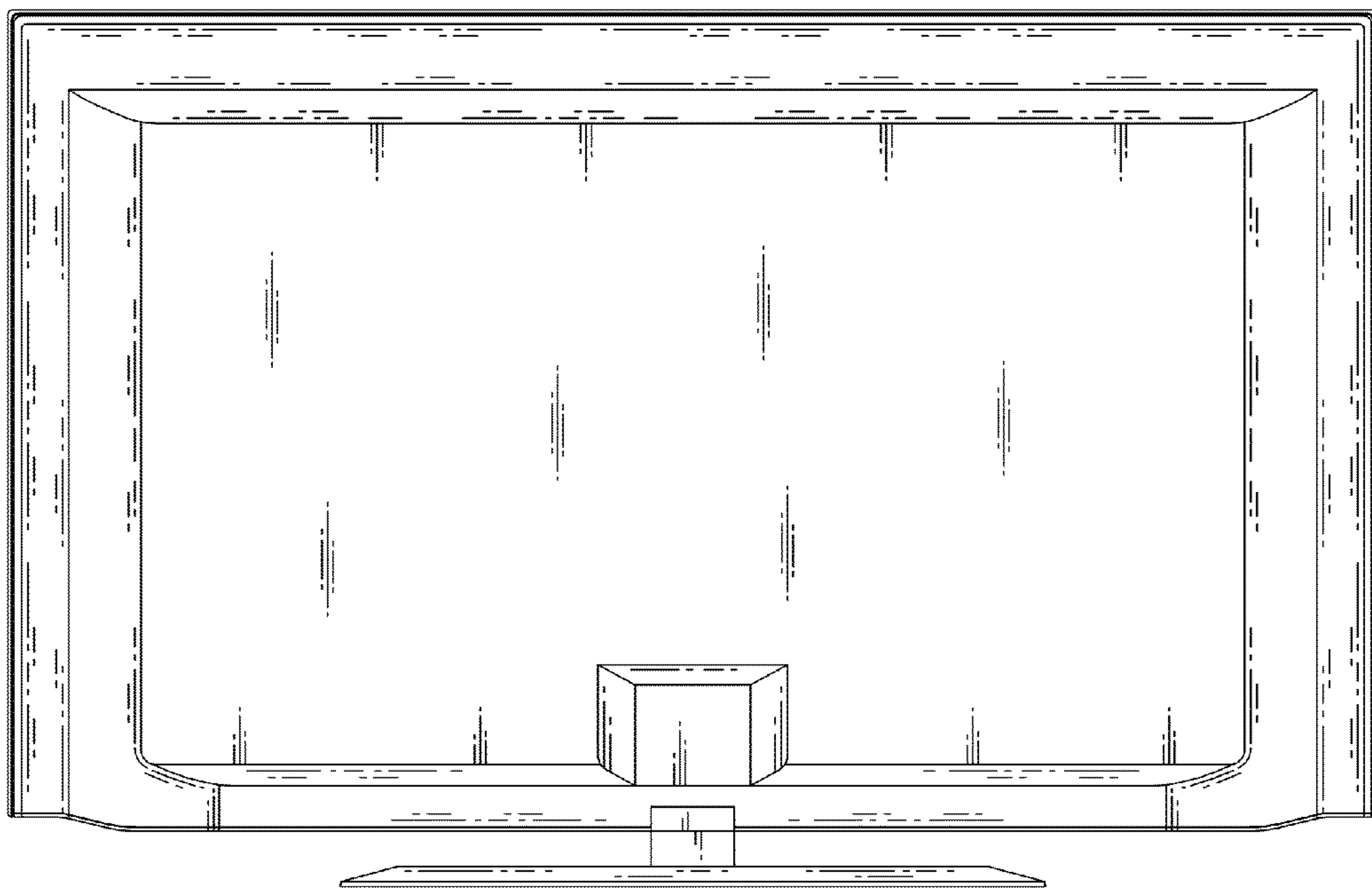

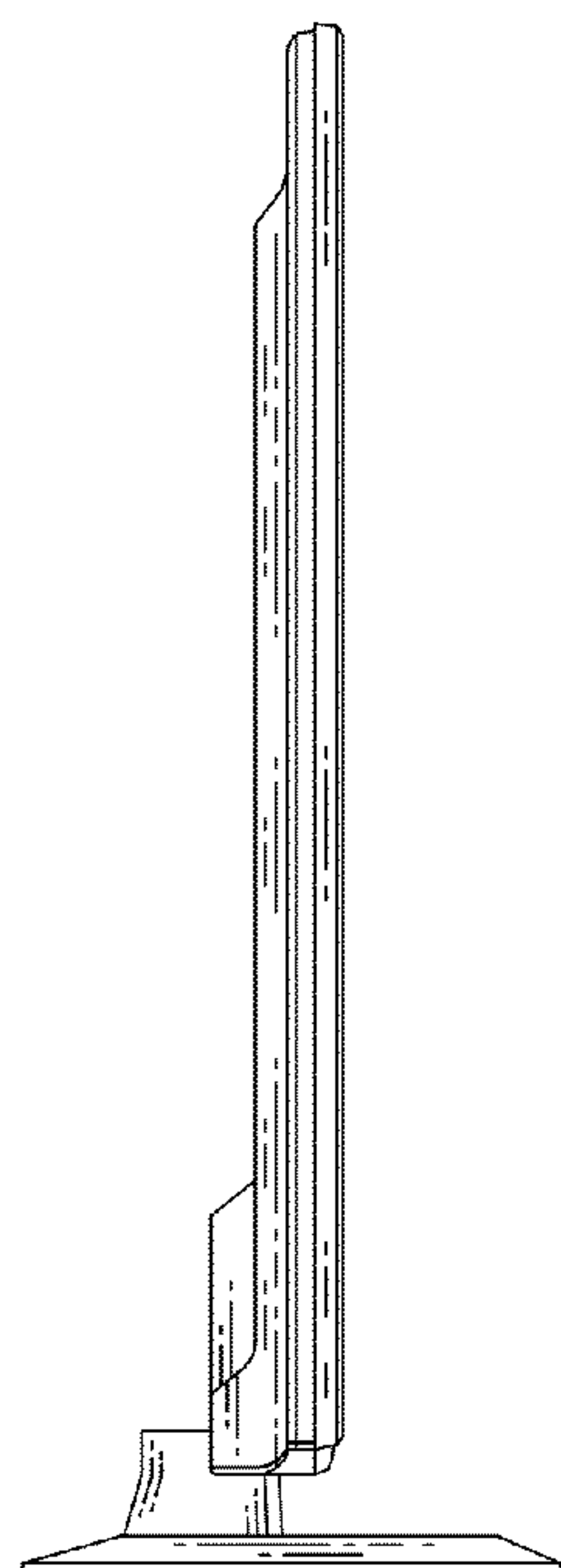

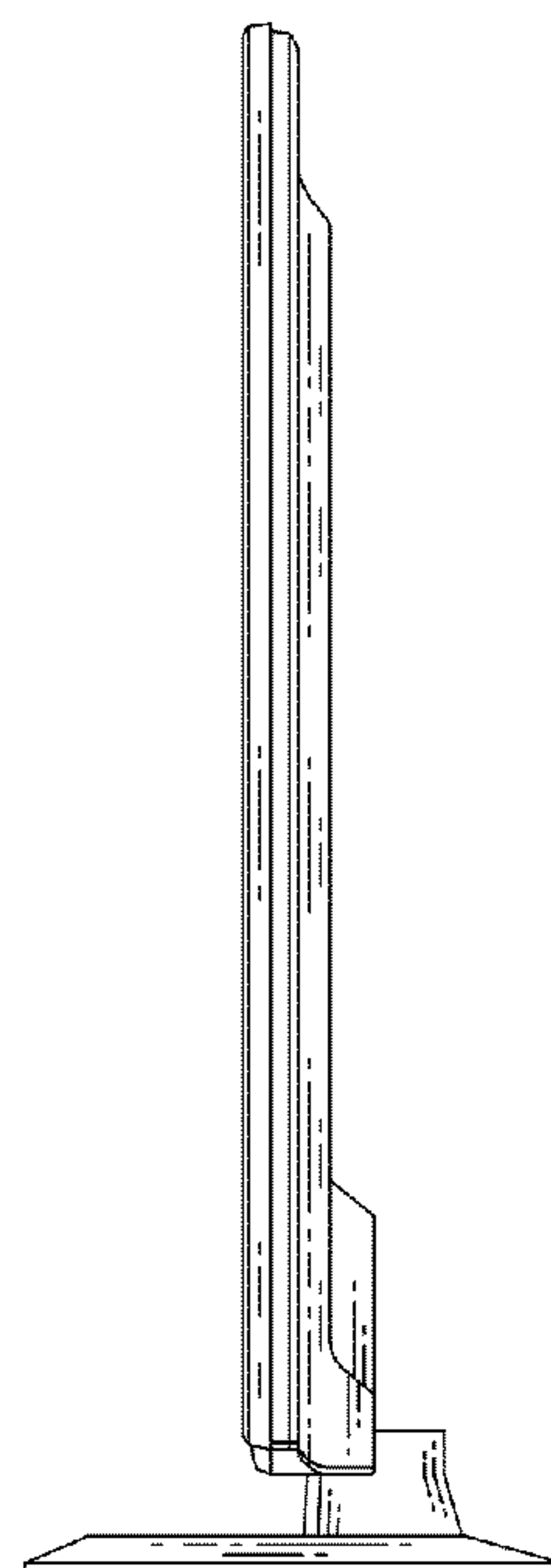

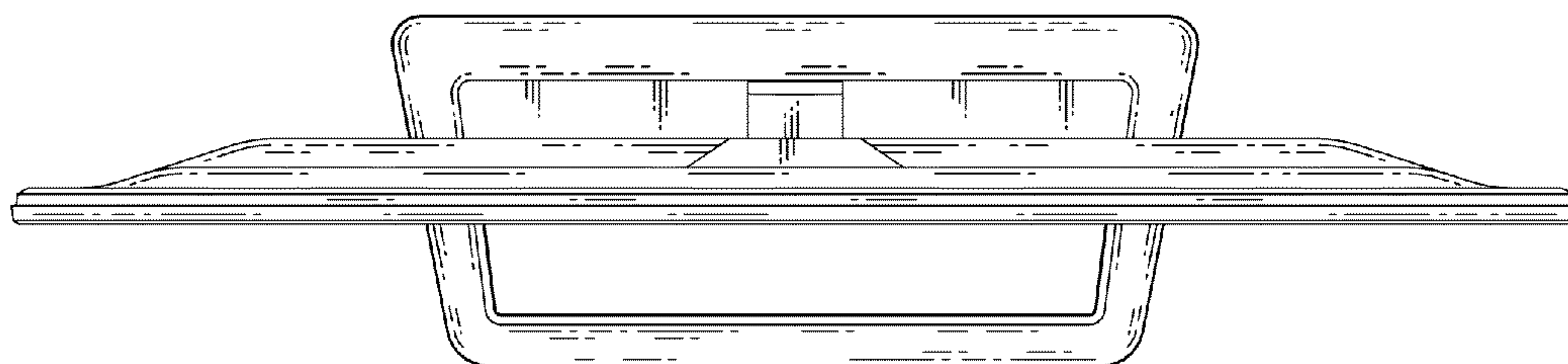
