We claim the ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone showing our new design:

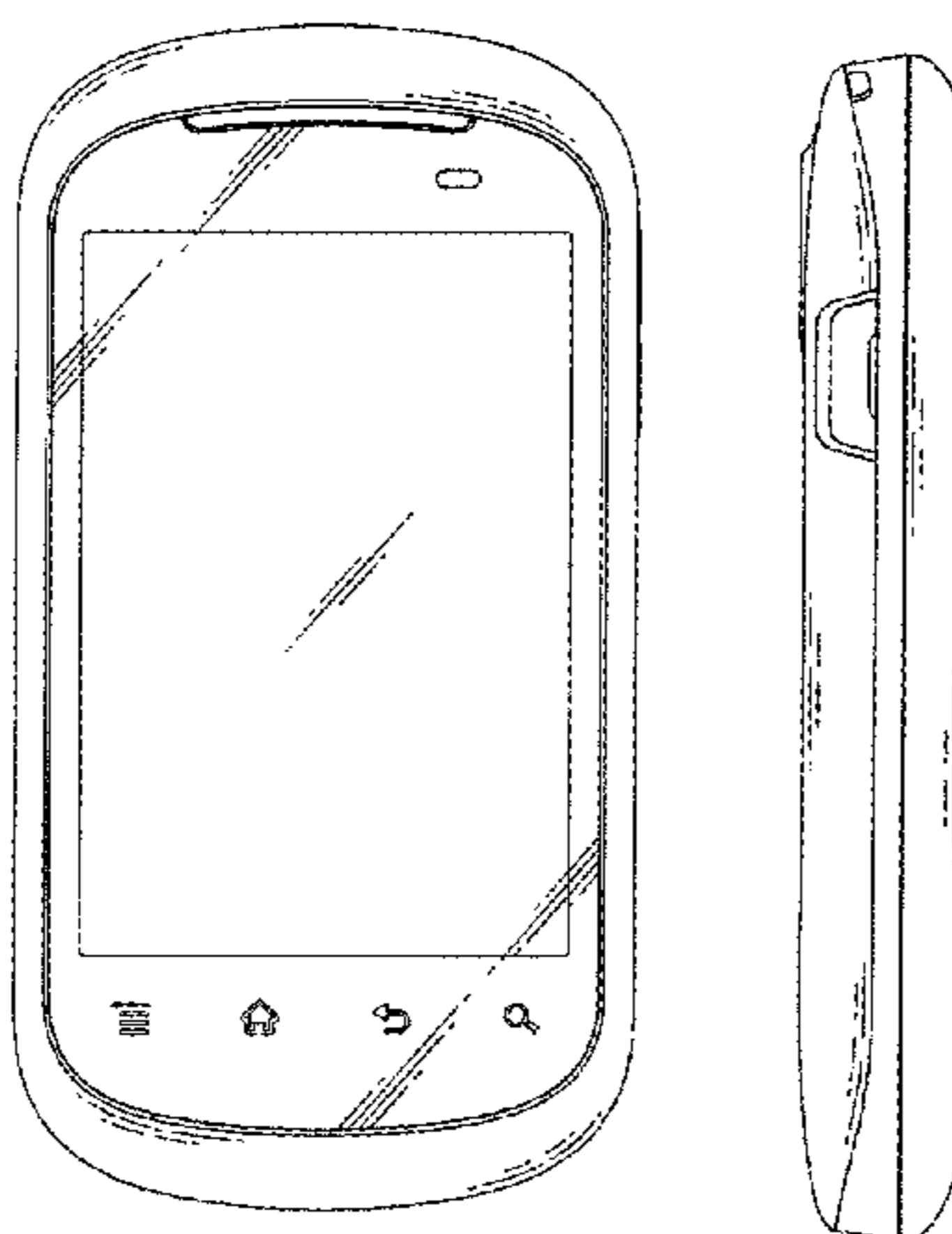

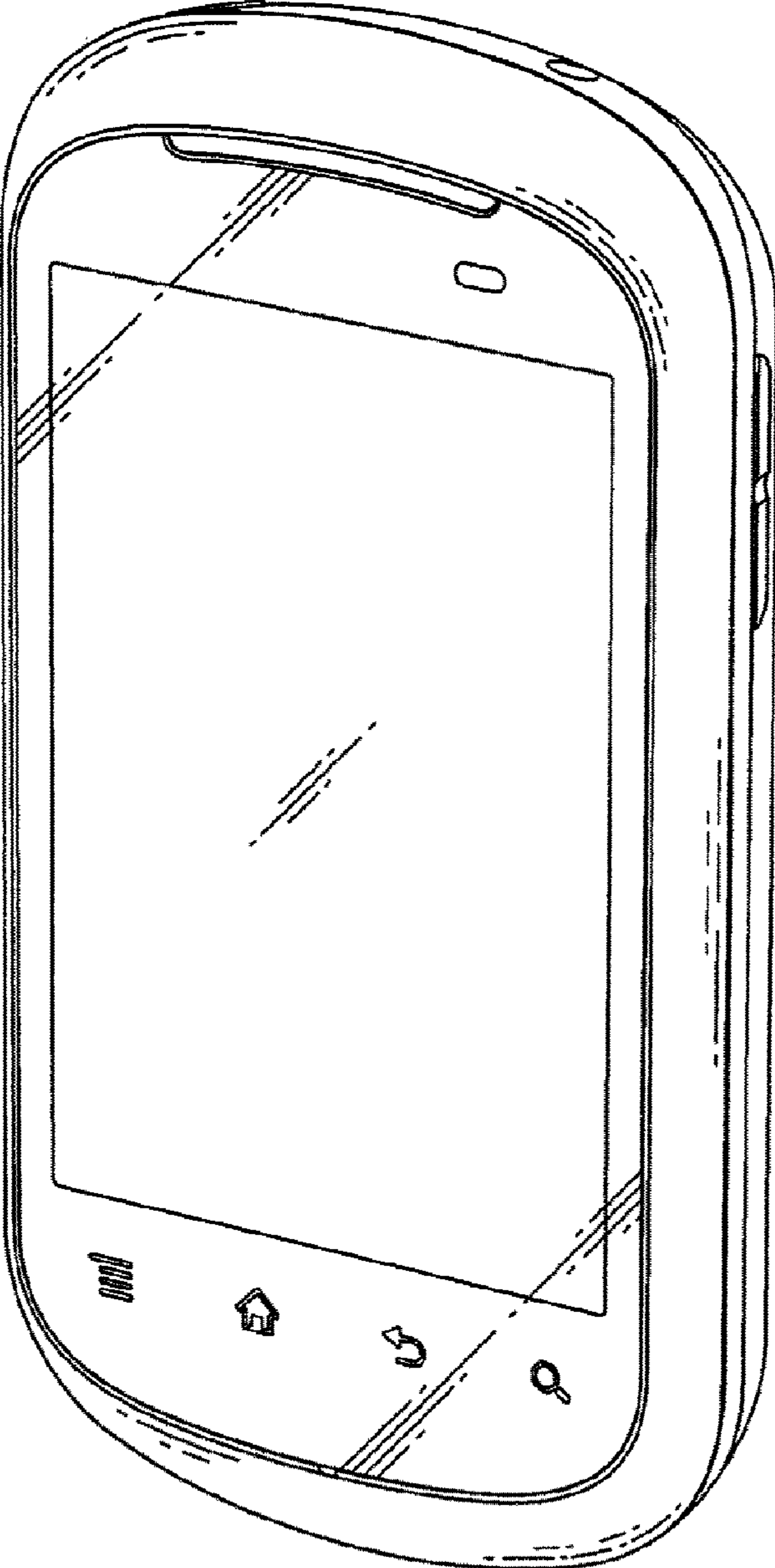

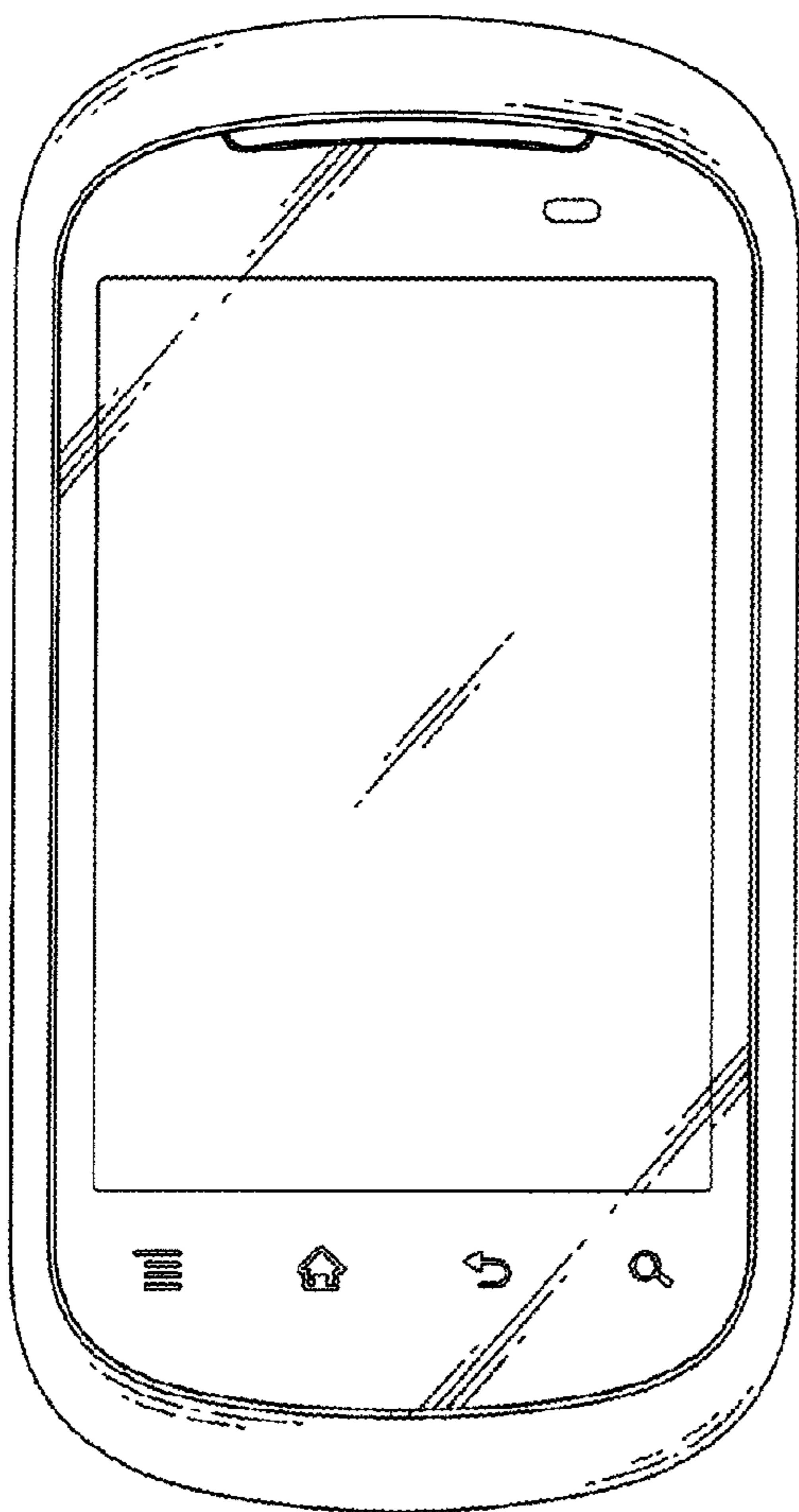

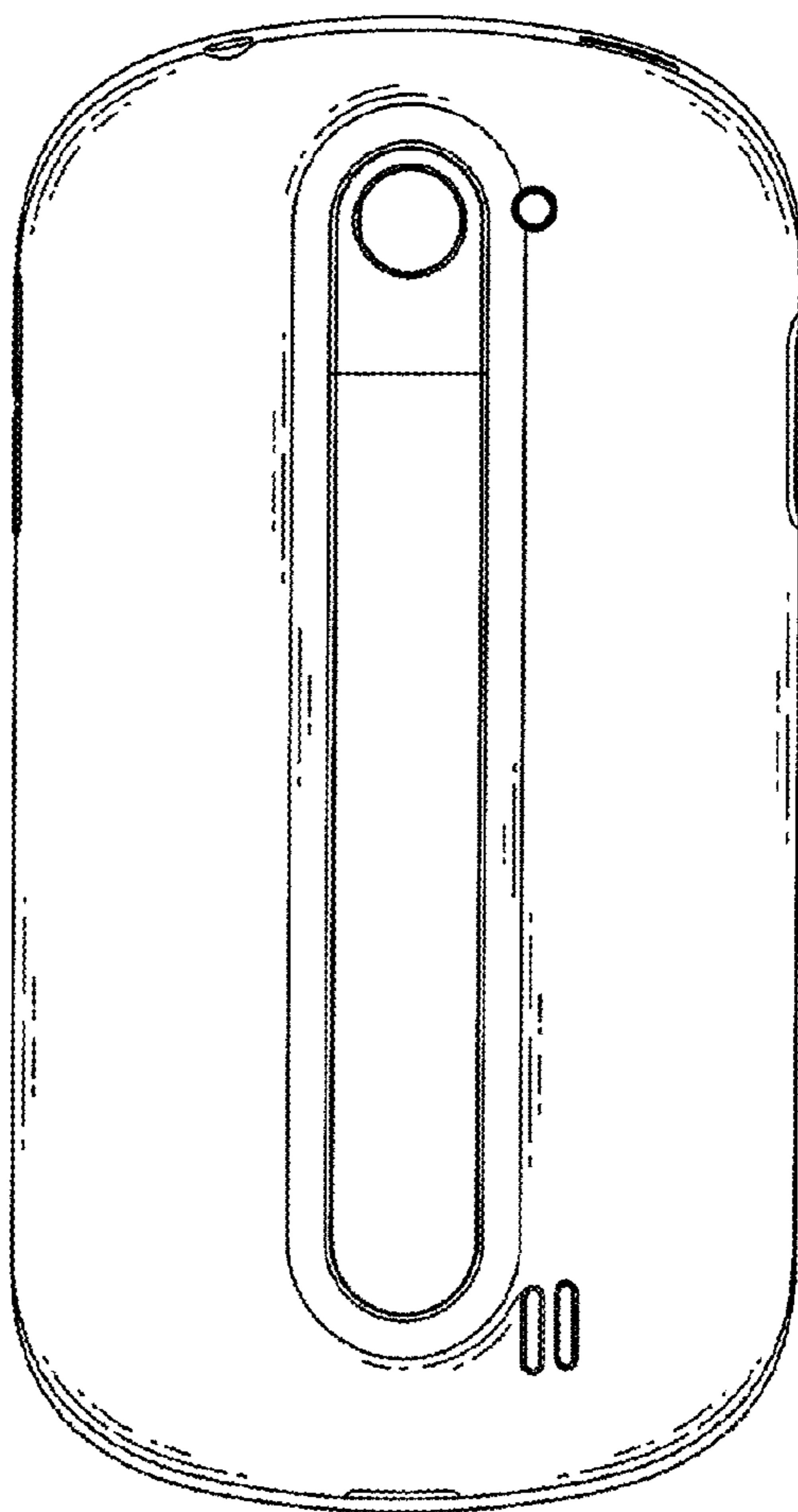

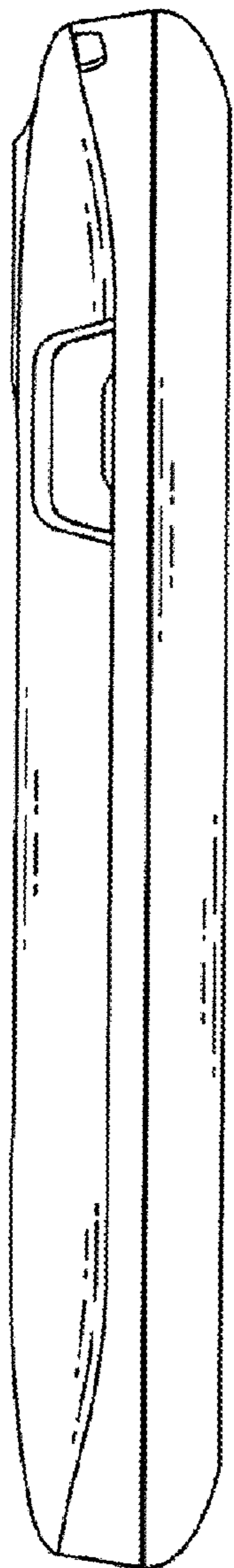

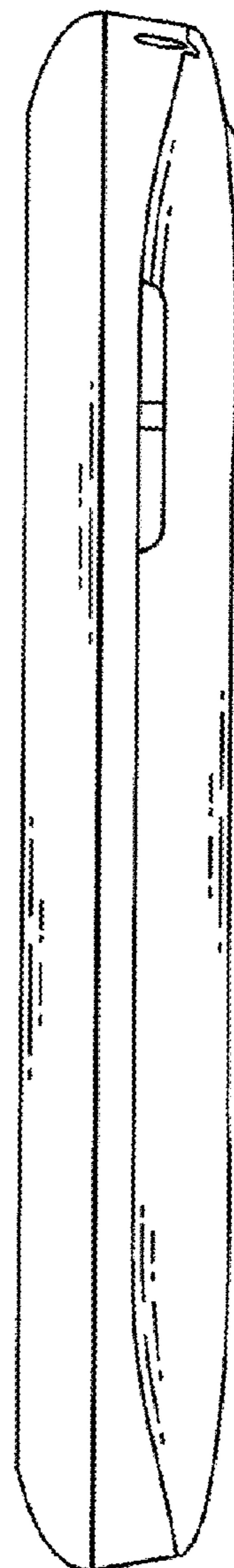

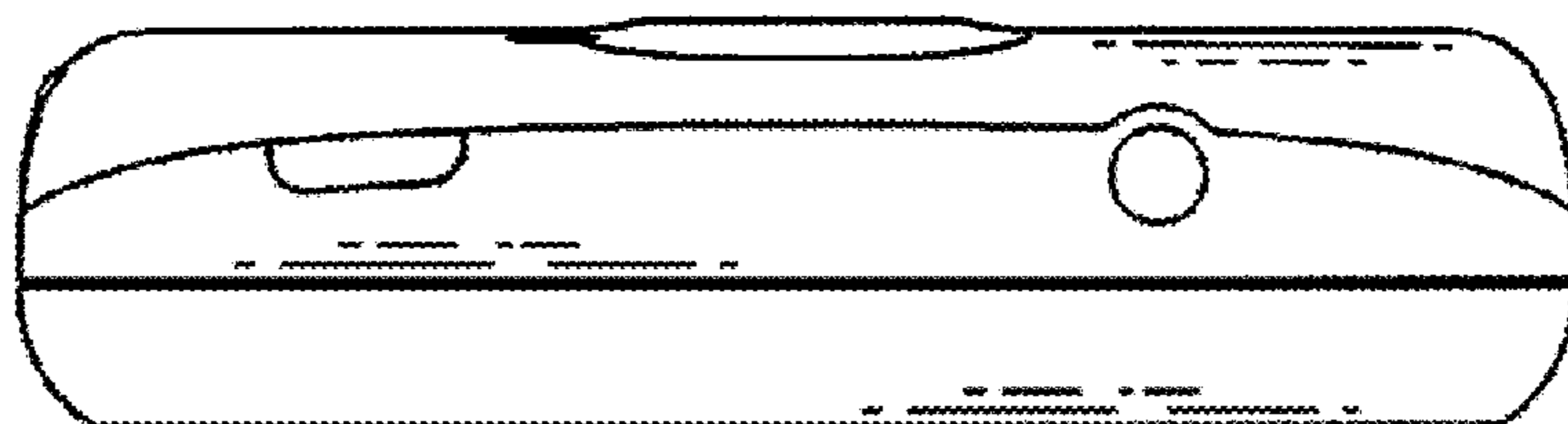
