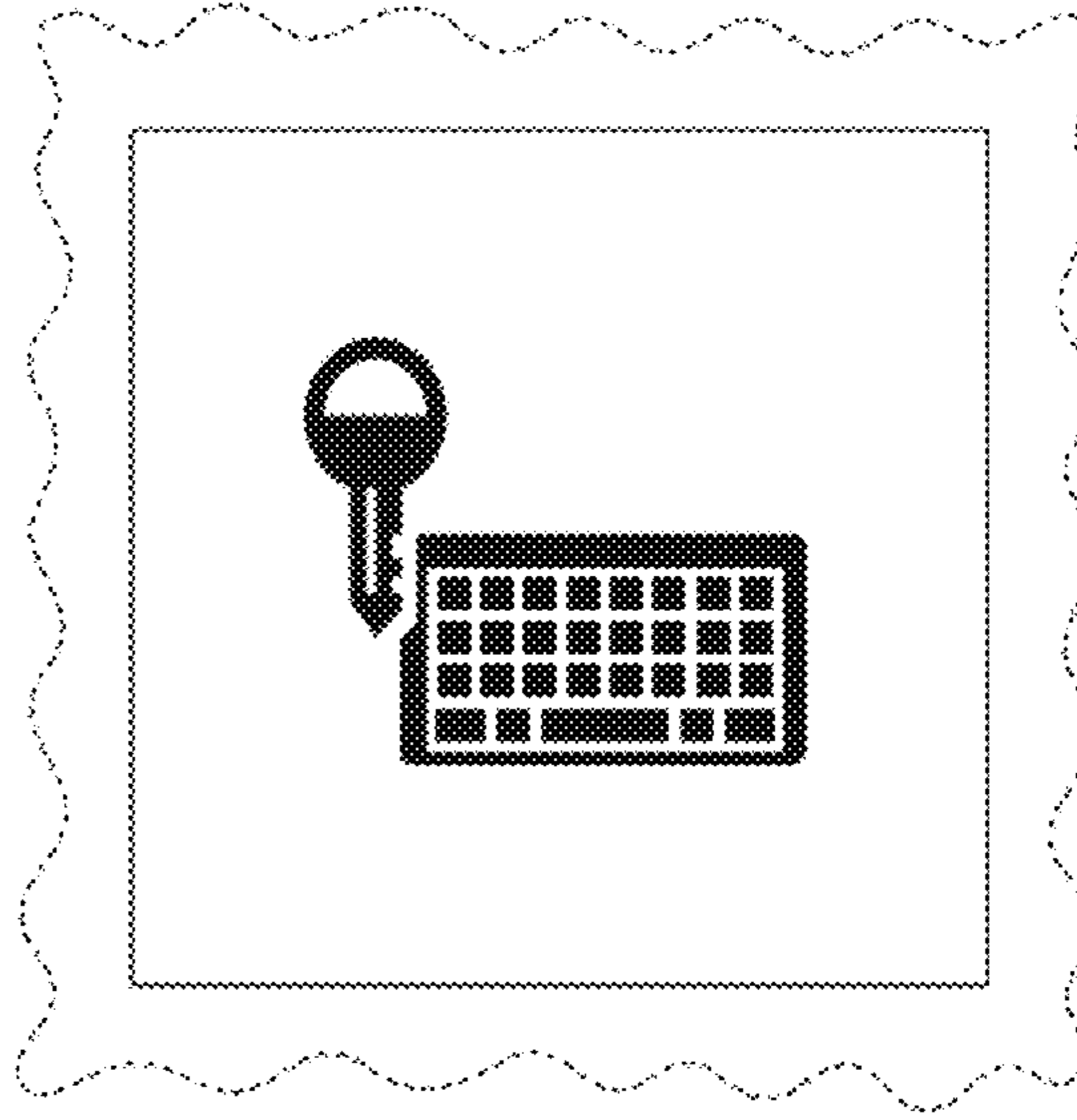
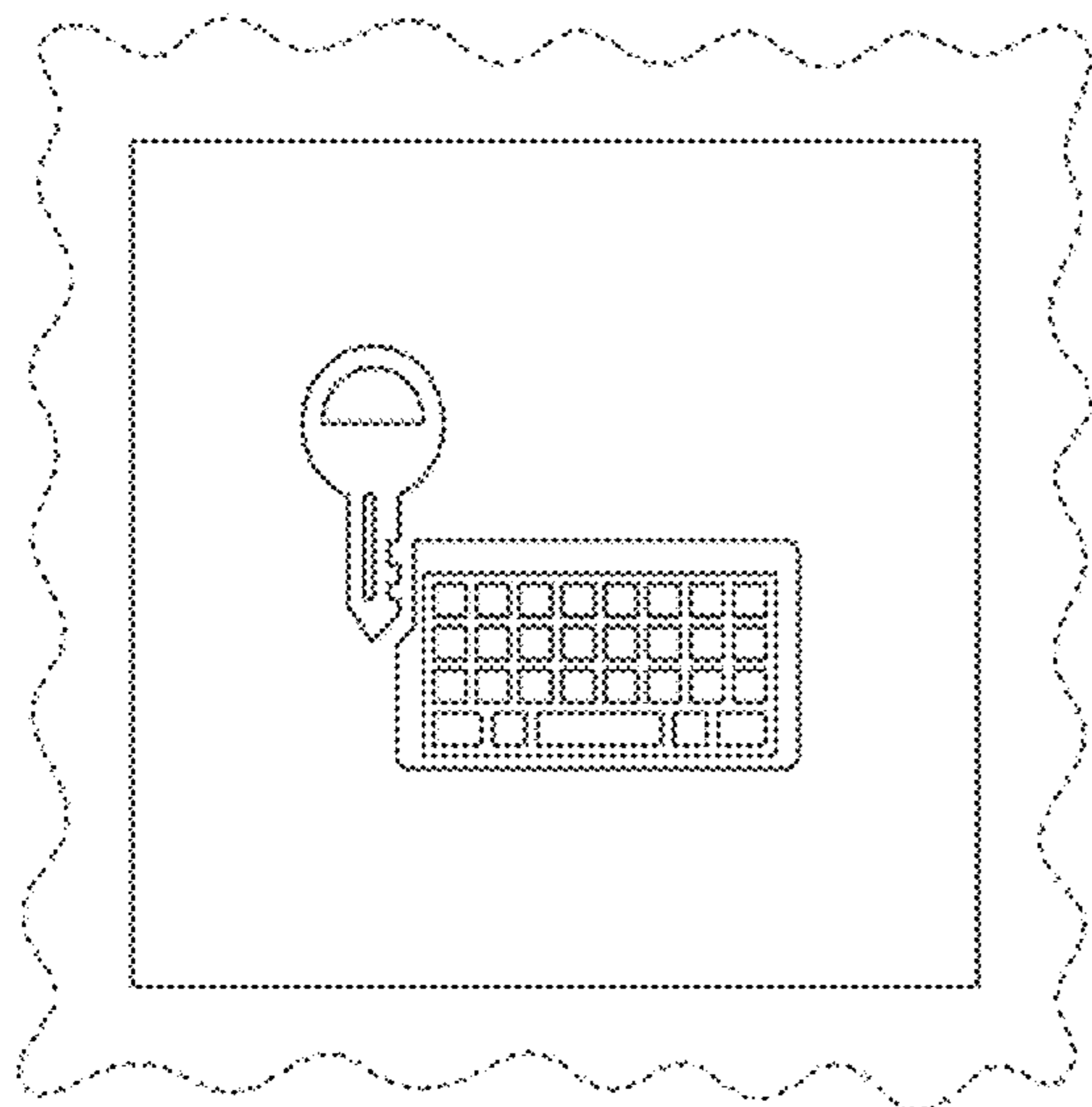
**DESCRIPTION**

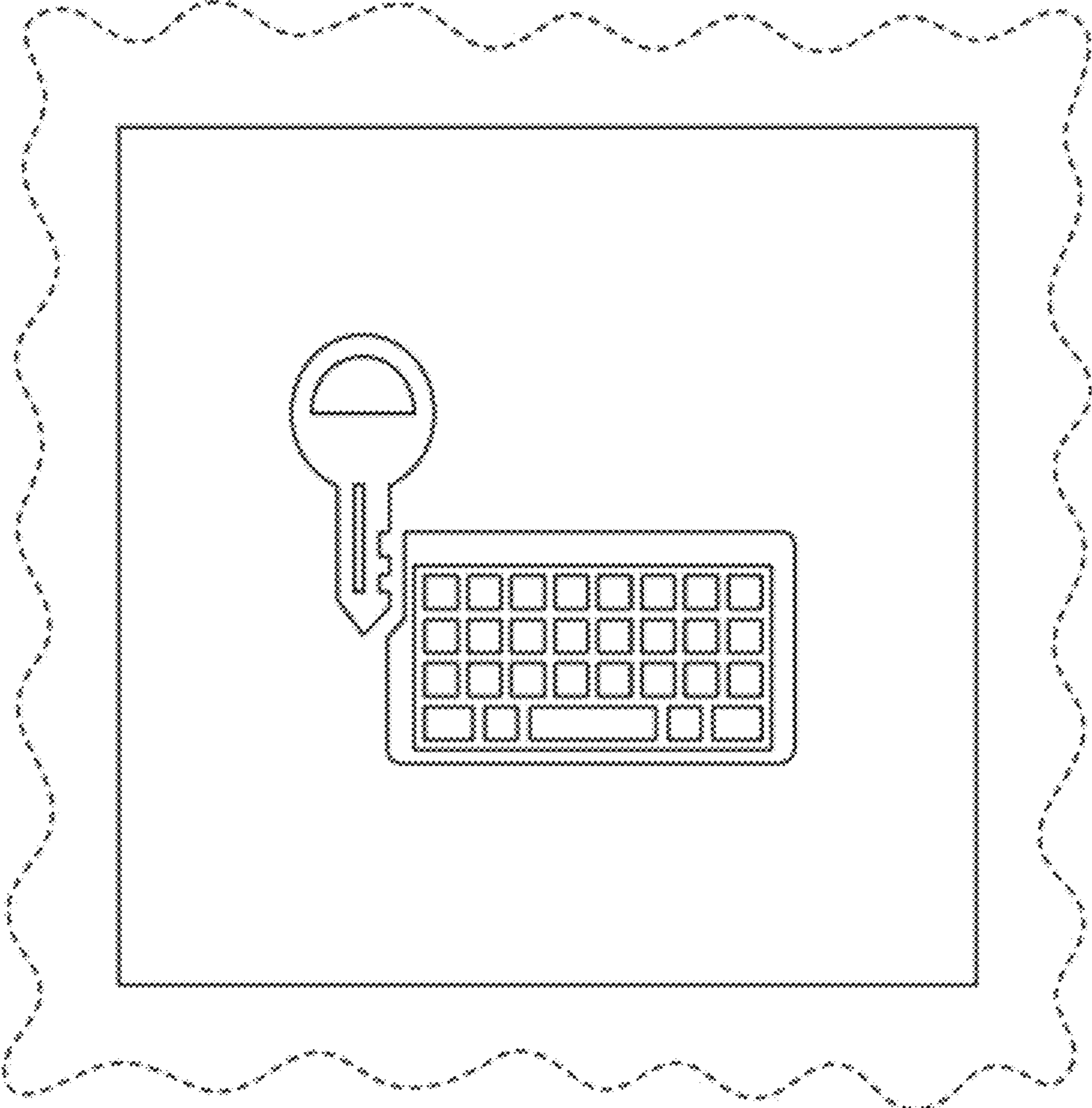

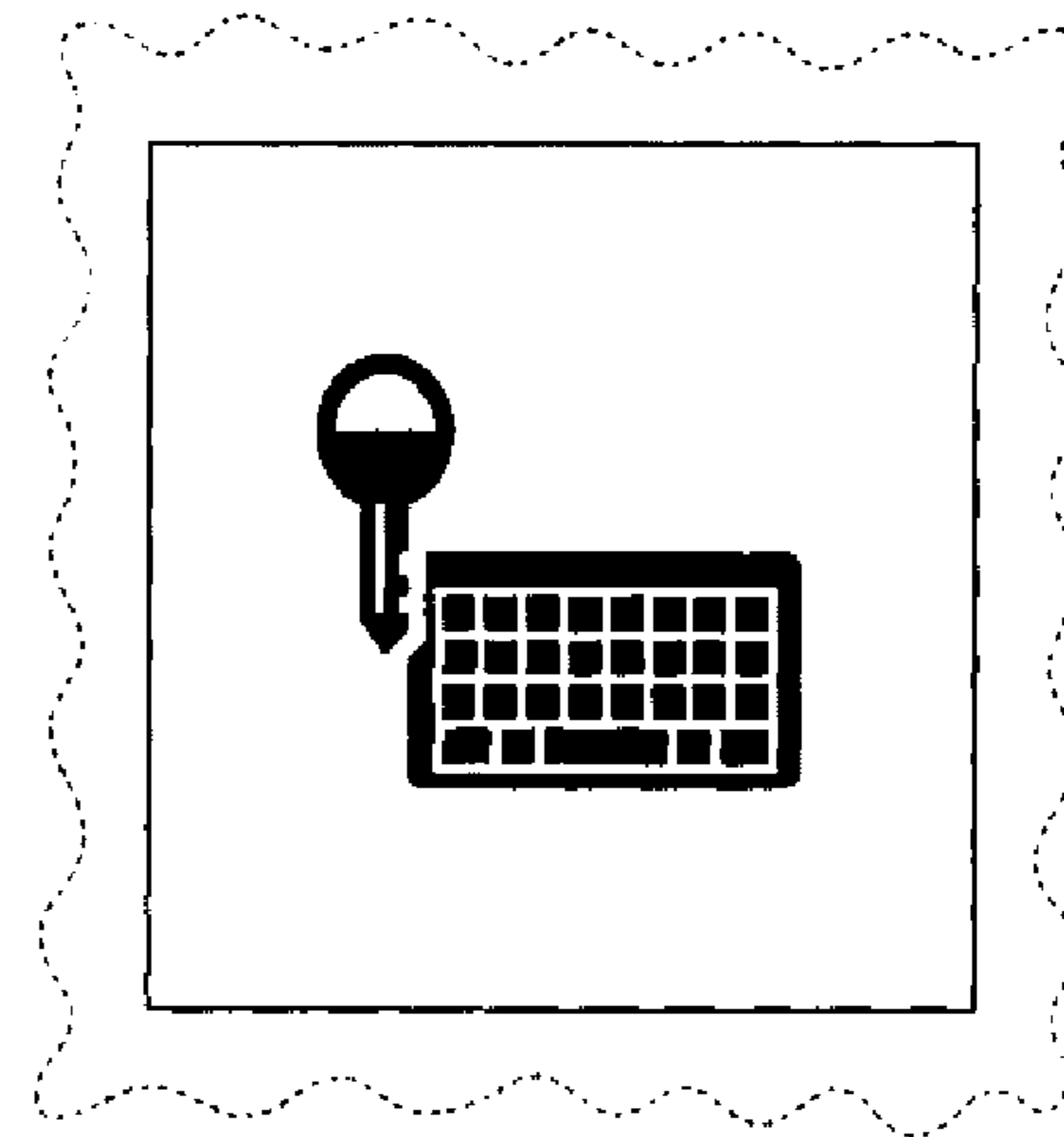
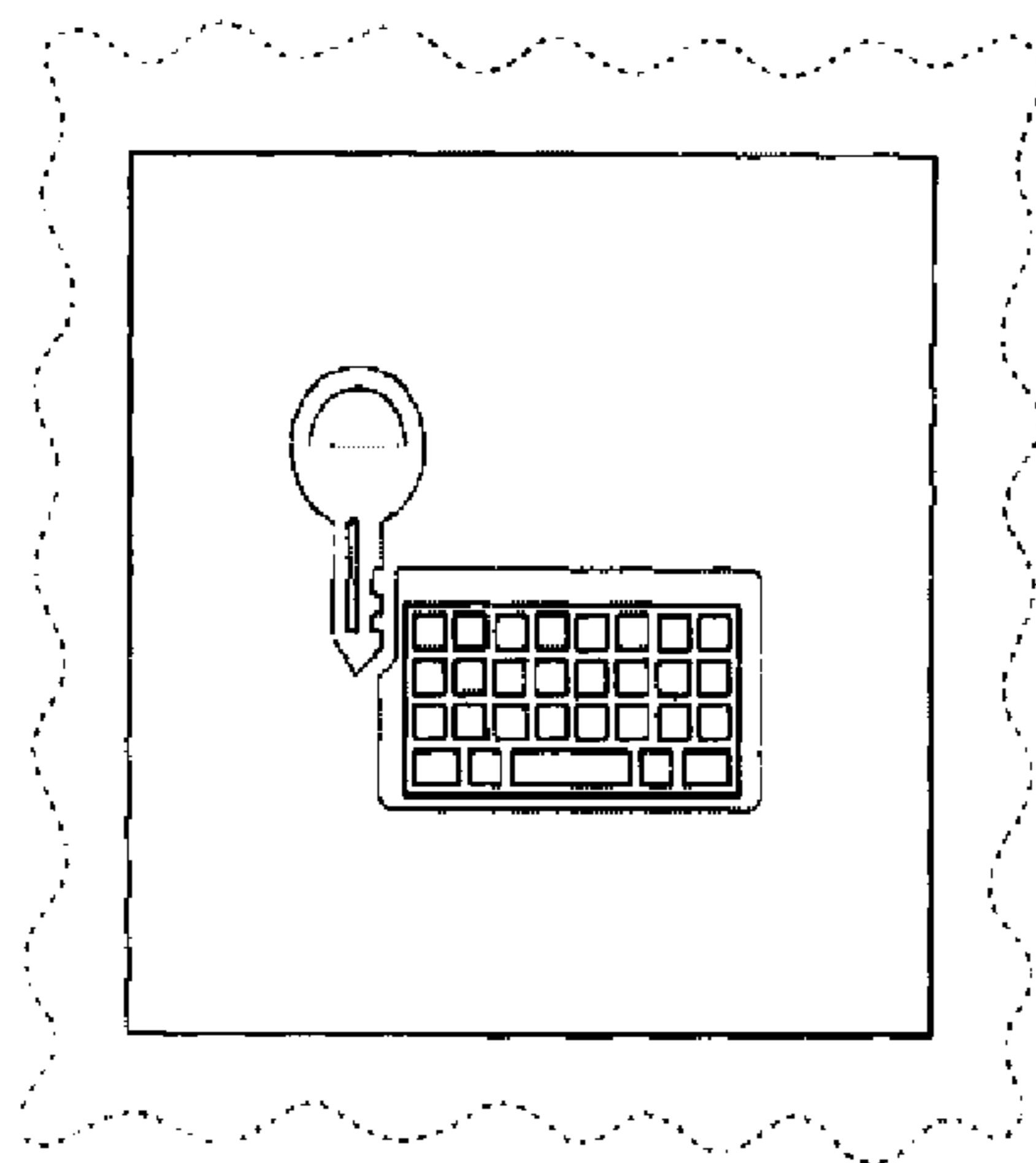

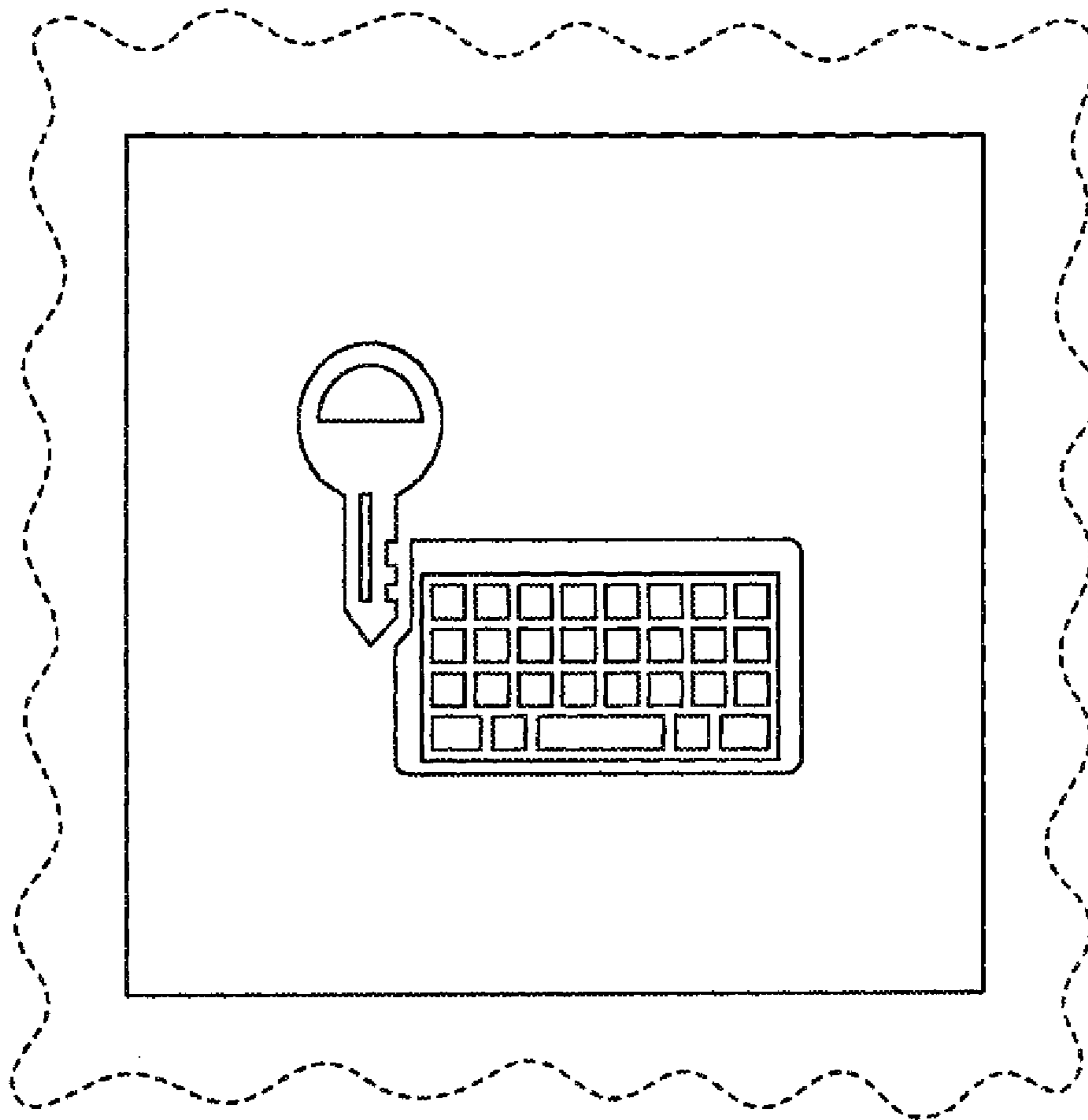

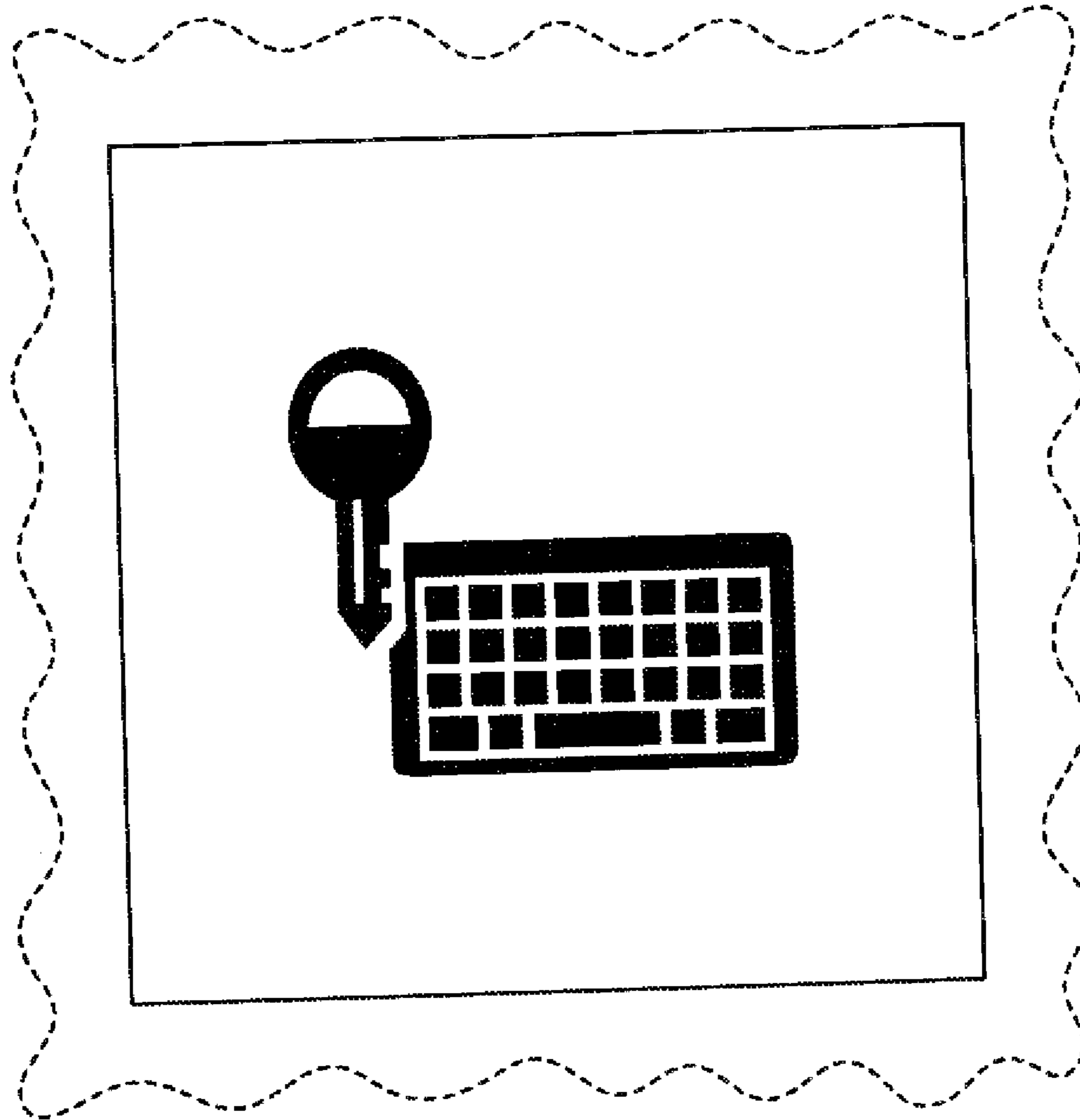
