(57) **CLAIM**

We claim the ornamental design for a door bin, as shown and described.

DESCRIPTION

Cross-reference is made to co-pending U.S. Utility patent application Ser. No. 13/114,319 entitled “Door Bin for a Domestic Refrigerator,” which was filed on May 24, 2011, is assigned to the same assignee as the present application, and is hereby incorporated by reference.

FIG. 18 is a second side elevation view of the door bin of FIG. 15;

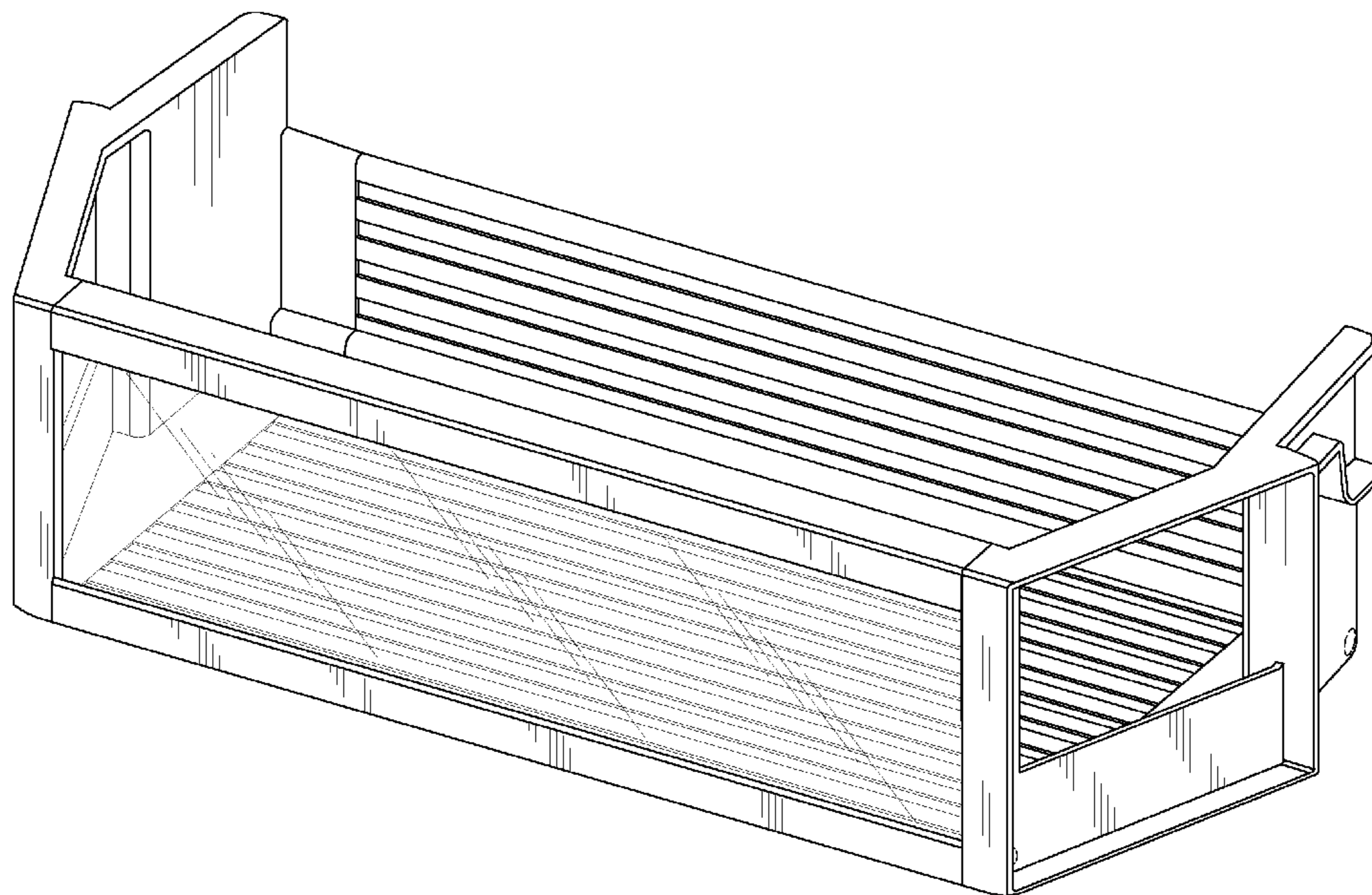
FIG. 19 is a rear elevation view of the door bin of FIG. 15;

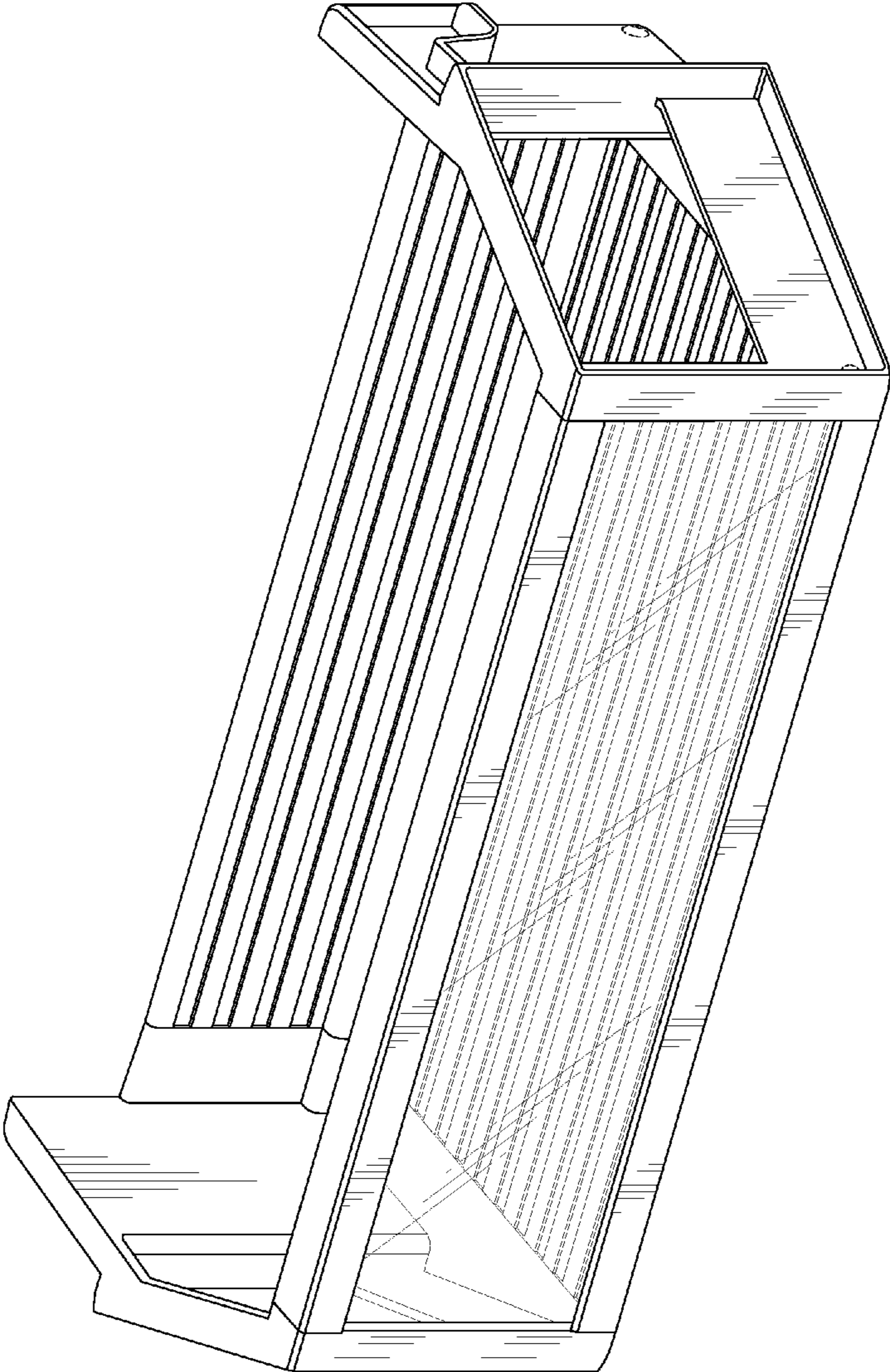

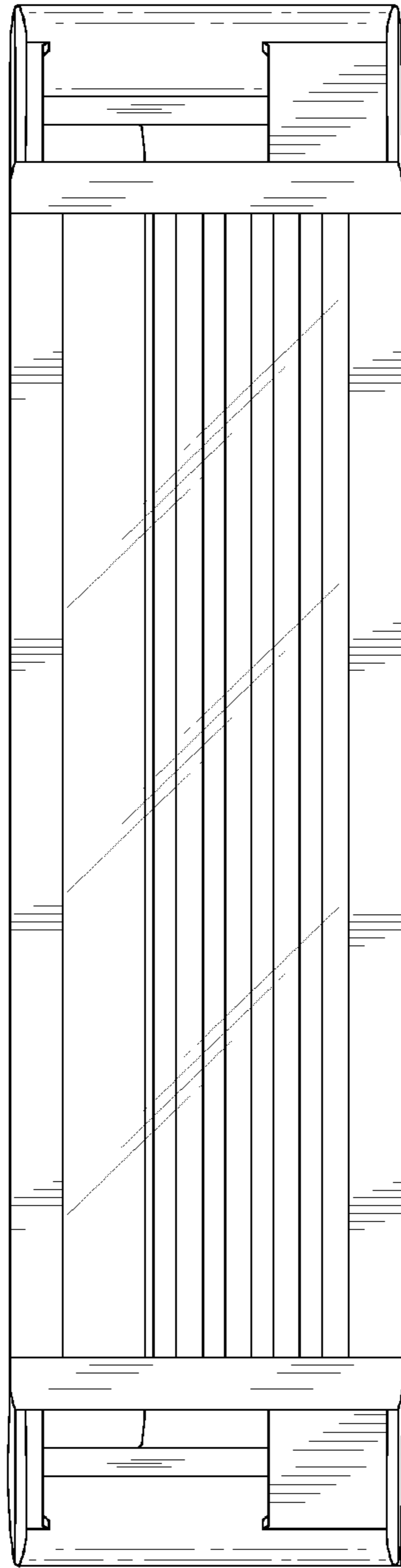

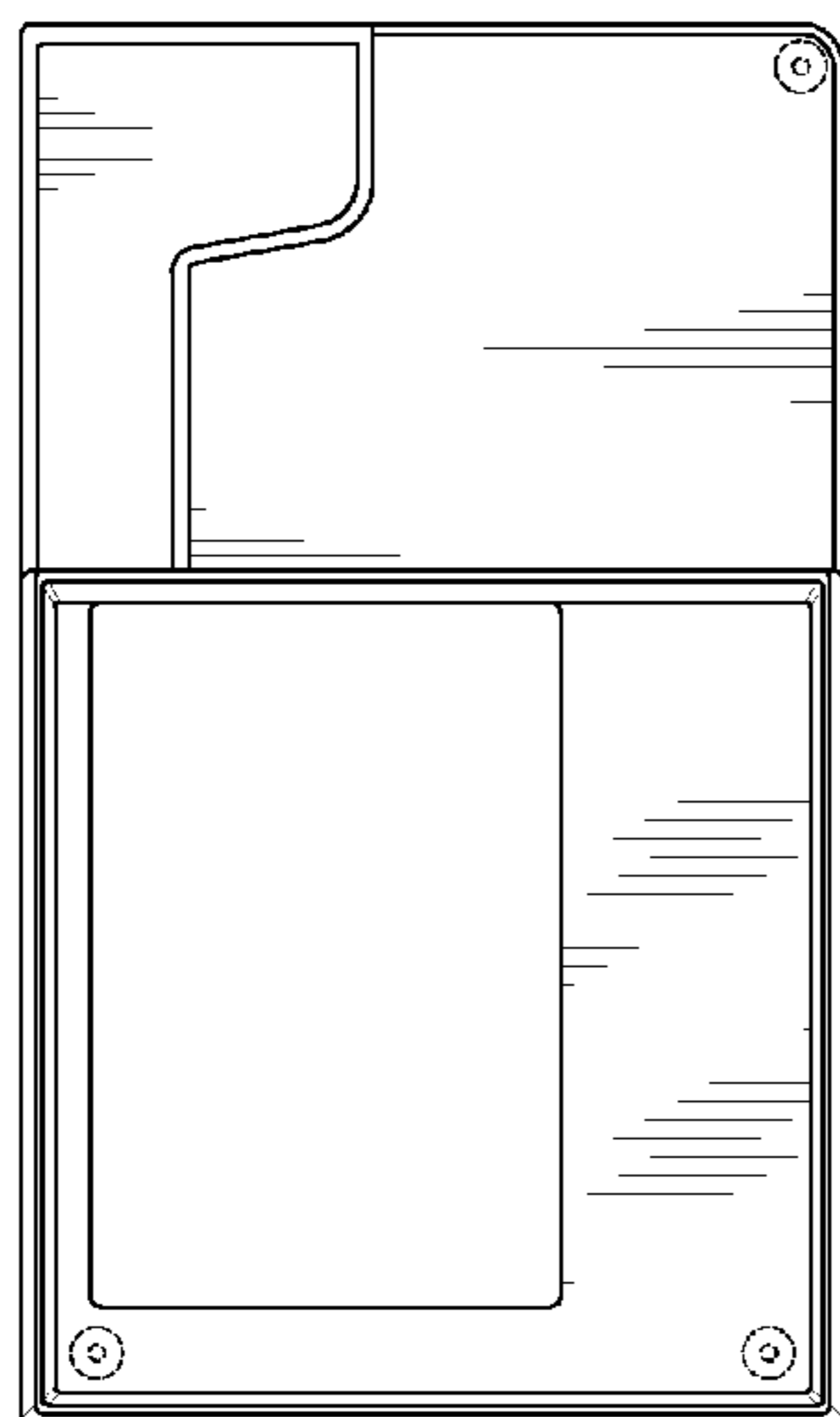

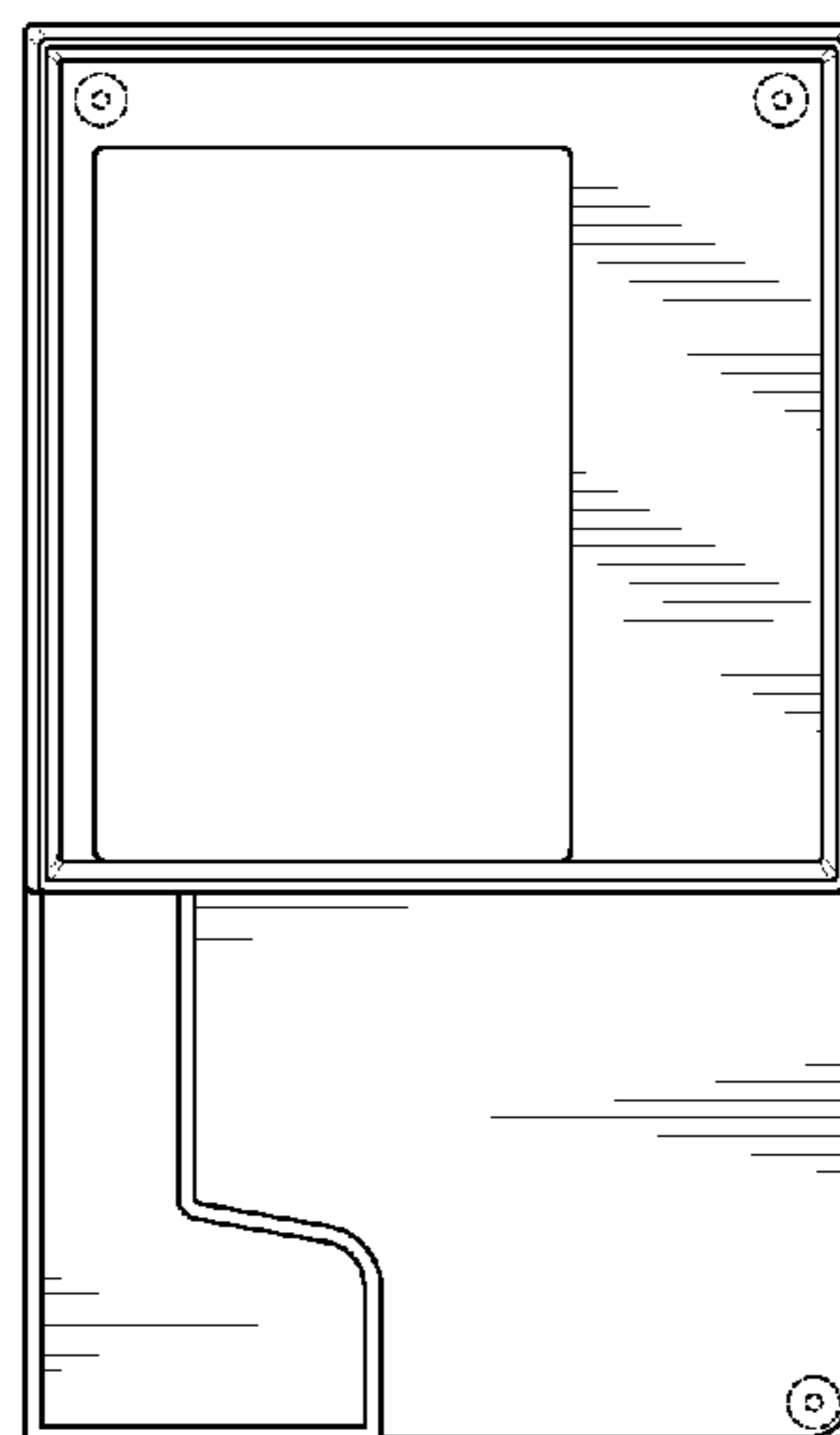

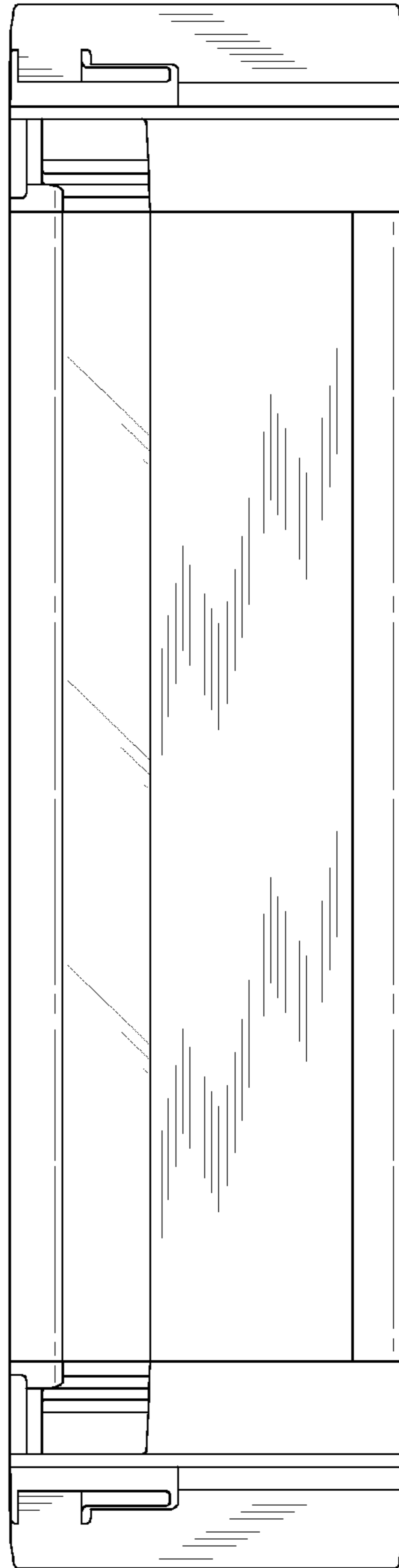

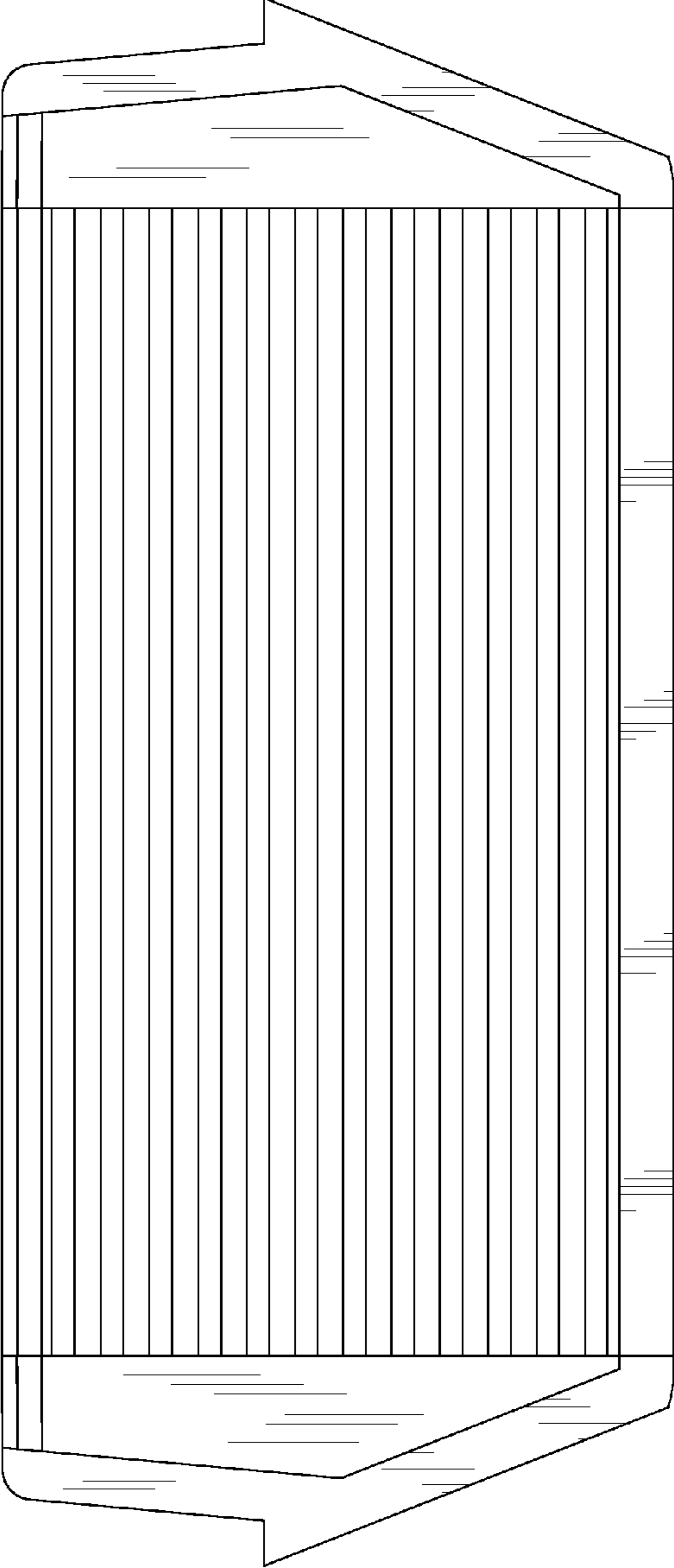

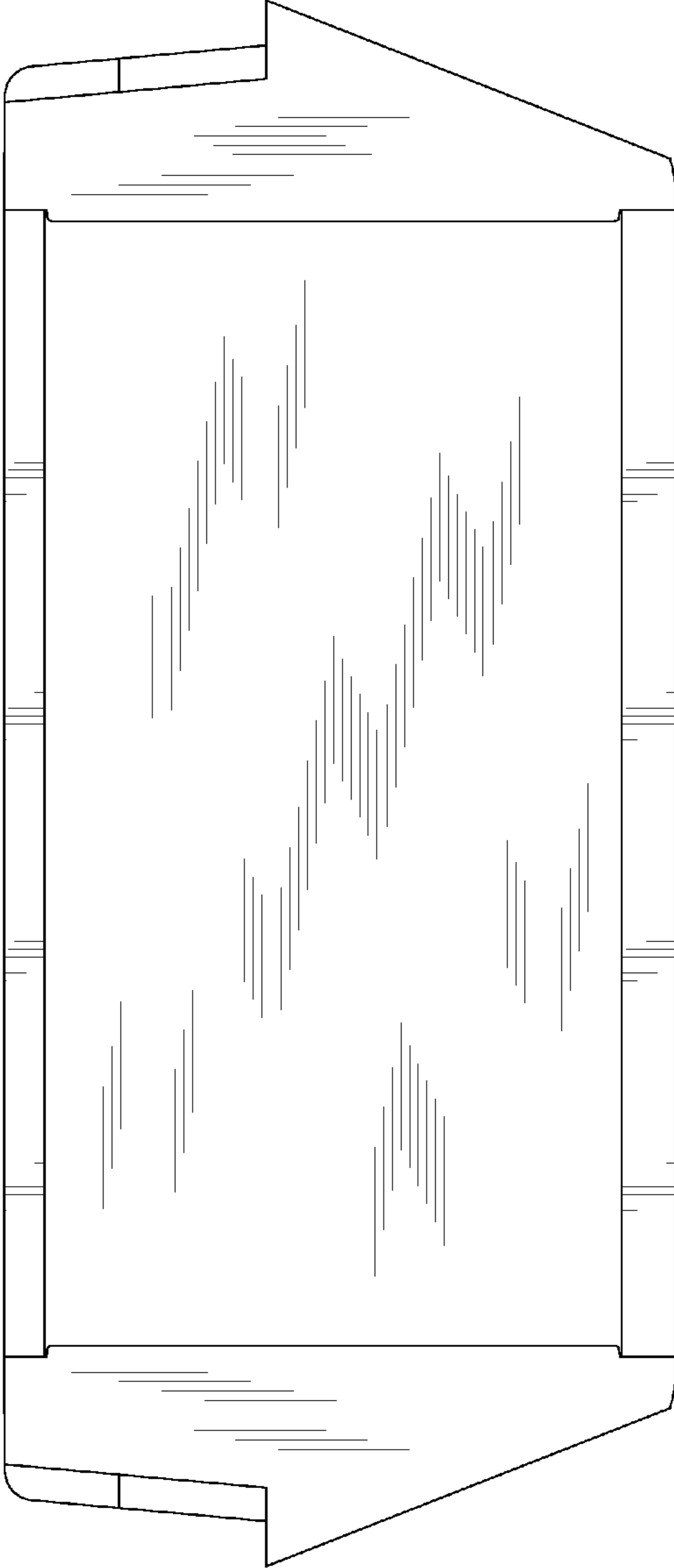

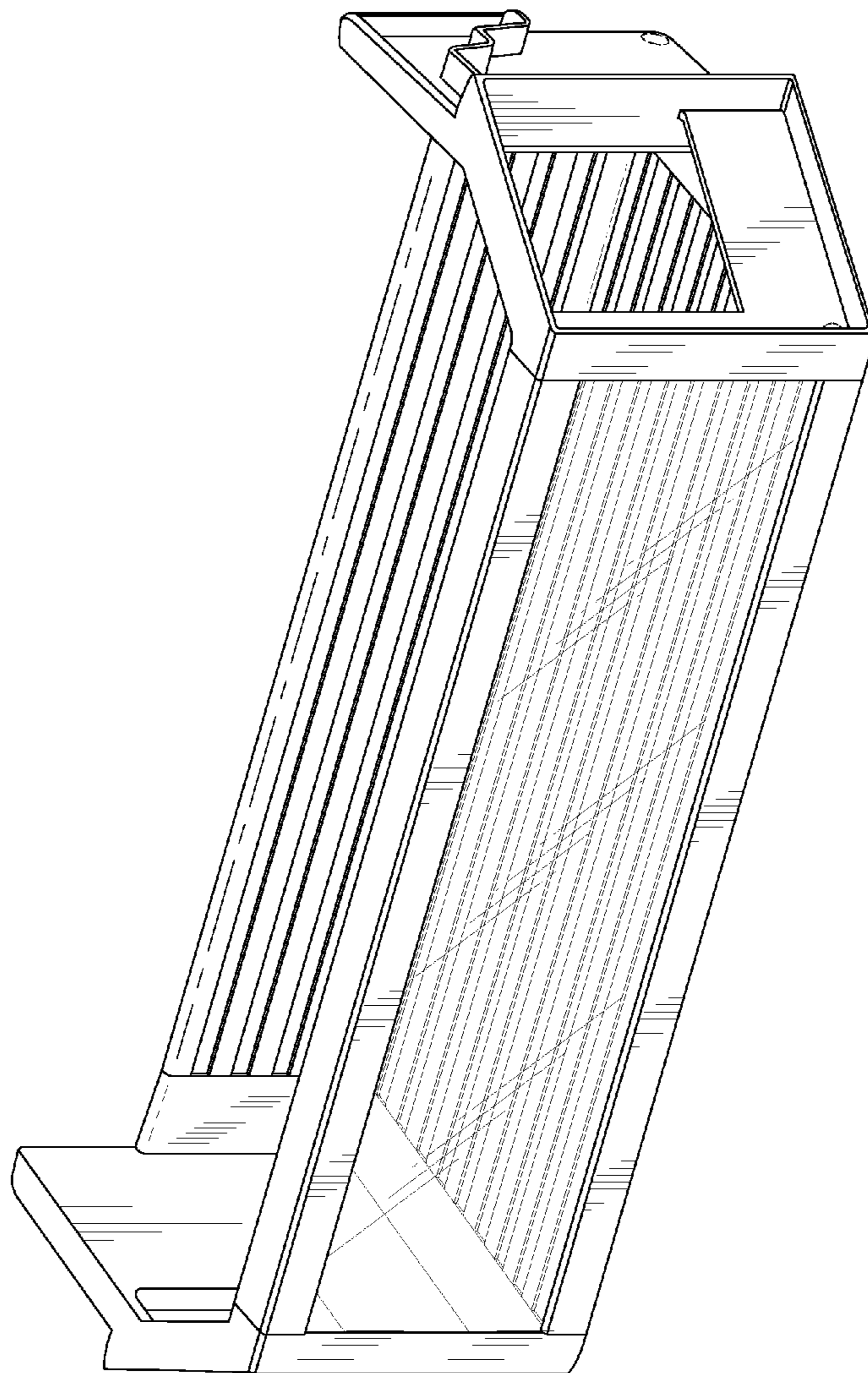

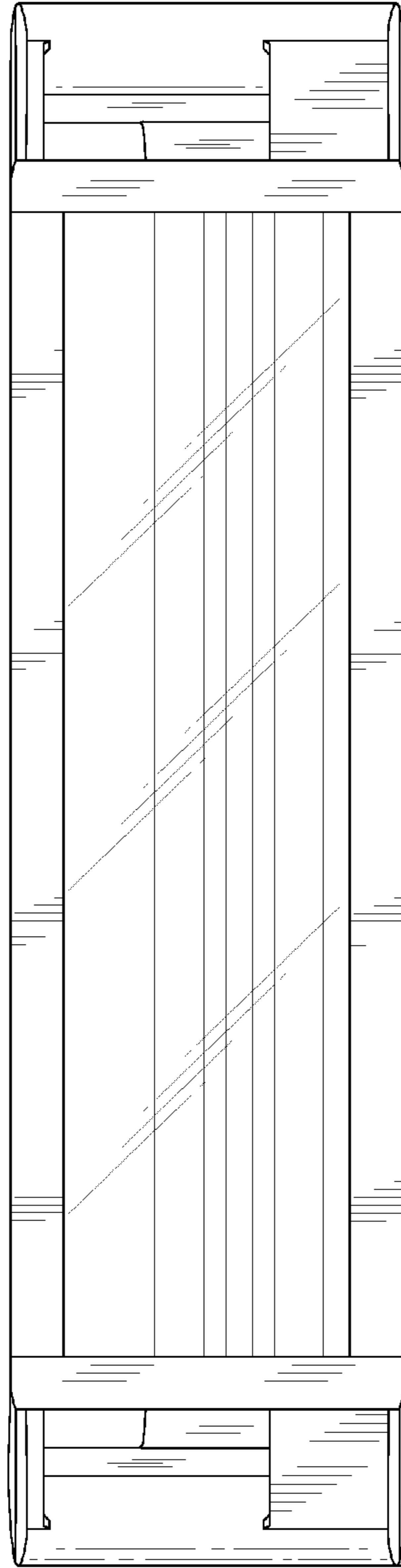

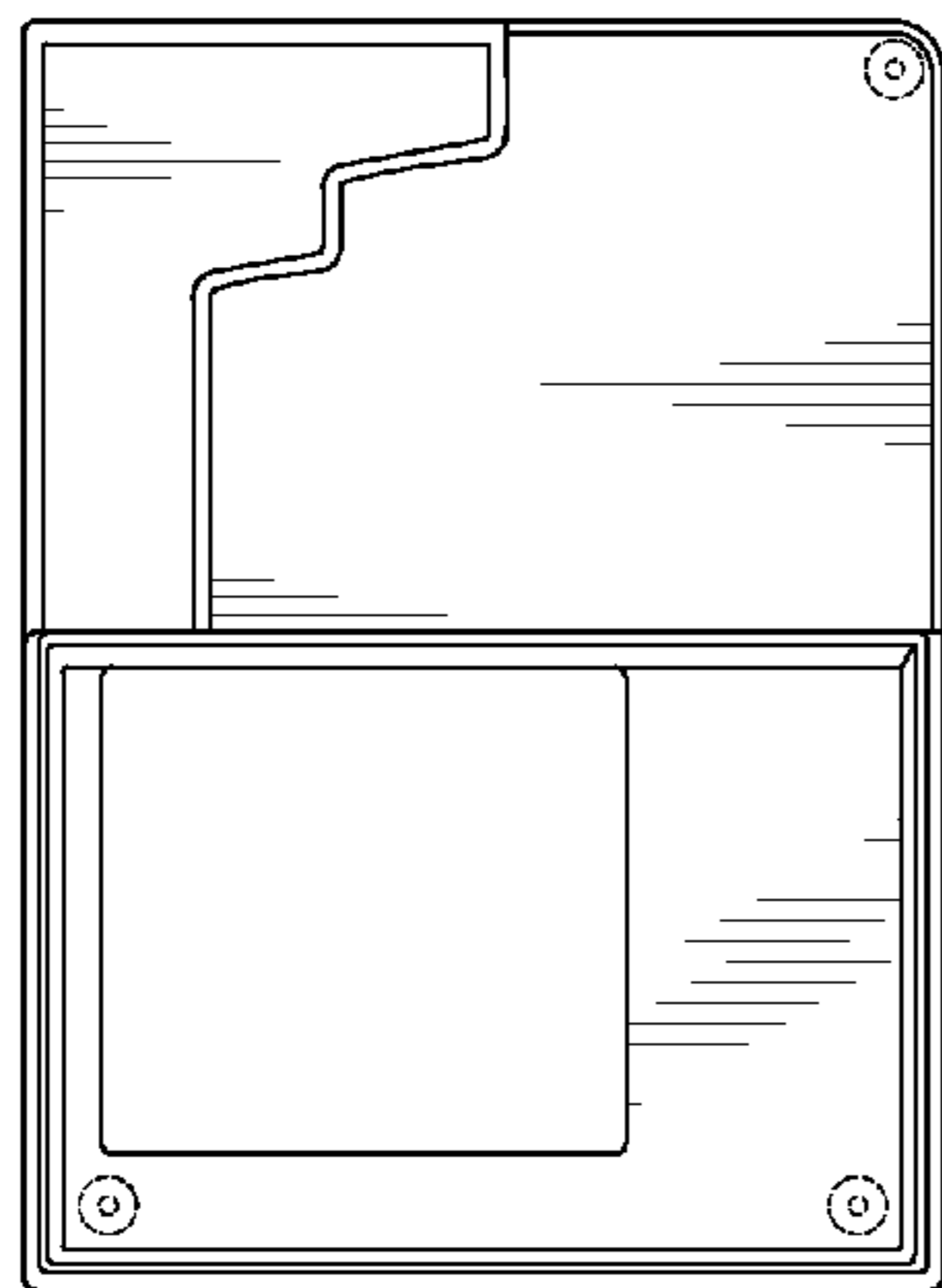

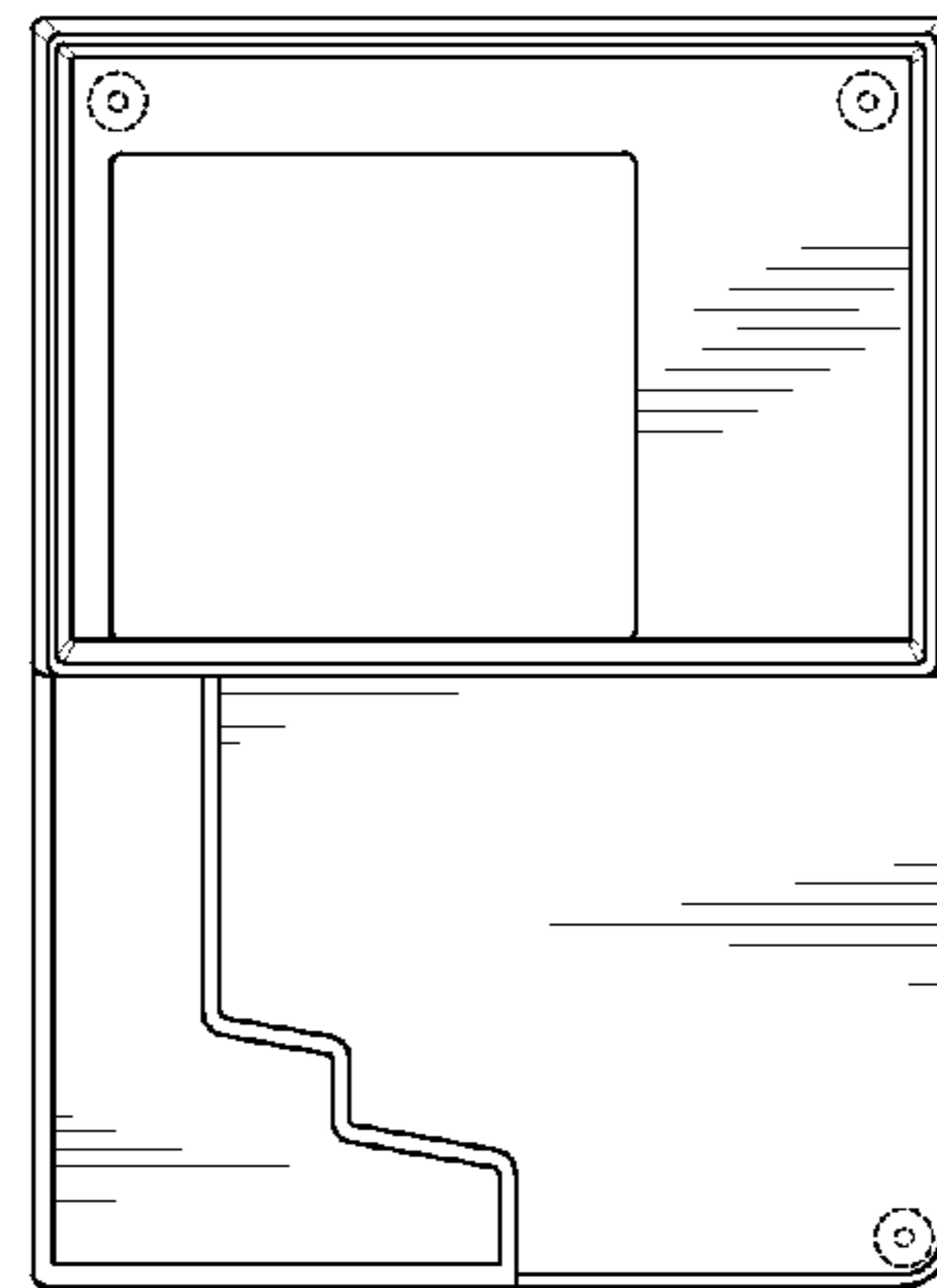

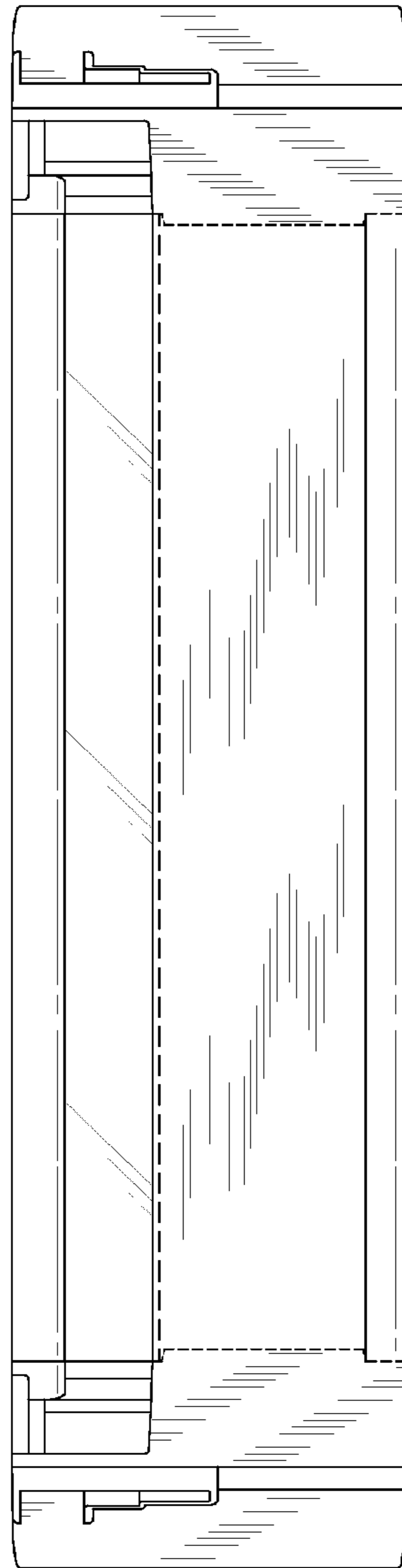

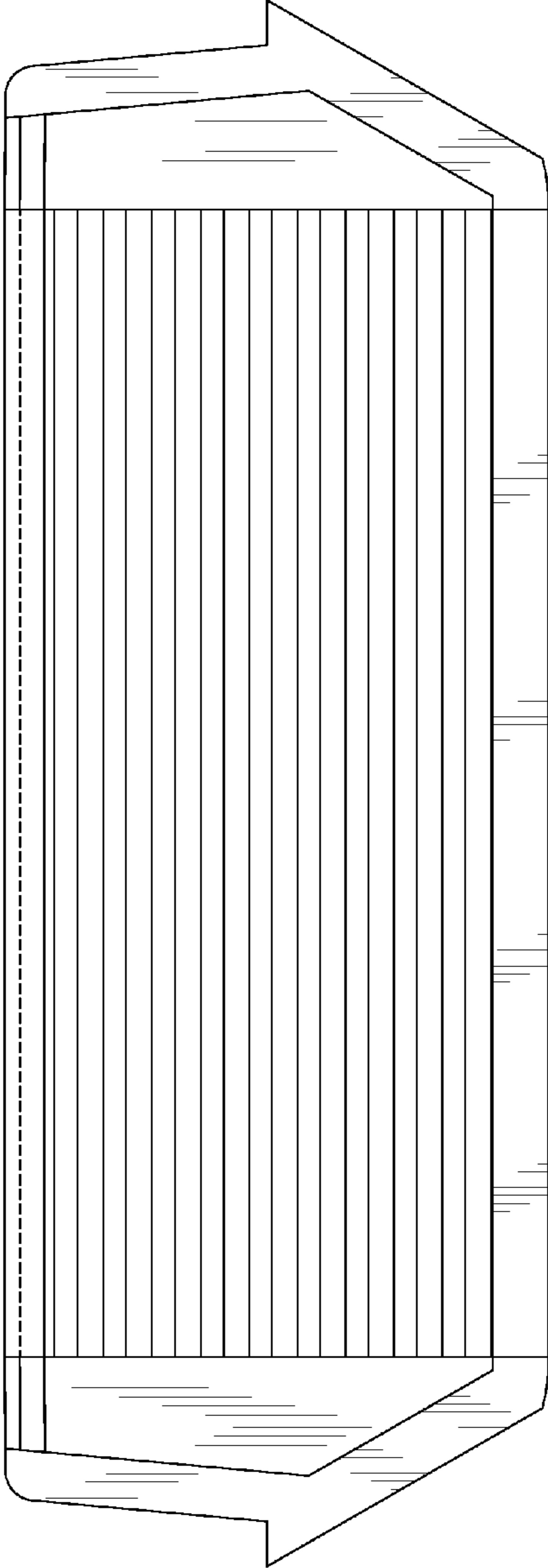

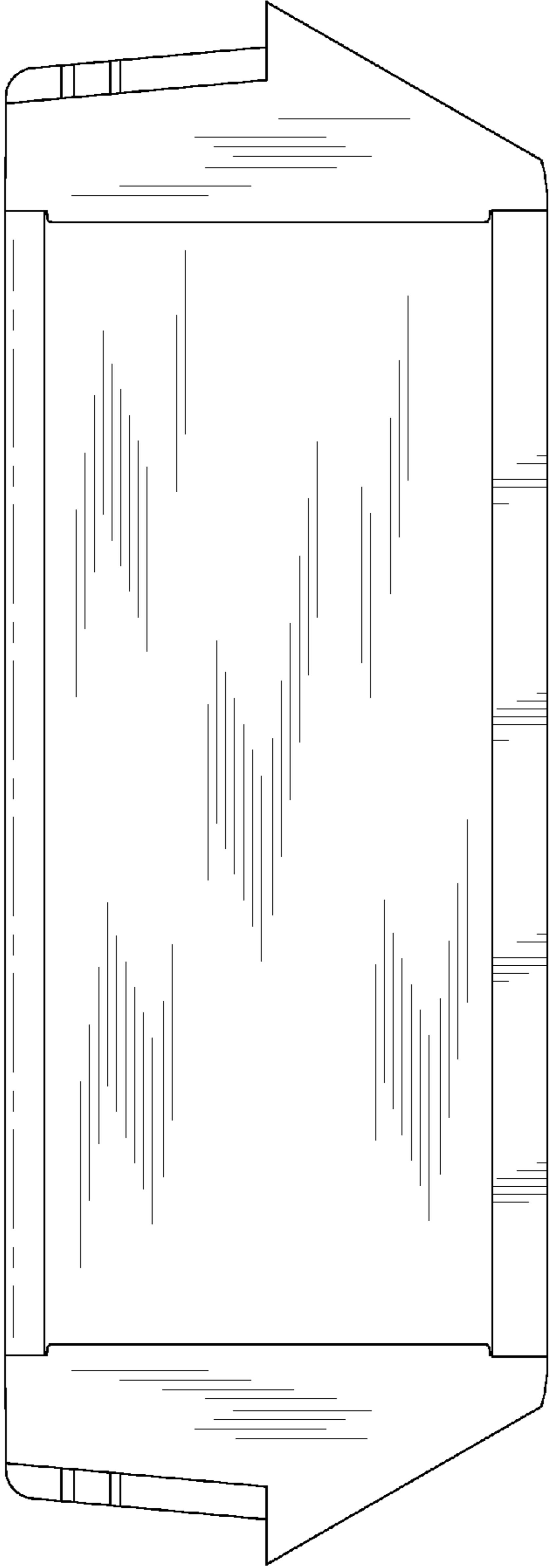

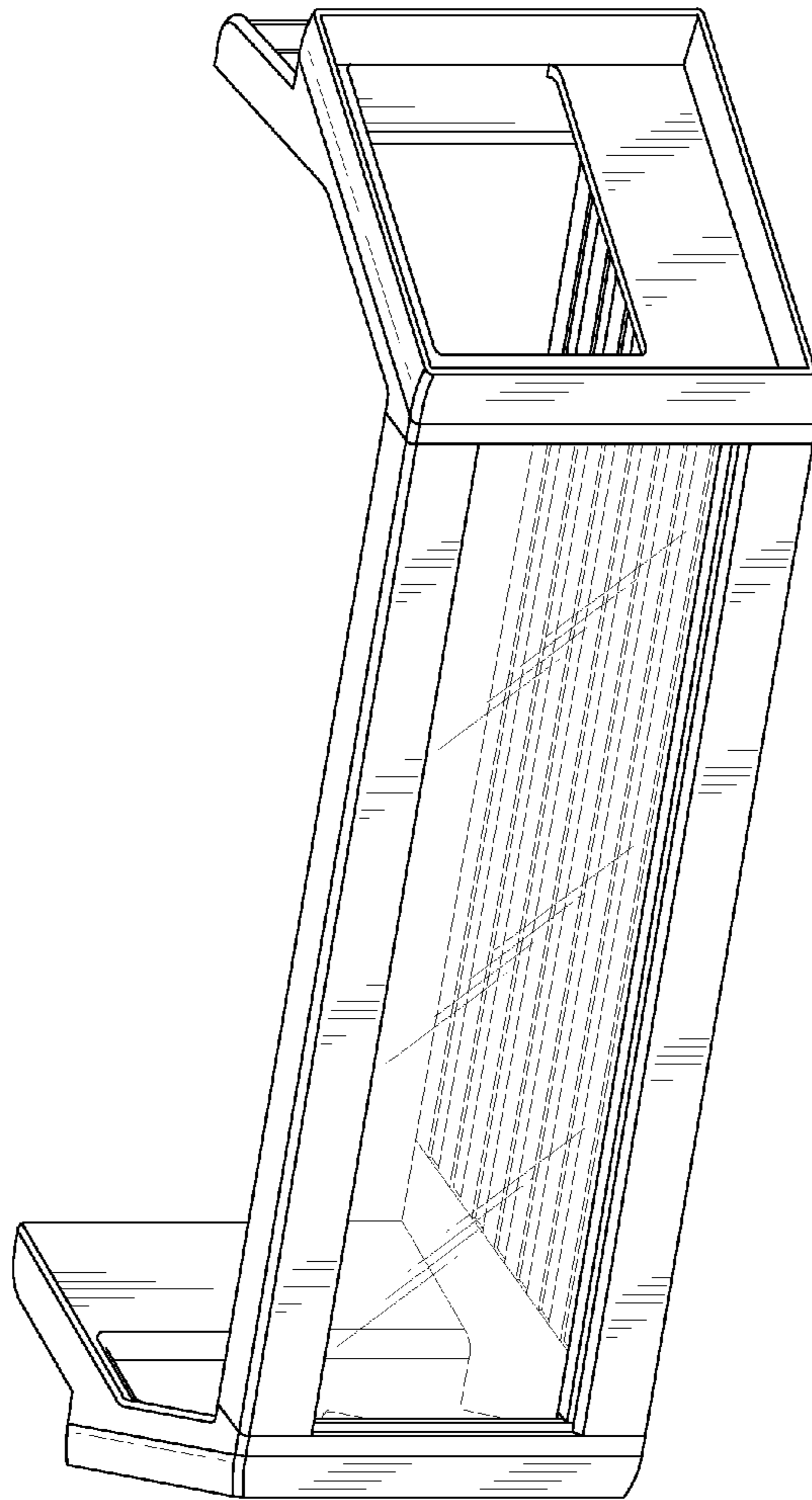

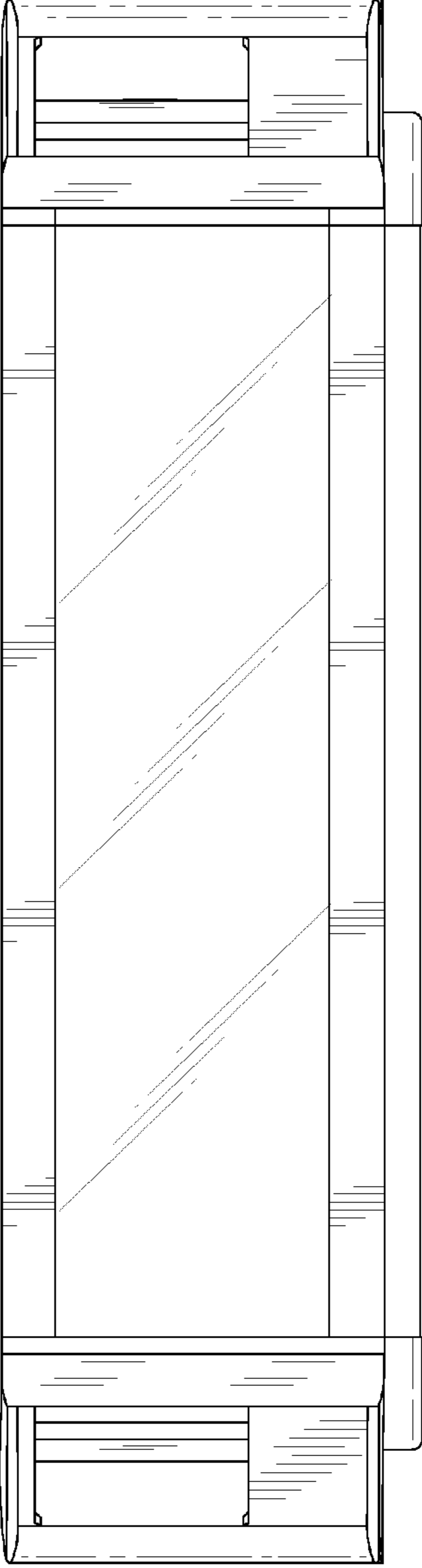

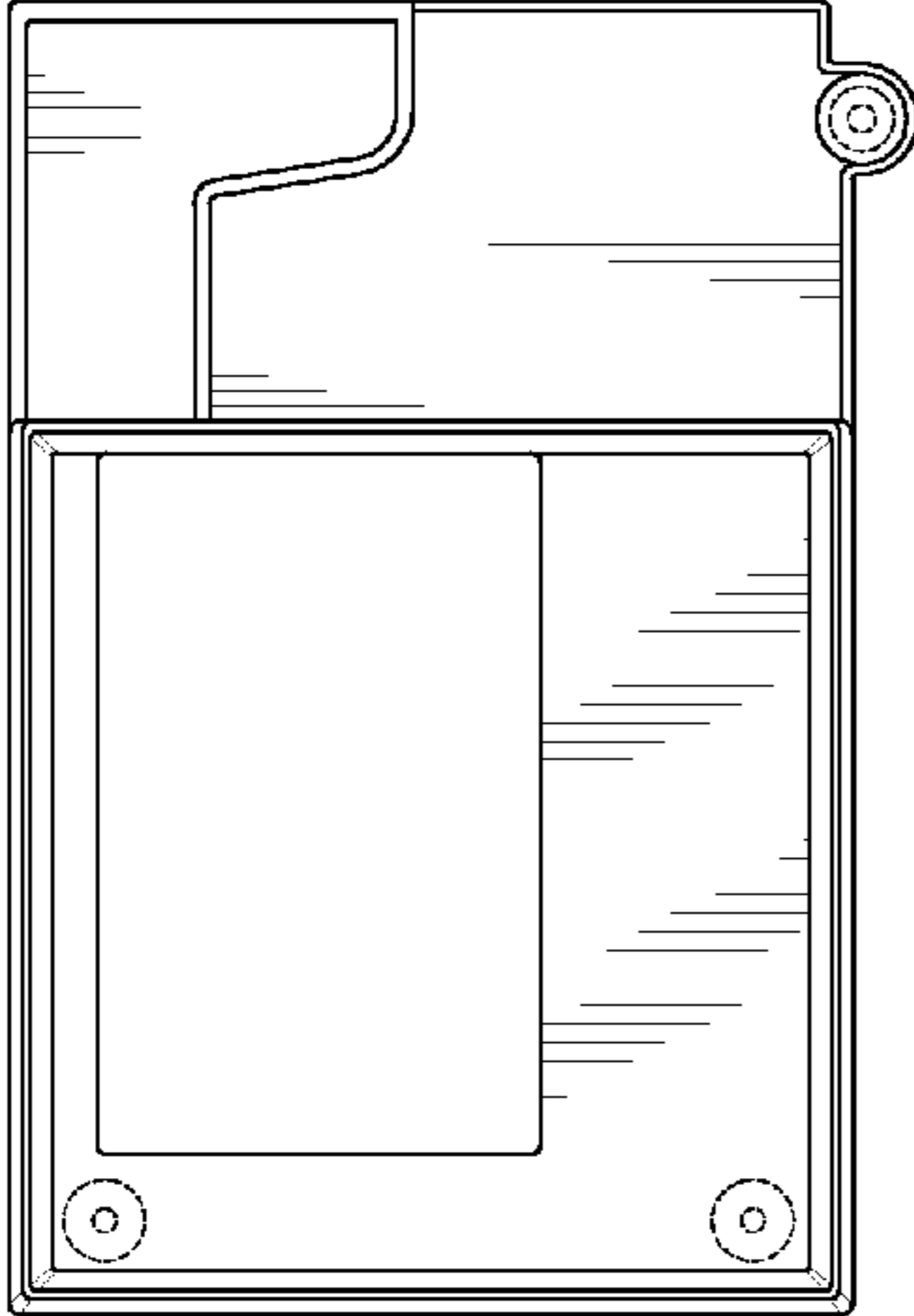

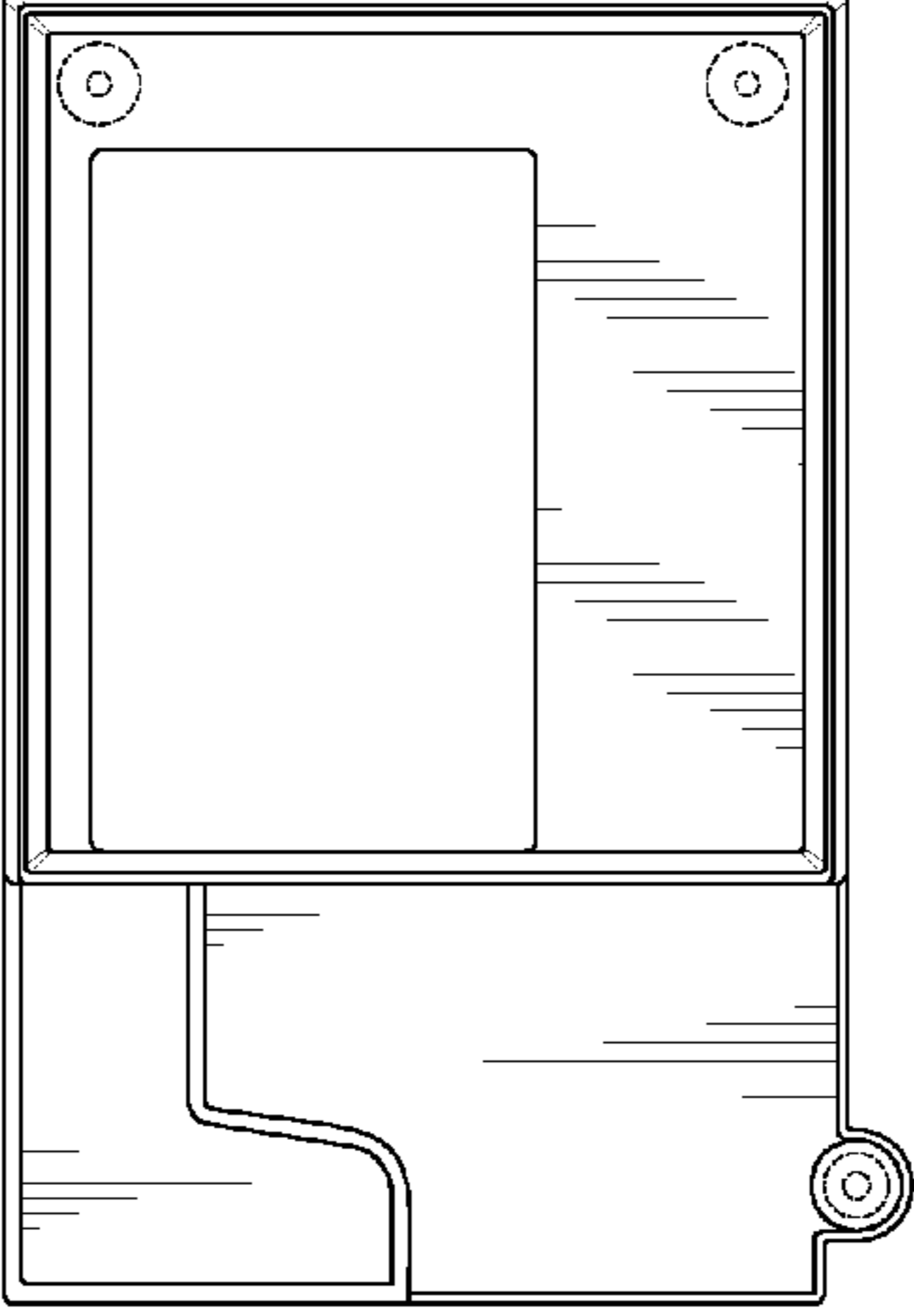

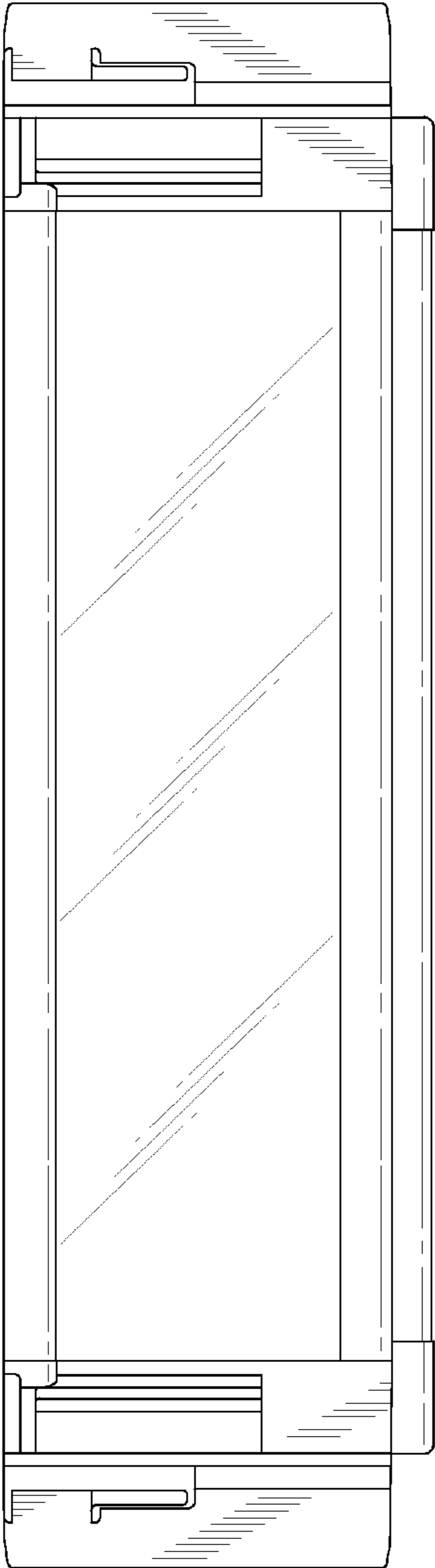

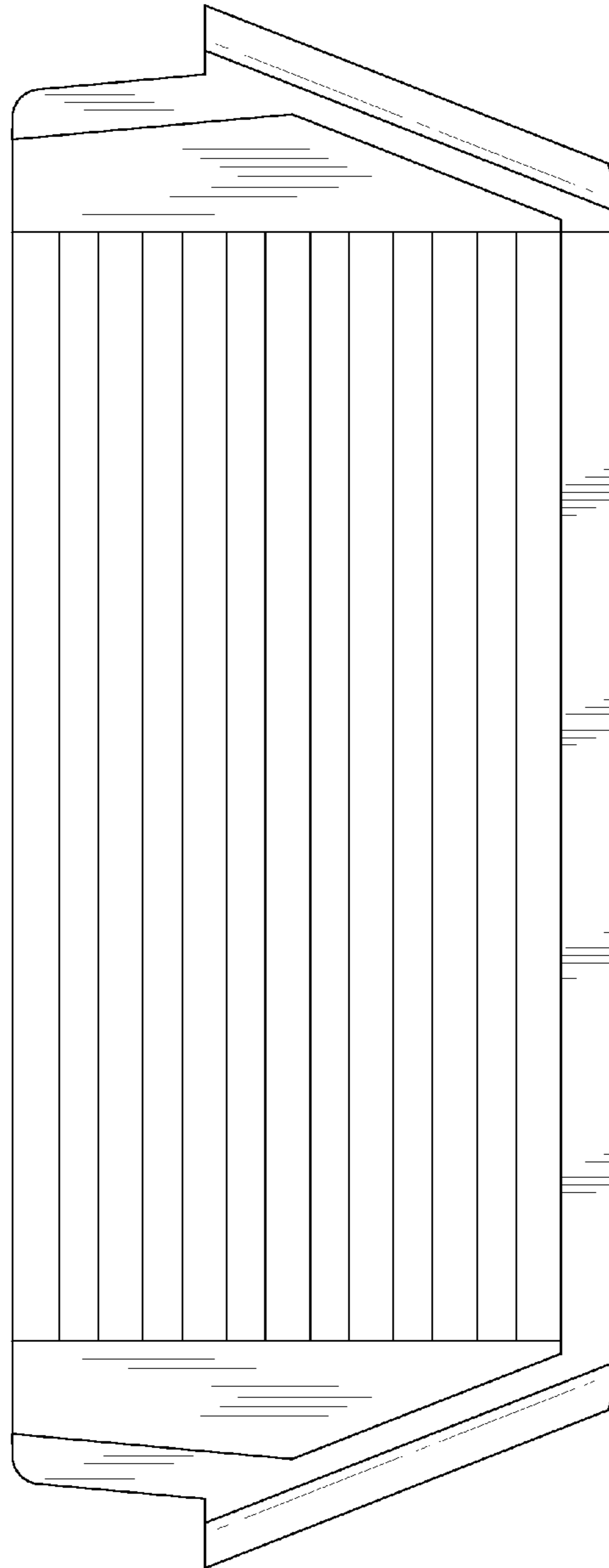

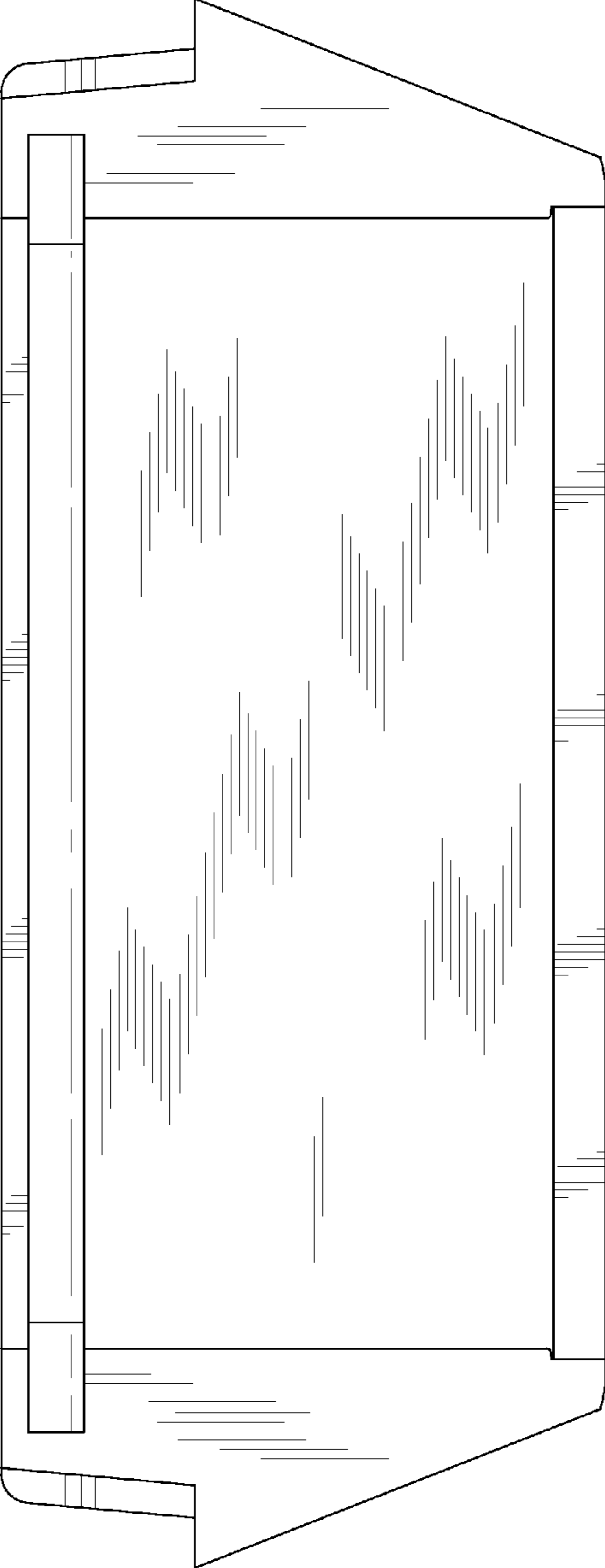
