(57) **CLAIM**

The ornamental design for an optical filter wheel for a microscope, as shown and described.

DESCRIPTION

FIG. 1 is an elevated, front perspective view of a first embodiment of an optical filter wheel for a microscope according to our design;

FIG. 17 is a bottom view thereof;

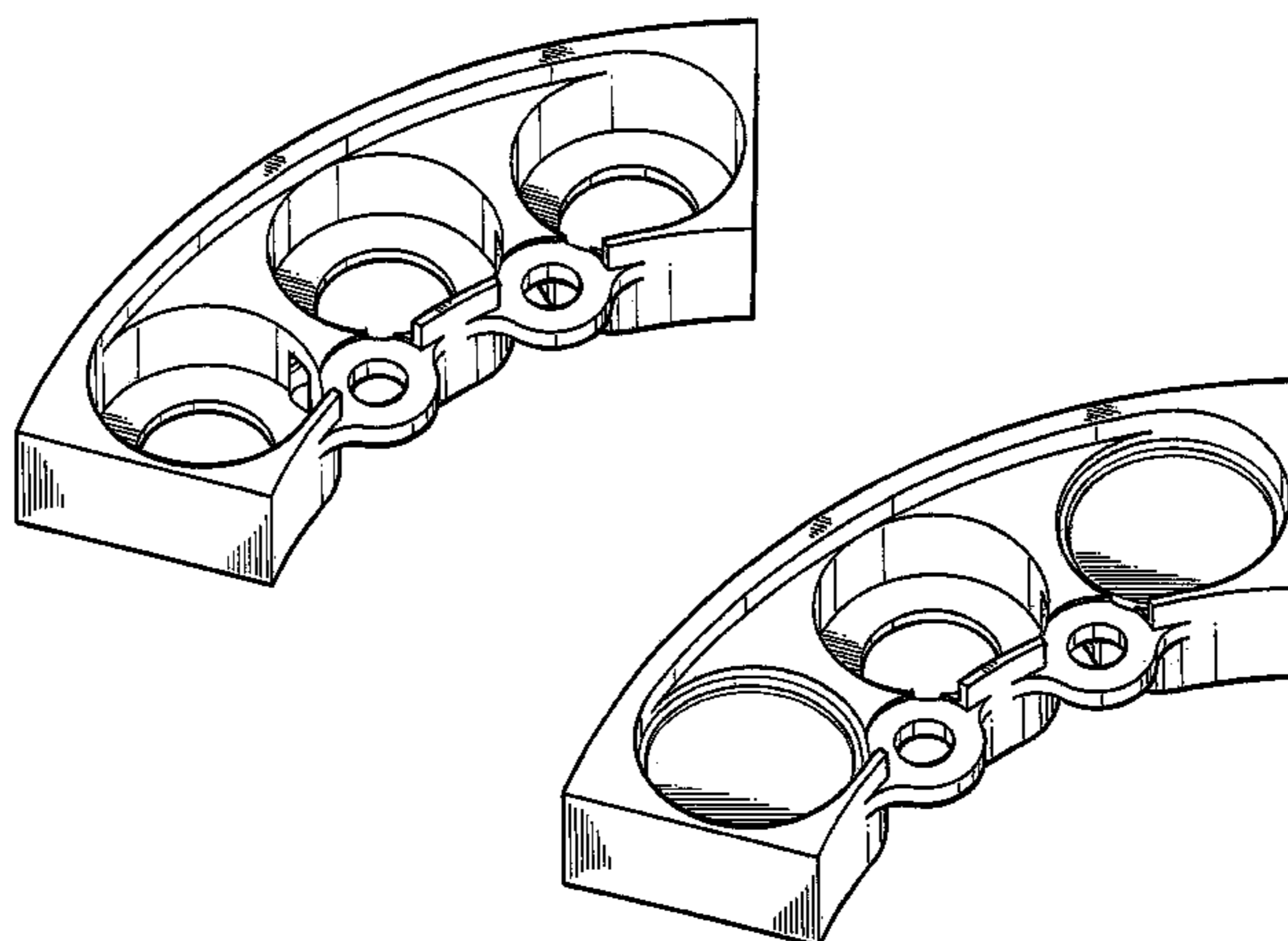
FIG. 18 is a right side view thereof;

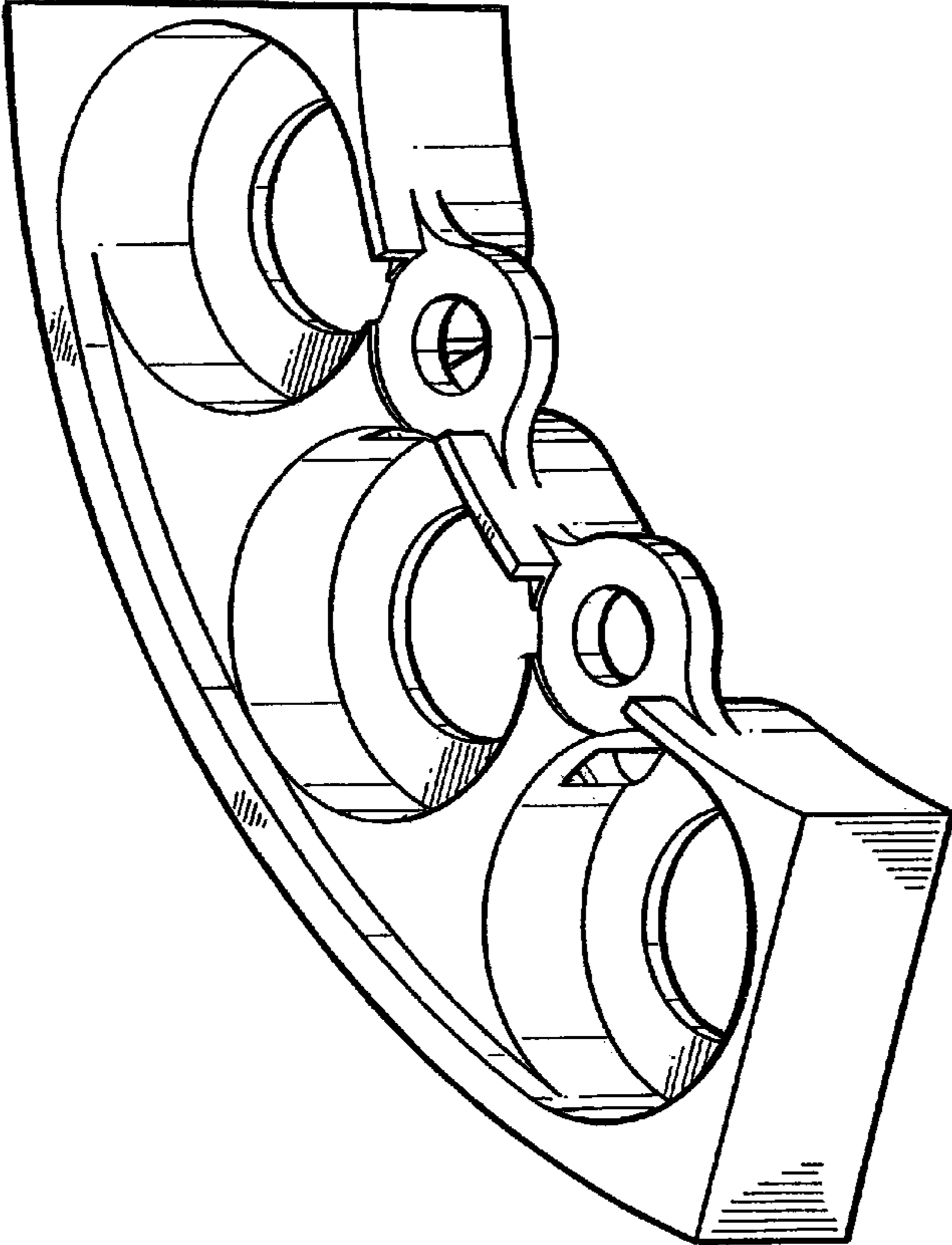

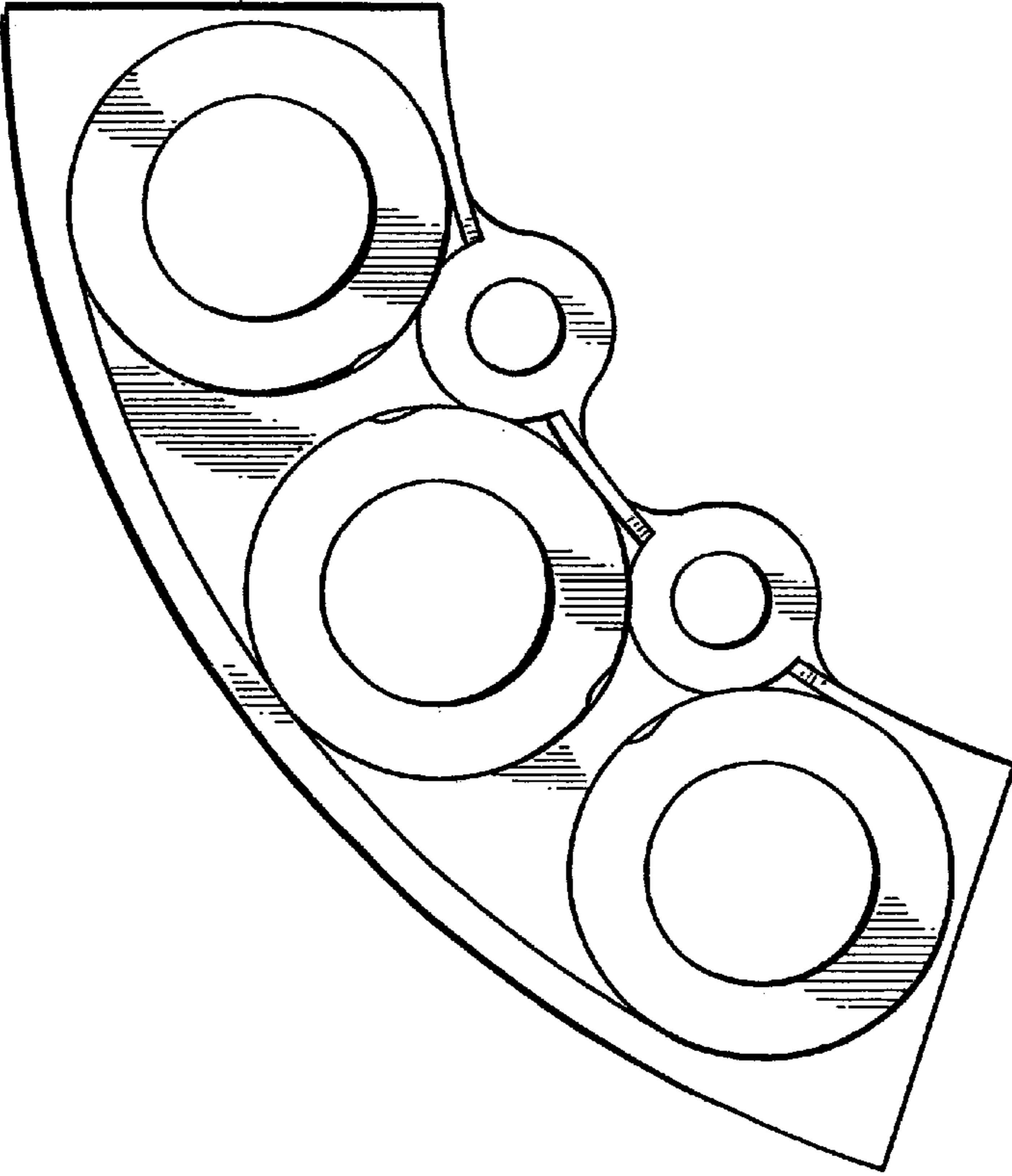

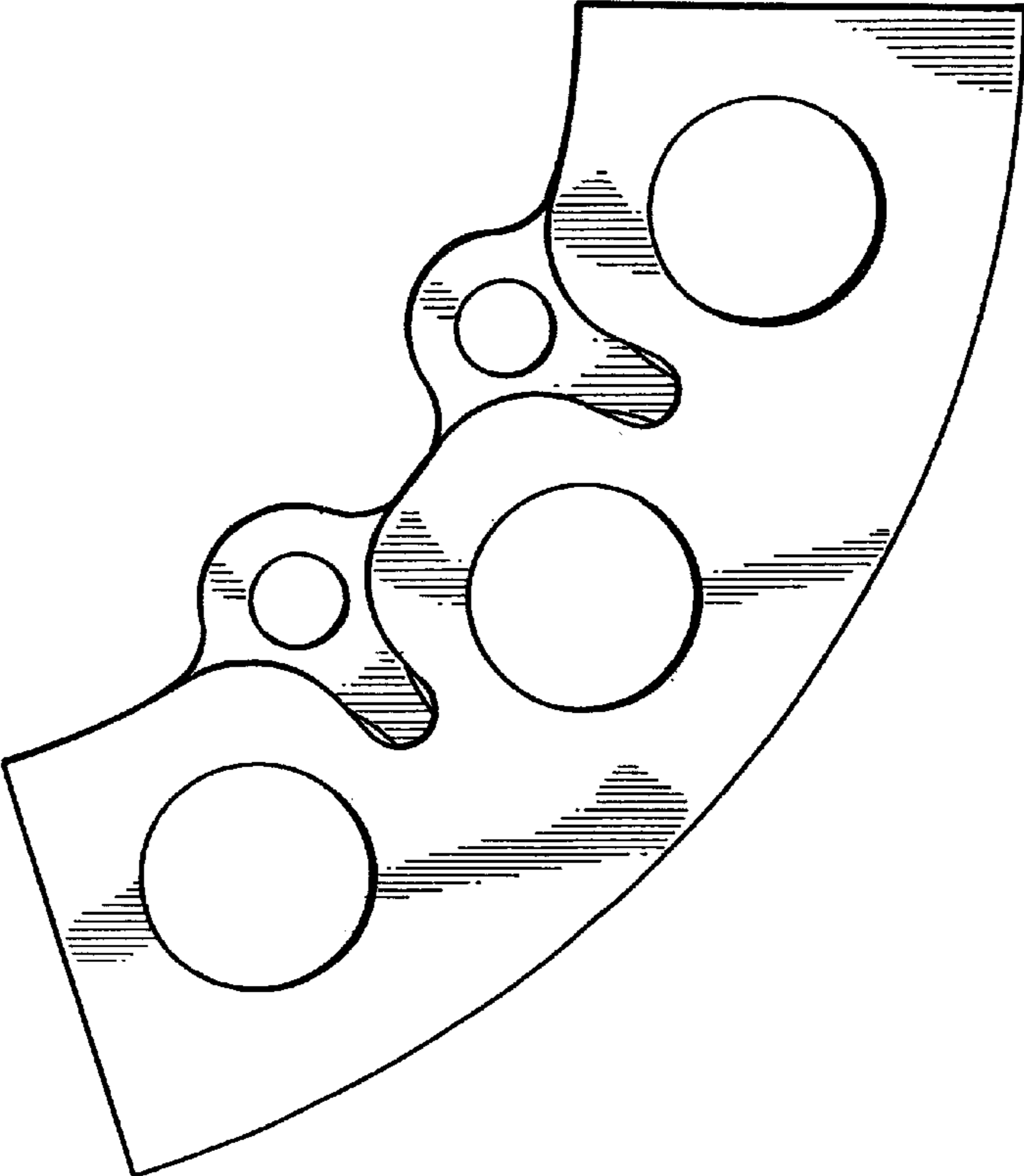

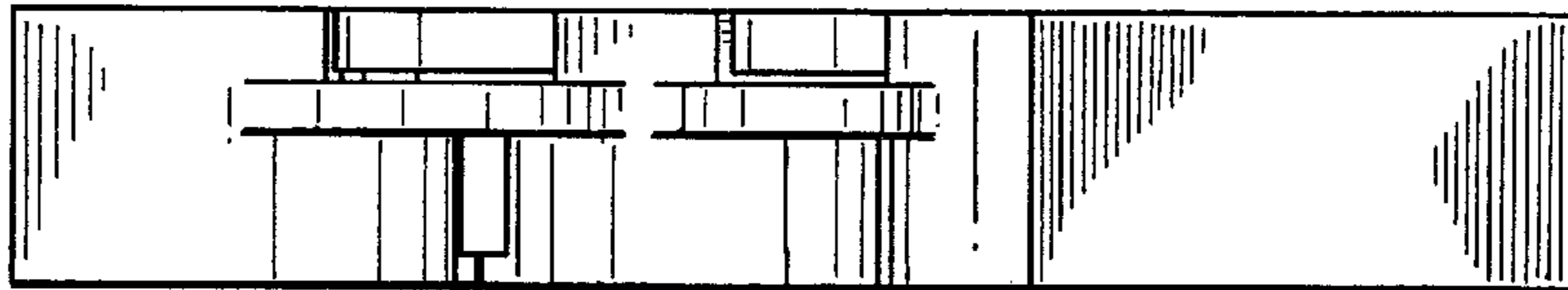

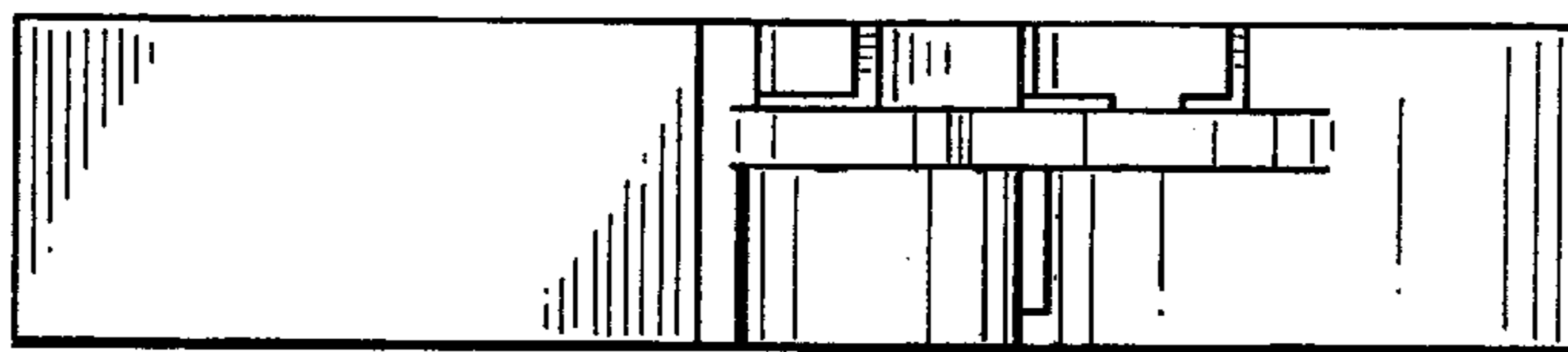

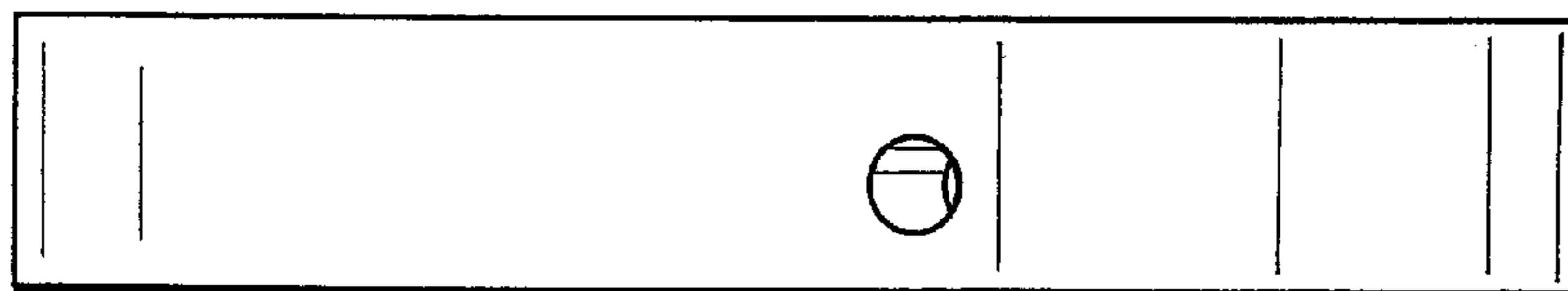

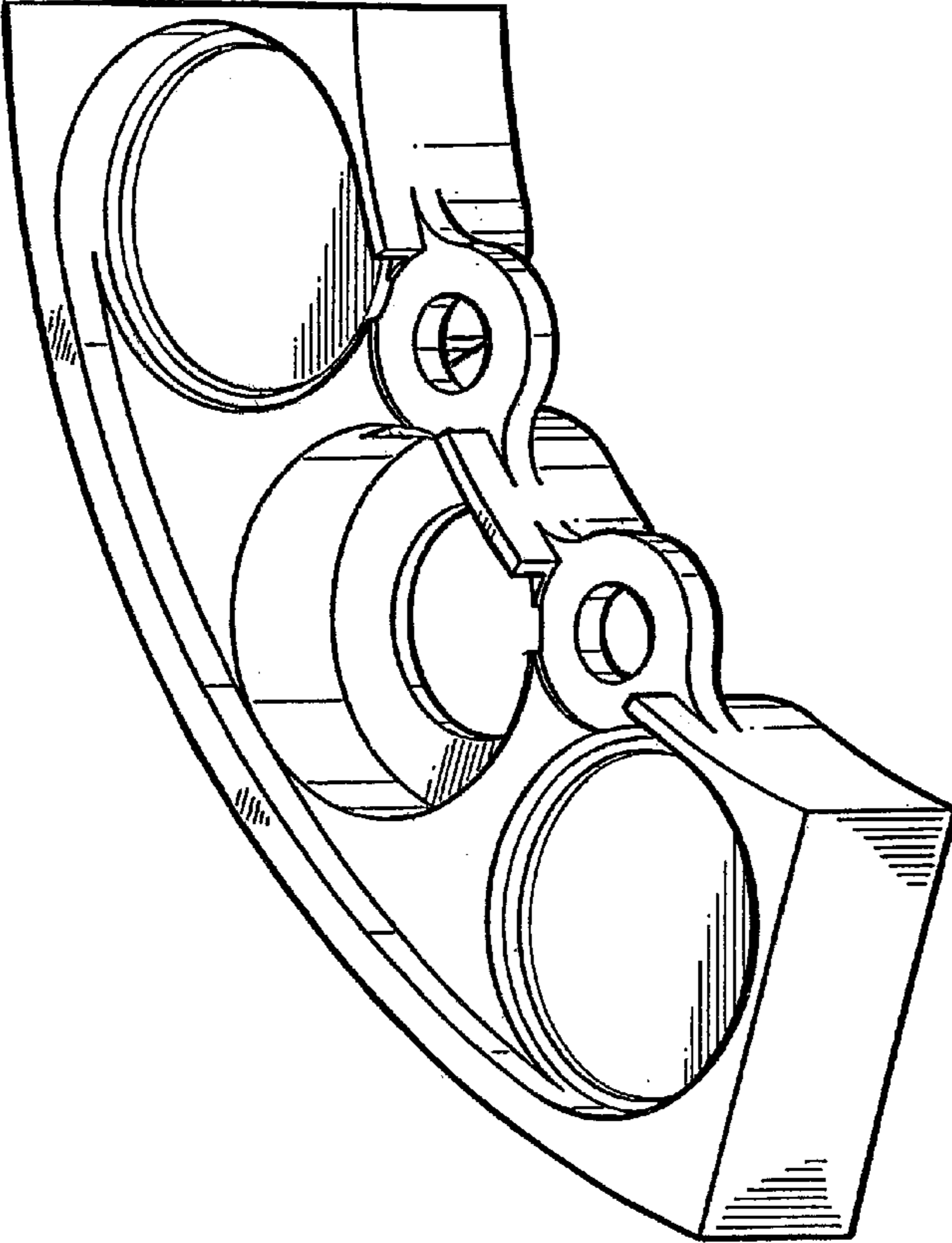

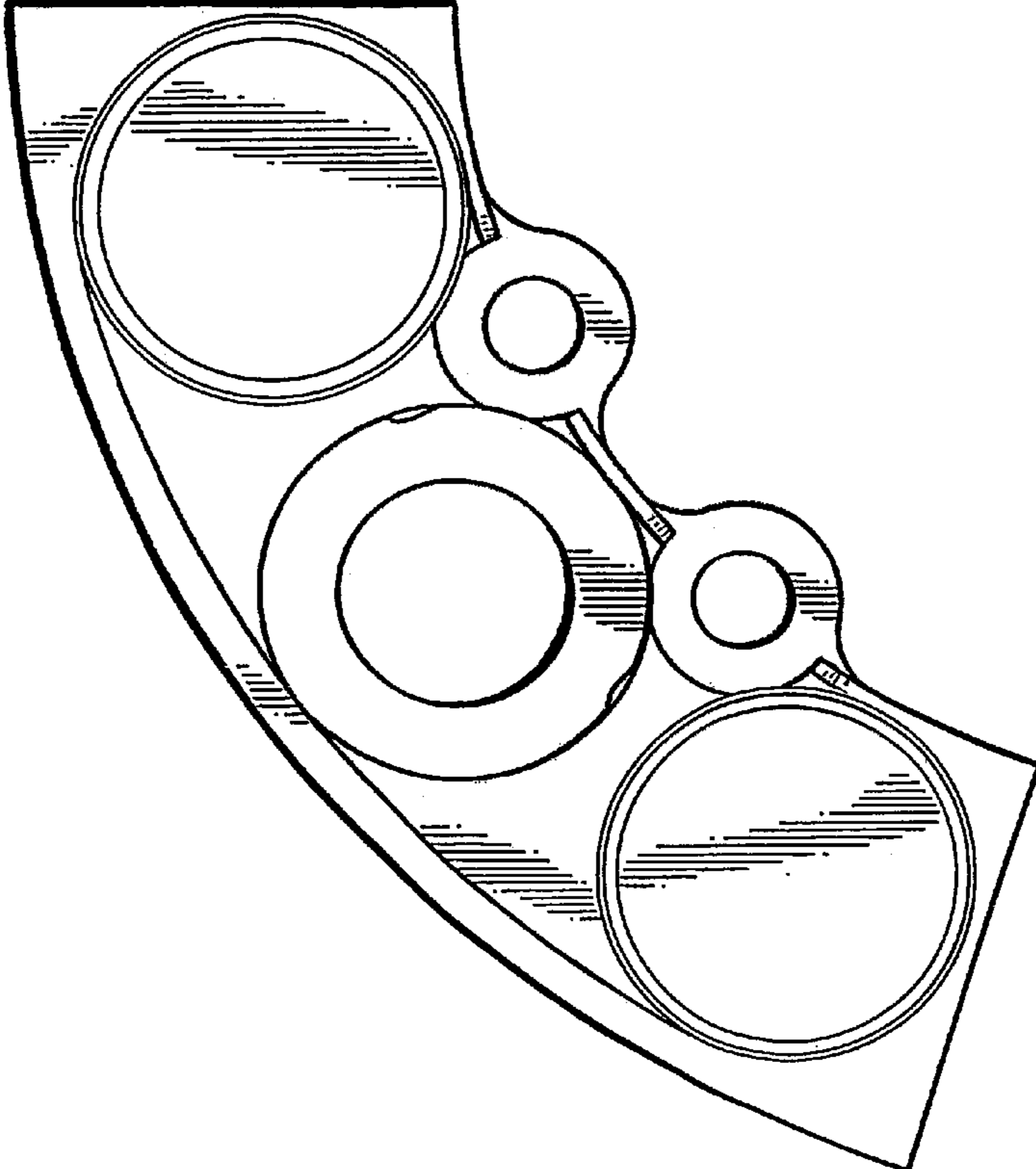

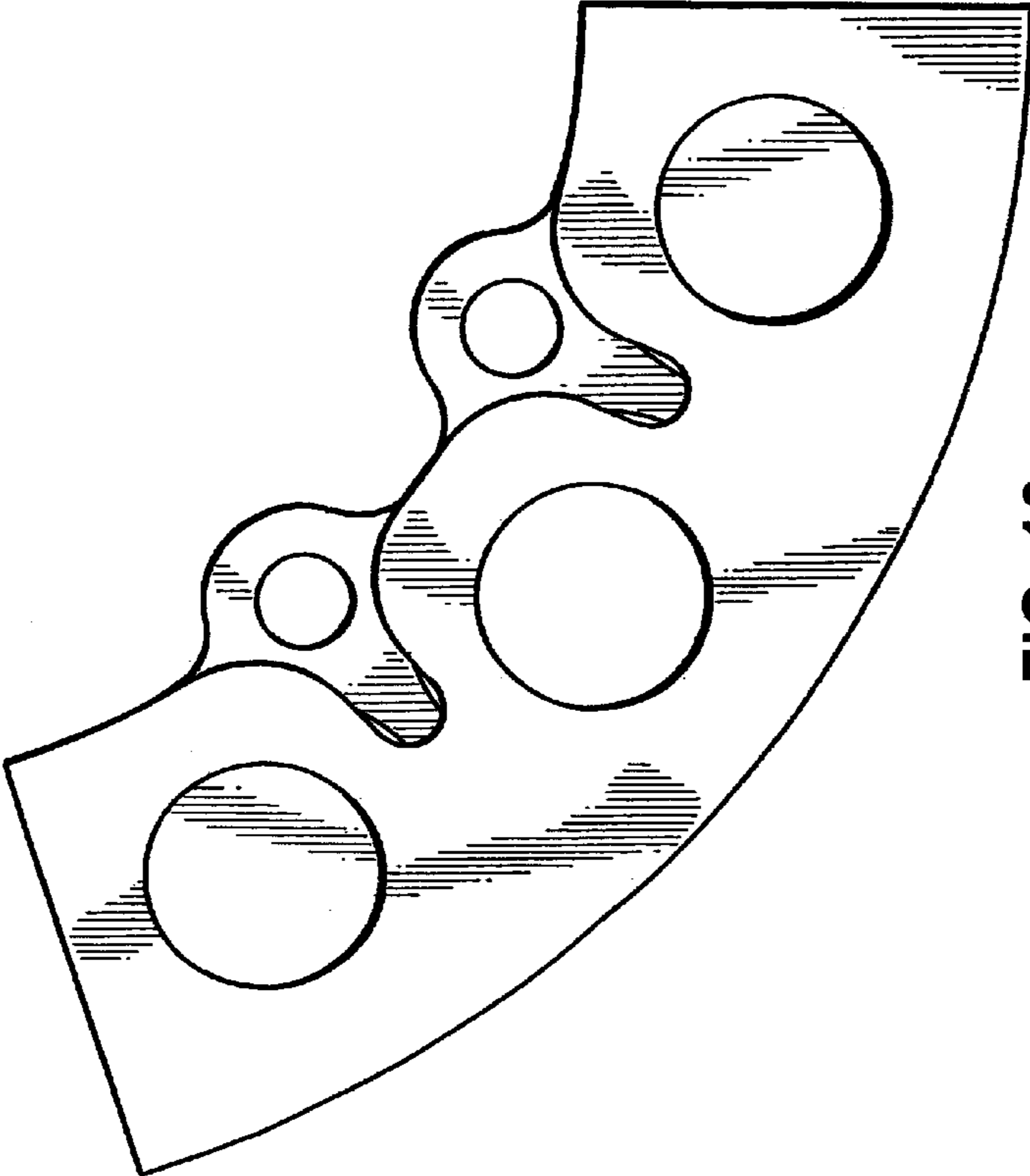

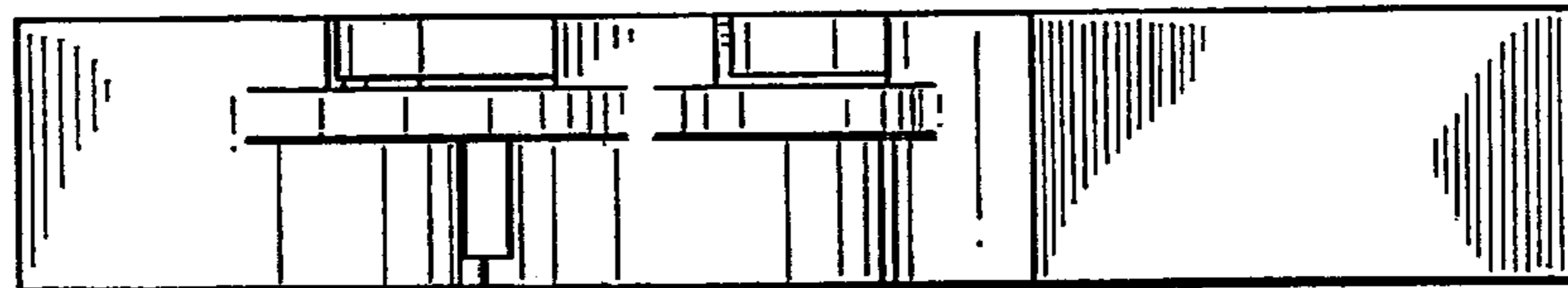

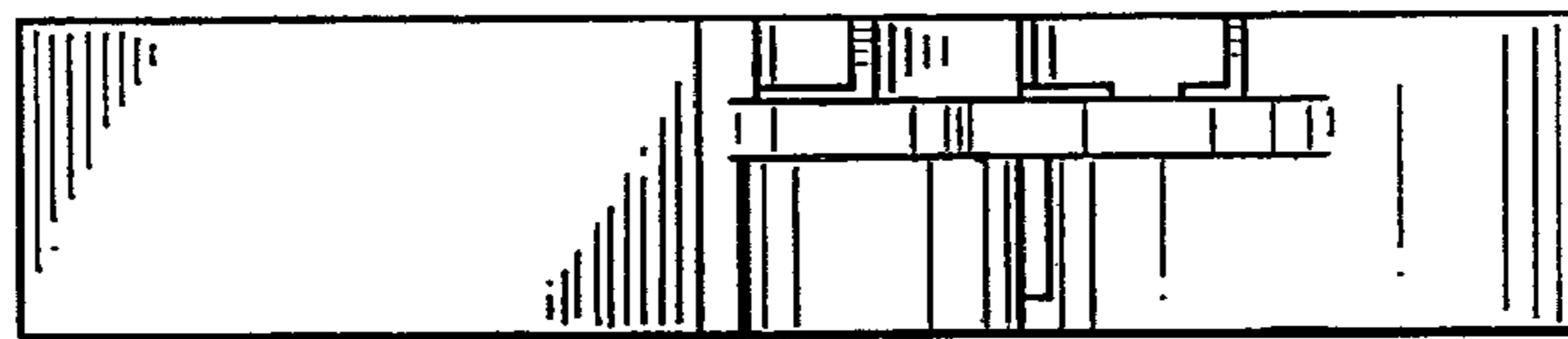

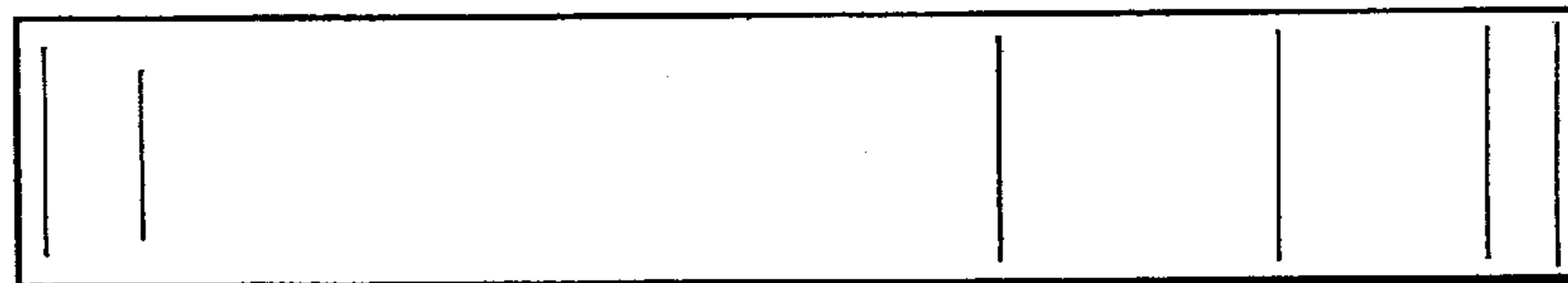

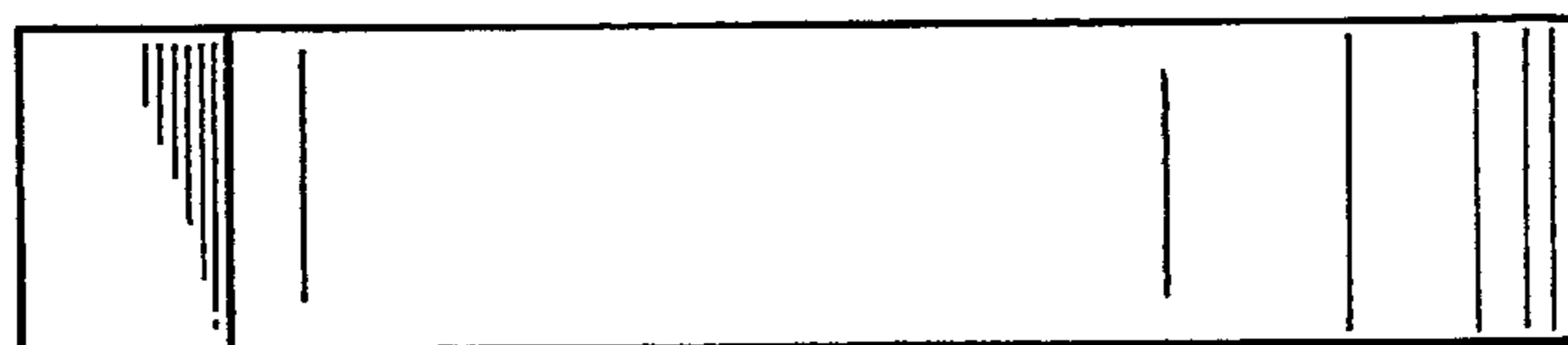

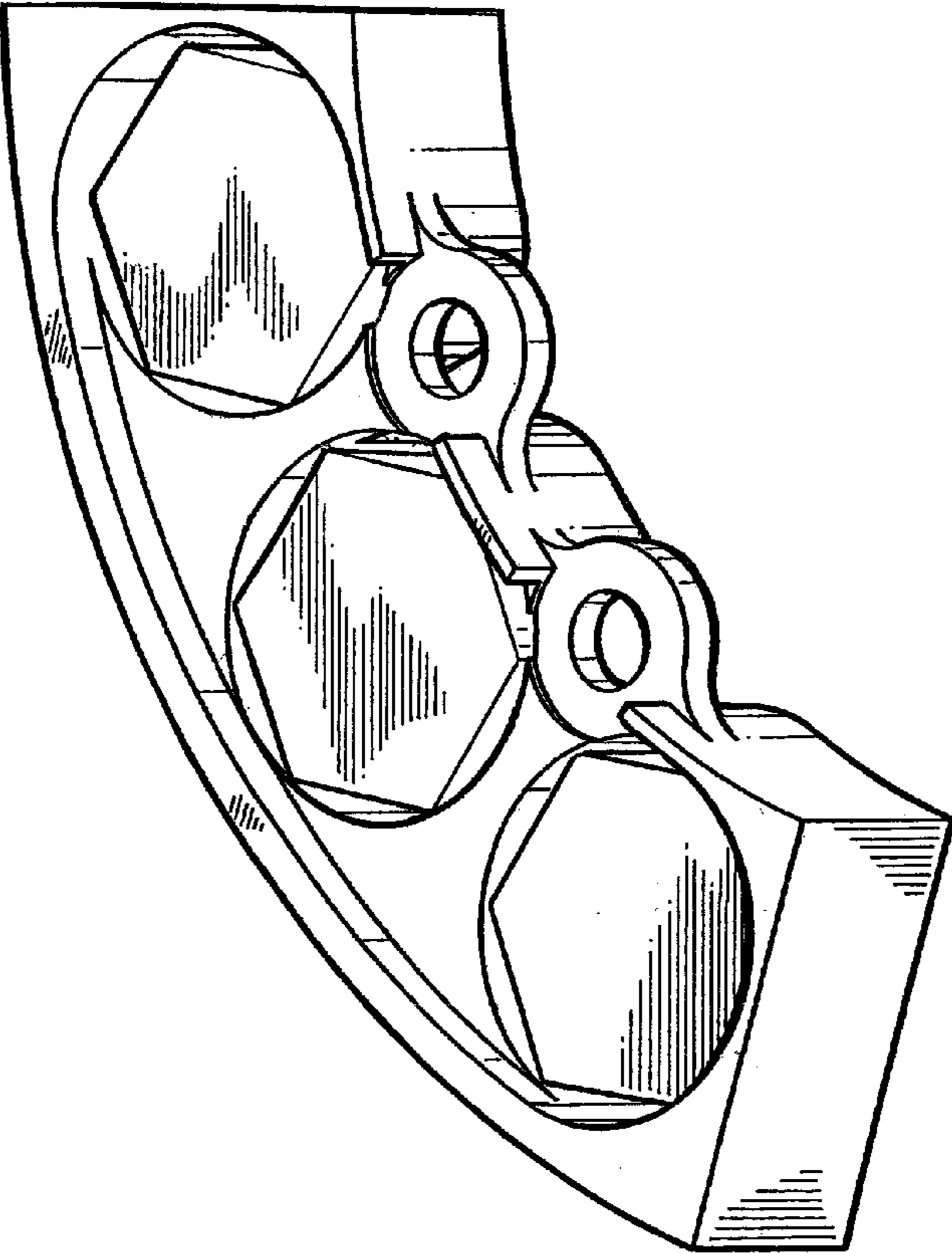

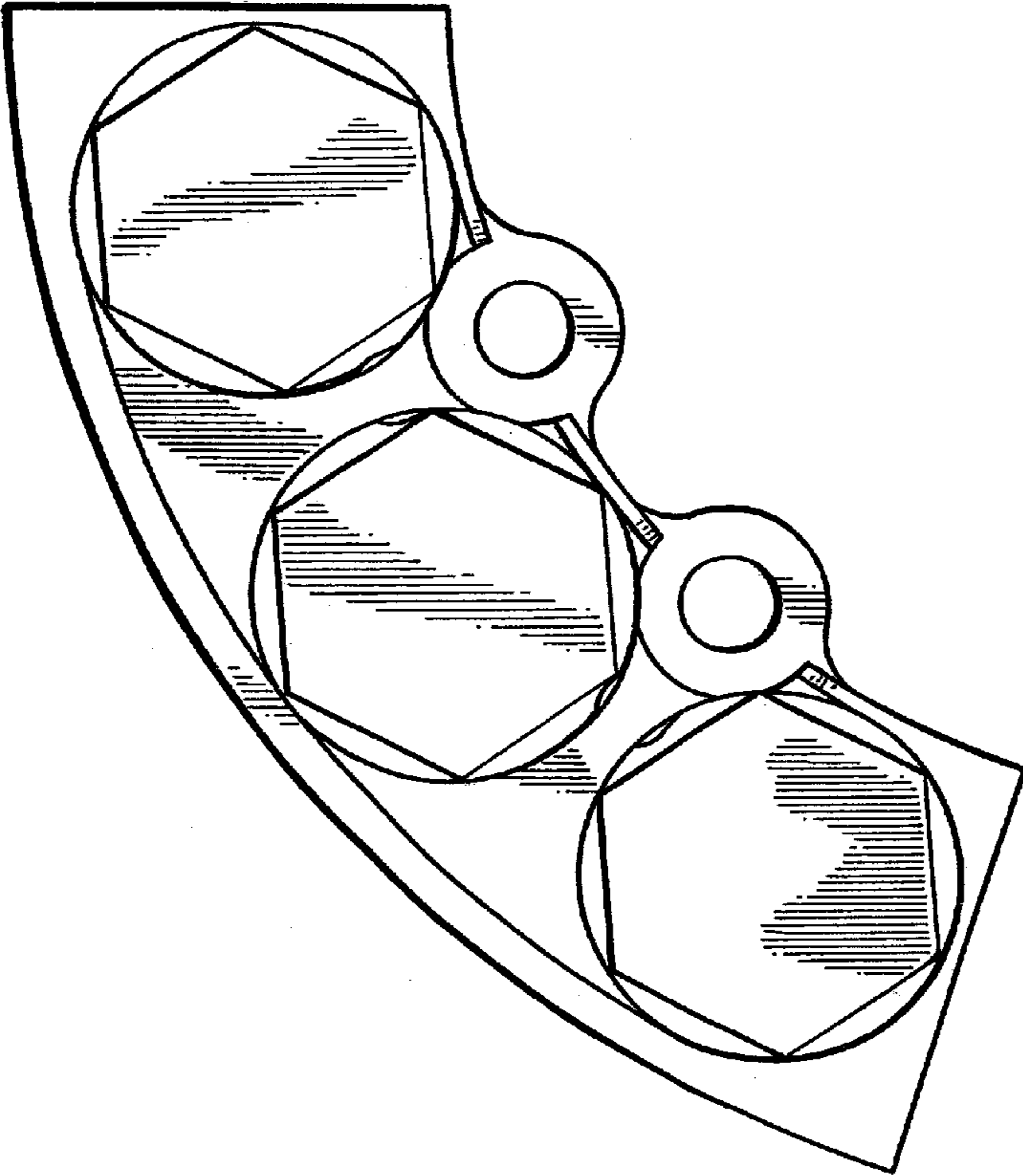

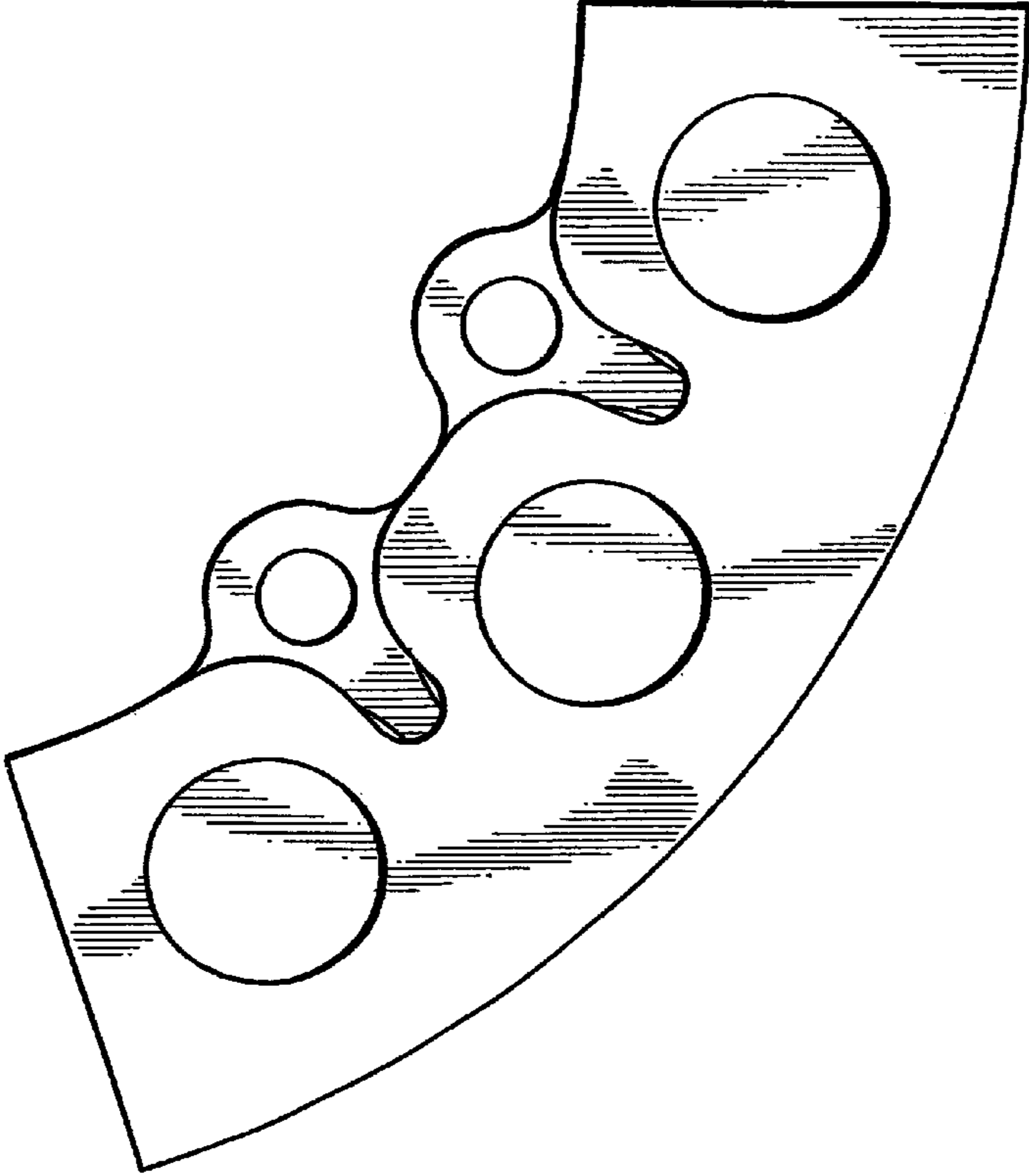

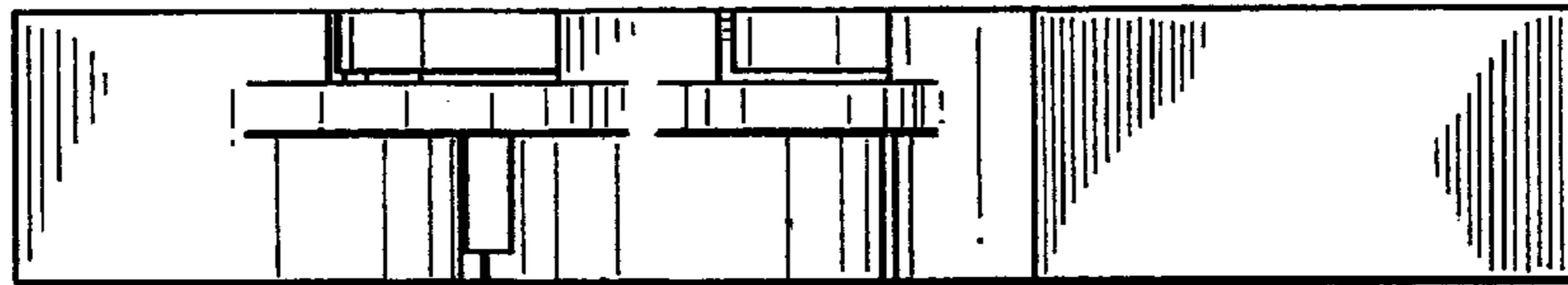

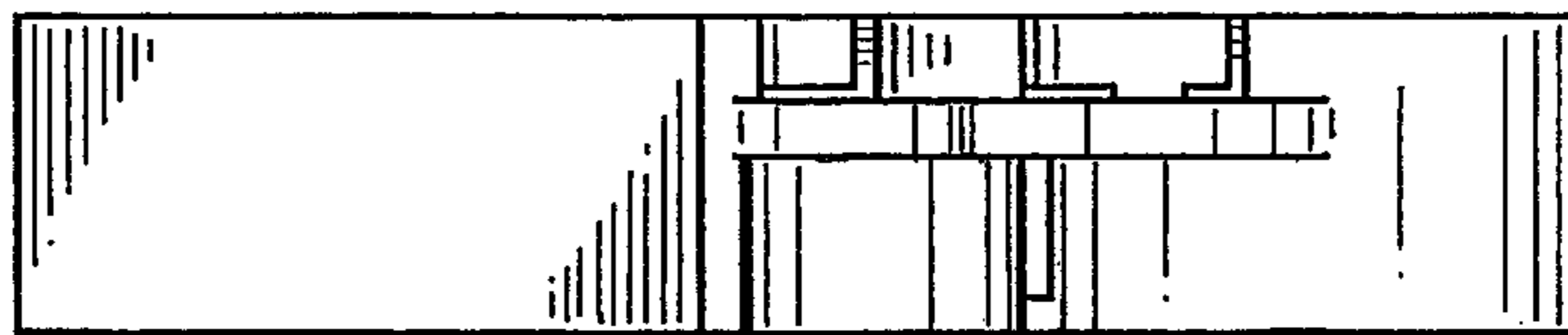

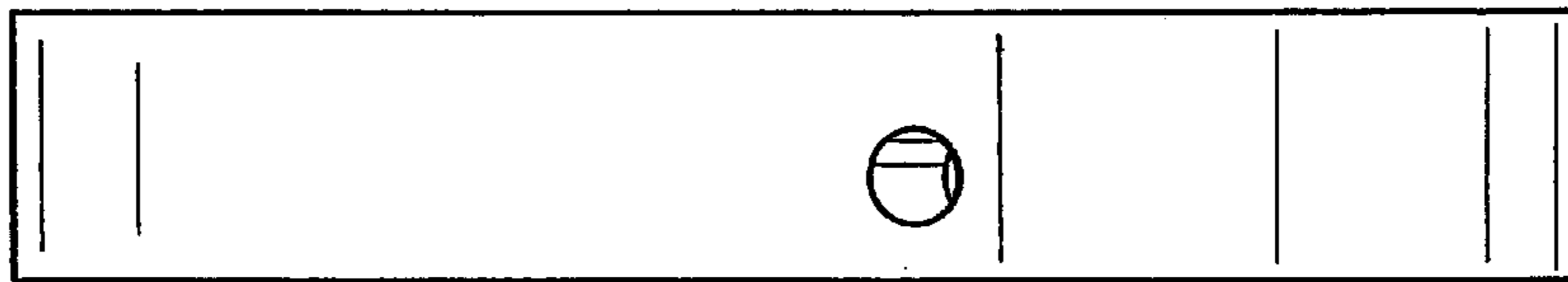

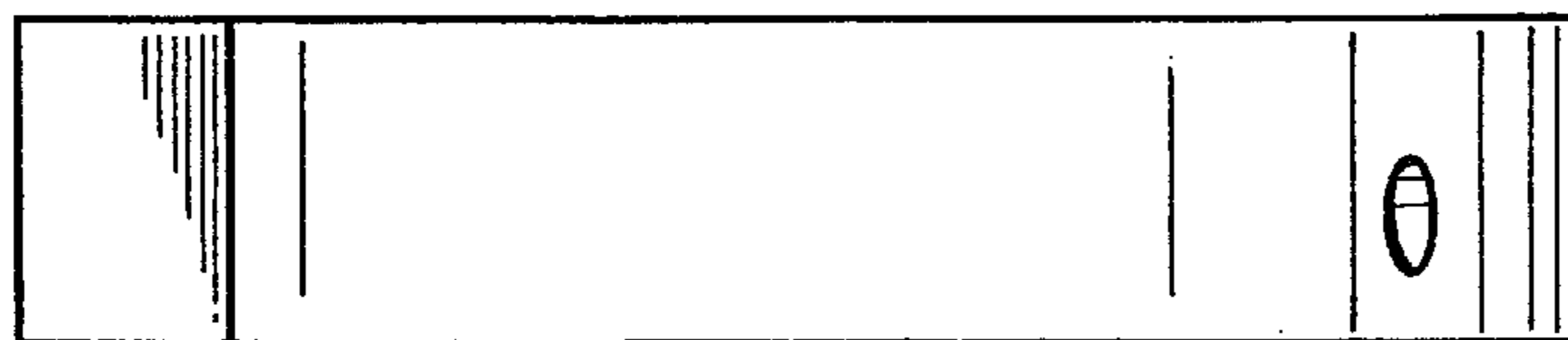
