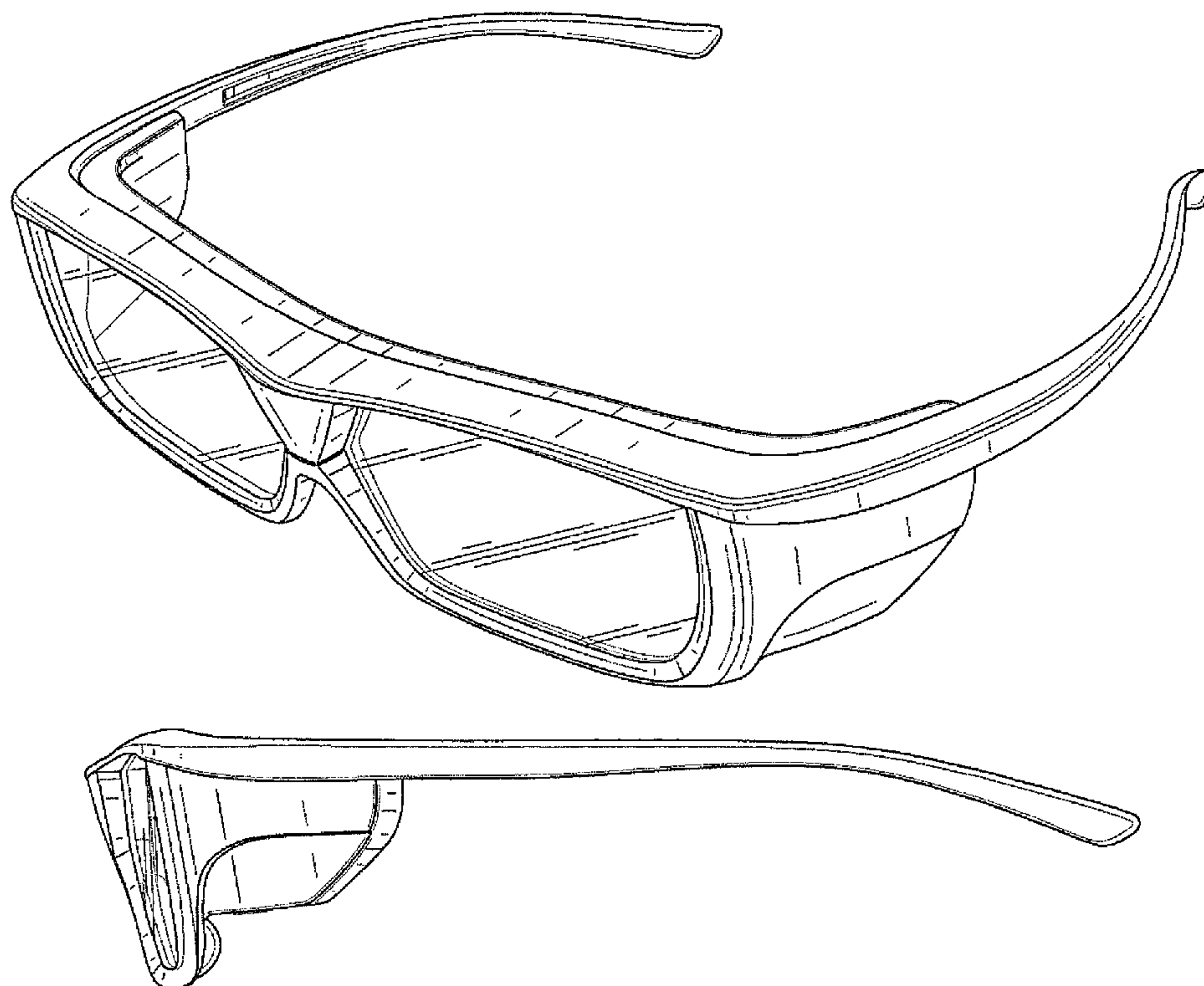
(57) **CLAIM**

The ornamental design for “3D glasses,” as shown and described.

DESCRIPTION

FIG. 1 is a right, front, top perspective view of 3D glasses in accordance with our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side elevation view thereof, the left side elevation being a mirror image thereof; and,
FIG. 7 is an inverted, right rear perspective view thereof.

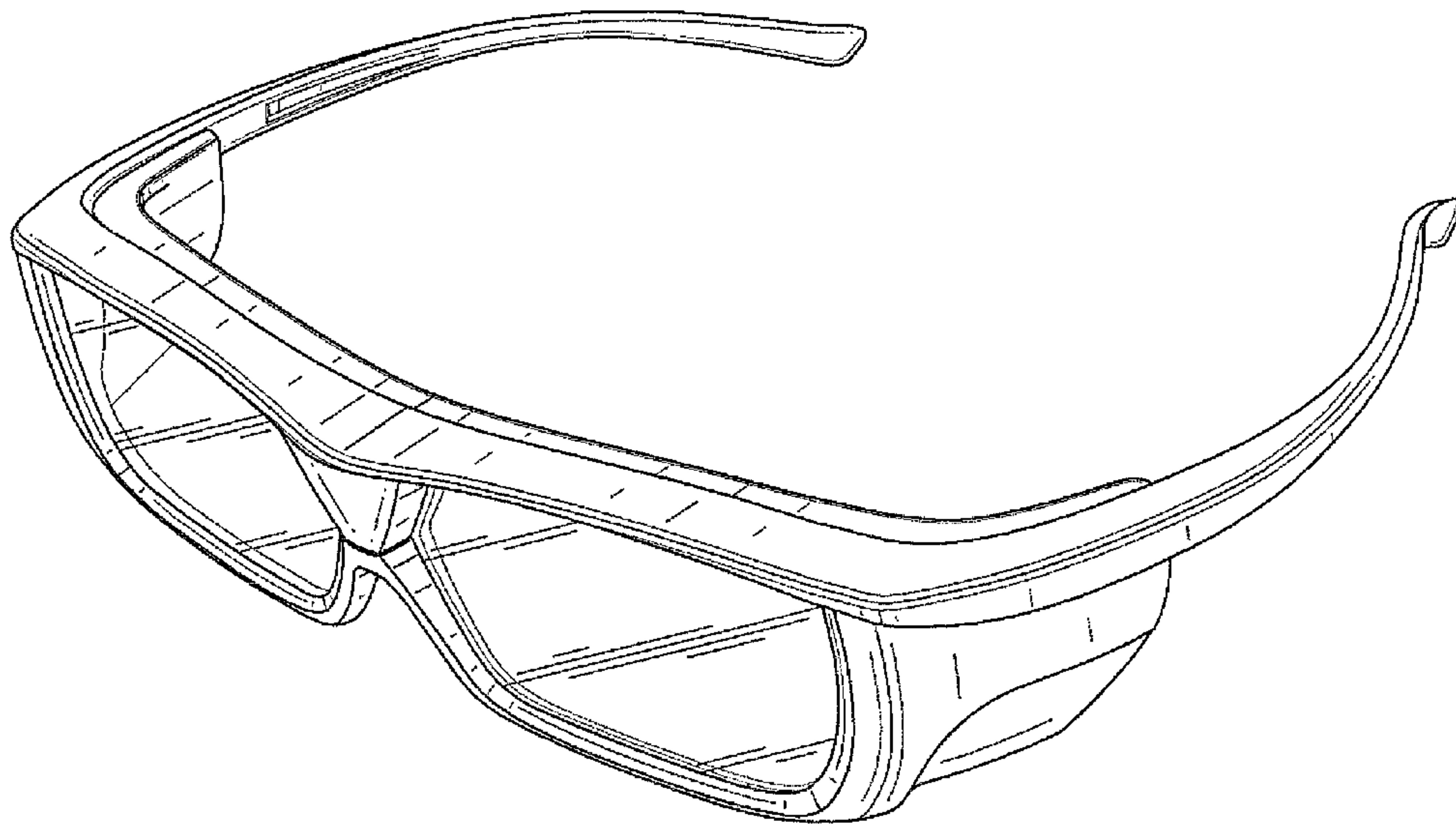

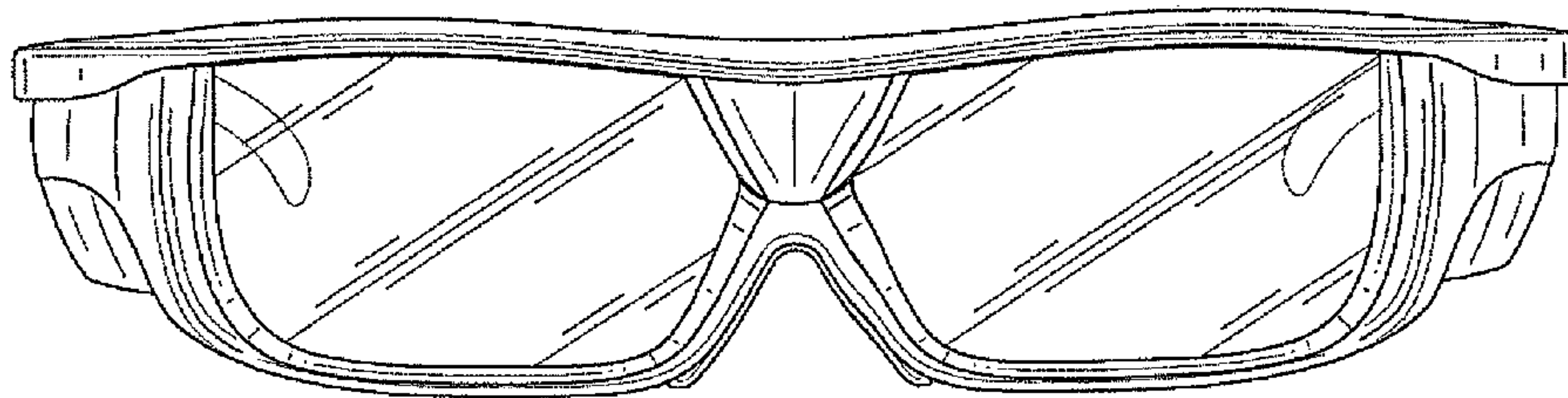

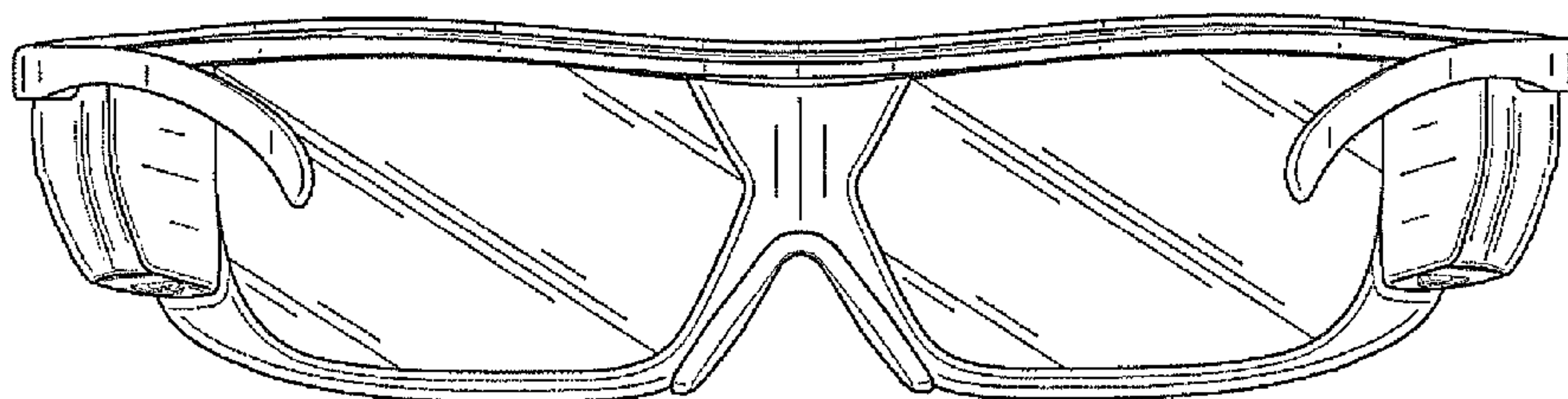

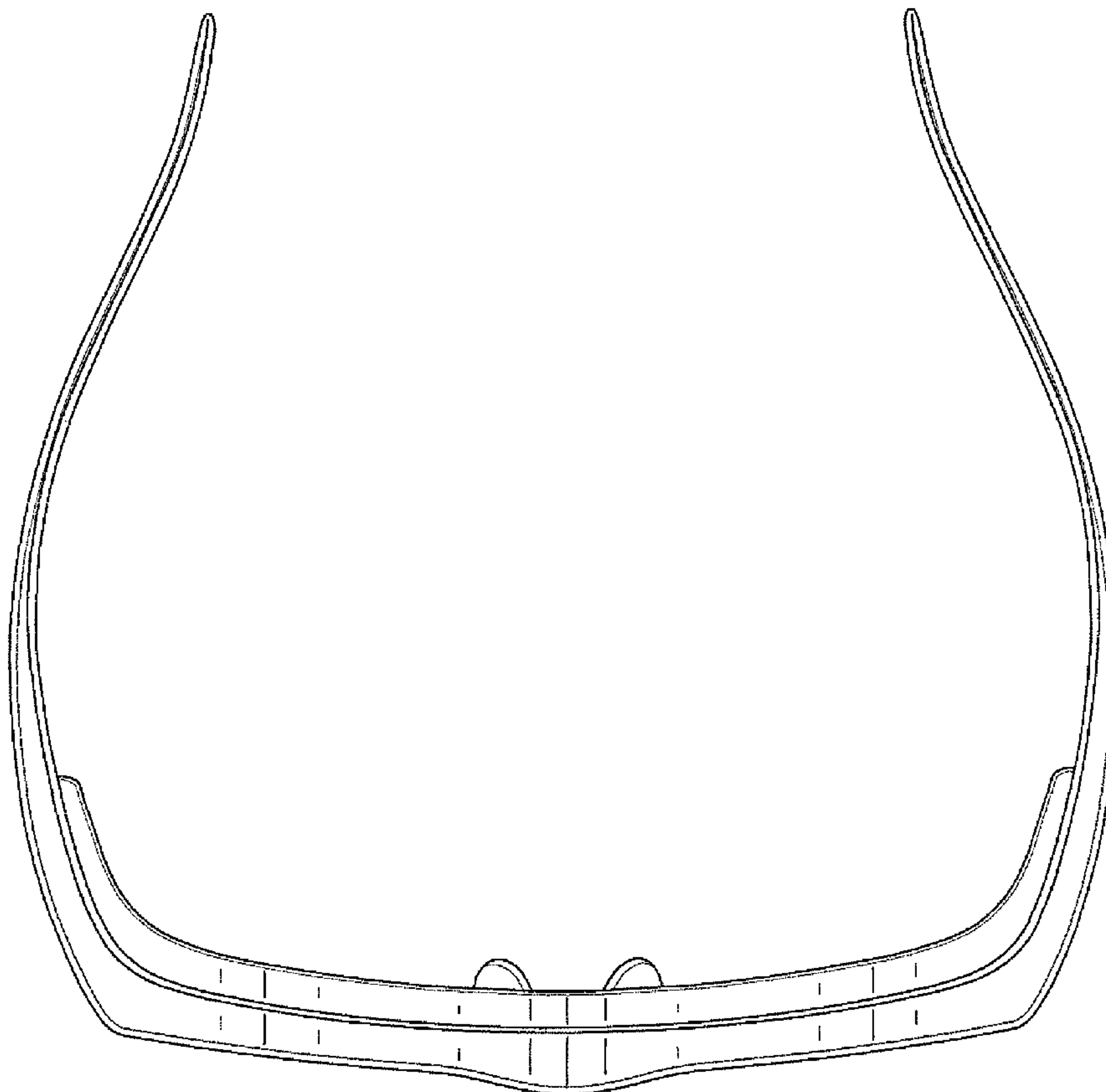

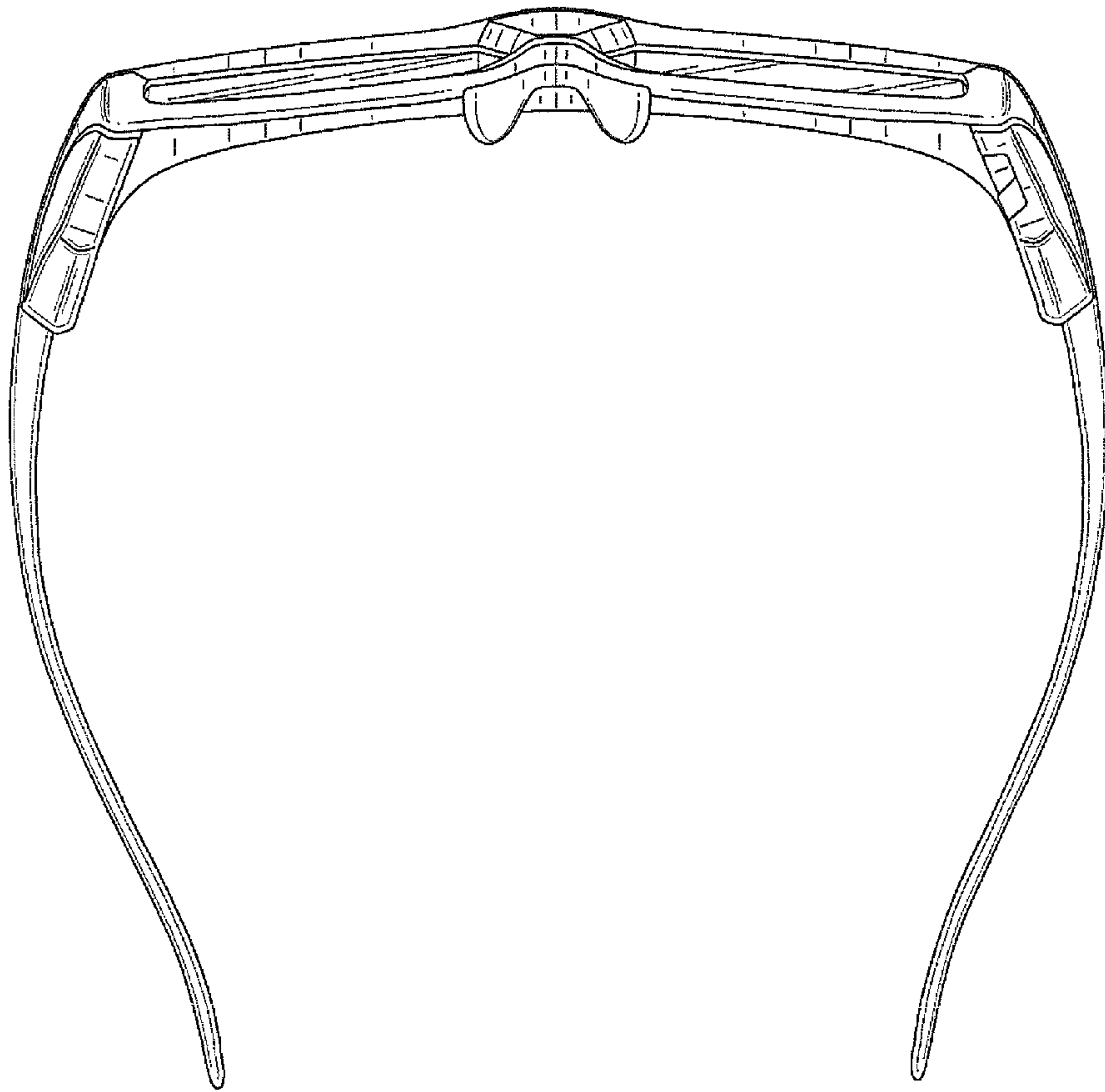

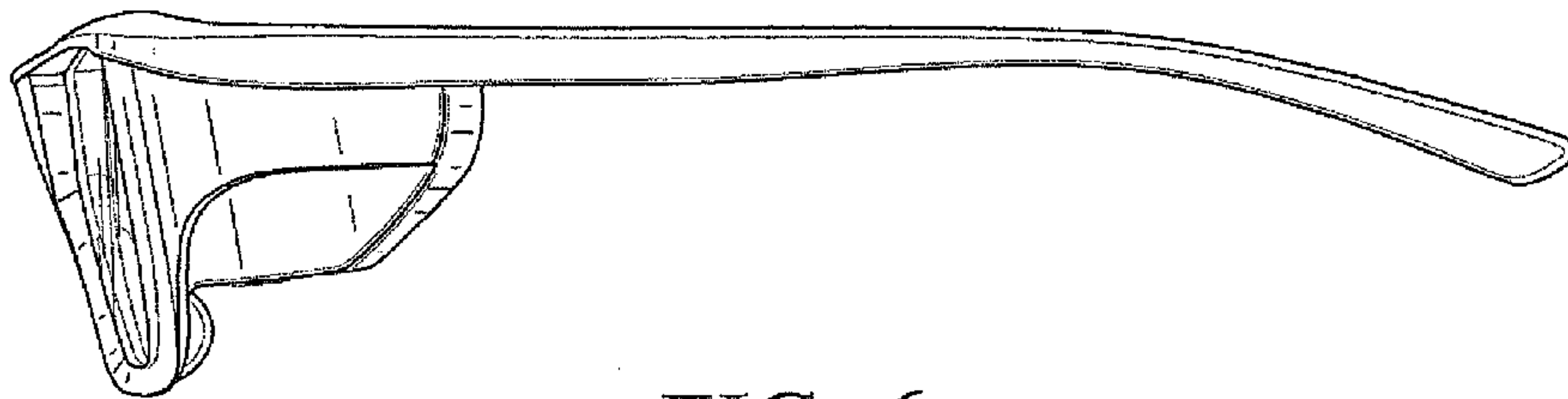

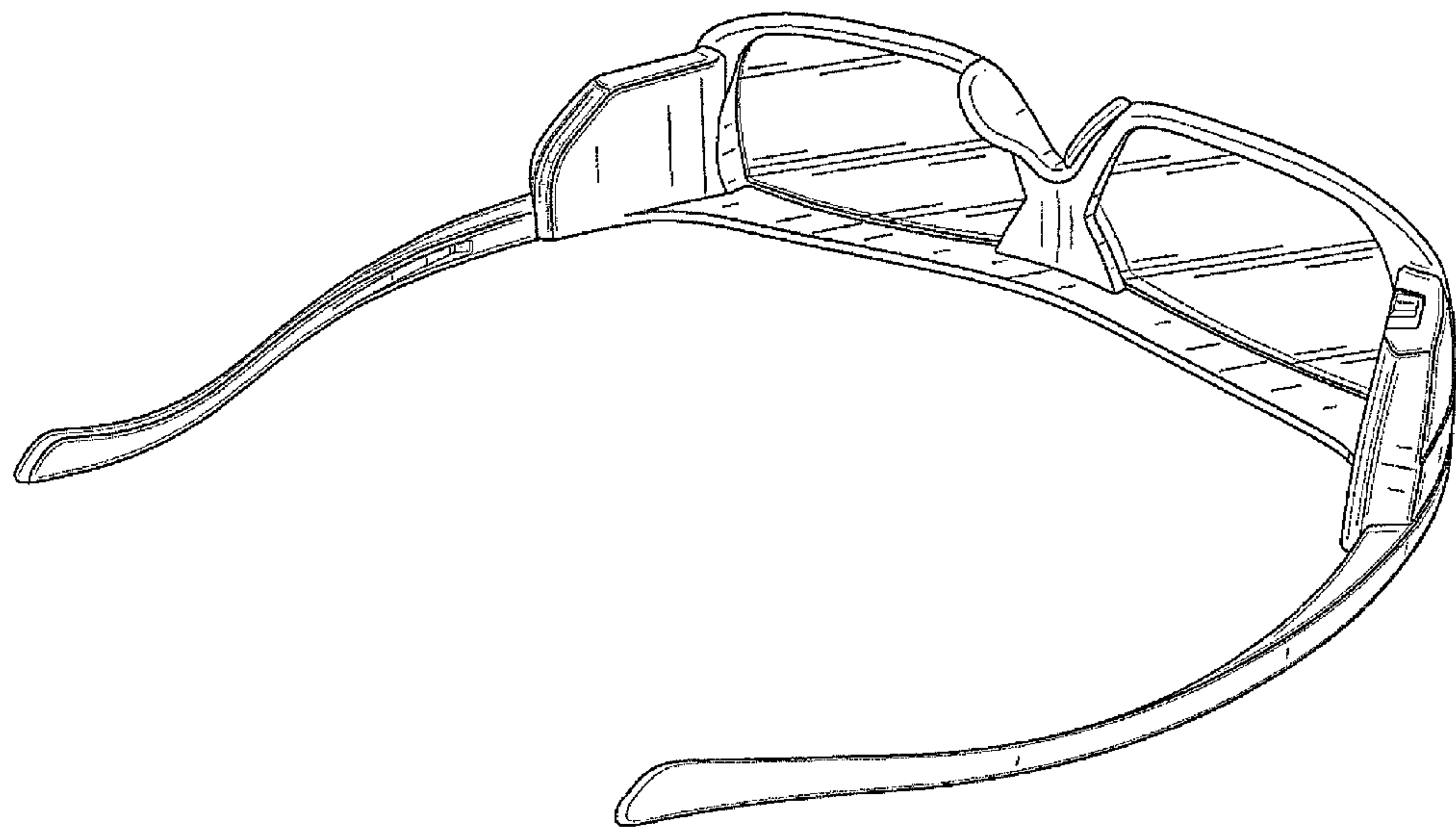
