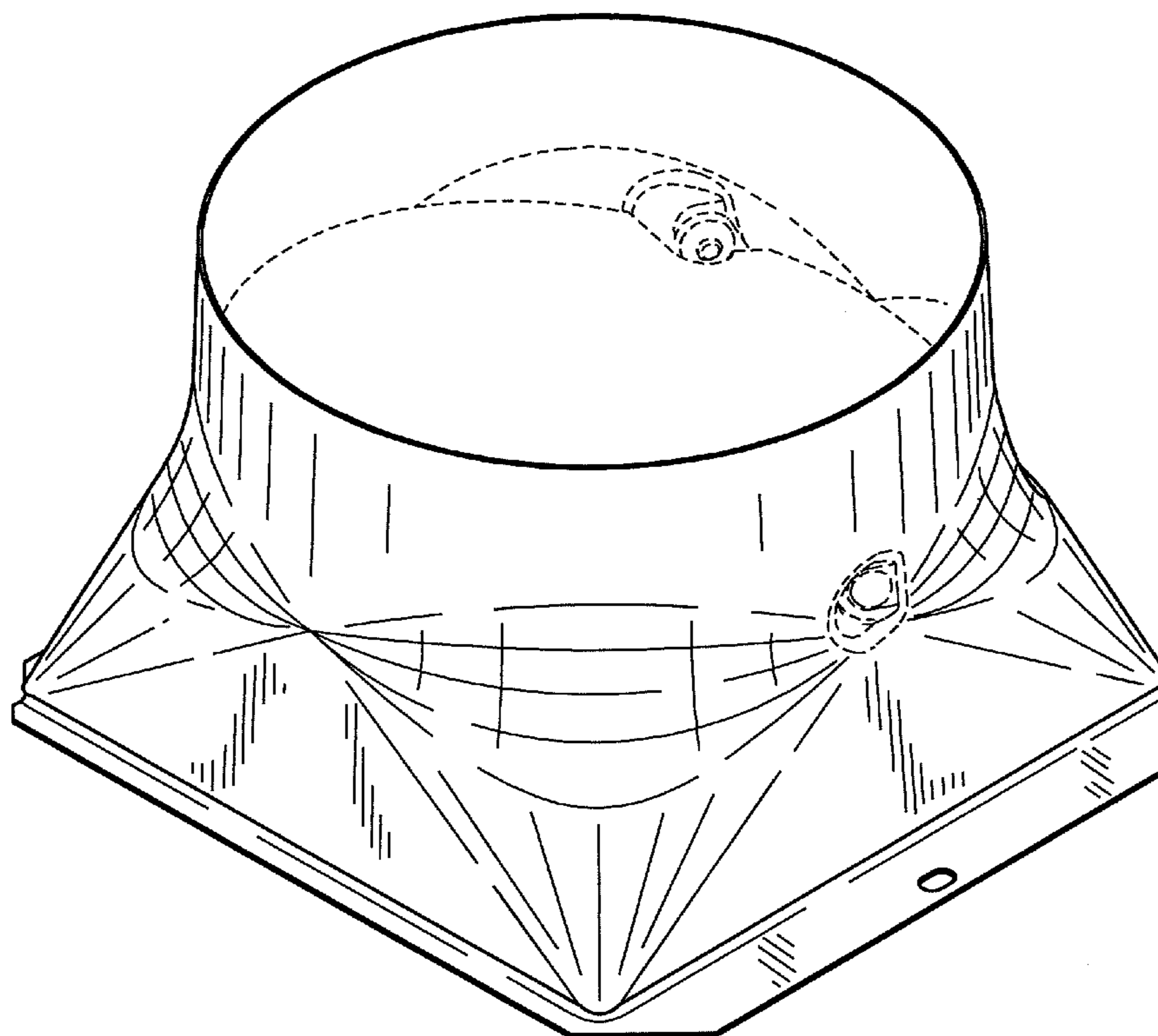
(57) **CLAIM**

We claim the ornamental design for a duct connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a duct connector;

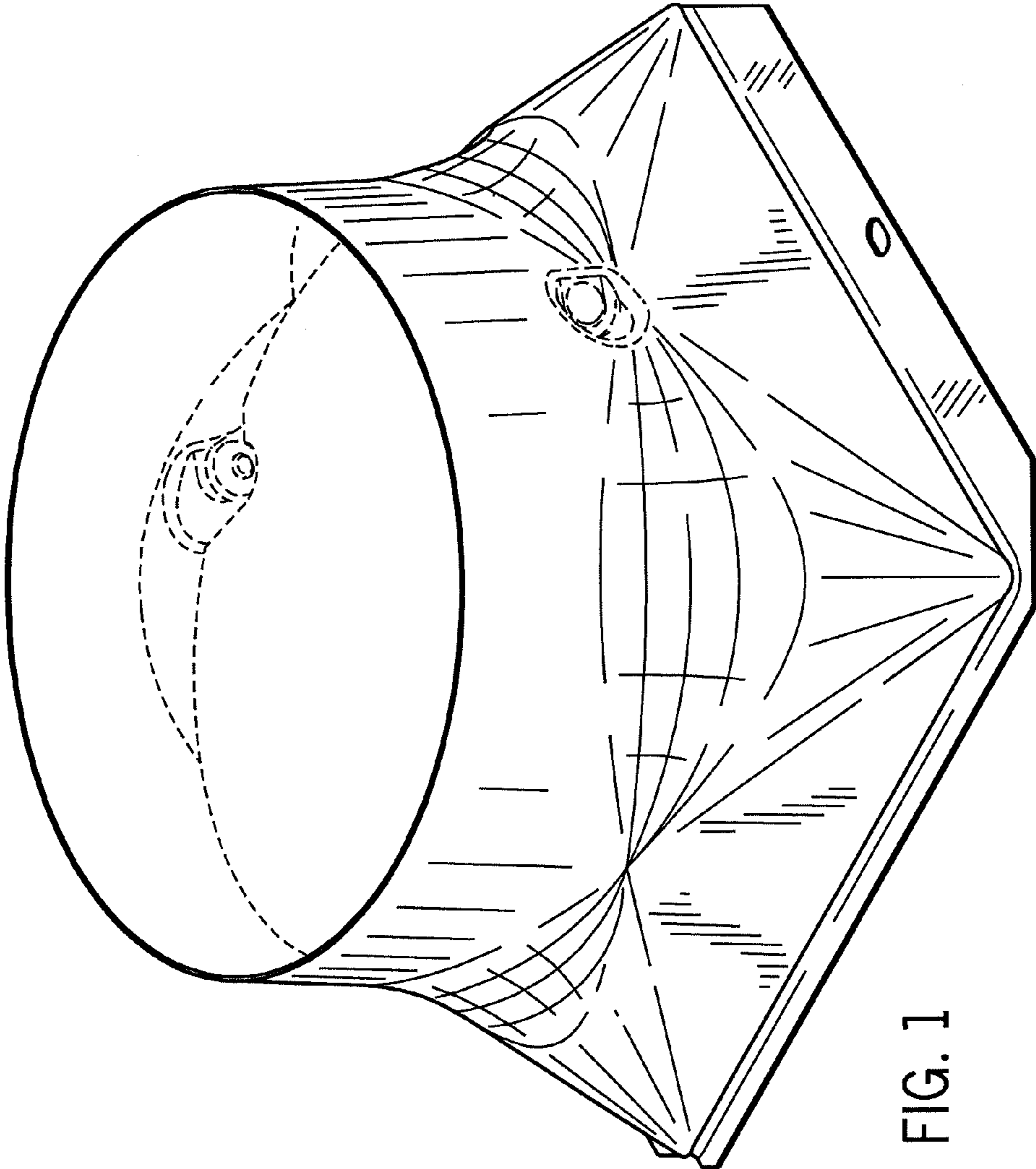

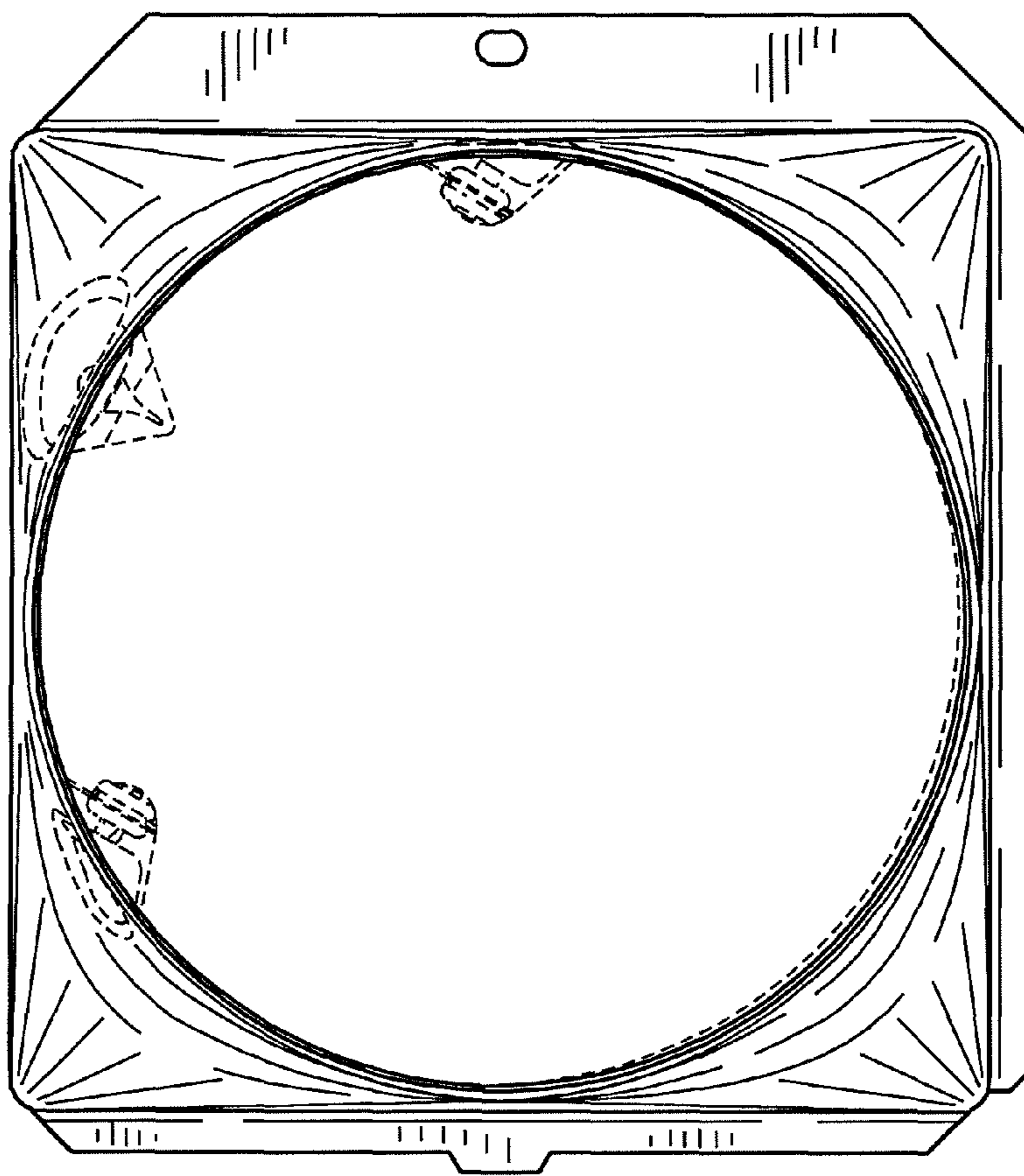

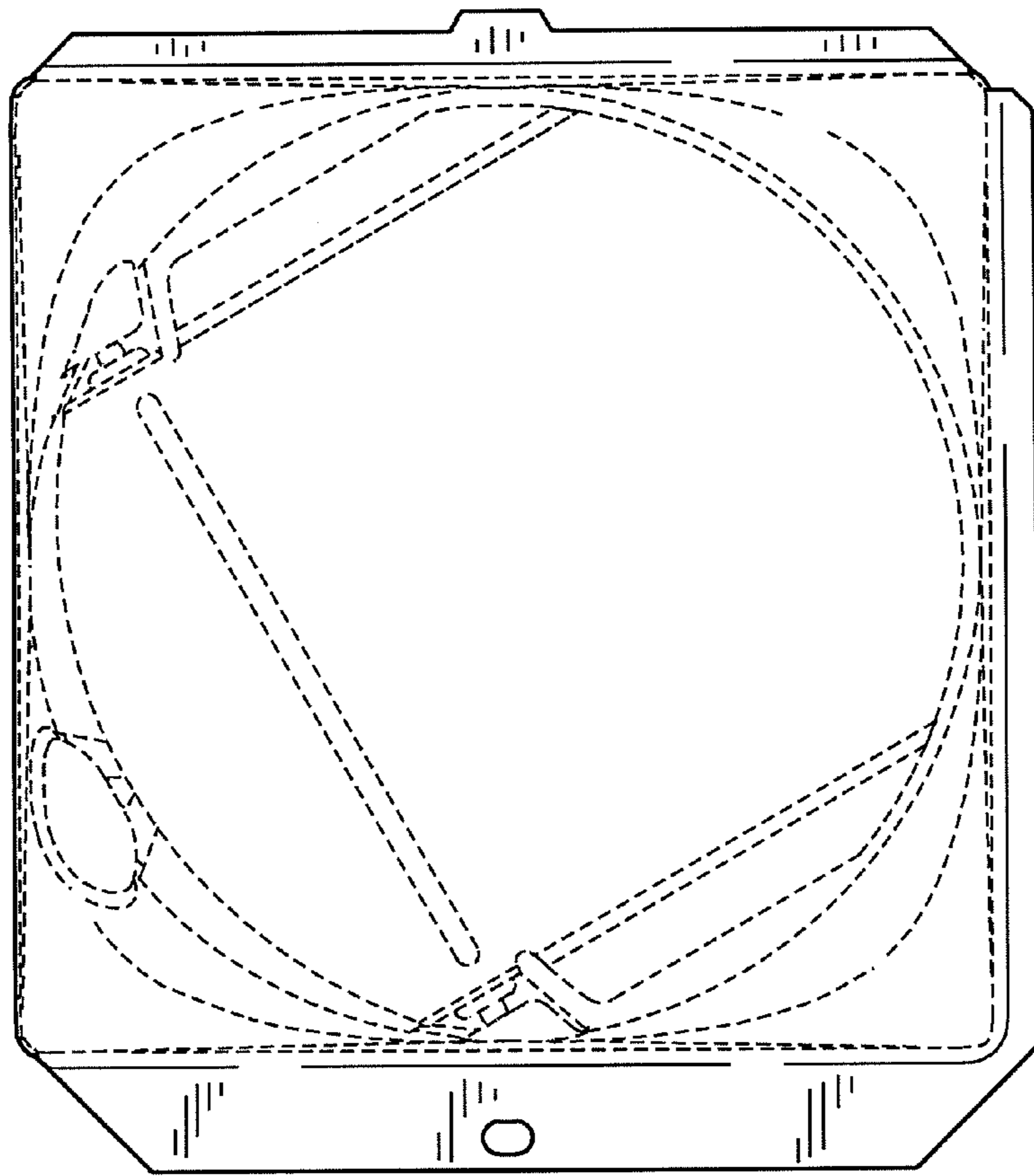

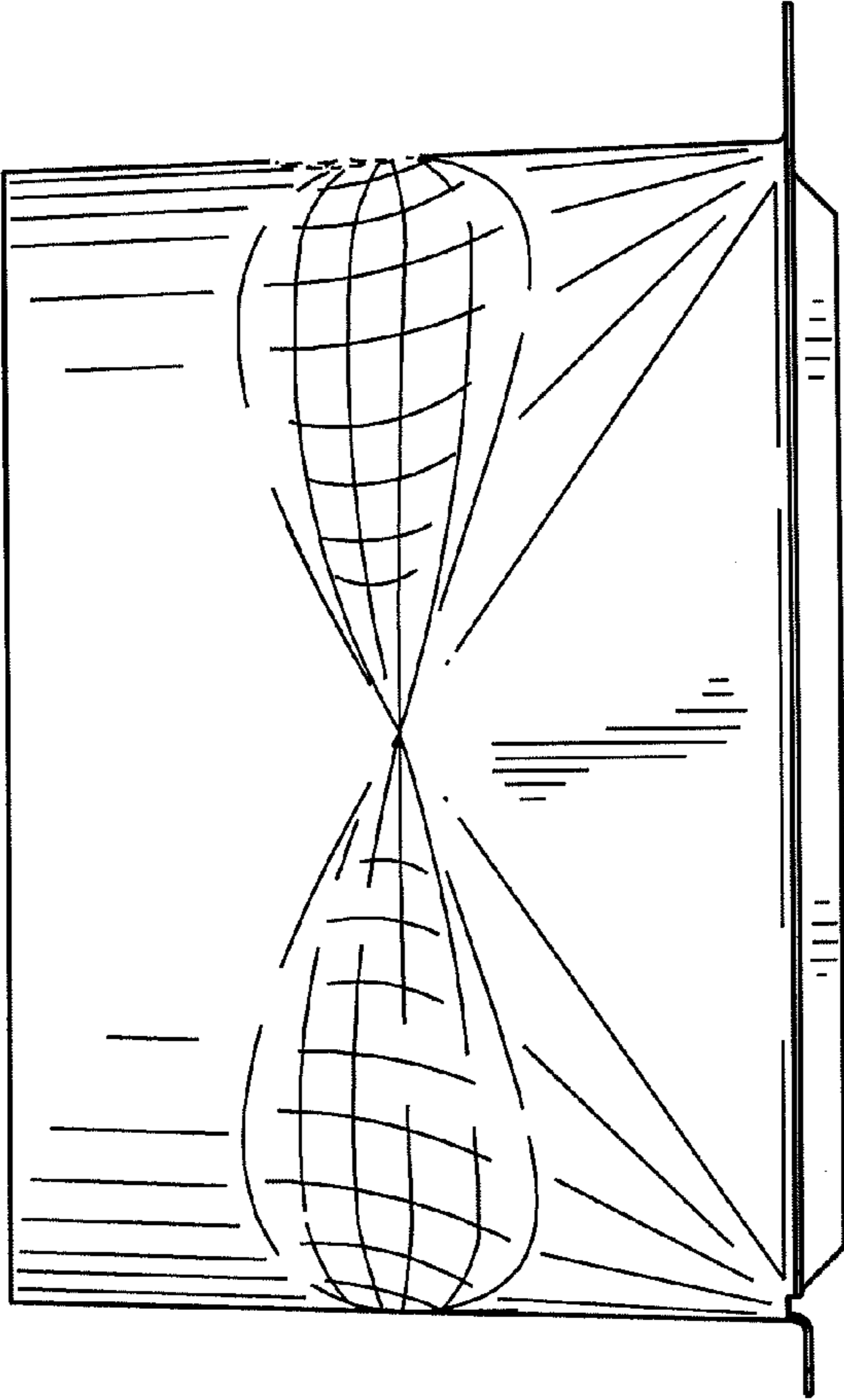

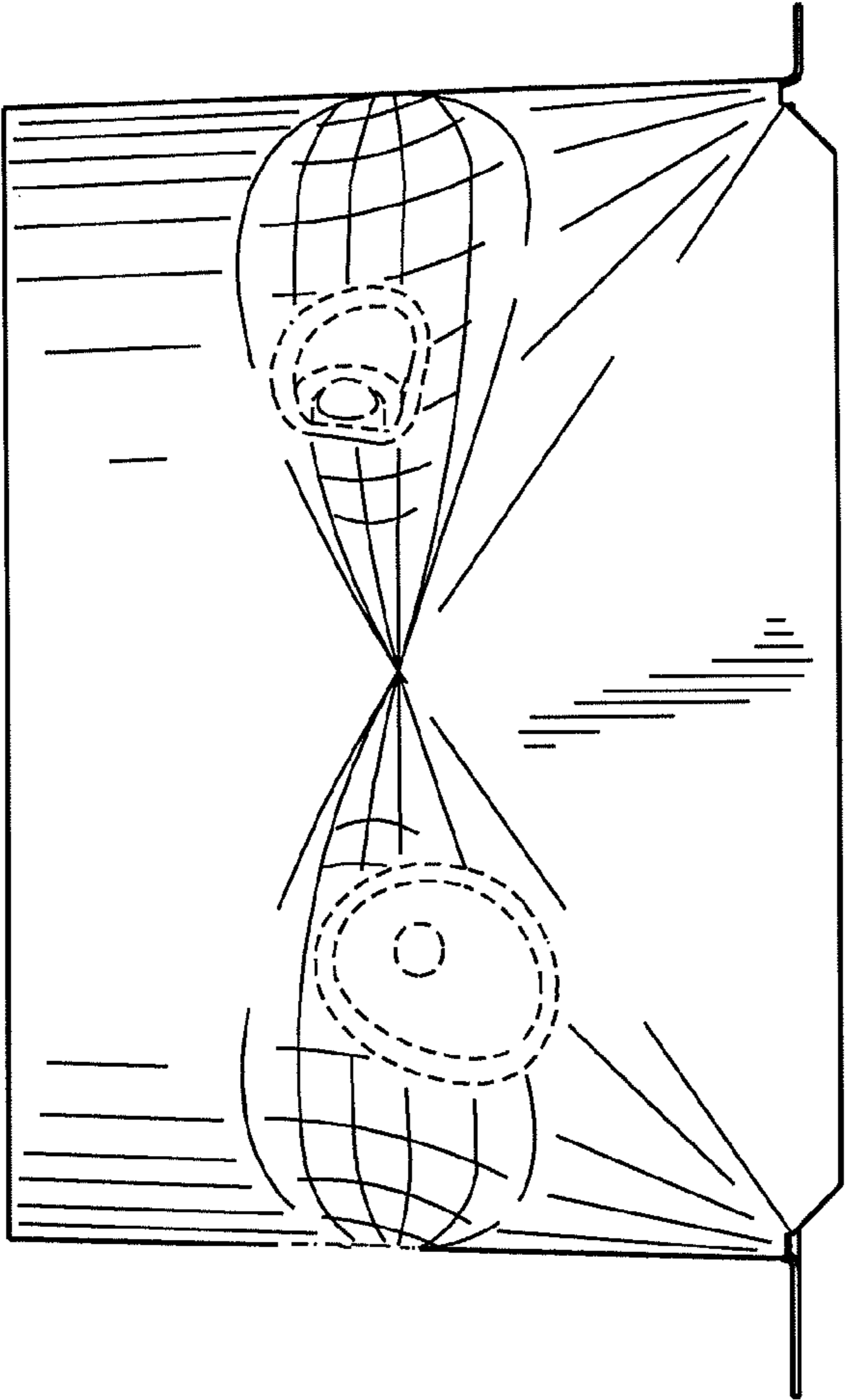

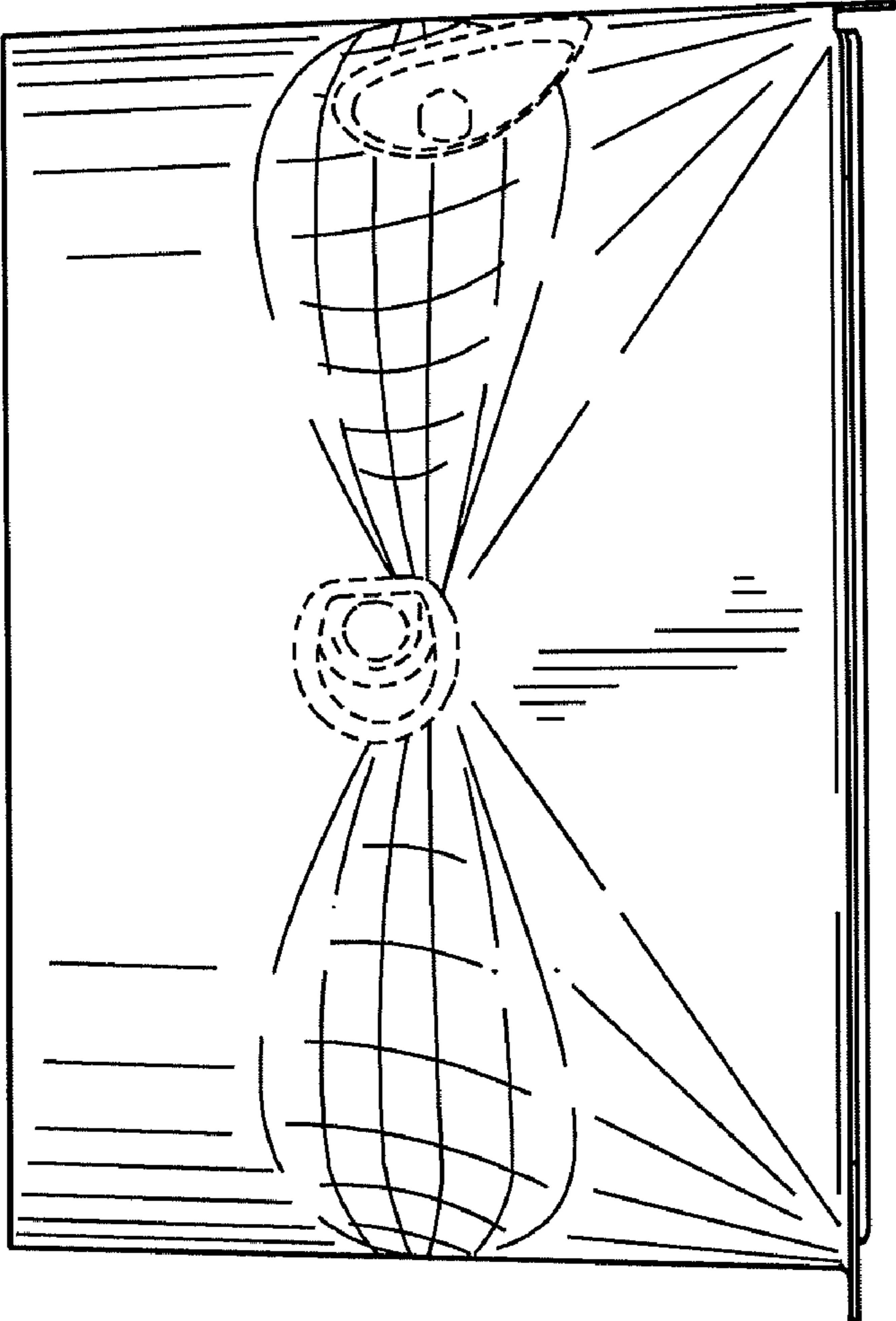

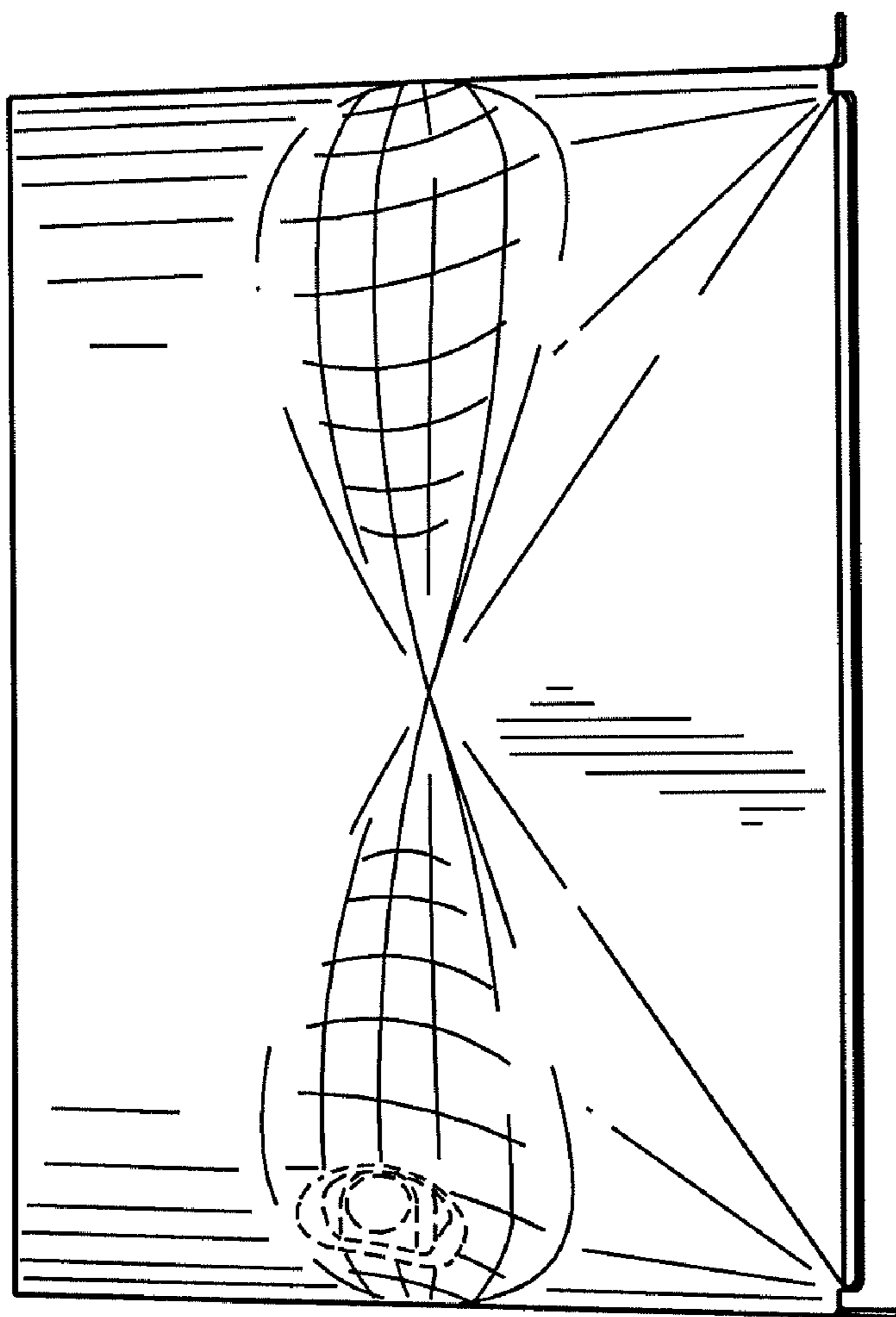
