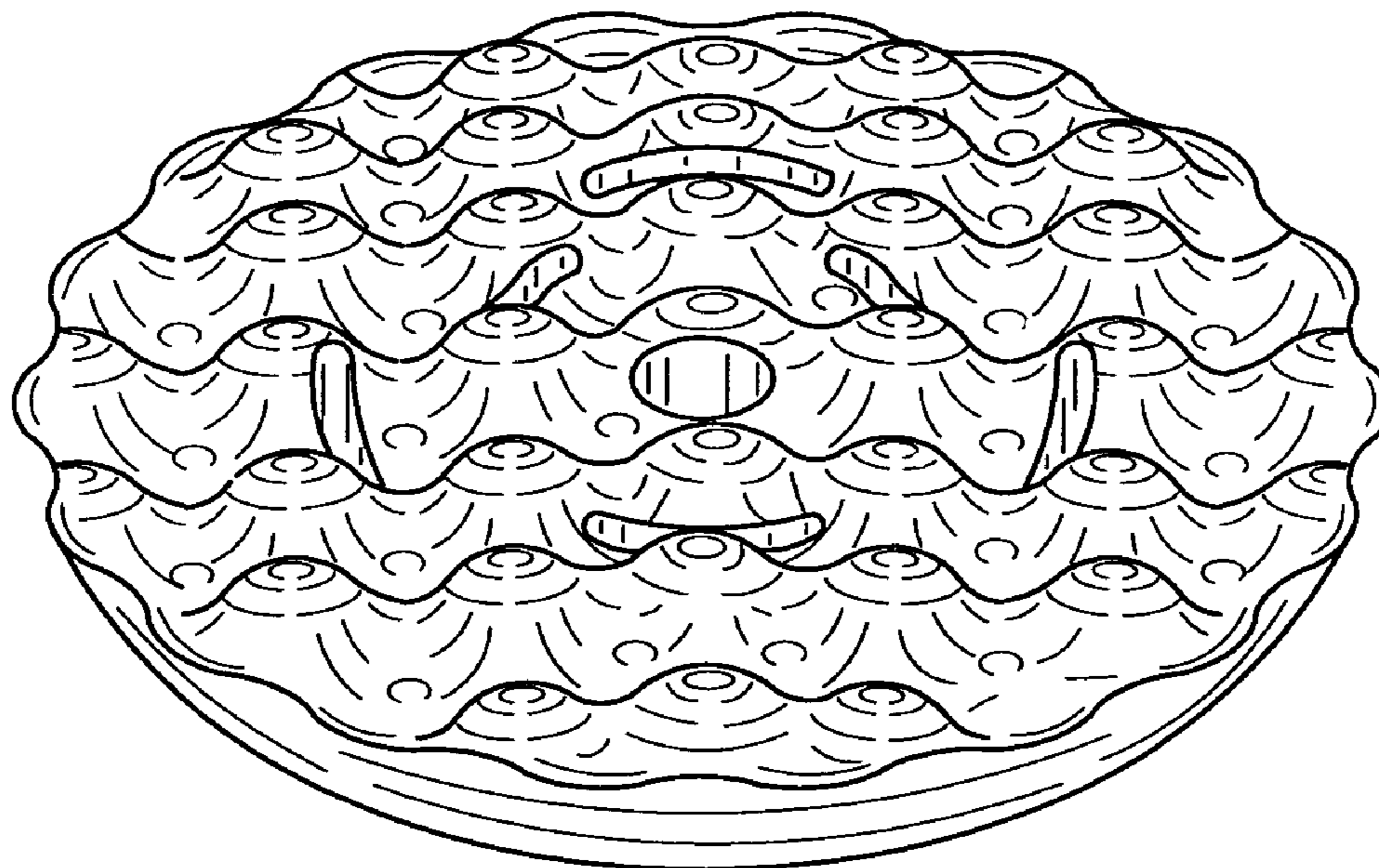
(57) **CLAIM**

The ornamental design for the vented waffle style buffing pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a top isometric view of the vented waffle style buffing pad showing my new design;  
FIG. 2 is a bottom isometric view of the invention;  
FIG. 3 is a side view, the opposite side view and the front and back views being a mirror image thereof;  
FIG. 4 is a top plan view; and,  
FIG. 5 is a bottom plan view.

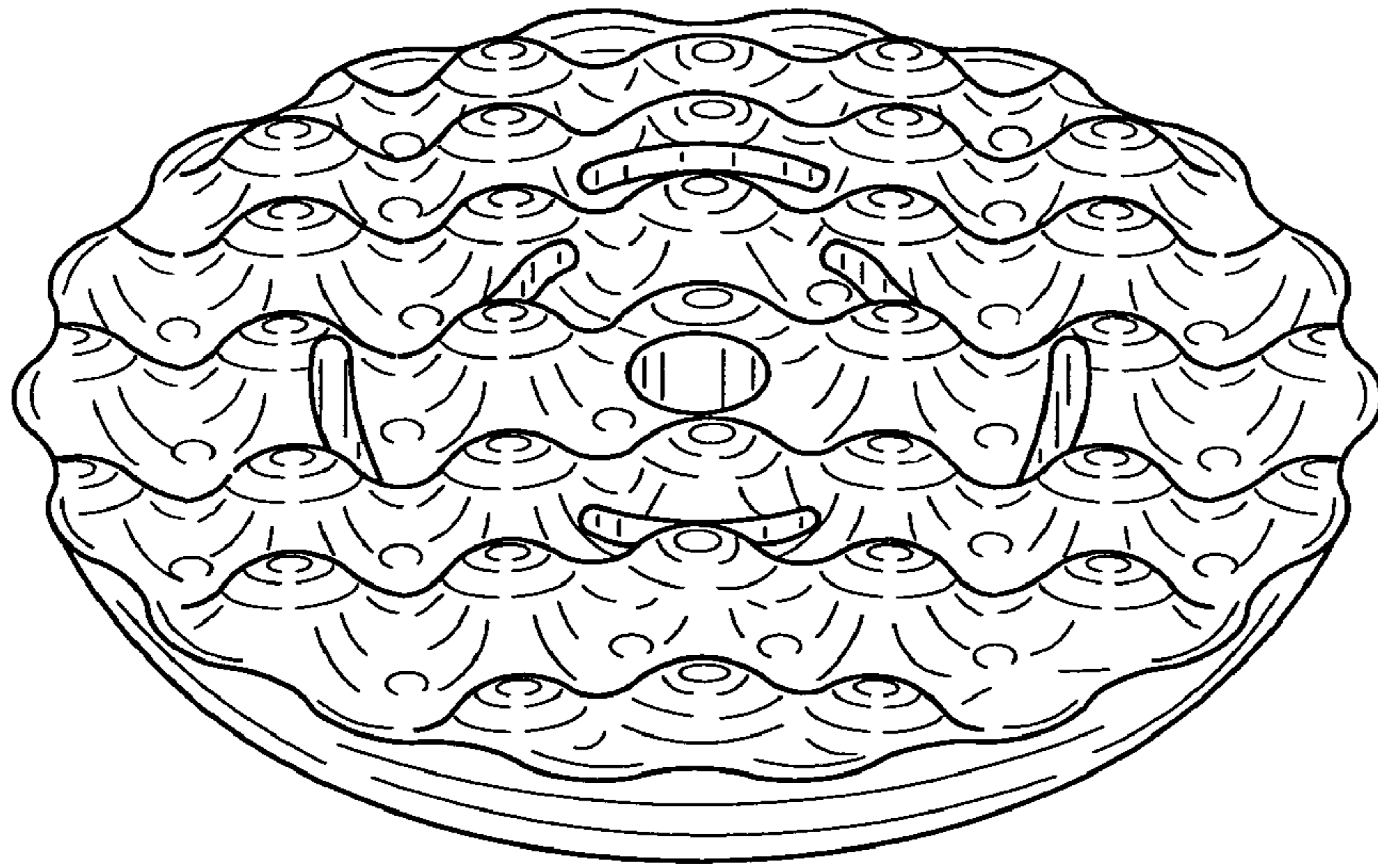

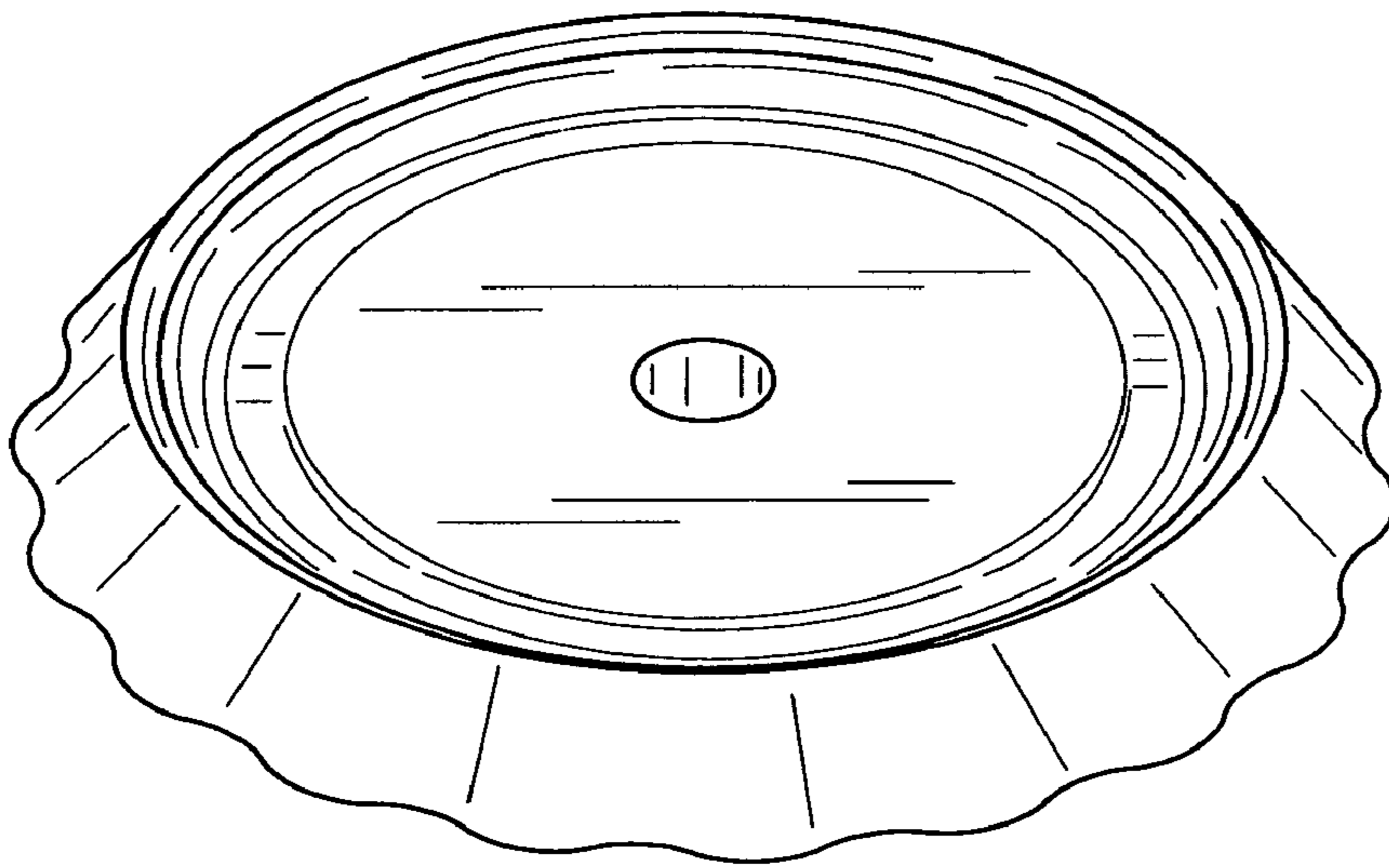

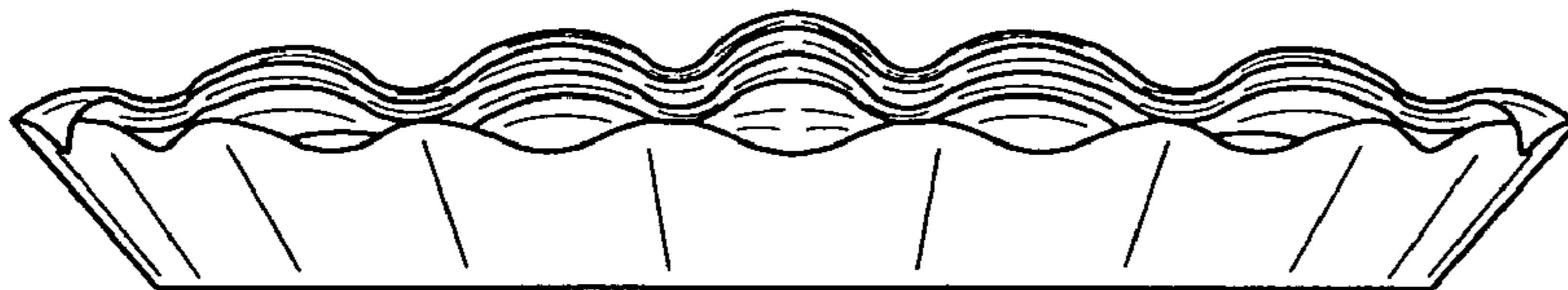

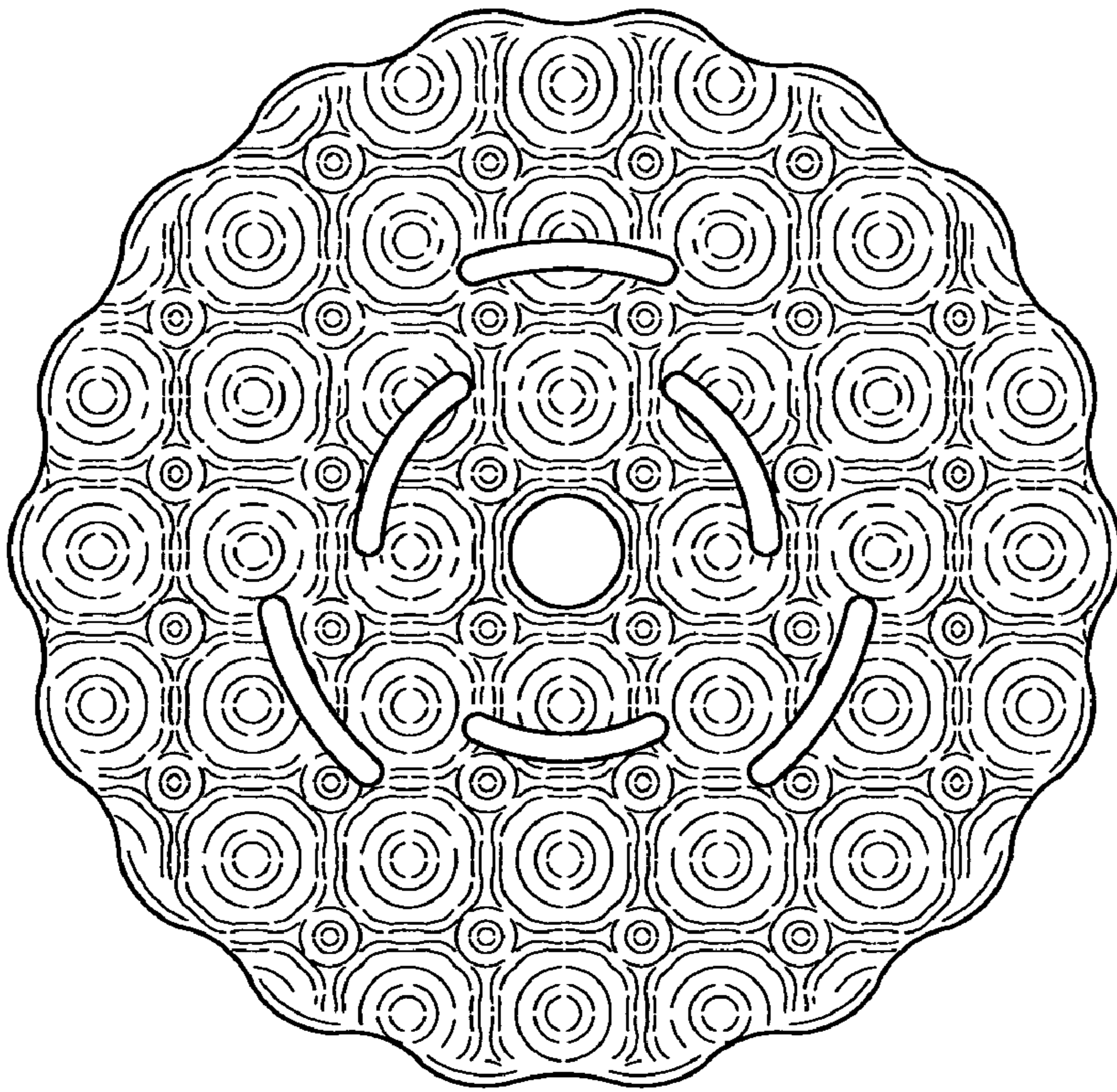

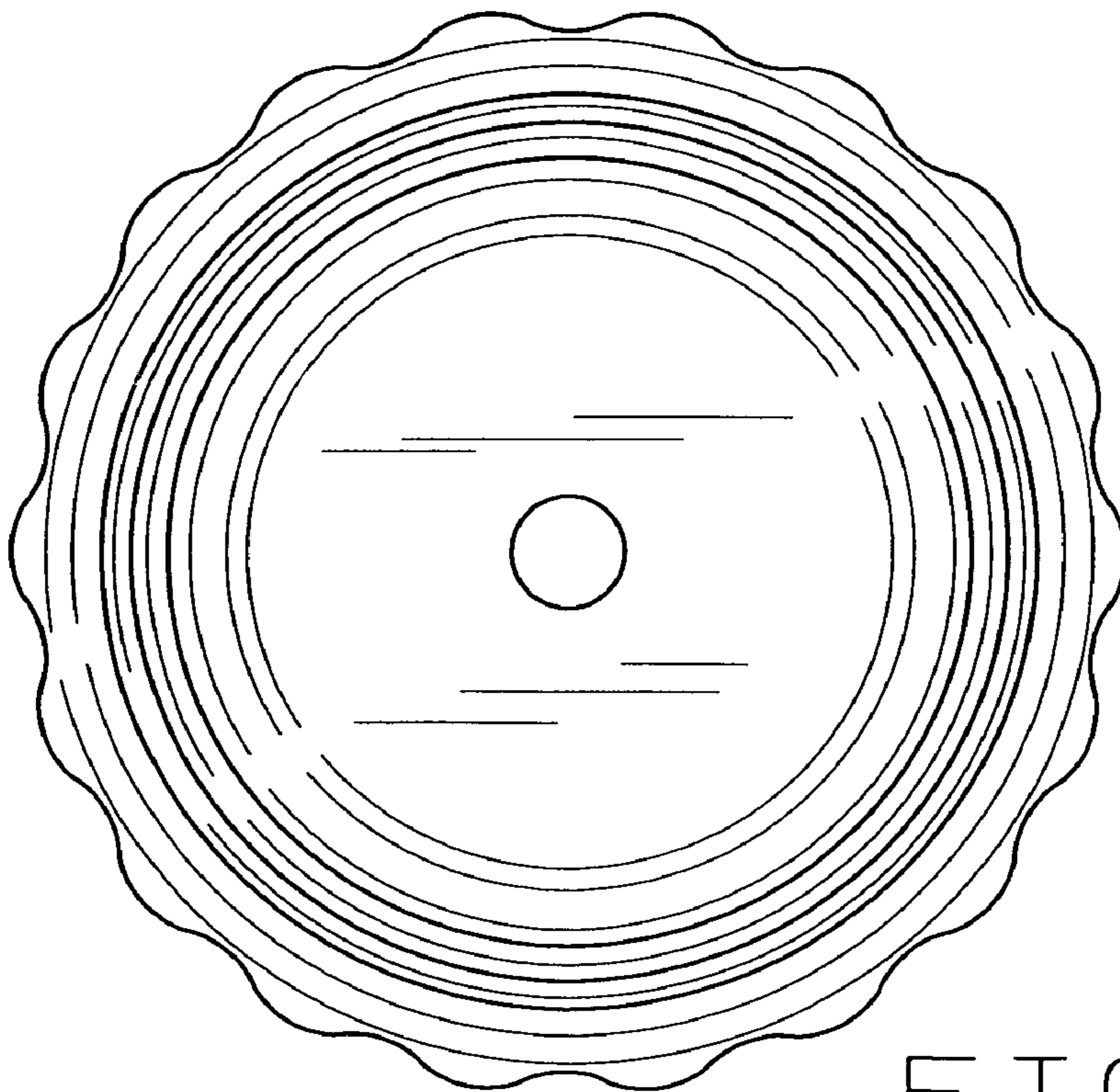
