The ornamental design for a tank top, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tank top according to a first embodiment of the design;

FIG. 2 is a rear view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a reduced top view thereof;

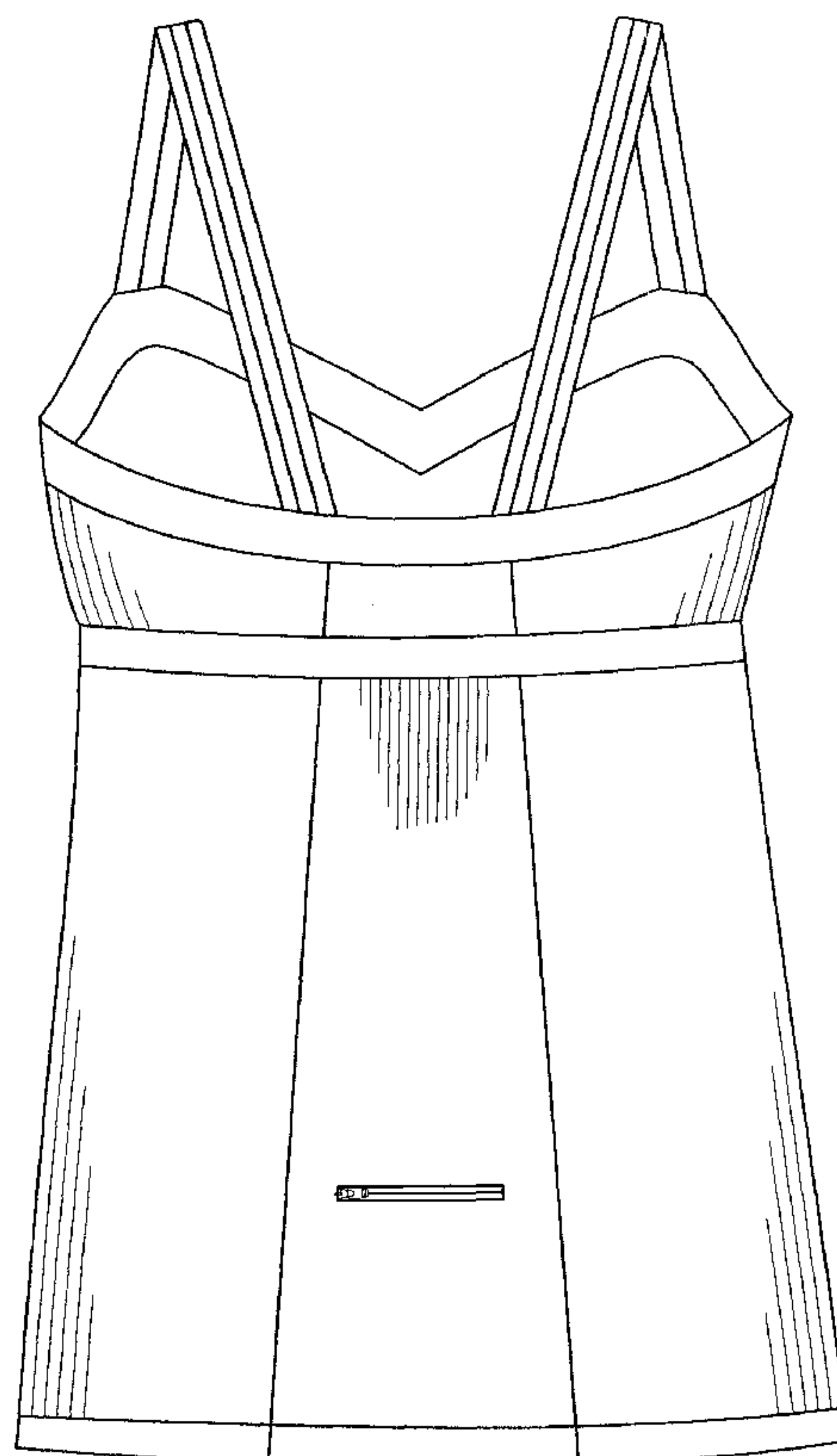
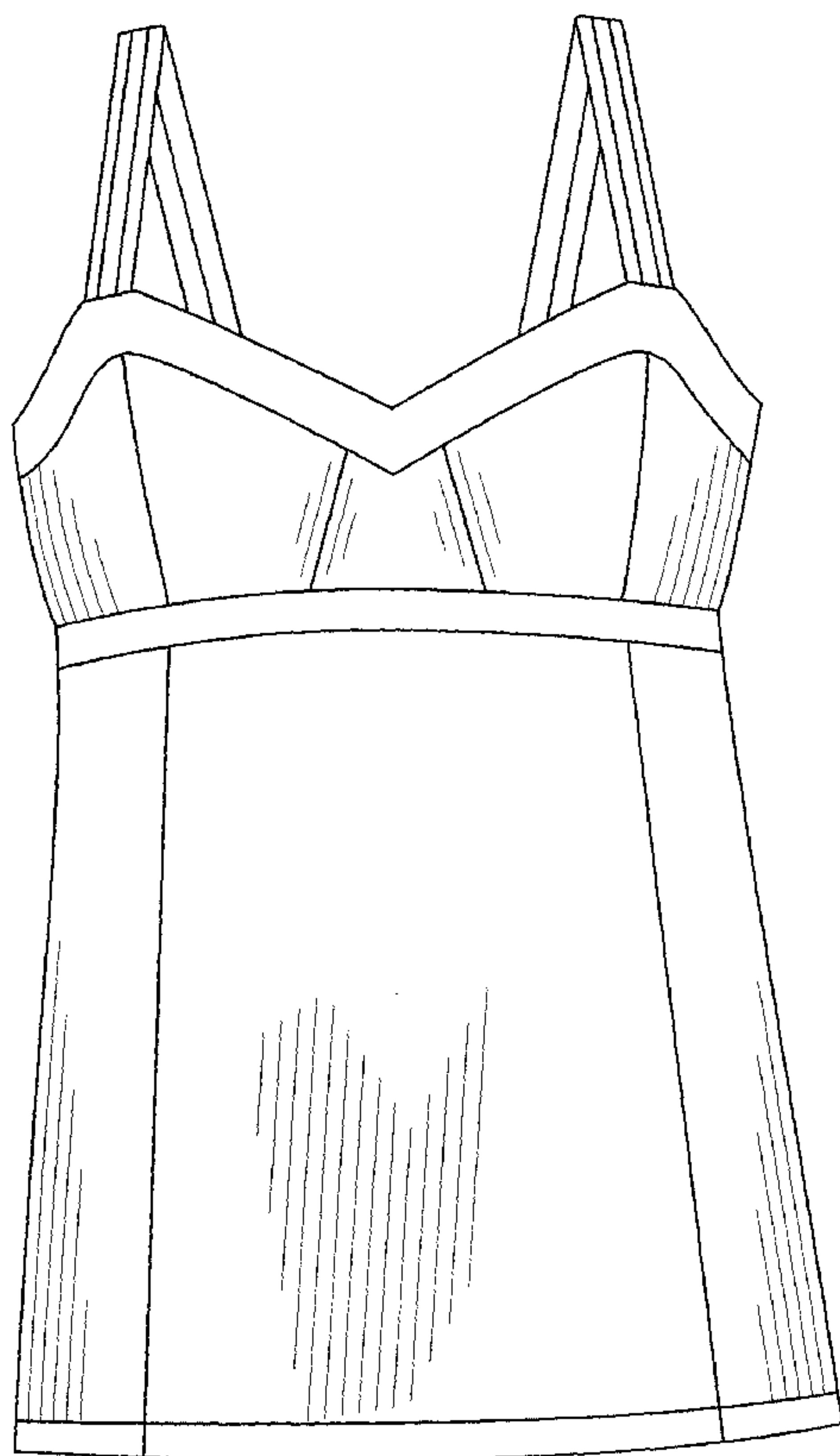
FIG. 6 is a front perspective view thereof;

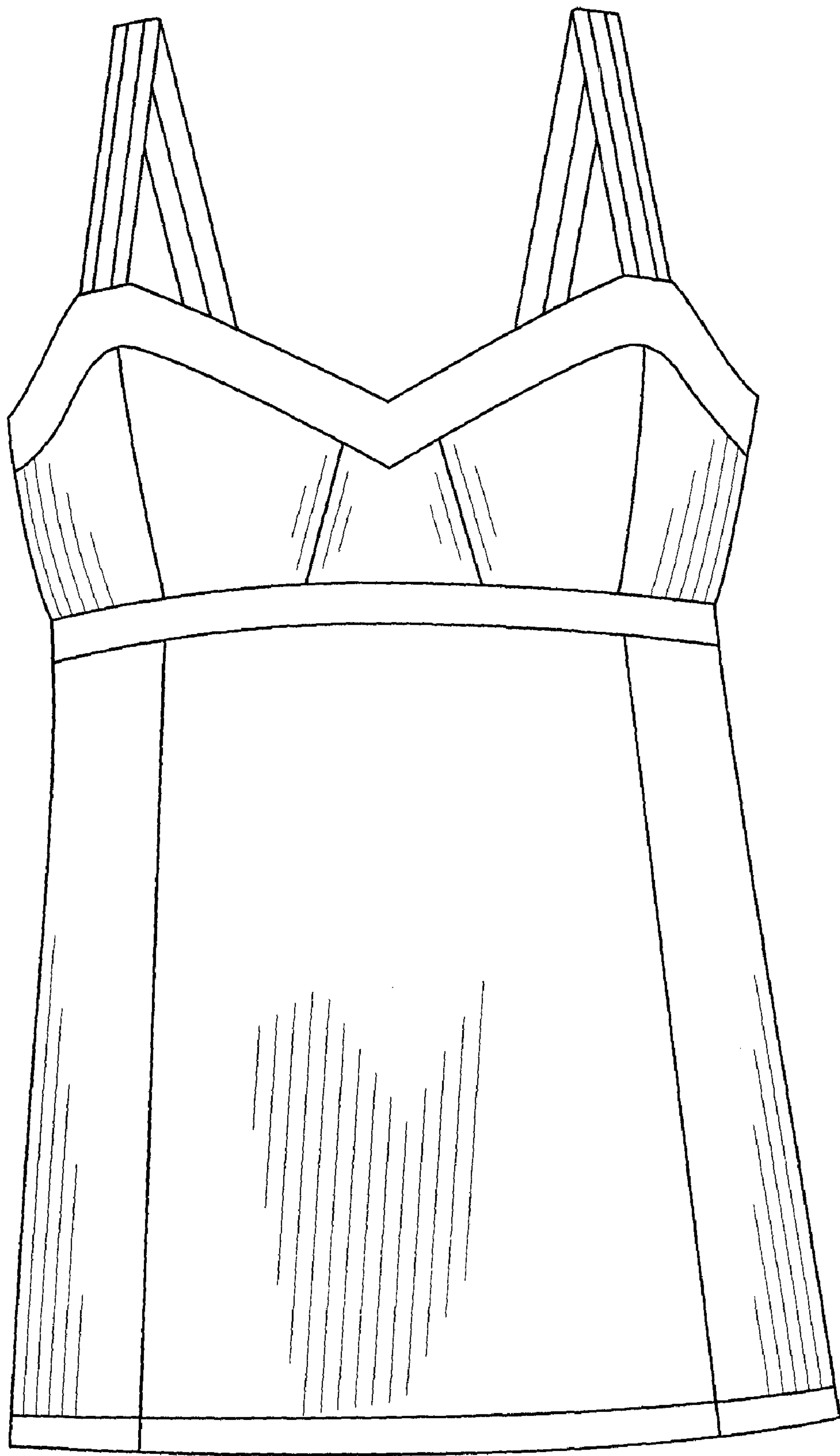

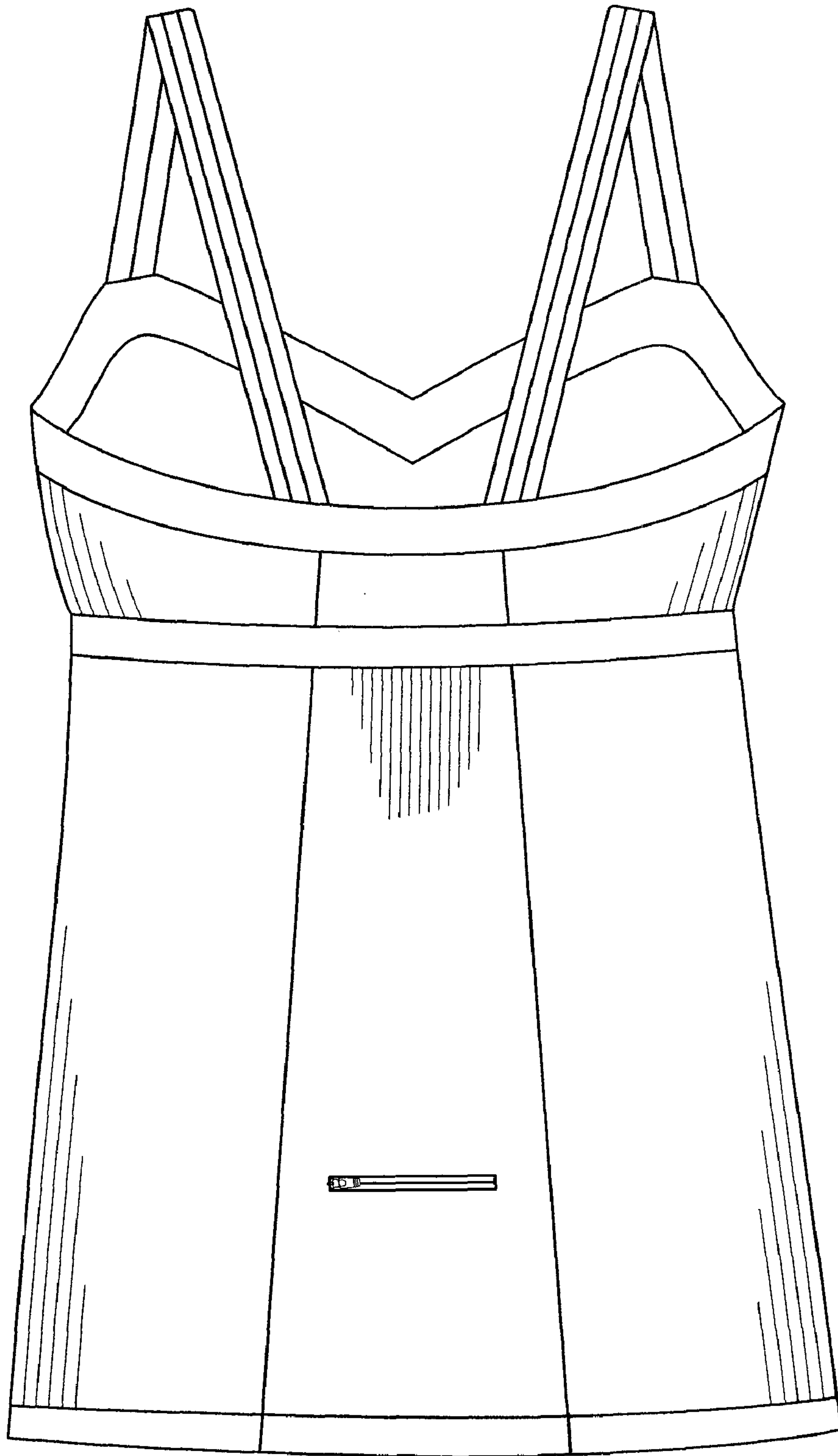

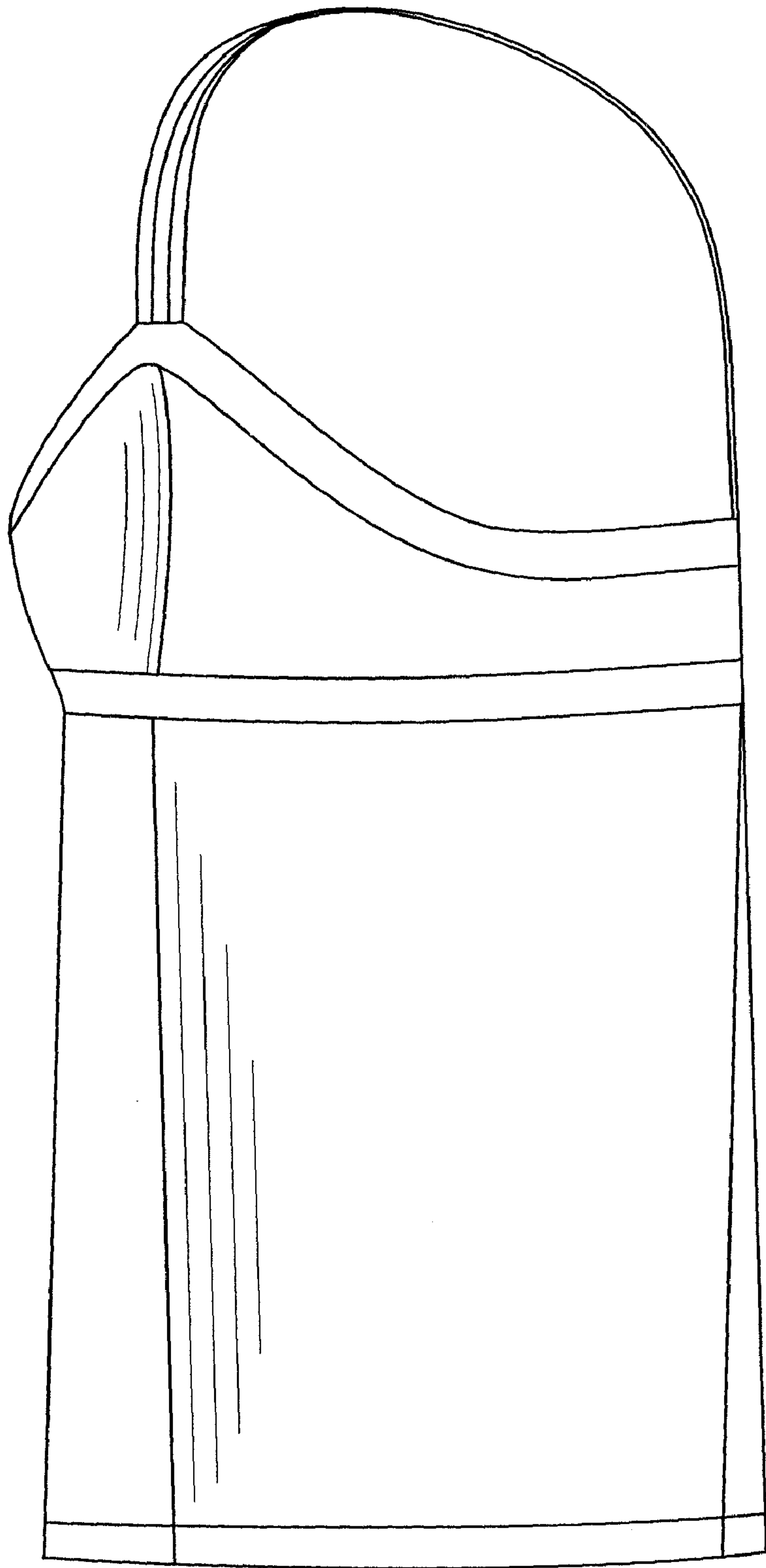

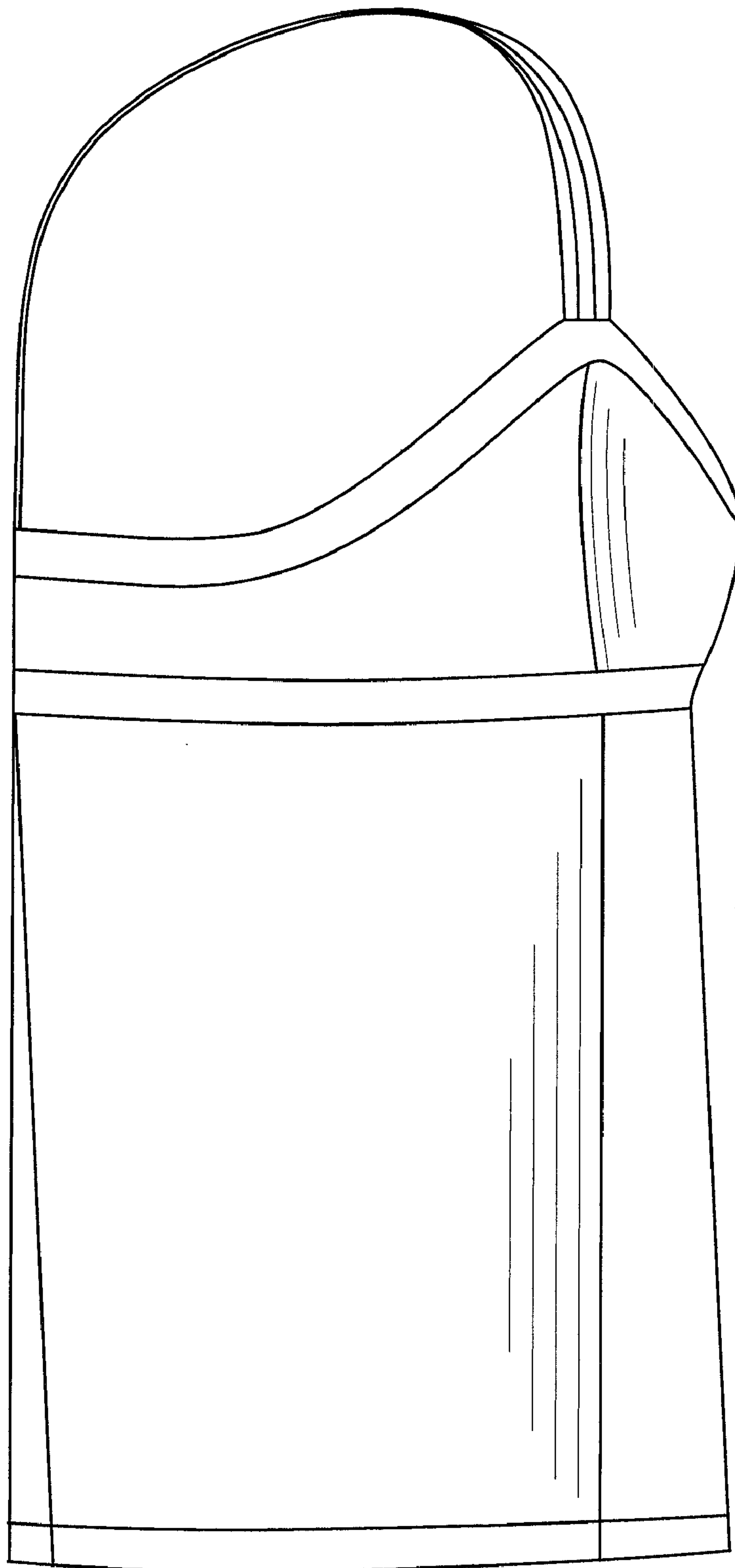

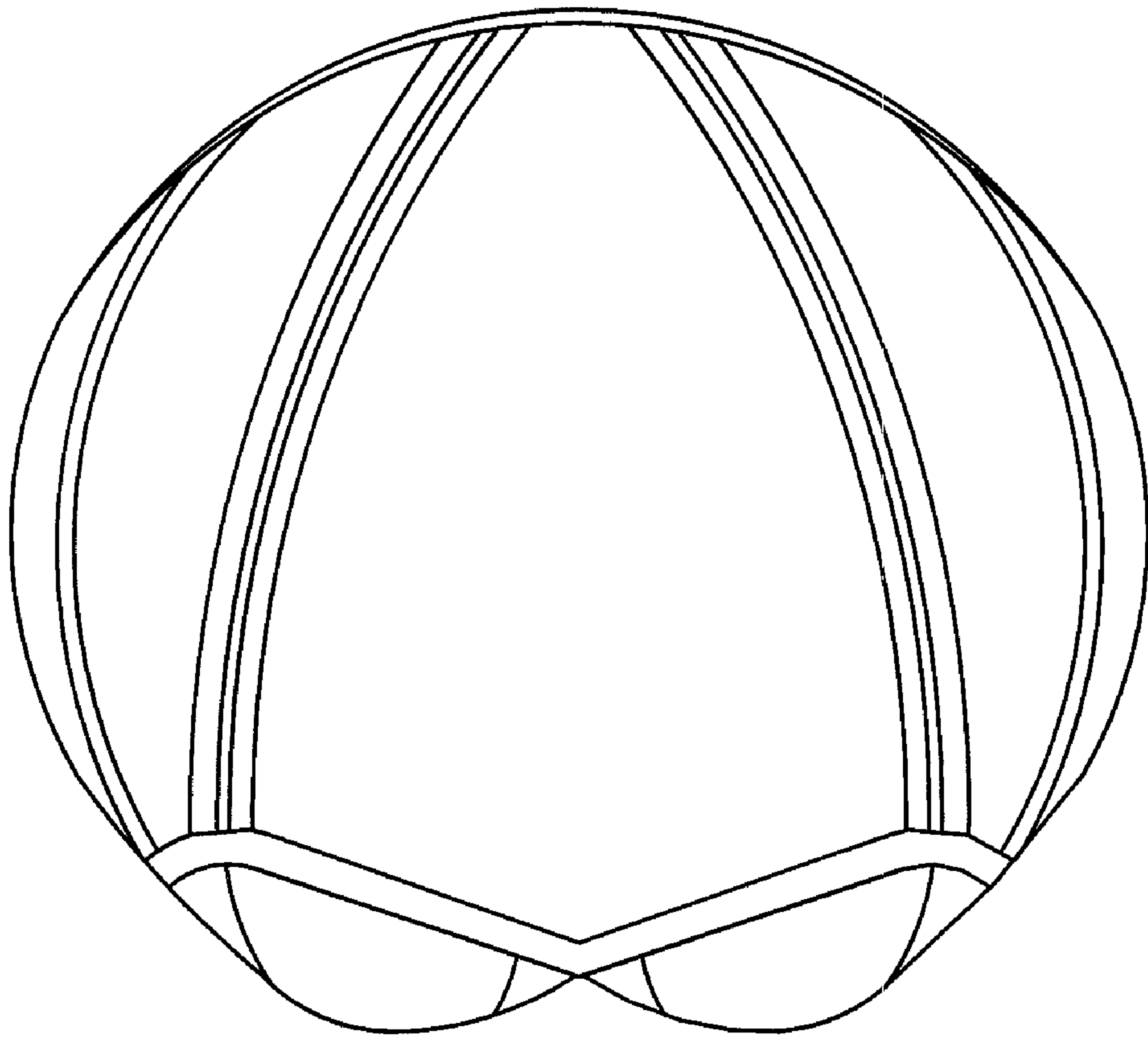

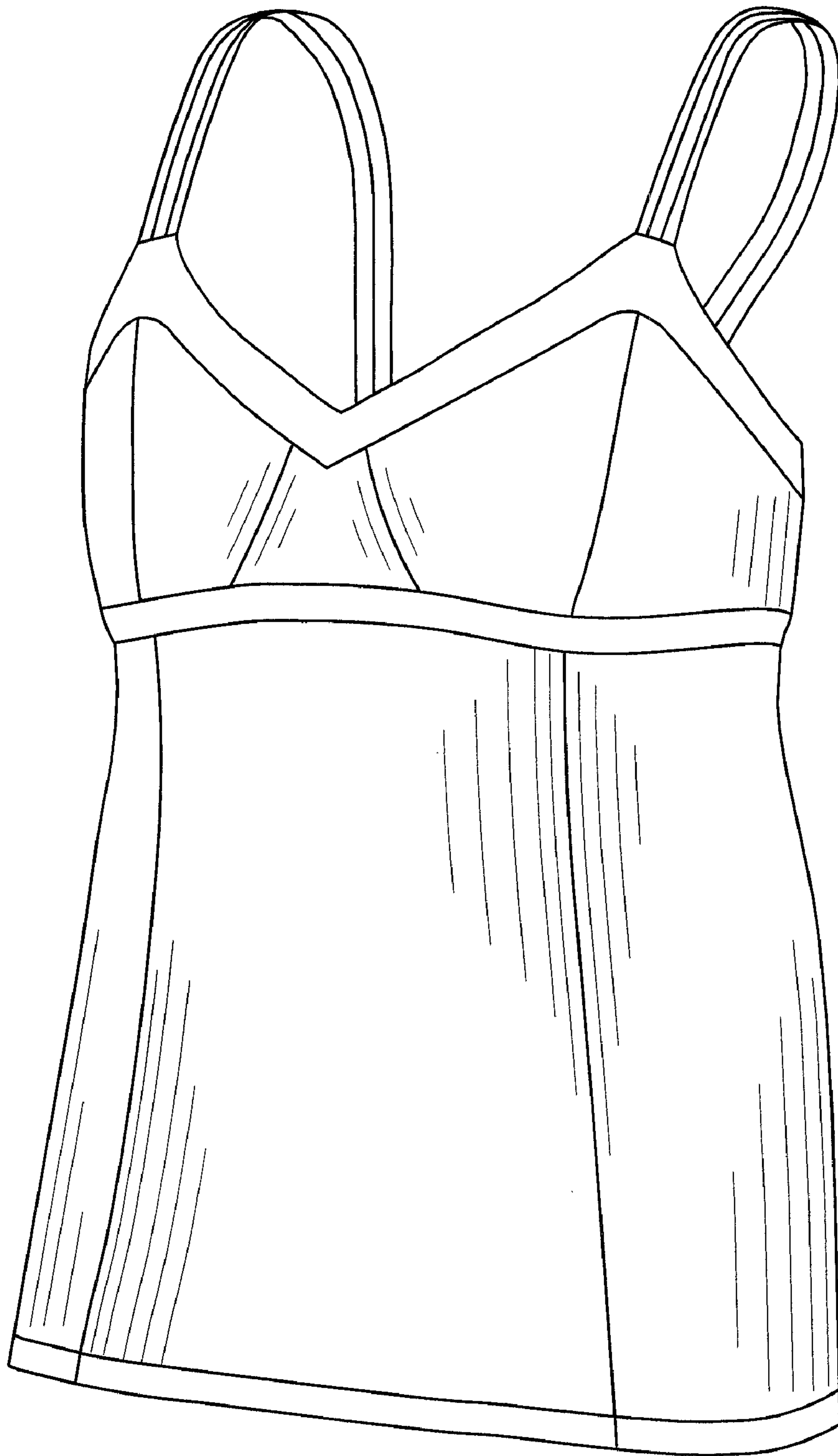

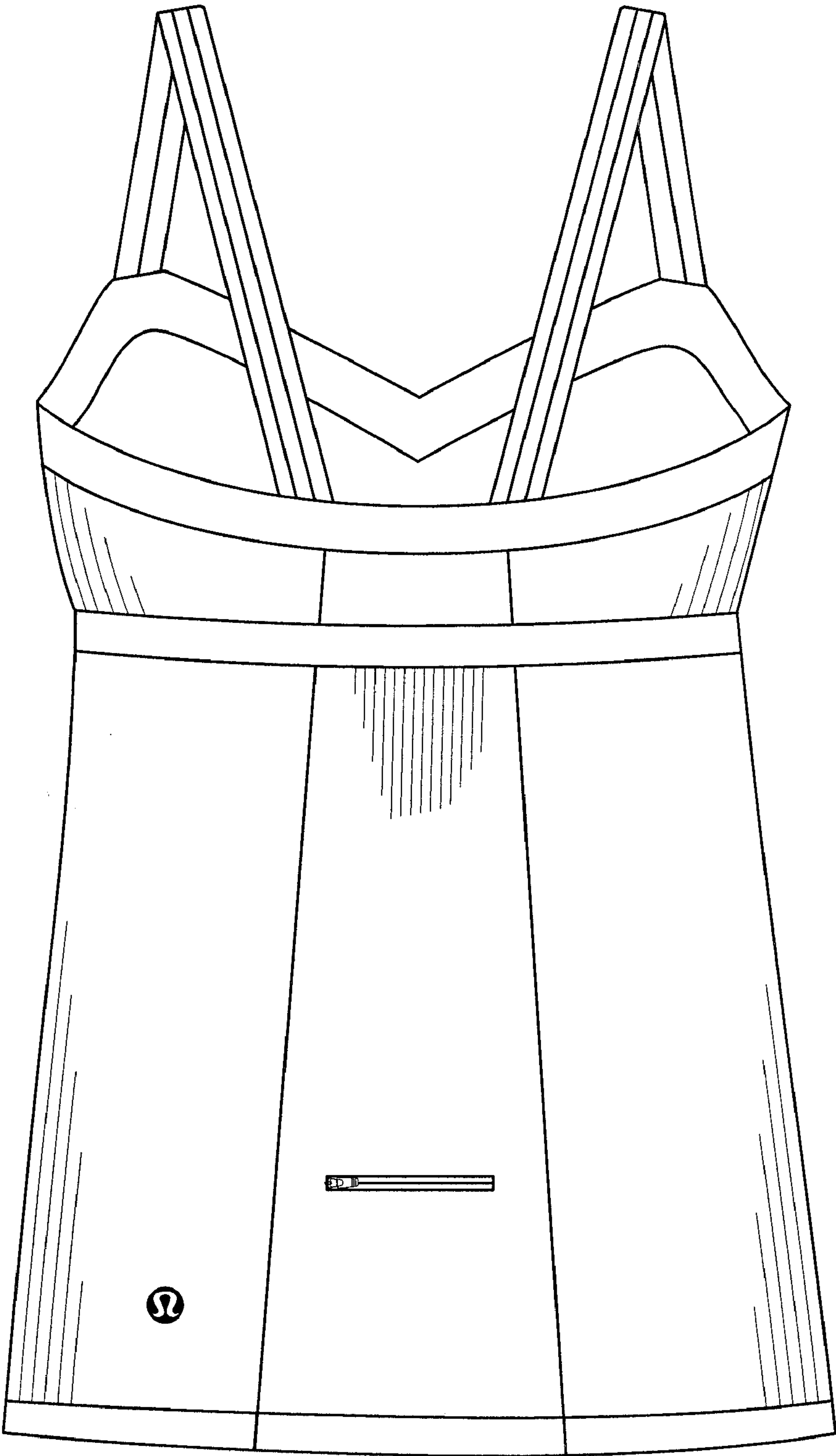

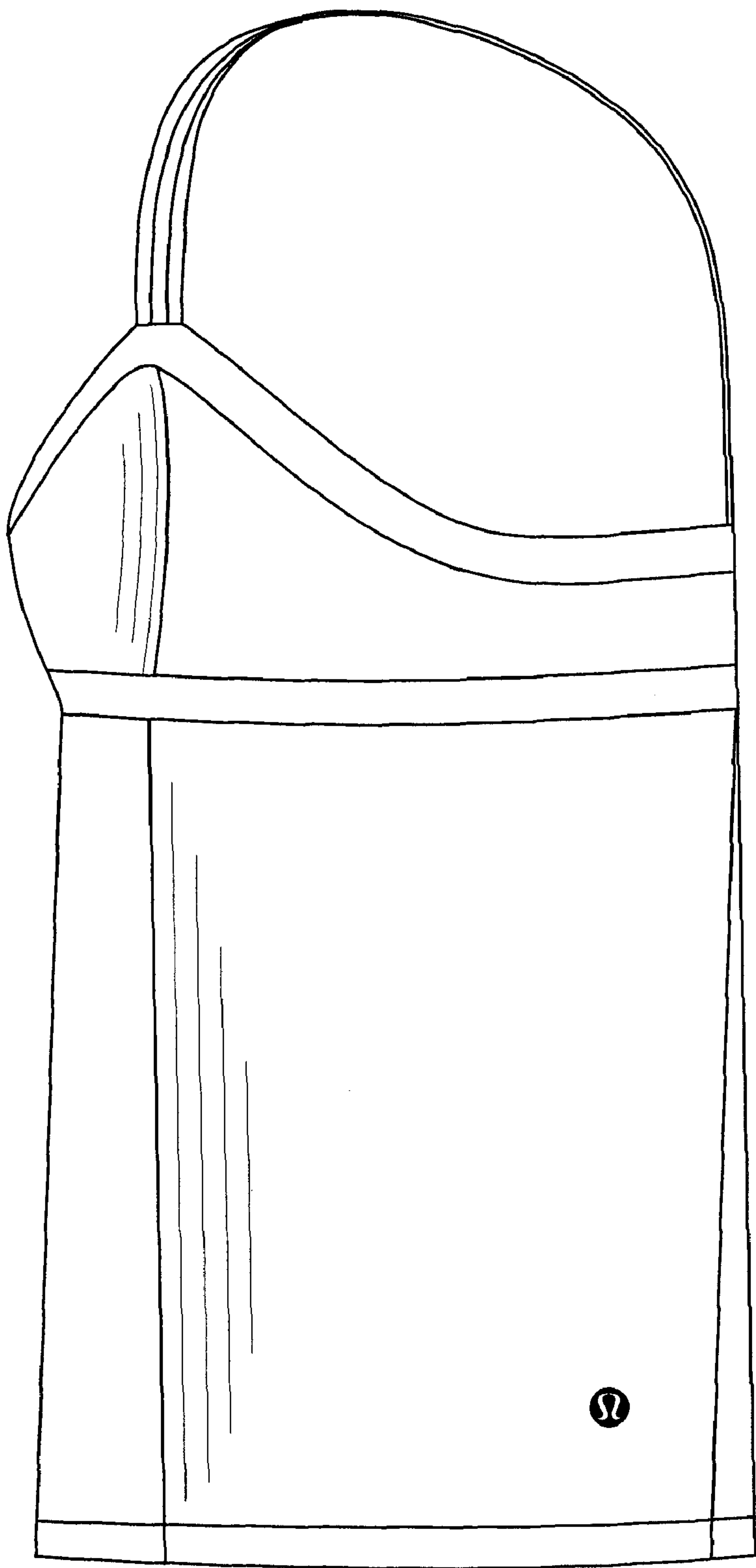
