FIG. 5 is another side elevation view thereof;

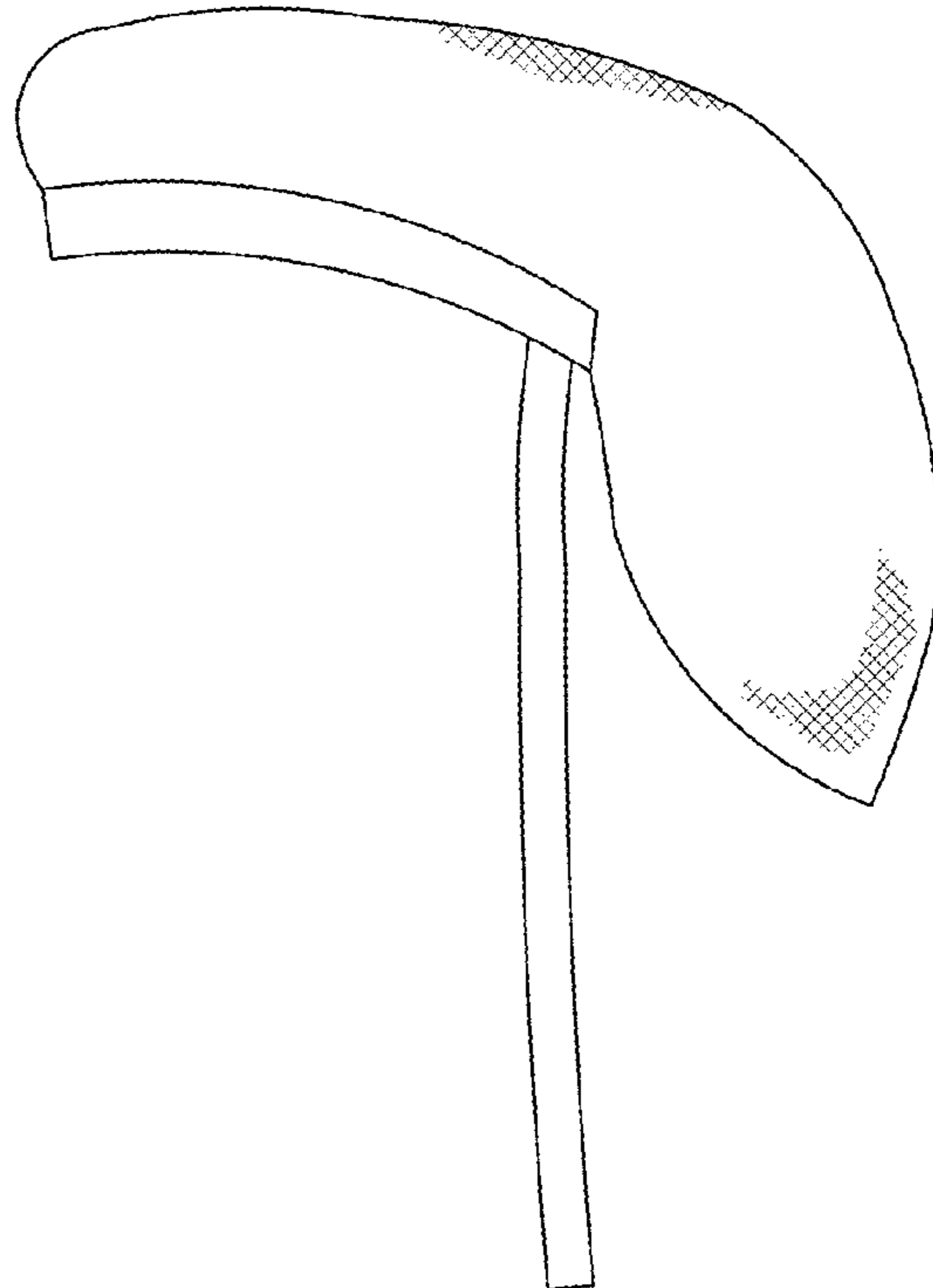
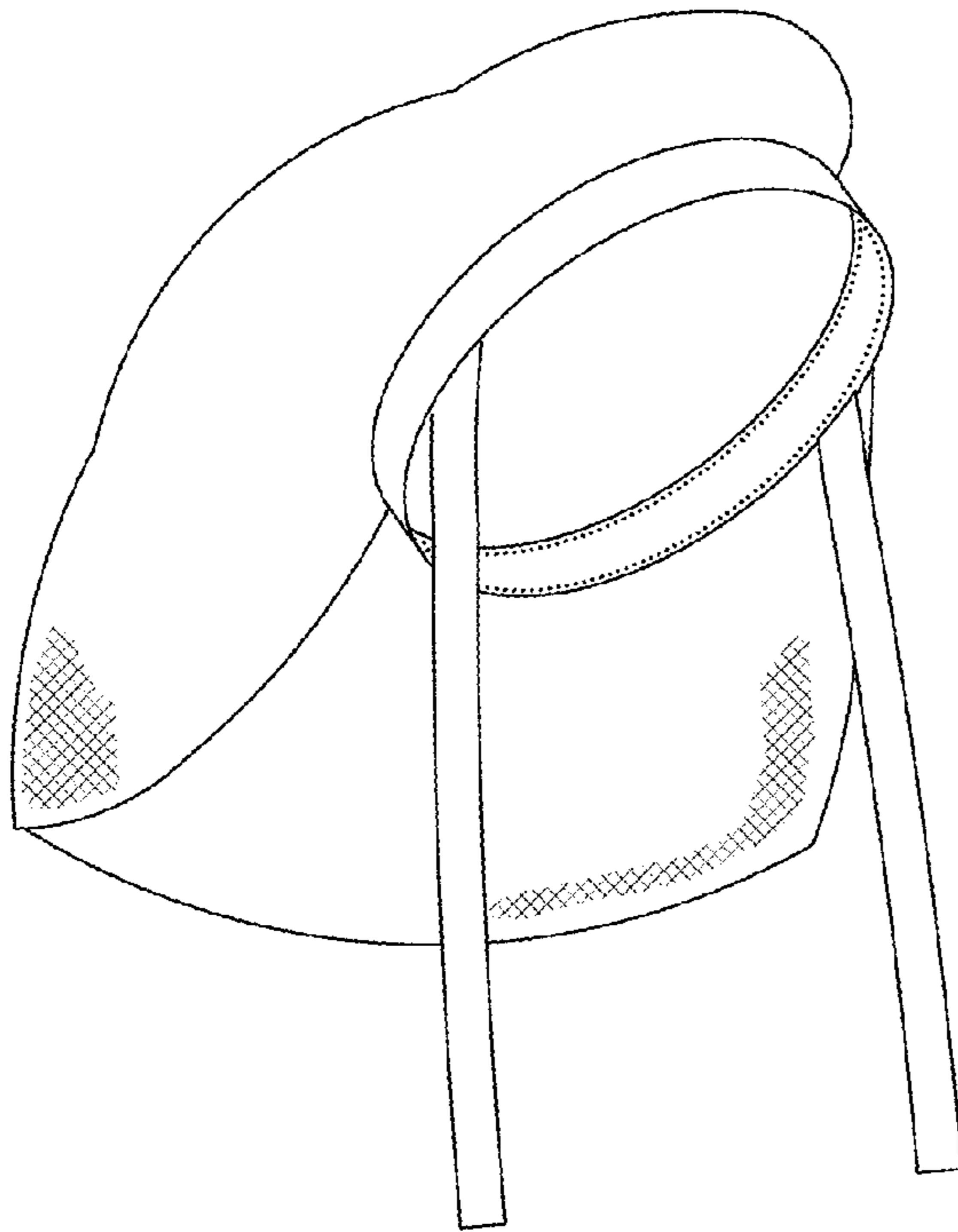
FIG. 6 is a back elevation view thereof;

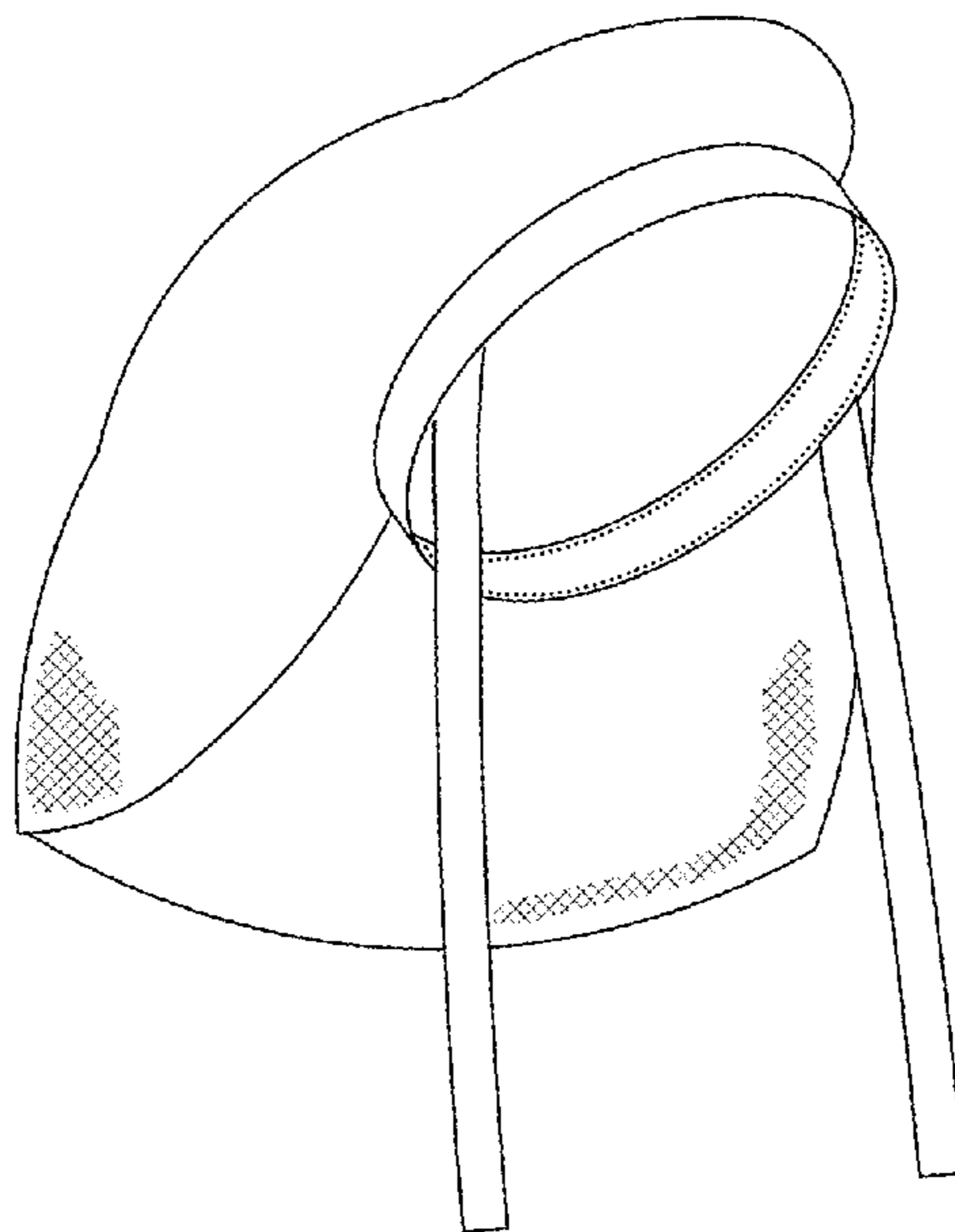

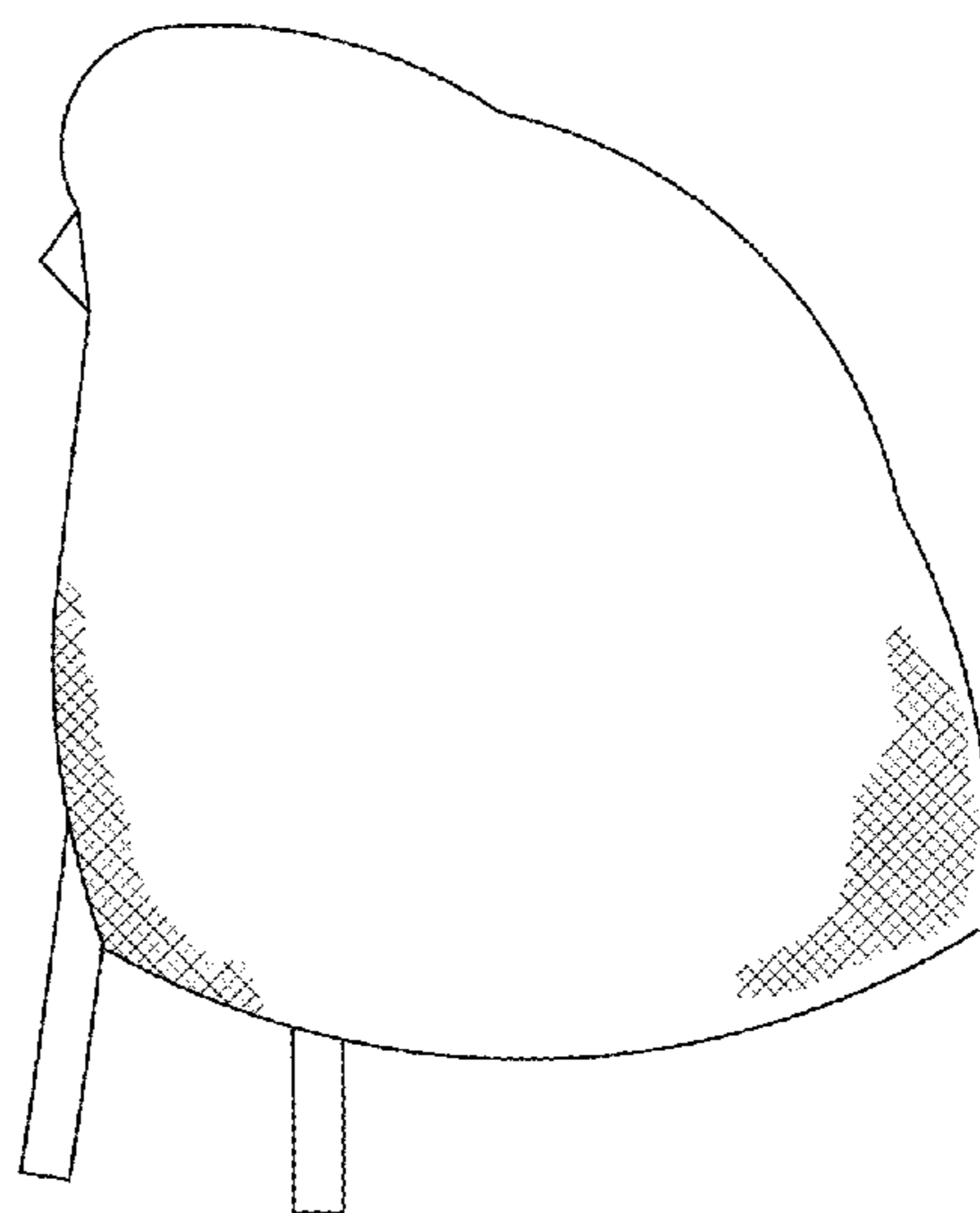

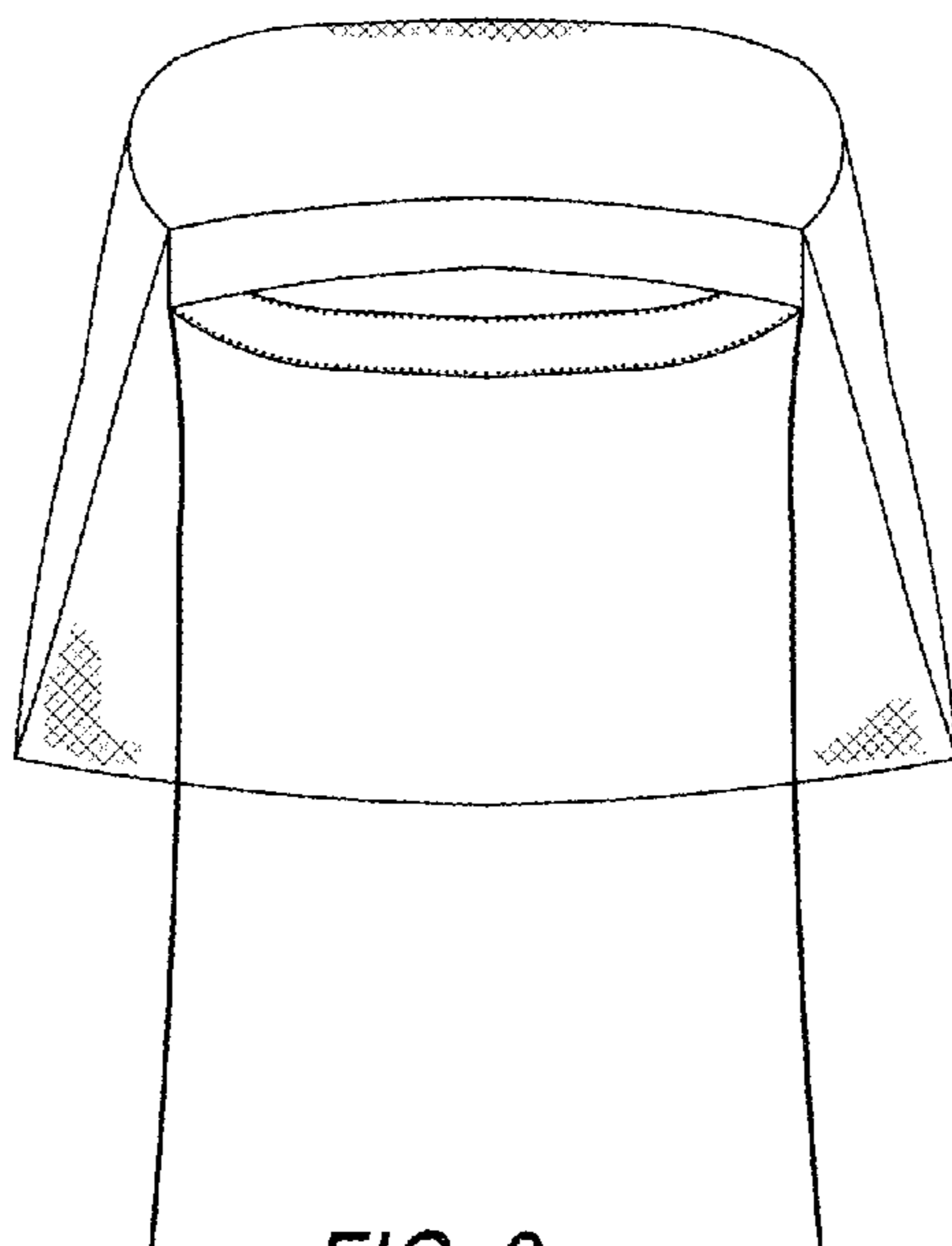

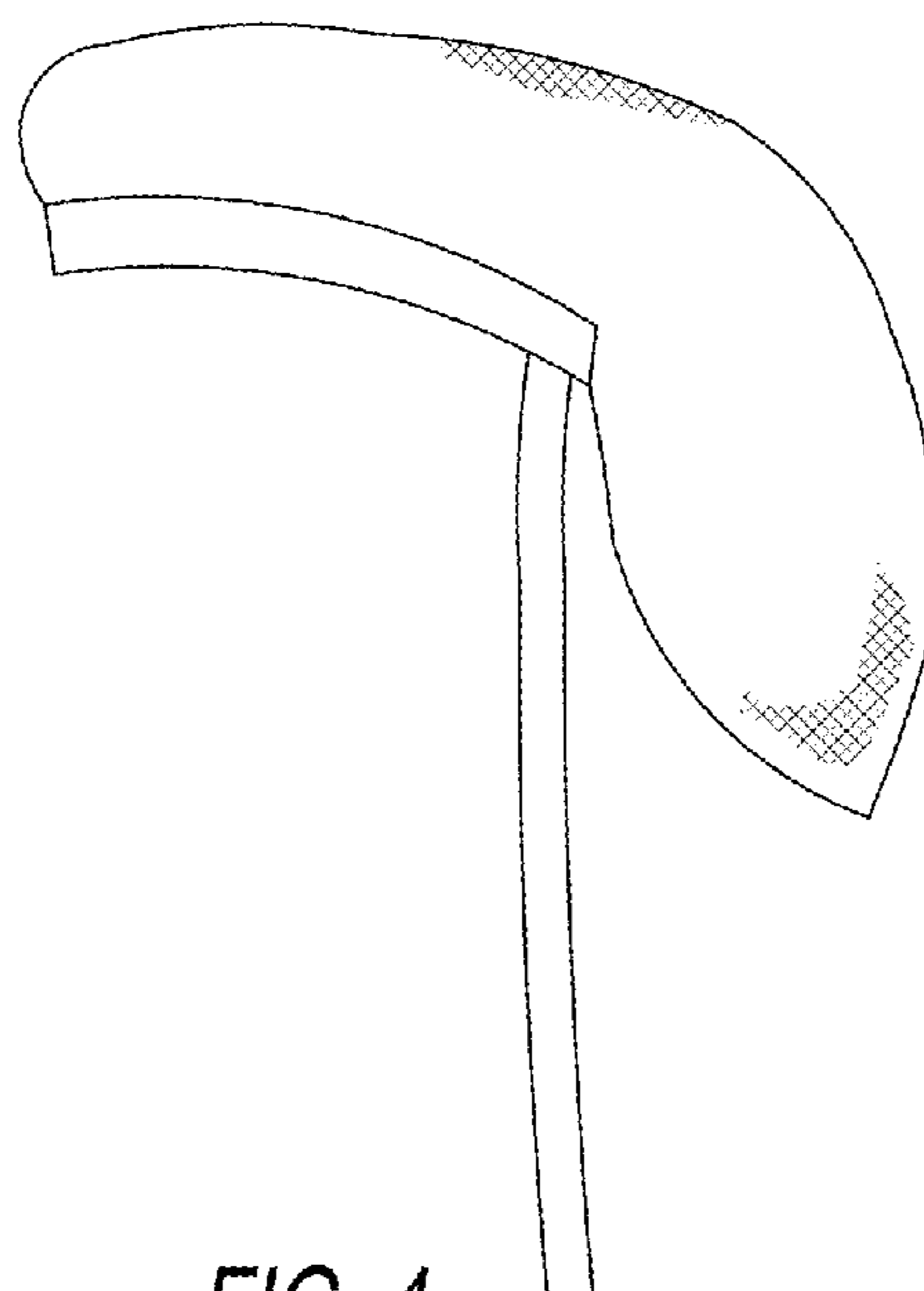

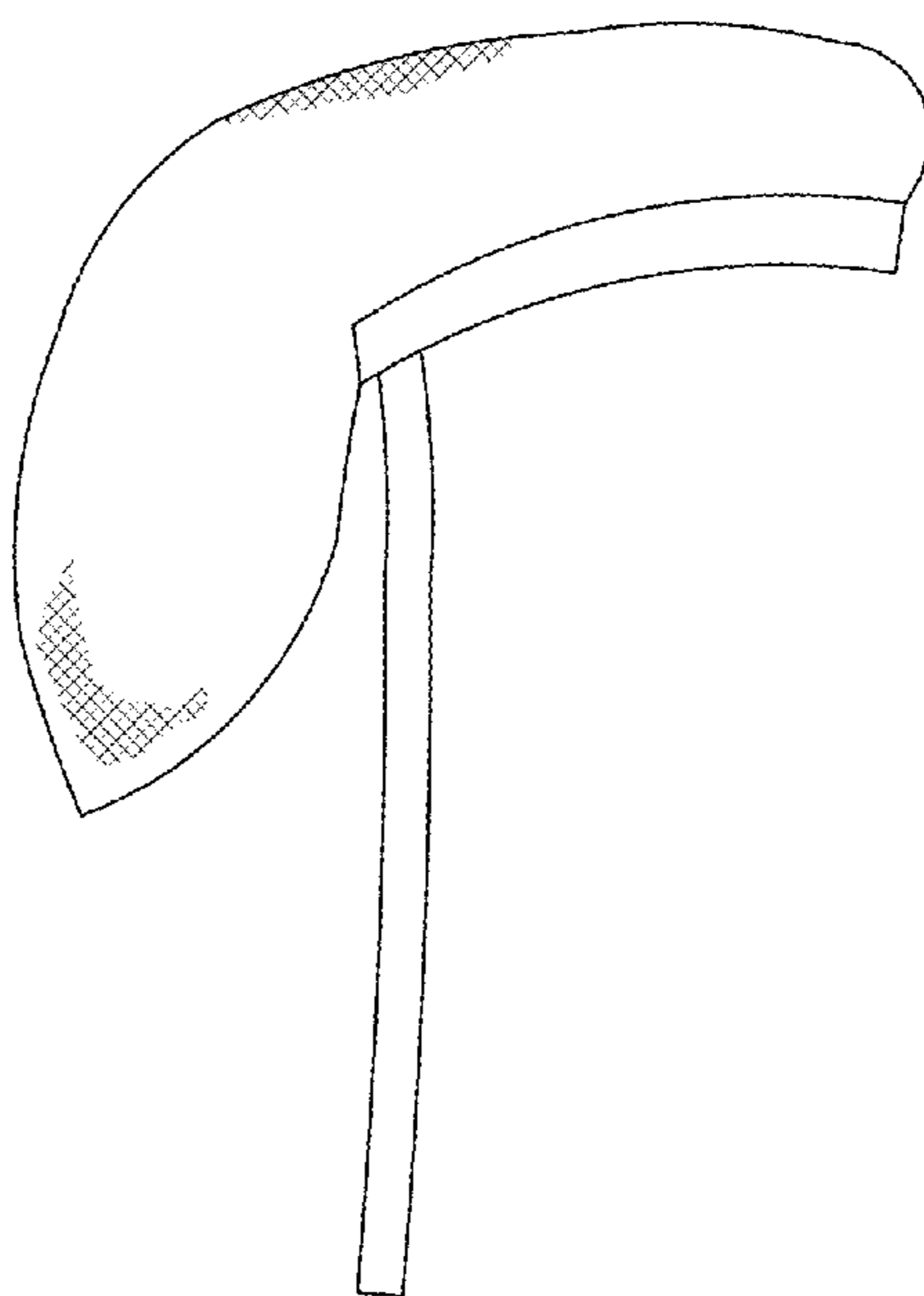

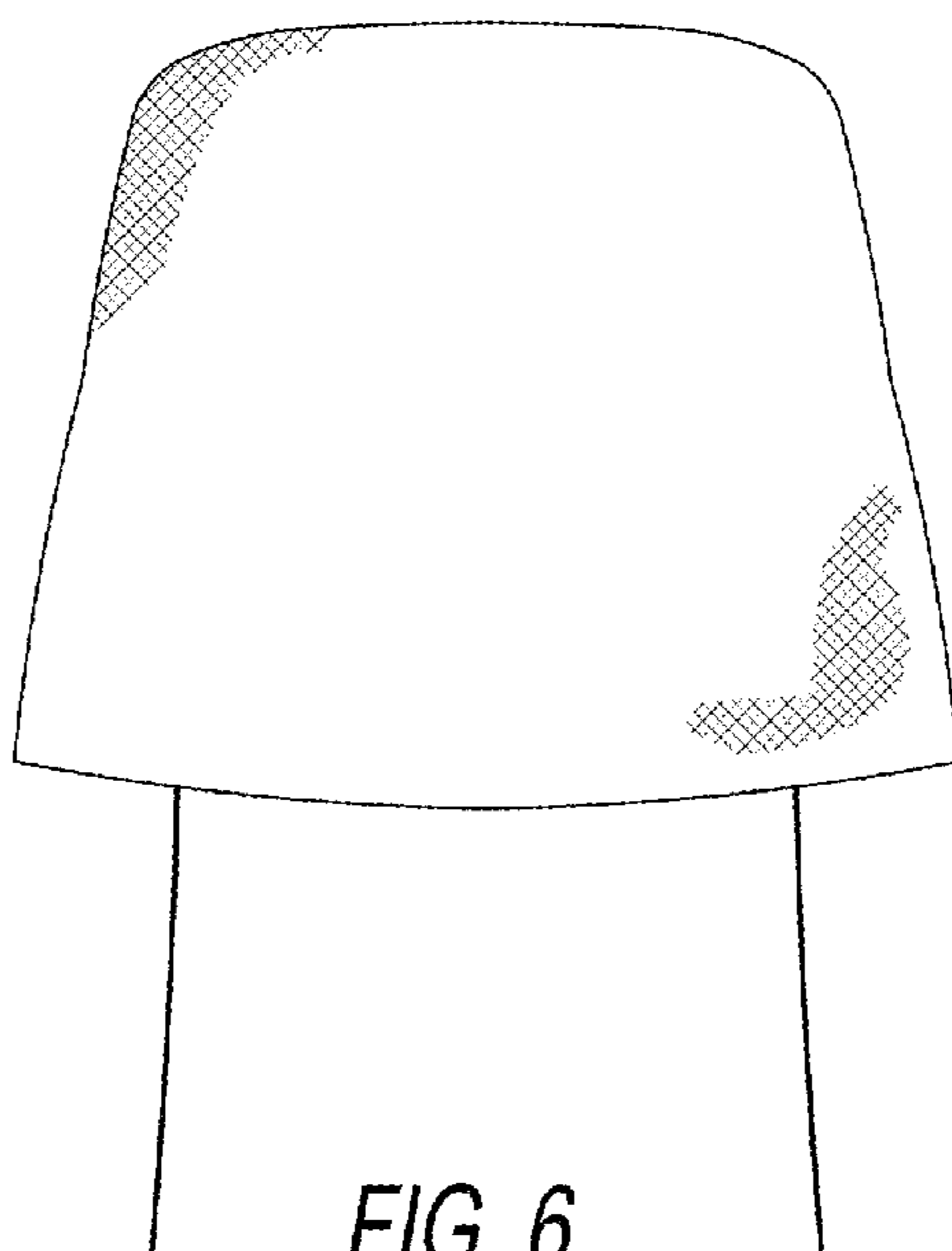

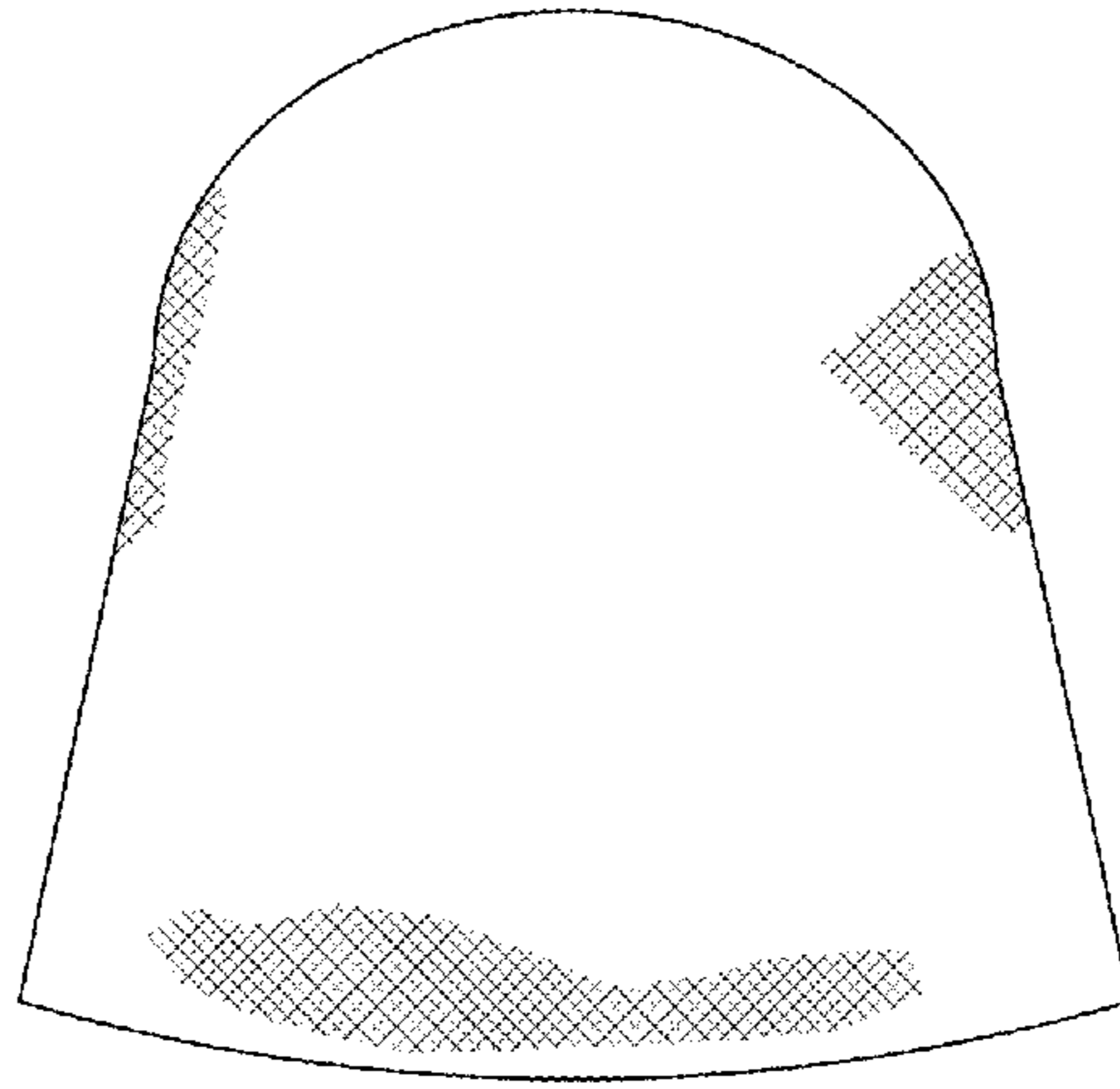

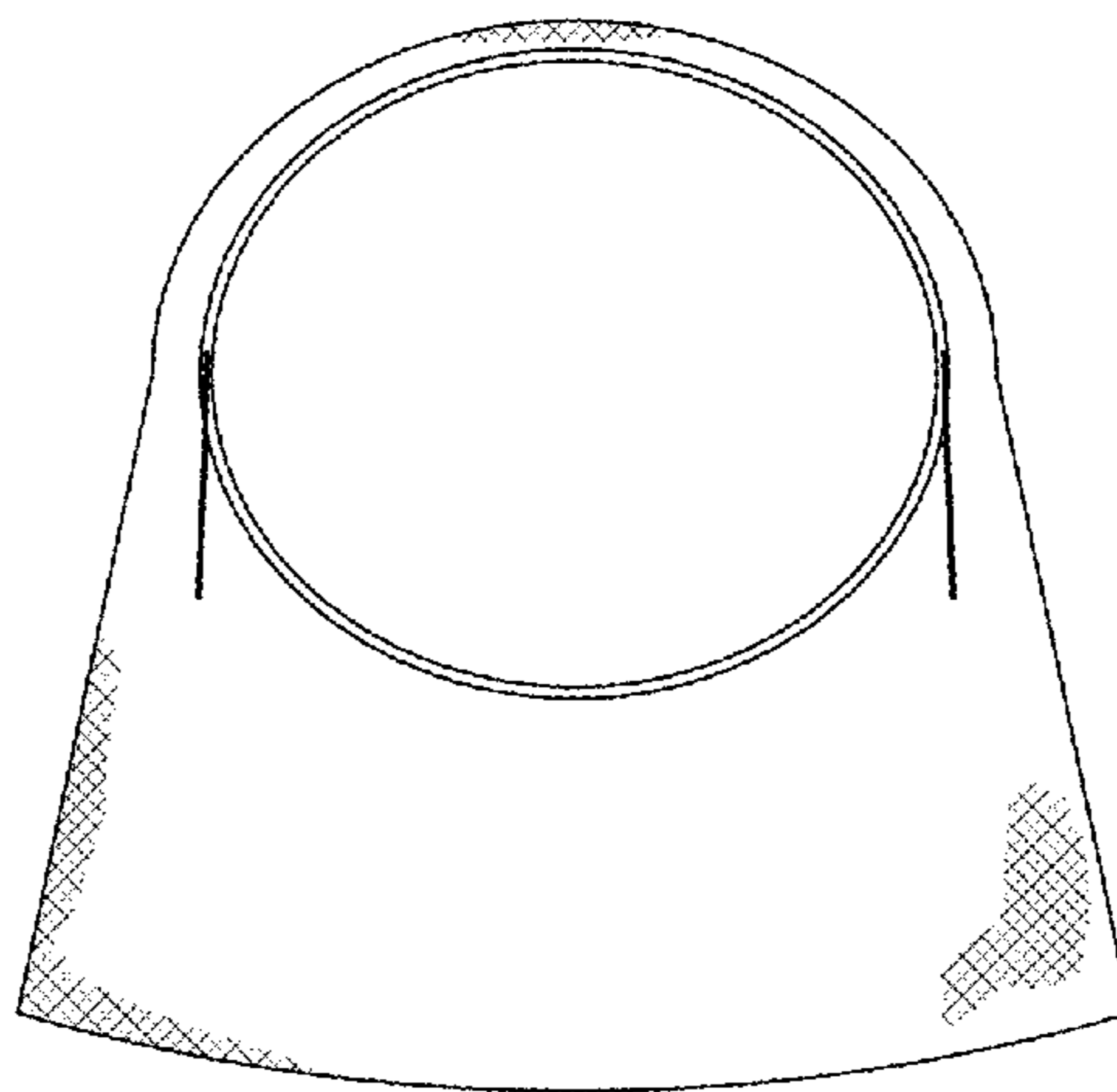
