(57) **CLAIM**

The ornamental design for an insole for high heel shoes, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a right insole for high heel shoes showing my new design;

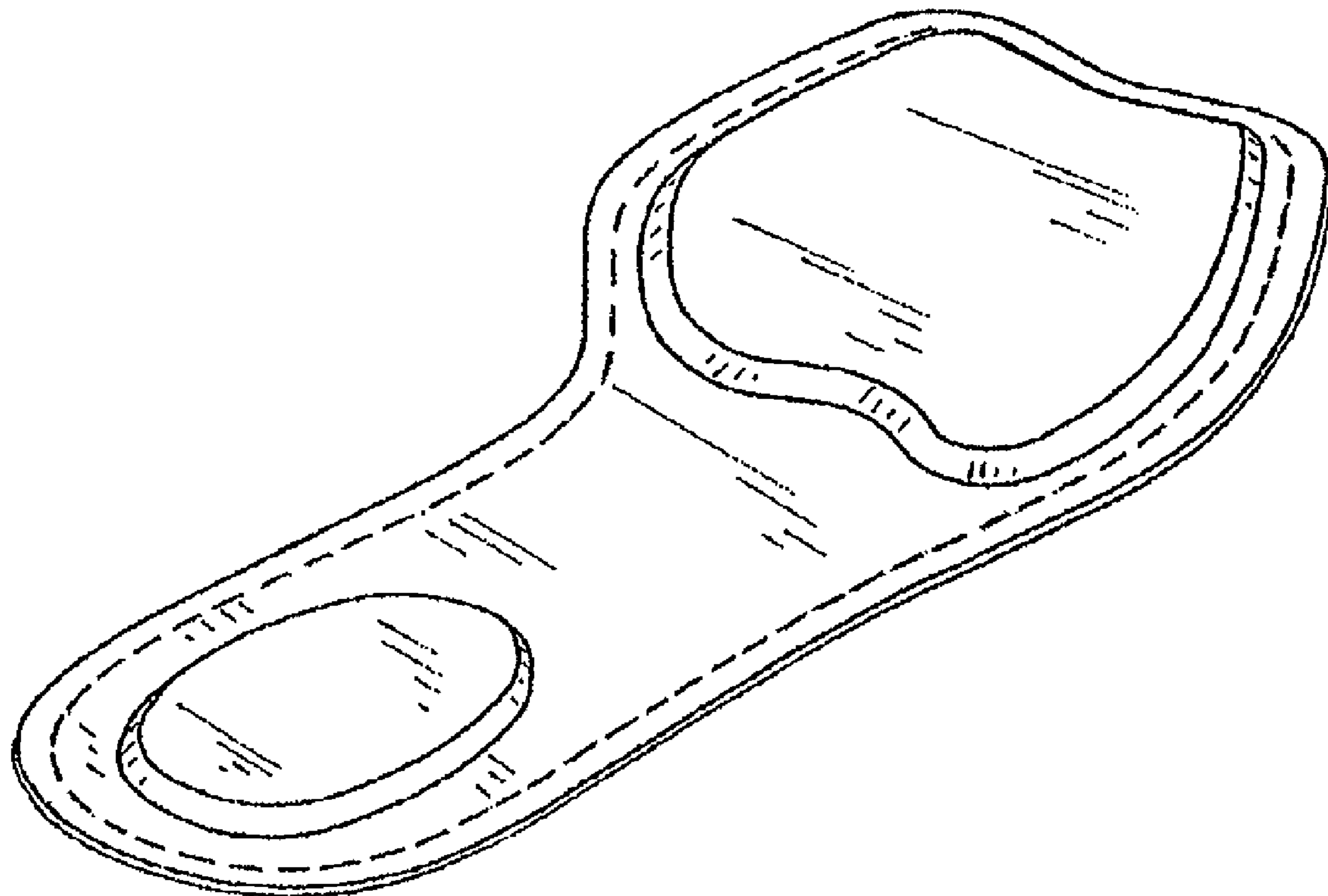
FIG. 2 is a top, rear perspective view thereof; and,

The broken lines in the drawings illustrate stitching.

The bottom of the insole is devoid of surface ornamentation and a view thereof is omitted.

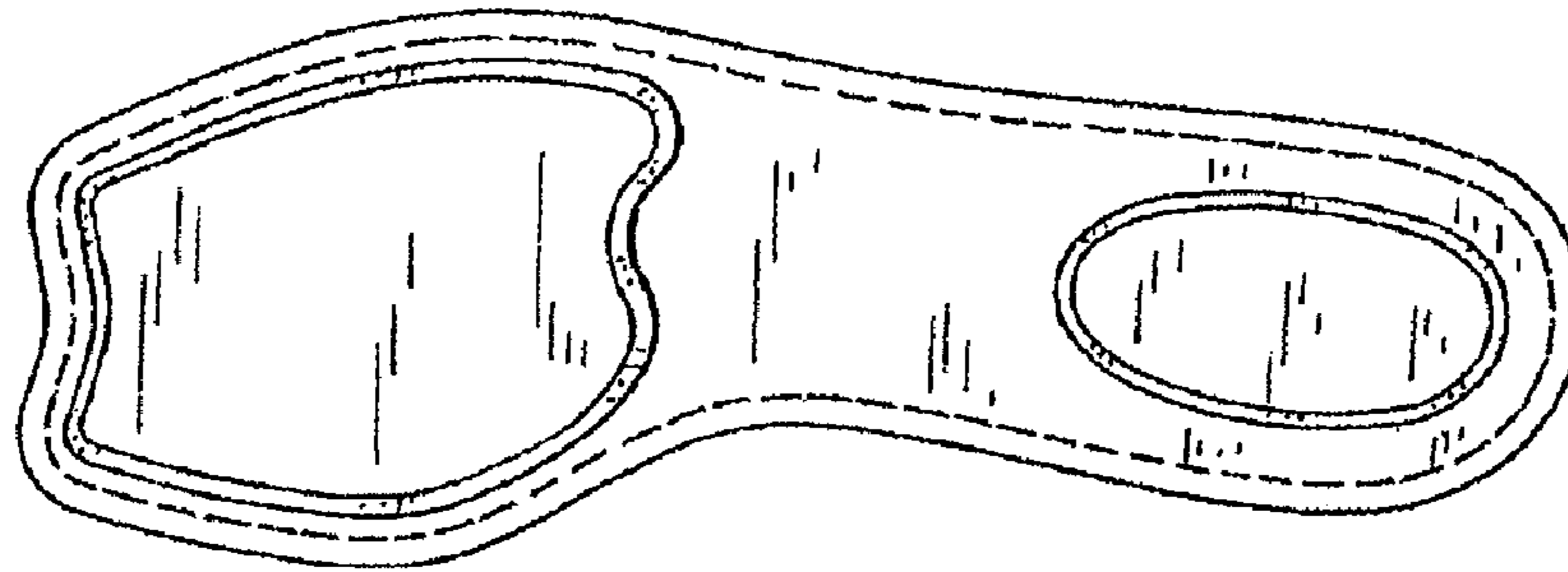

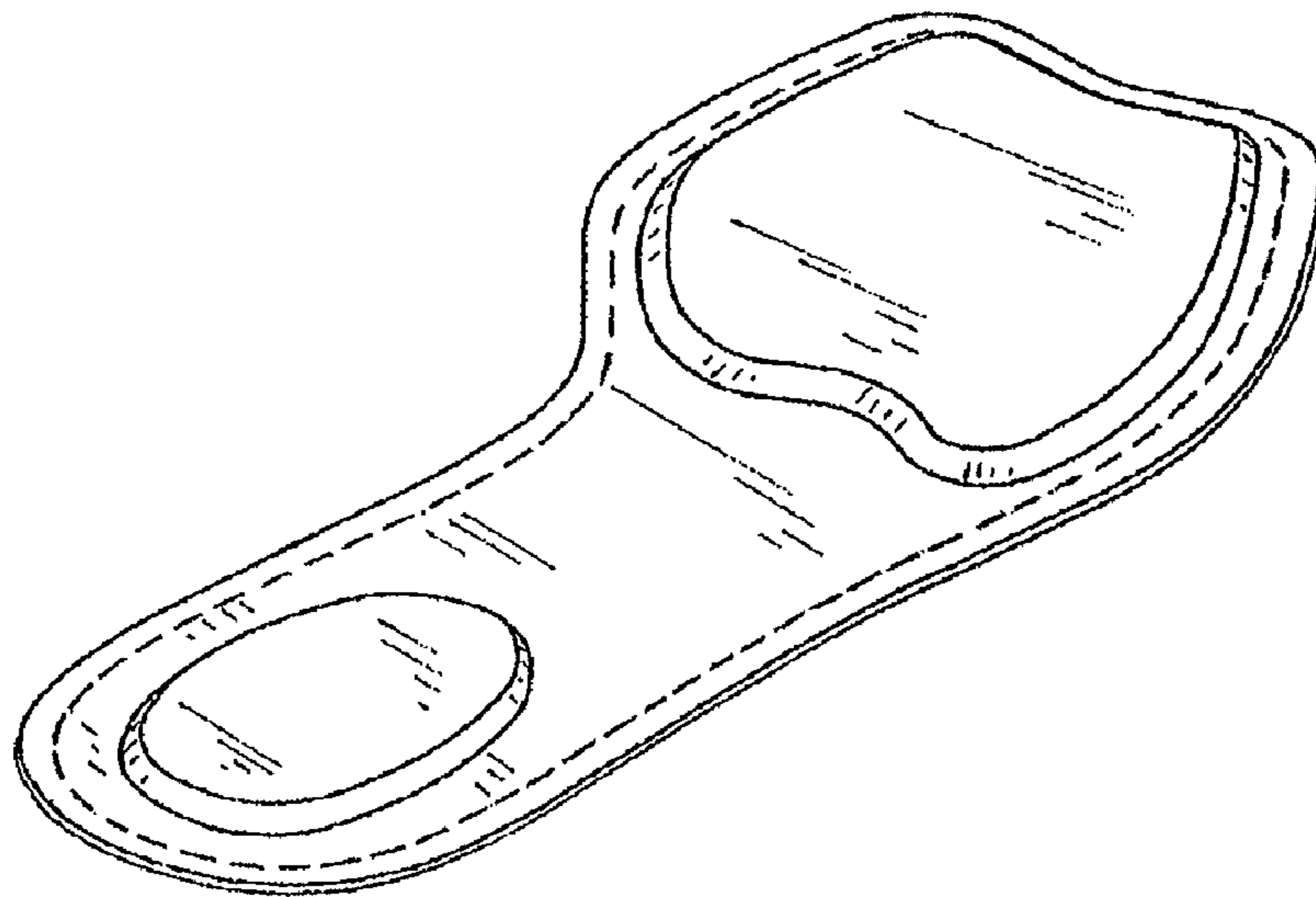
